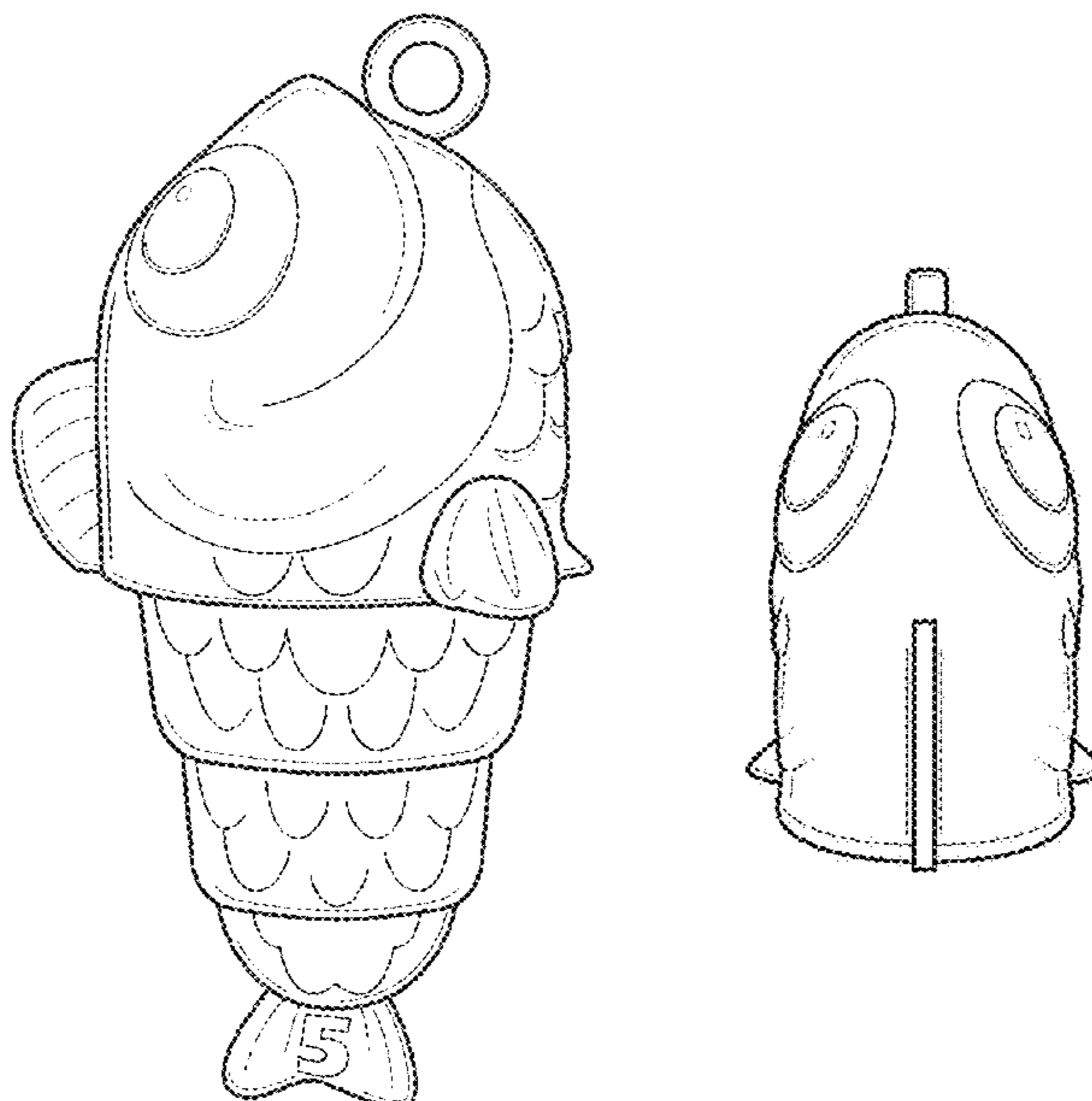
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of the present invention of an expand-
able toy in its expanded configuration;
FIG. 2 is a side view of the expandable toy of FIG. 1;
FIG. 3 is a bottom view of the expandable toy of FIG. 1;
FIG. 4 is a front view of the expandable toy of FIG. 1;
FIG. 5 is a top view of the present invention of an expand-

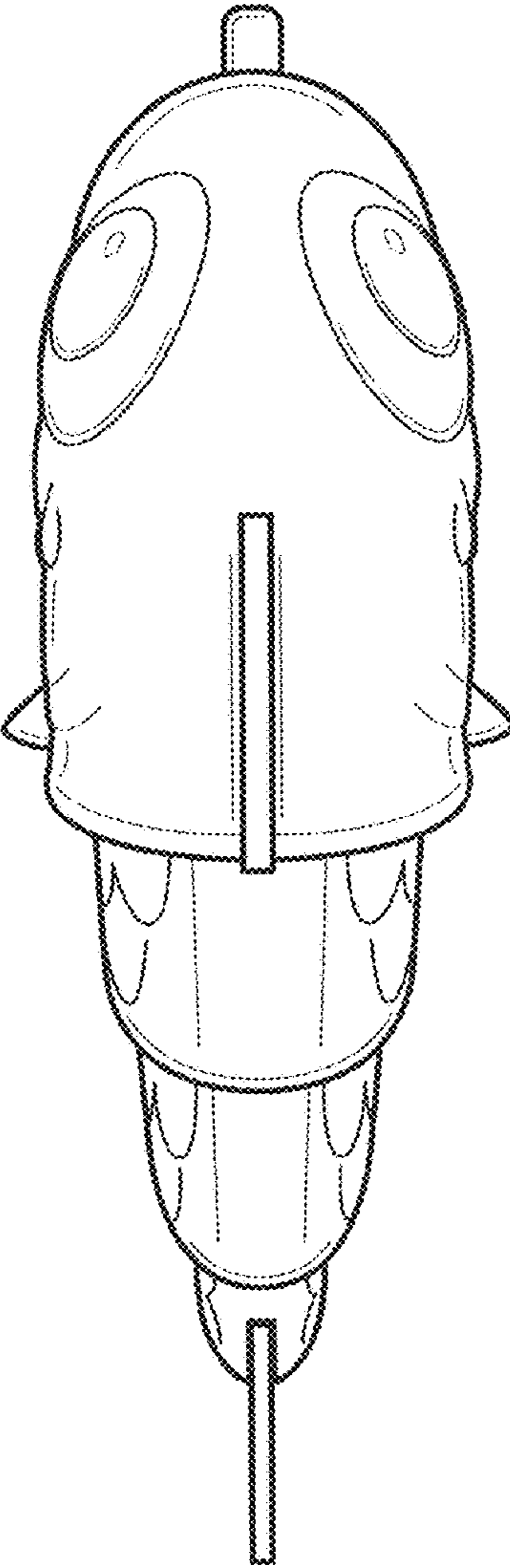

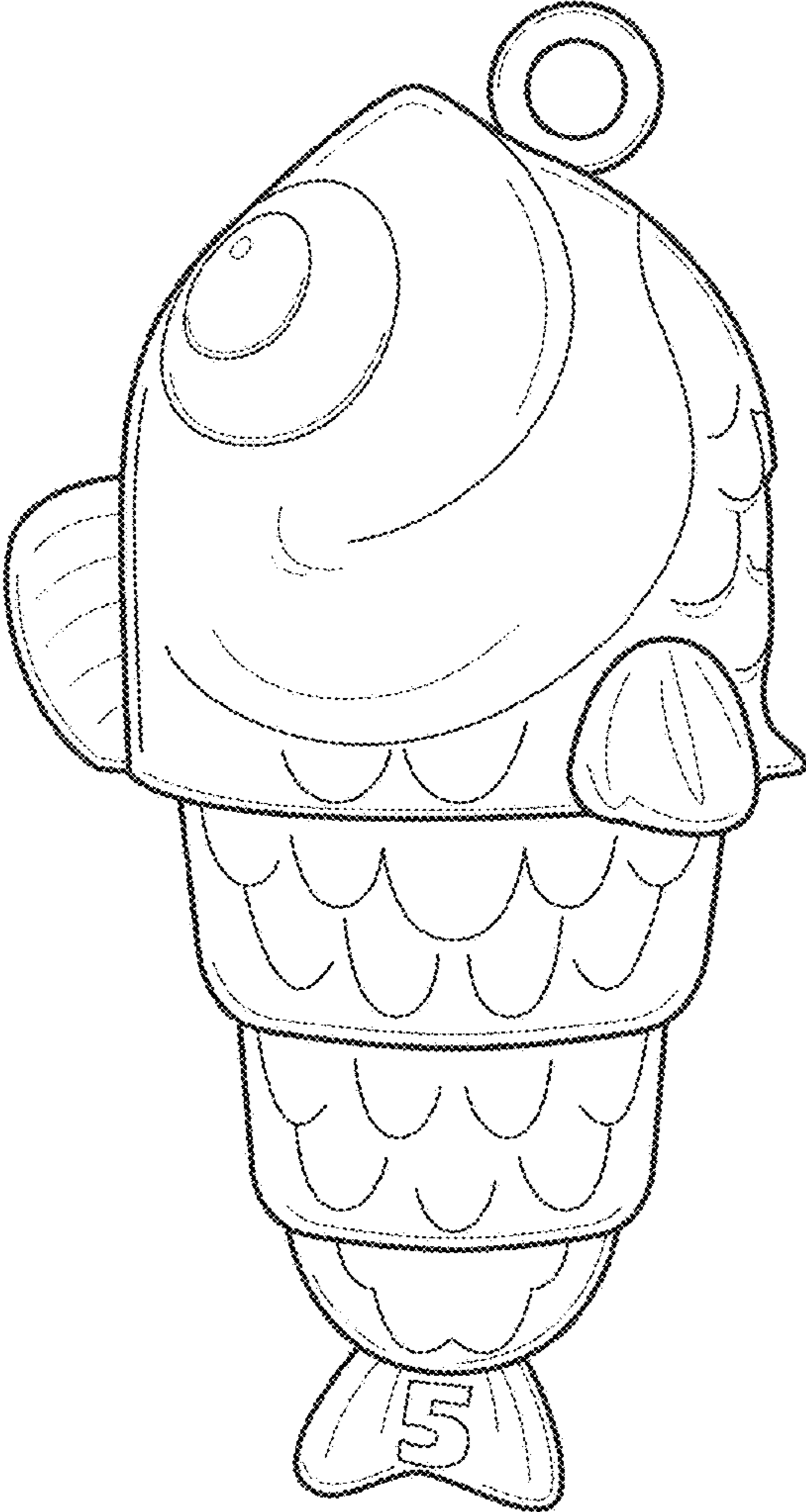

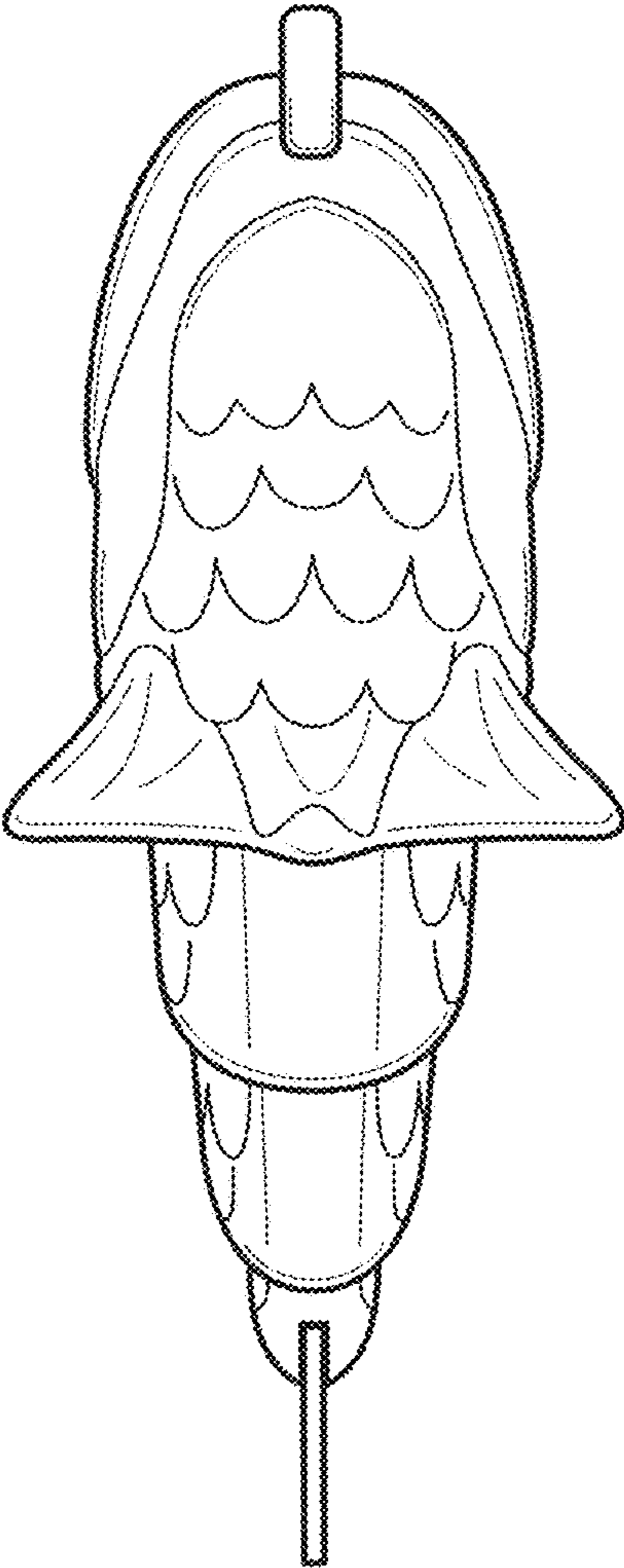

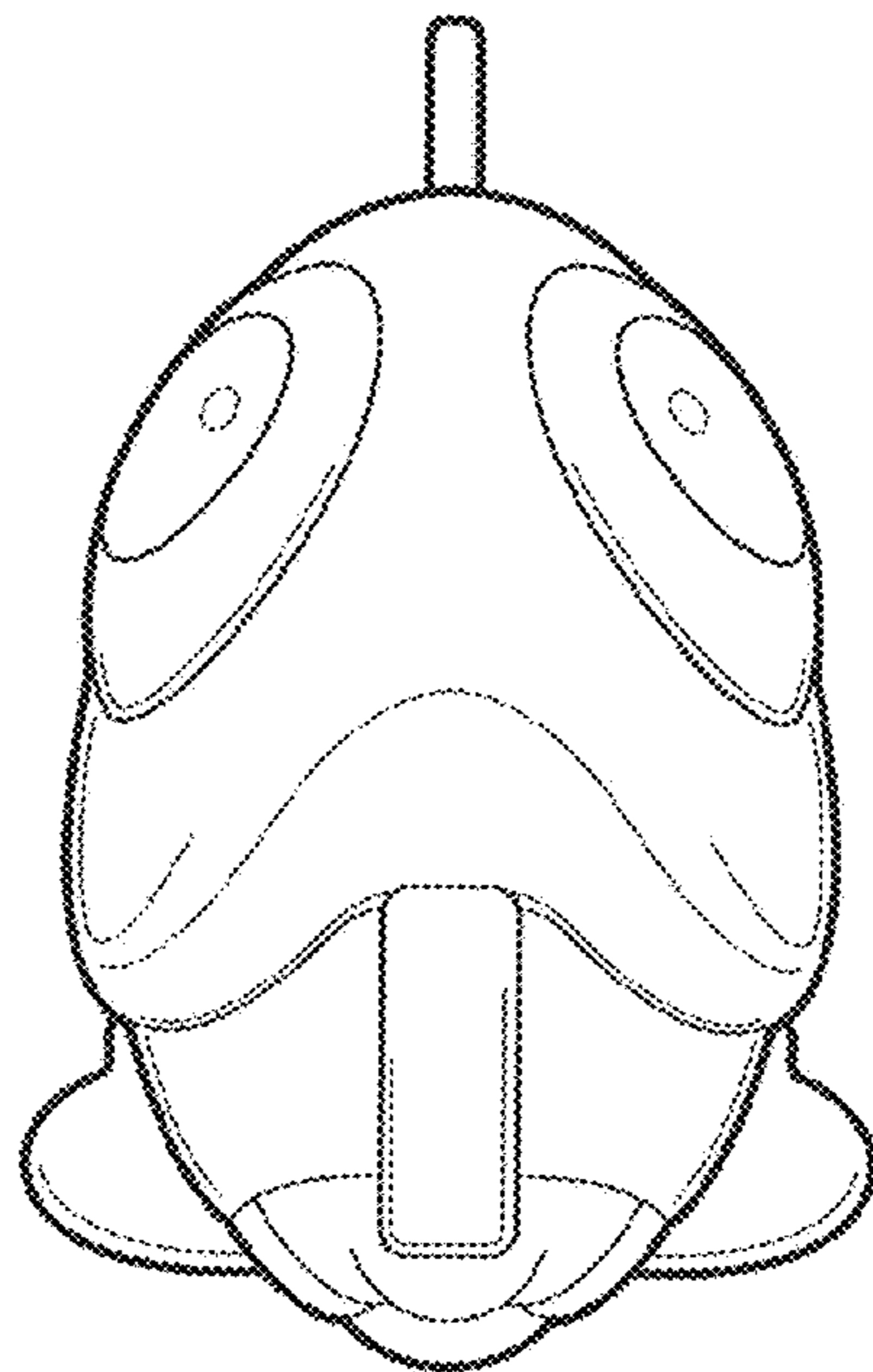

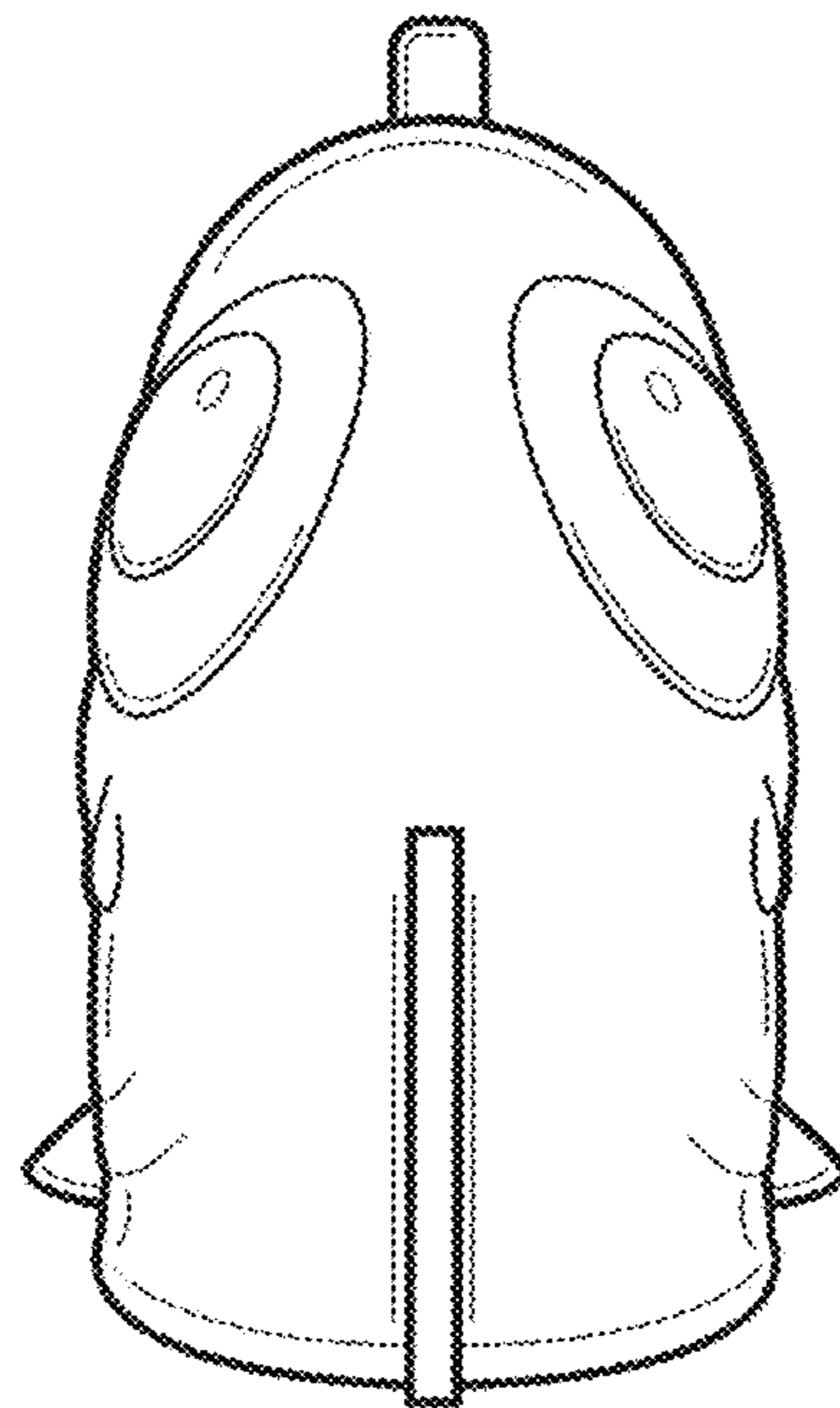

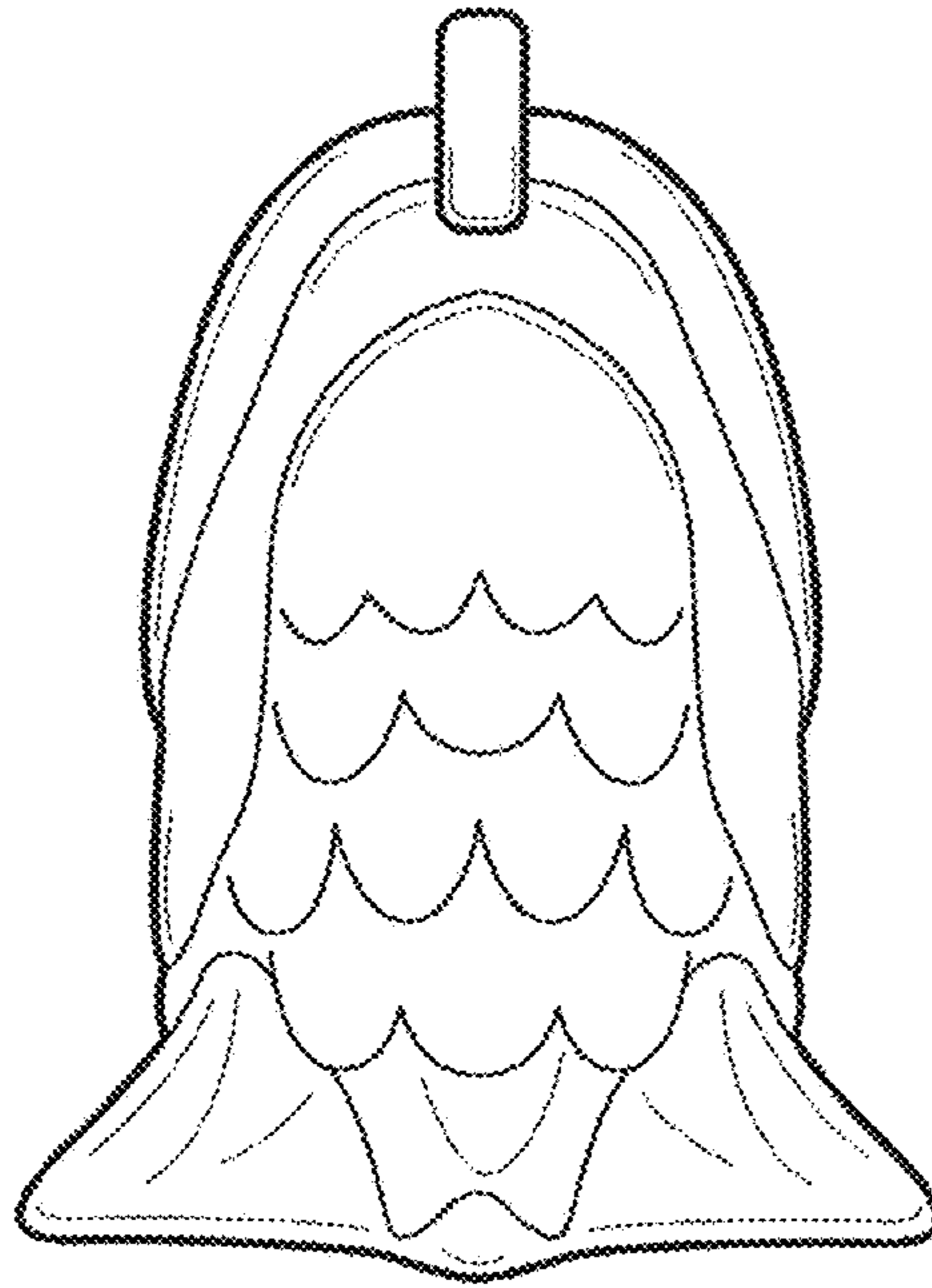

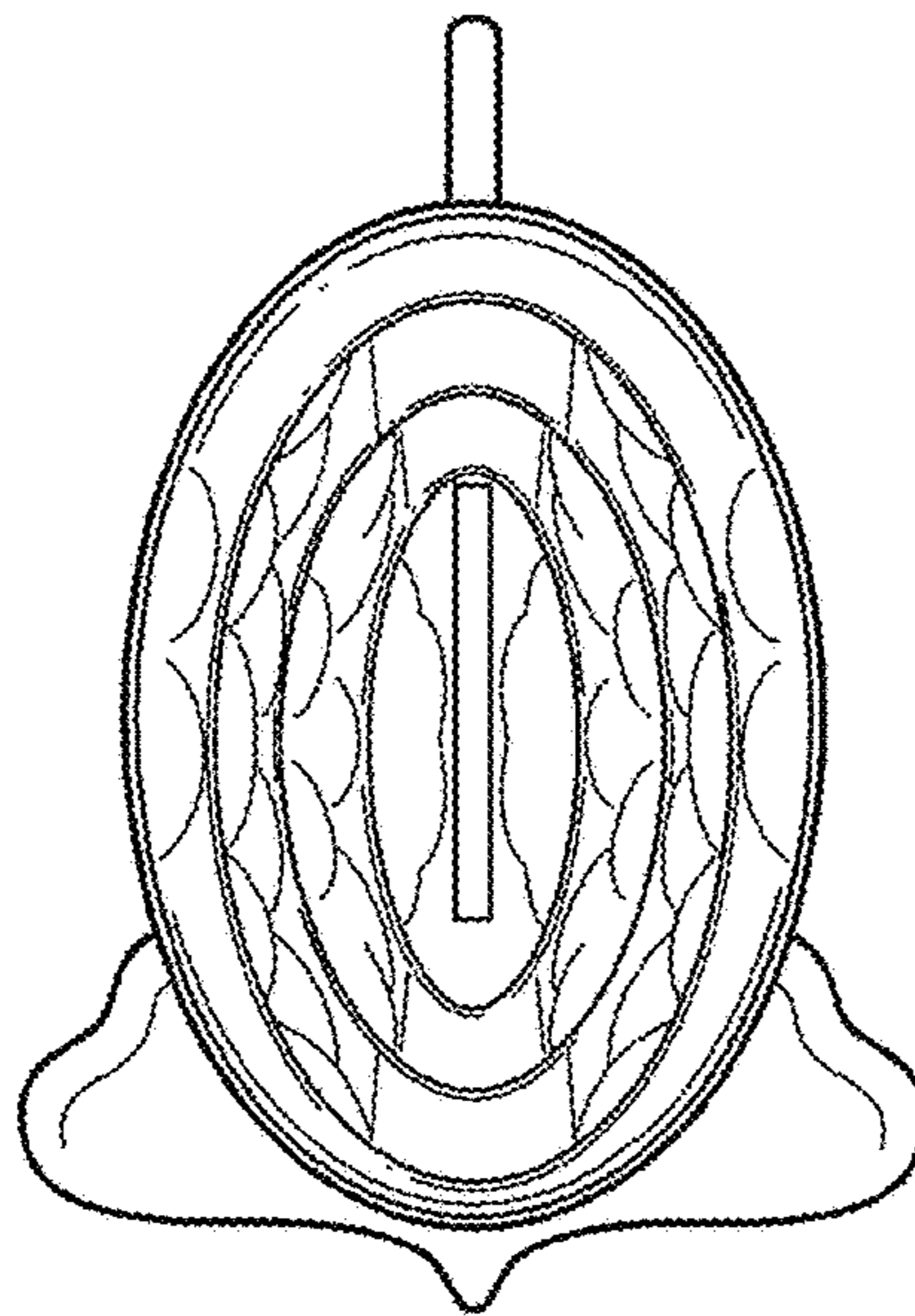
