(57) **CLAIM**

I claim, the ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a light fixture according to the present invention.

FIG. 2 is a front view of the light fixture of FIG. 1.

FIG. 3 is a rear view of the light fixture of FIG. 1.

FIG. 4 is a left side view of the light fixture of FIG. 1.

FIG. 5 is a right side view of the light fixture of FIG. 1.

FIG. 6 is a top view of the light fixture of FIG. 1; and,

FIG. 7 is a bottom view of the light fixture of FIG. 1.

The broken lines in the drawings illustrate the portions of the light fixture that form no part of the claim. The multi-circles element shown in the broken line in FIG. 3 forms no part of the claim.

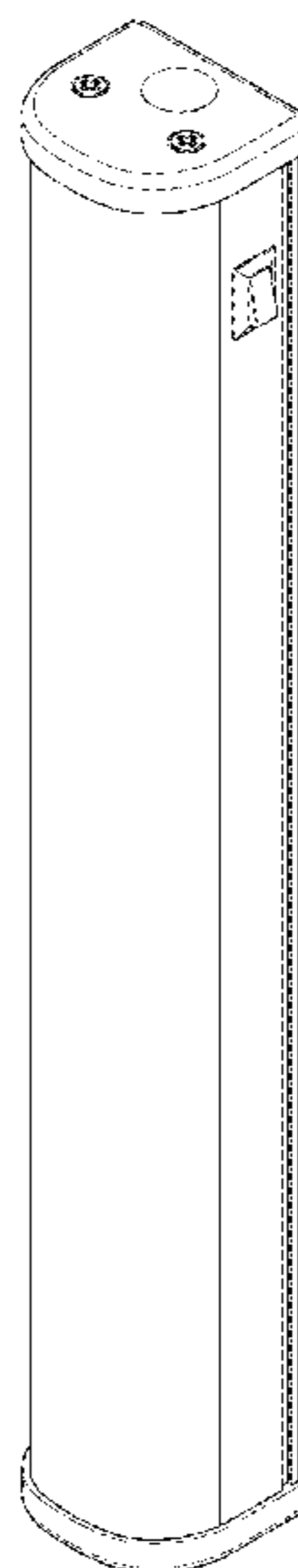

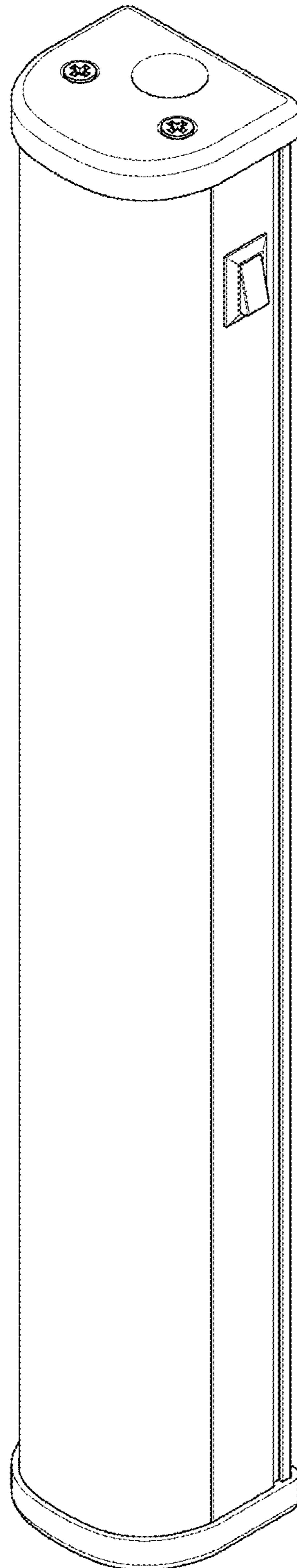

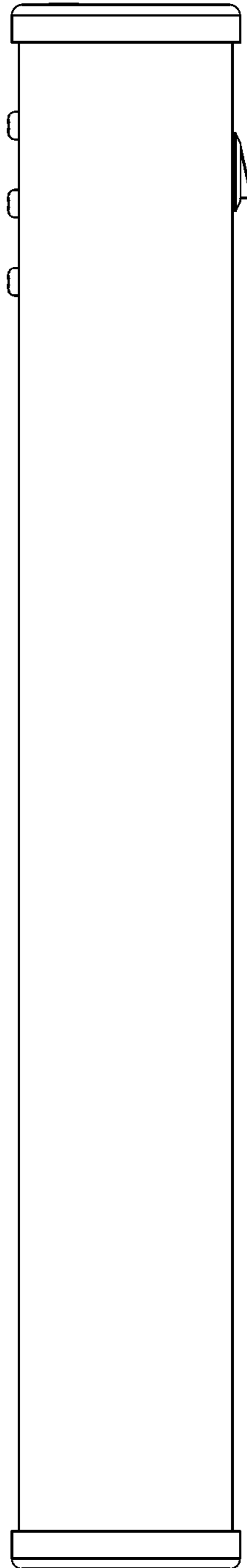

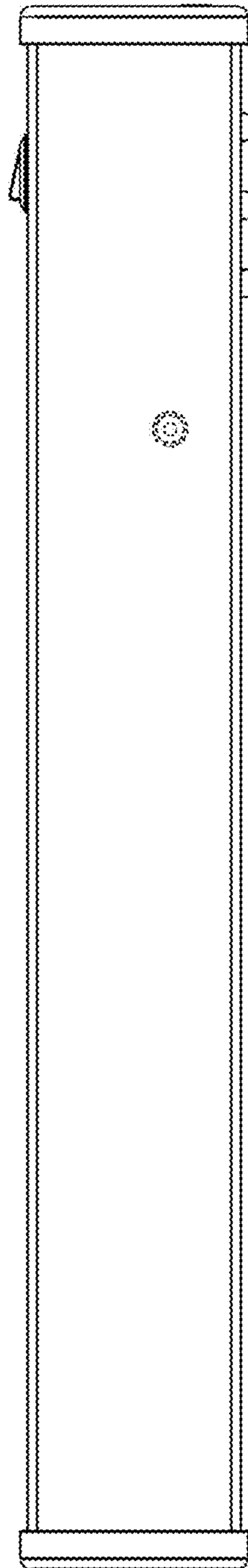

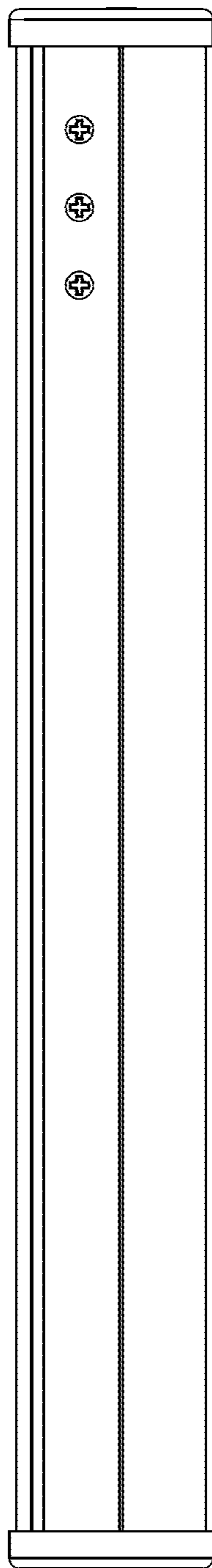

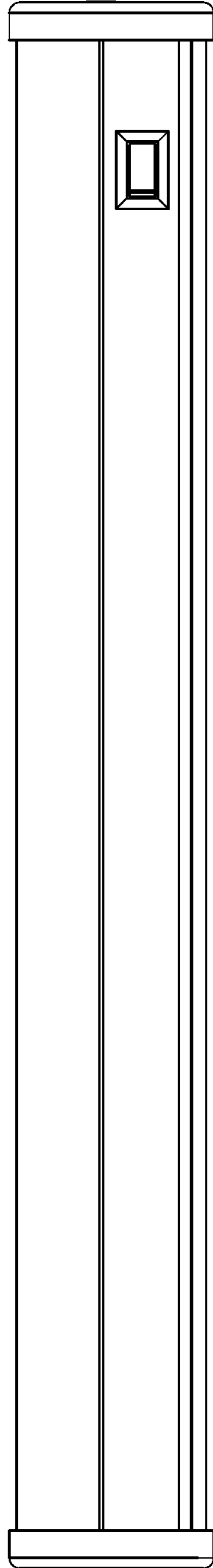

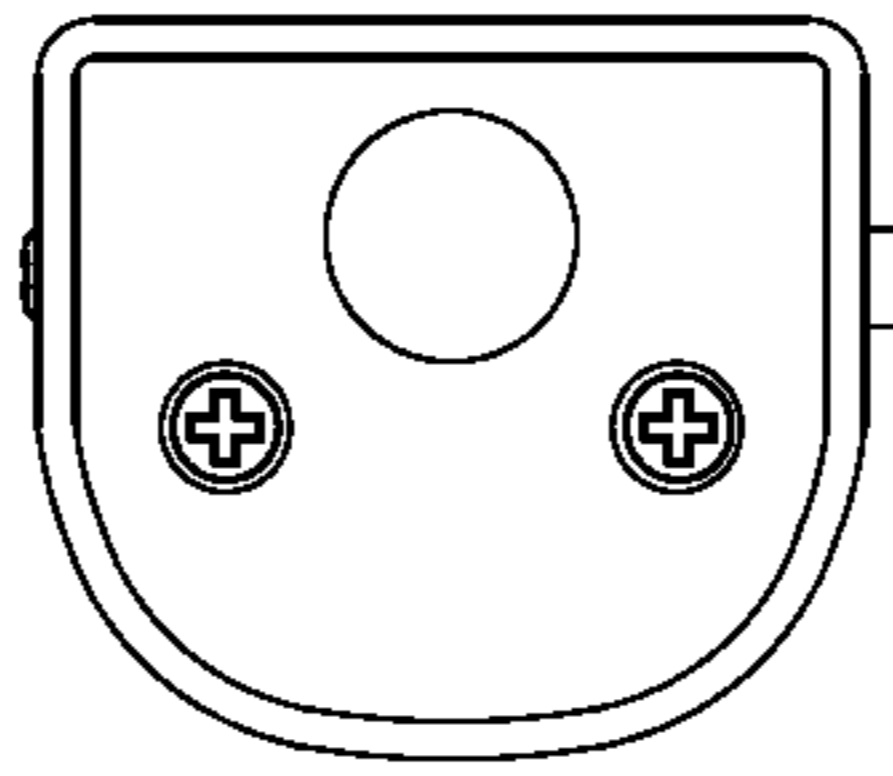
