(57) **CLAIM**

The ornamental design of the eyelash applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side view of the eyelash applicator according to a first embodiment of the present disclosure showing our new design, with a right side view being a mirror thereof; FIG. 2 is a perspective view of the eyelash applicator of FIG. 1;

FIG. 3 is a left side view of the eyelash applicator according to a second embodiment of the present disclosure showing our new design; with a right side view being a mirror thereof;

FIG. 4 is a perspective view of the eyelash applicator of FIG. 3;

FIG. 5 is a left side view of the eyelash applicator according to a third embodiment of the present disclosure showing our new design;

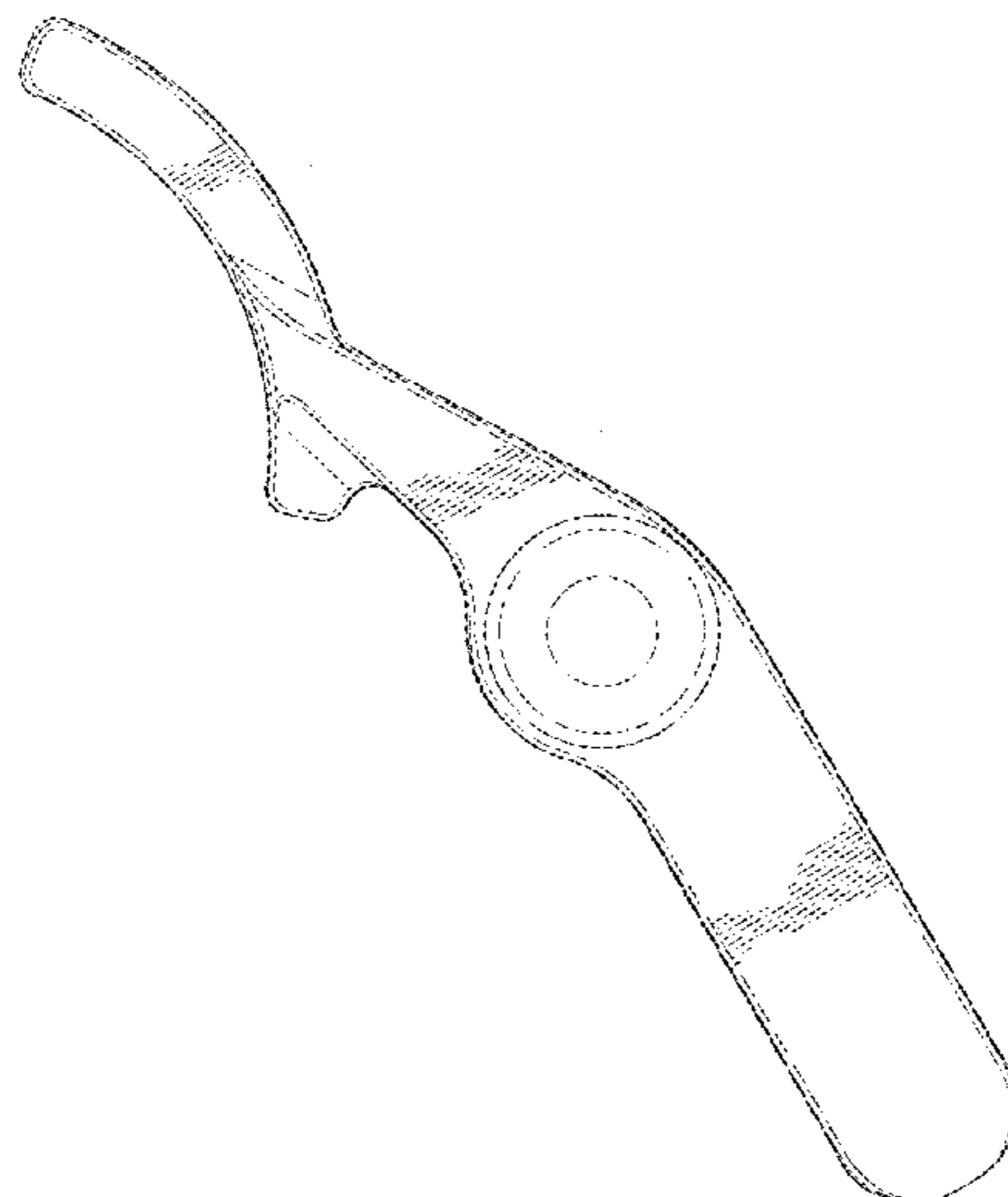
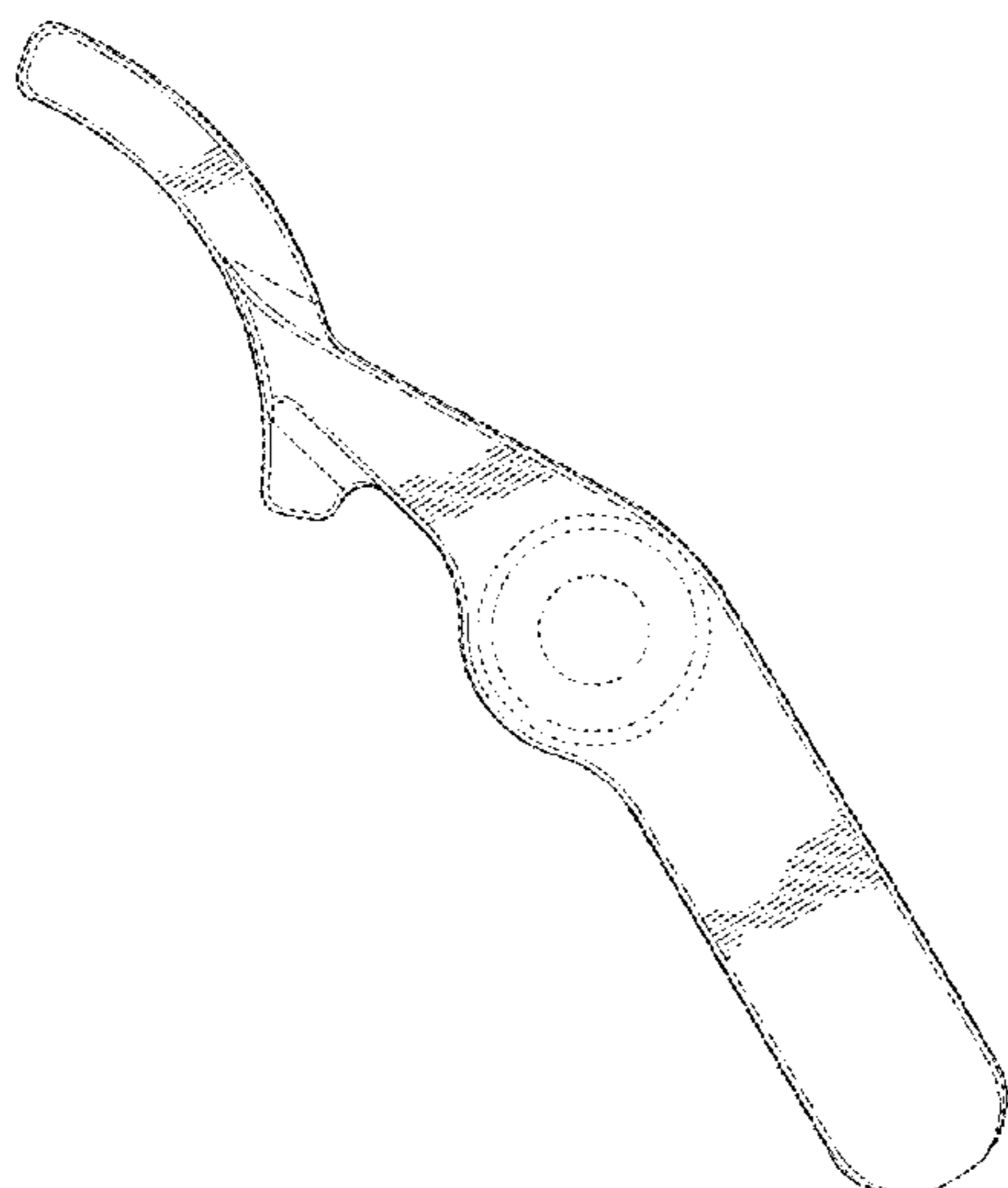
FIG. 6 is a right side view of the eyelash applicator of FIG. 5;

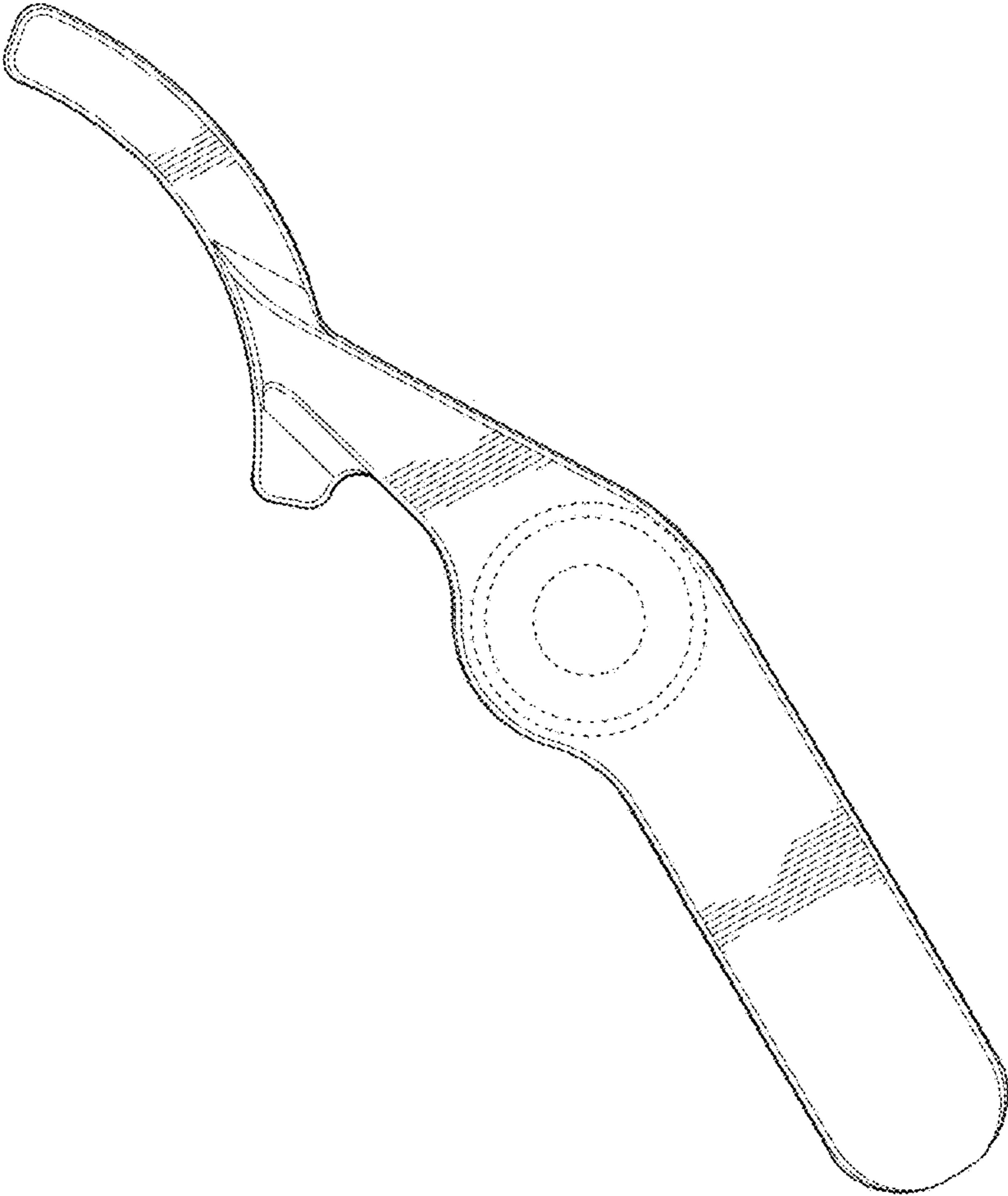

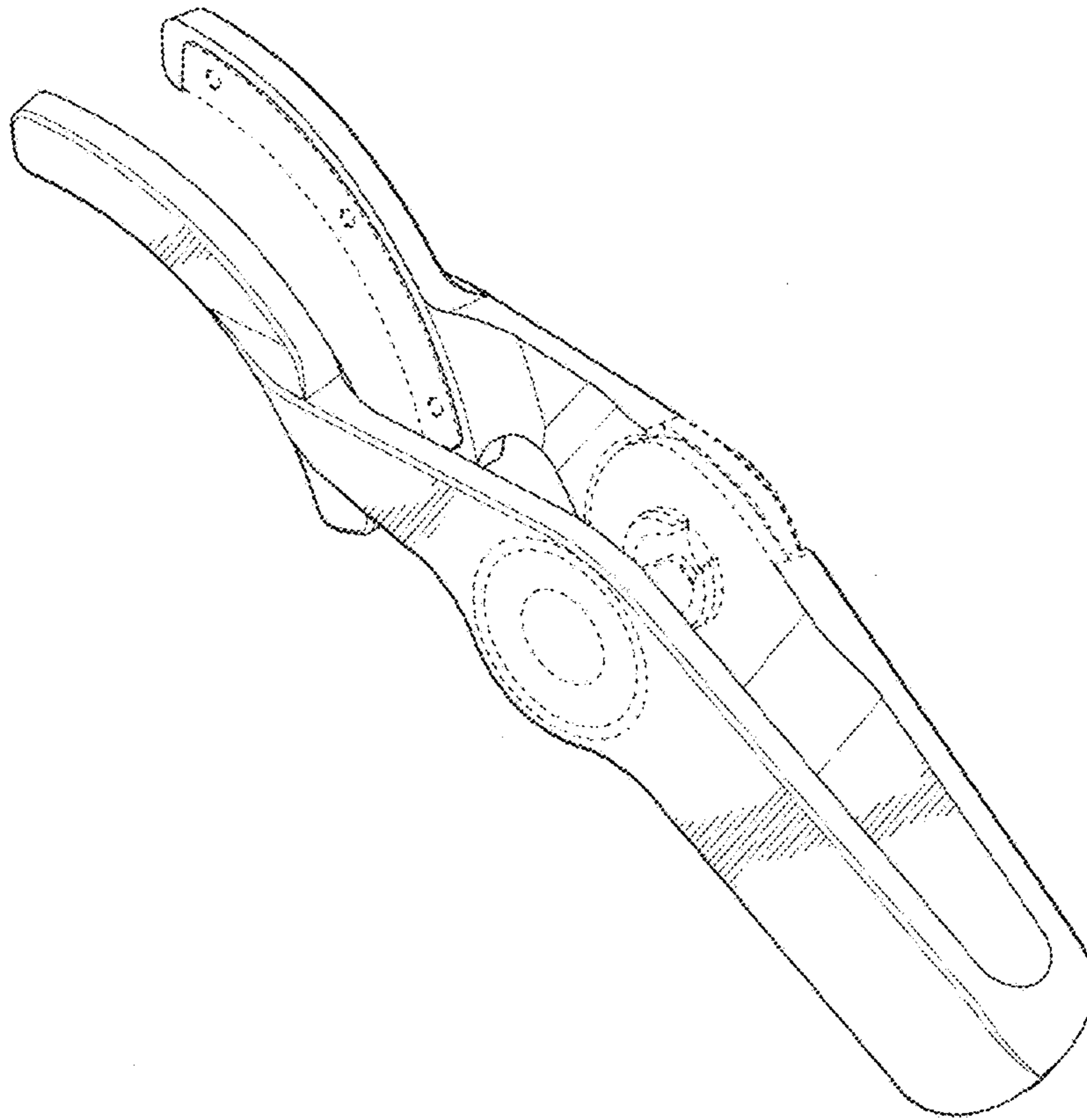

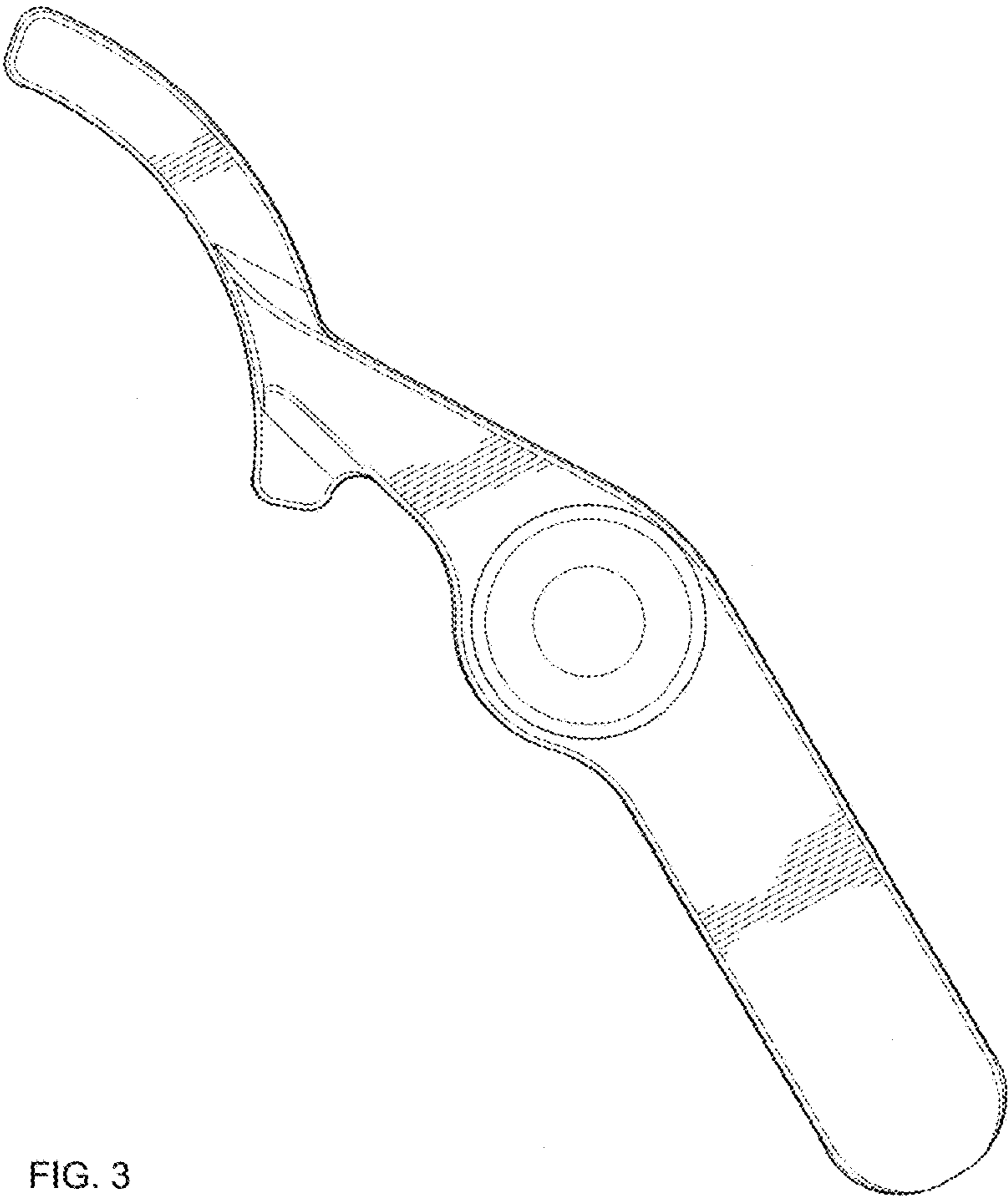

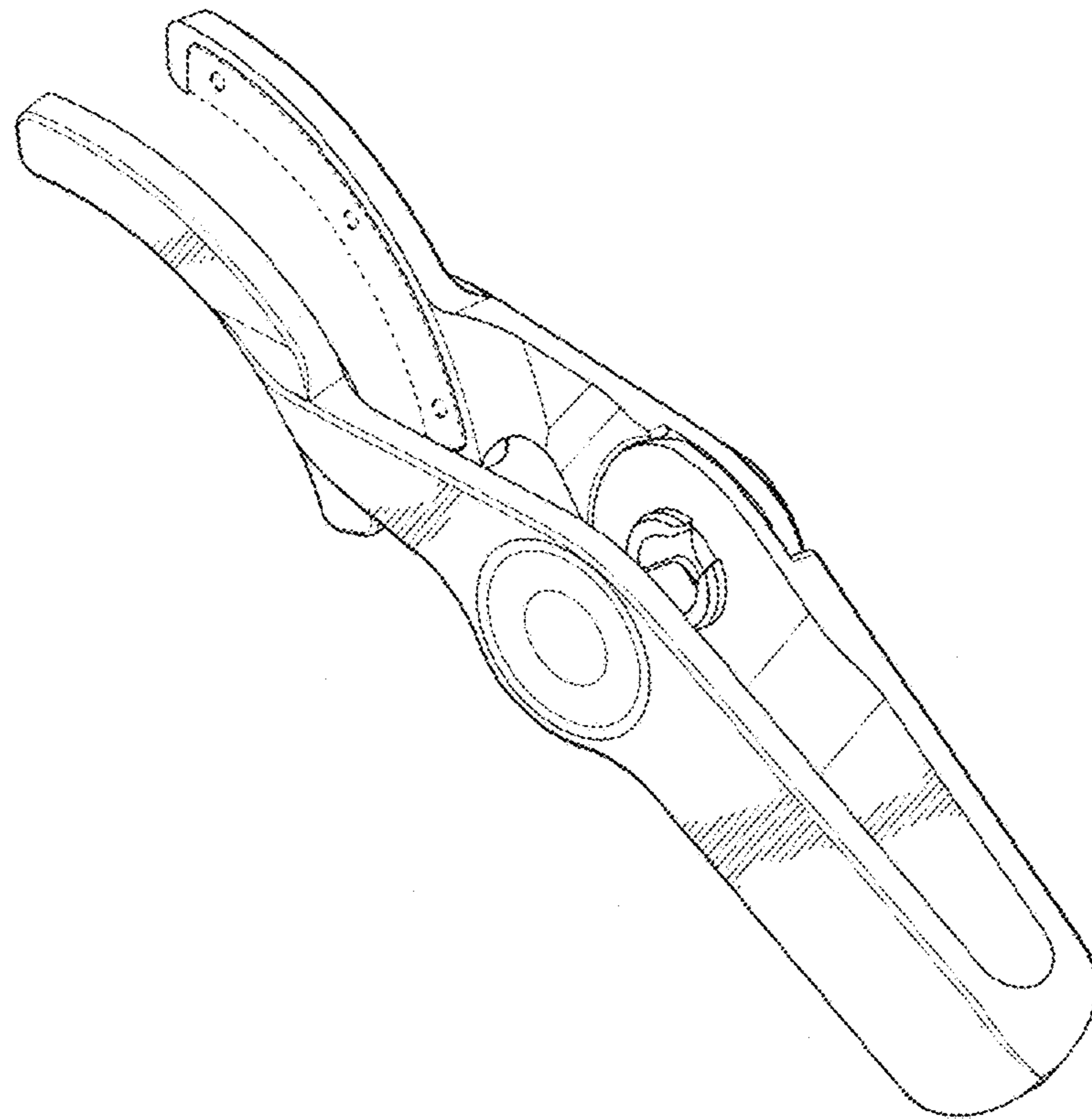

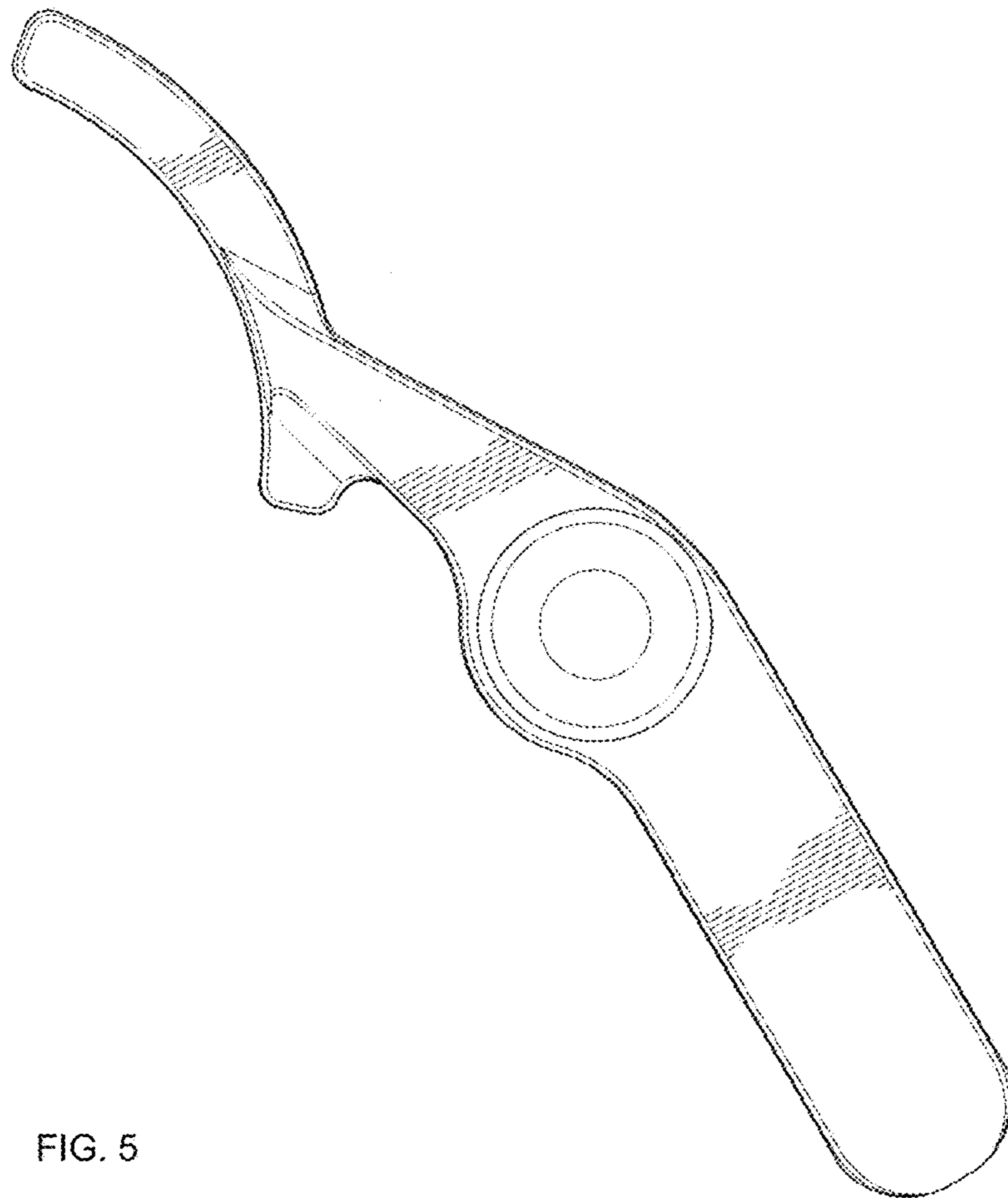

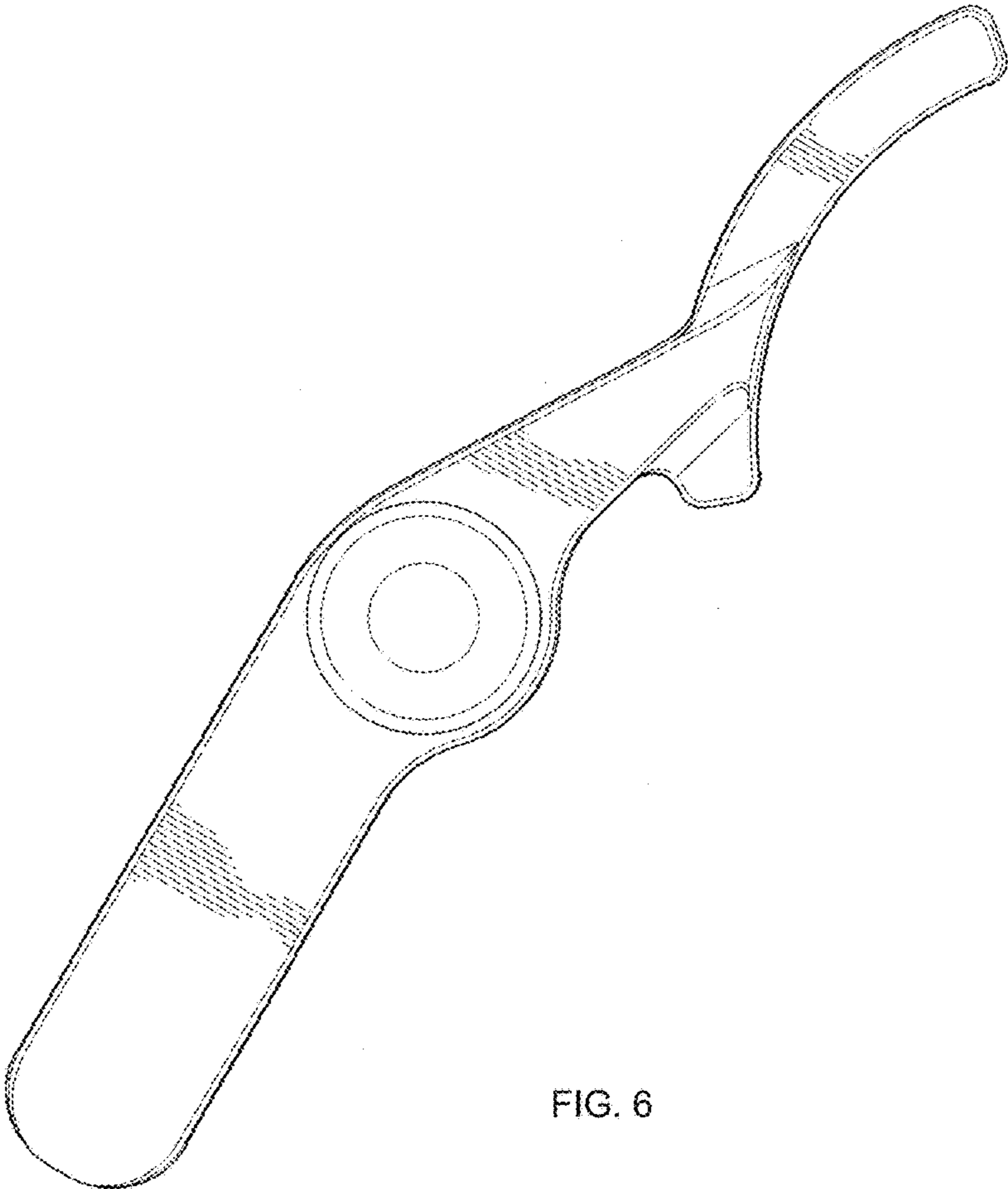

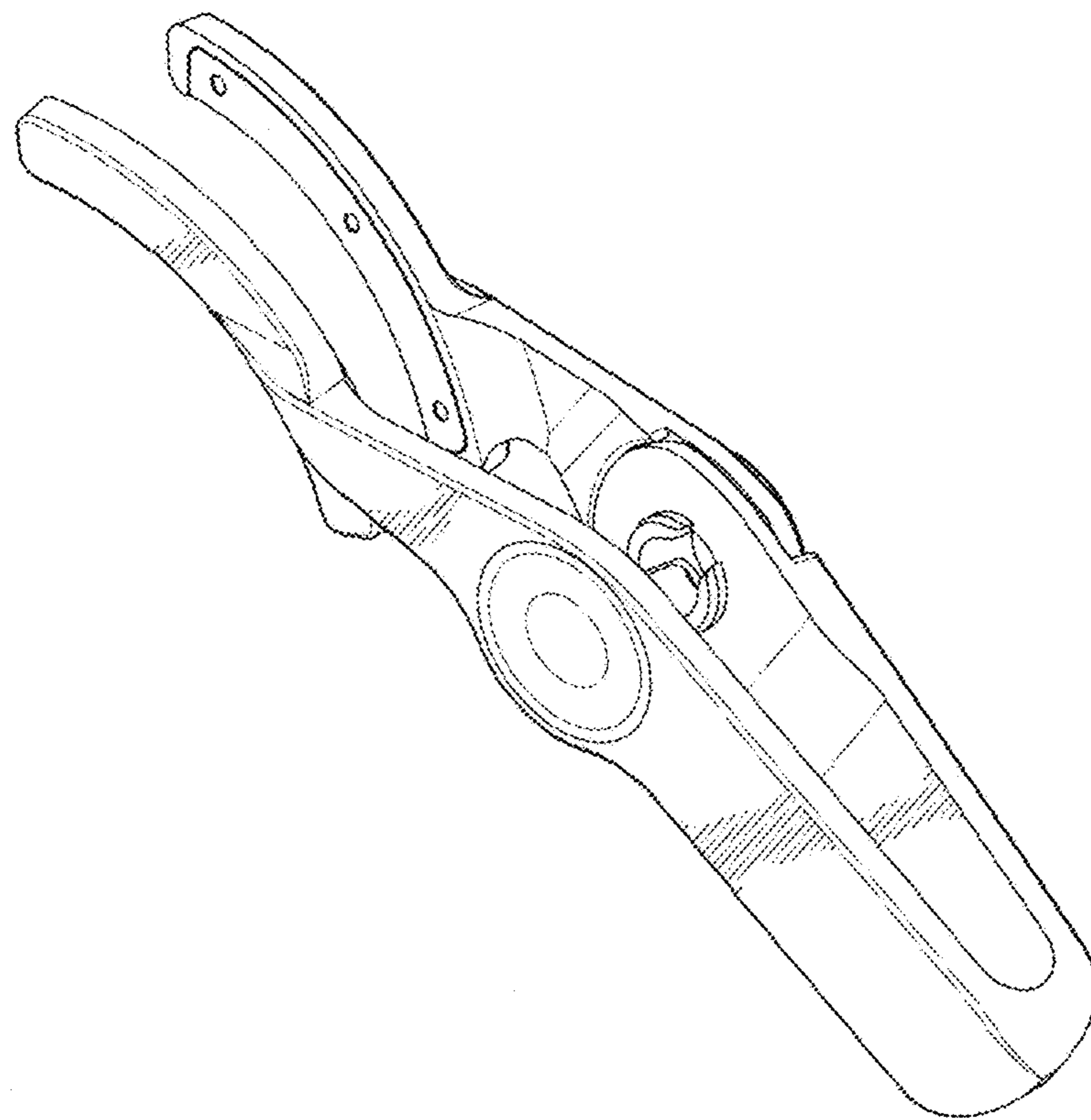

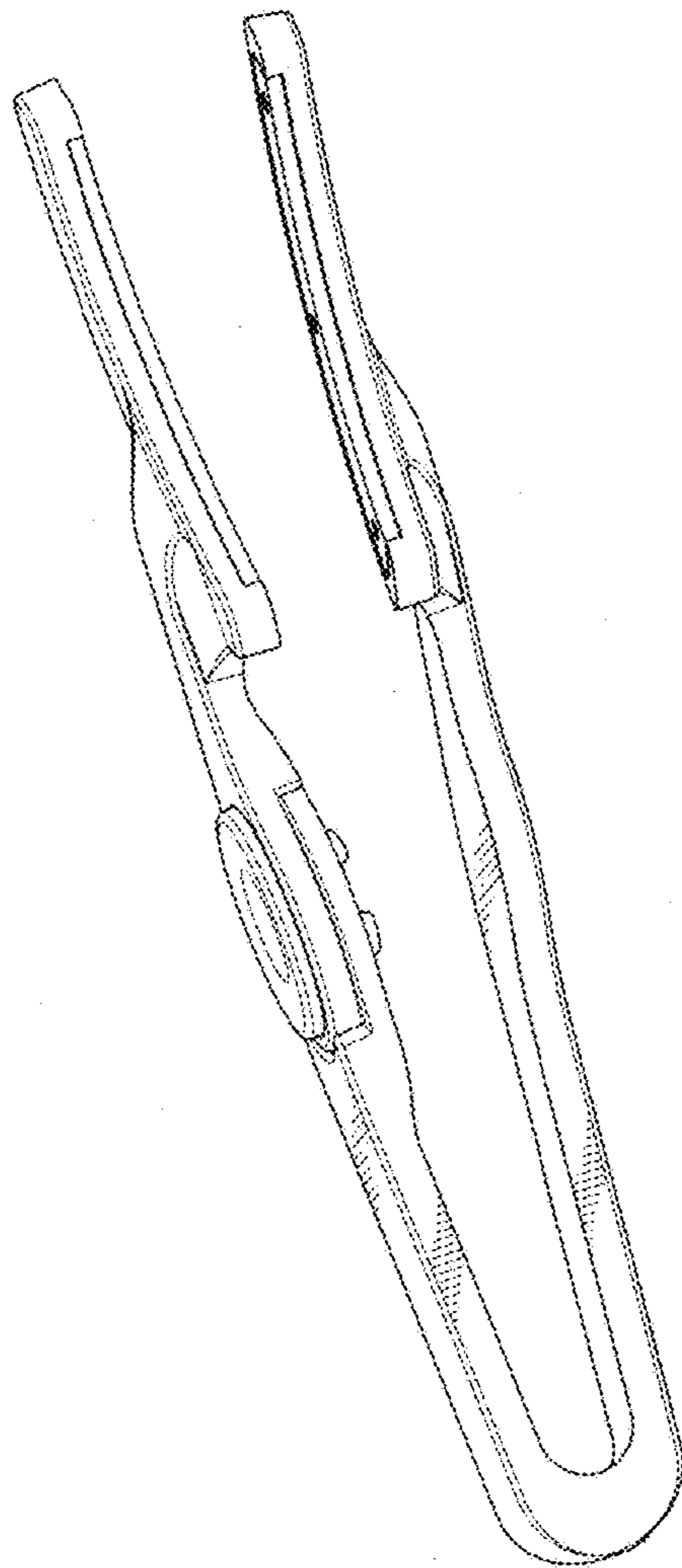
