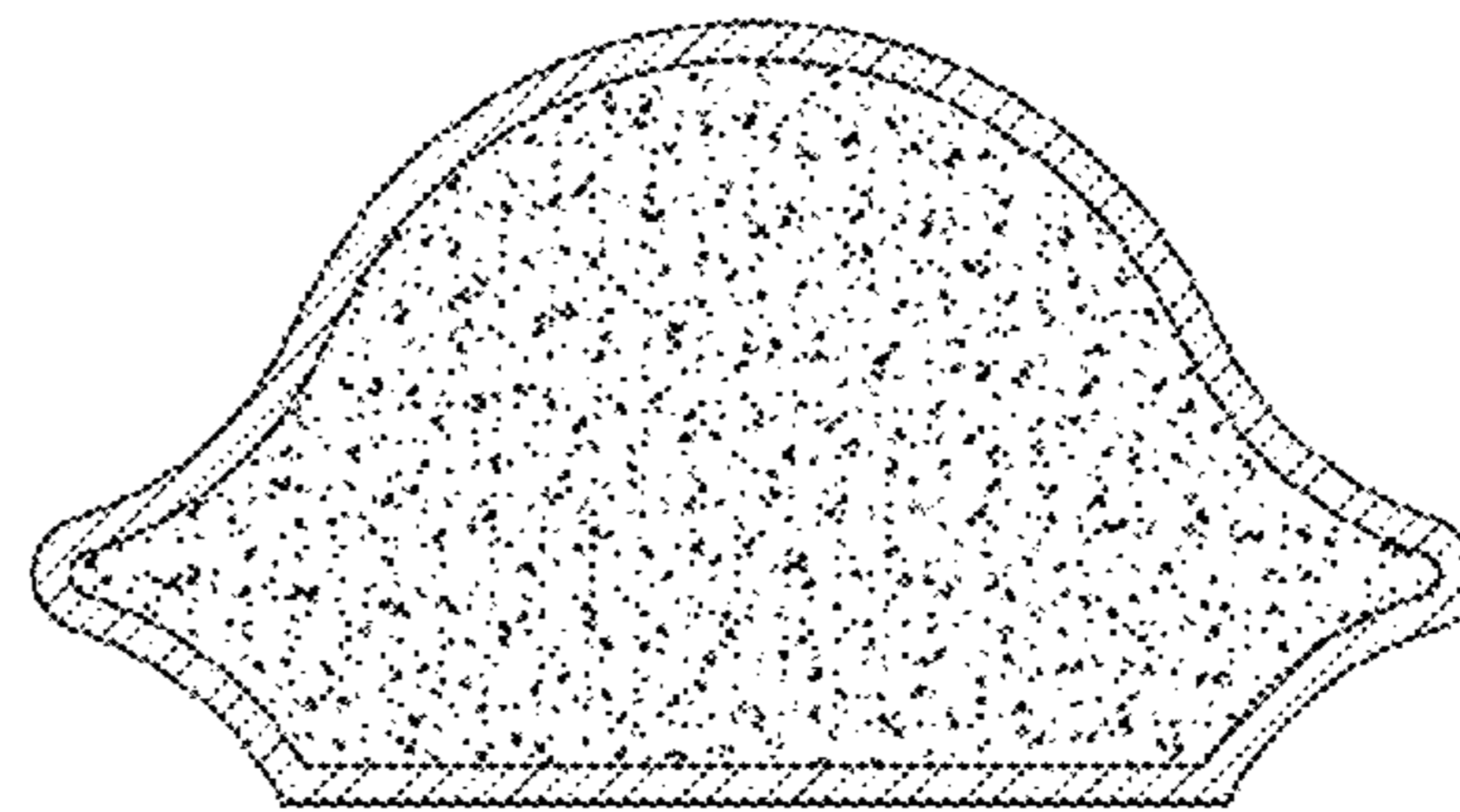
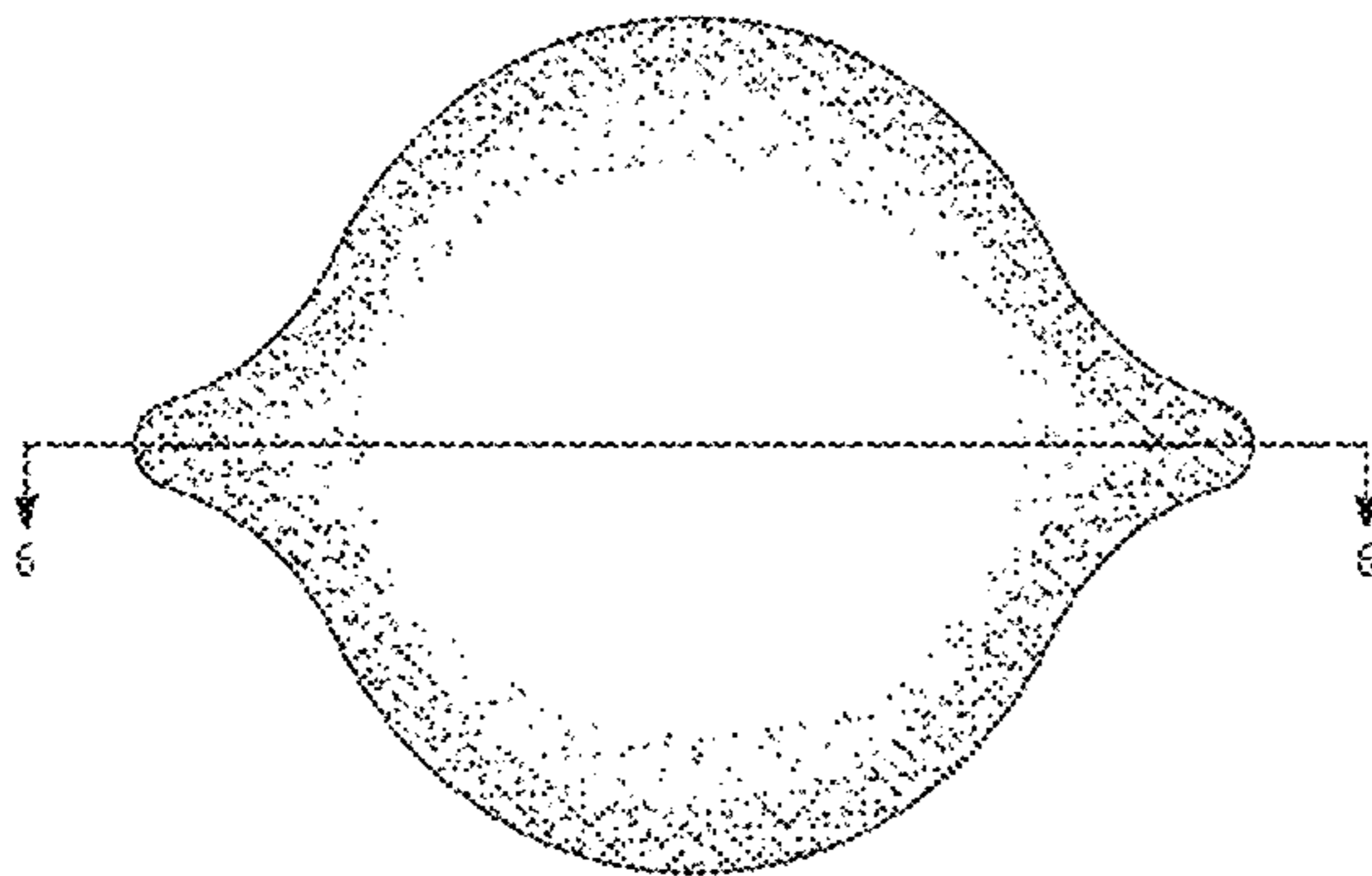
The ornamental design for a confectionery product, as

**DESCRIPTION**

FIG. 1 is a front elevation view of a confectionery product;  
FIG. 2 is a rear elevation view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a left side elevation view thereof; and,  
FIG. 6 is a cross-sectional view thereof taken along line 6-6  
shown in FIG. 3.

The speckled shading shown on the inside of the confec-  
tionery product in FIG. 6 illustrates a filling that has a  
contrasting appearance from the exterior of the confec-  
tionery product.

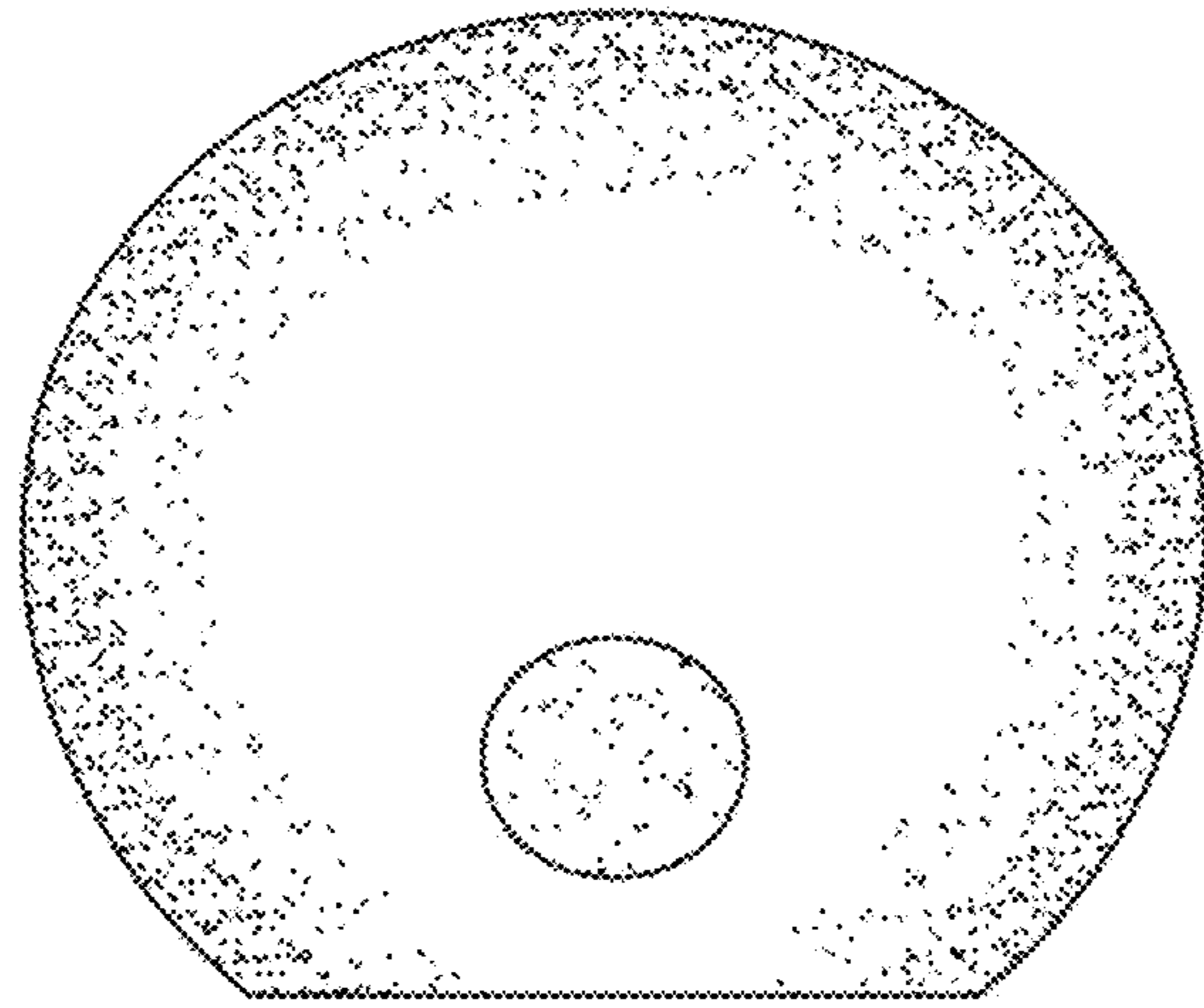

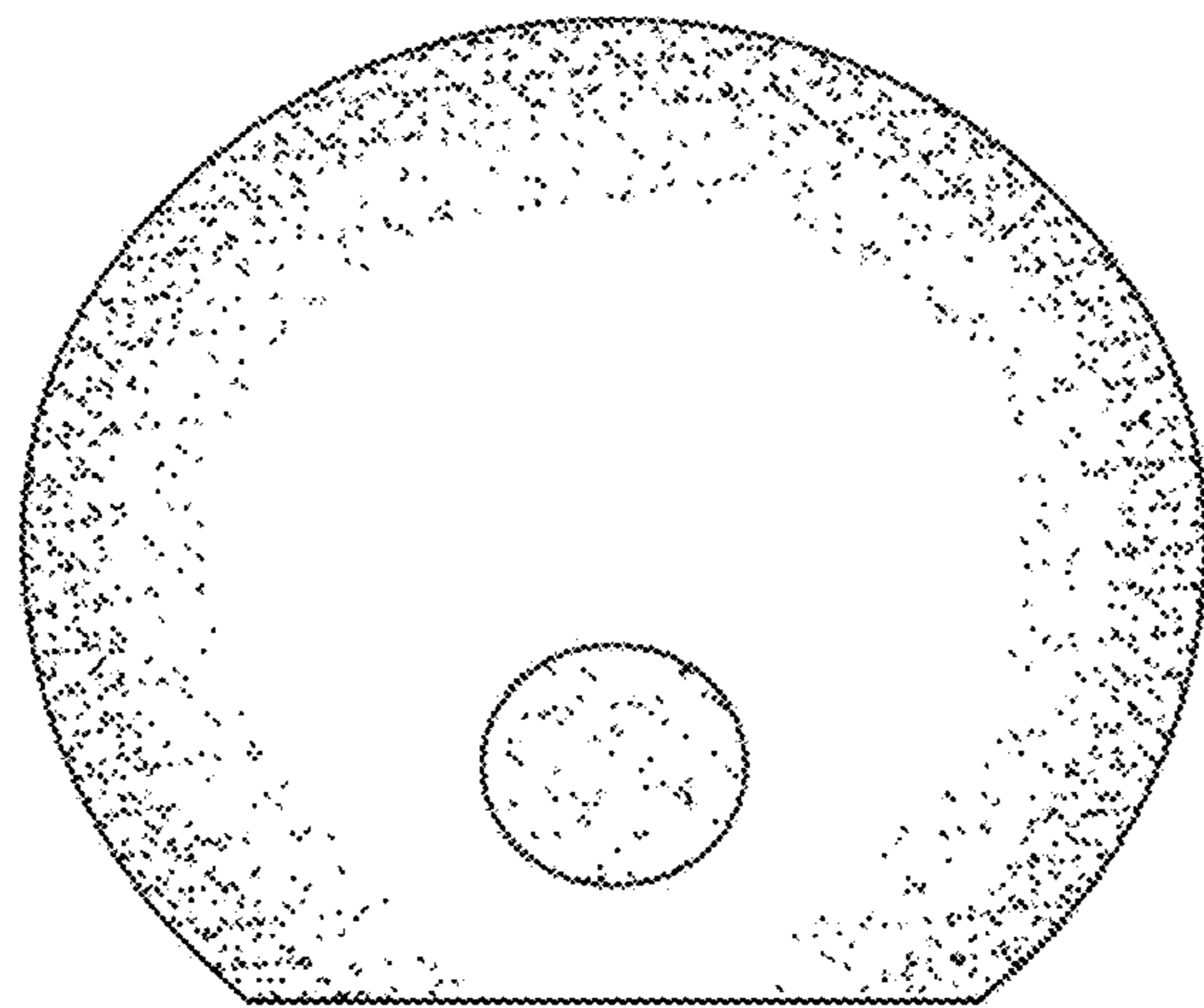

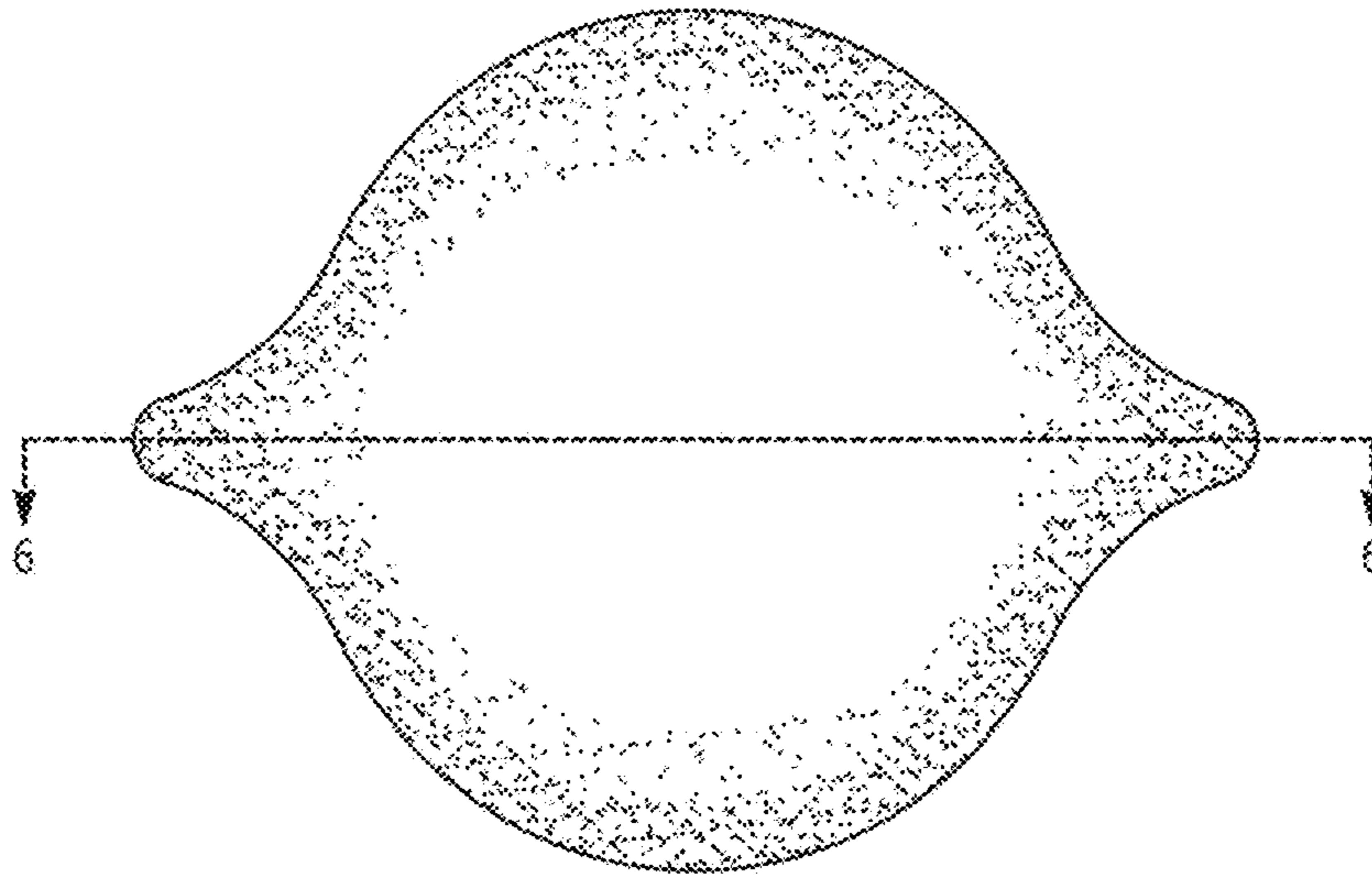

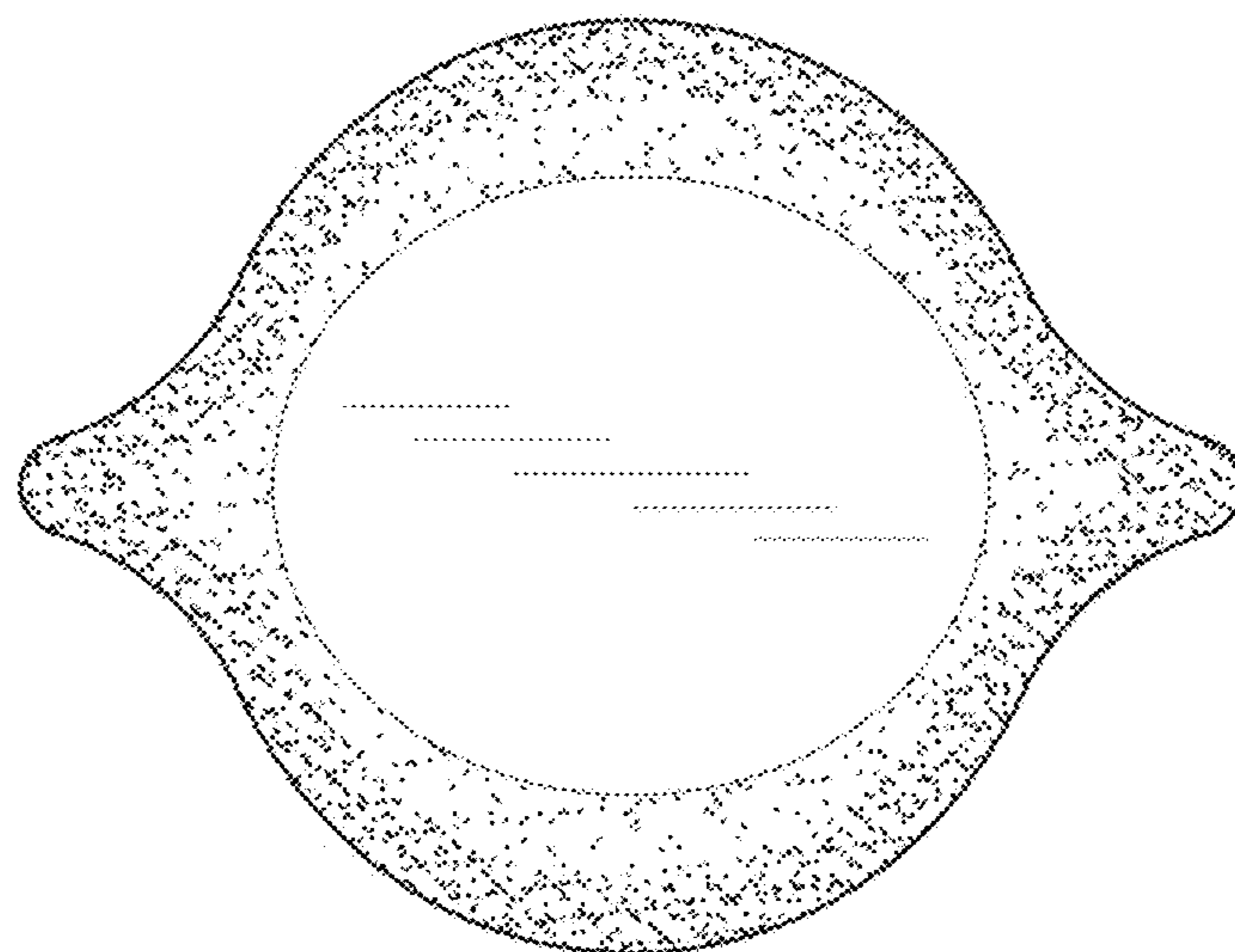

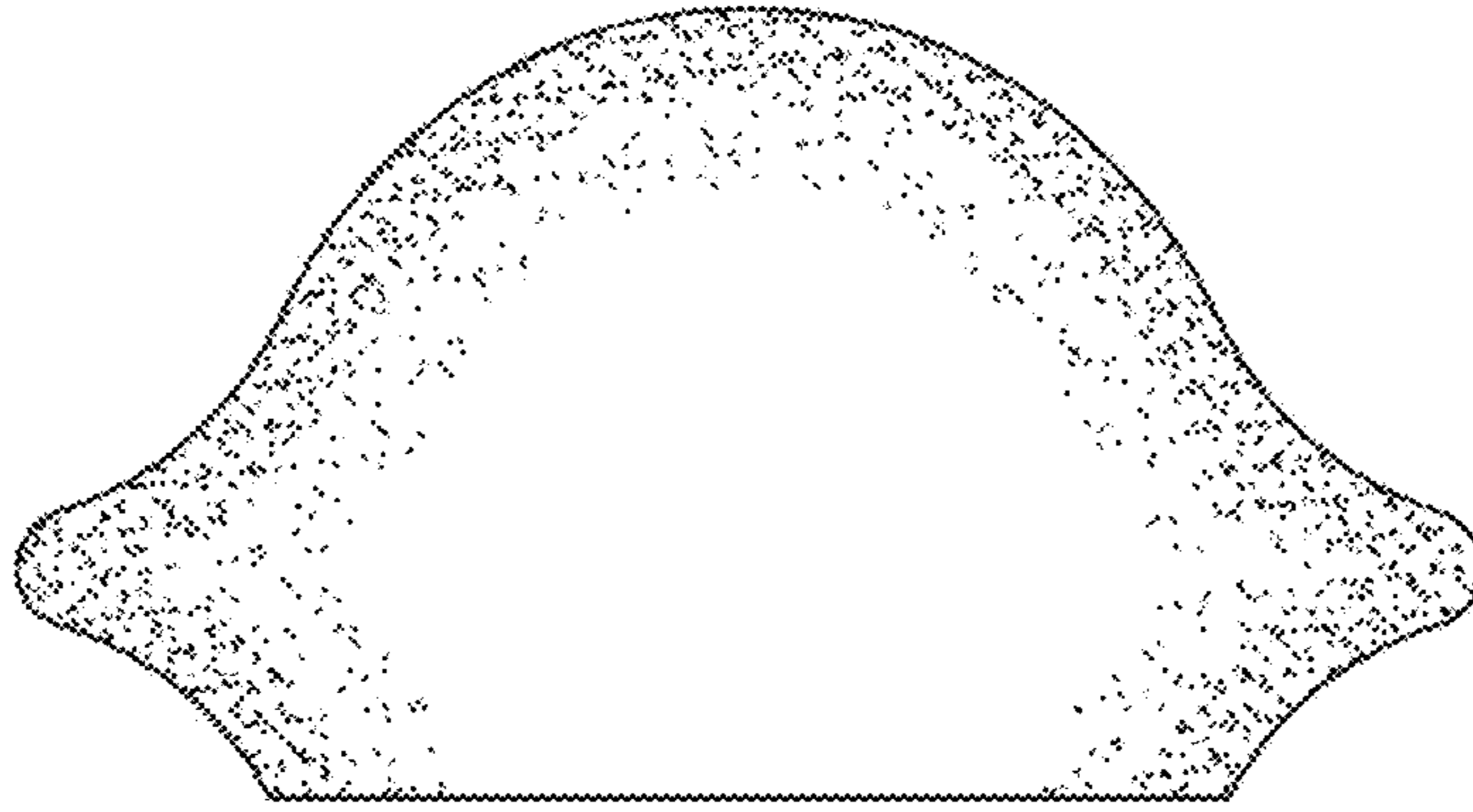

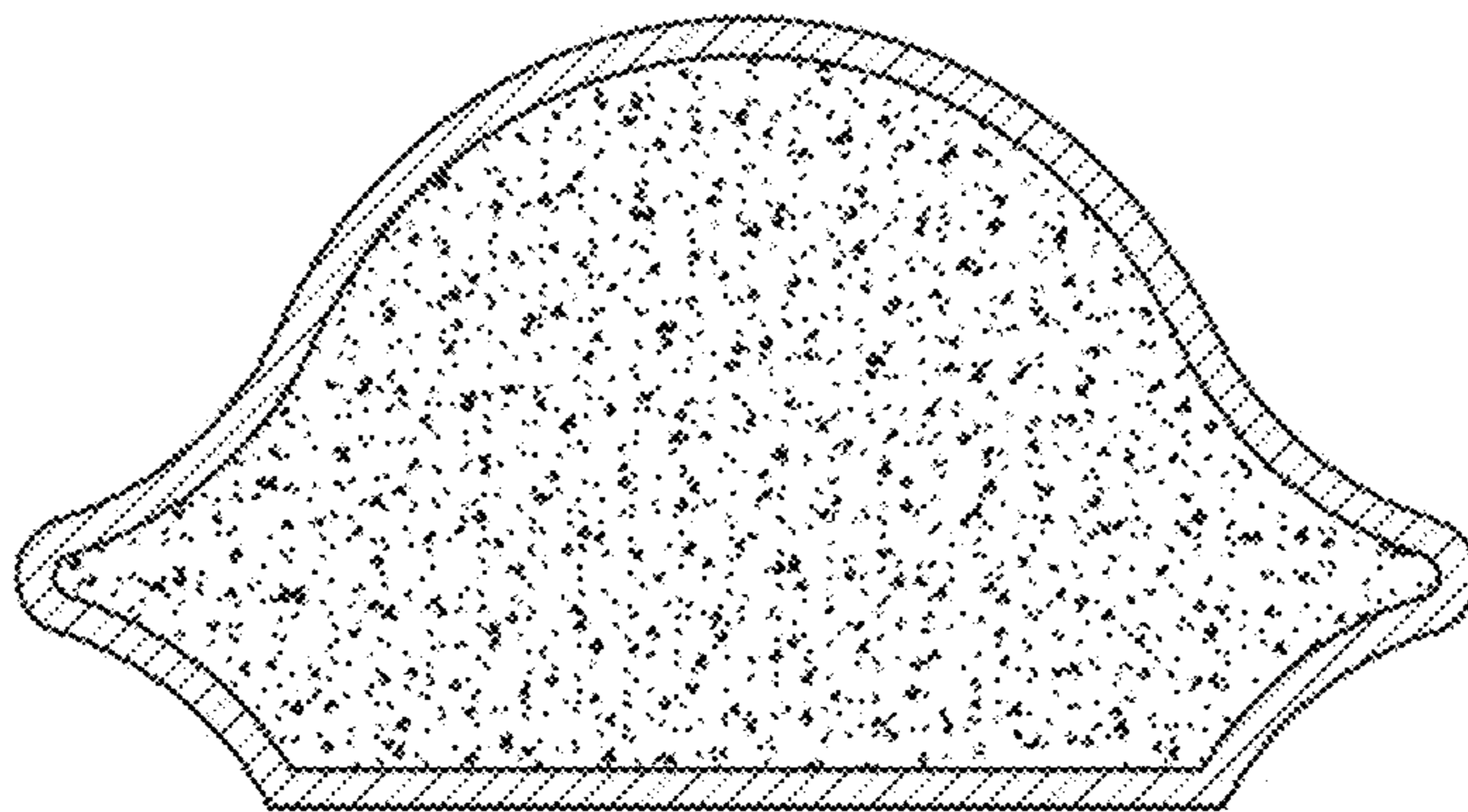
