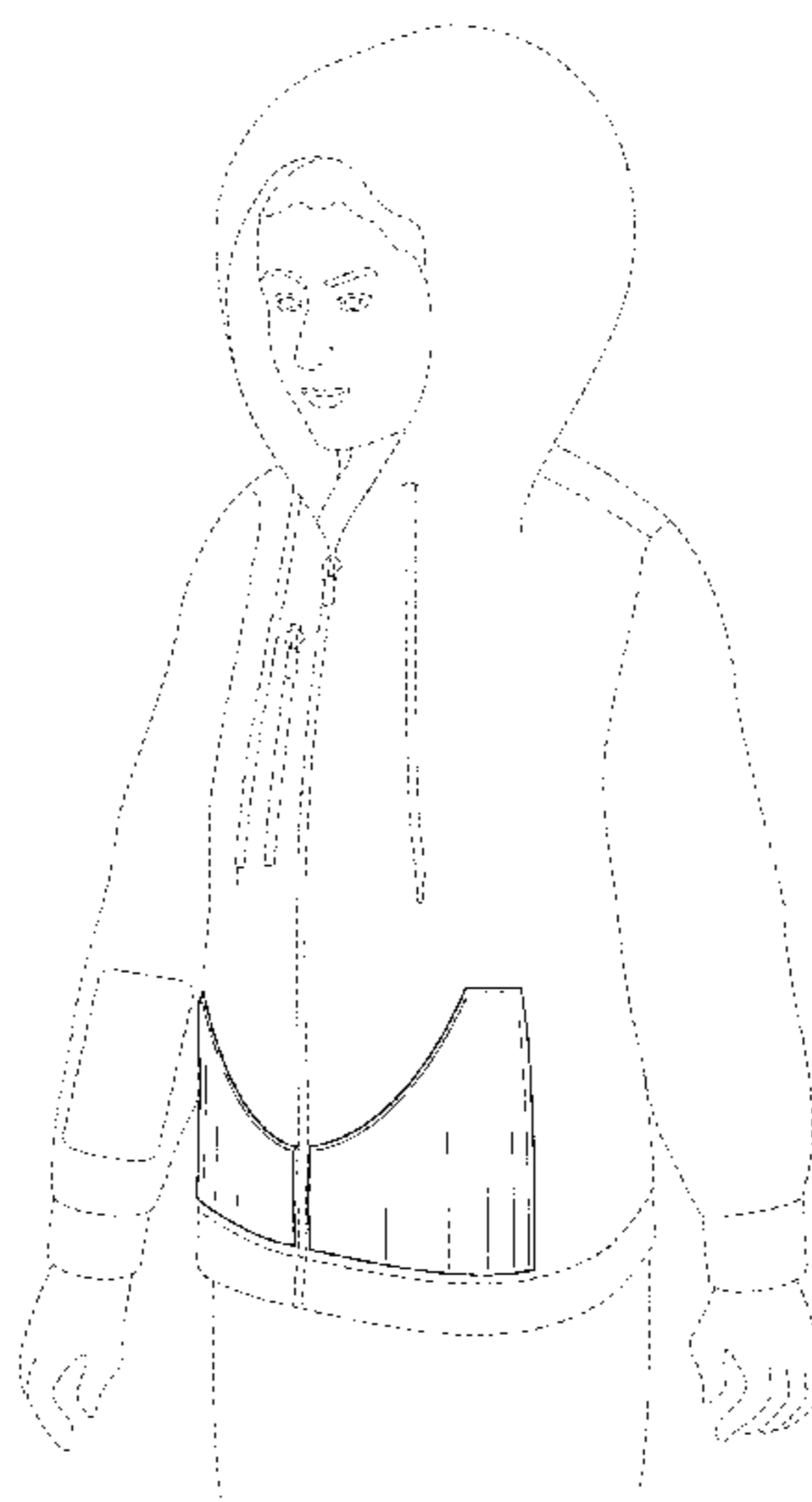

In some implementations, the environmental subject matter, which is not directed to claimed subject matter, includes a sweatshirt, jacket, or hoodie.

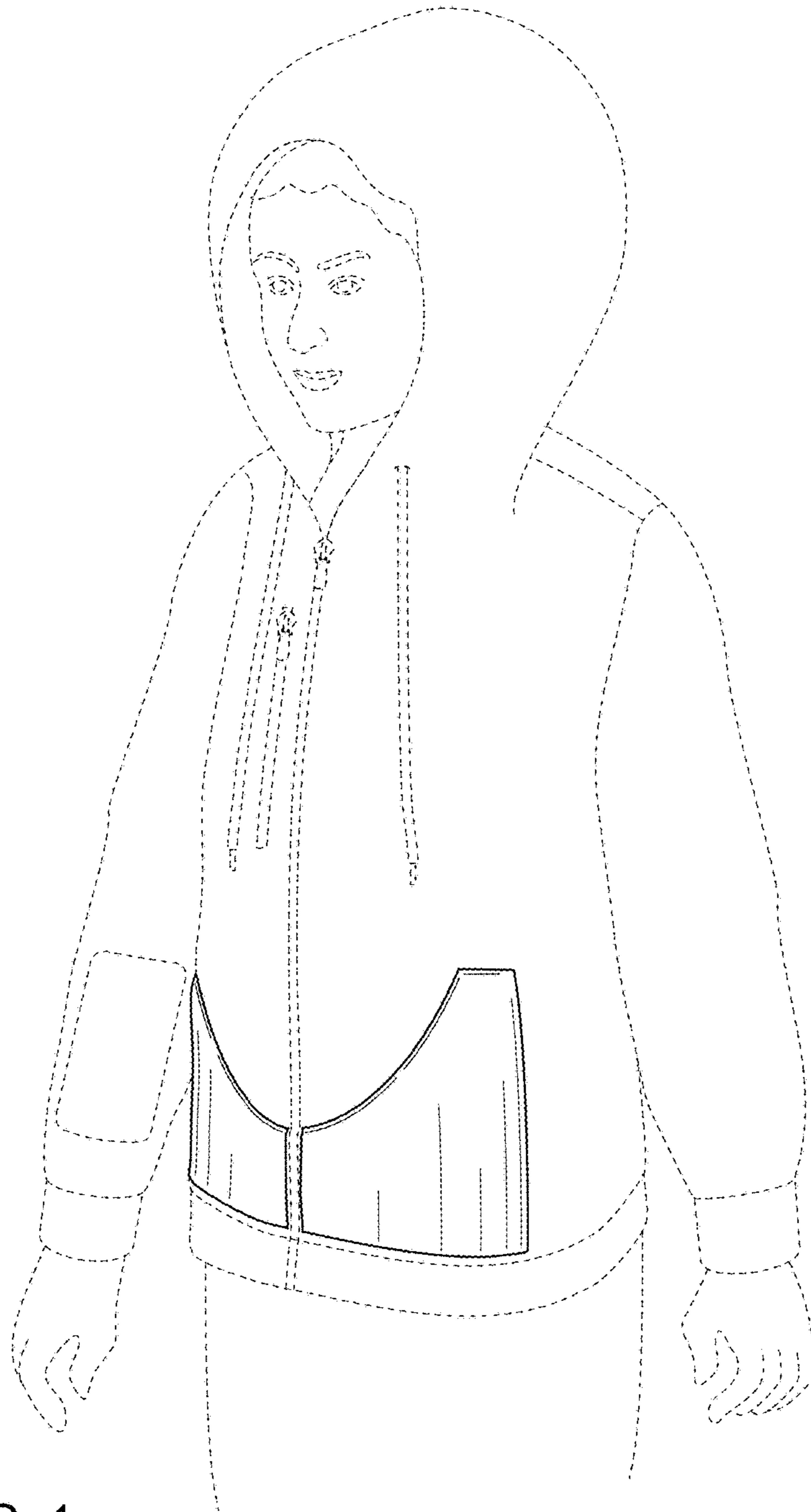

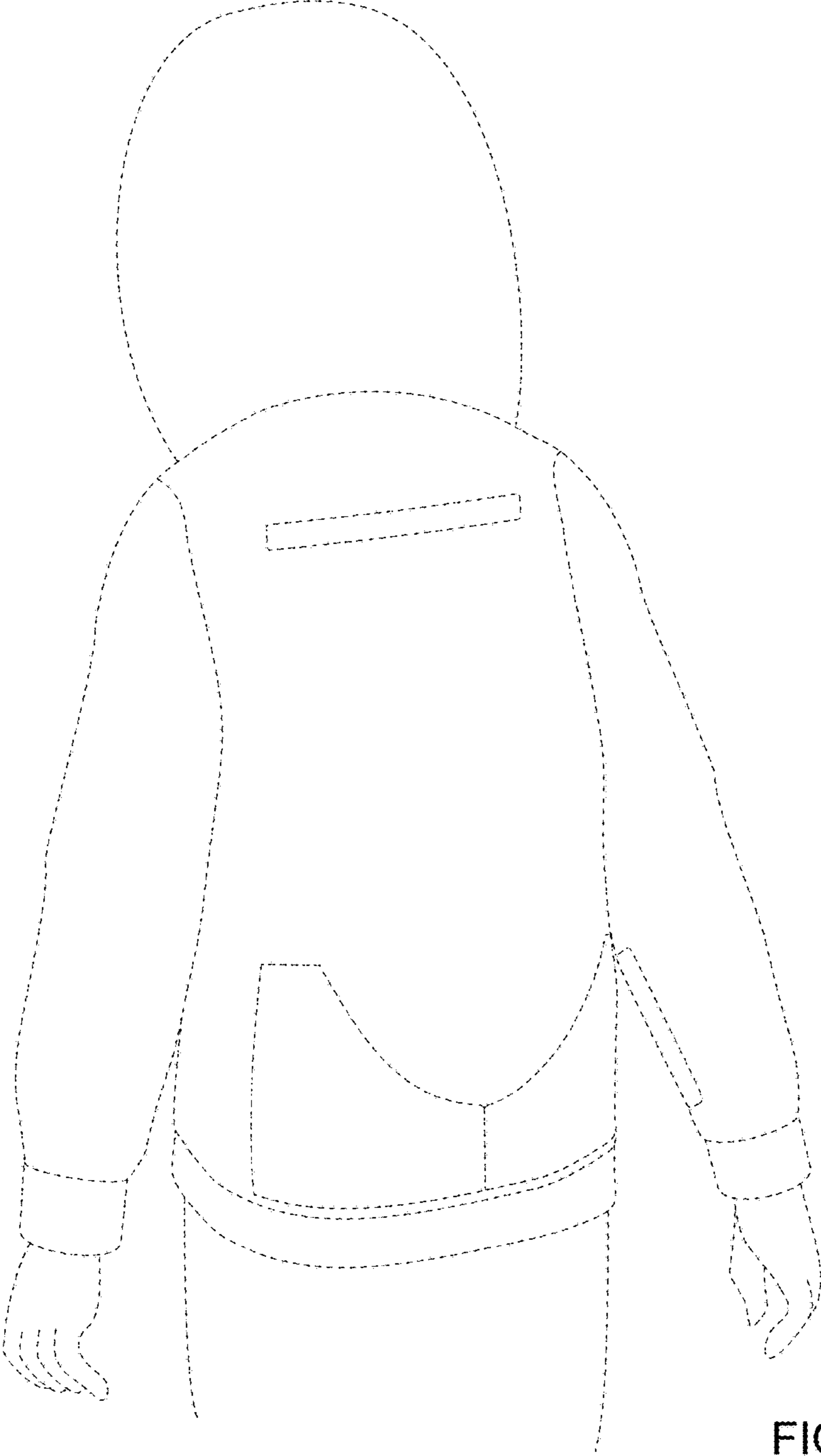

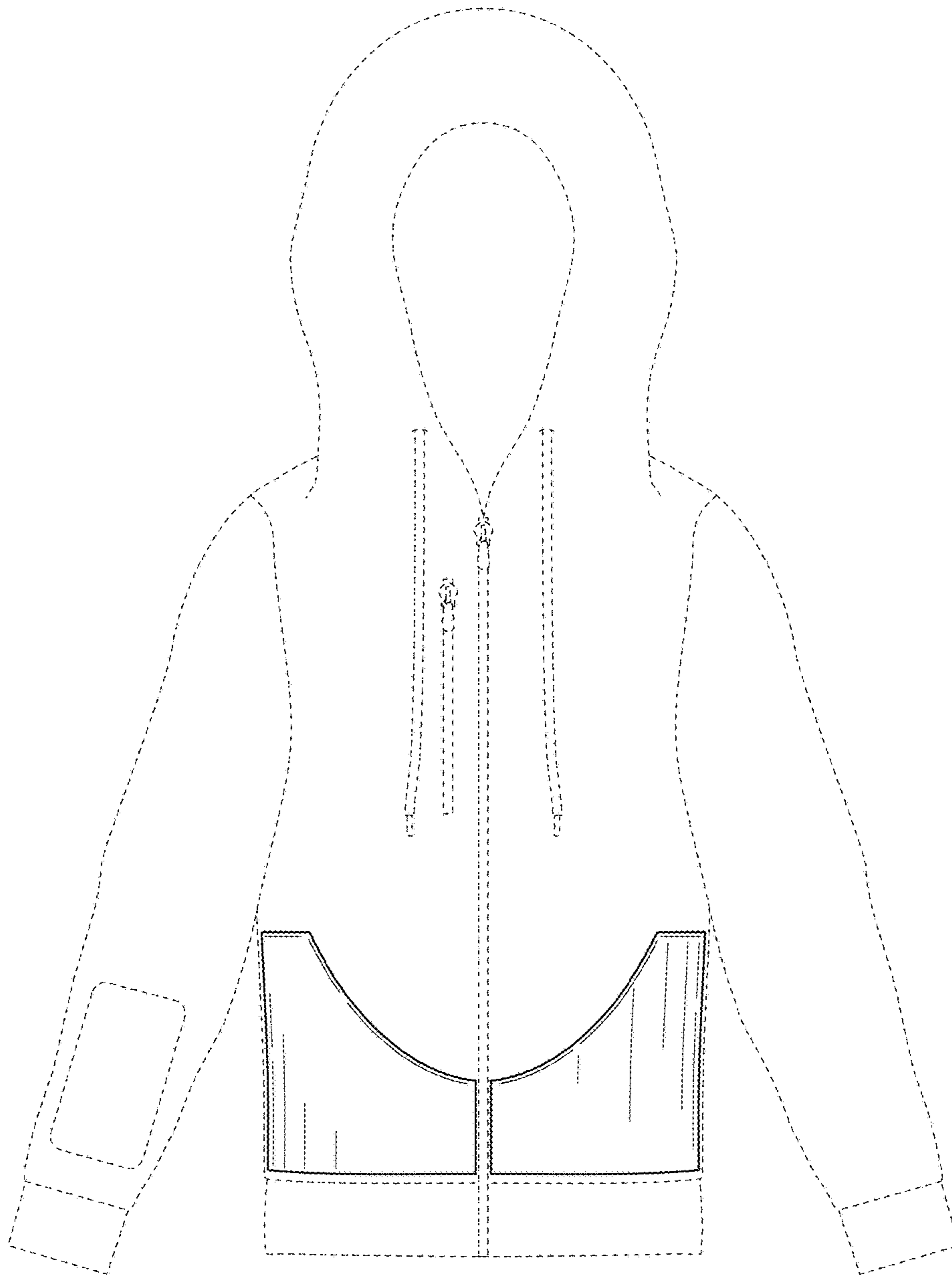

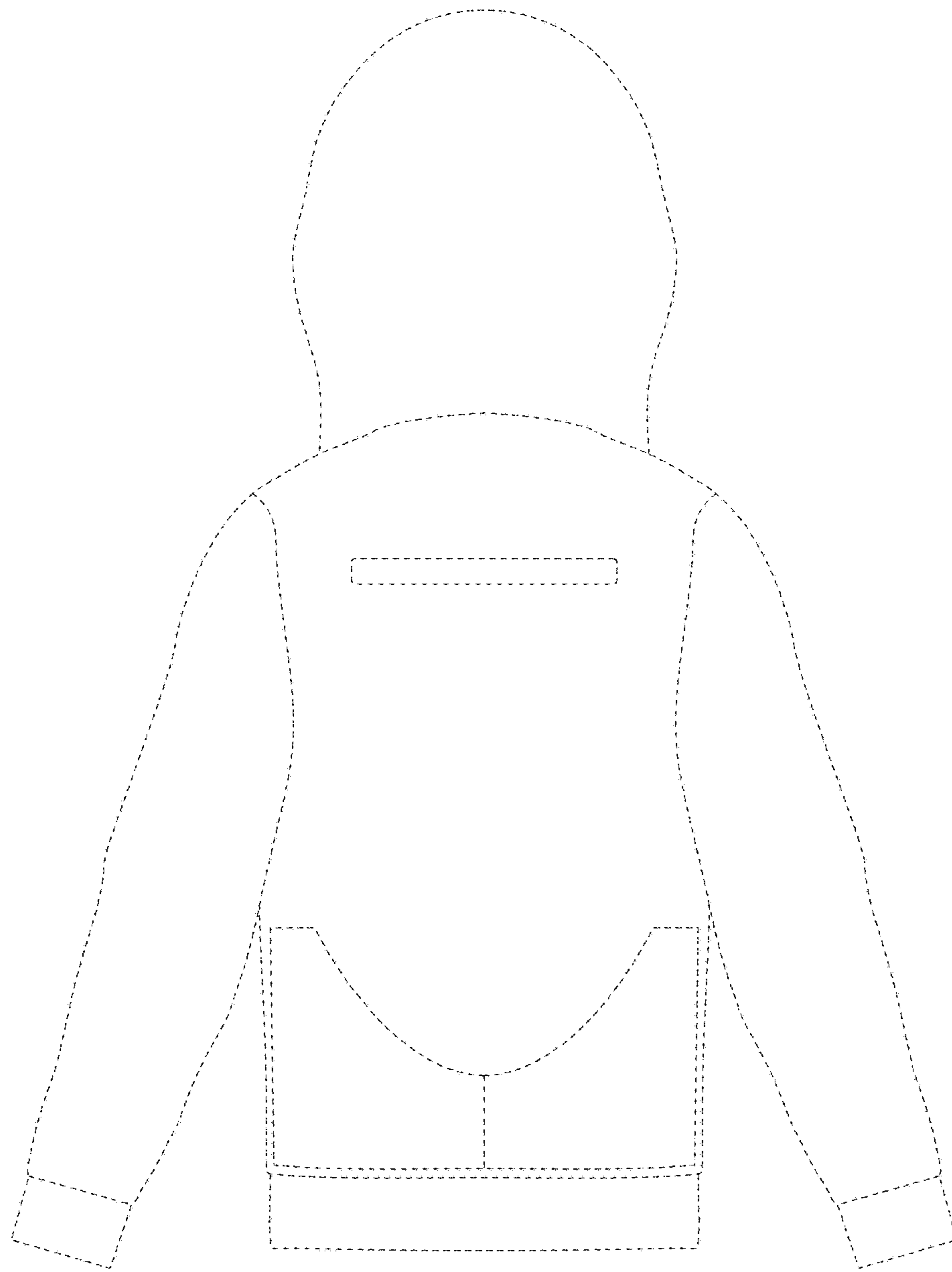

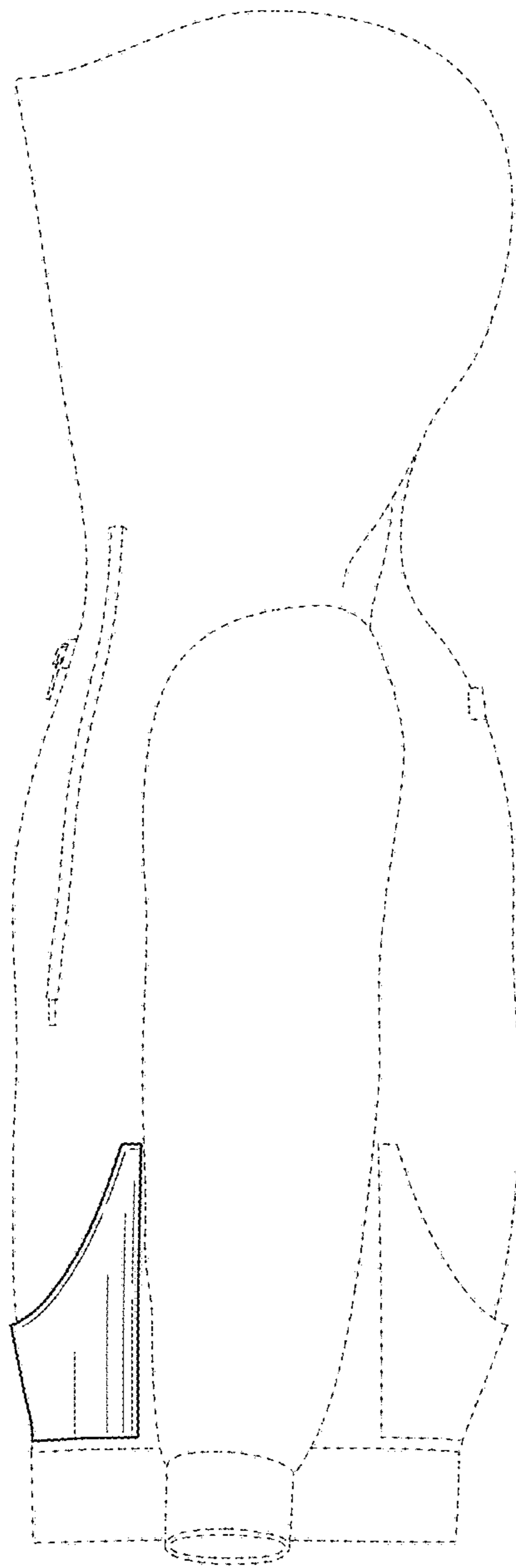

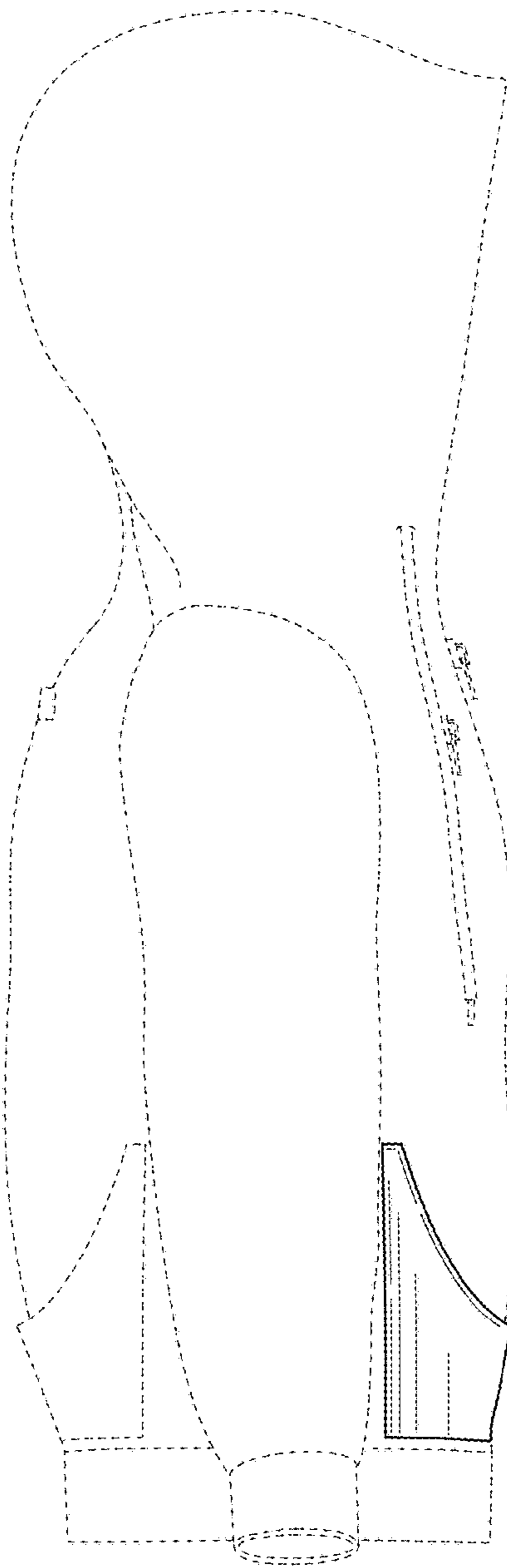

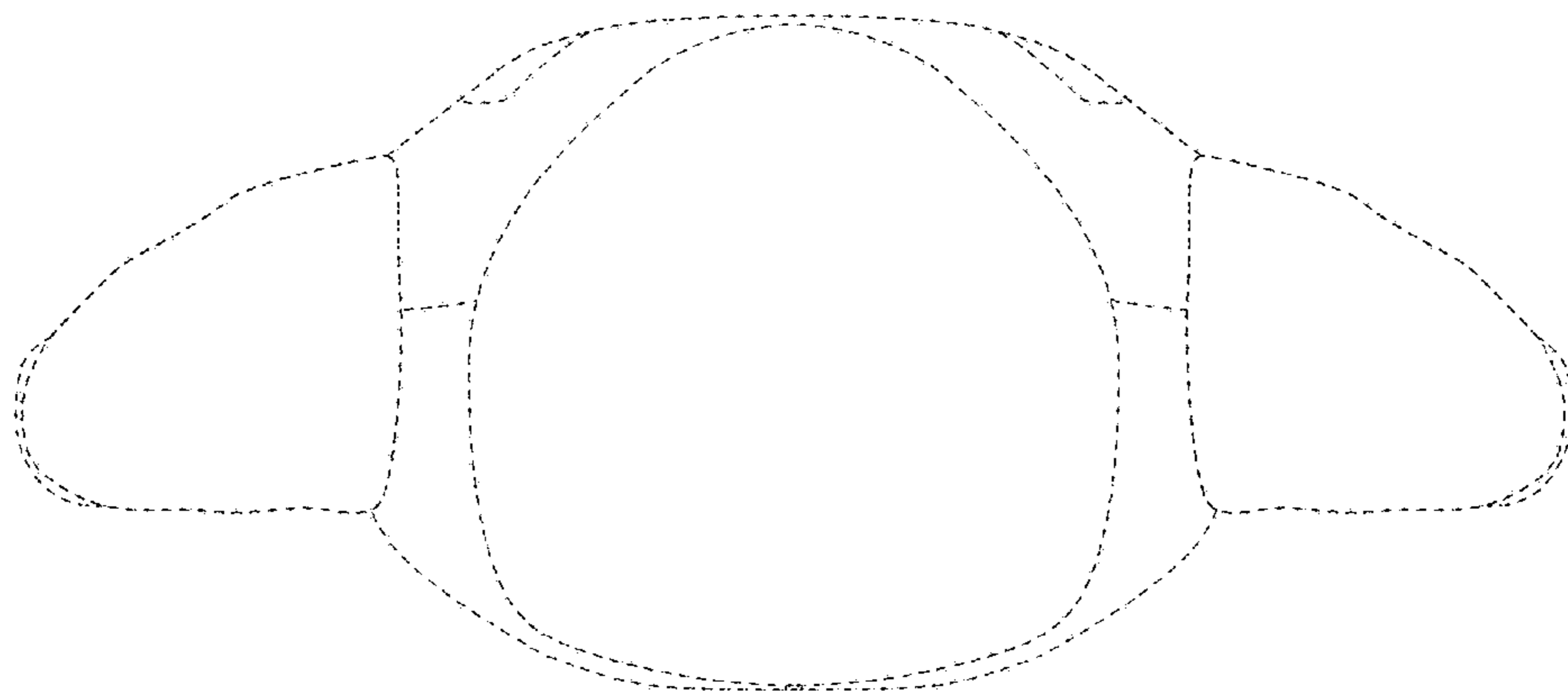

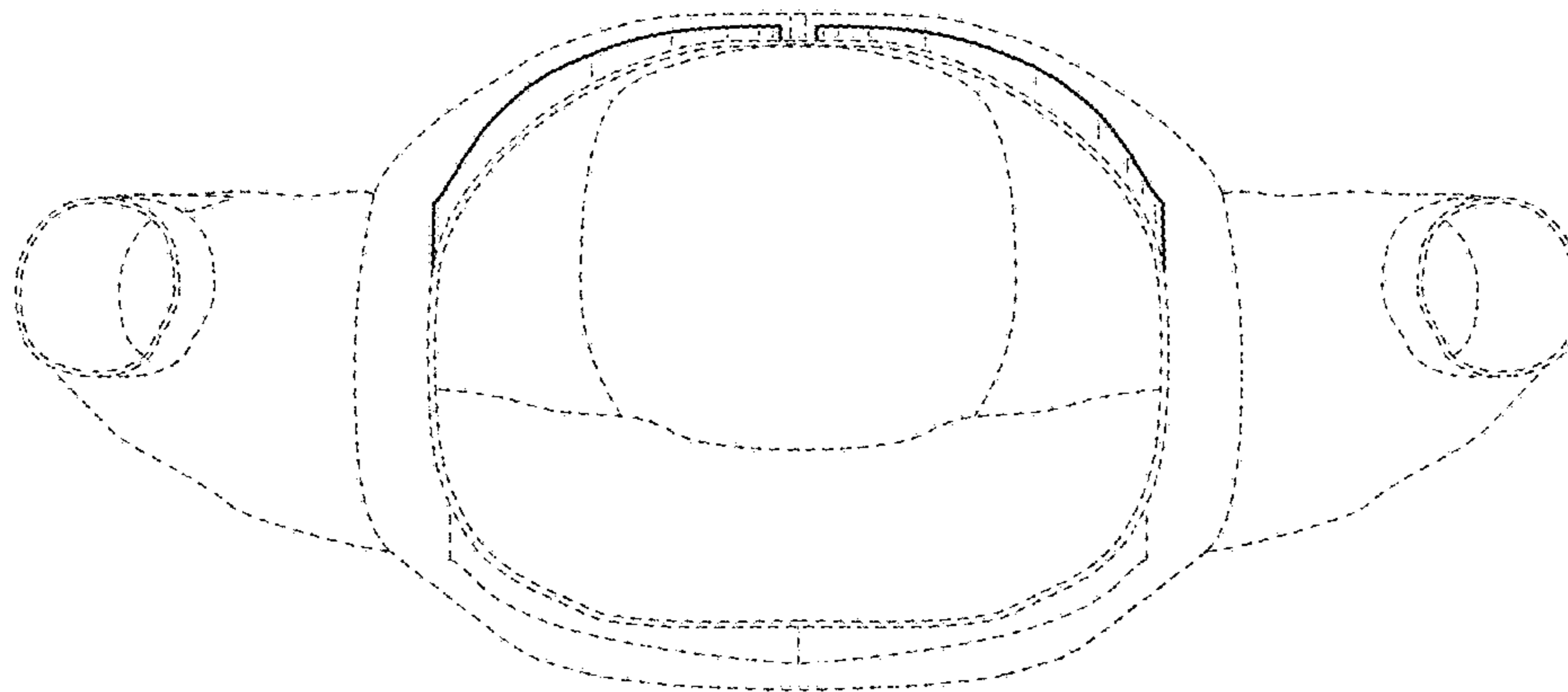

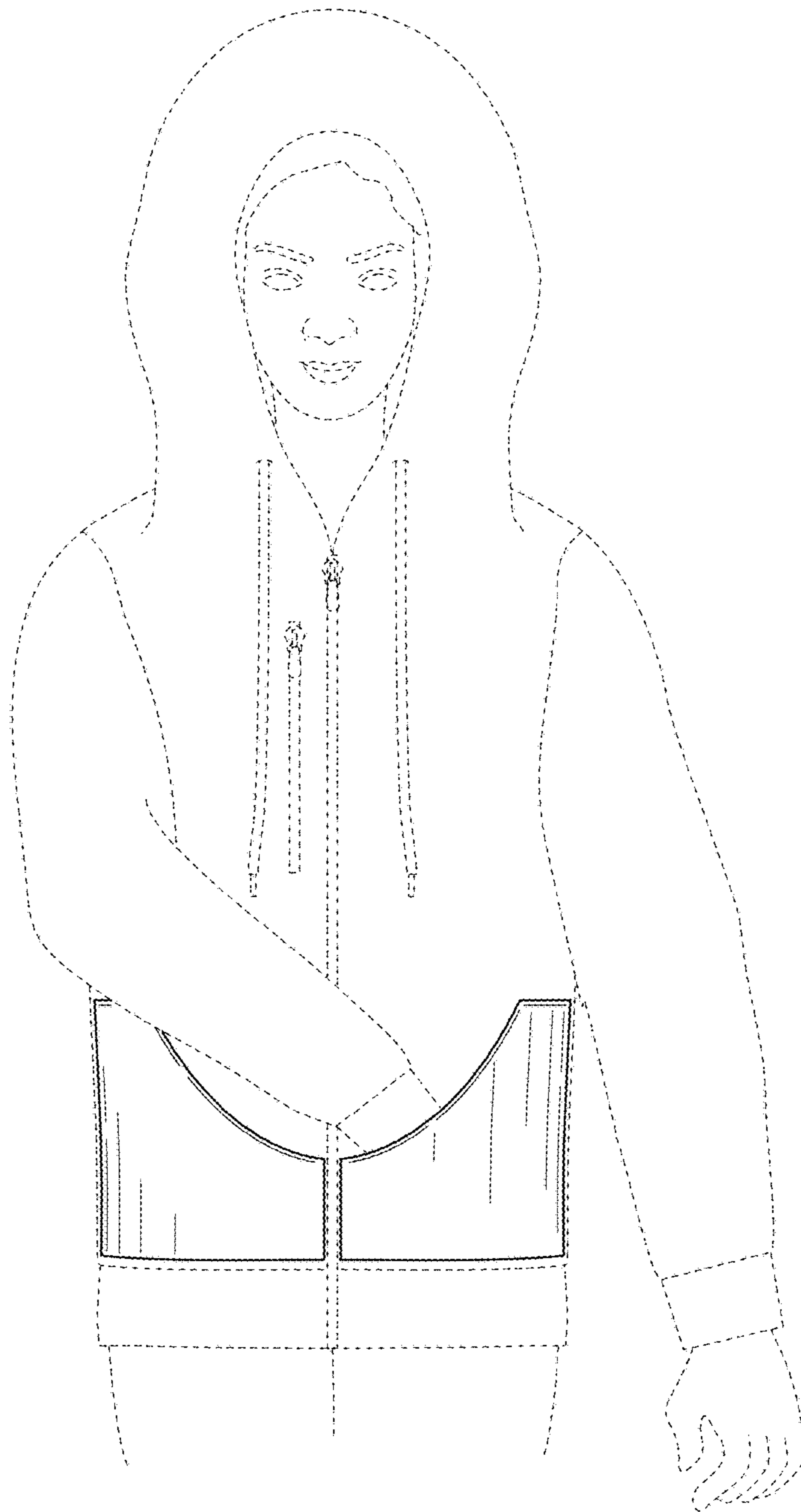

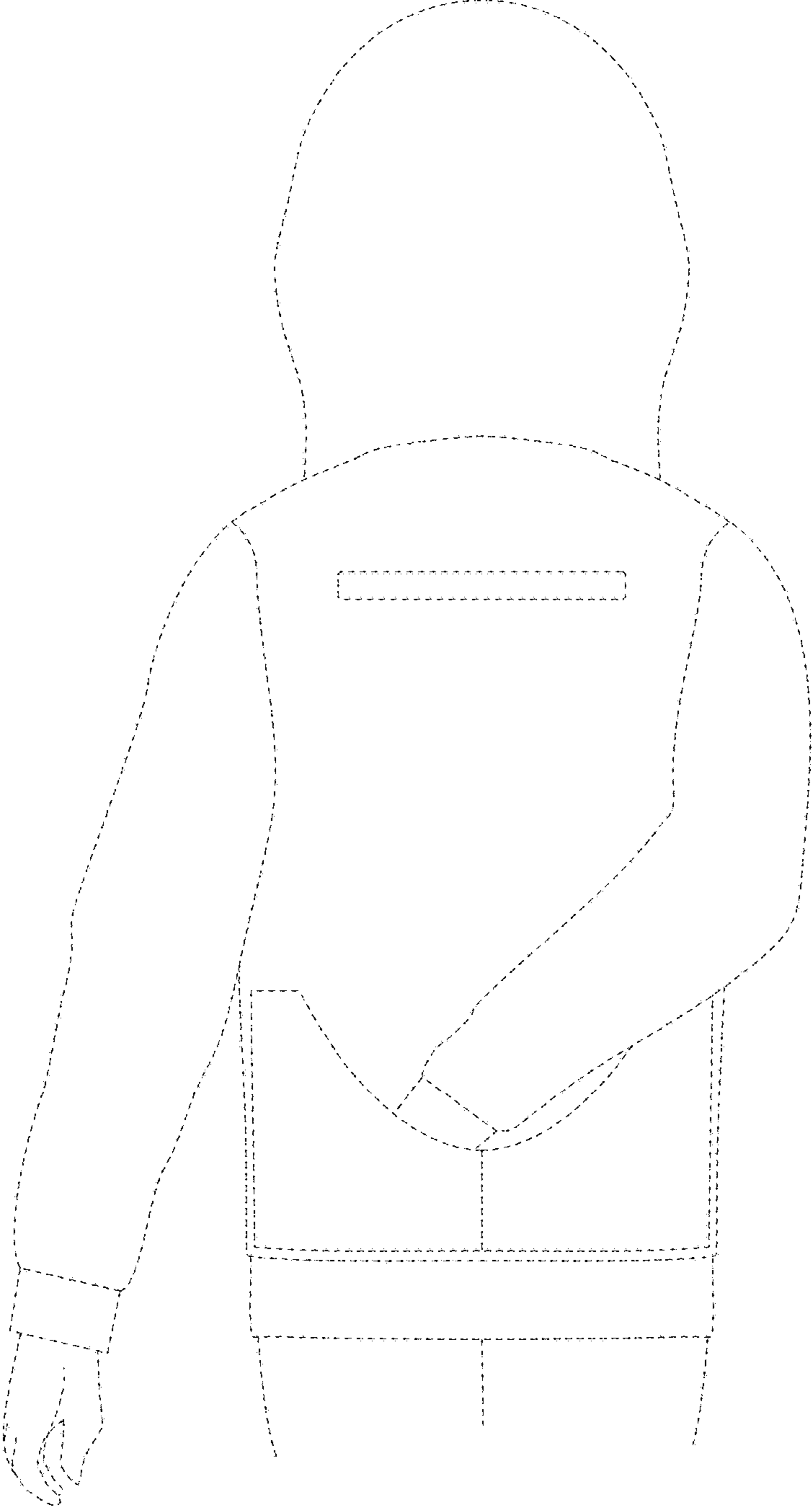
