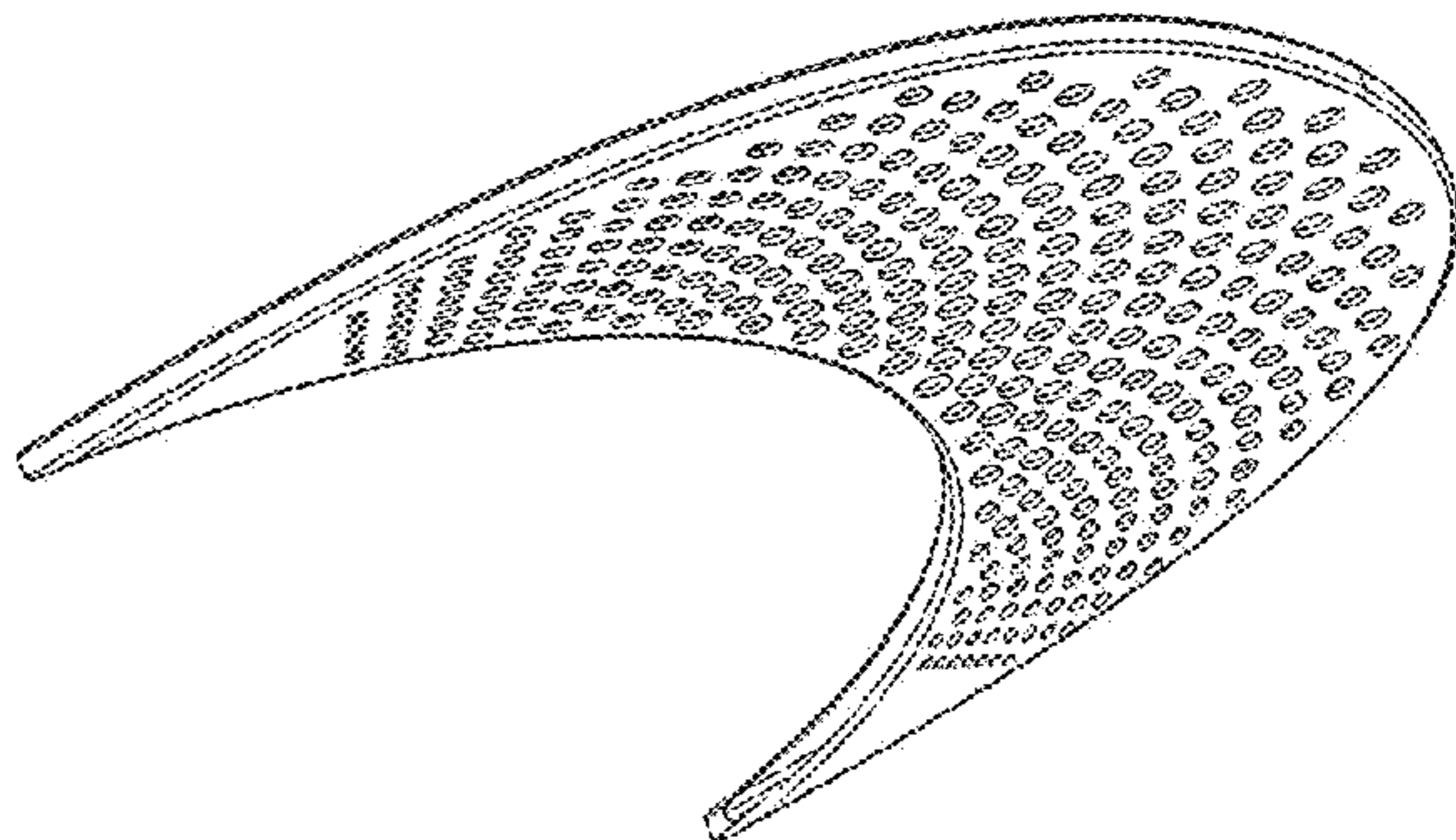
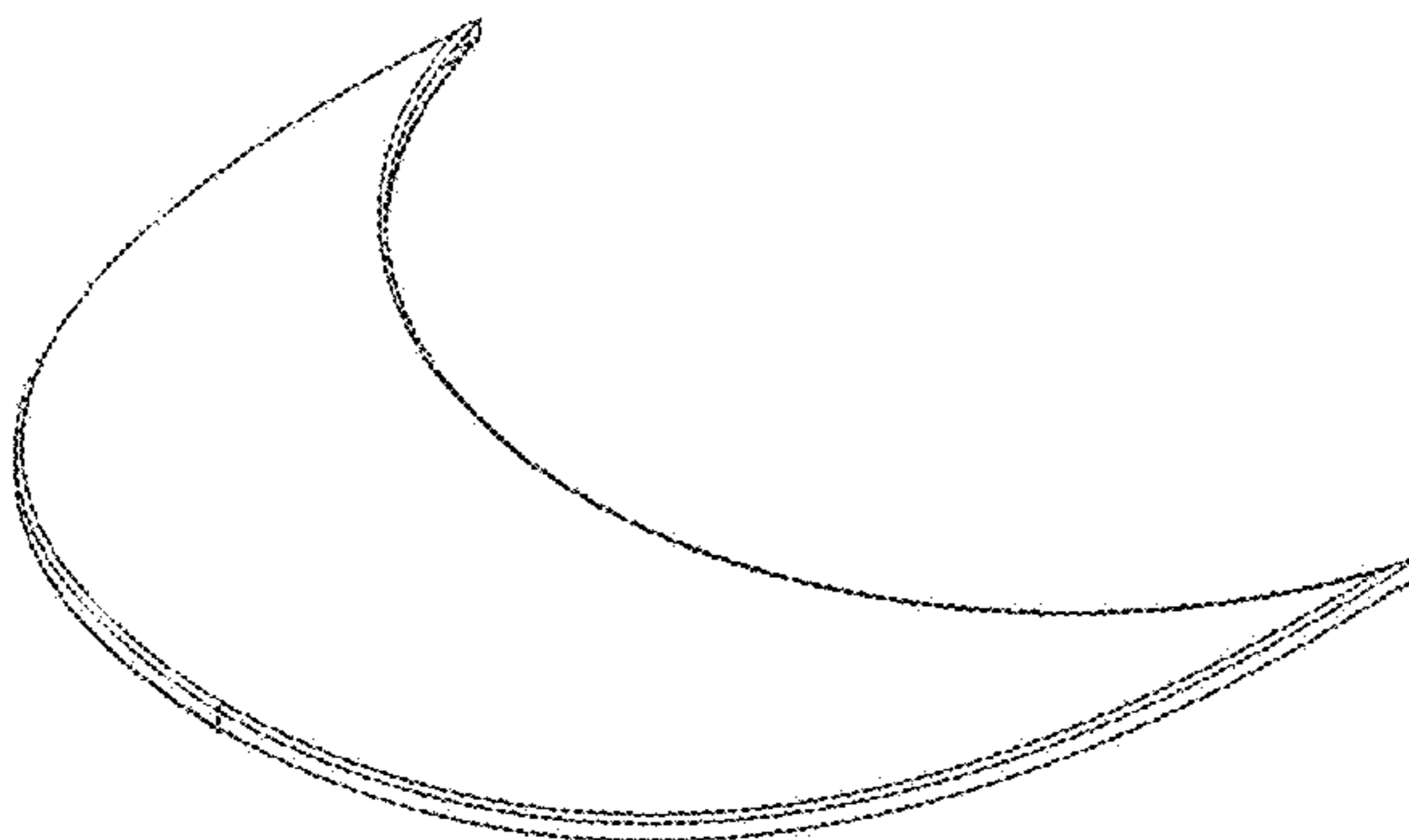
(57) **CLAIM**

The ornamental design for sleeve protector for the bill of a hat, as shown and described.

DESCRIPTION

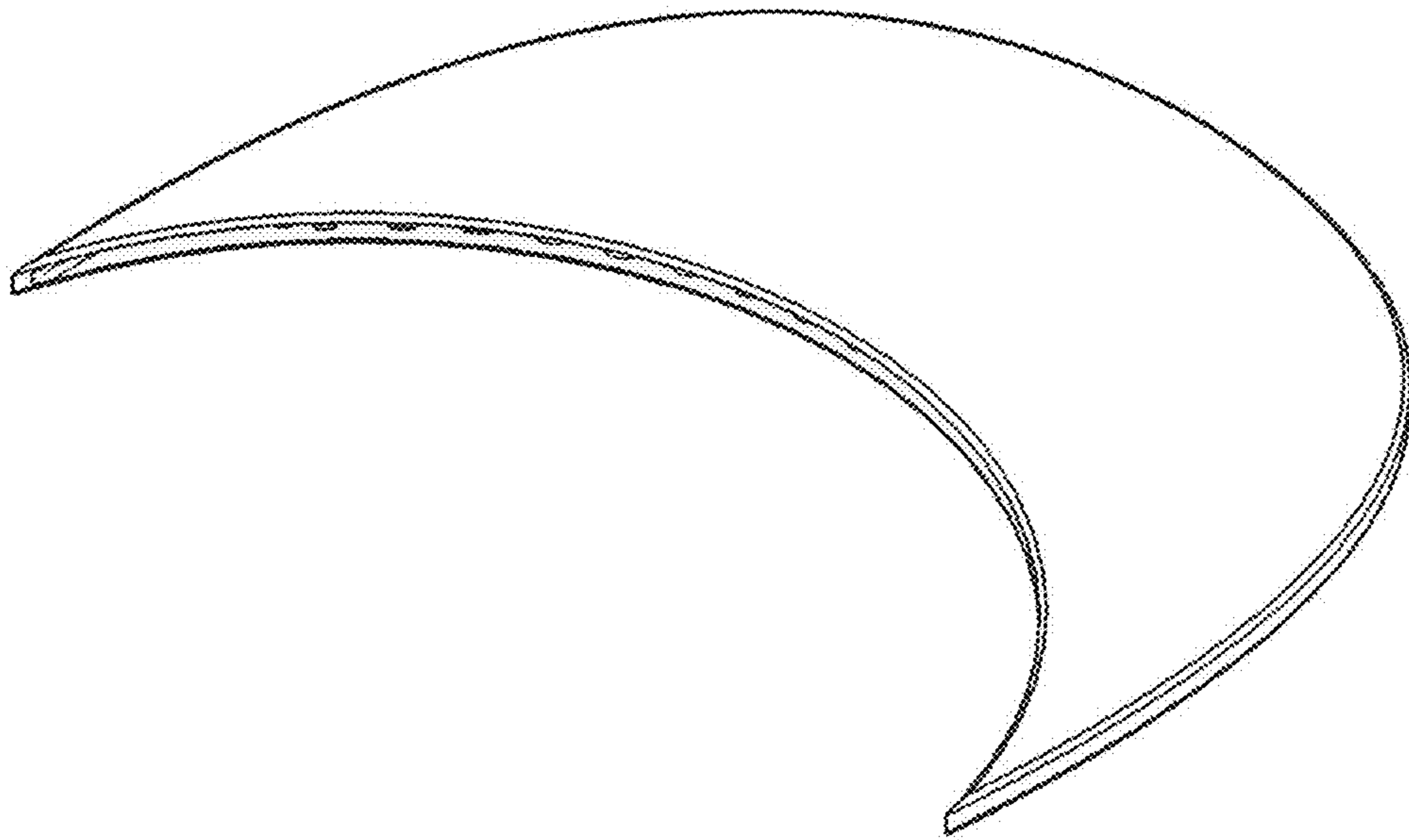

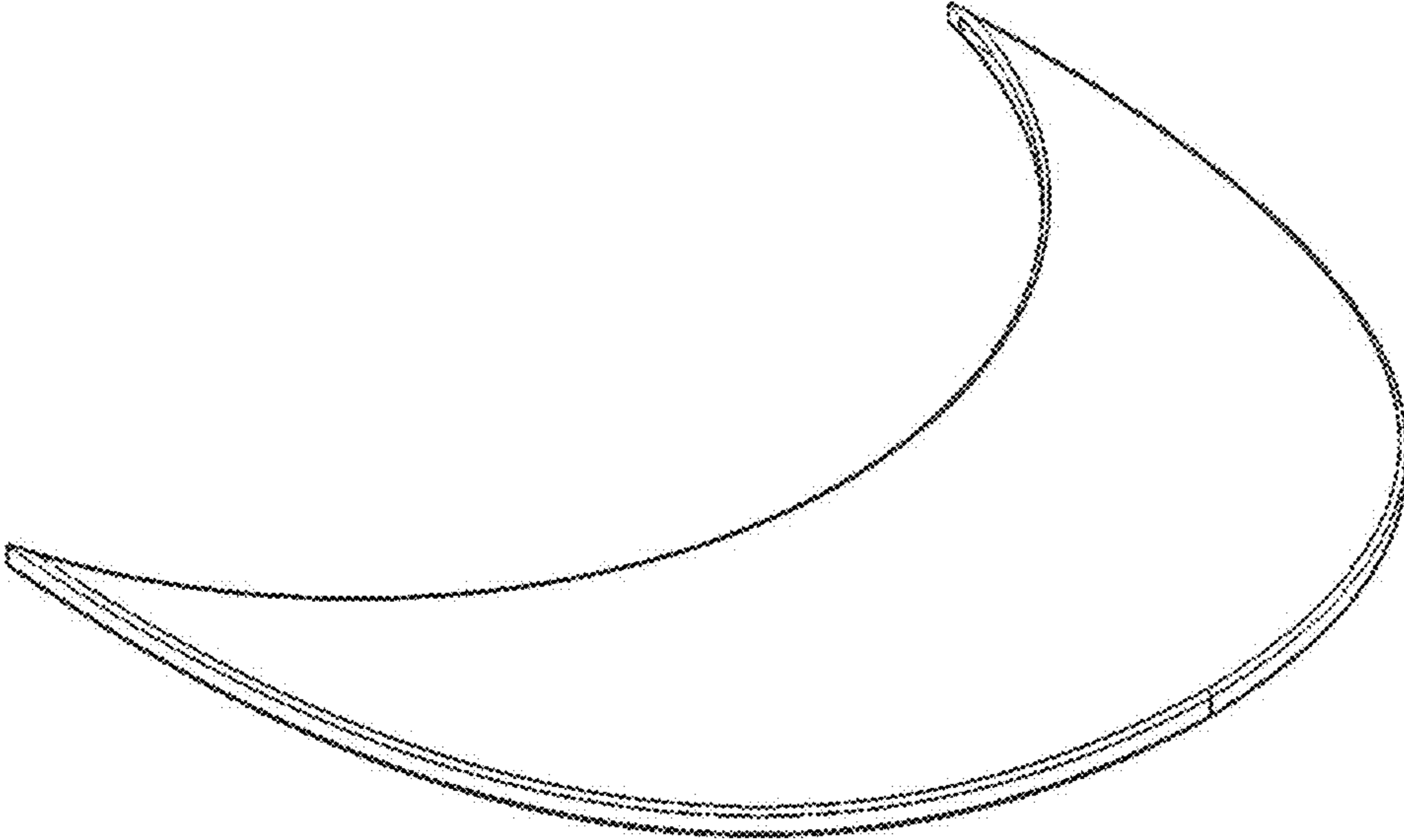

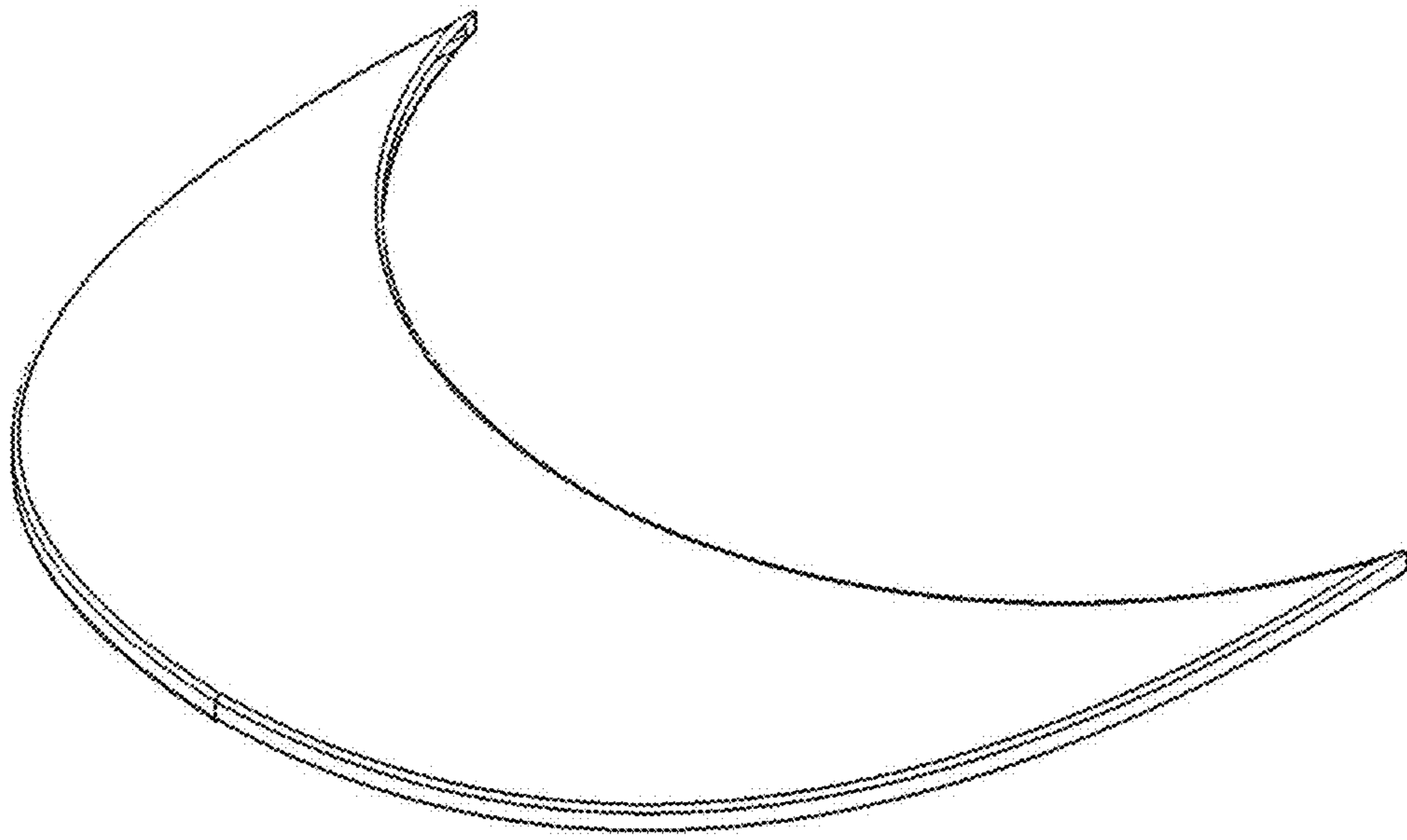

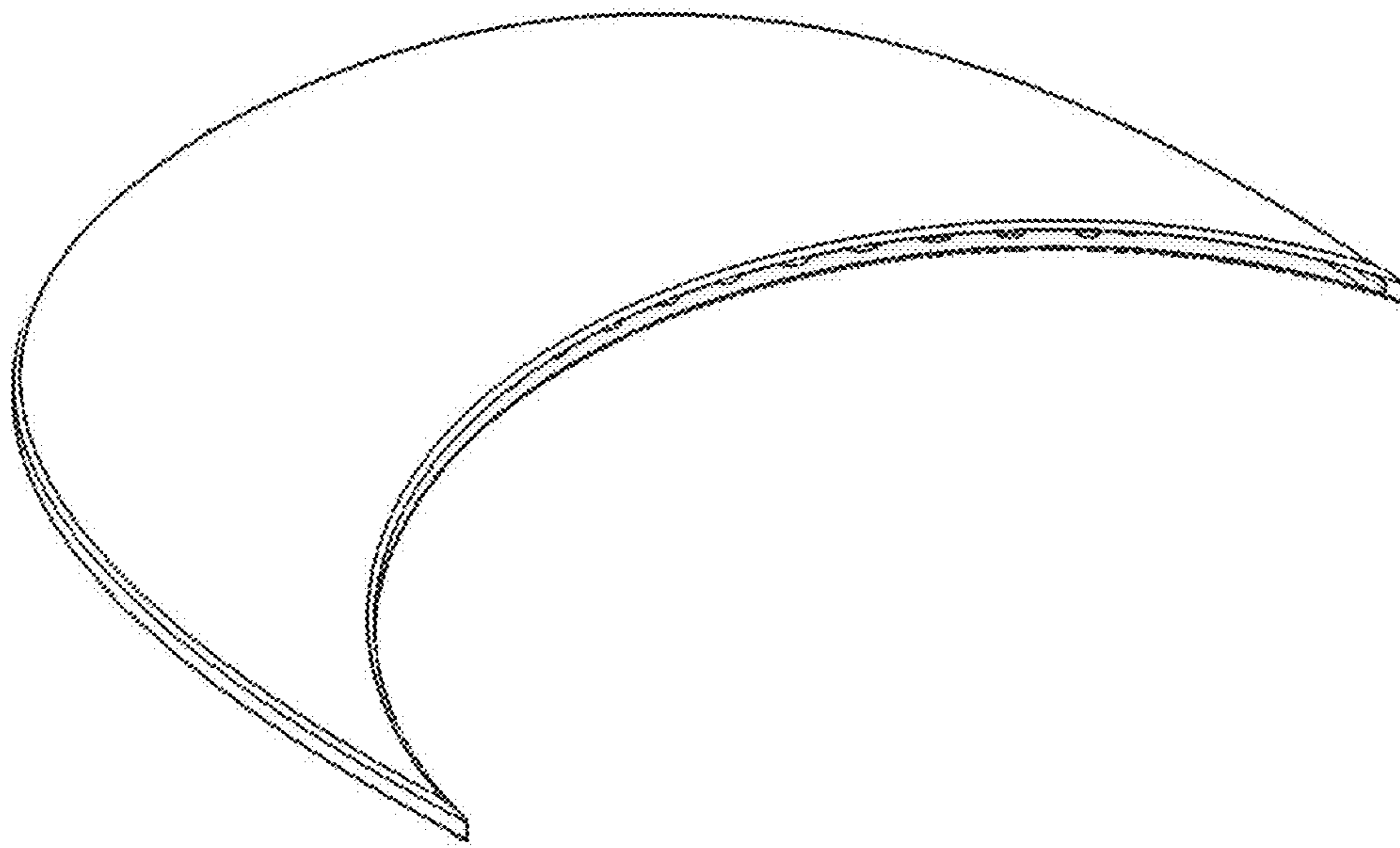

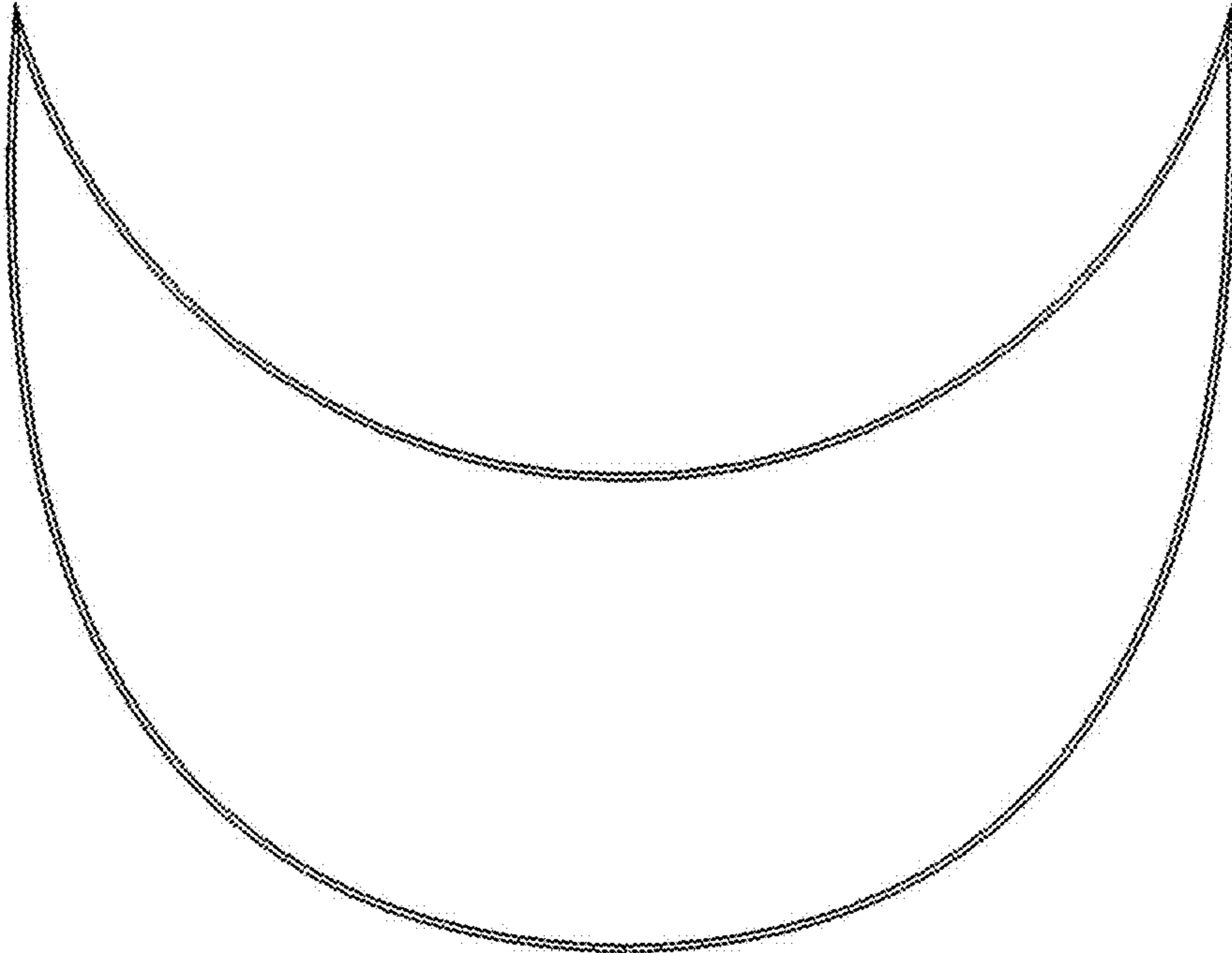

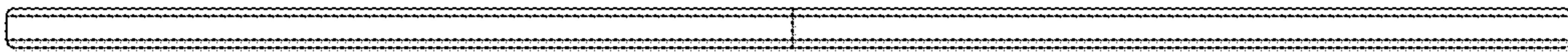

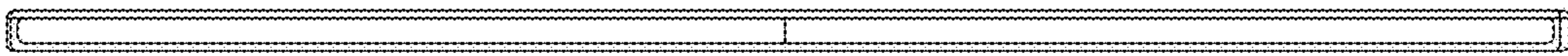

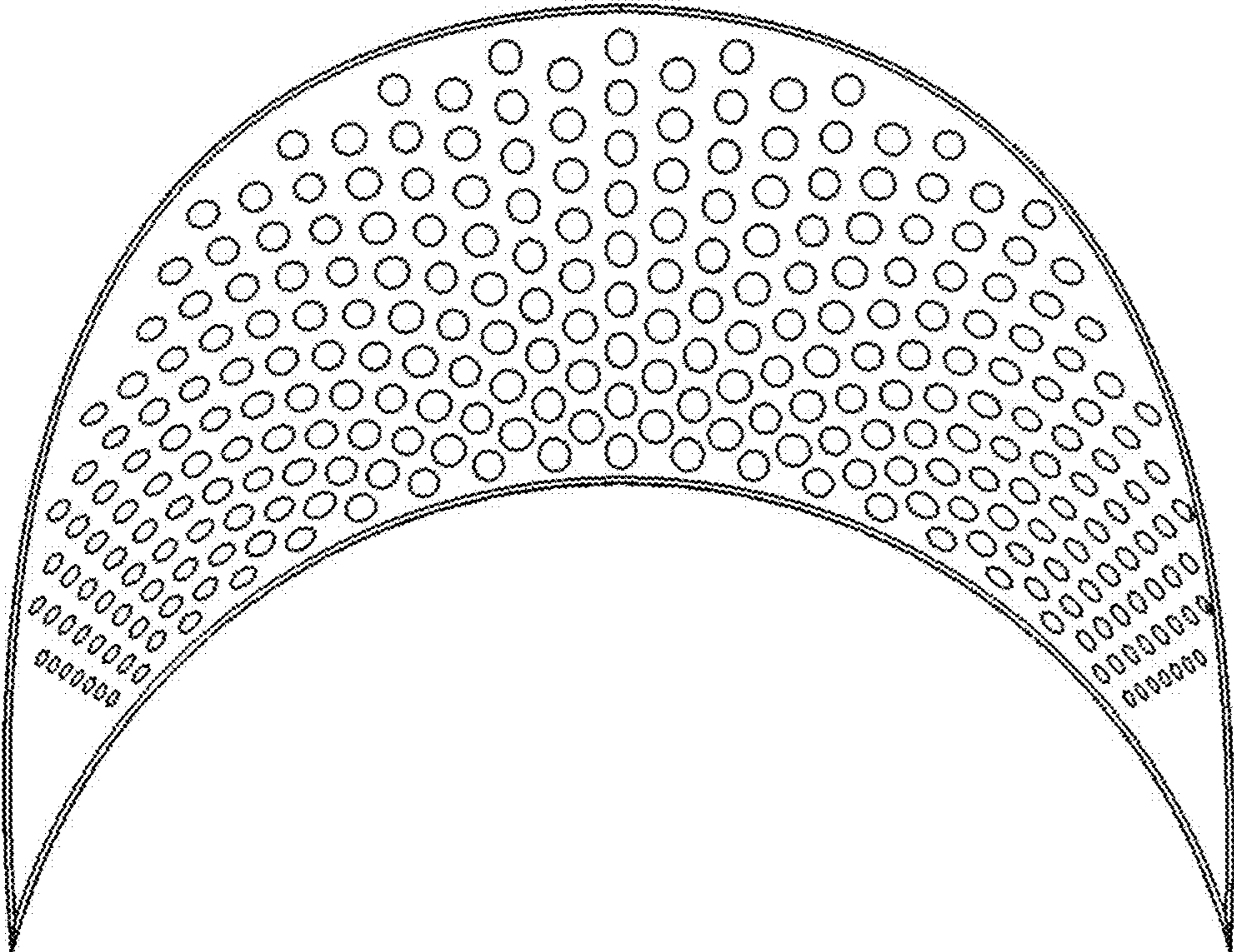

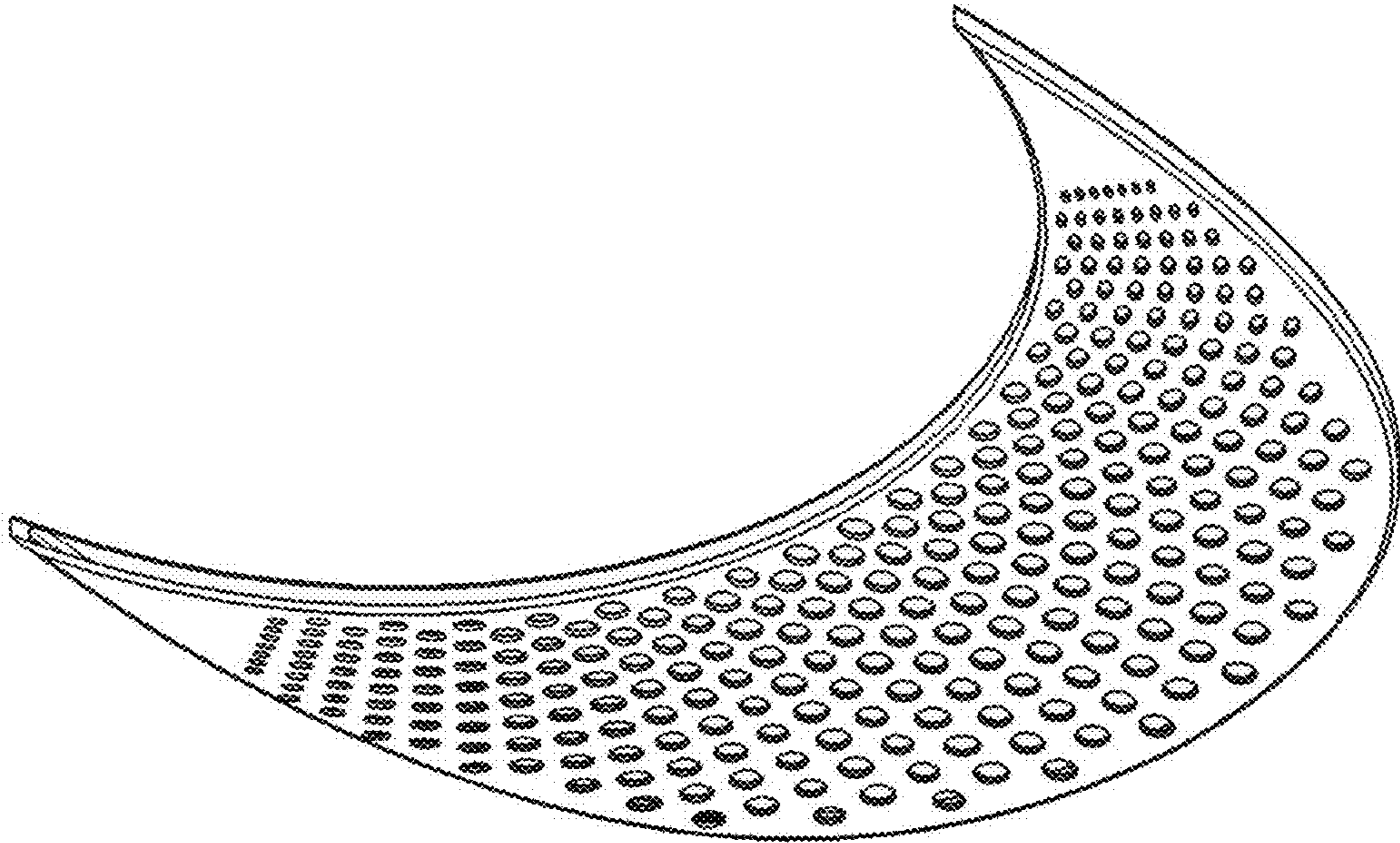

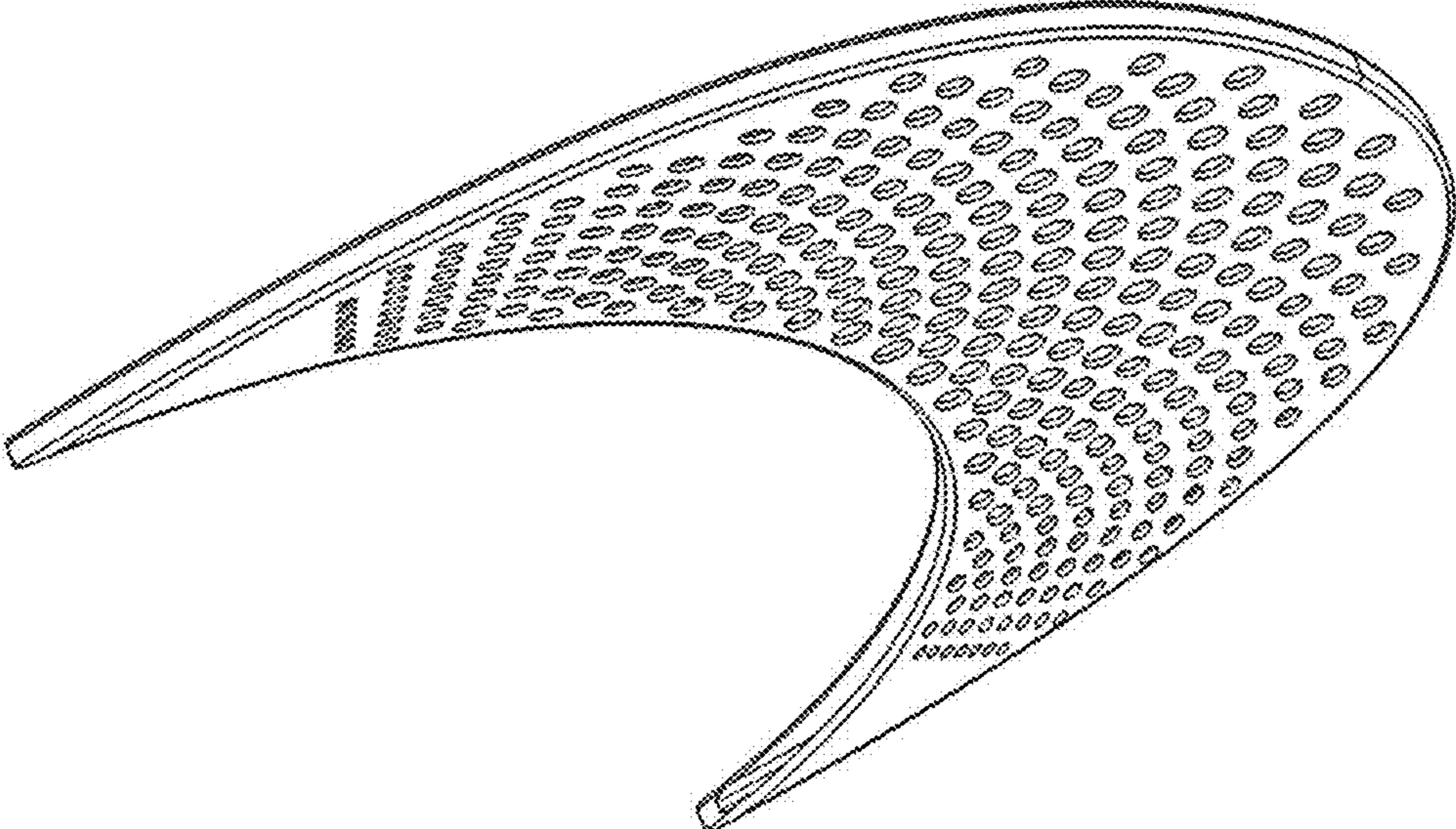

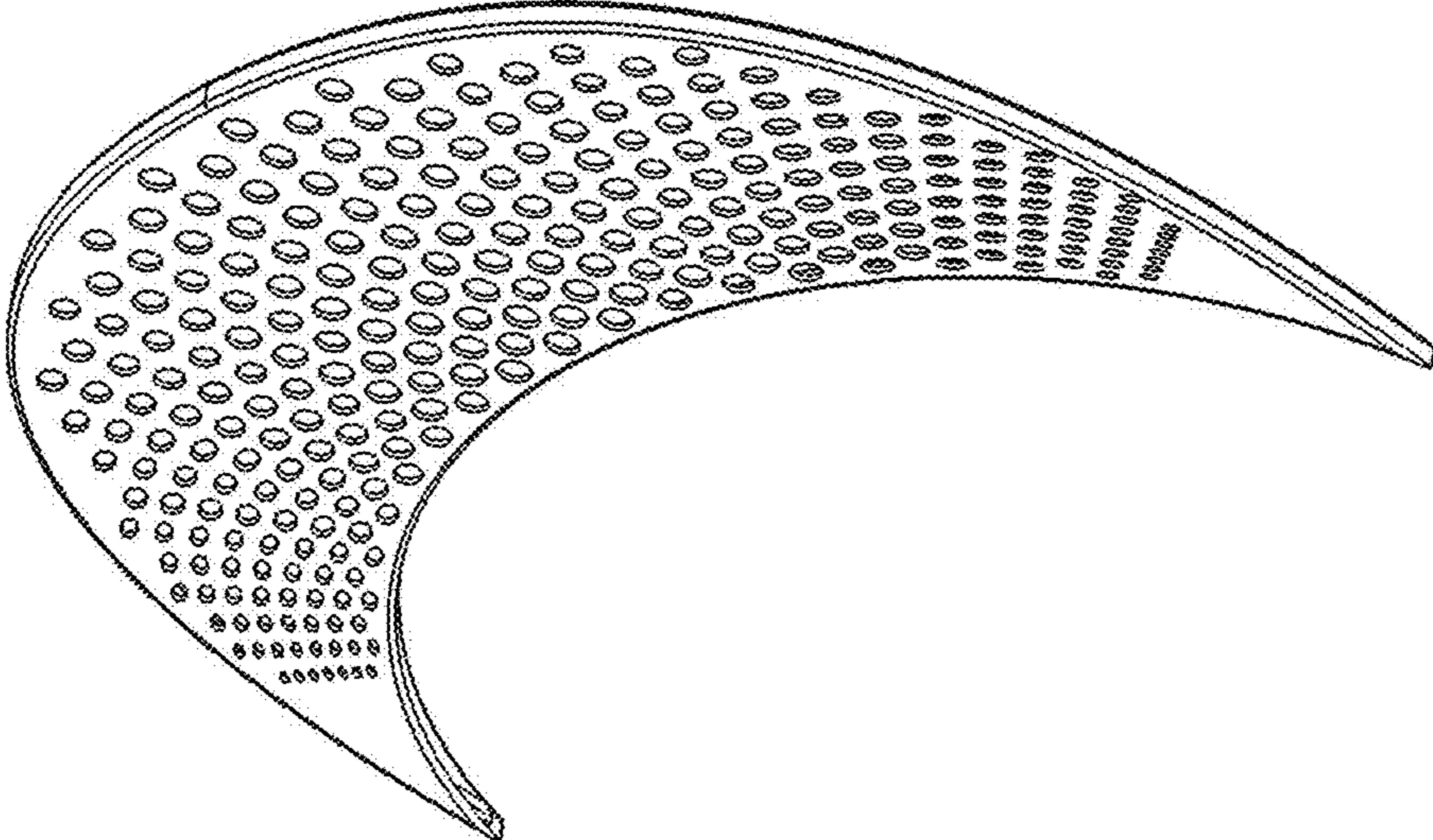

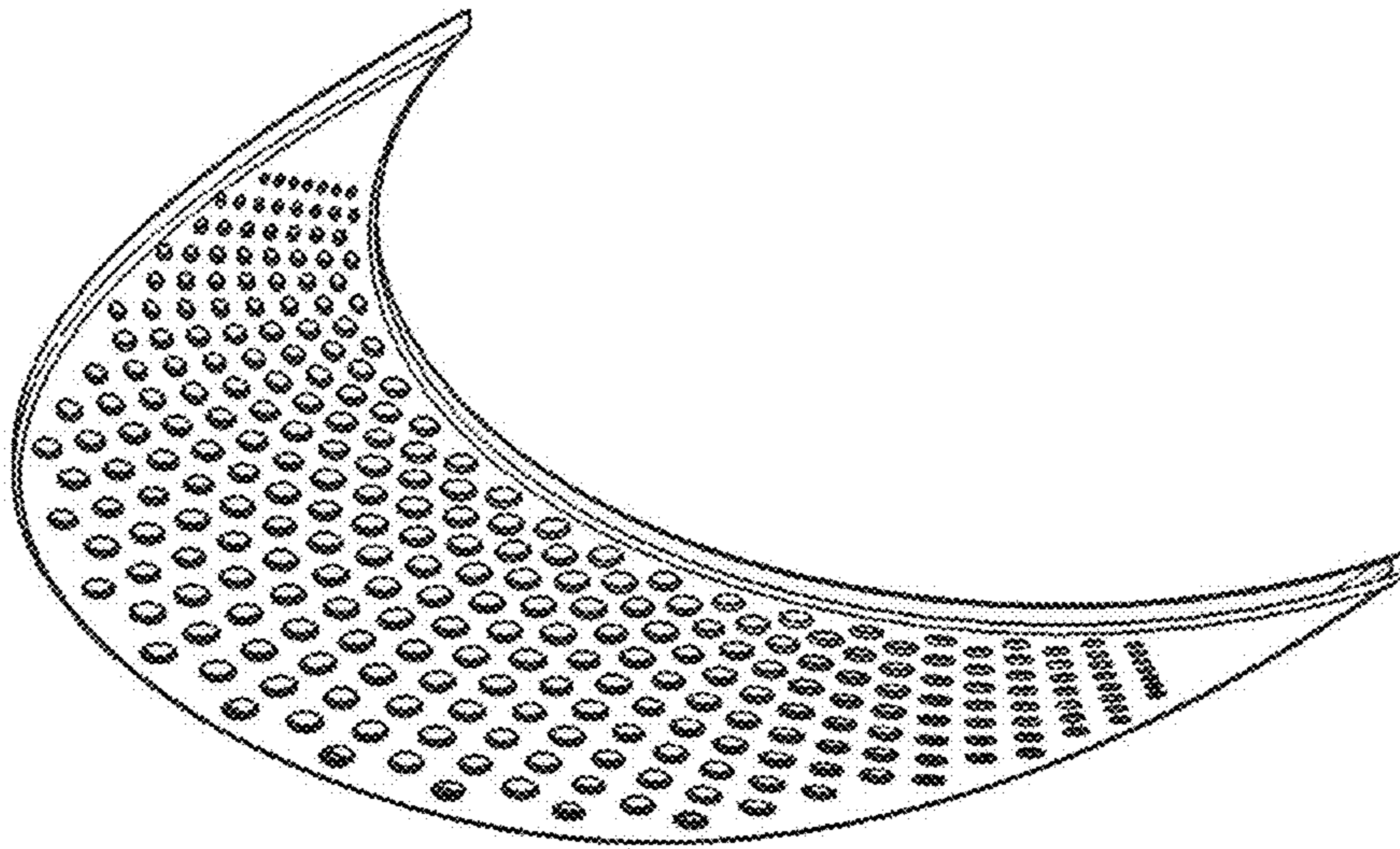
