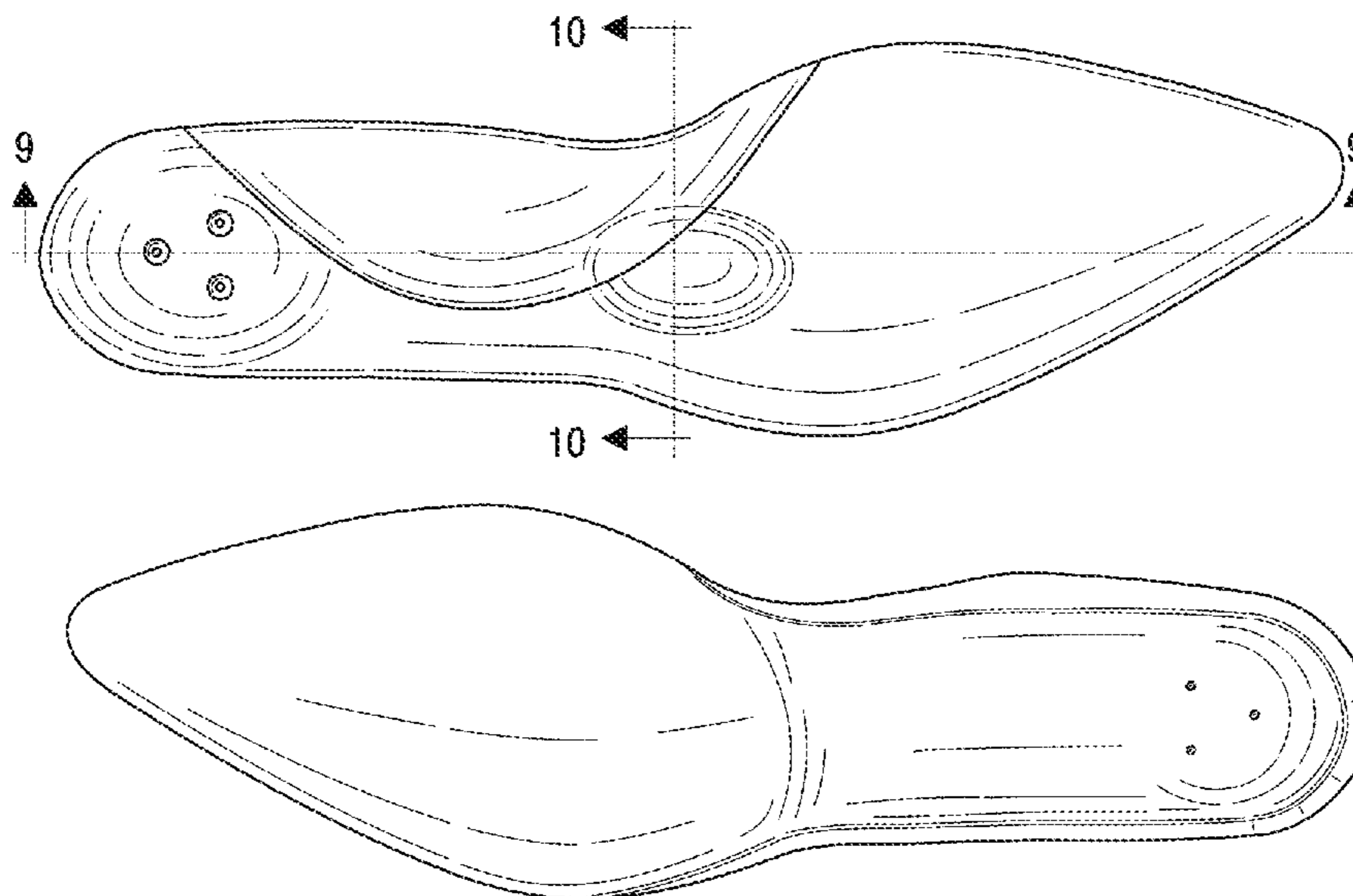

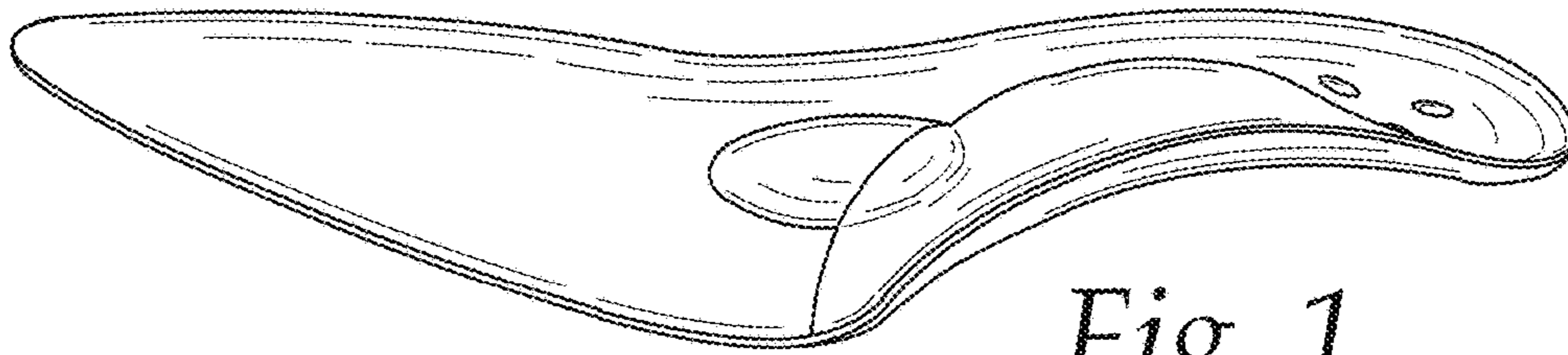
The ornamental design for a footwear insole, as shown and

**DESCRIPTION**

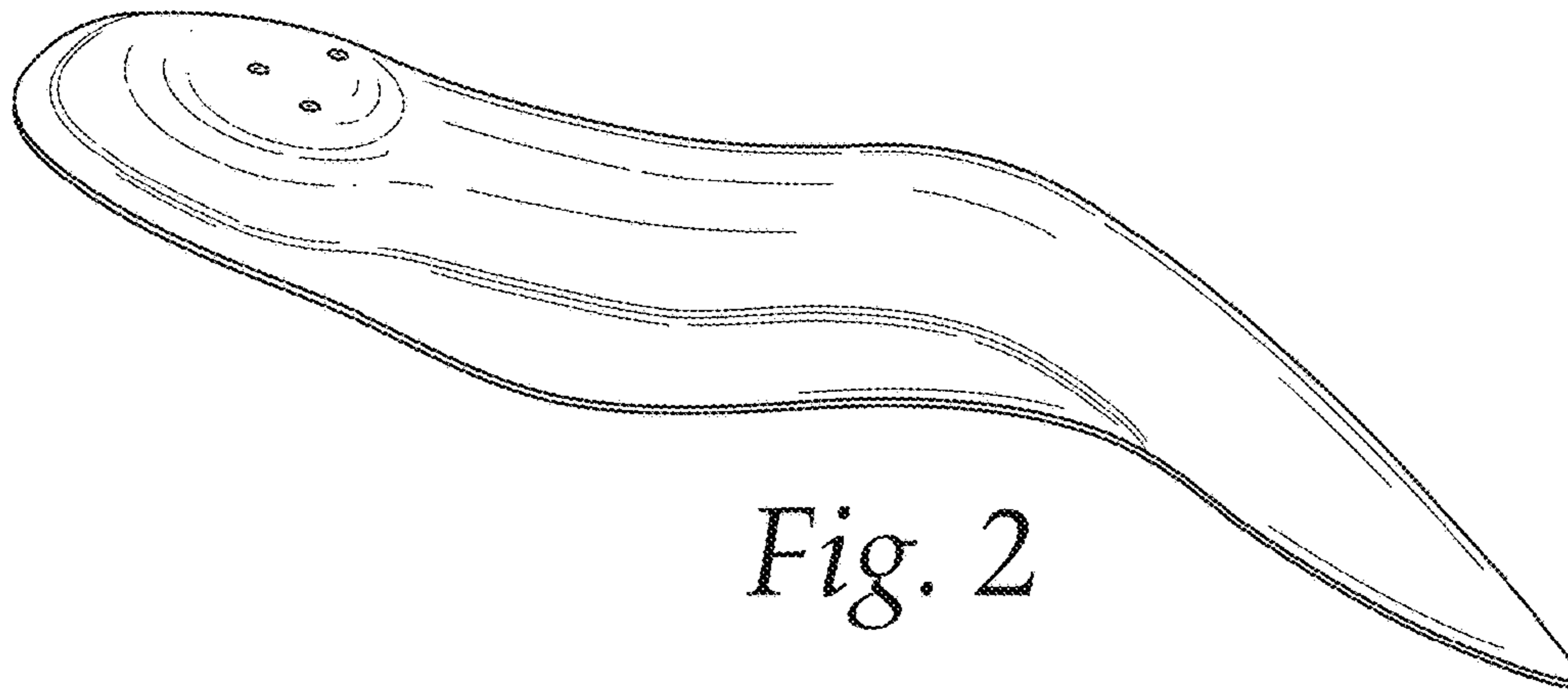
FIG. 1 is a top perspective view of a footwear insole

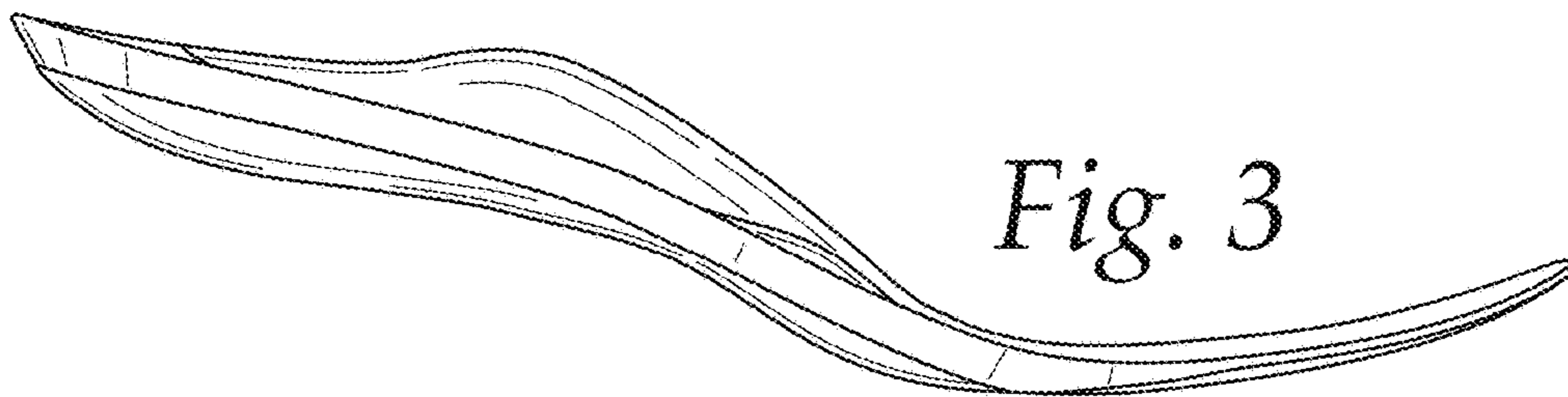




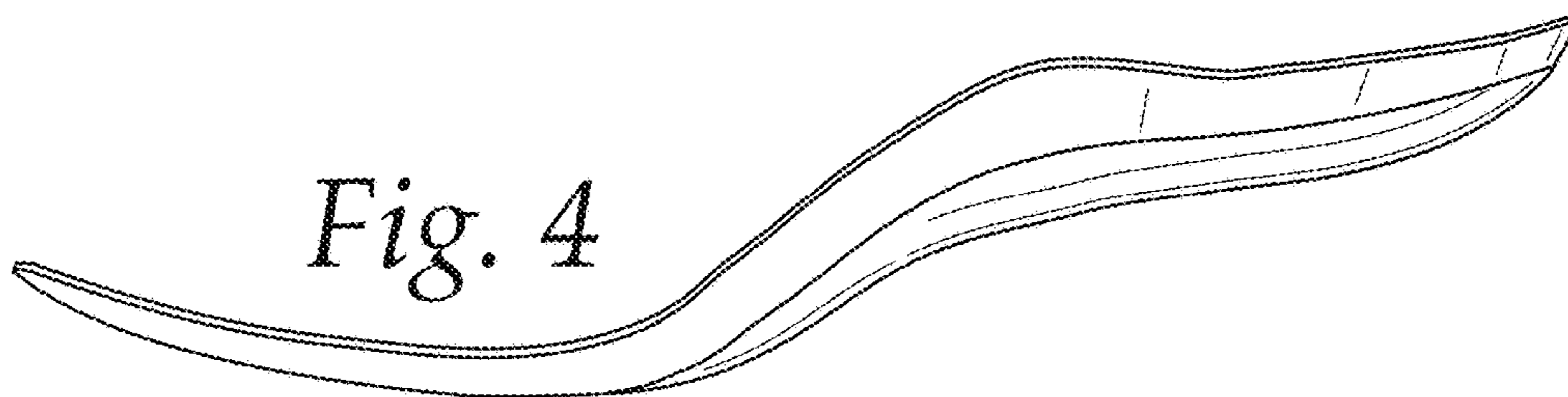

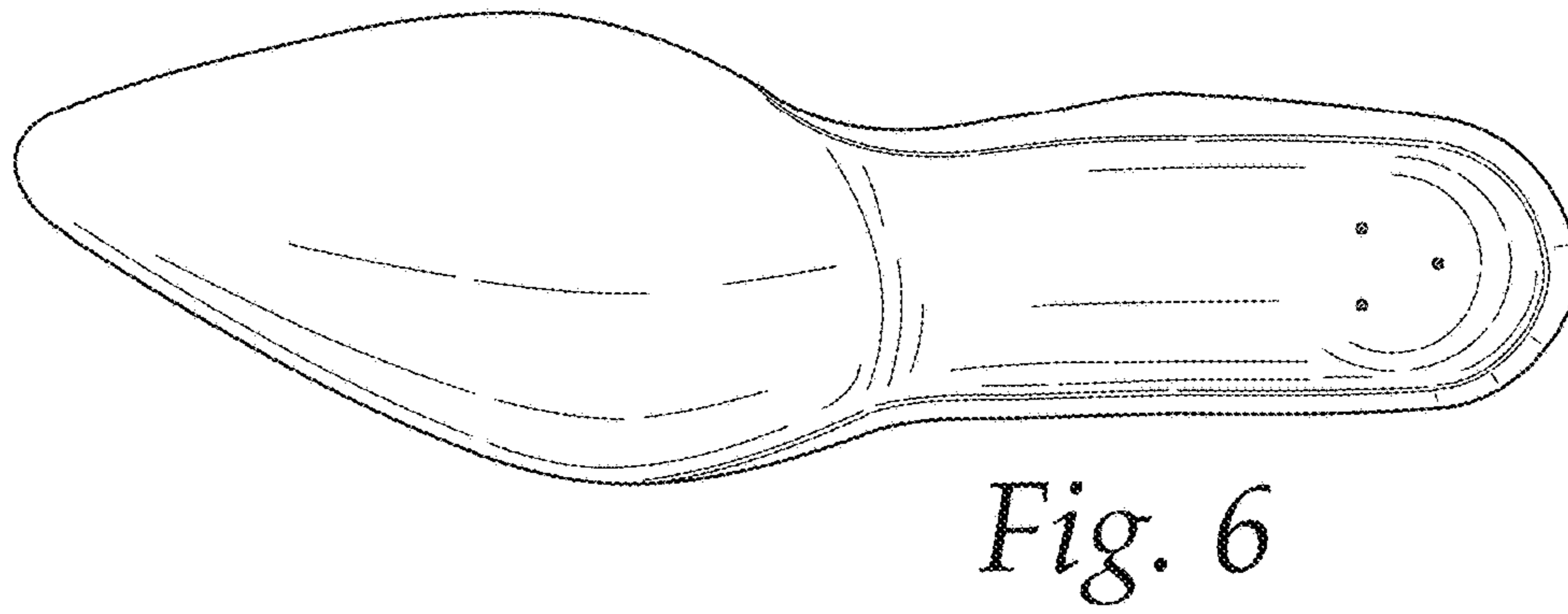
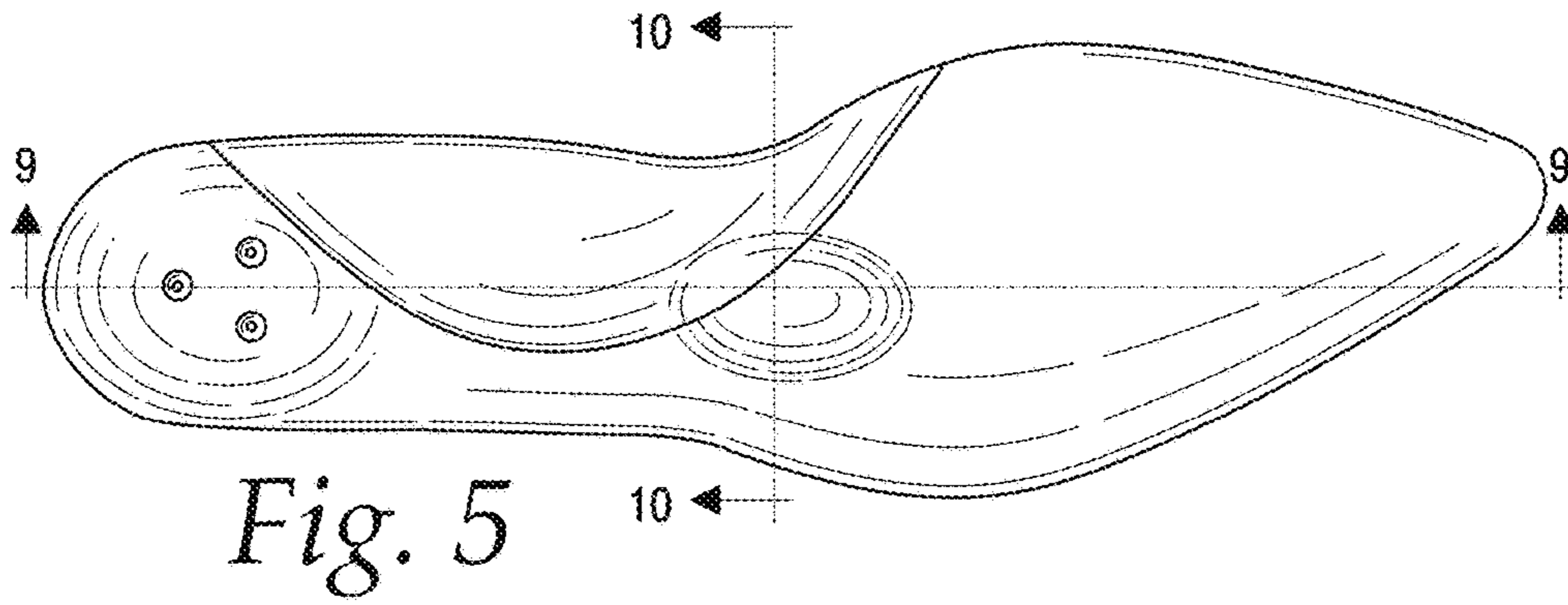

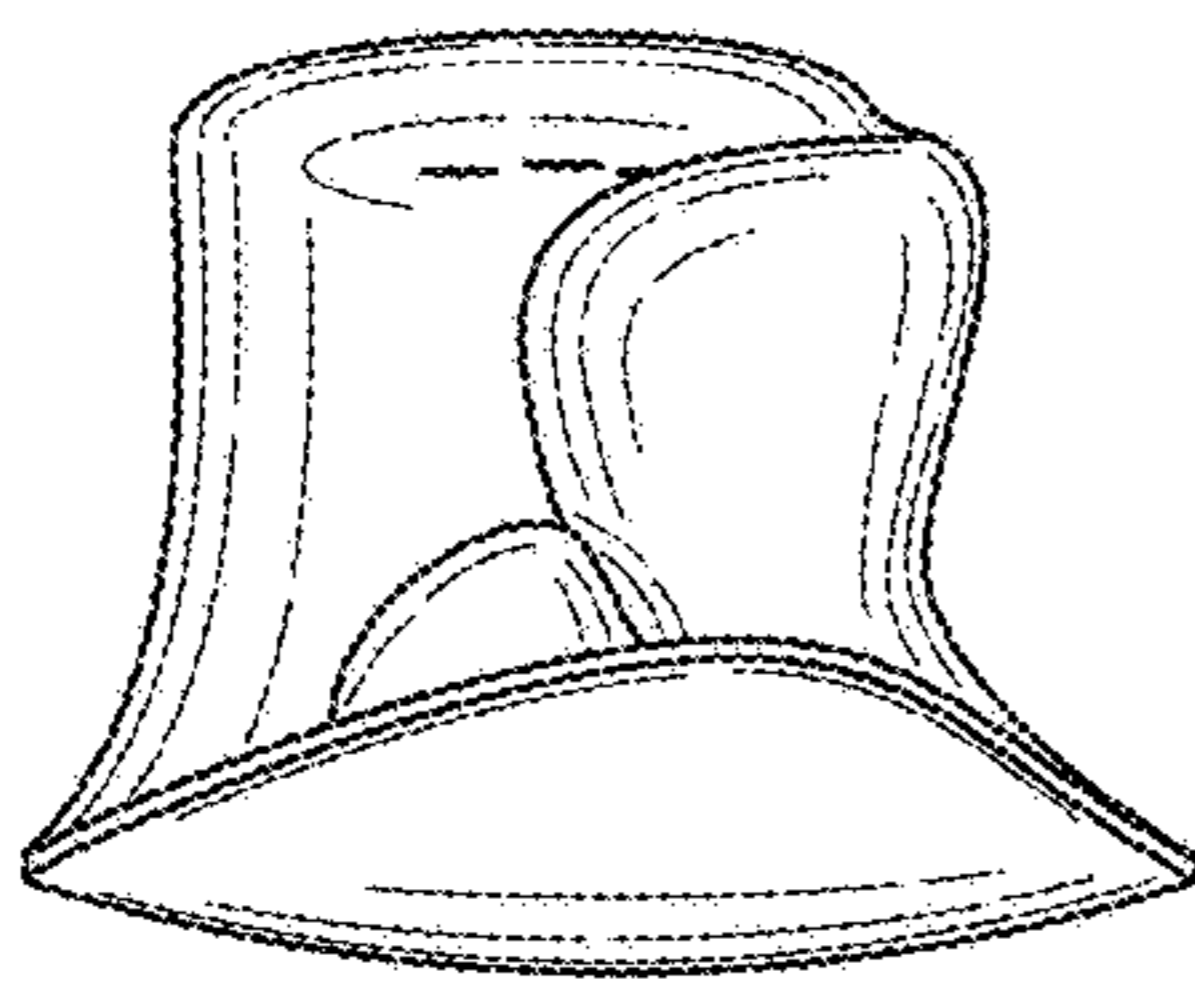

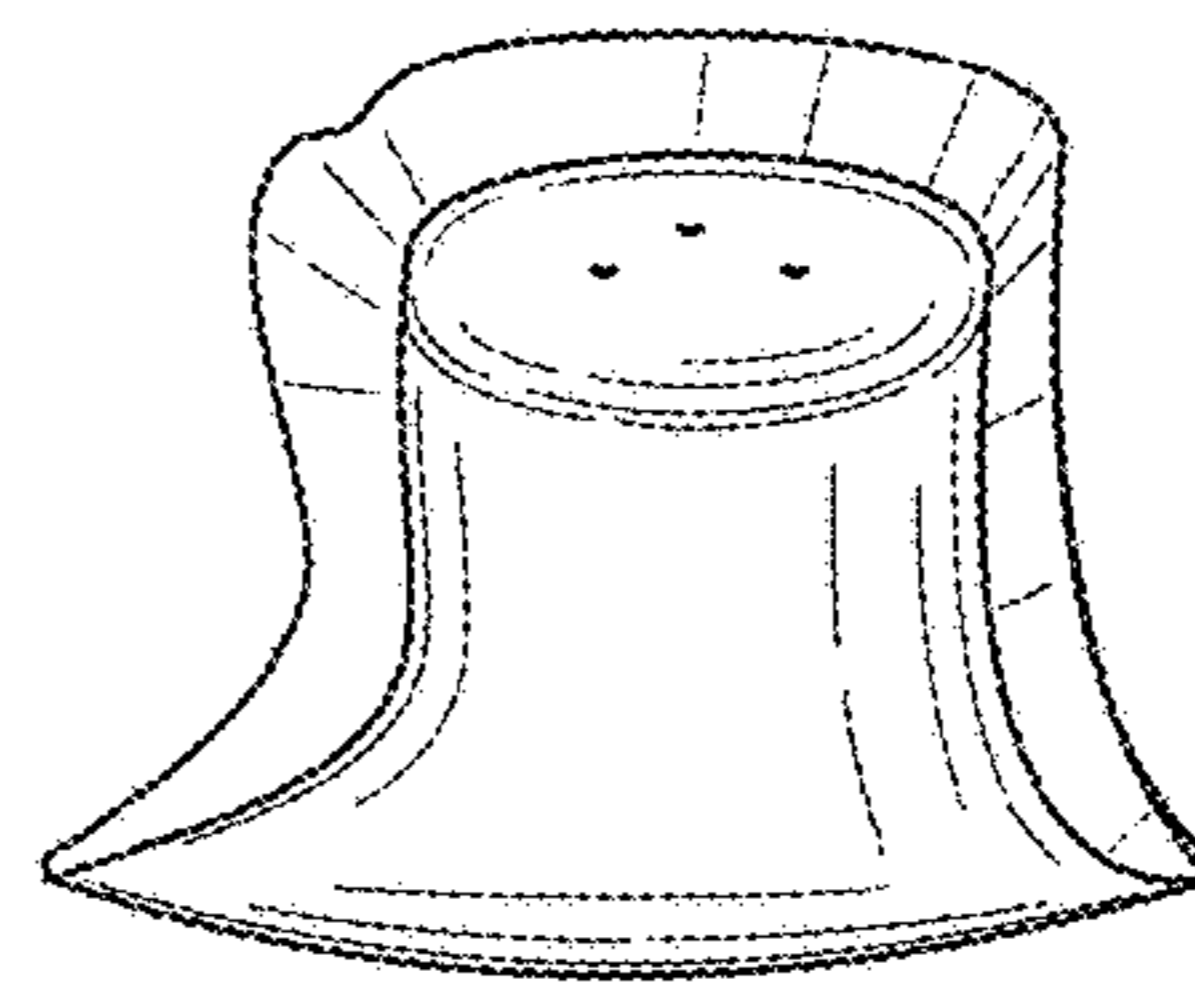

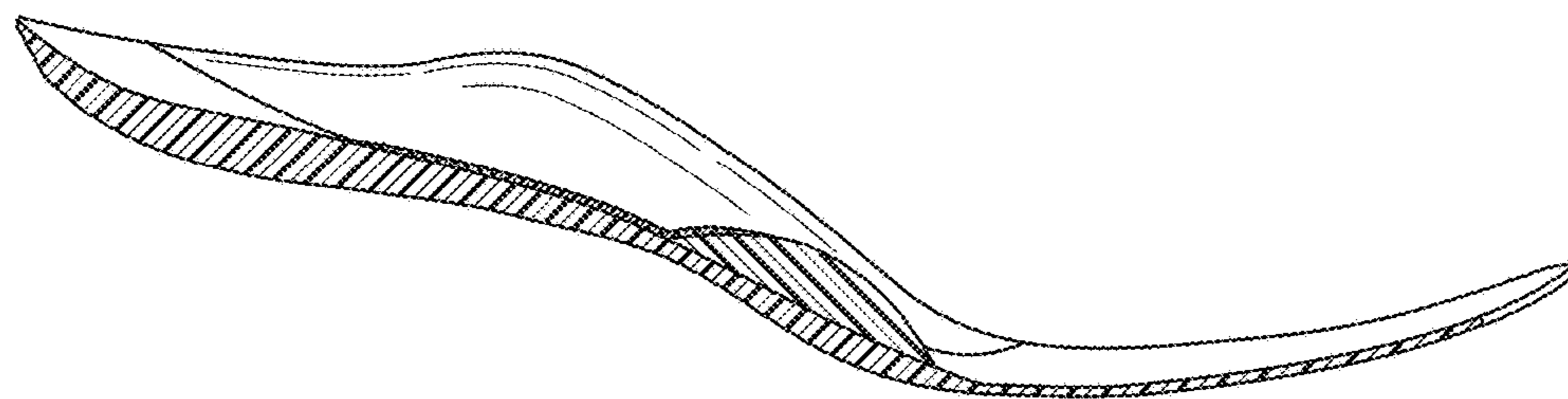

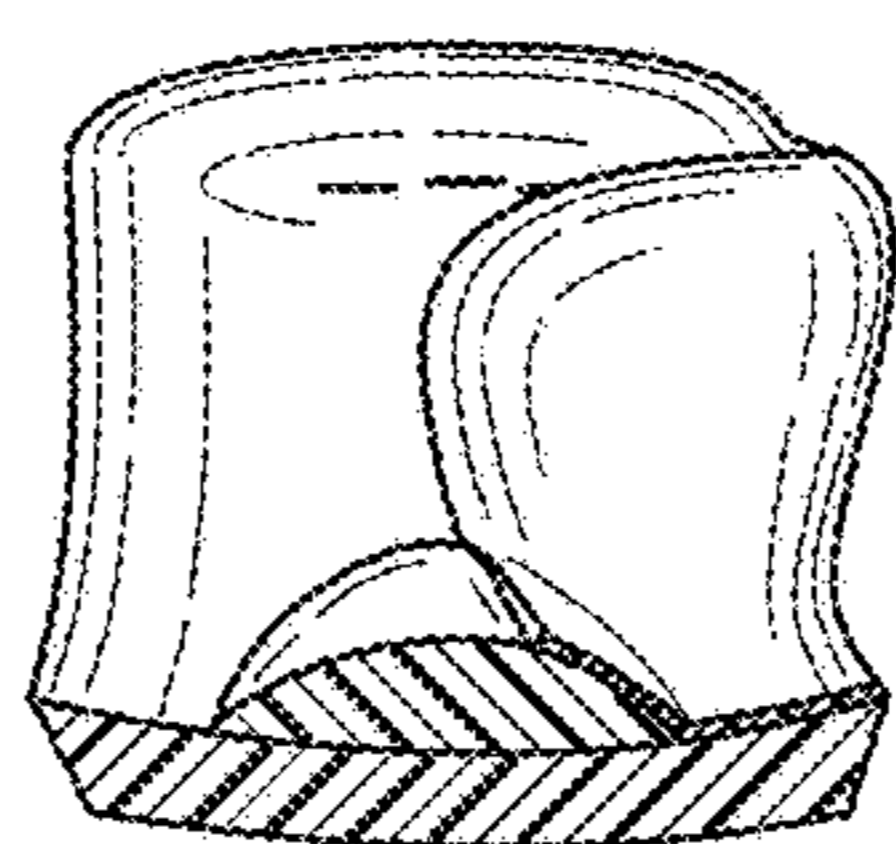
