(57) **CLAIM**

We claim the ornamental design for a ferrule for cosmetic brush, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a ferrule for cosmetic brush with a brush handle and bristles dashed to show environment.

FIG. 2 is an isometric view of the ferrule for cosmetic brush, showing our new design.

FIG. 3 is a front elevation view of the ferrule for cosmetic brush.

FIG. 4 is a rear elevation view of the ferrule for cosmetic brush.

FIG. 5 is a right side elevation view of the ferrule for cosmetic brush.

FIG. 6 is a left side elevation view of the ferrule for cosmetic brush.

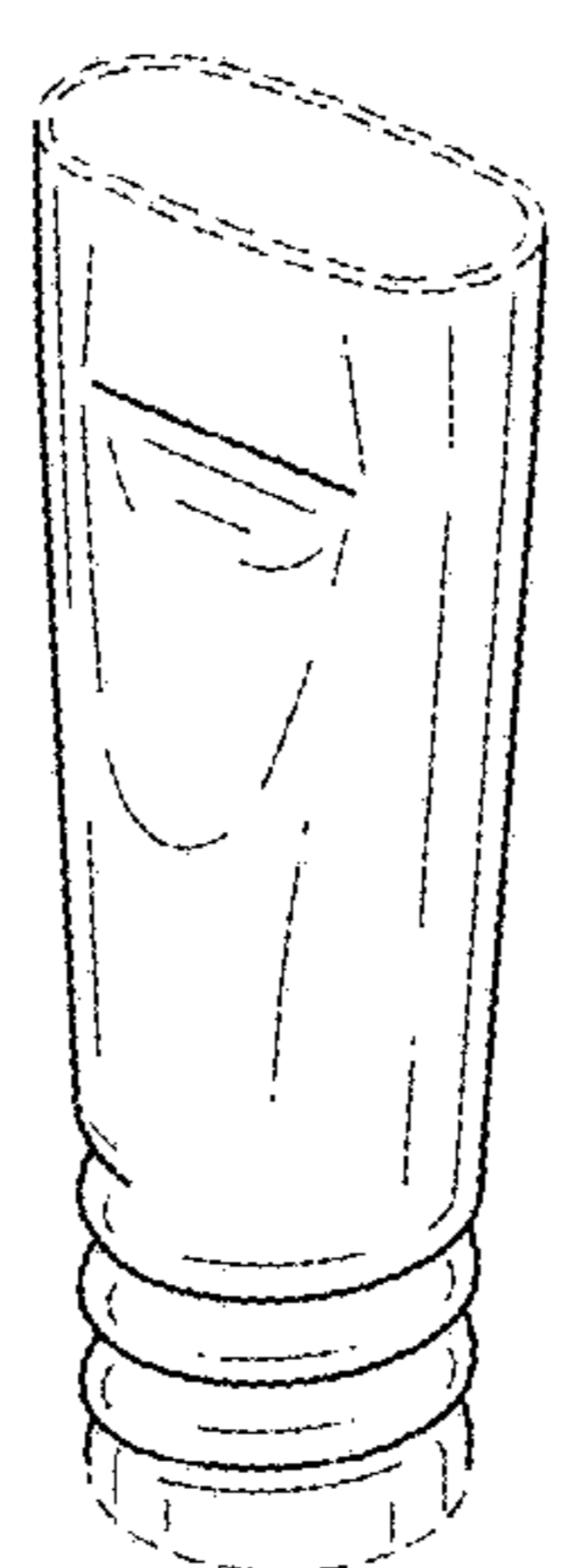
FIG. 7 is a top plan view of the ferrule for cosmetic brush; and,

FIG. 8 is a bottom plan view of the ferrule for cosmetic brush.

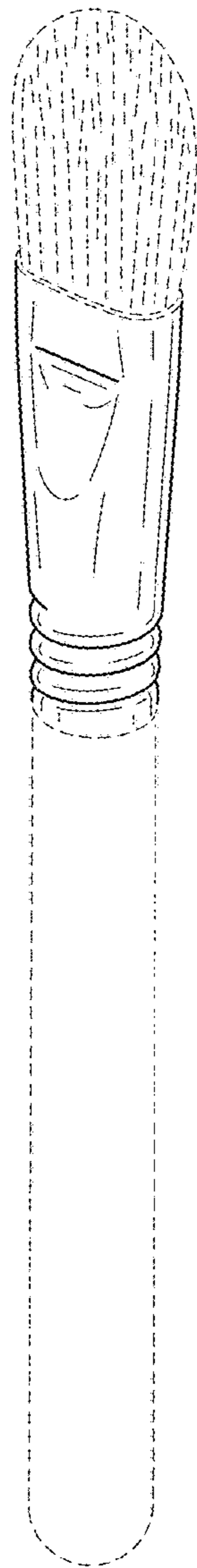

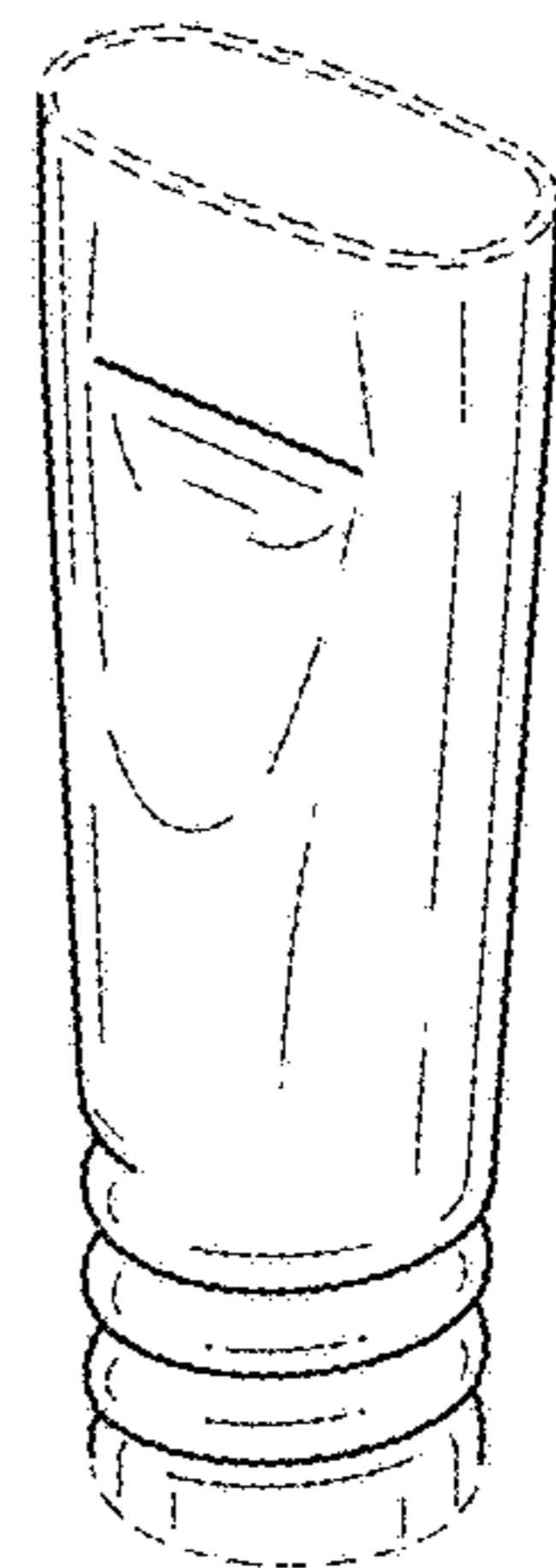

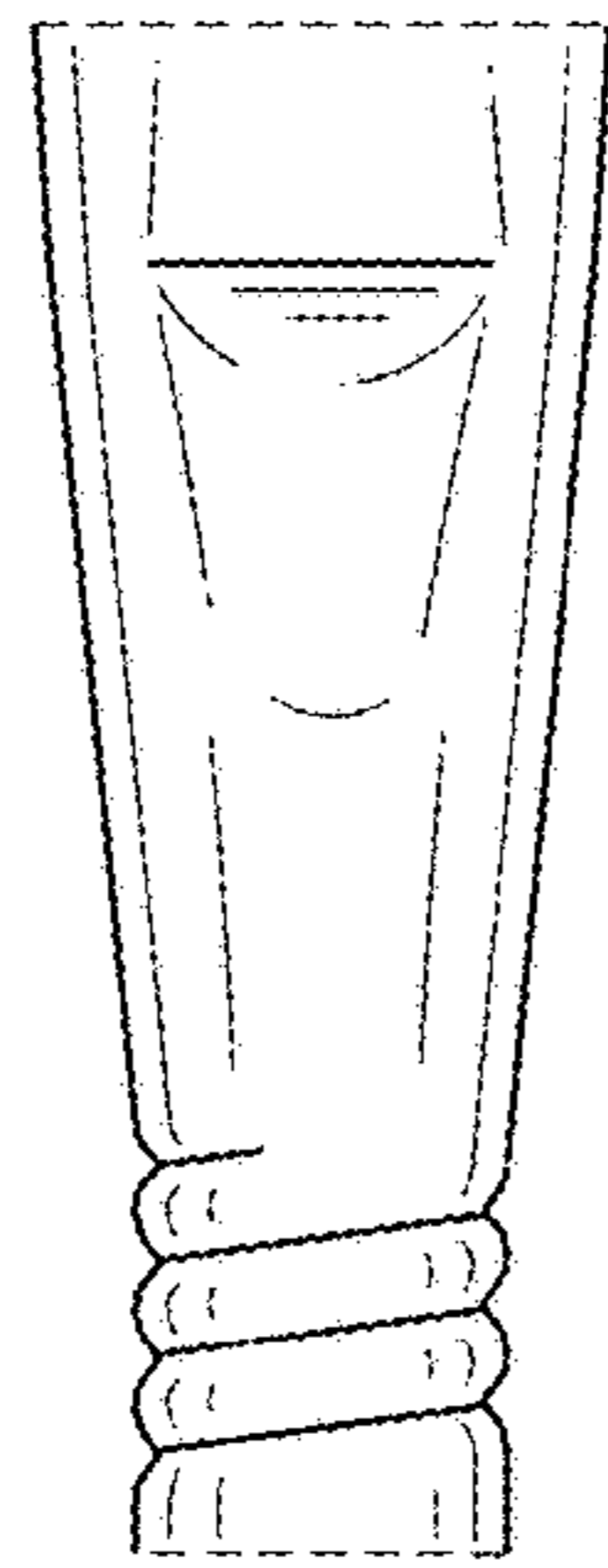

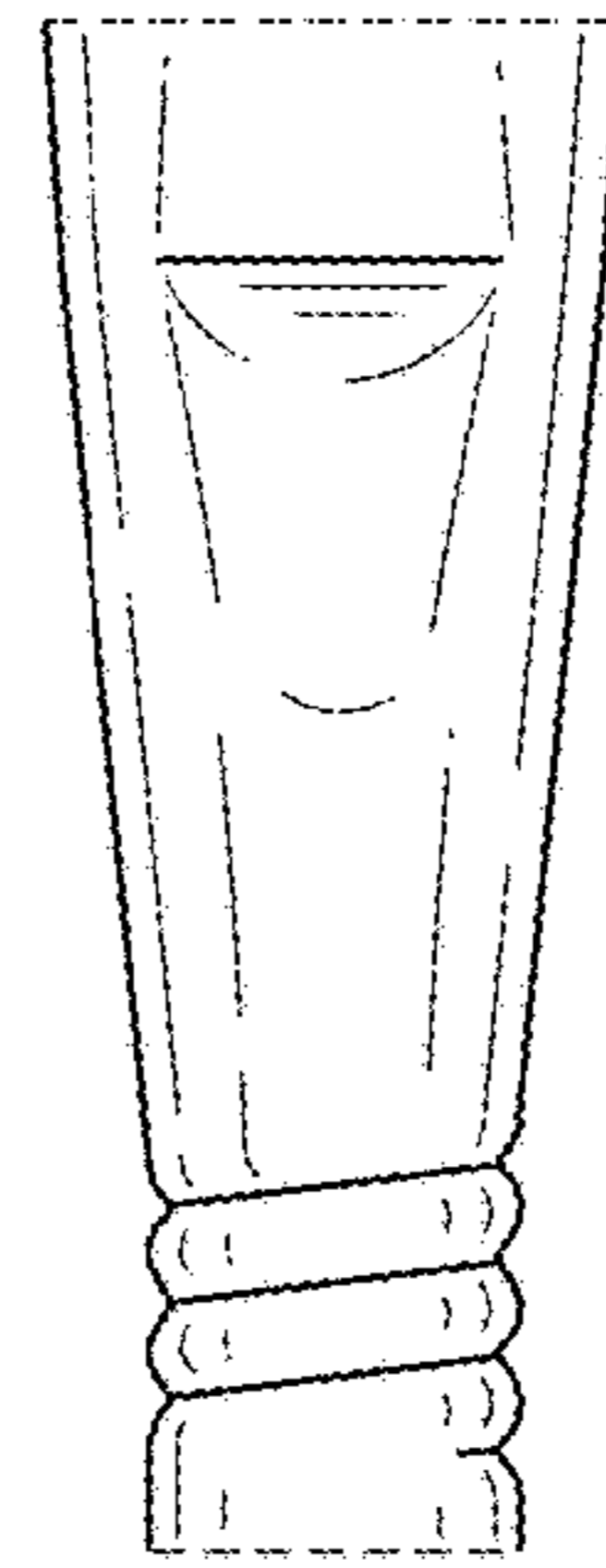

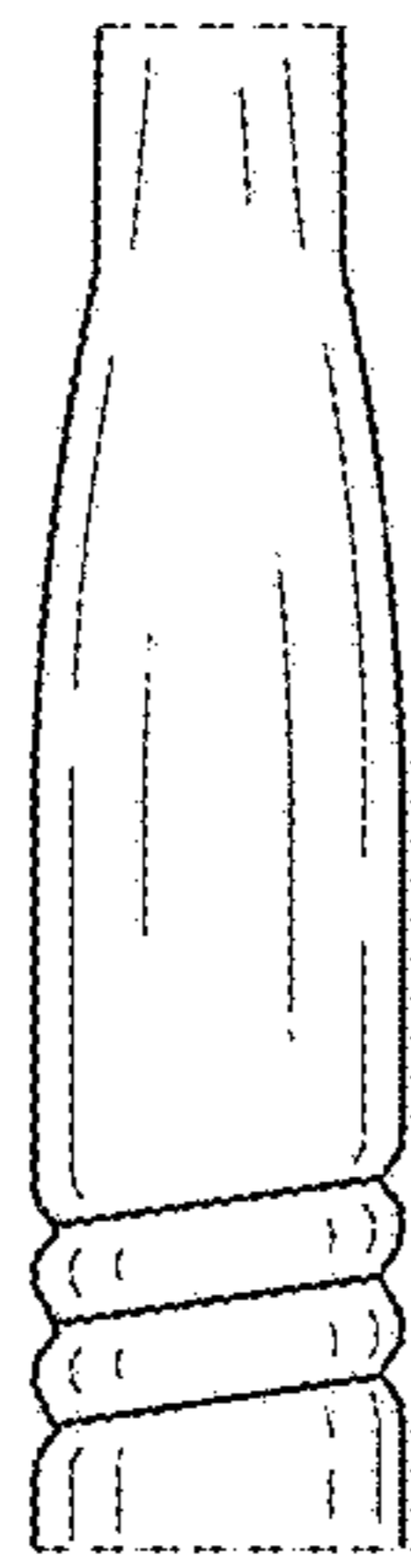

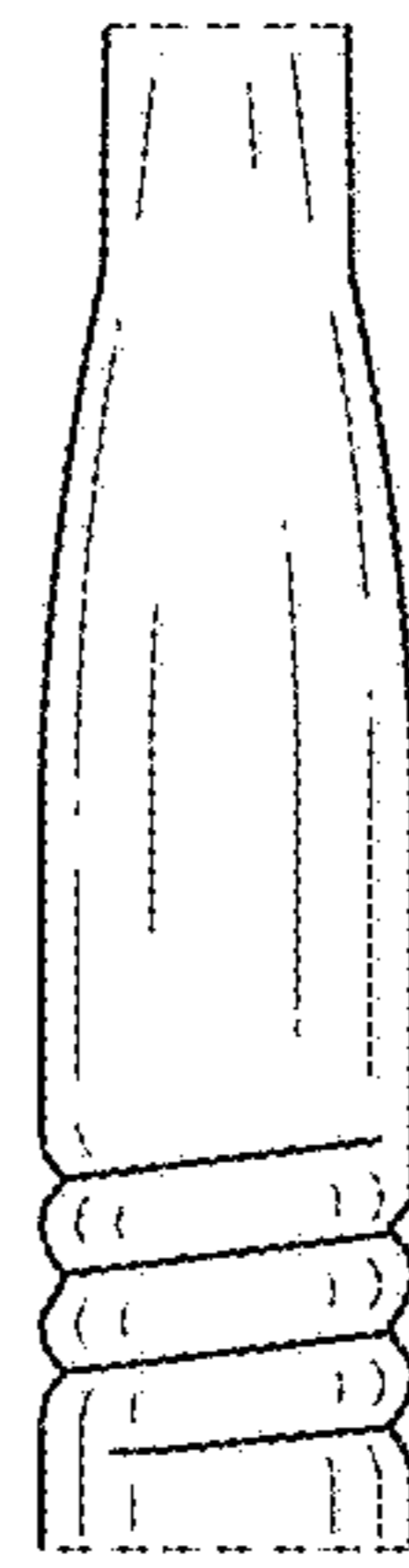

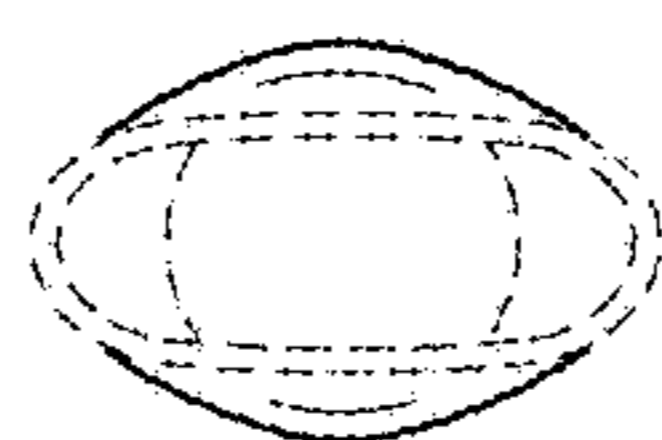

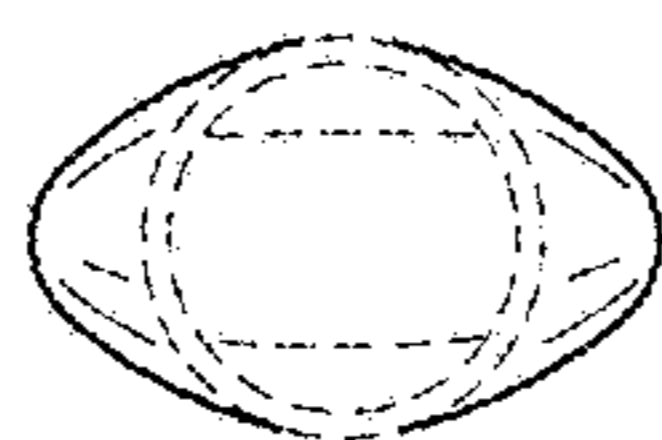
