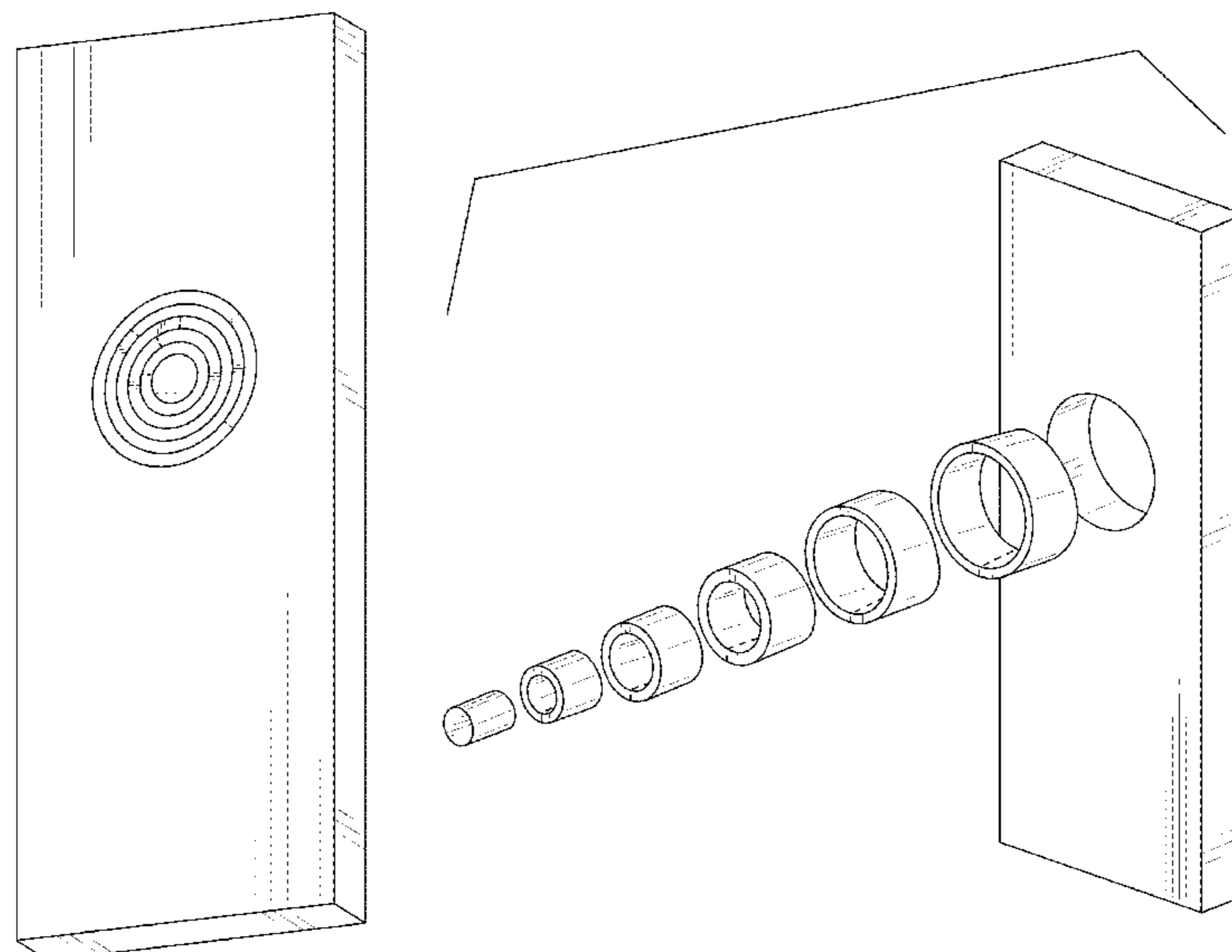
(57) **CLAIM**

I claim the ornamental design for a mattress pad, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a mattress pad showing the
new design, as viewed from the front, right, and bottom.
FIG. 2 is a perspective view thereof, as viewed from the rear,
left, and top.
FIG. 3 is a front view thereof. The rear view is identical.
FIG. 4 is a top view thereof. The bottom view is identical.
FIG. 5 is a right side view thereof. The left side view is
identical.
FIG. 6 is a perspective exploded view thereof, as viewed
from the front, left, and bottom; and,
FIG. 7 is a perspective exploded view thereof, as viewed
from the front, right, and top.

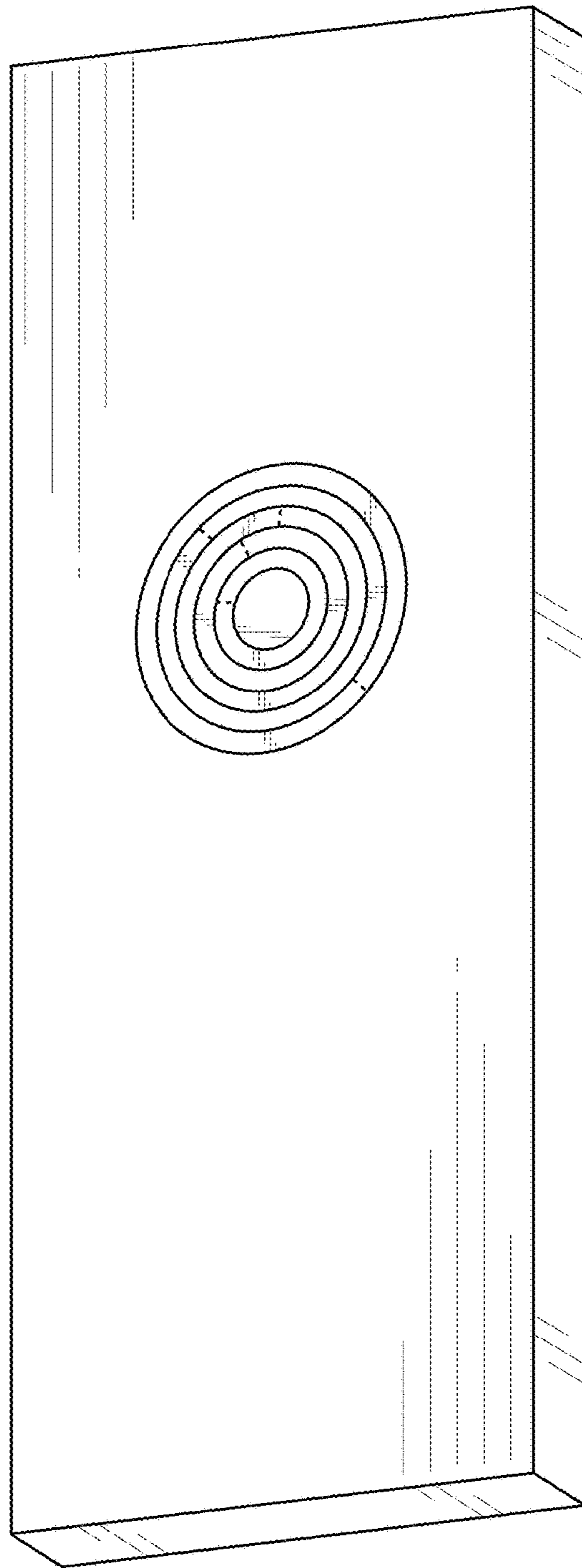

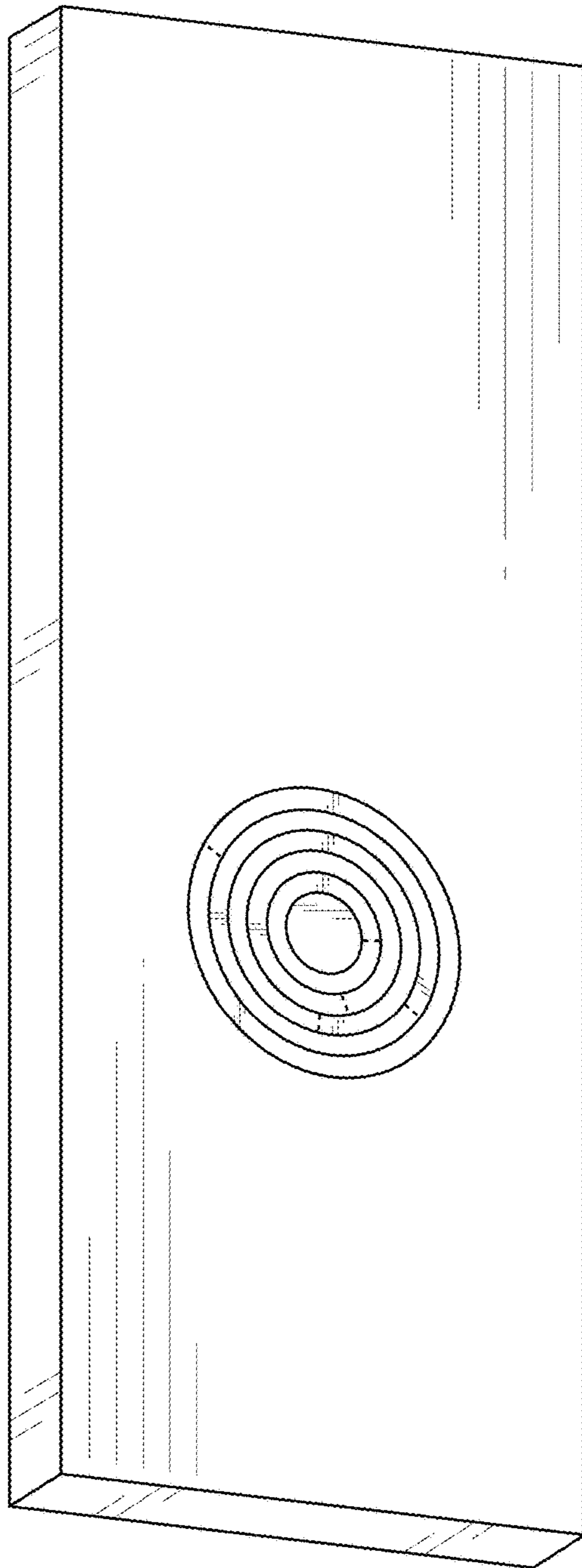

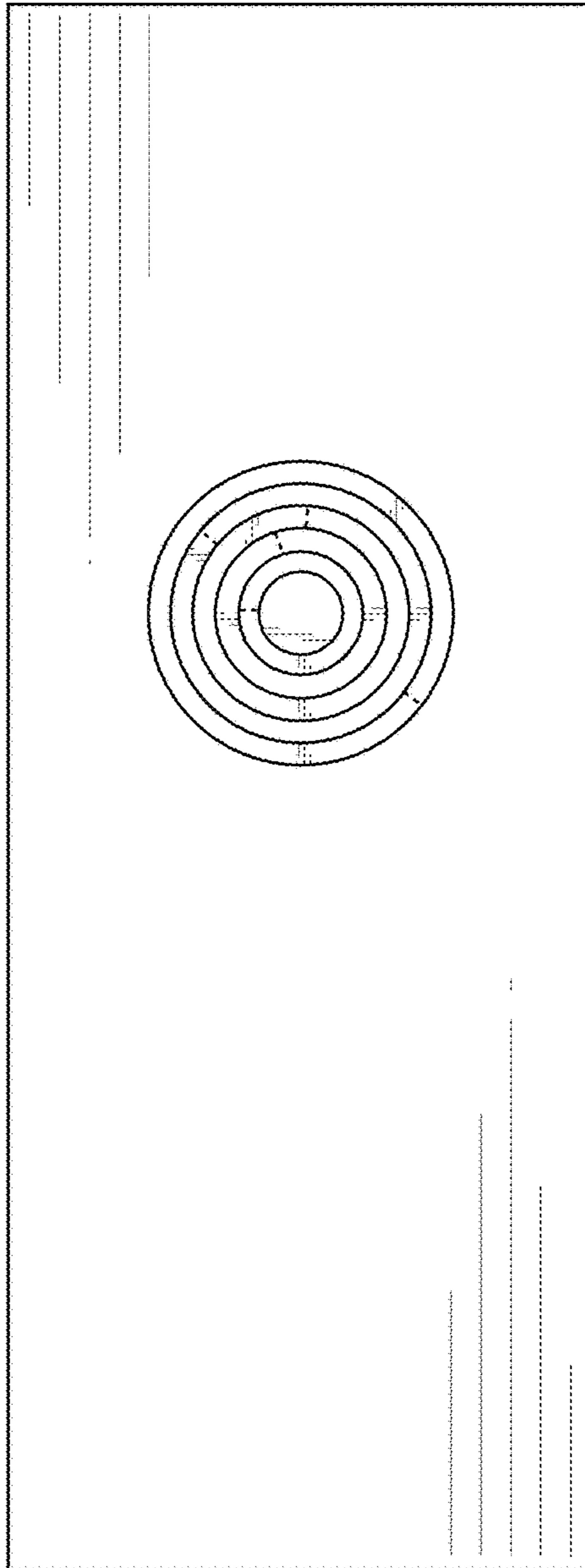

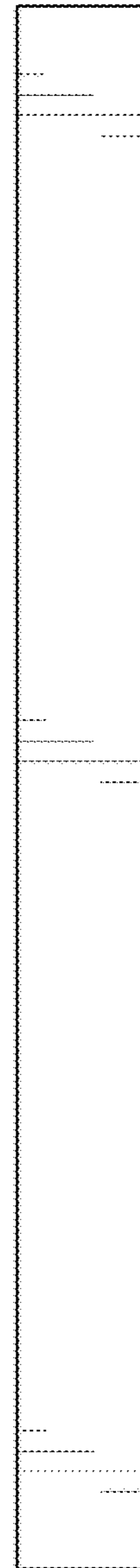

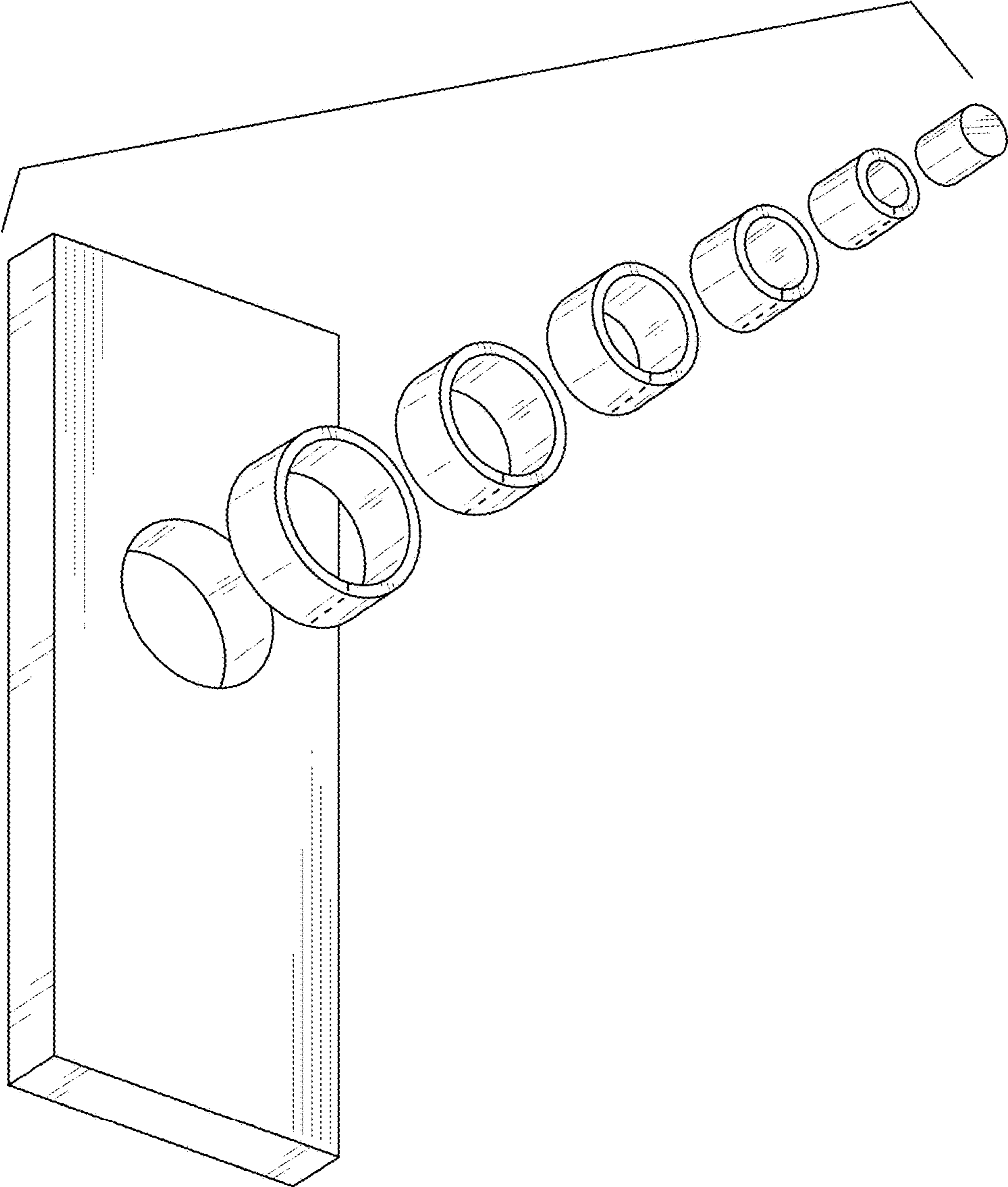

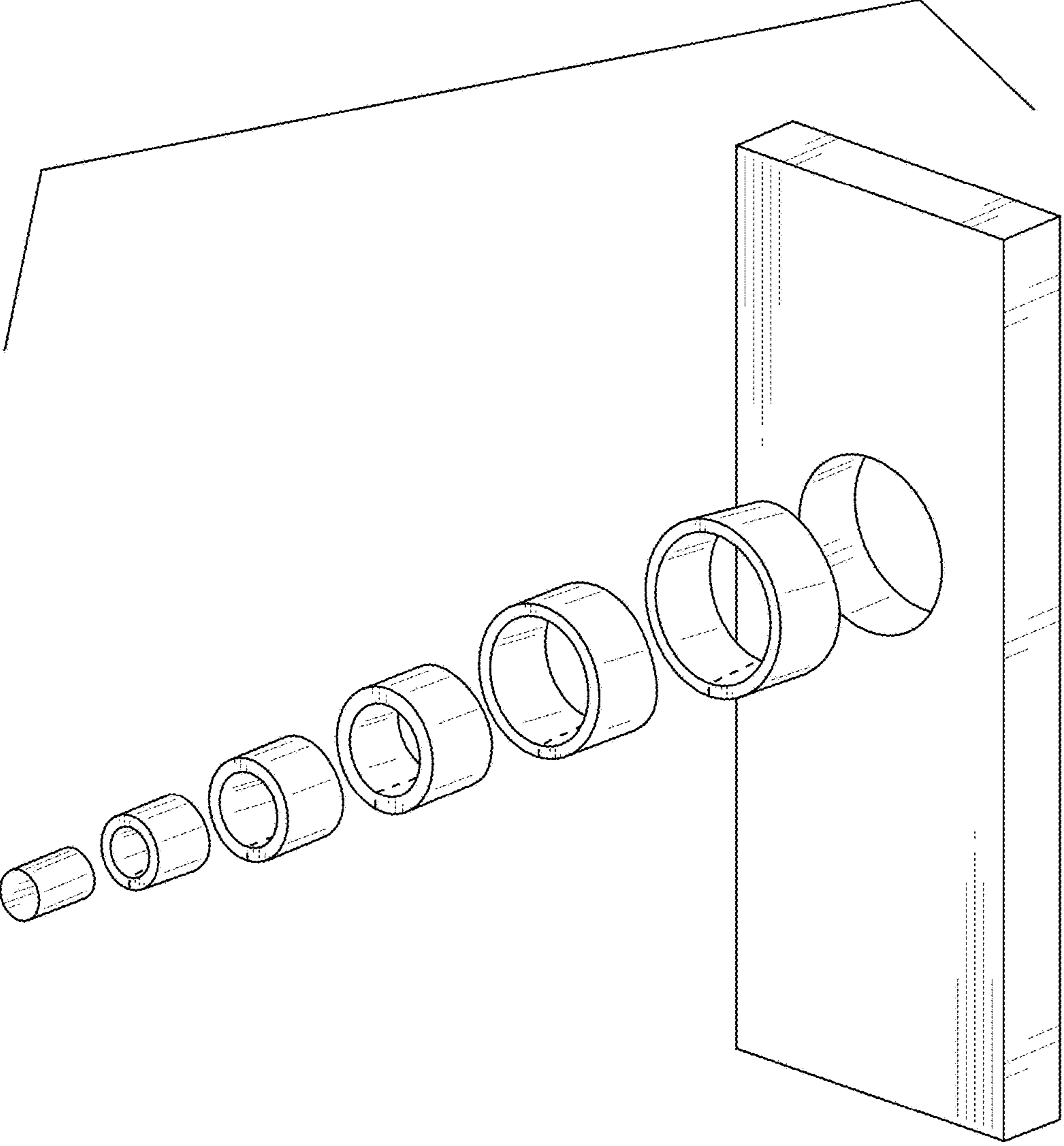
