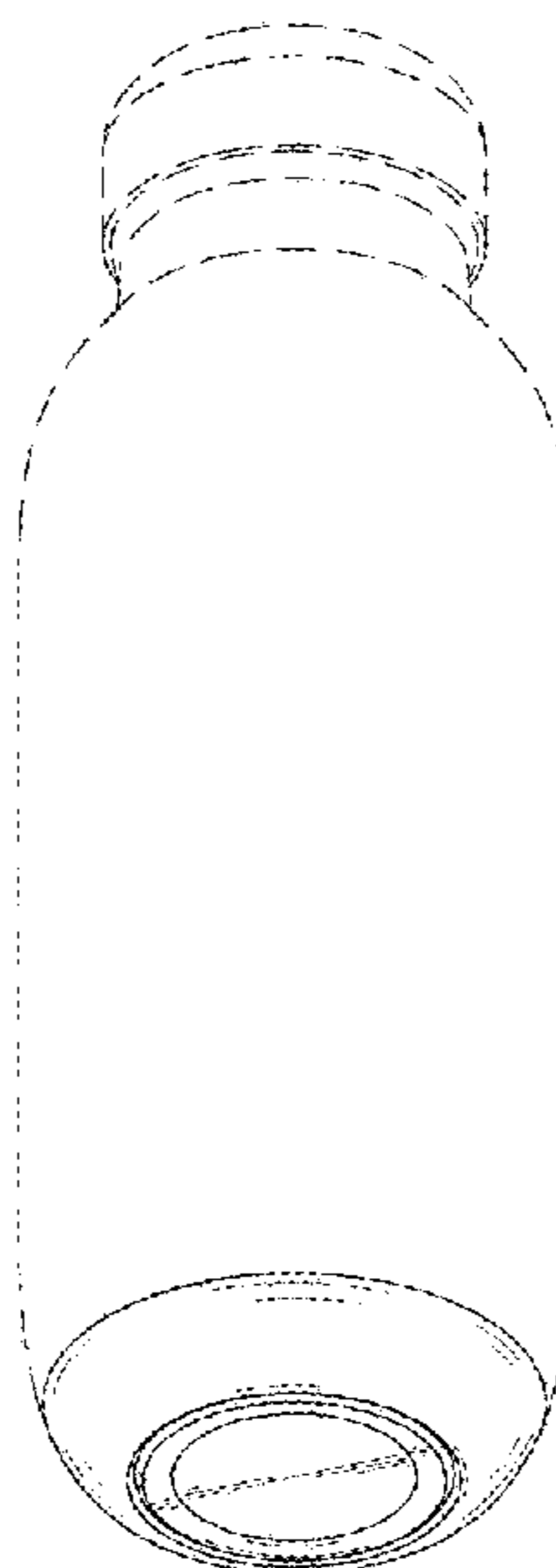
FIG. 1 is a front elevation view of a bottom base of vacuum flask showing my new design;

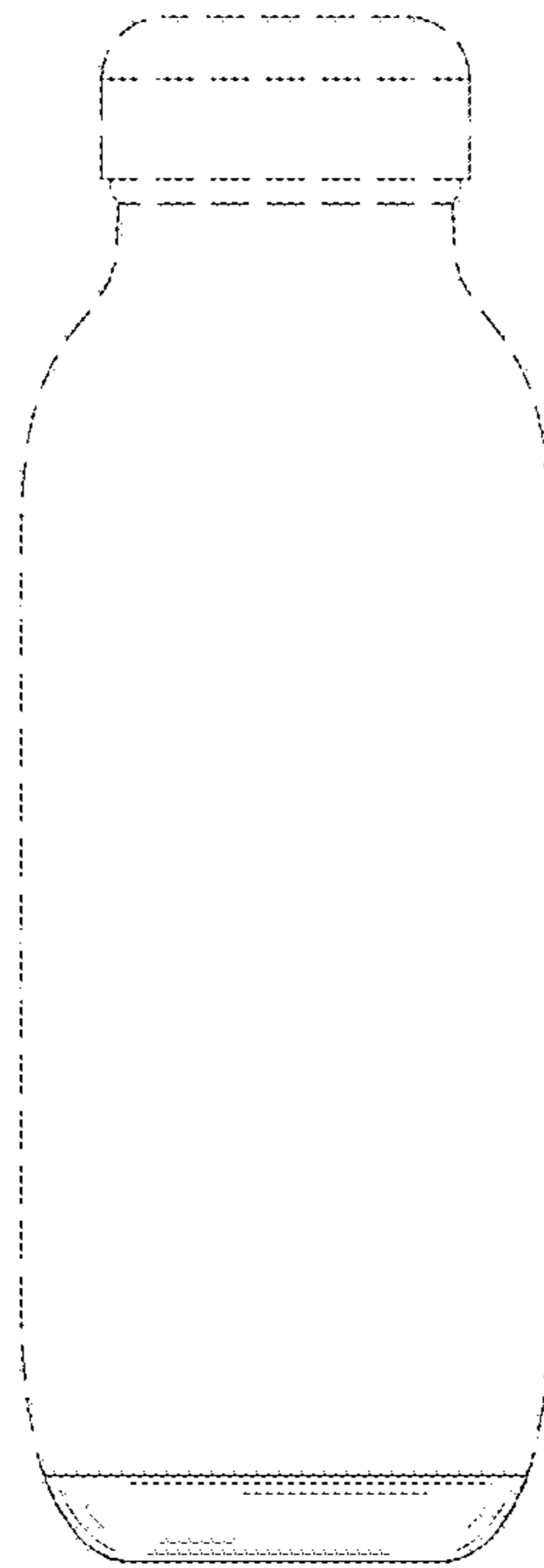

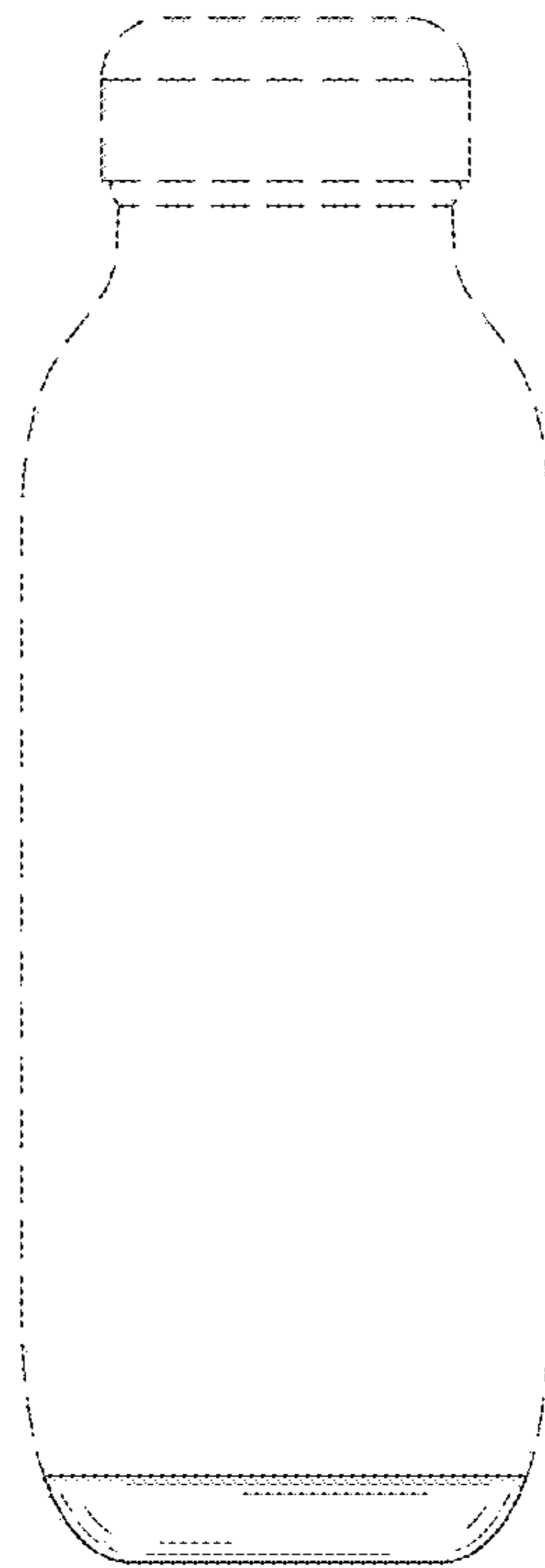

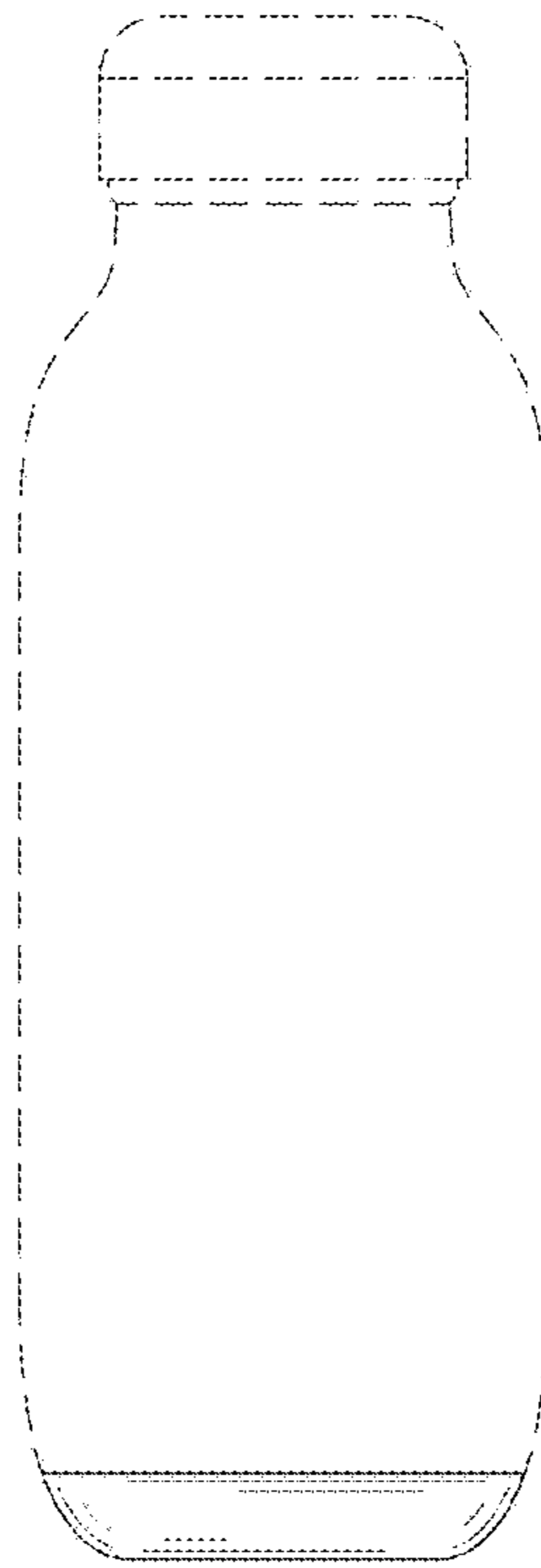

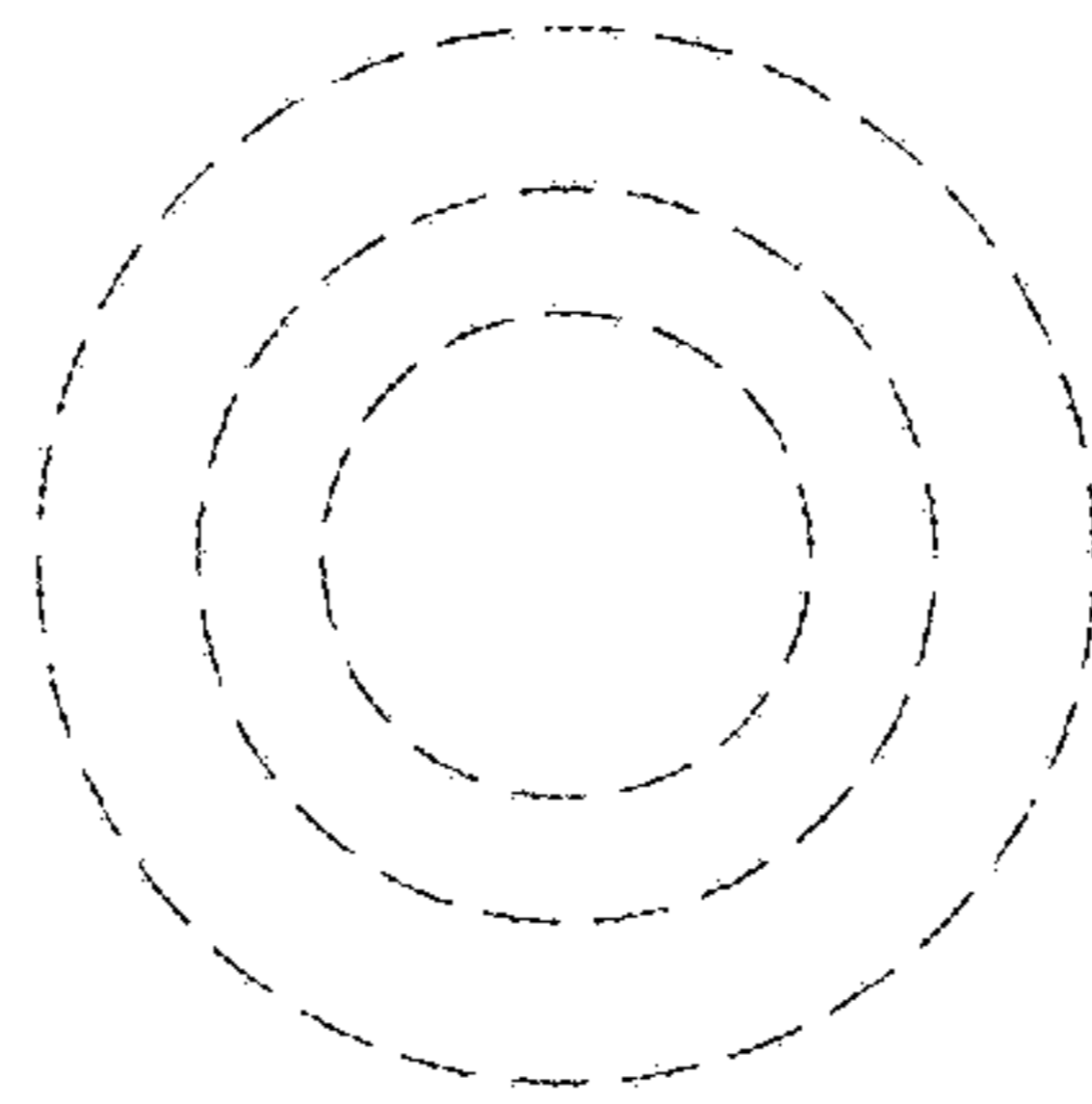

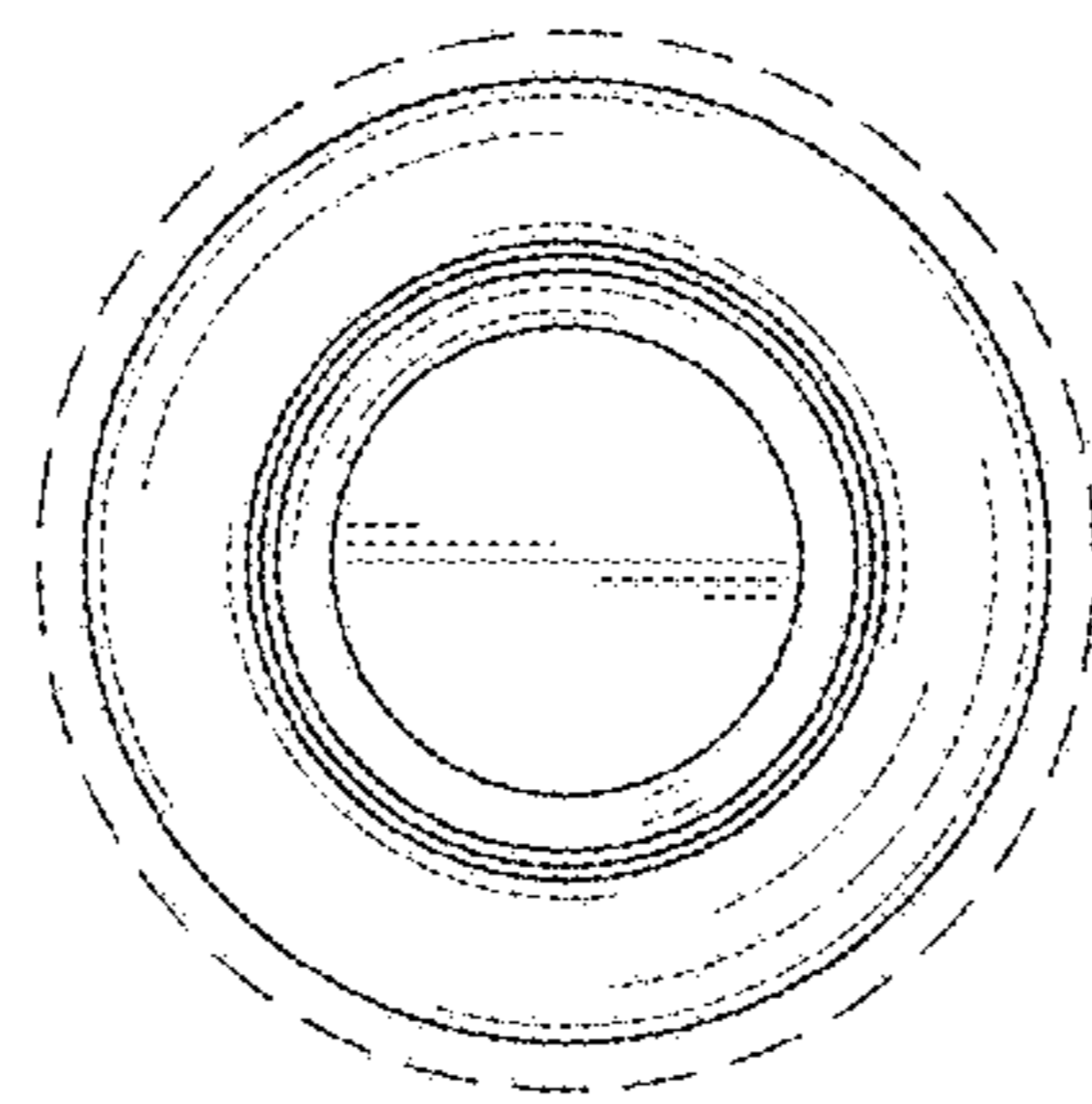

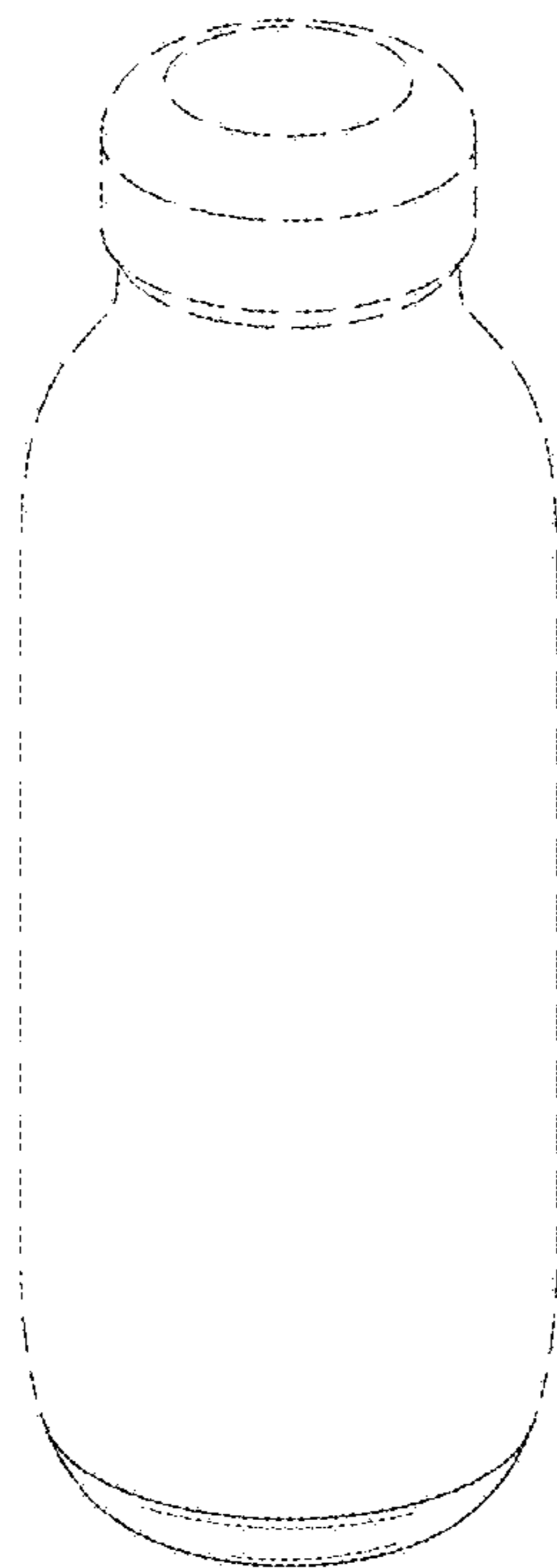

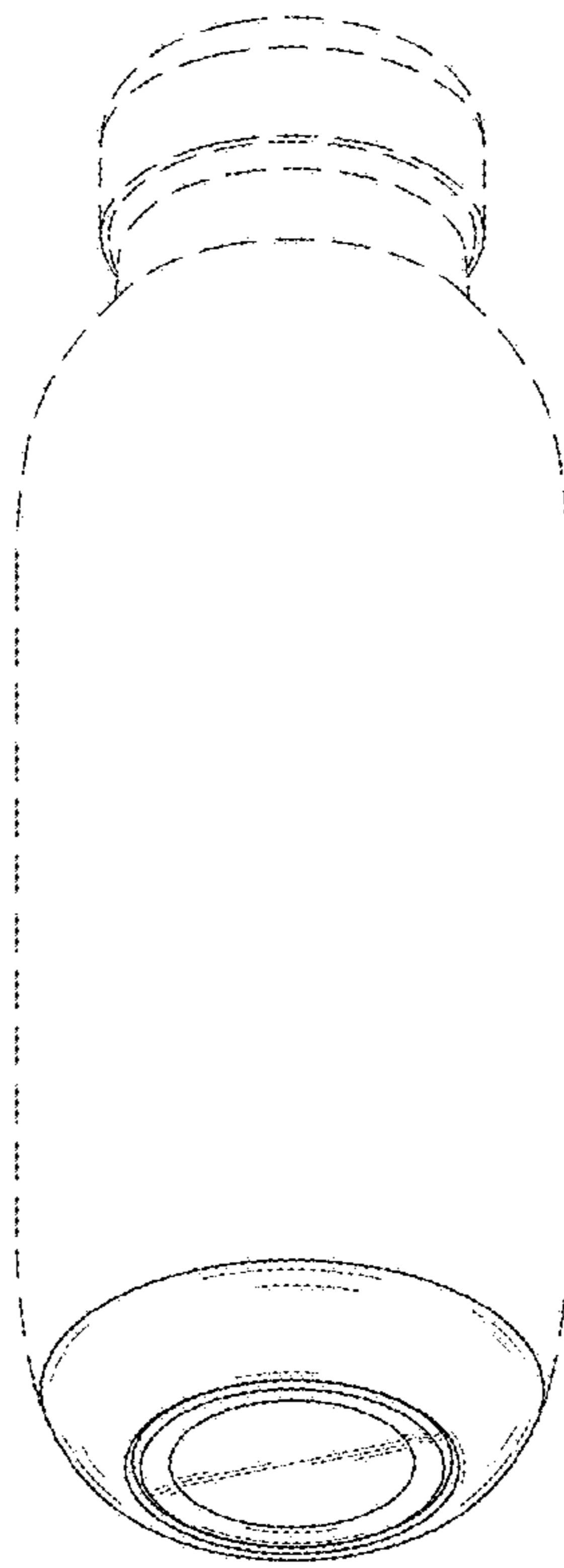
