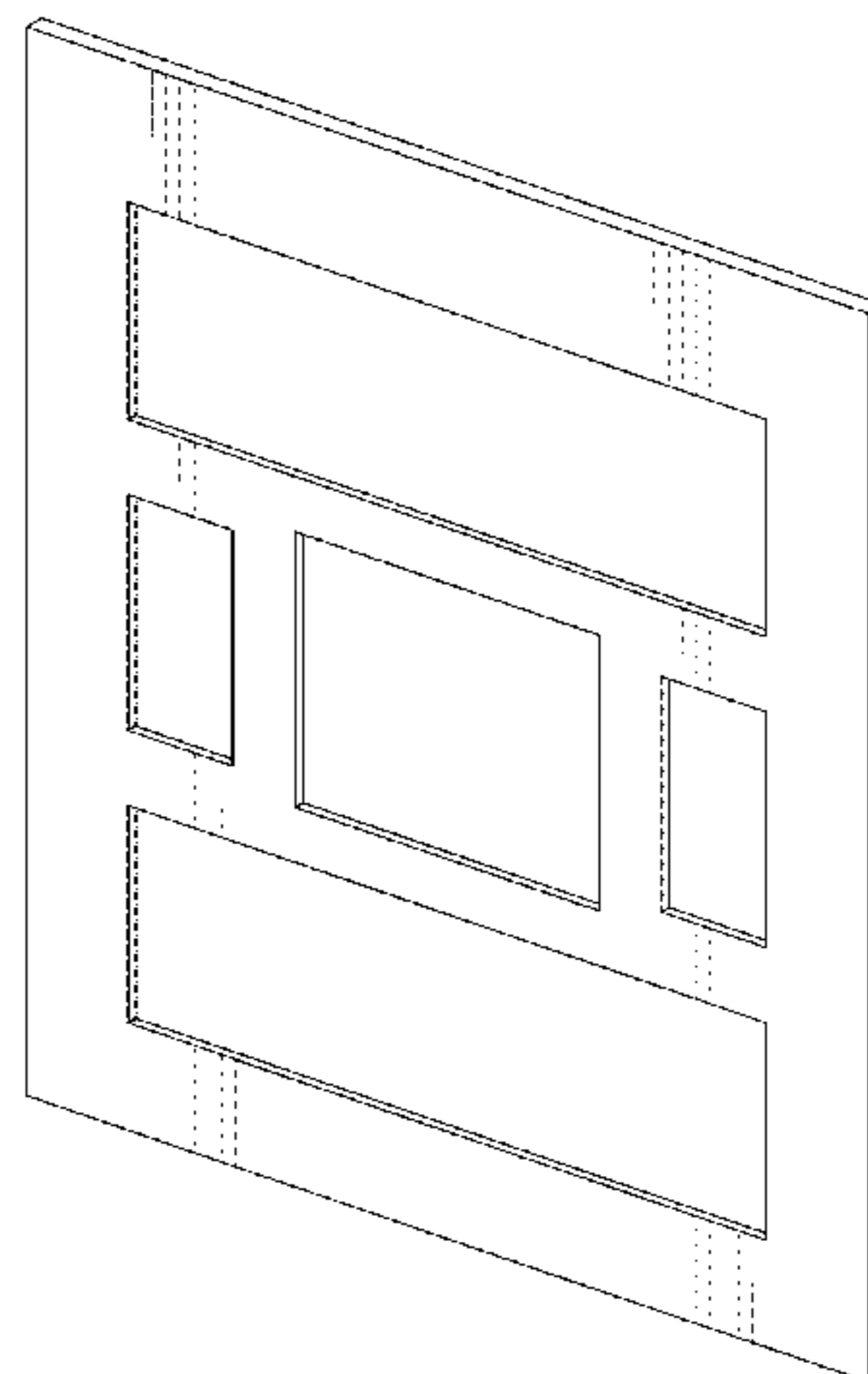
(57) **CLAIM**

The ornamental design for an alignment jig, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an alignment jig;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top plan view thereof which is substantially  
identical to a bottom plan view thereof; and,  
FIG. 6 is a left-side elevational view thereof which is  
substantially identical to a right-side elevation view thereof.  
The ornamental design which is claimed is shown in solid  
lines in the drawings. Features shown in broken lines are  
presented for illustrative purposes and form no part of the  
claimed design.

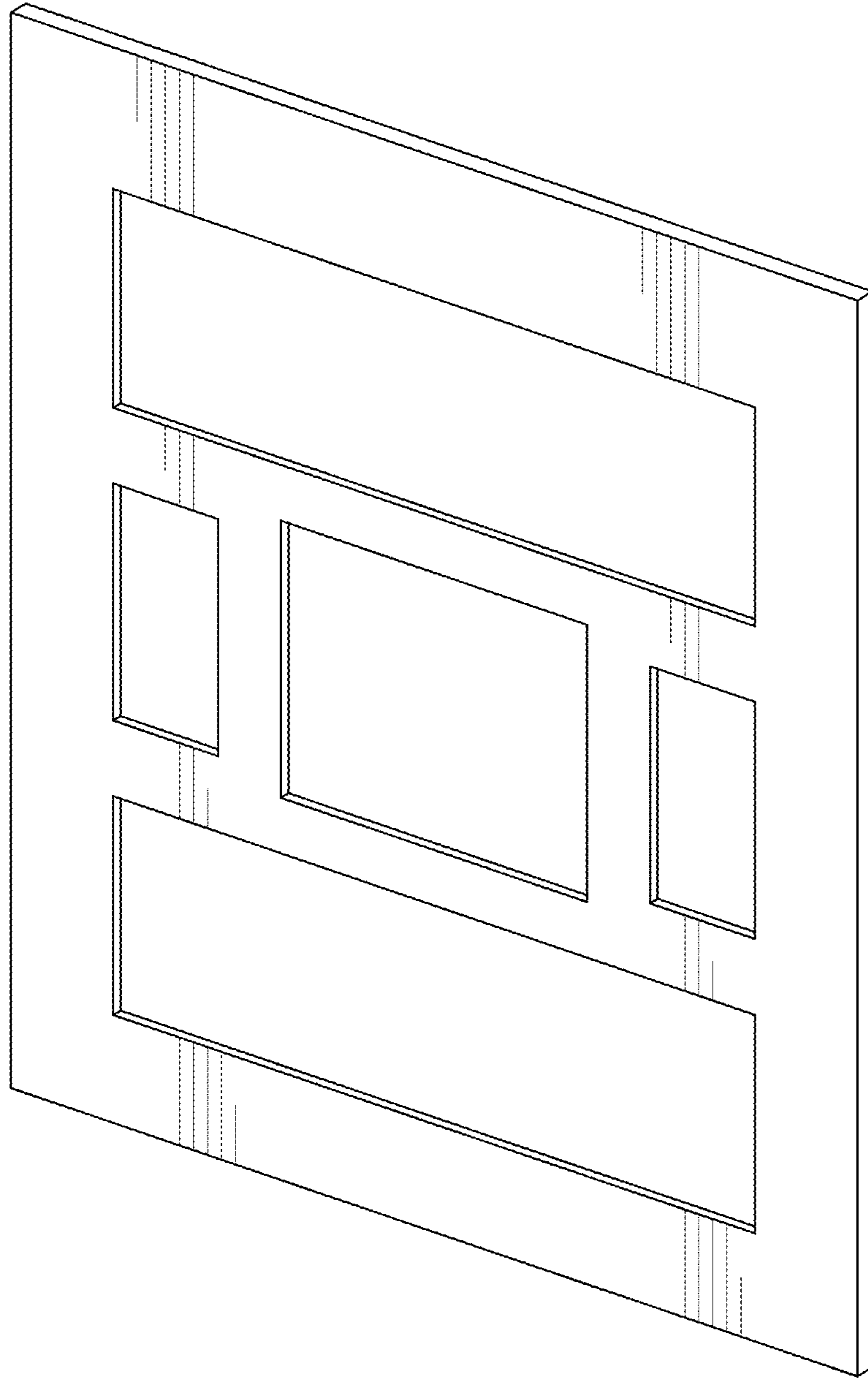

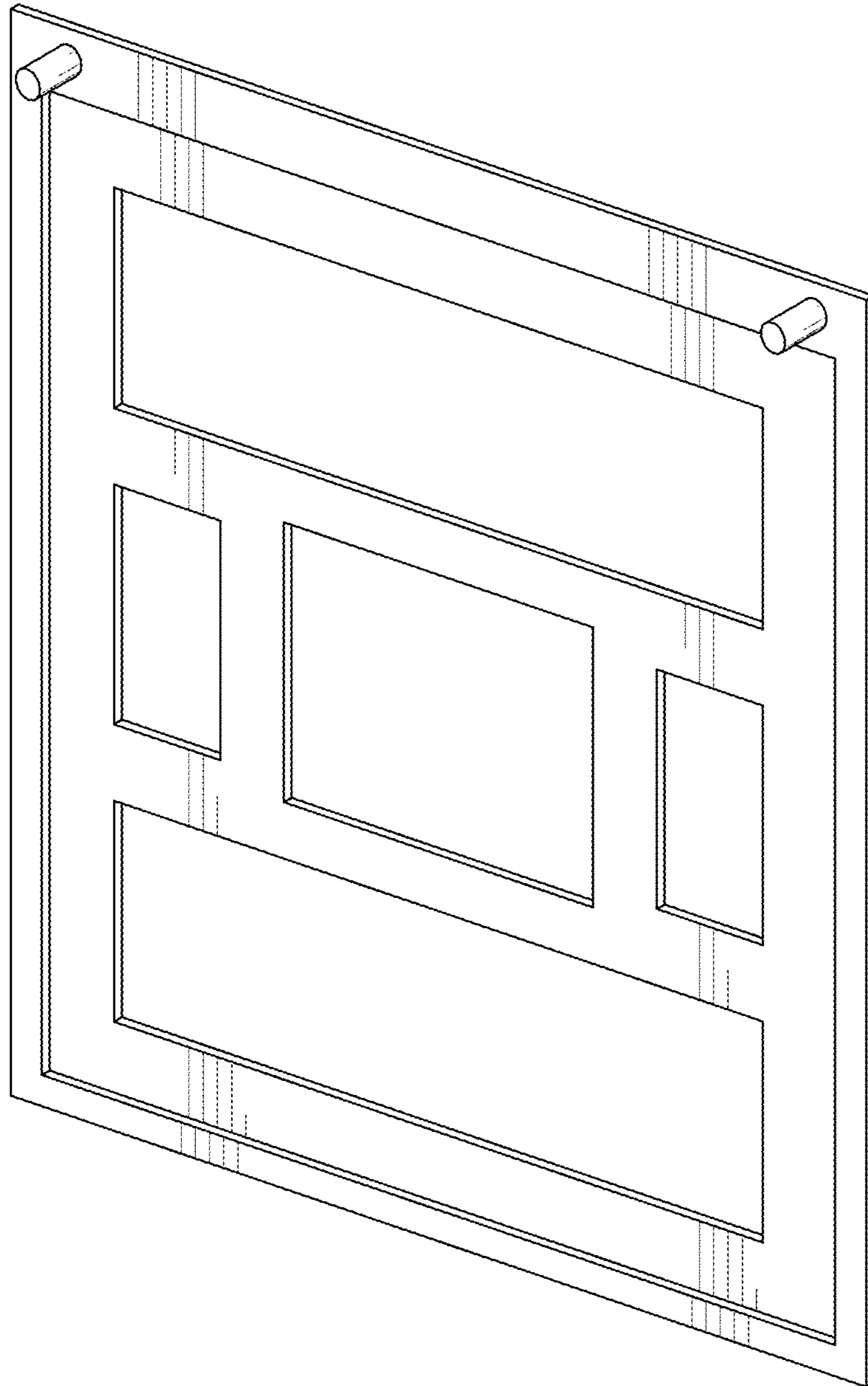

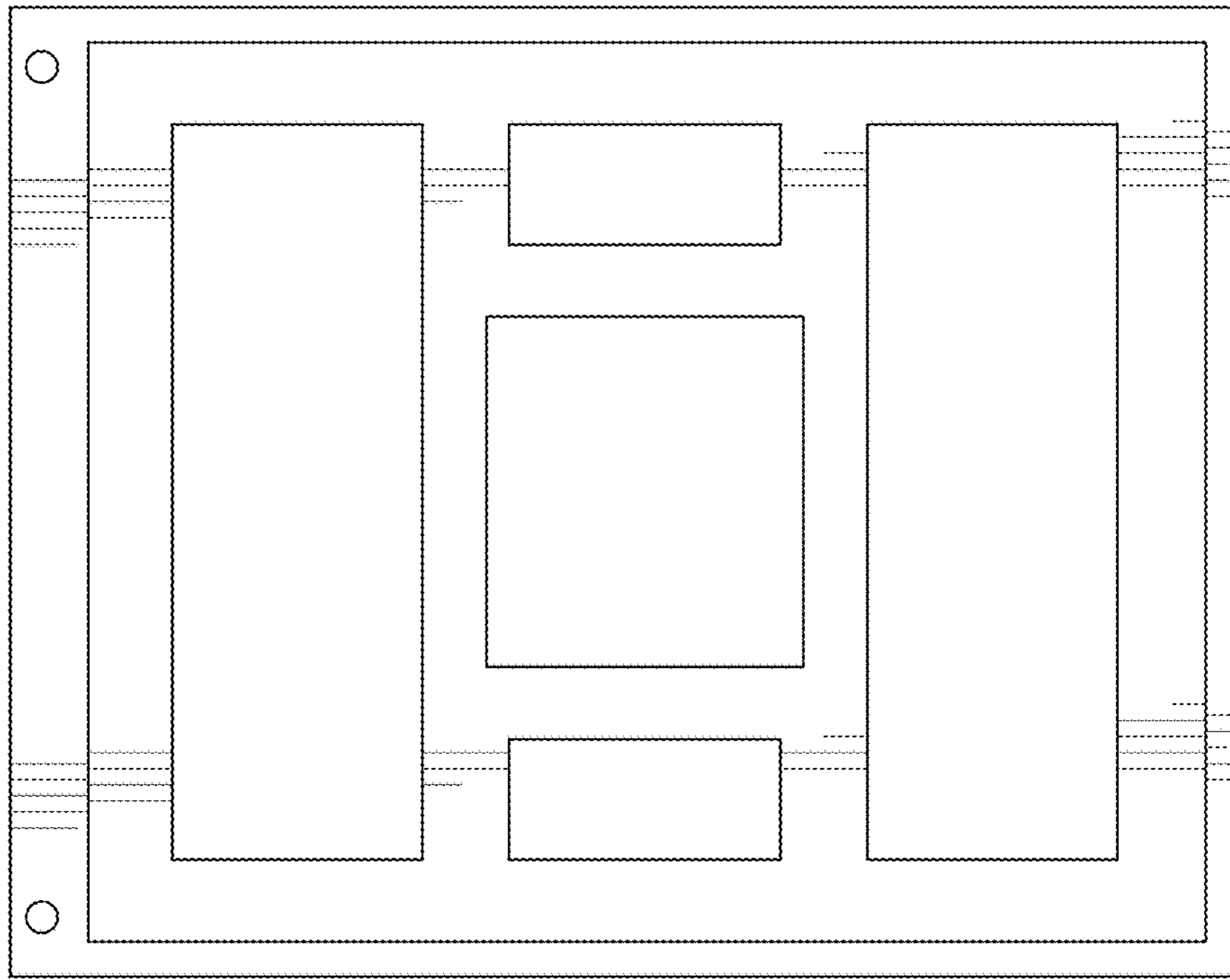

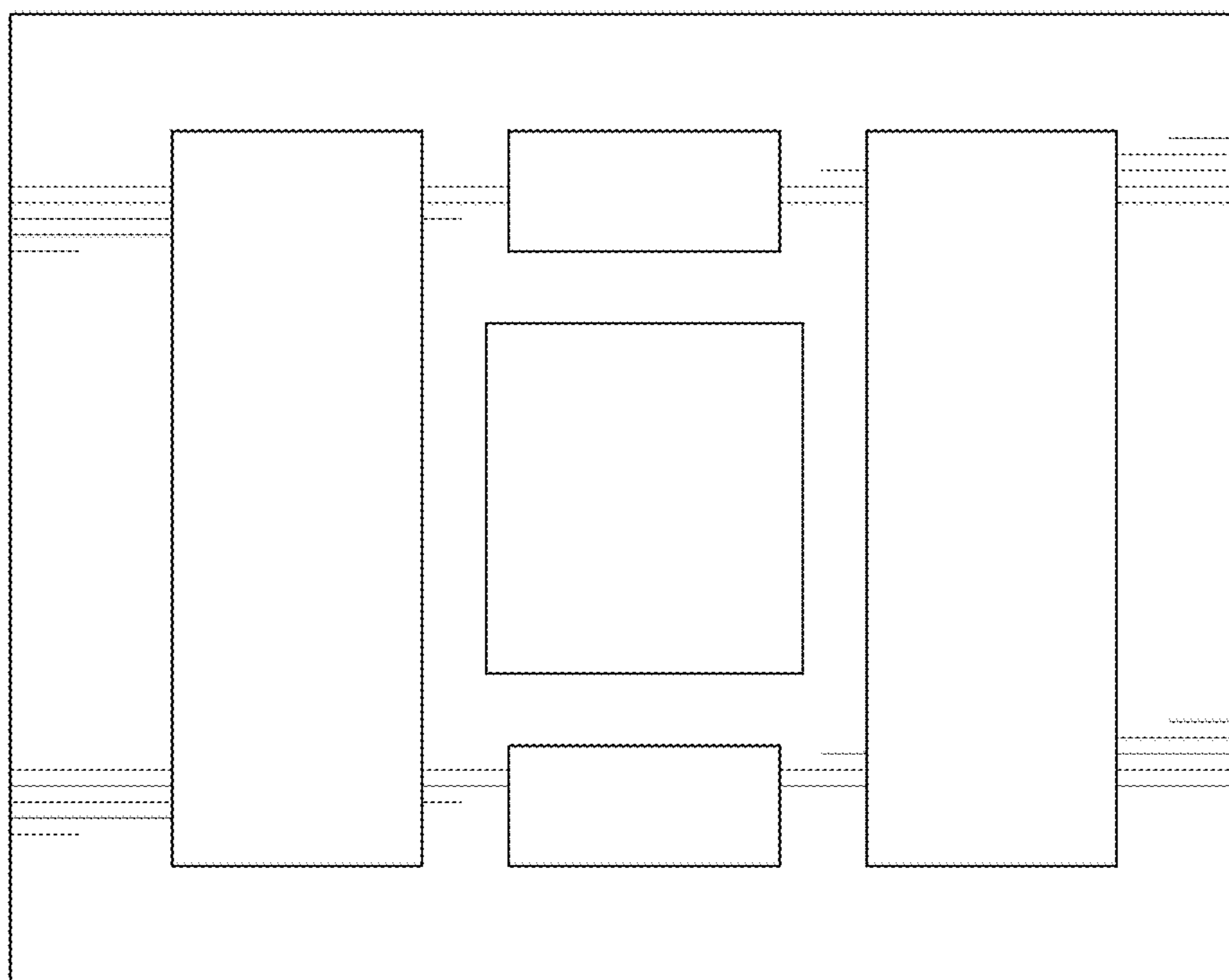

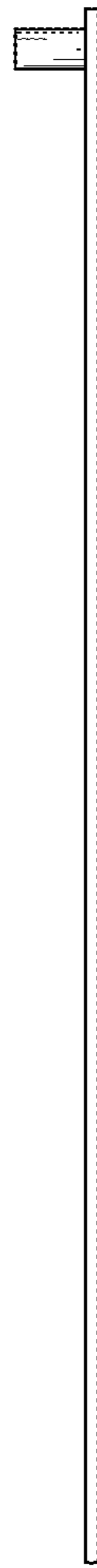
