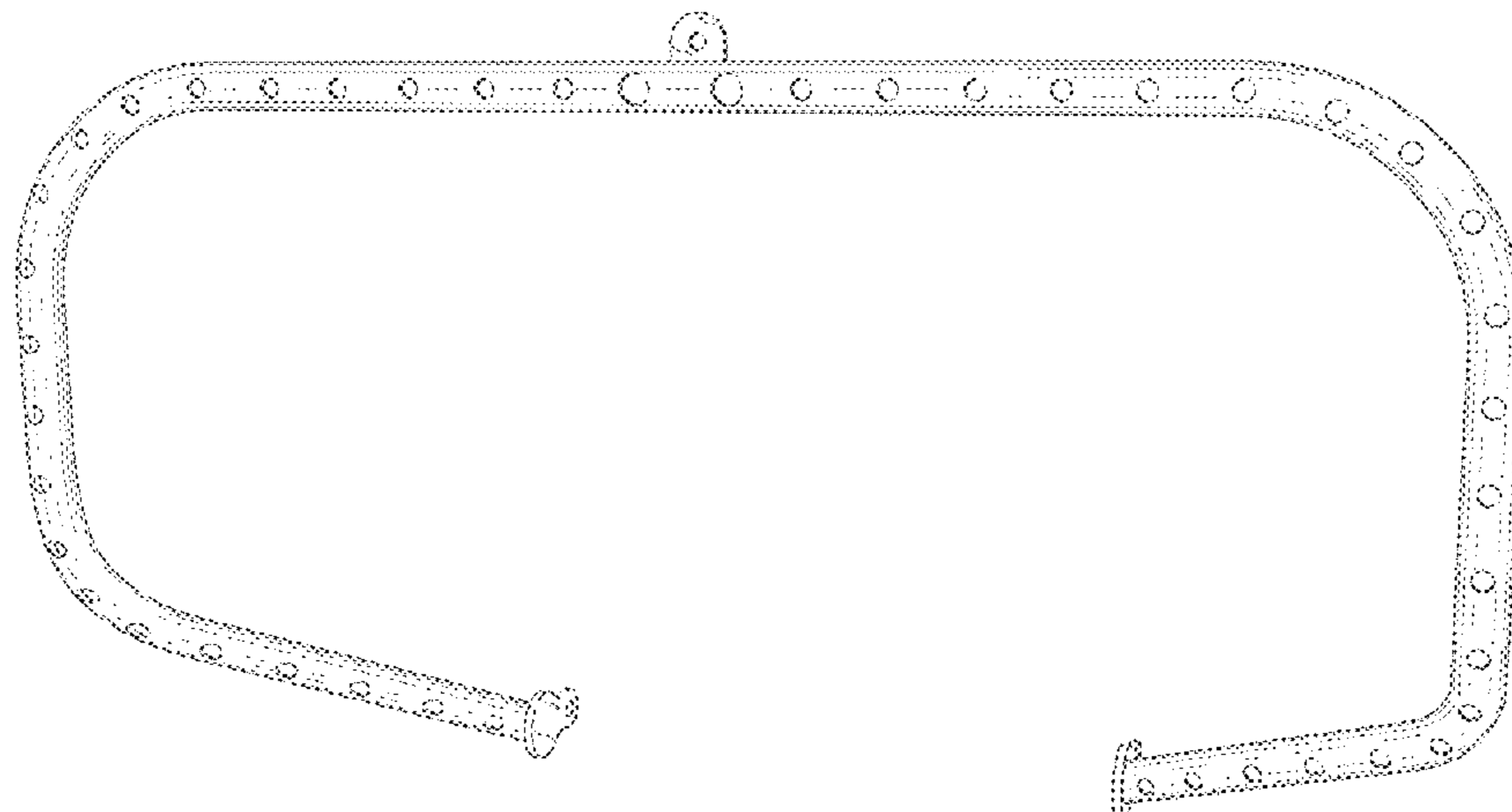
(57) **CLAIM**

The ornamental design for an illuminable motorcycle engine guard, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an illuminable motorcycle engine guard showing my new design;  
 FIG. 2 is a front elevation view thereof;  
 FIG. 3 is a rear elevation view thereof;  
 FIG. 4 is a left side elevation view thereof;  
 FIG. 5 is a right side elevation view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a bottom plan view thereof; and,  
 FIG. 8 is a front perspective view thereof when installed on an exemplary motorcycle.  
 The broken line showing of the motorcycle is provided for the purpose of illustrating environmental structure and forms no part of the claimed design.

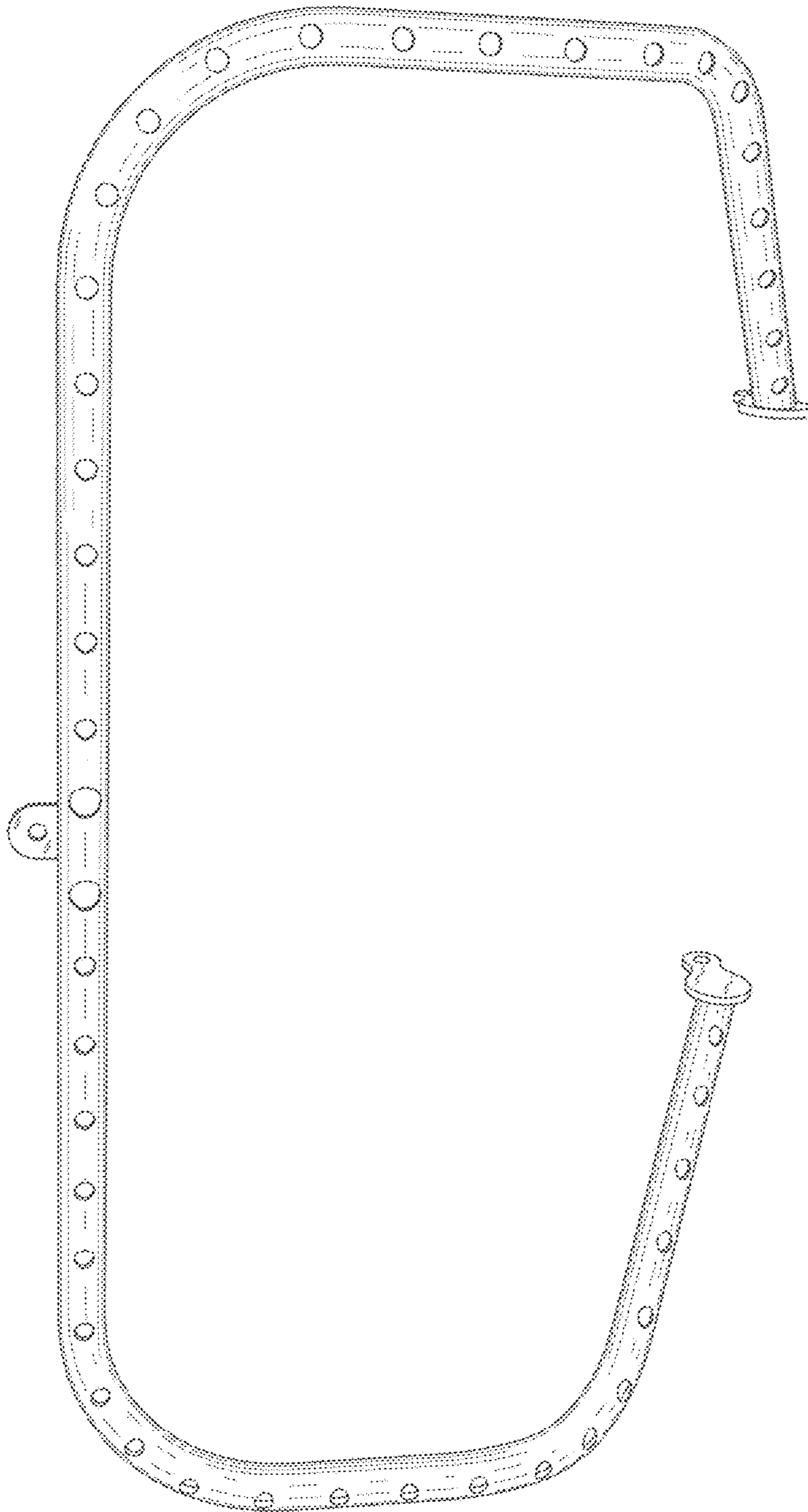

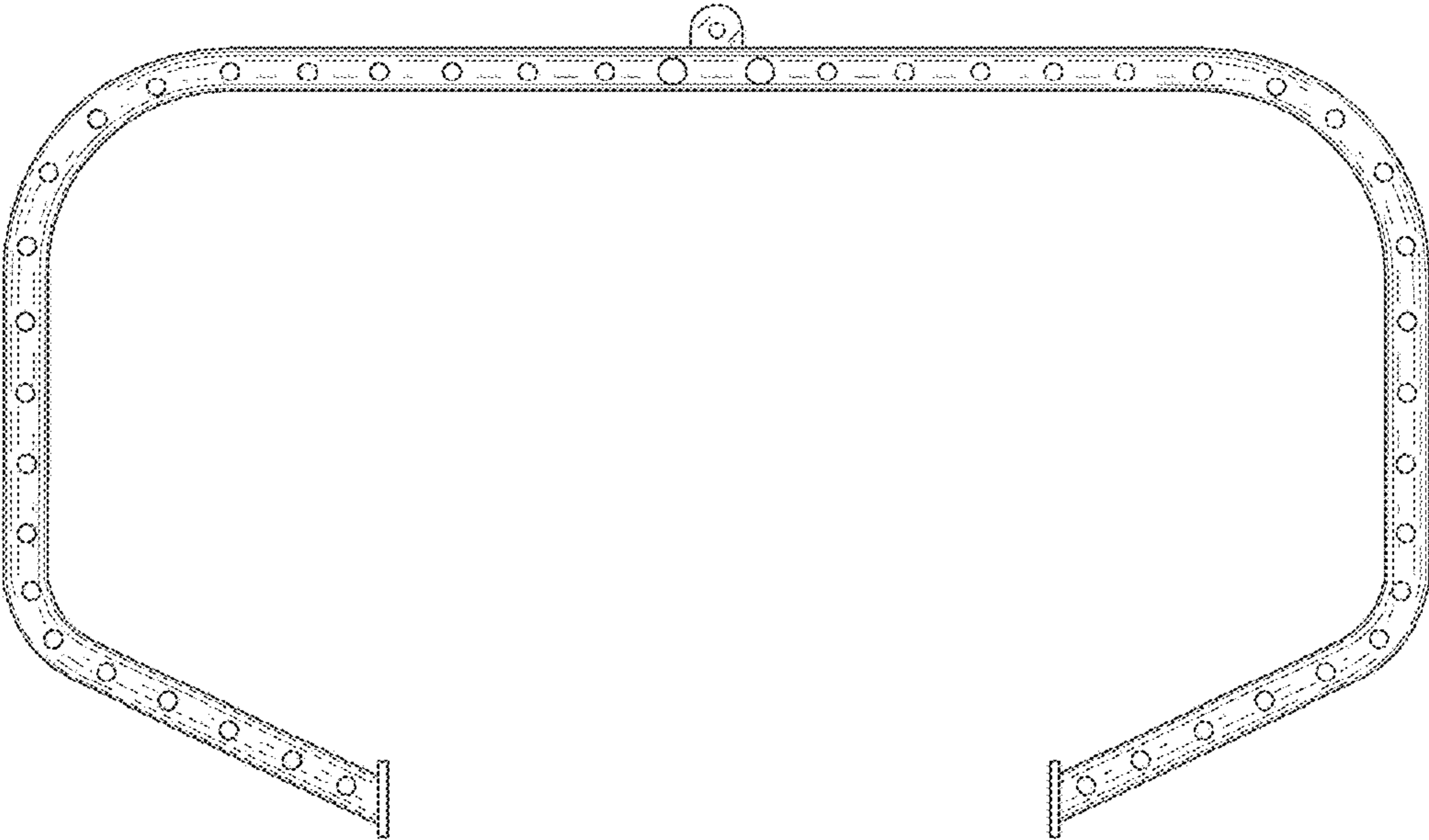

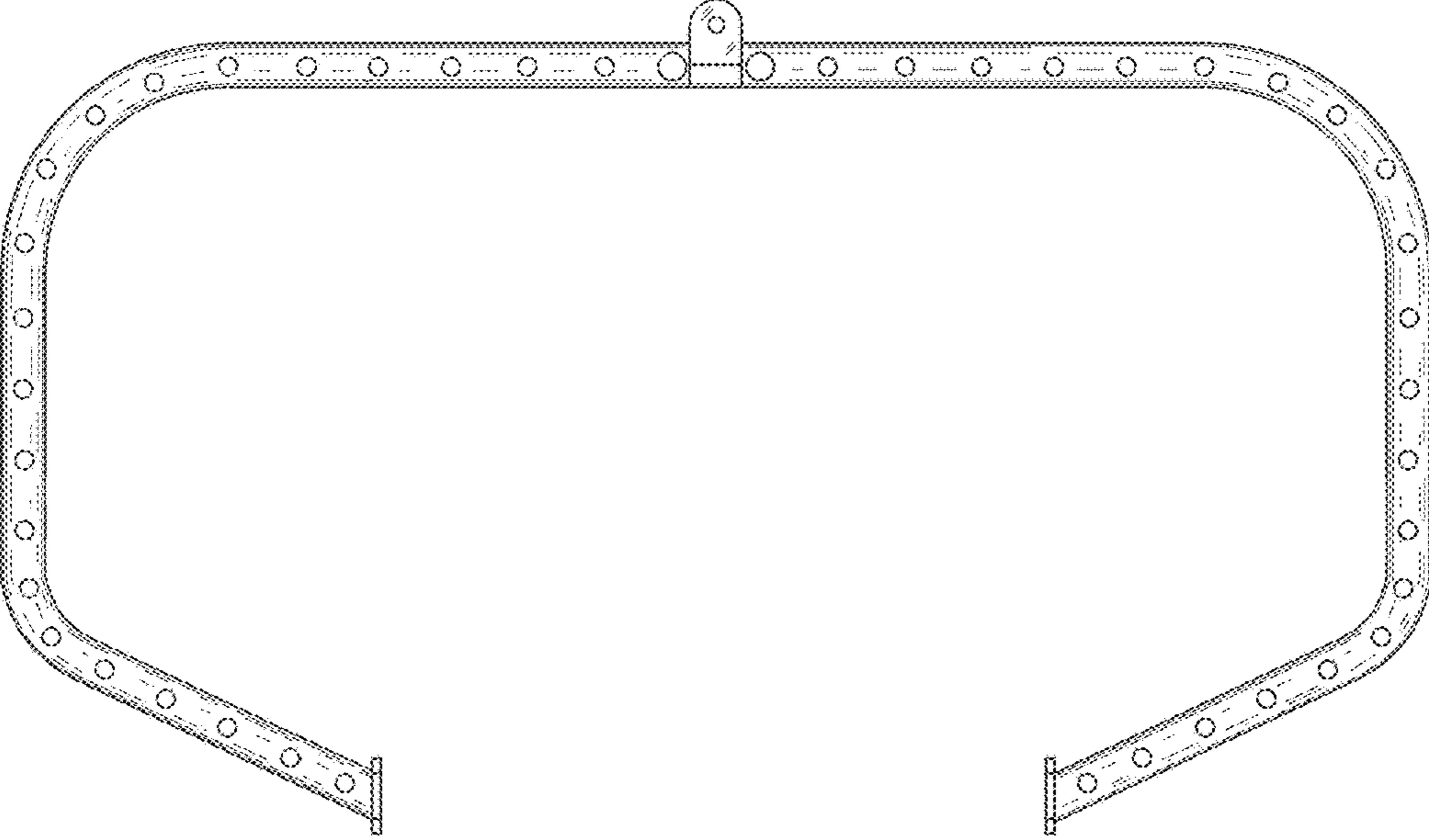

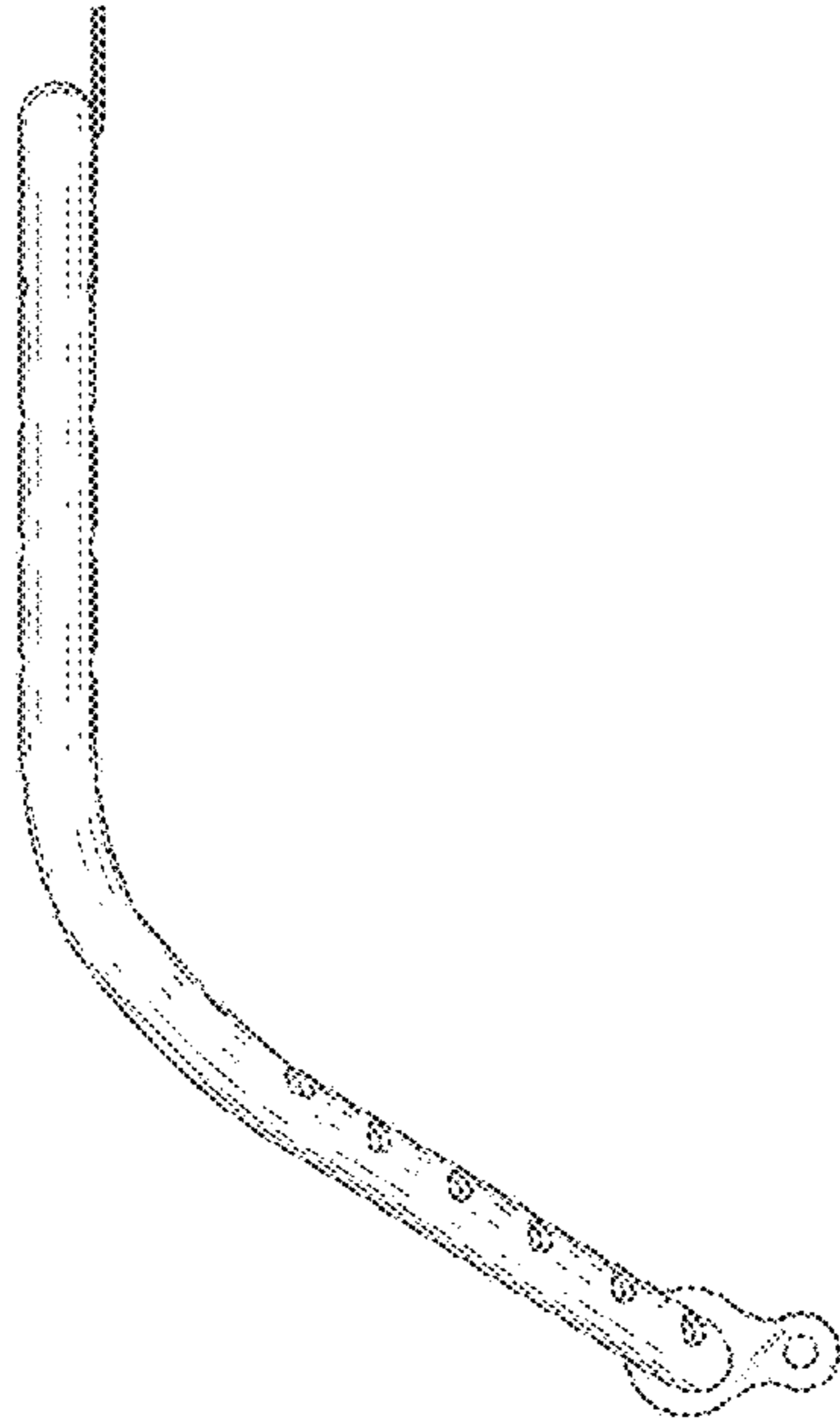

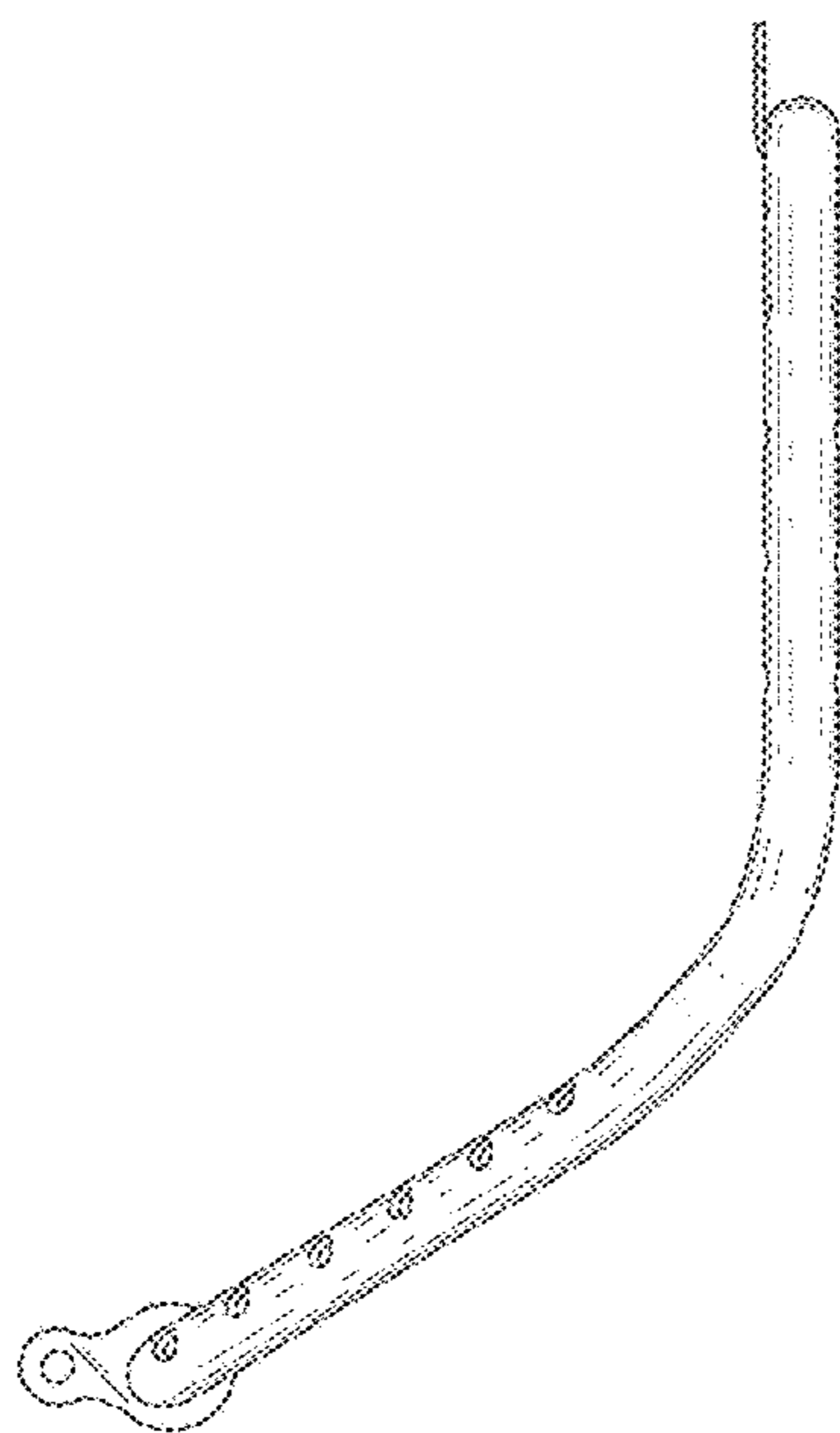

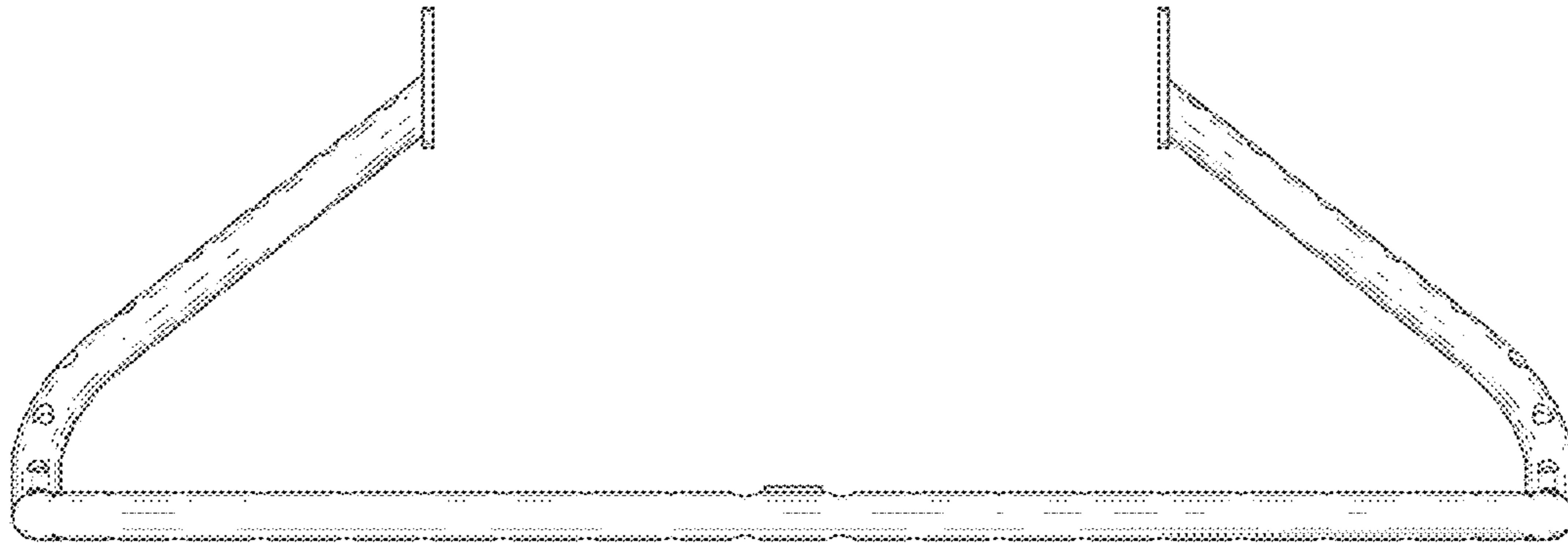

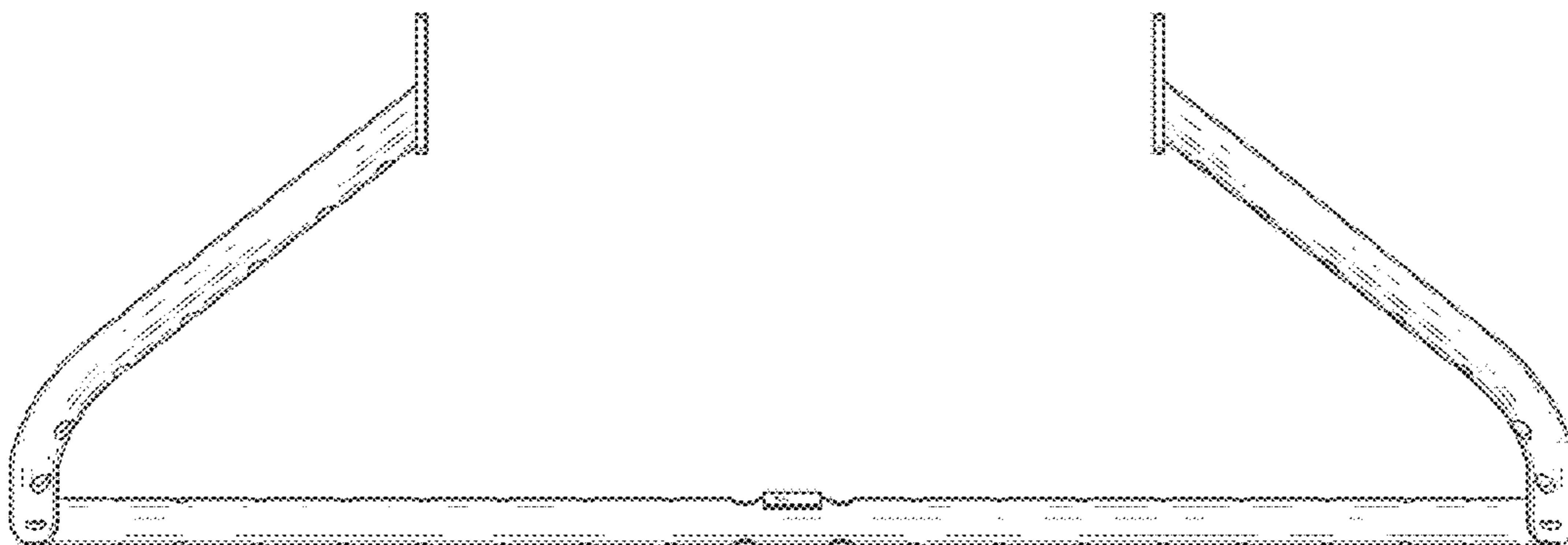

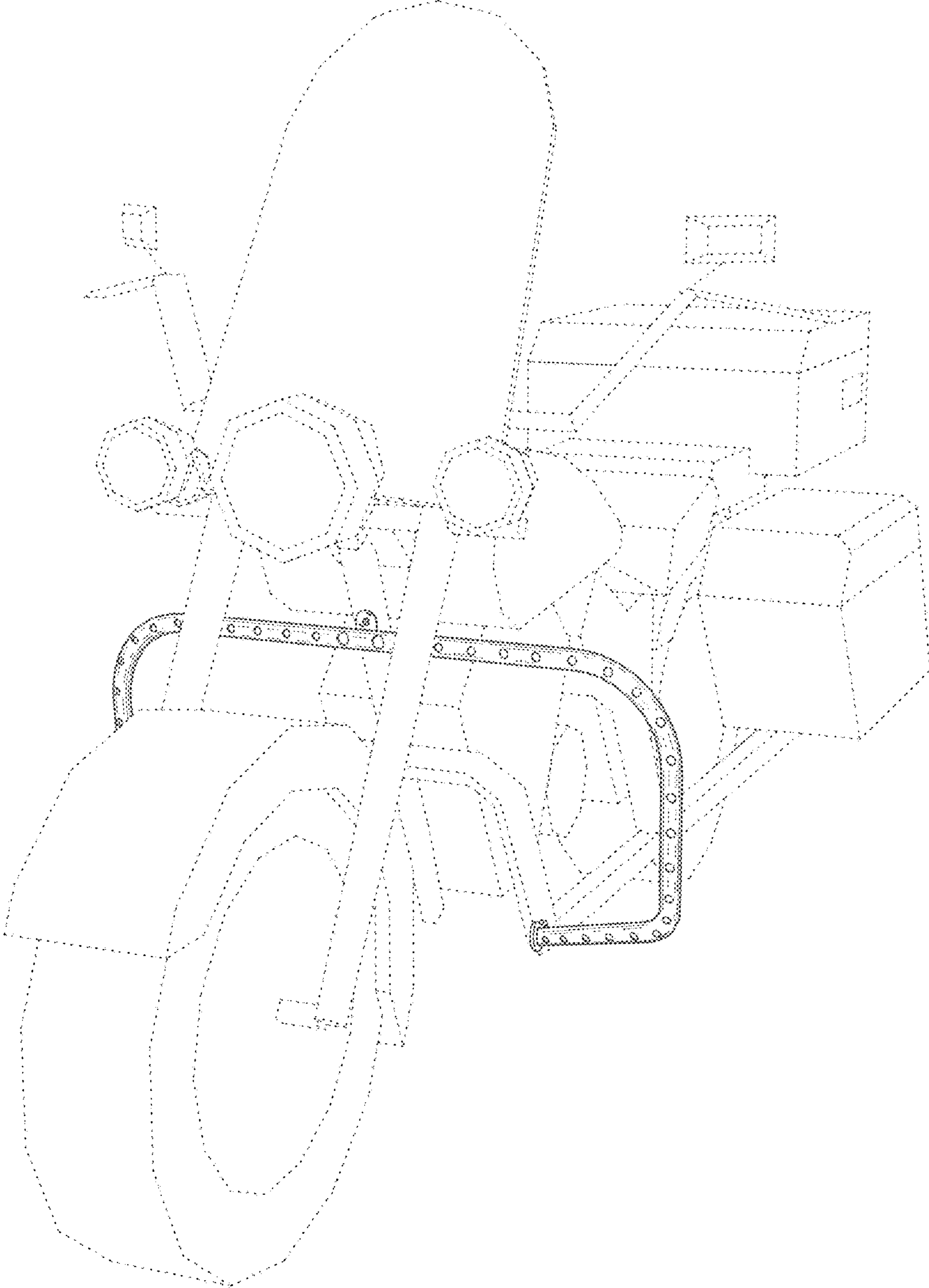
