(57) **CLAIM**

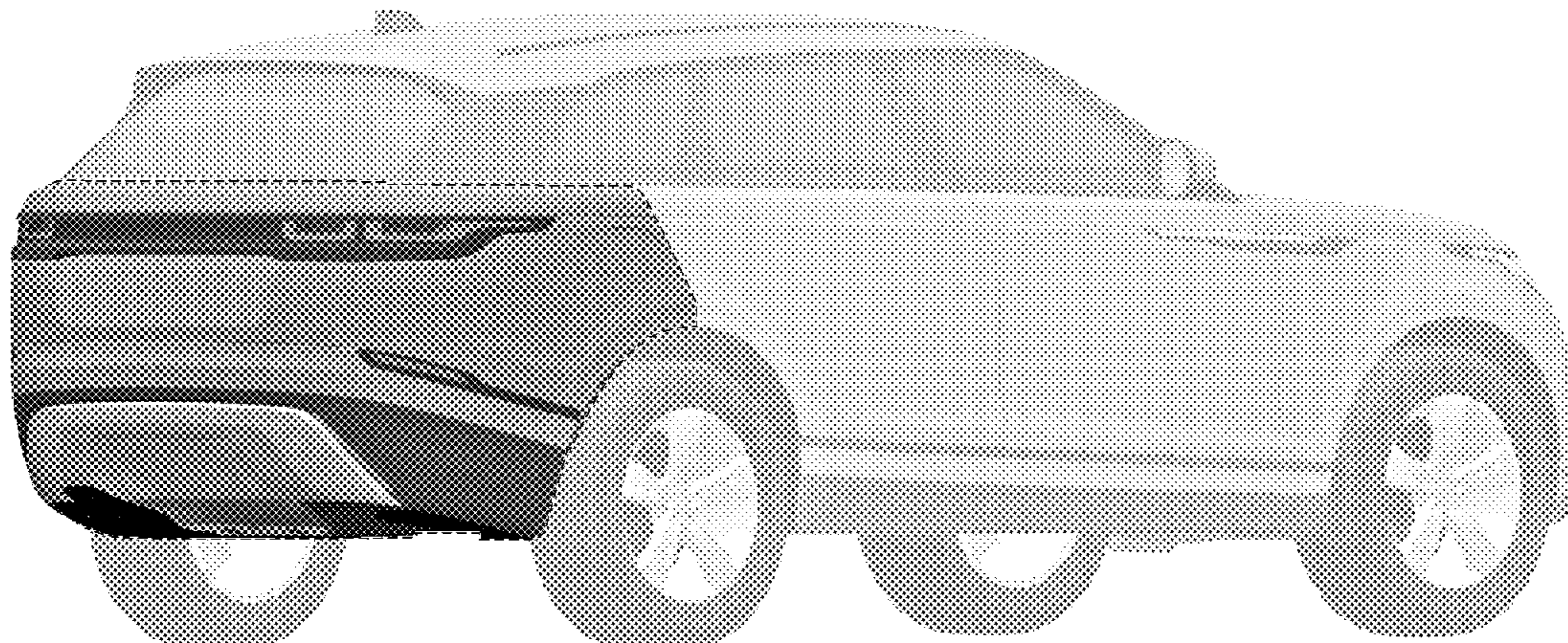
The ornamental design for a rear end of a vehicle, as shown and described.

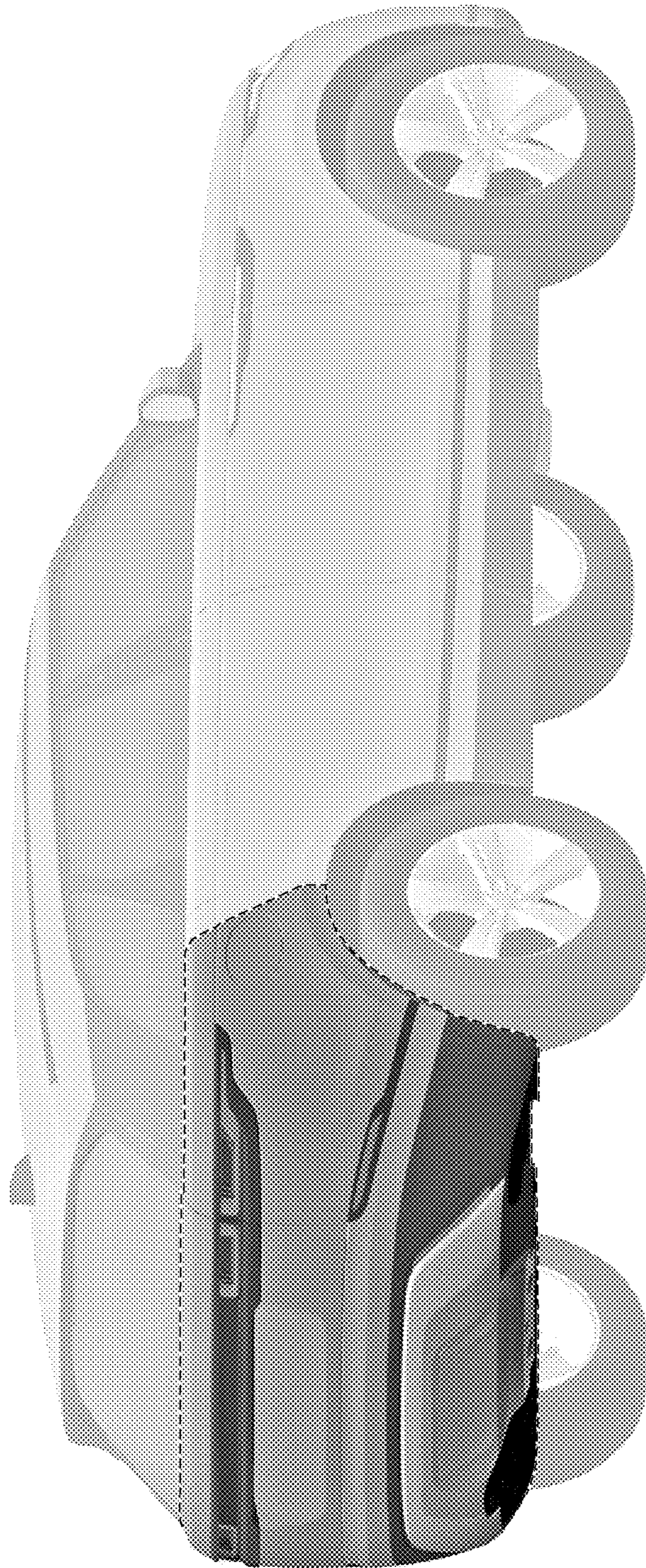

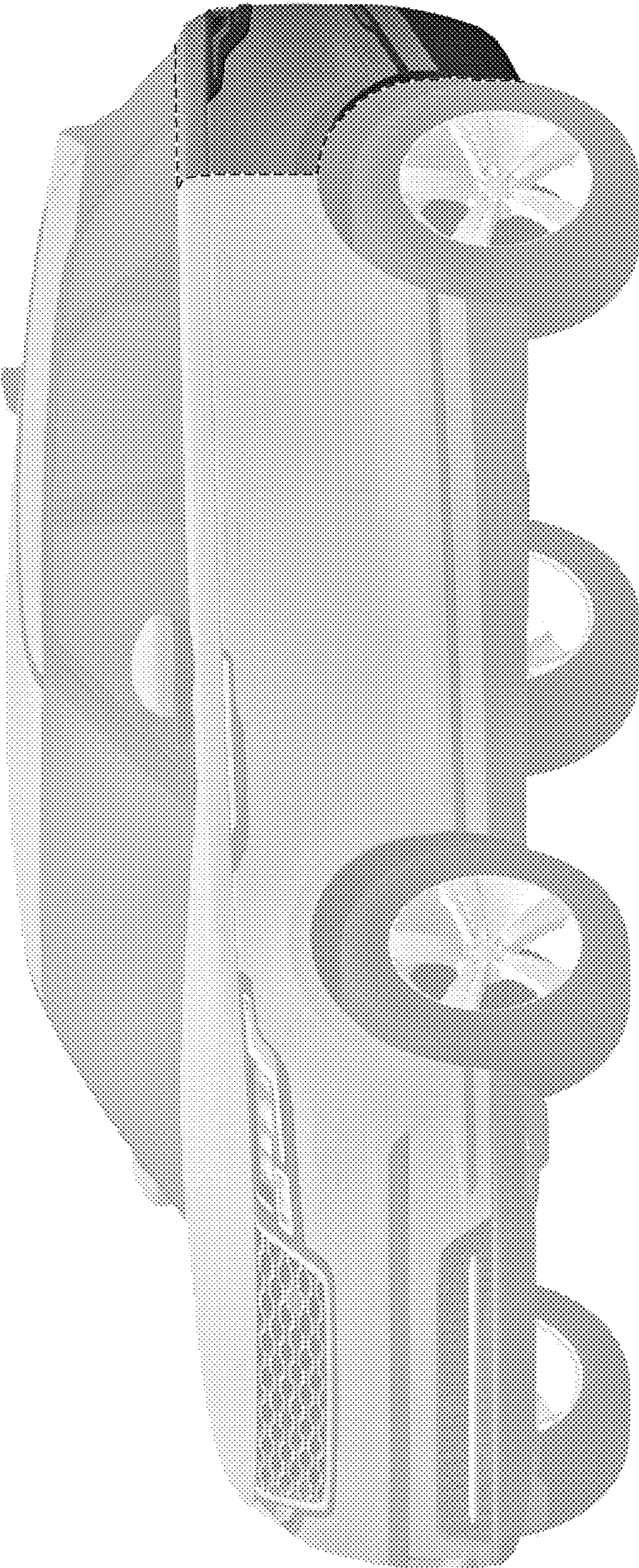

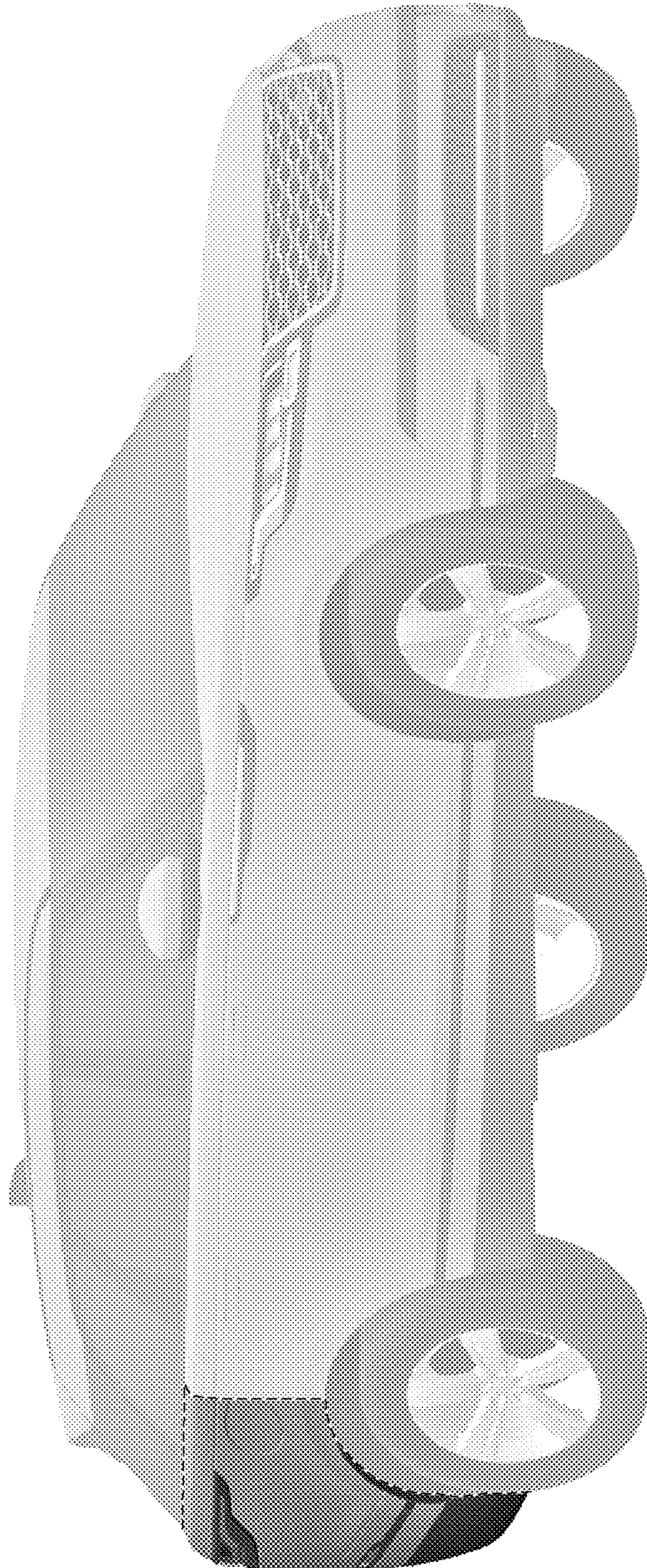

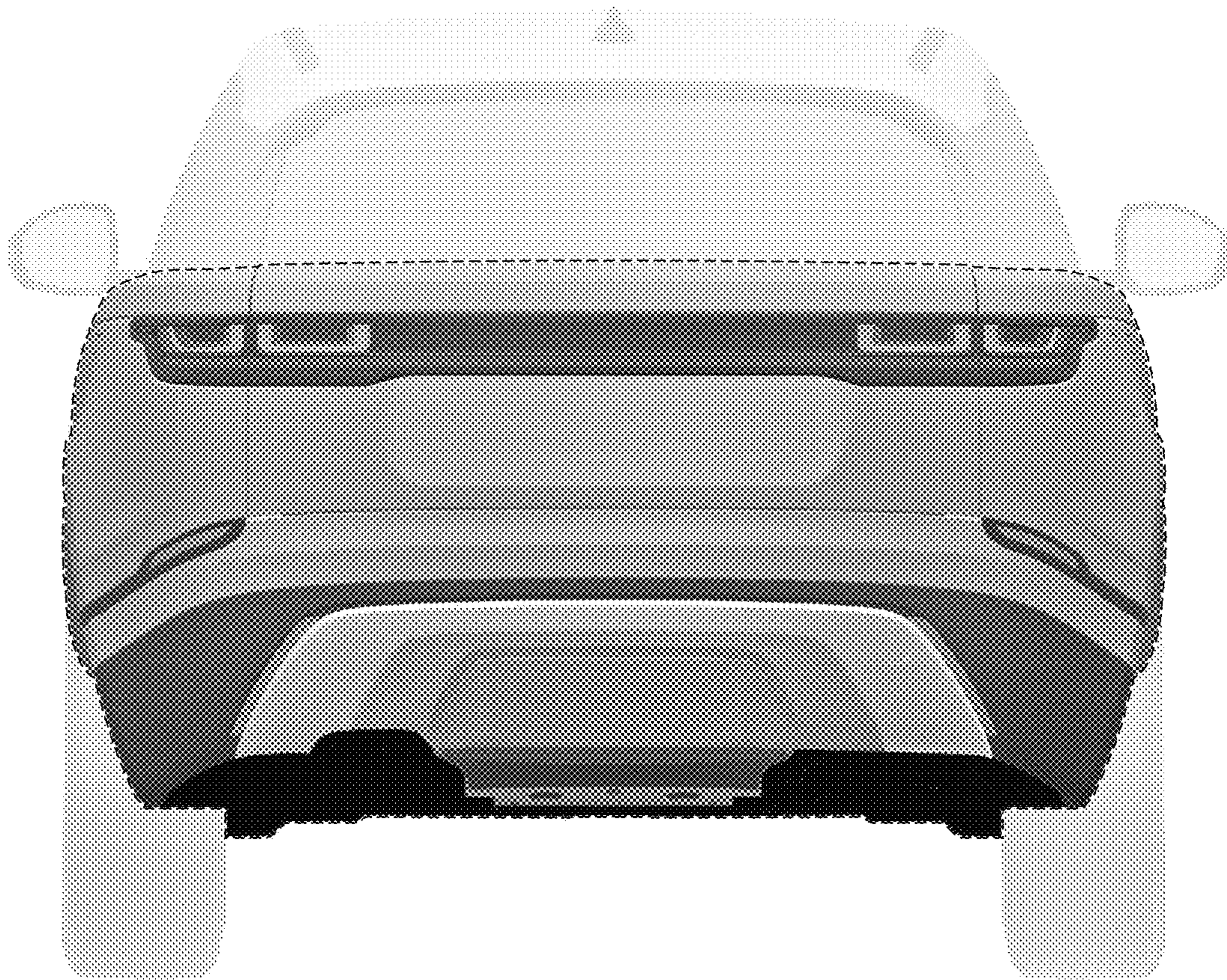

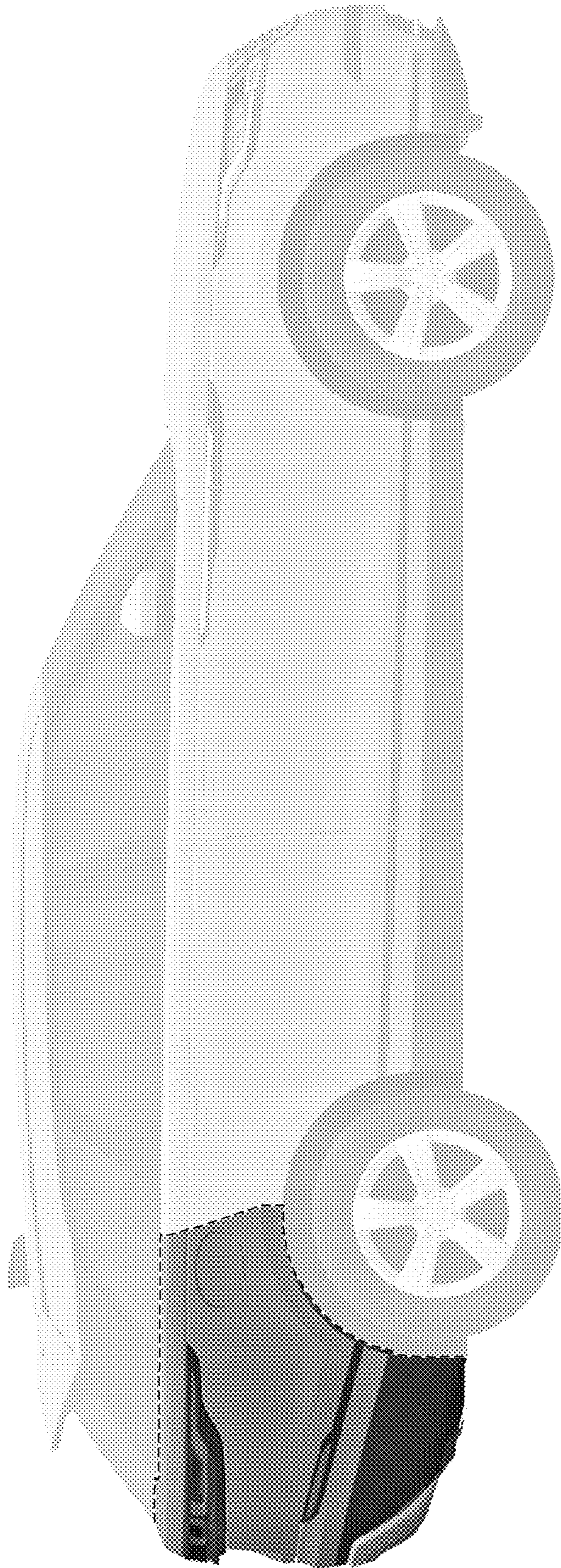

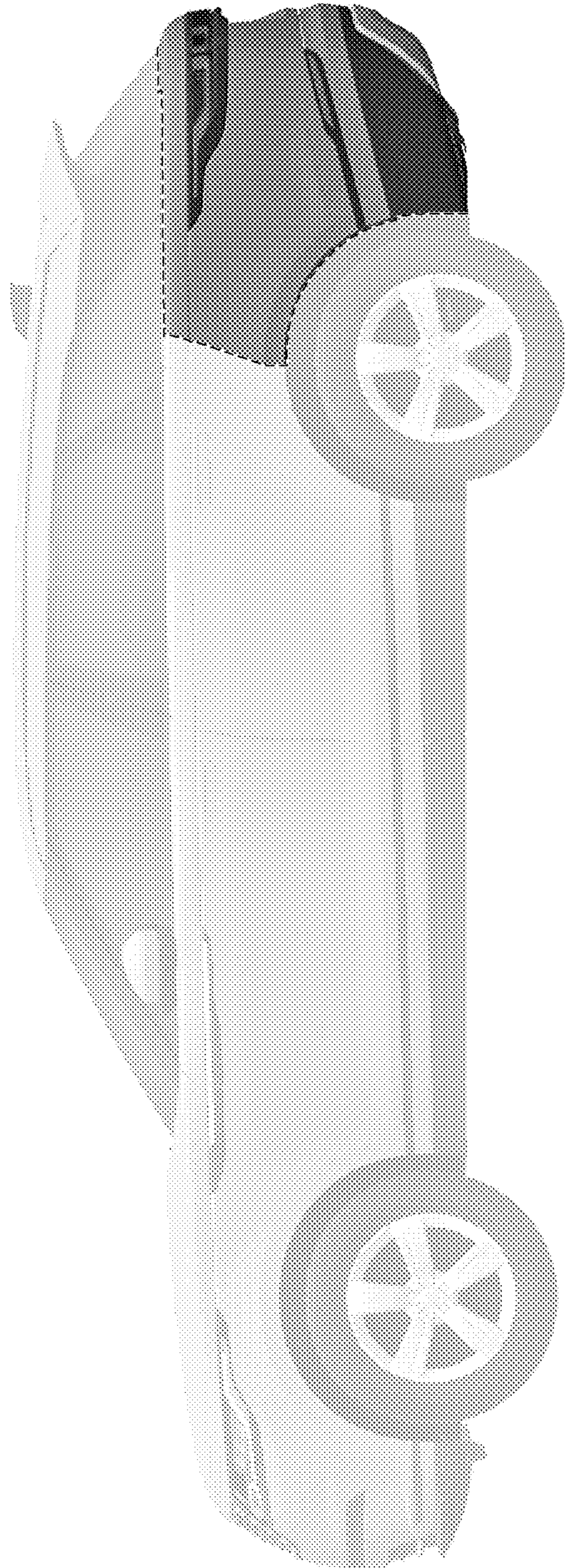
