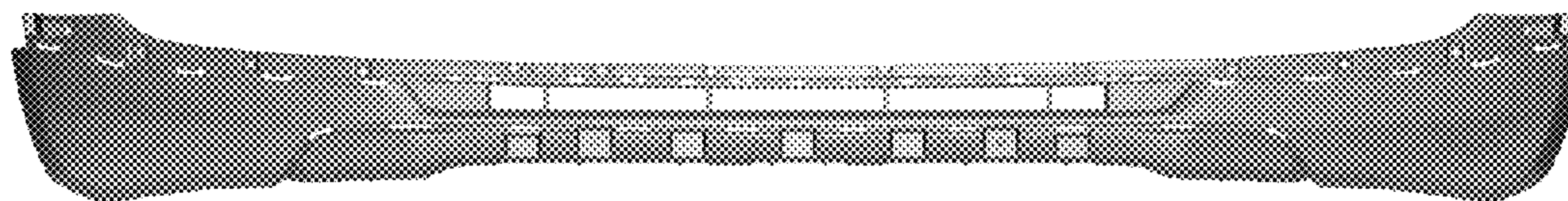
(57) **CLAIM**

The ornamental design for a vehicle front lower bumper cover, as shown and described.

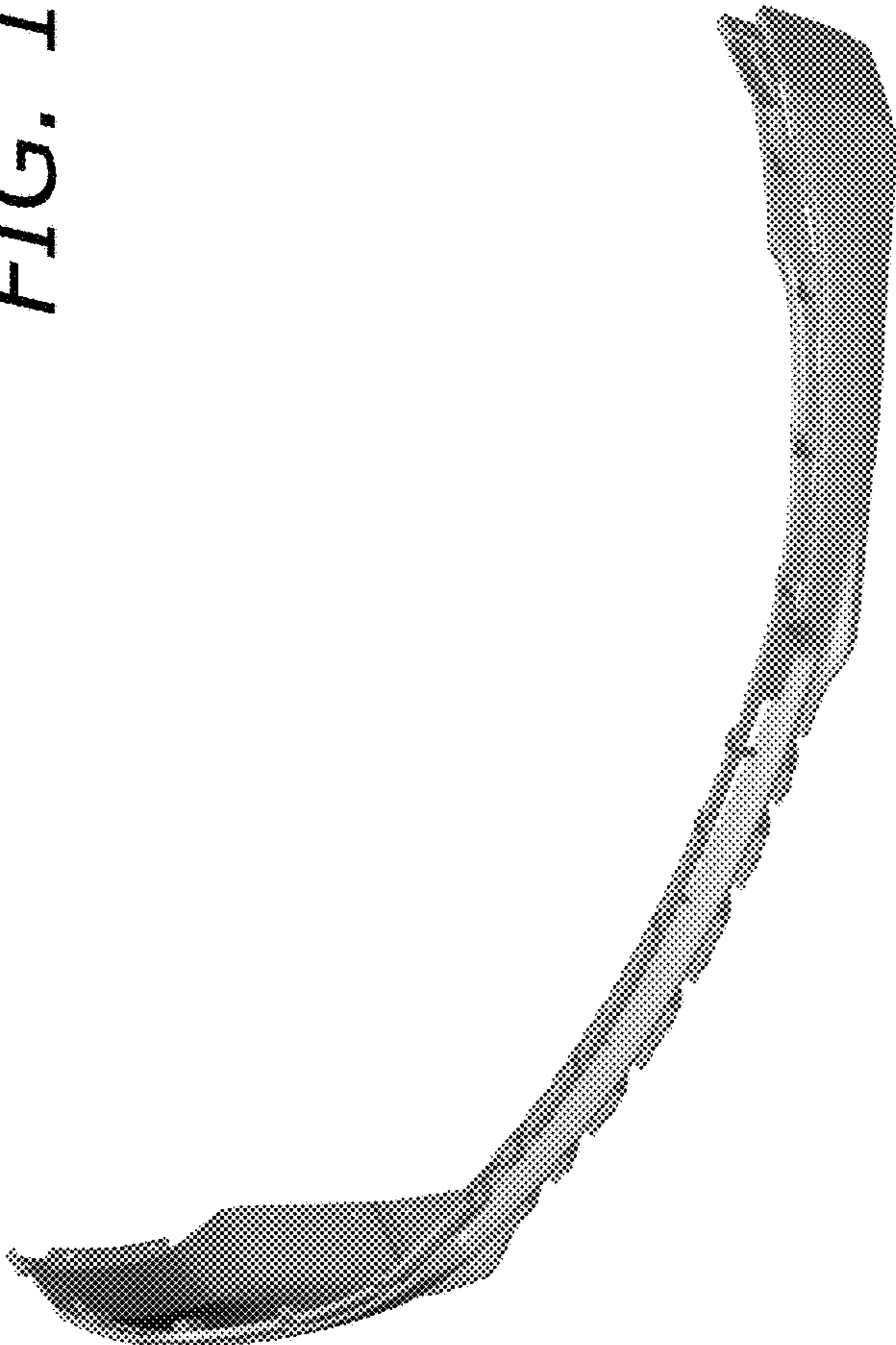
**DESCRIPTION**

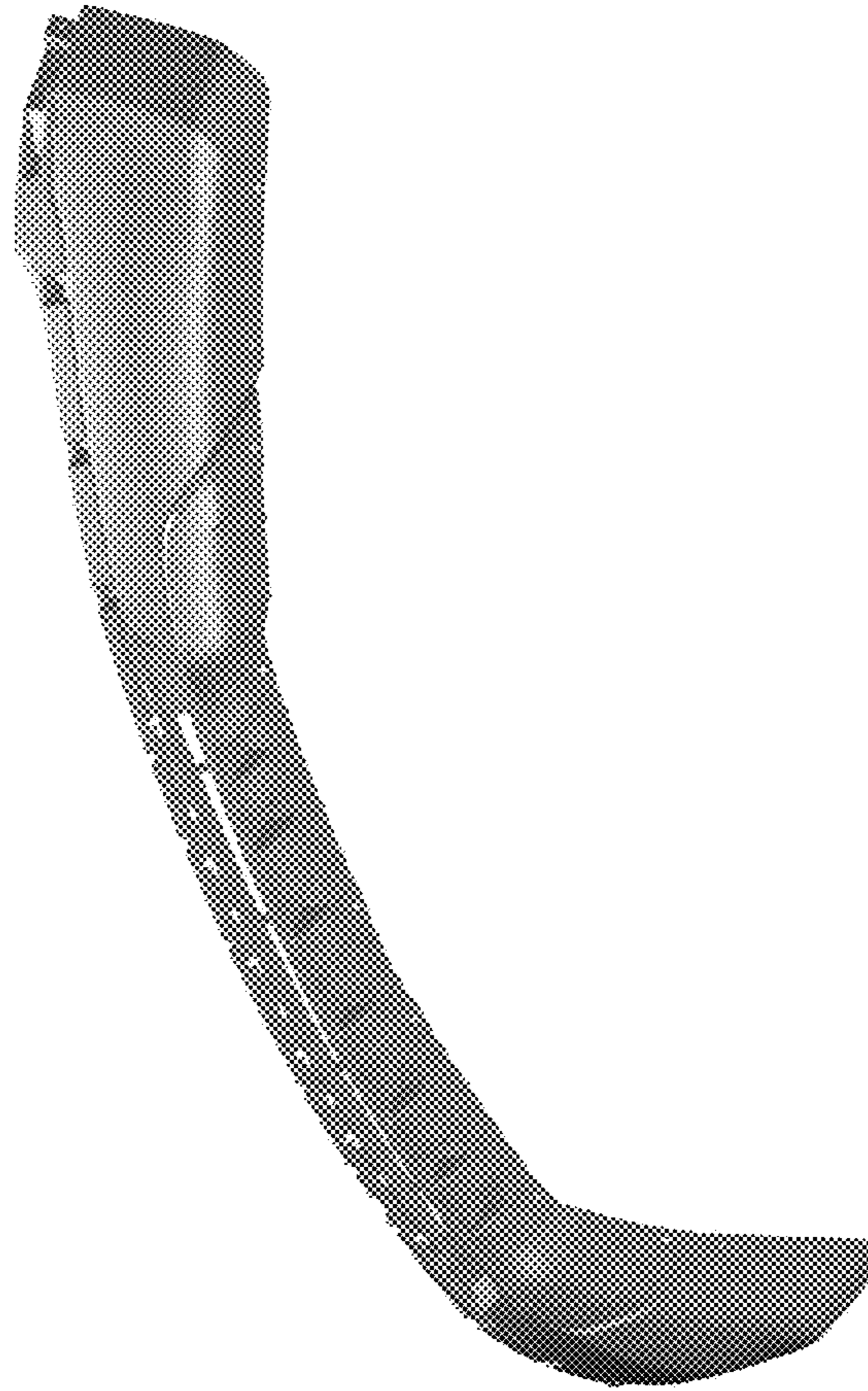
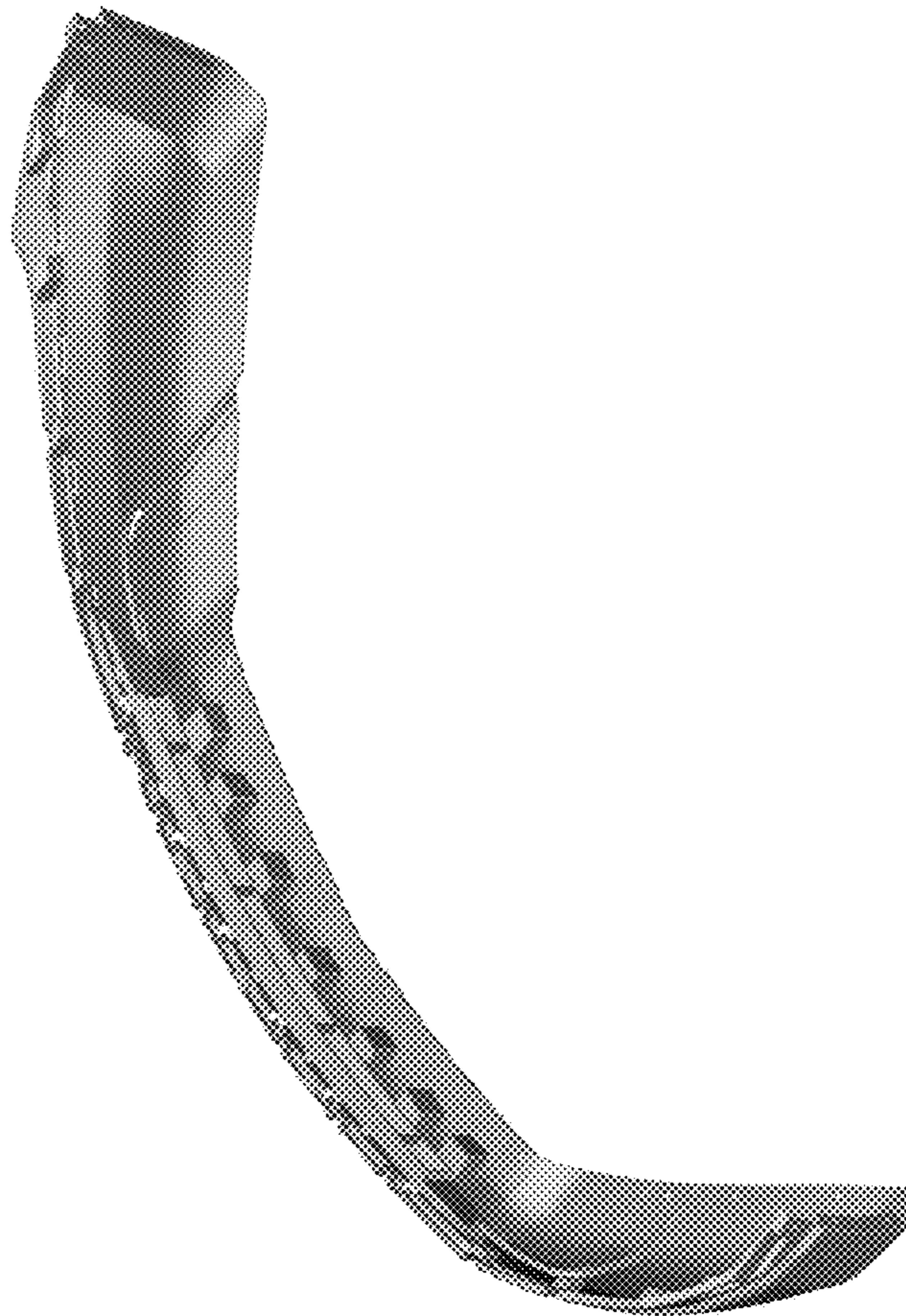

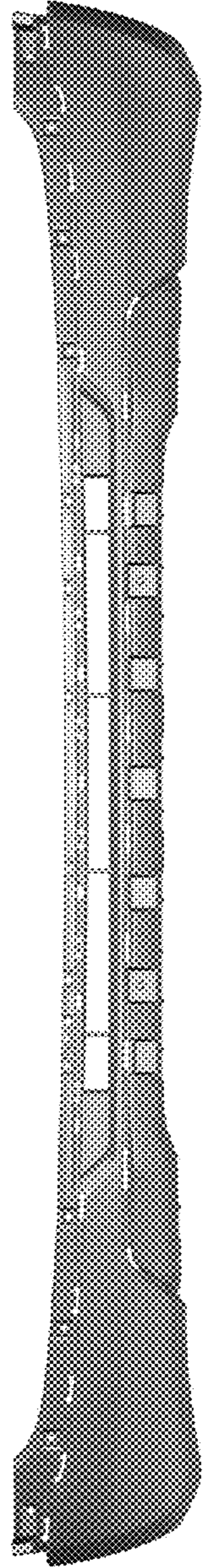

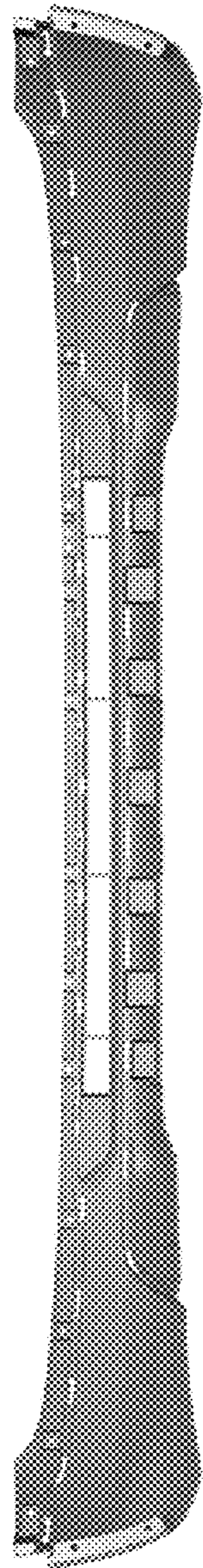

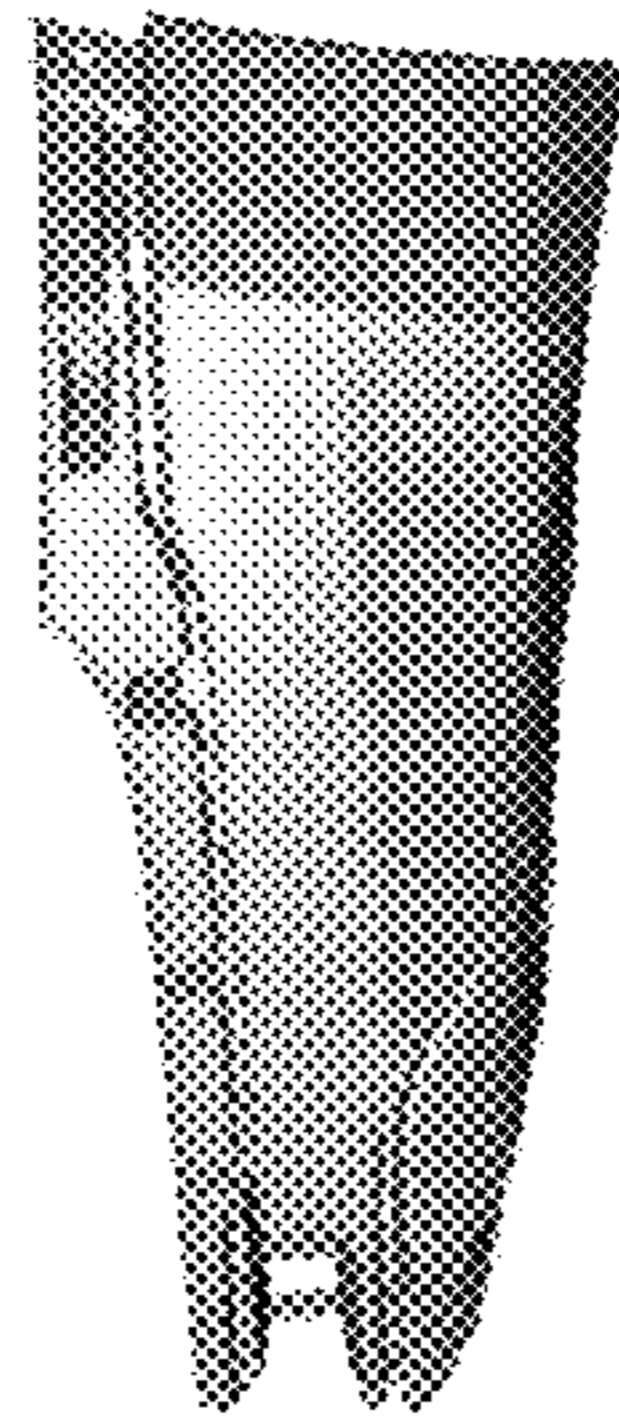

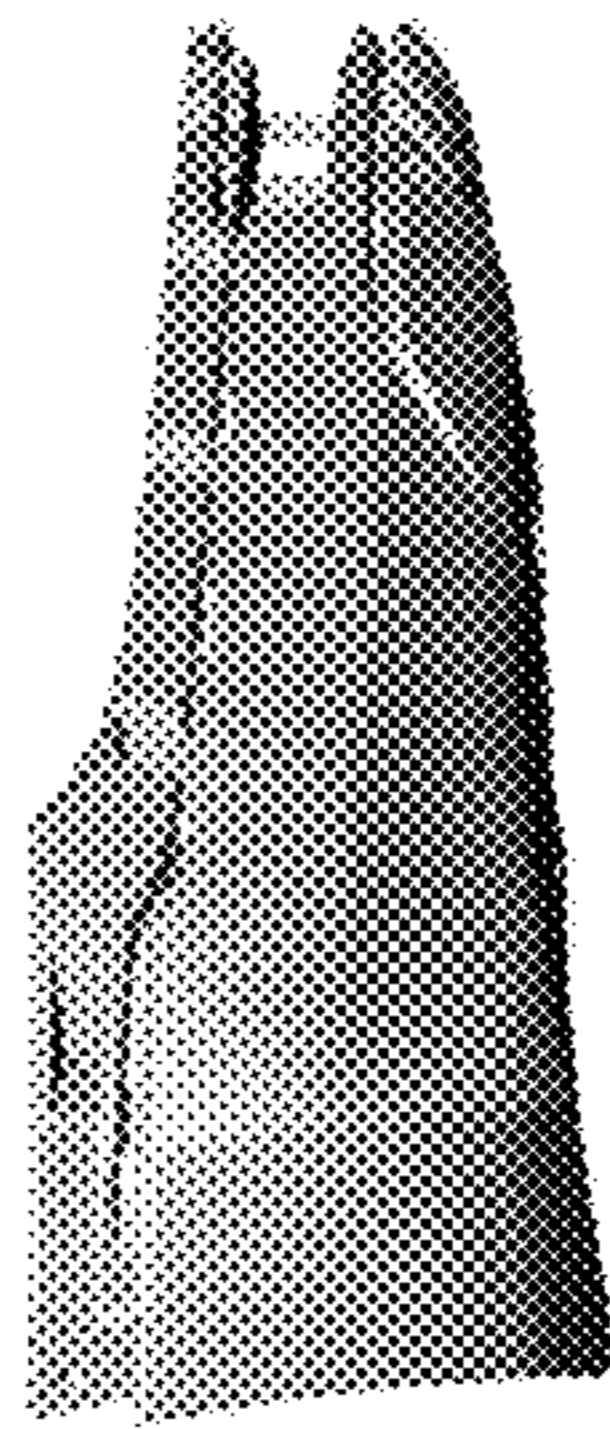

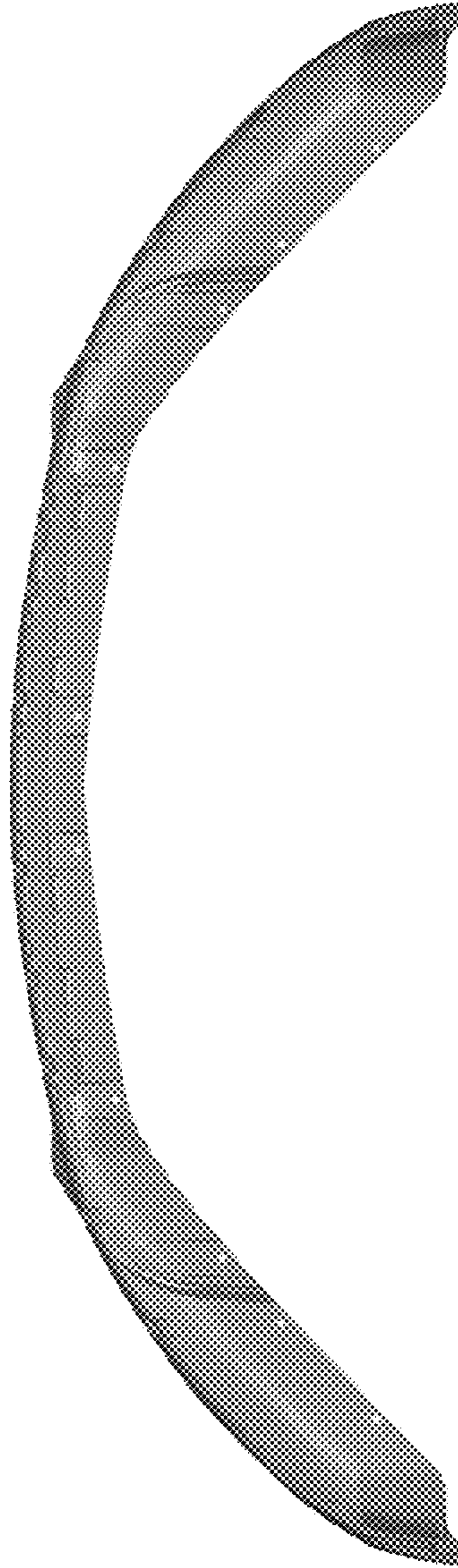

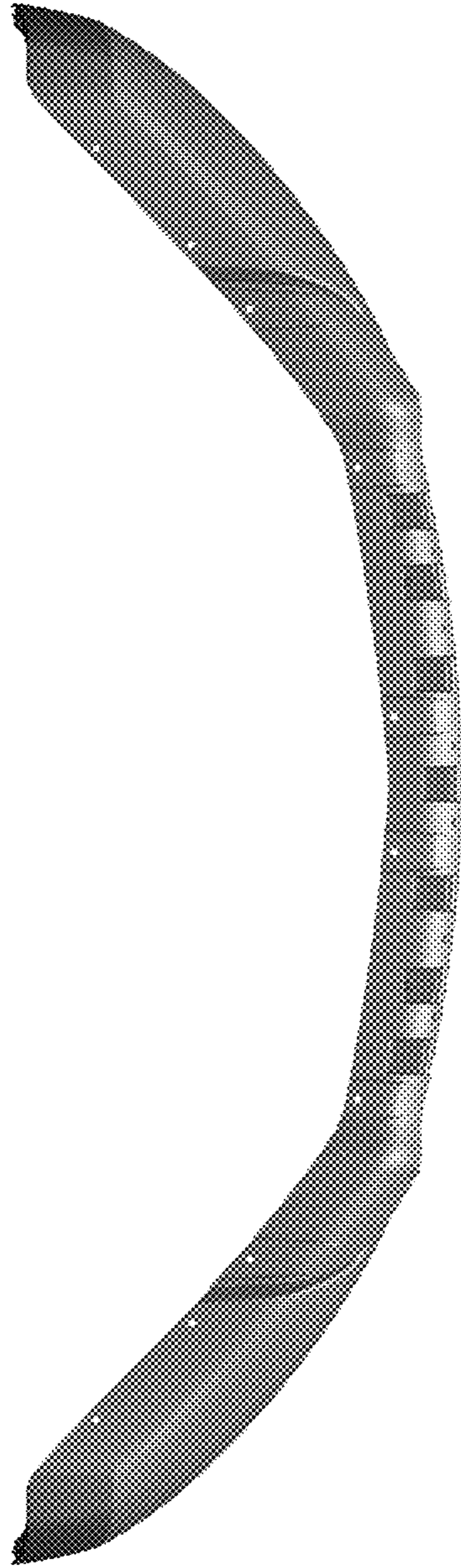
