FIG. 18 is front elevation view thereof;

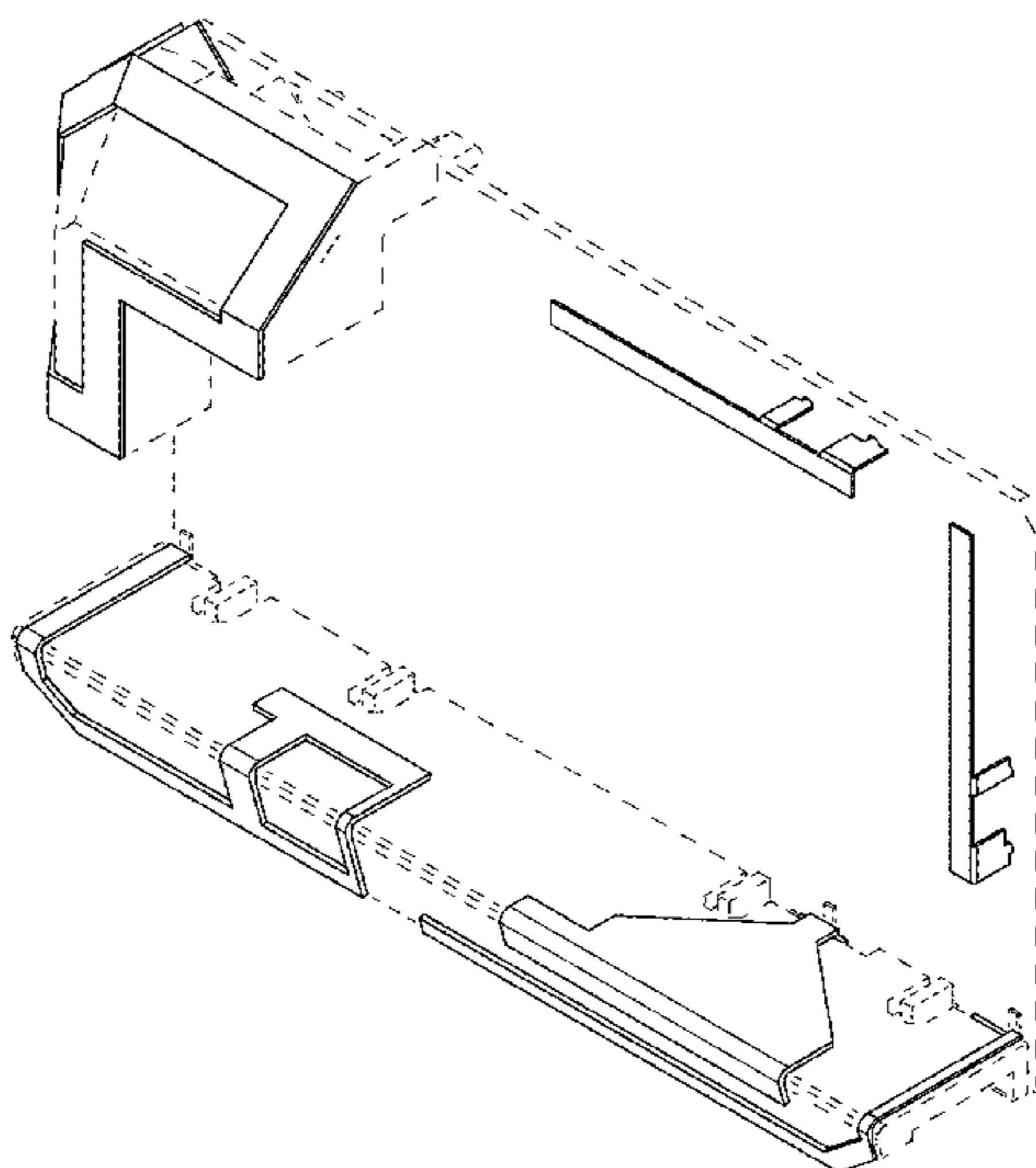
FIG. 19 is a rear elevation view thereof;

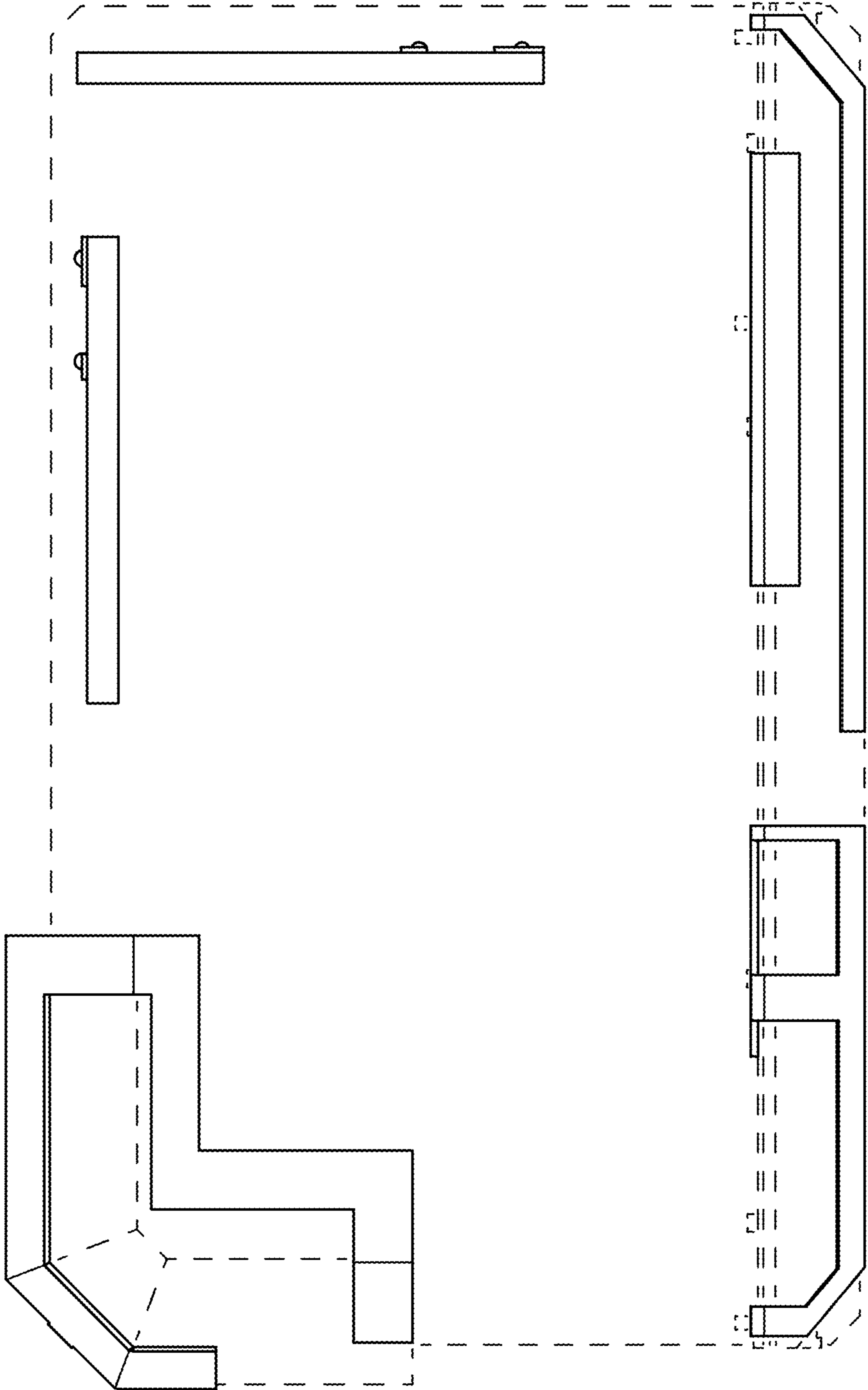

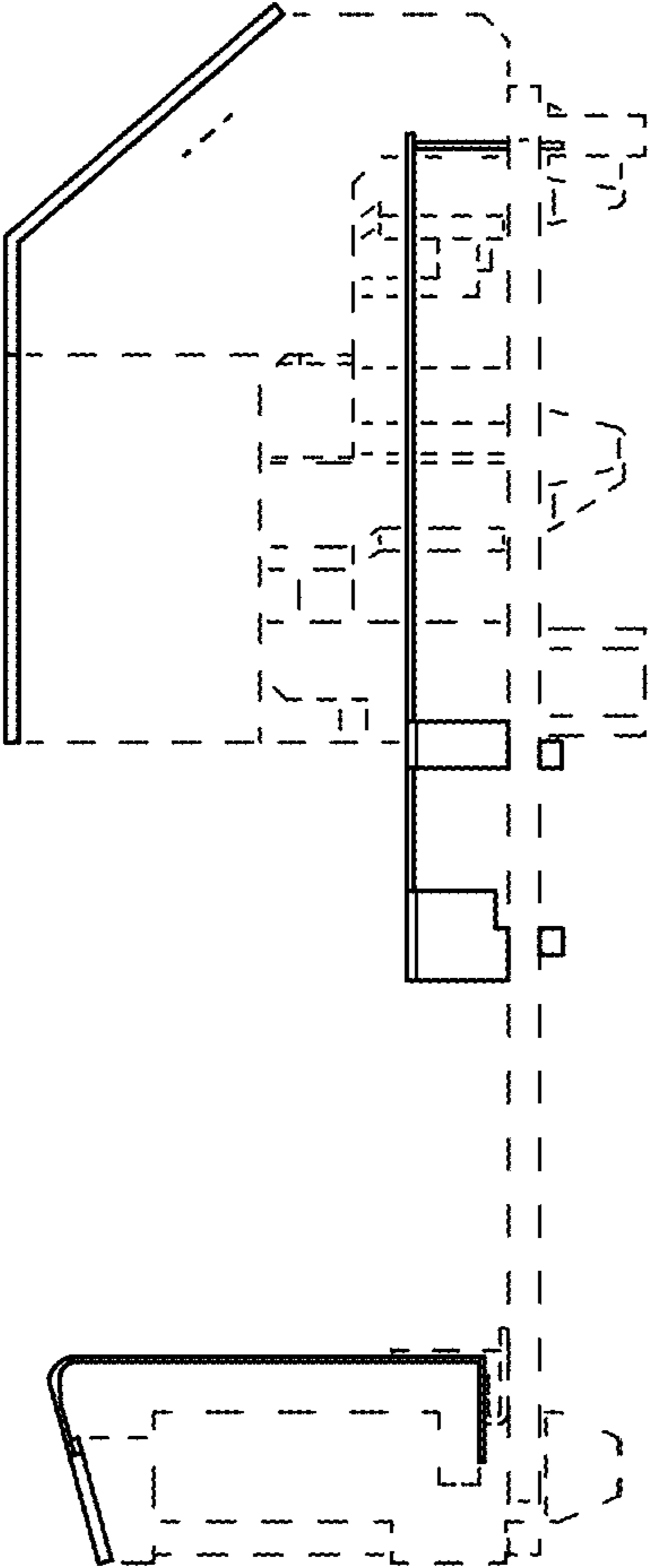

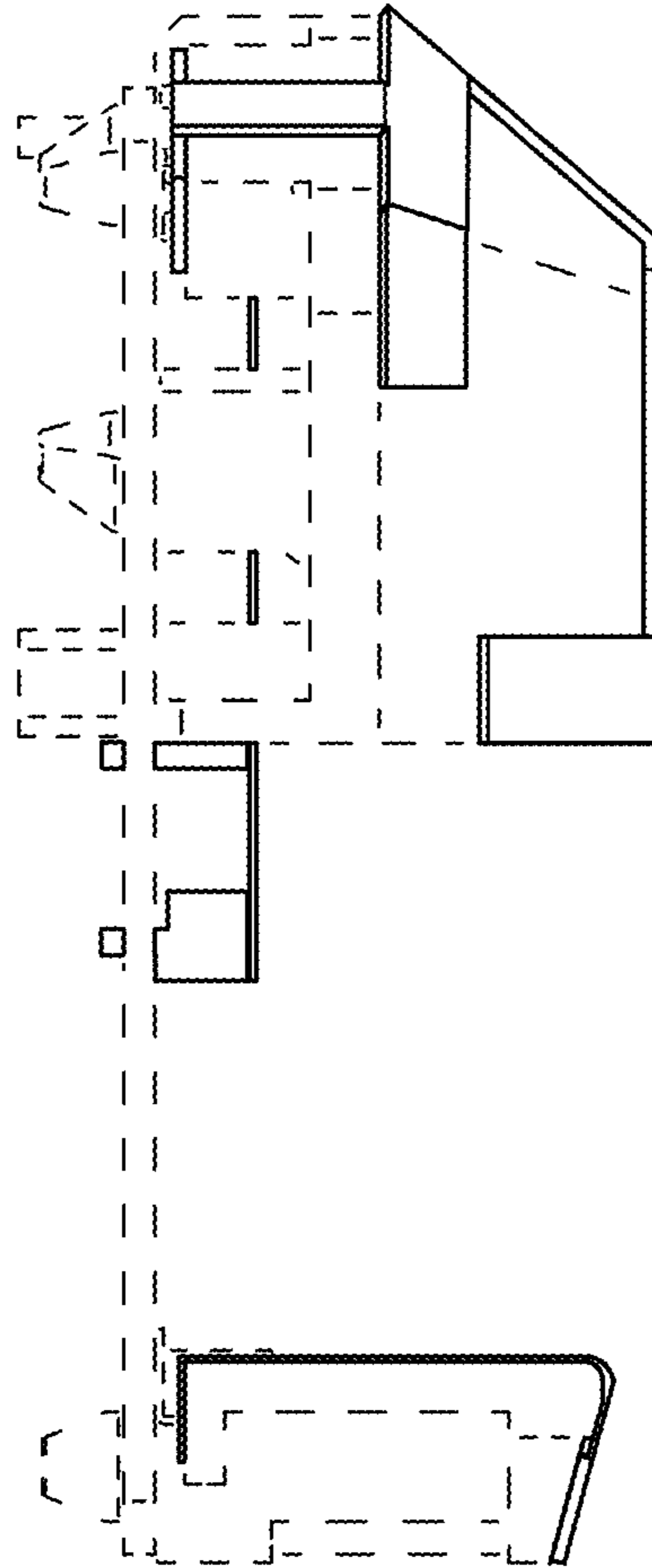

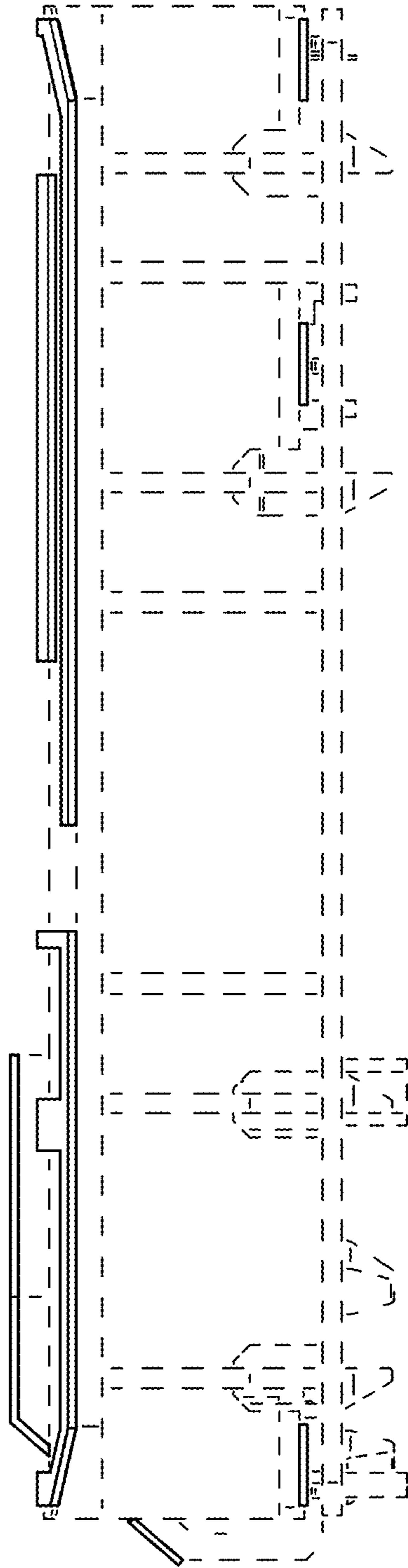

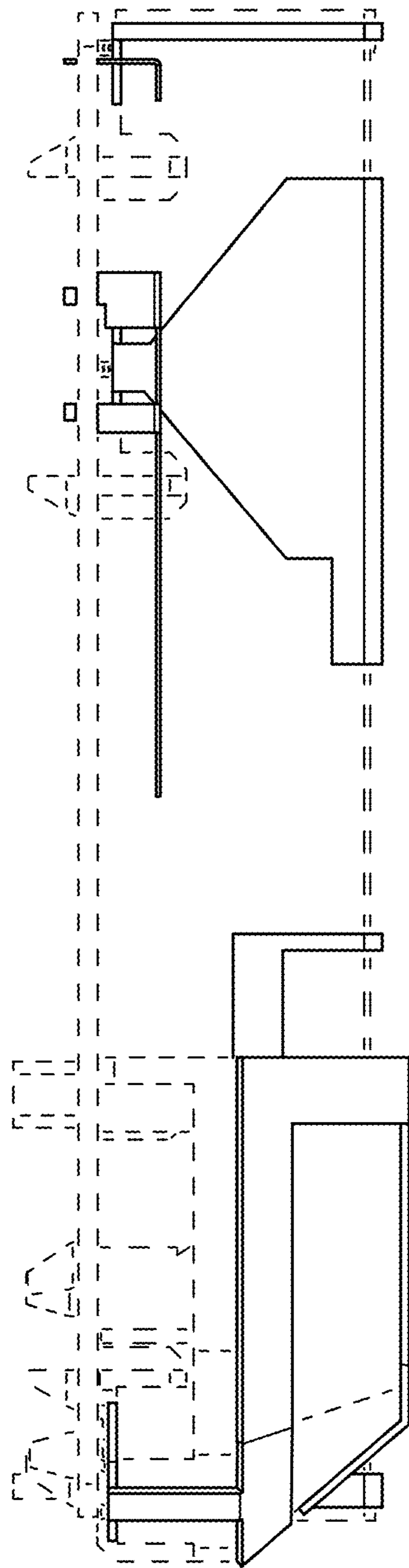

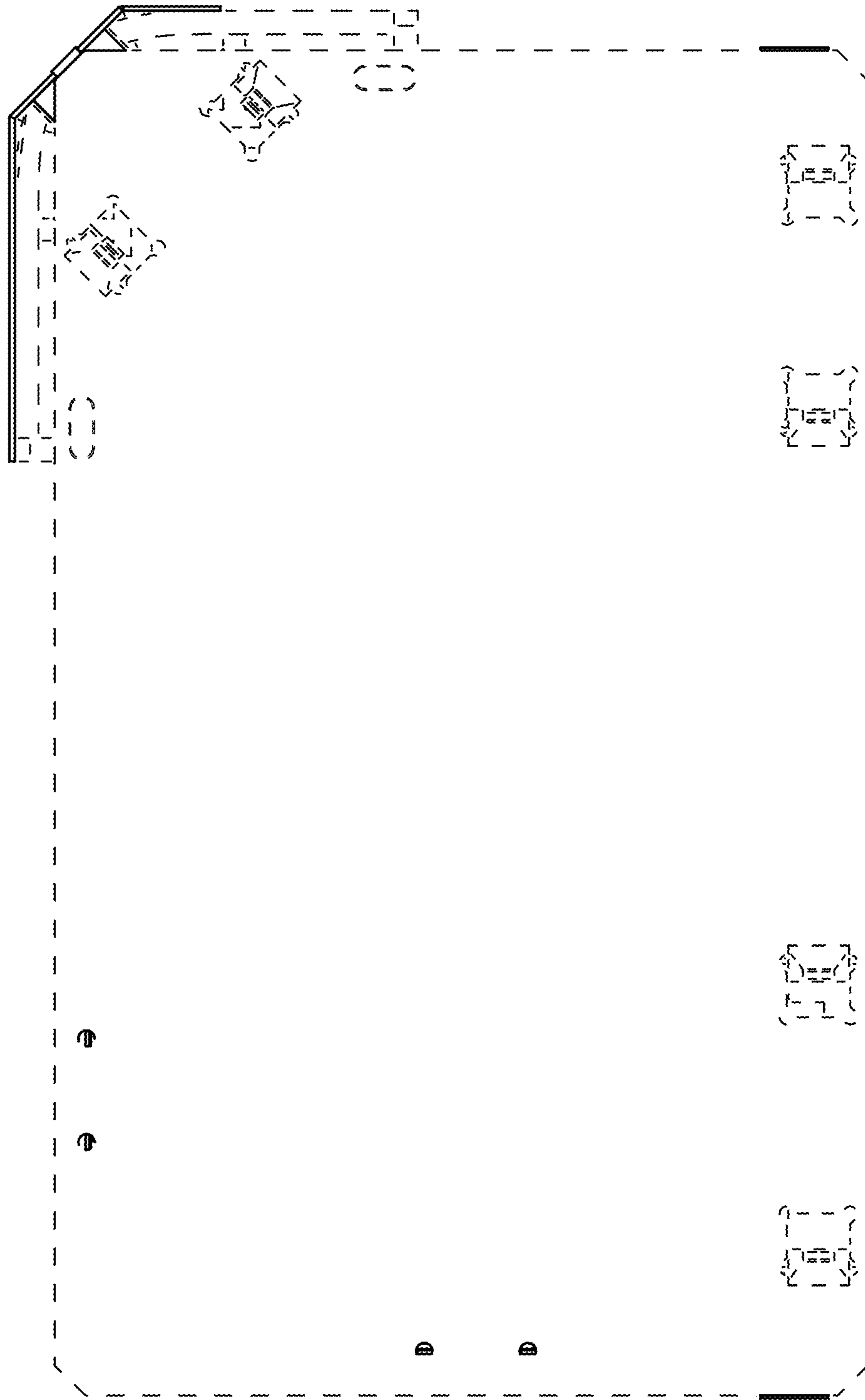

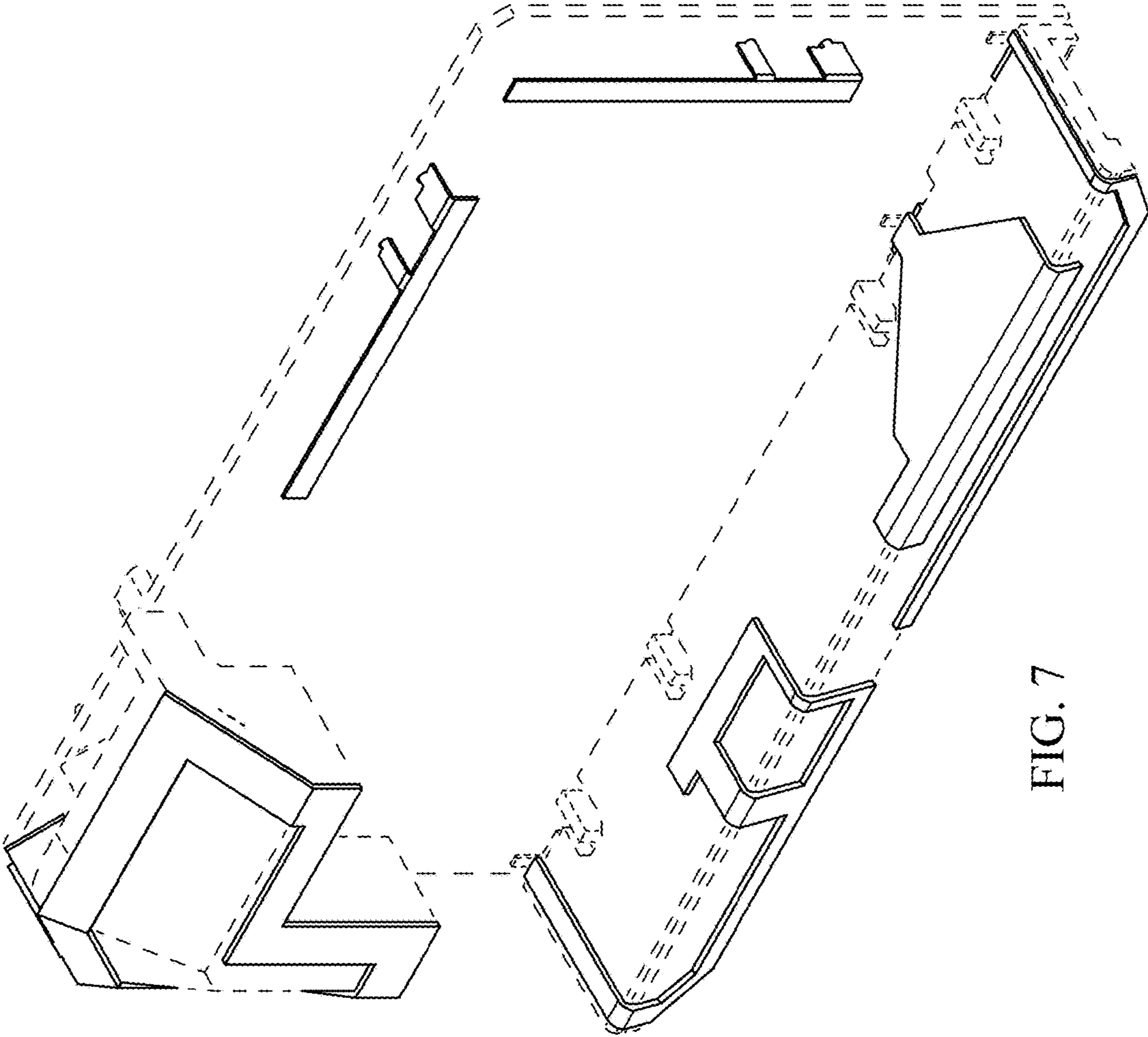

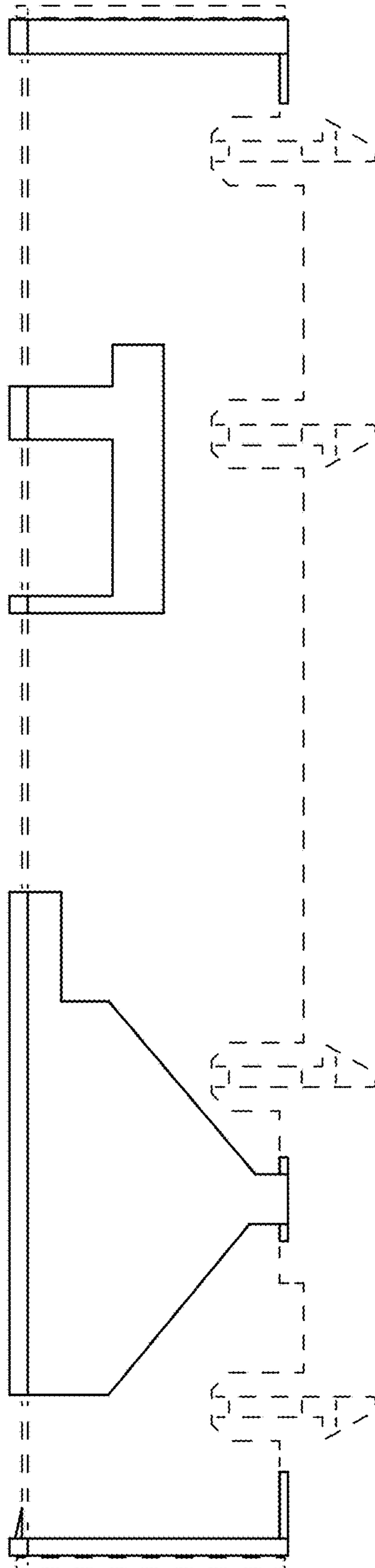

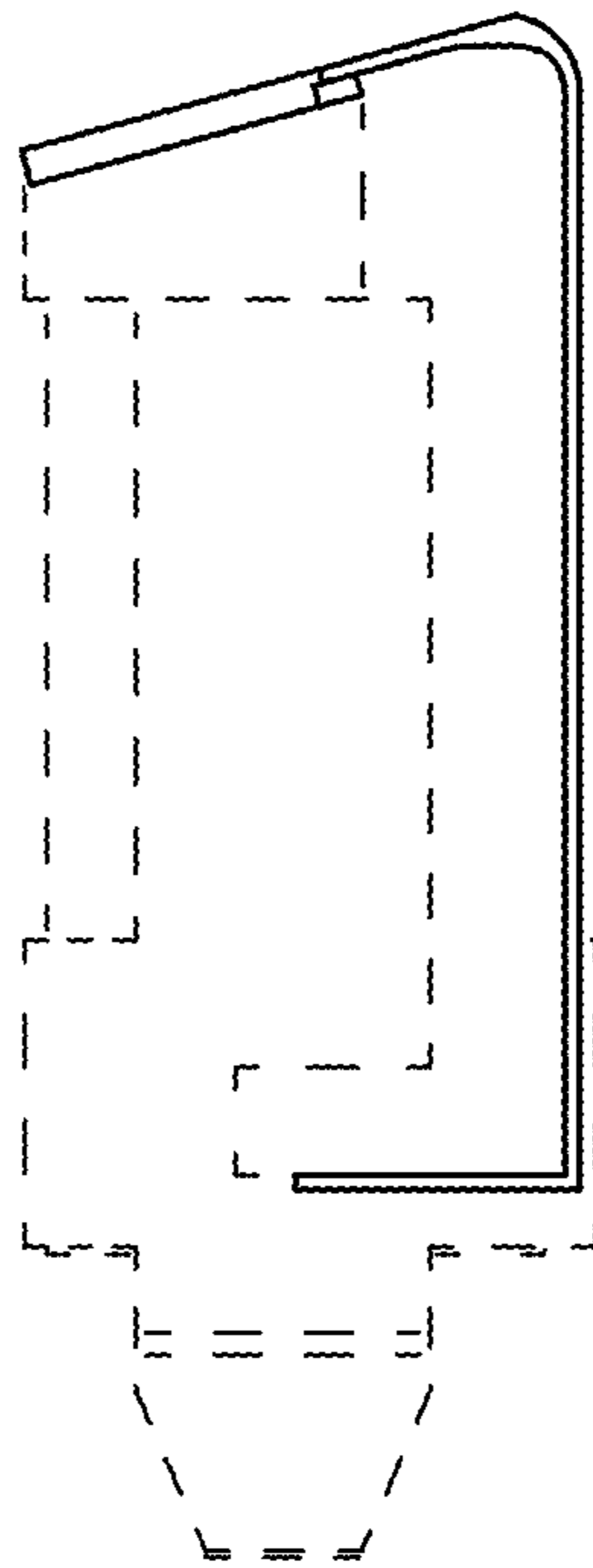

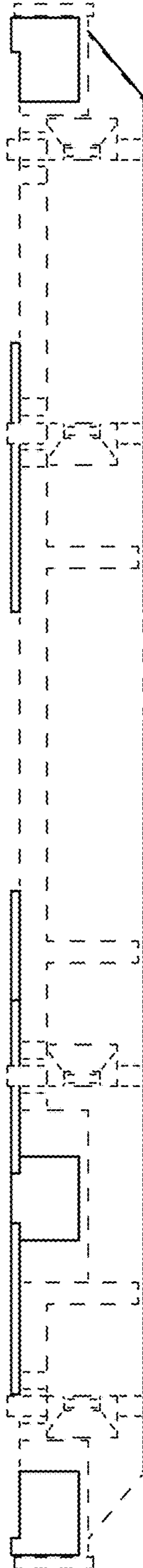

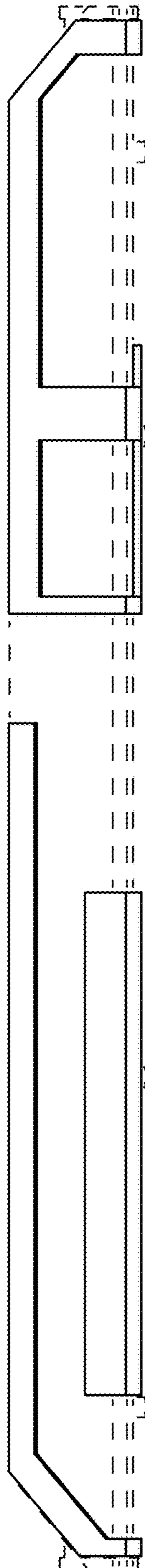

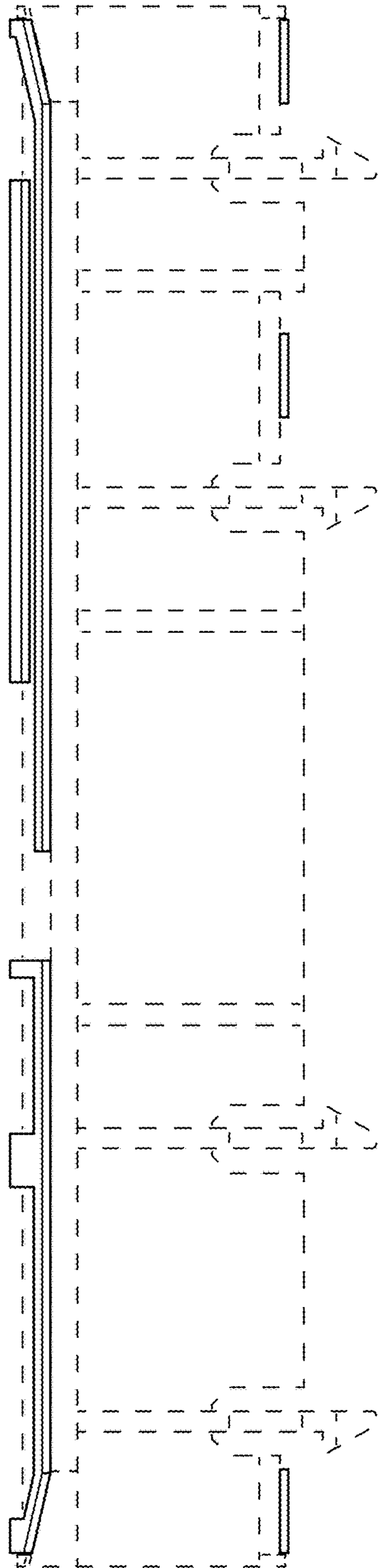

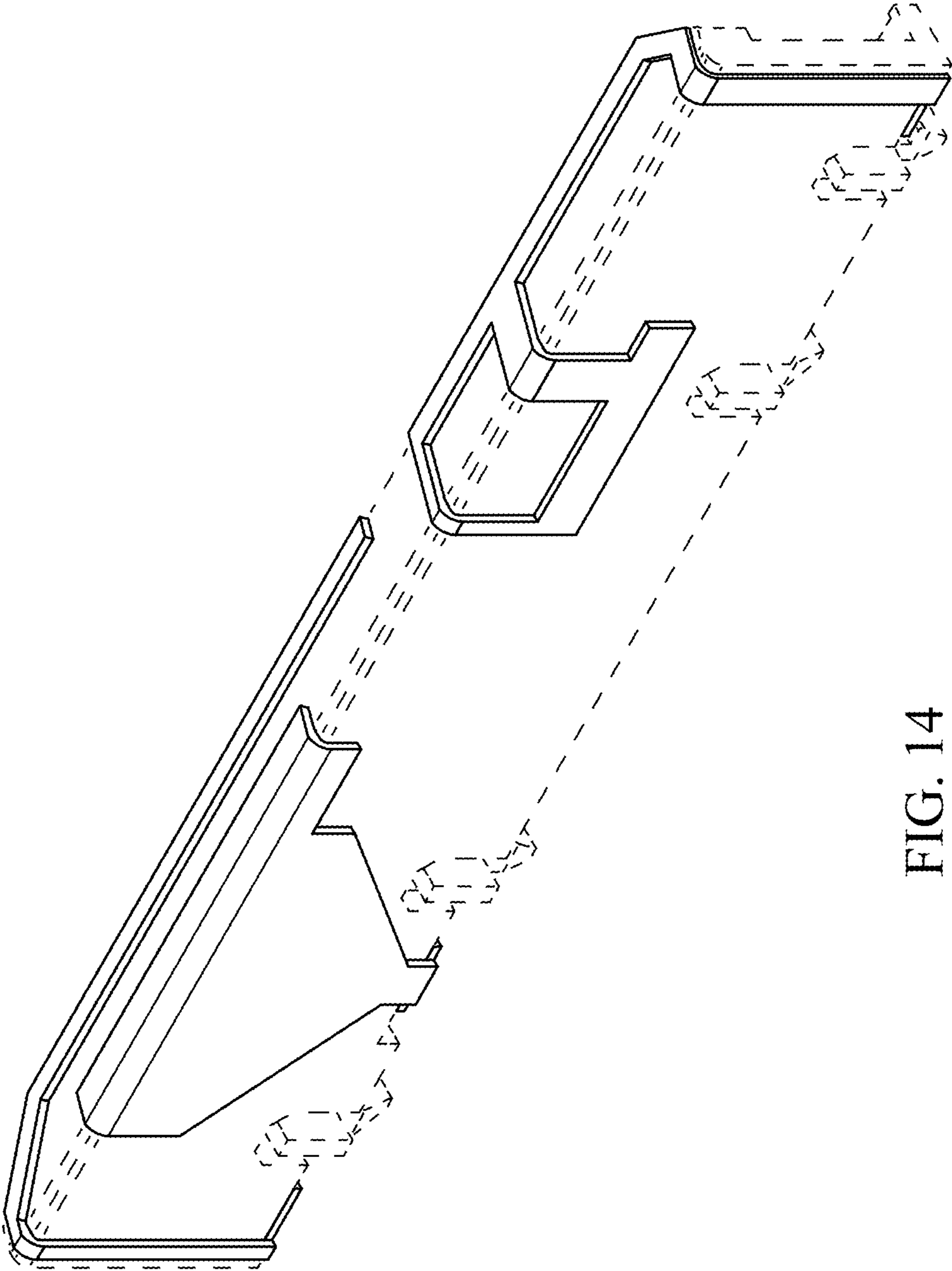

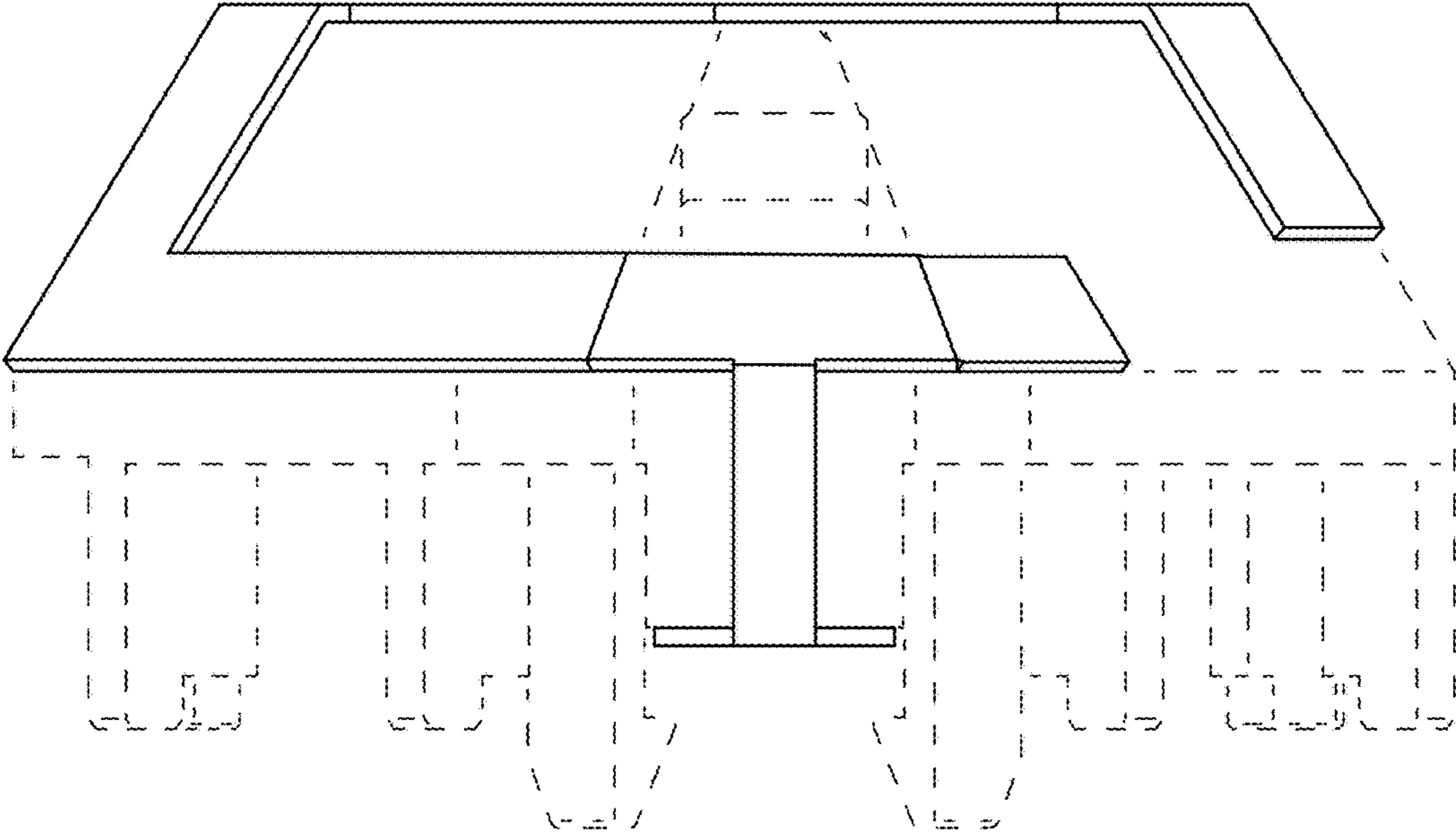

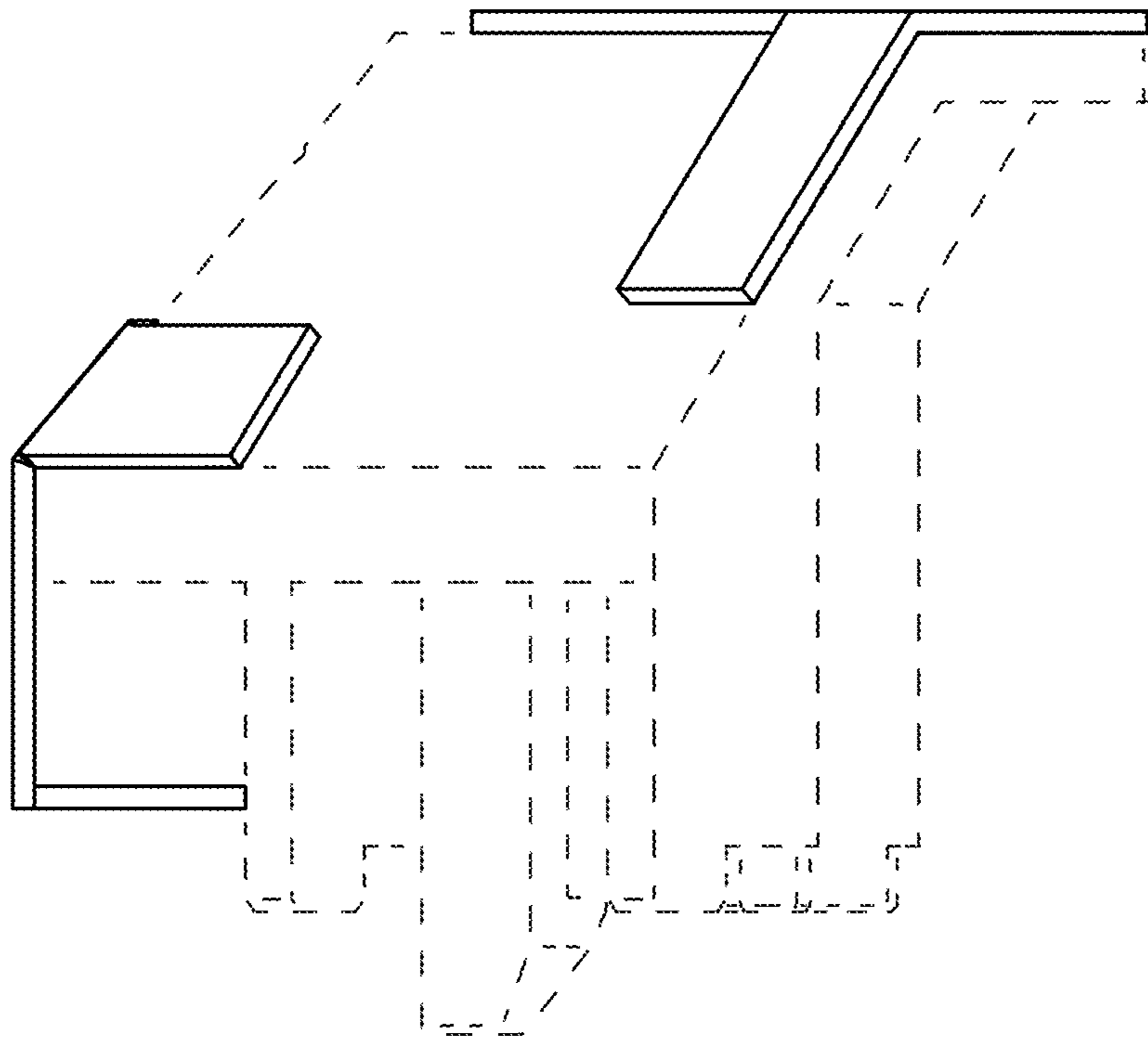

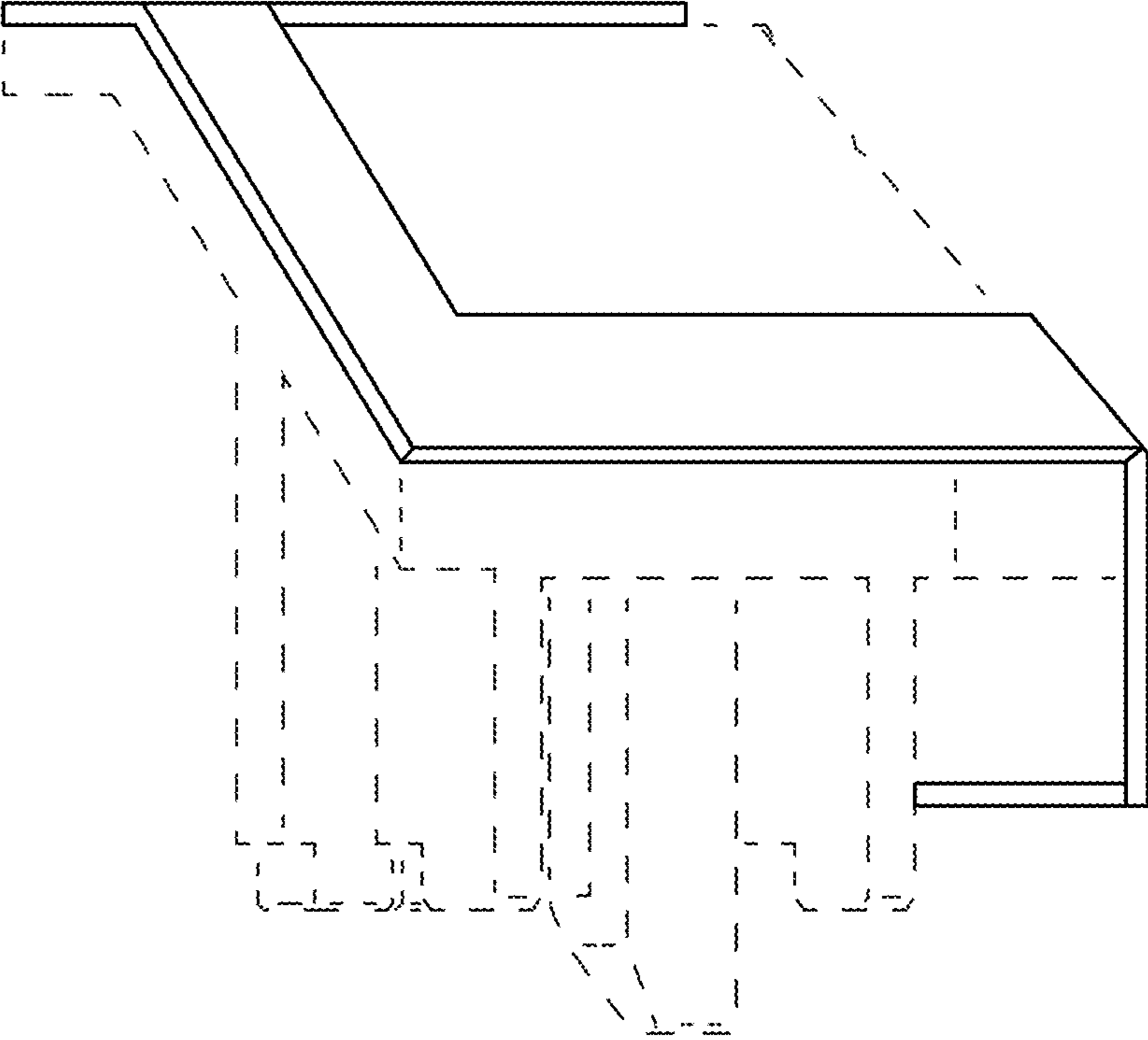

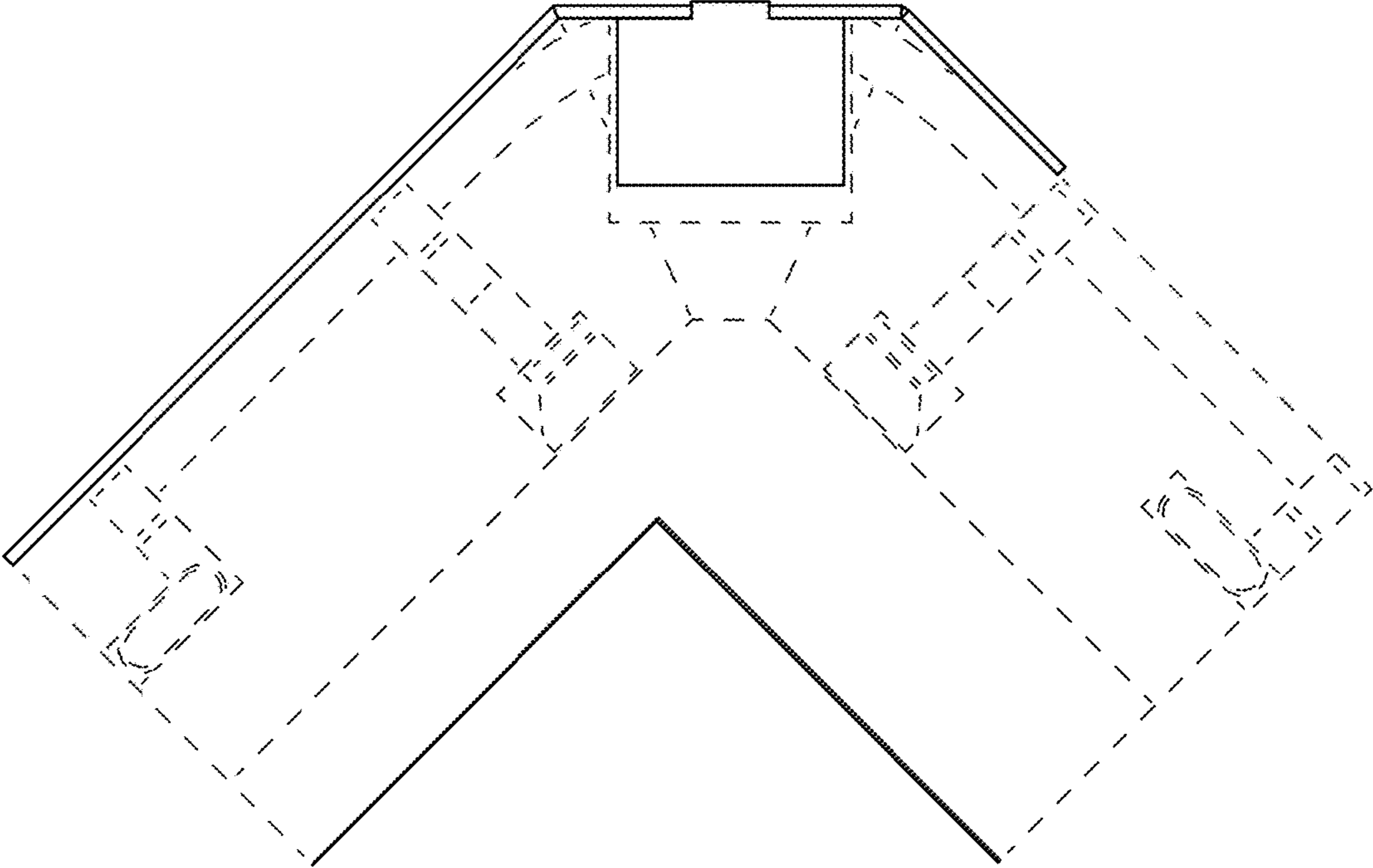

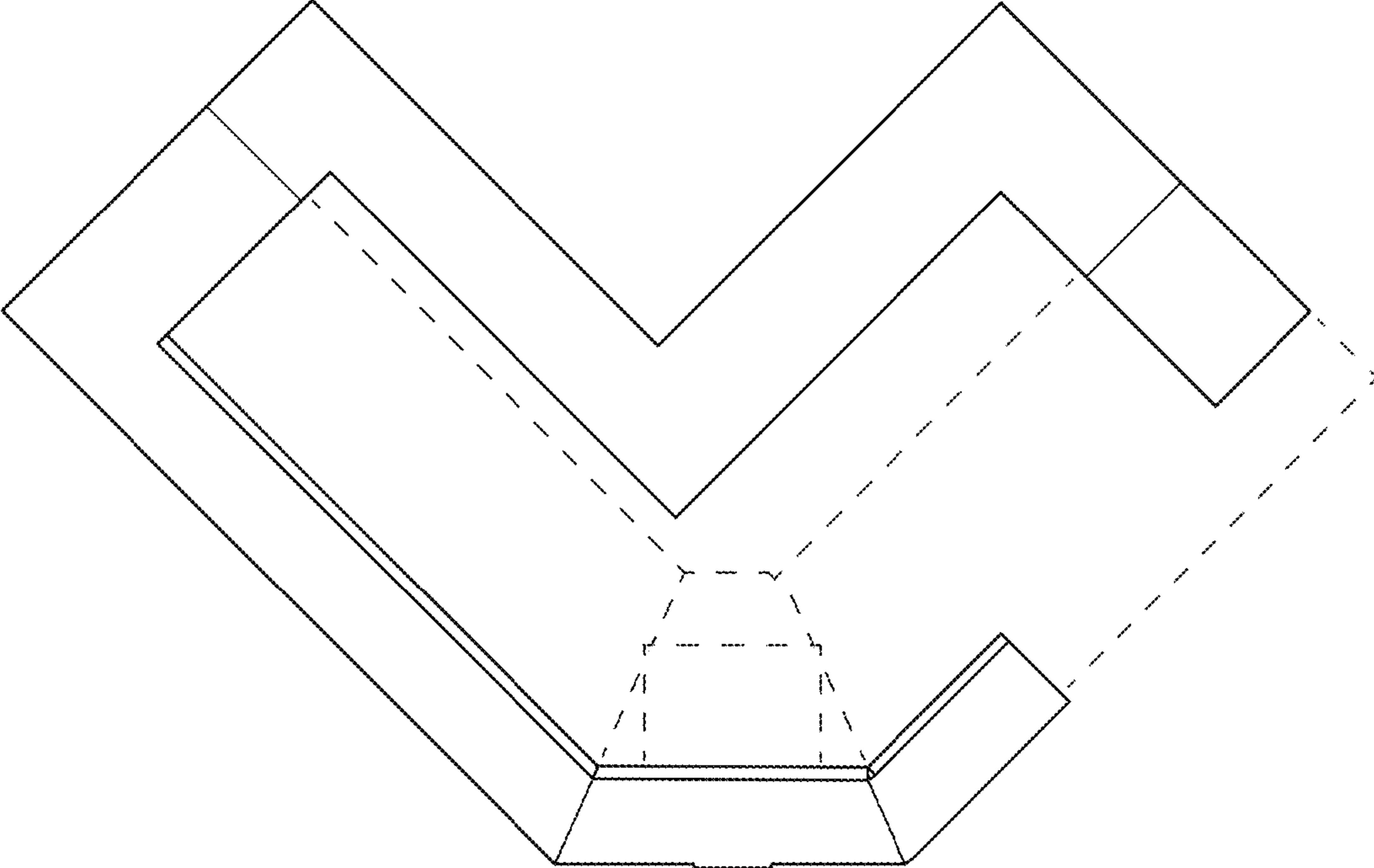

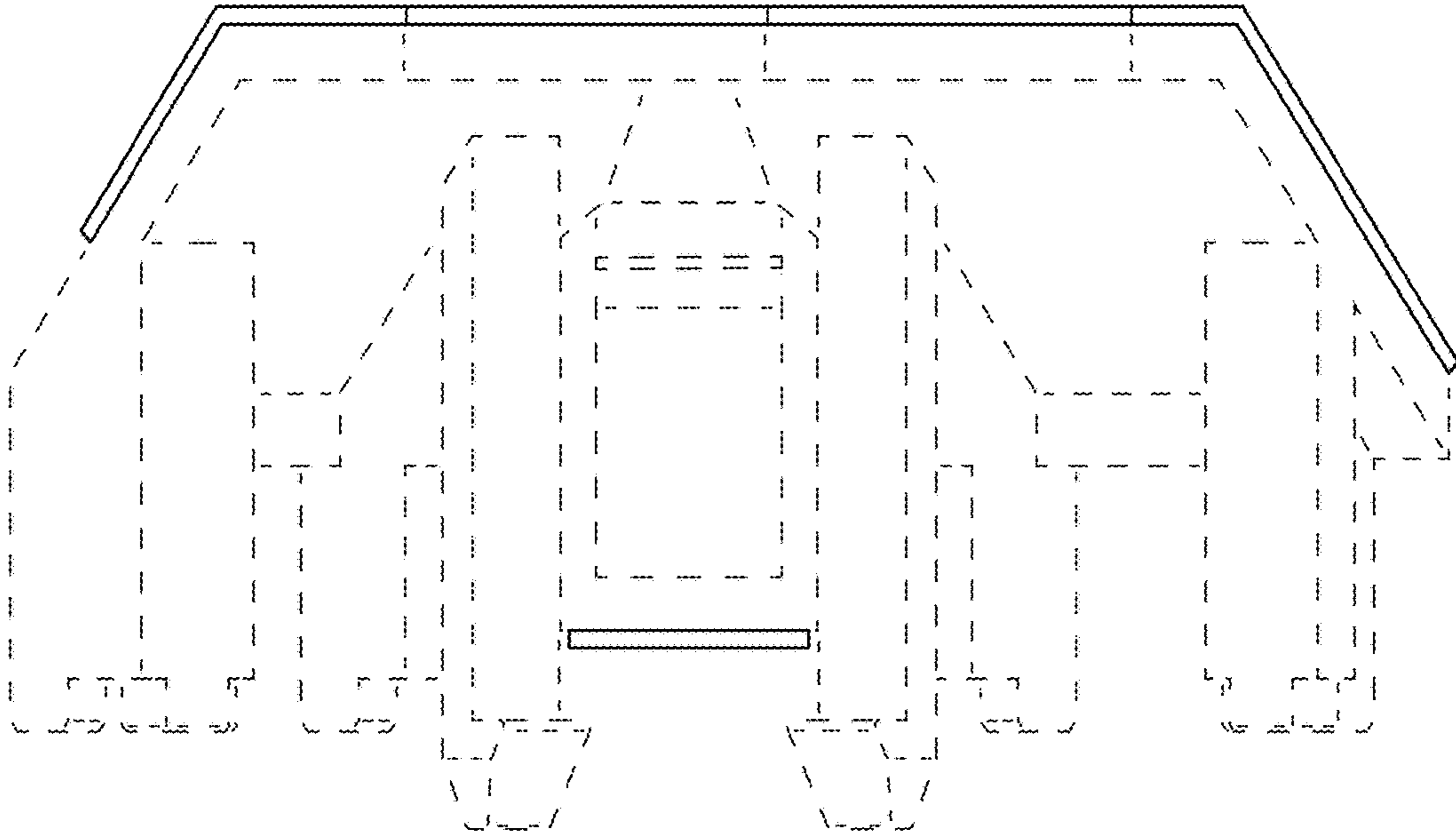

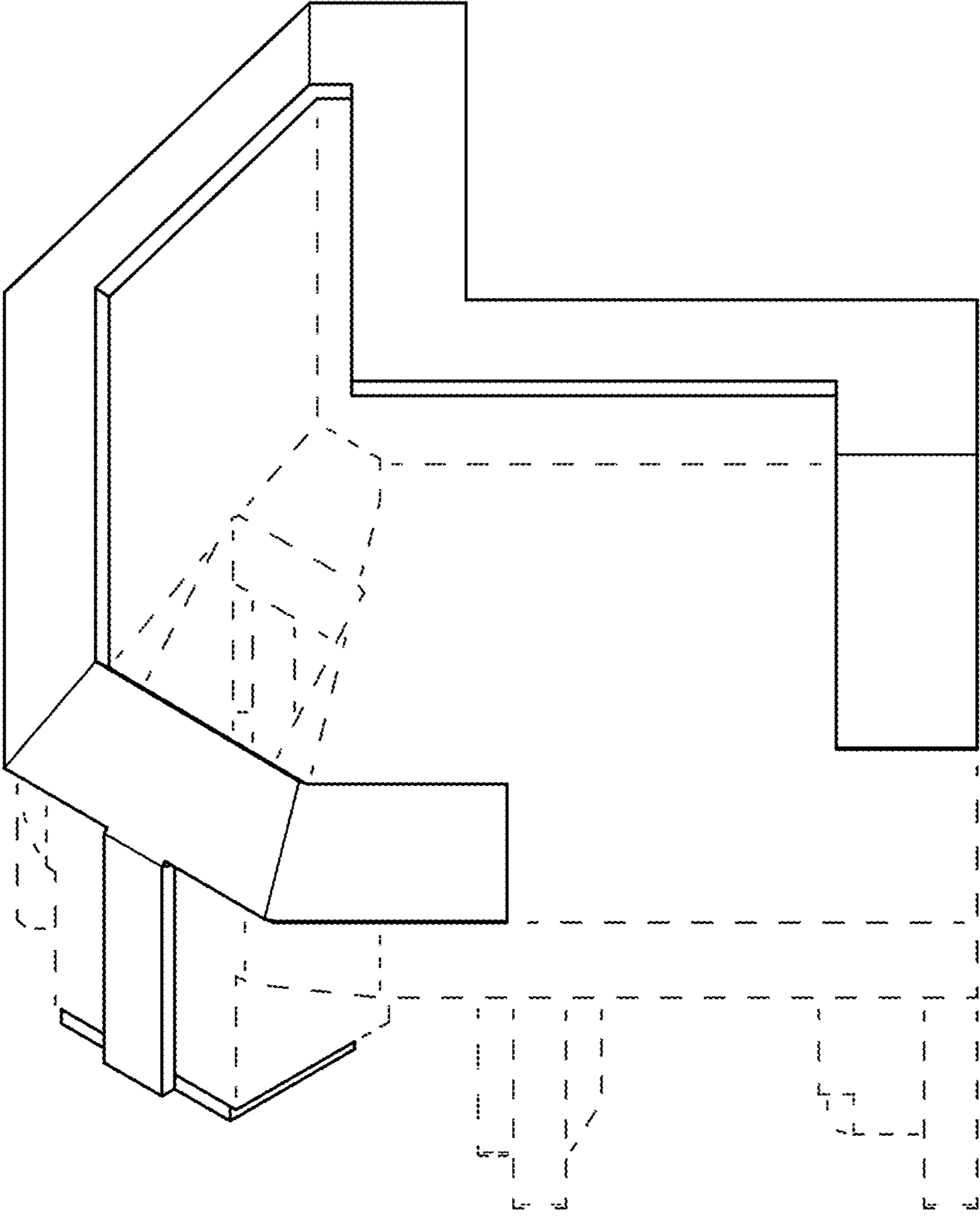
