DESCRIPTION

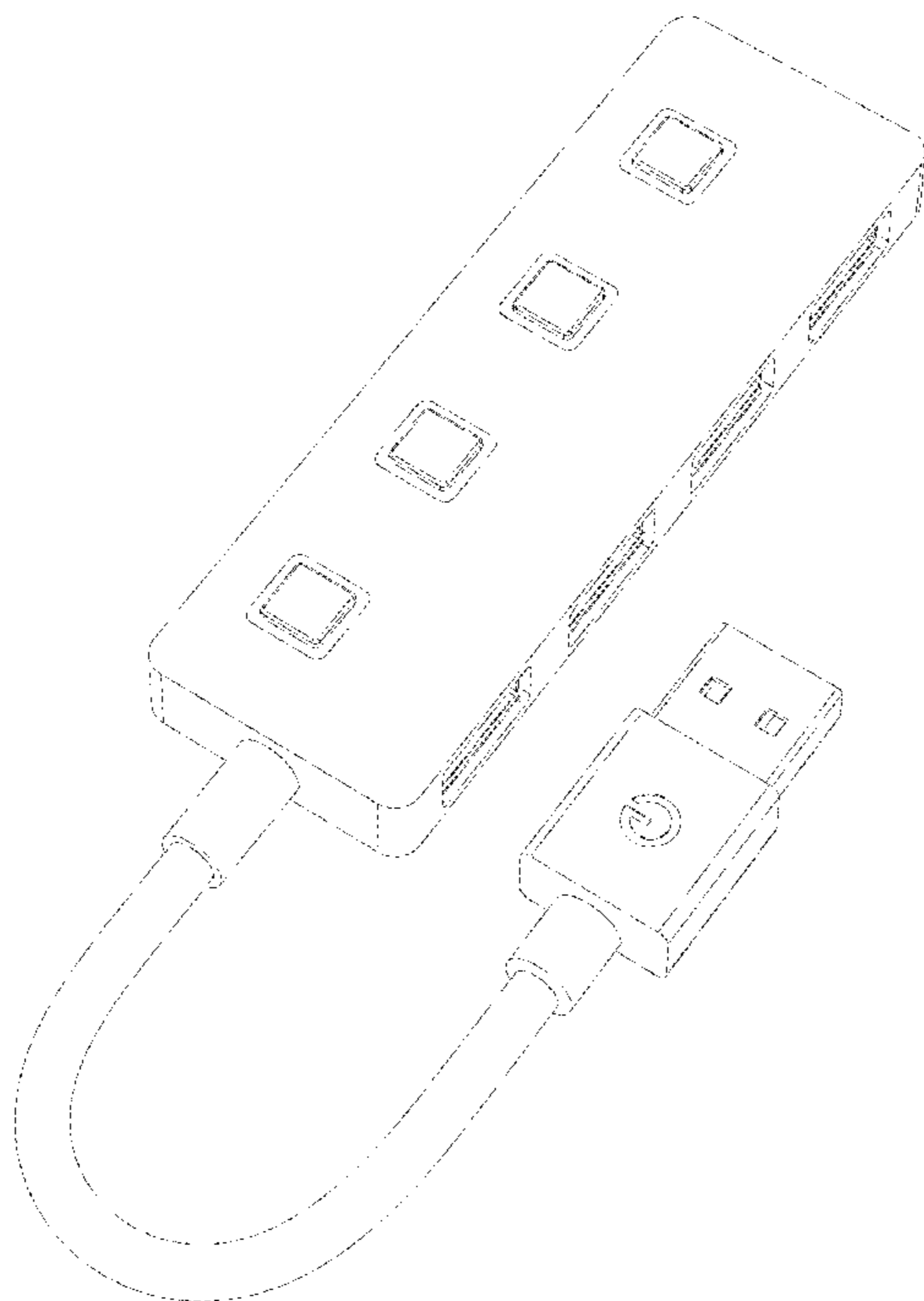
FIG. 1 is a top view of a USB hub, showing my new design;

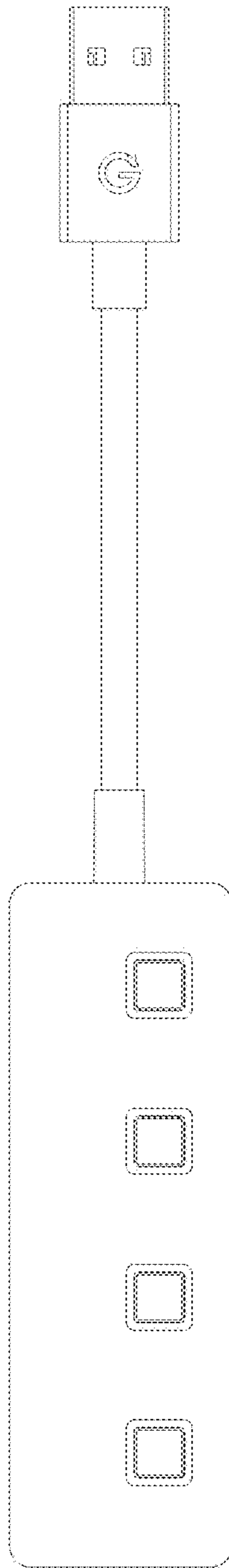

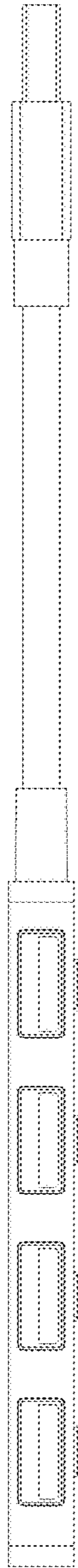

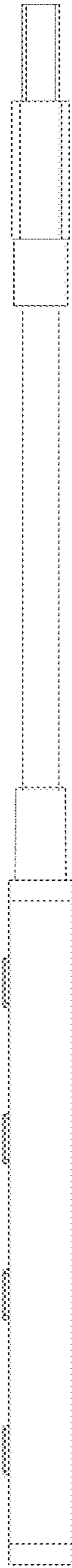

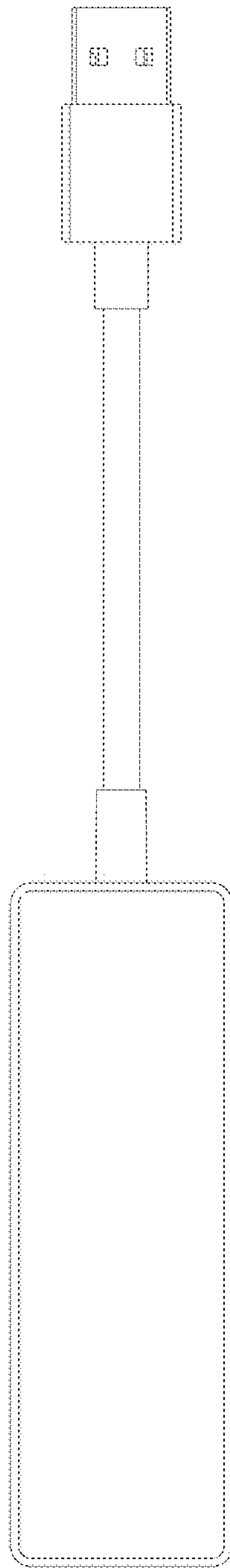

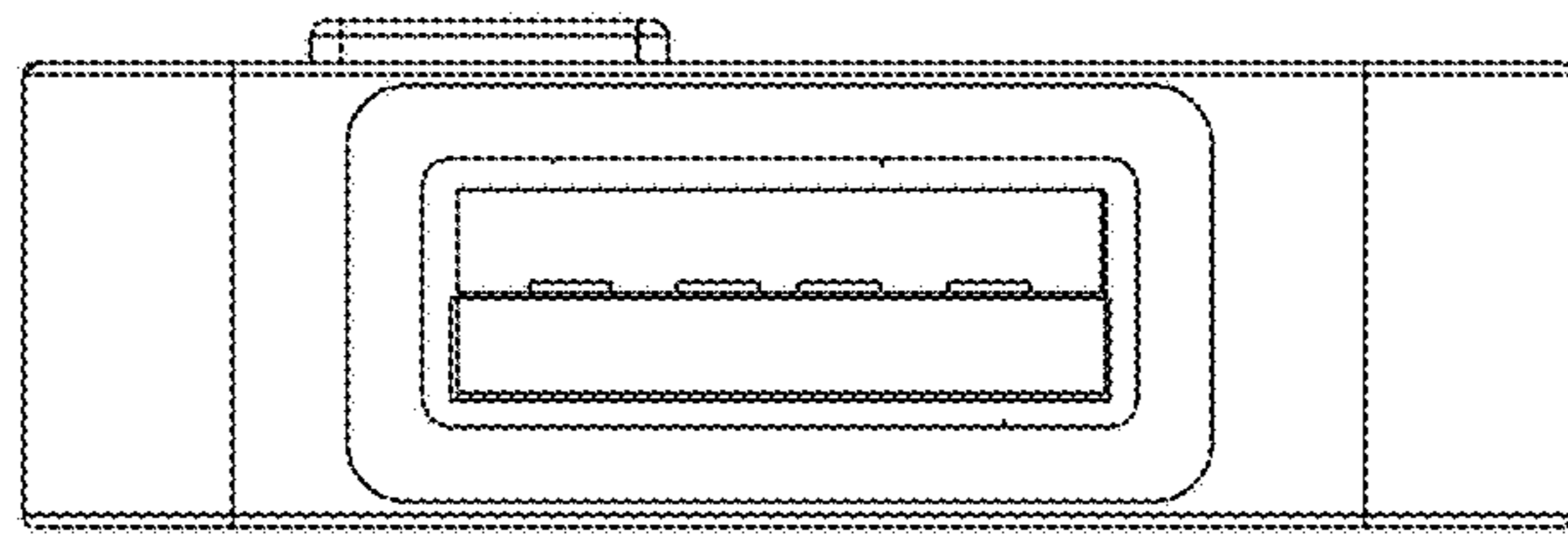

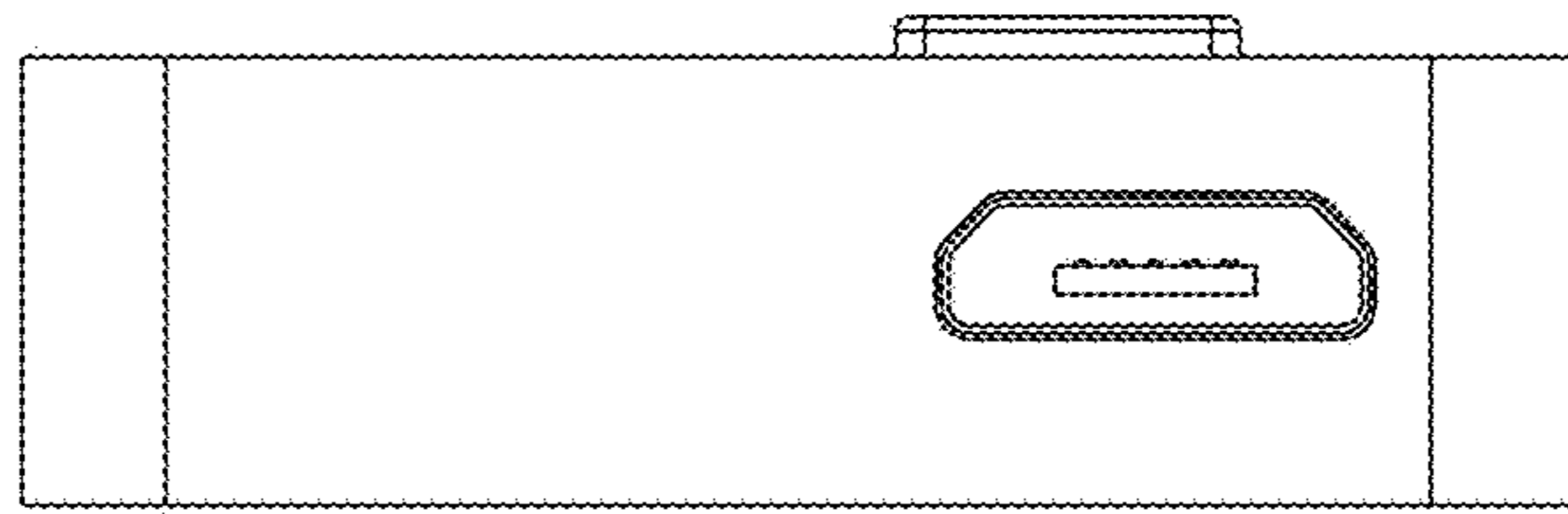

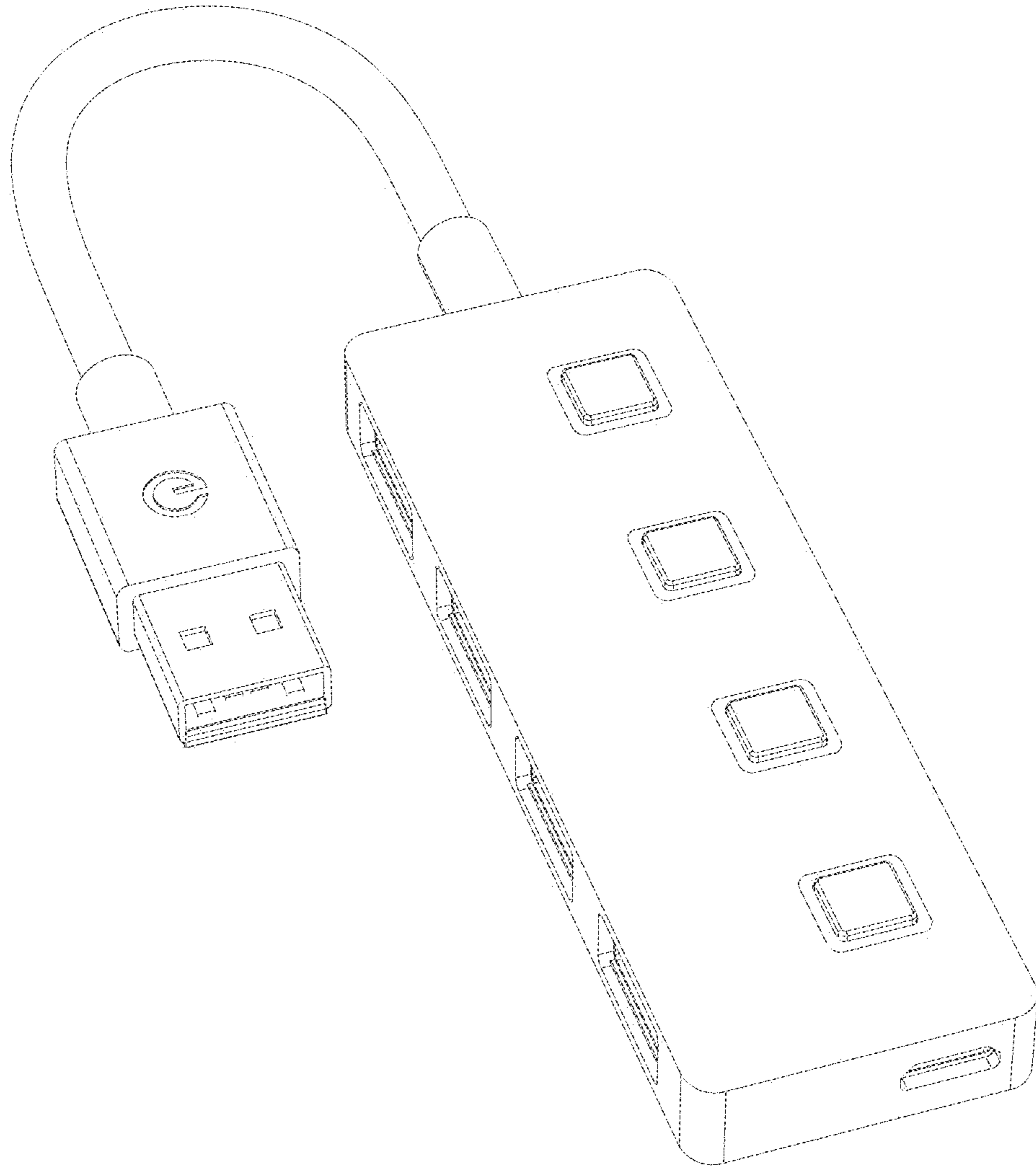

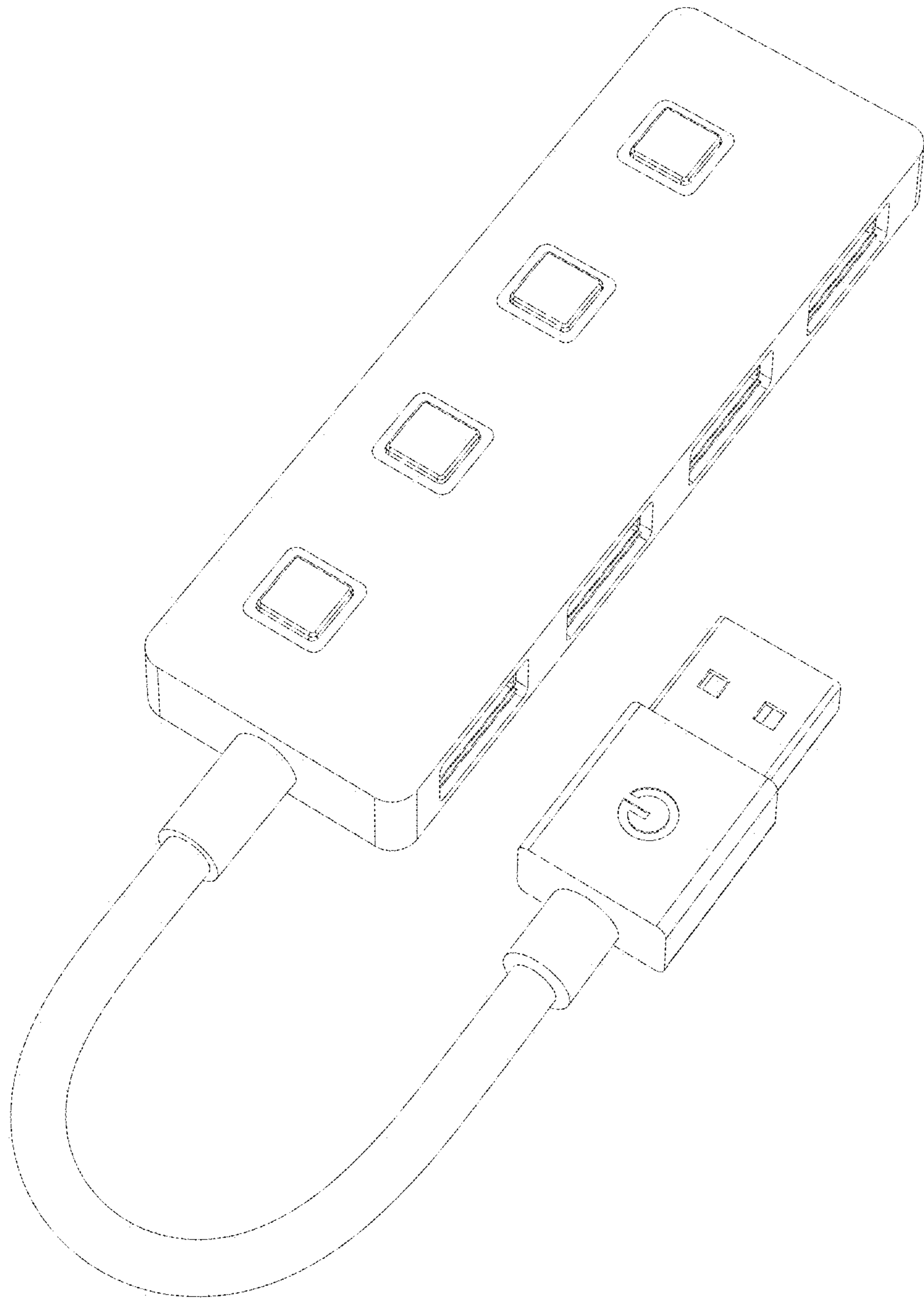
