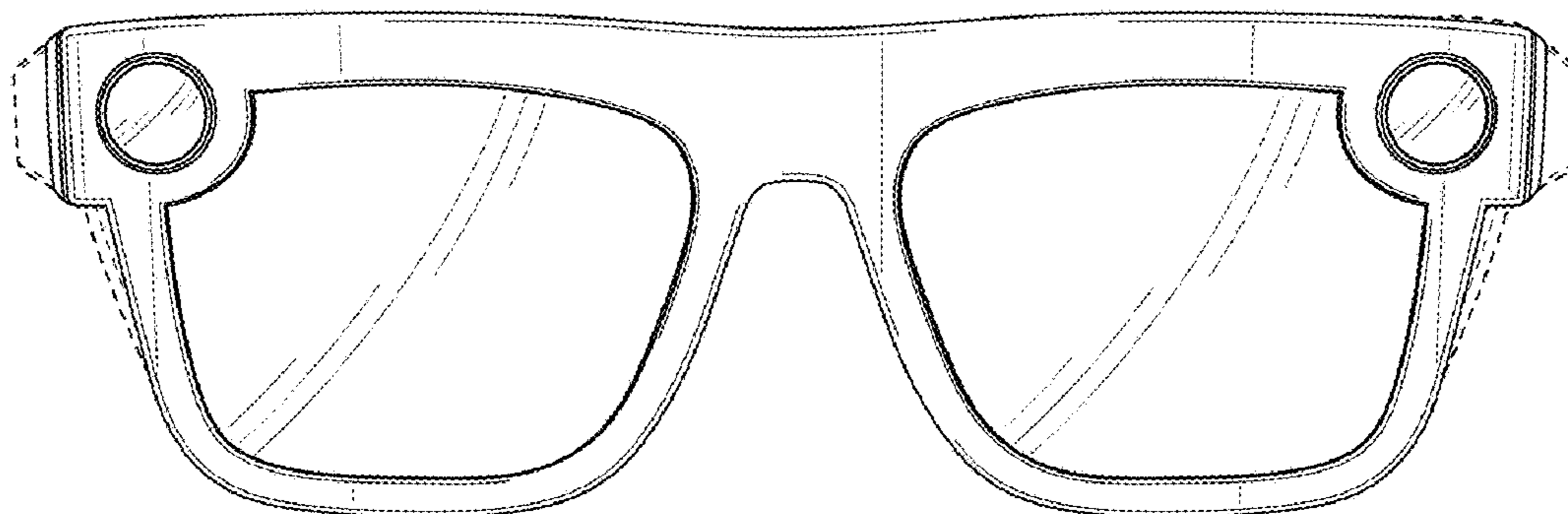
(57) **CLAIM**

The ornamental design for eyeglasses, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of eyeglasses; FIG. 2 is a rear elevation view thereof; FIG. 3 is a left-side elevation view thereof; FIG. 4 is a right-side elevation view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines in the figures illustrate portions of the eyeglasses and form no part of the claimed design.

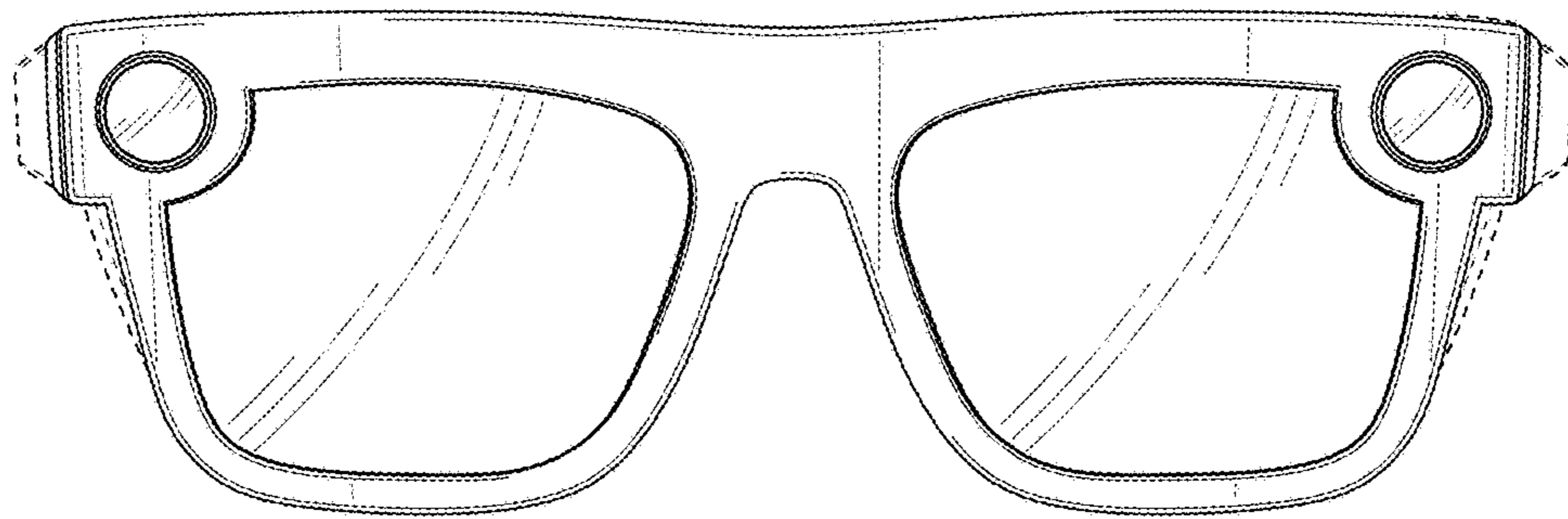

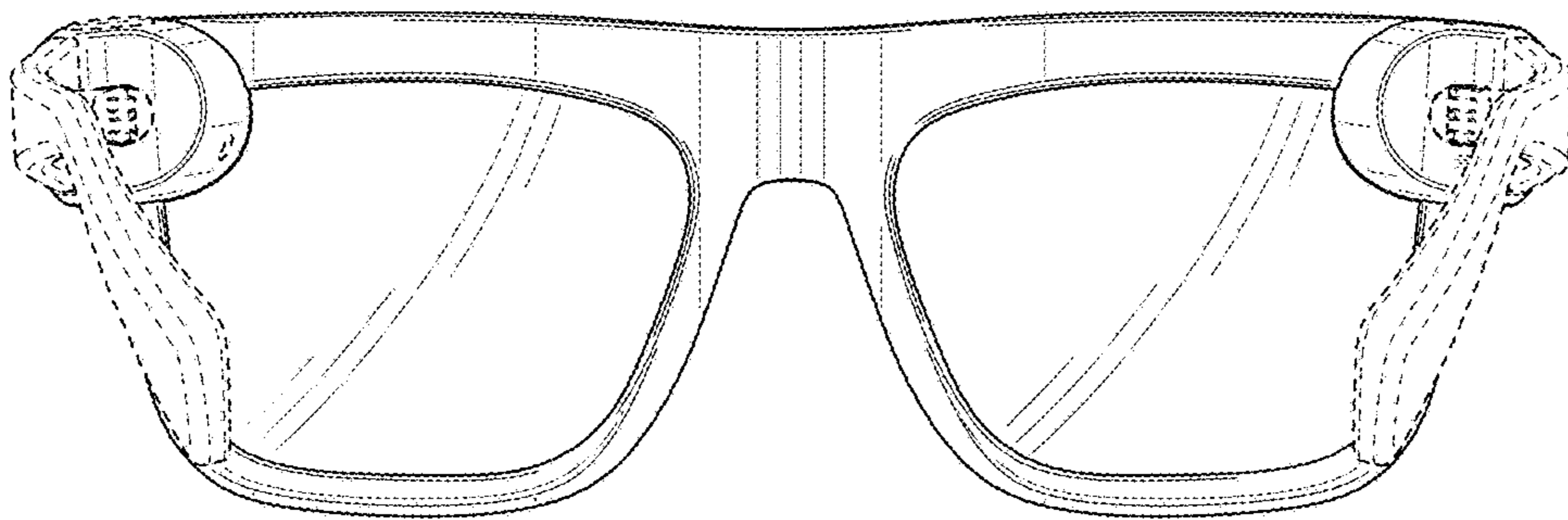

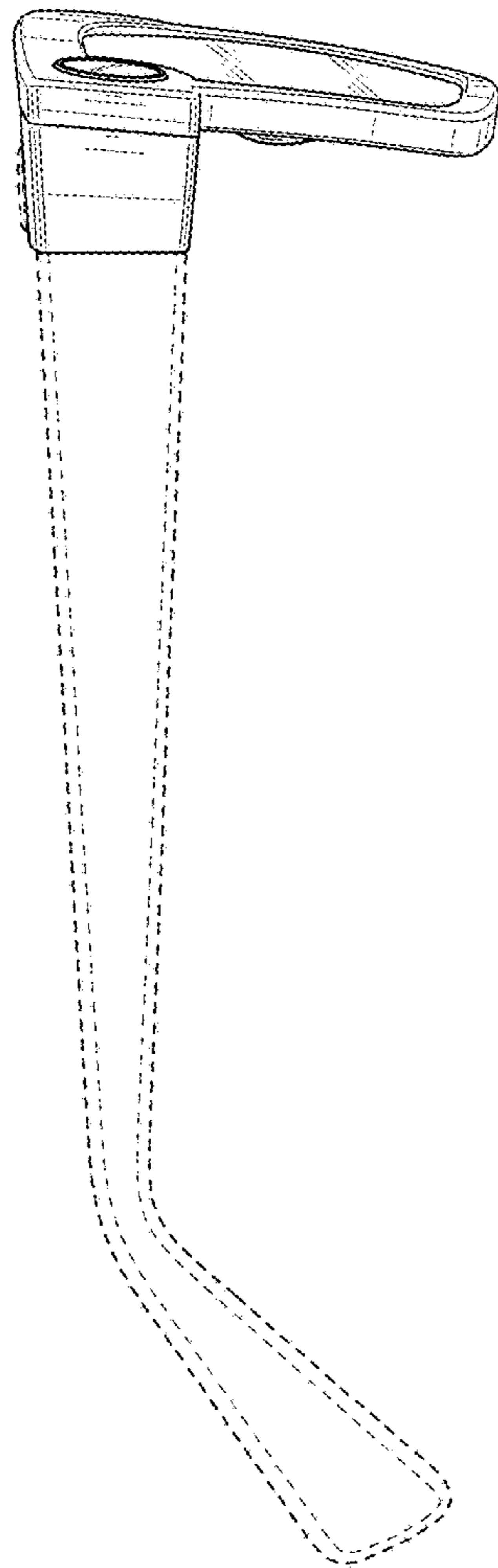

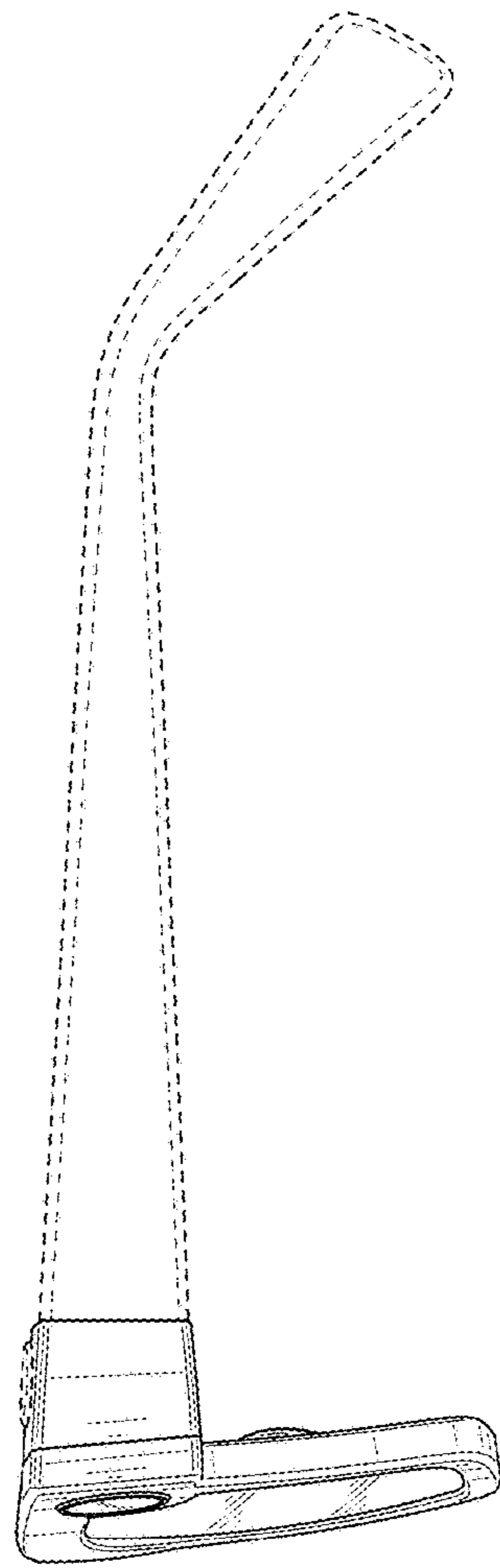

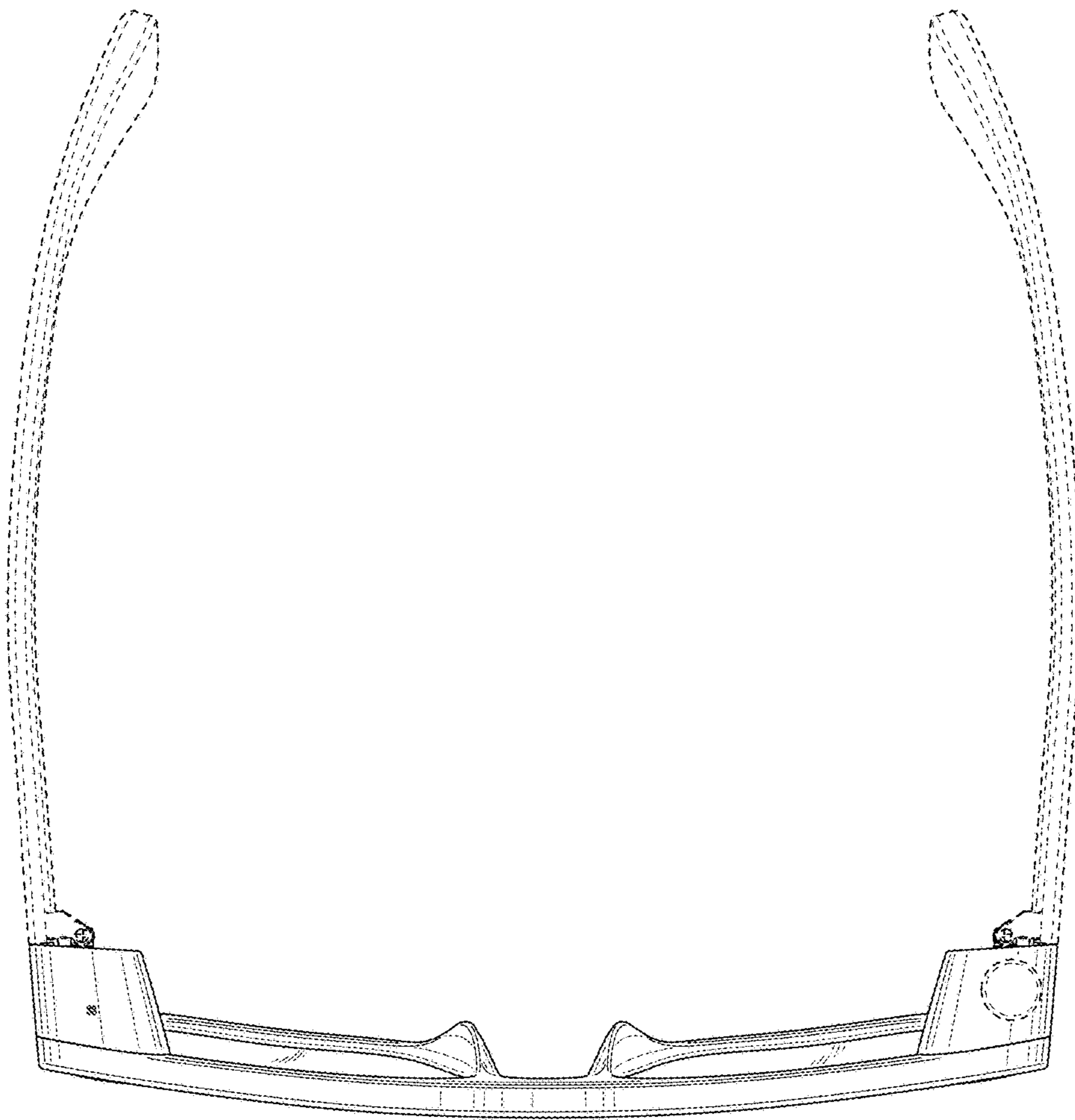

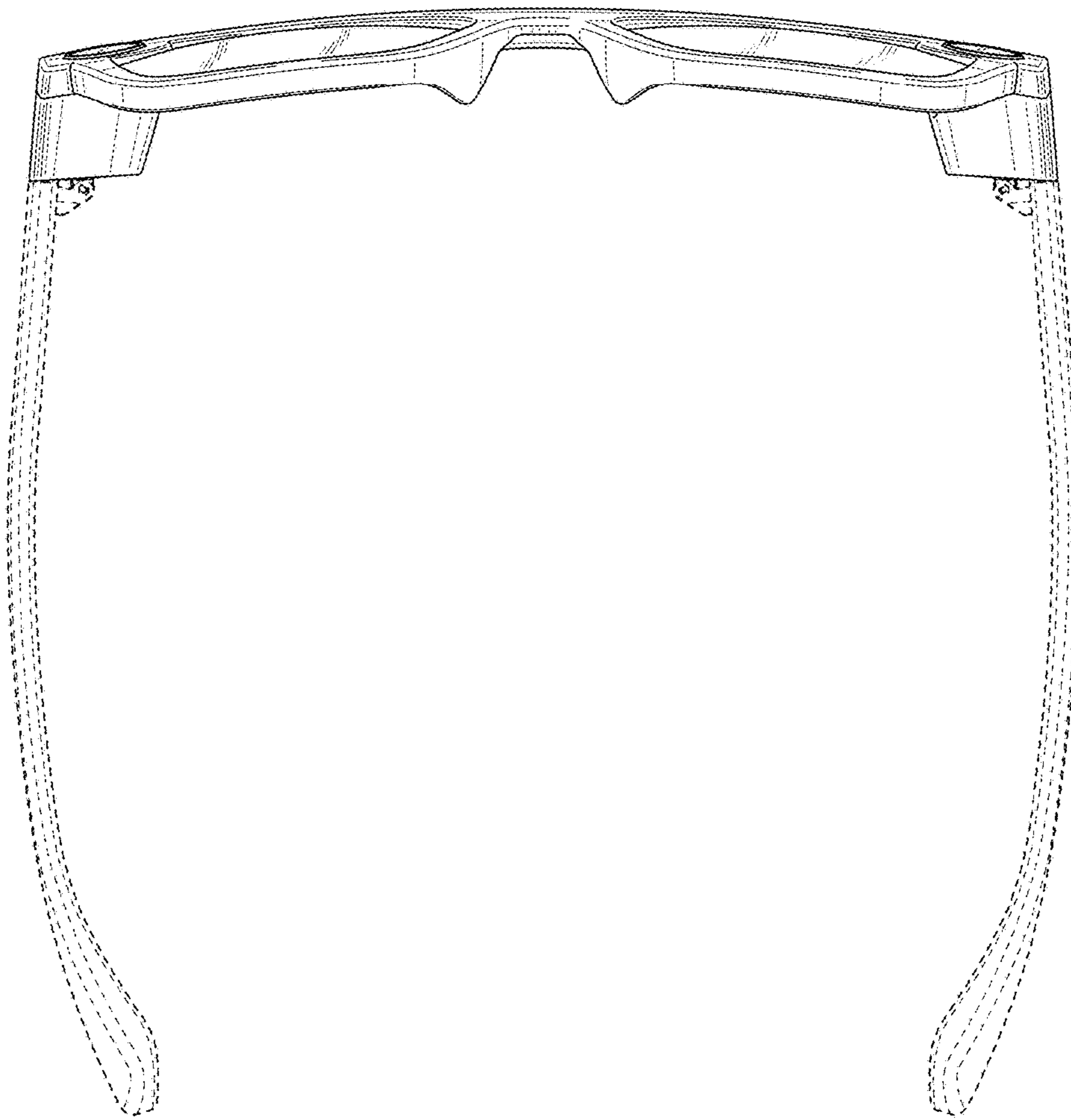
