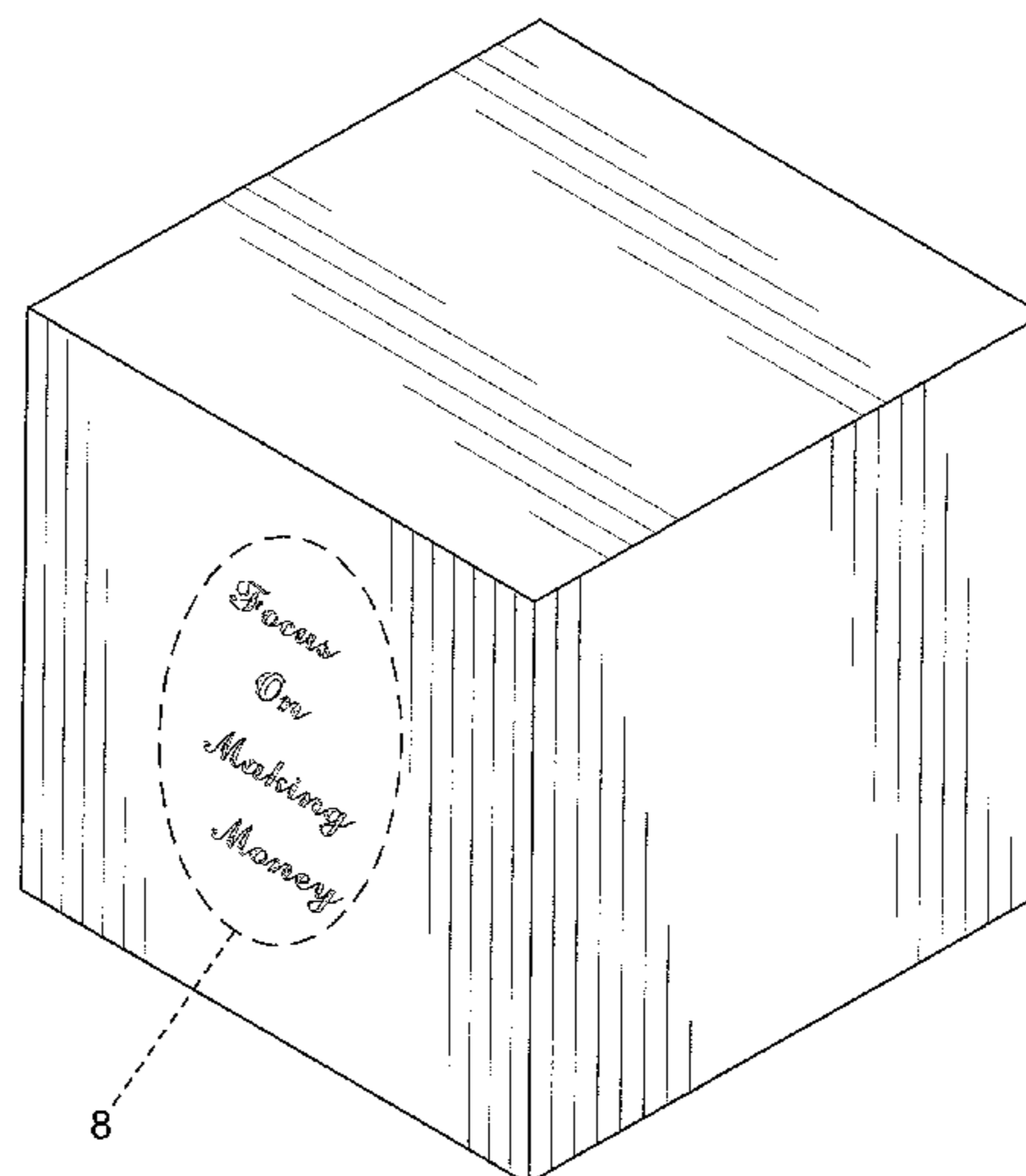

**DESCRIPTION**

FIG. 1 is a front left isometric view of a block;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;

FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a left side elevational view thereof;

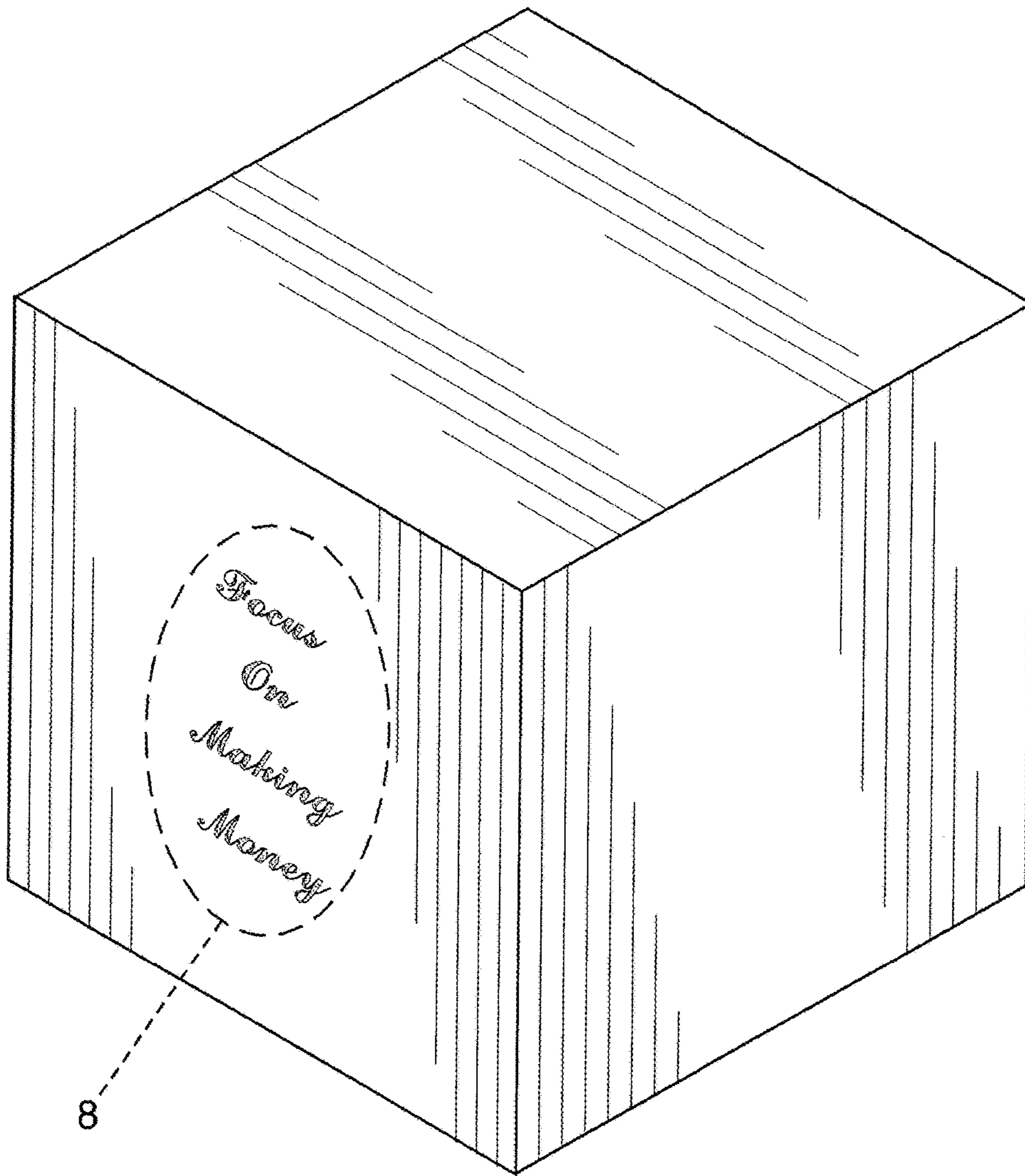

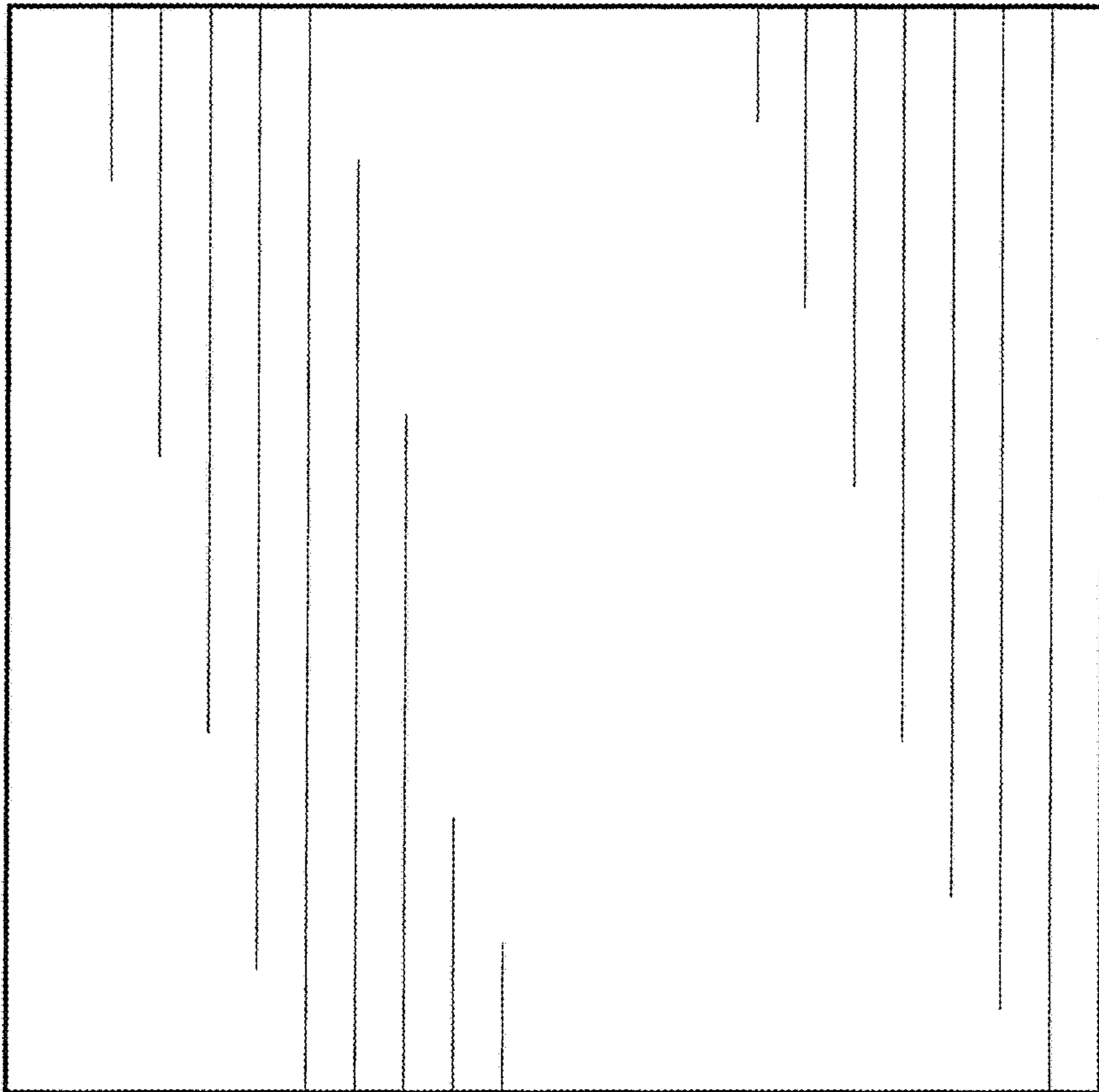

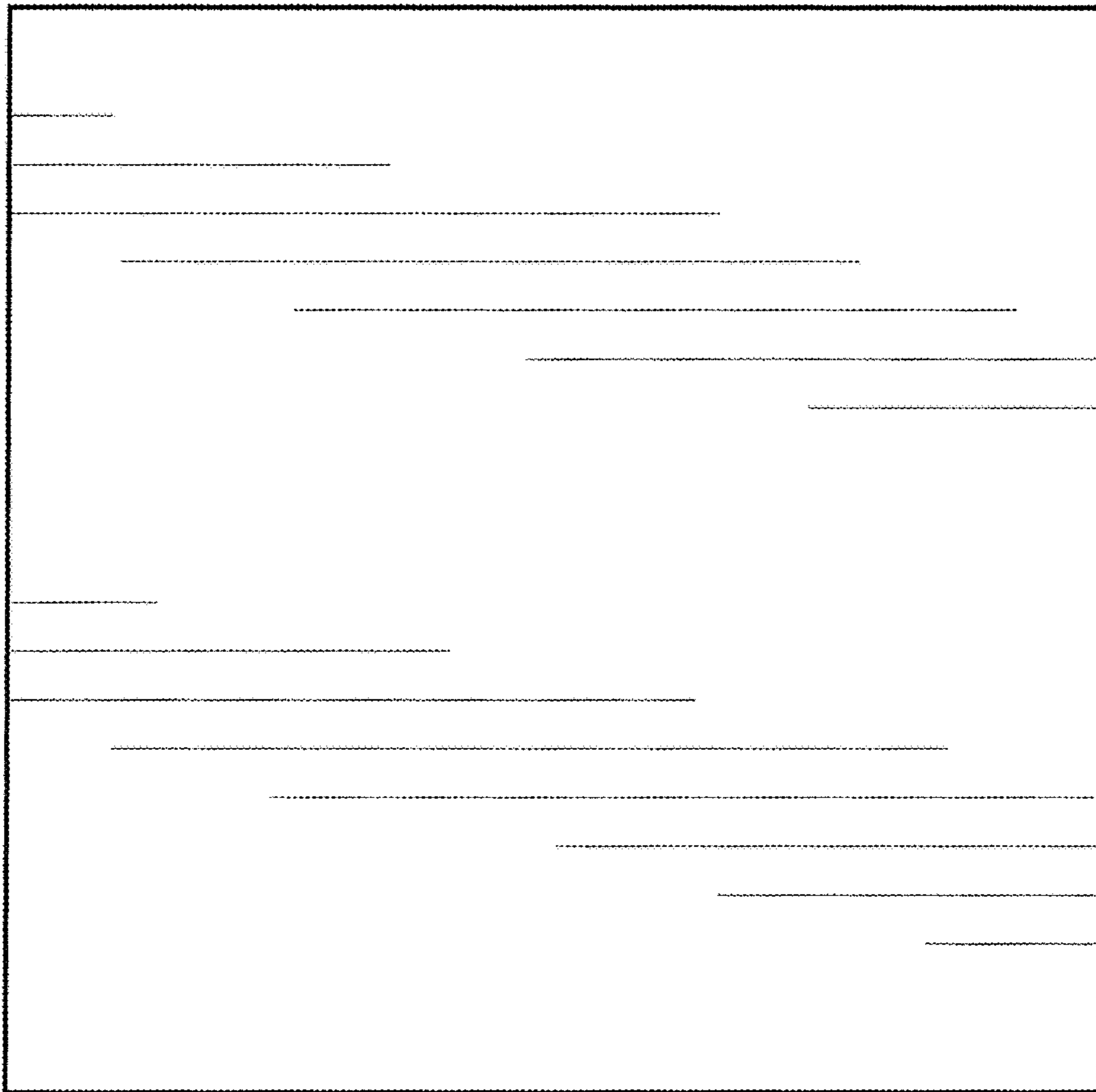

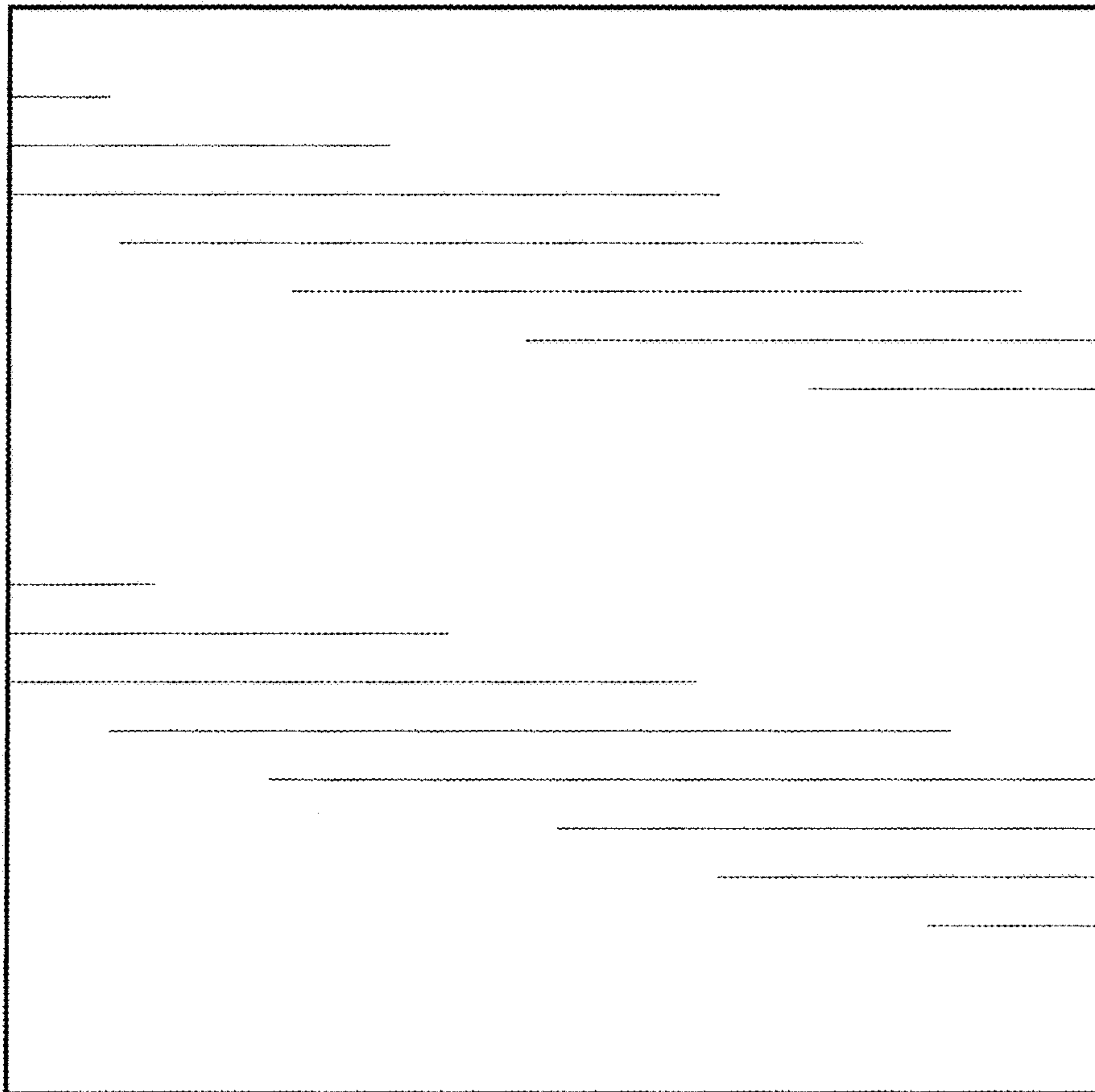

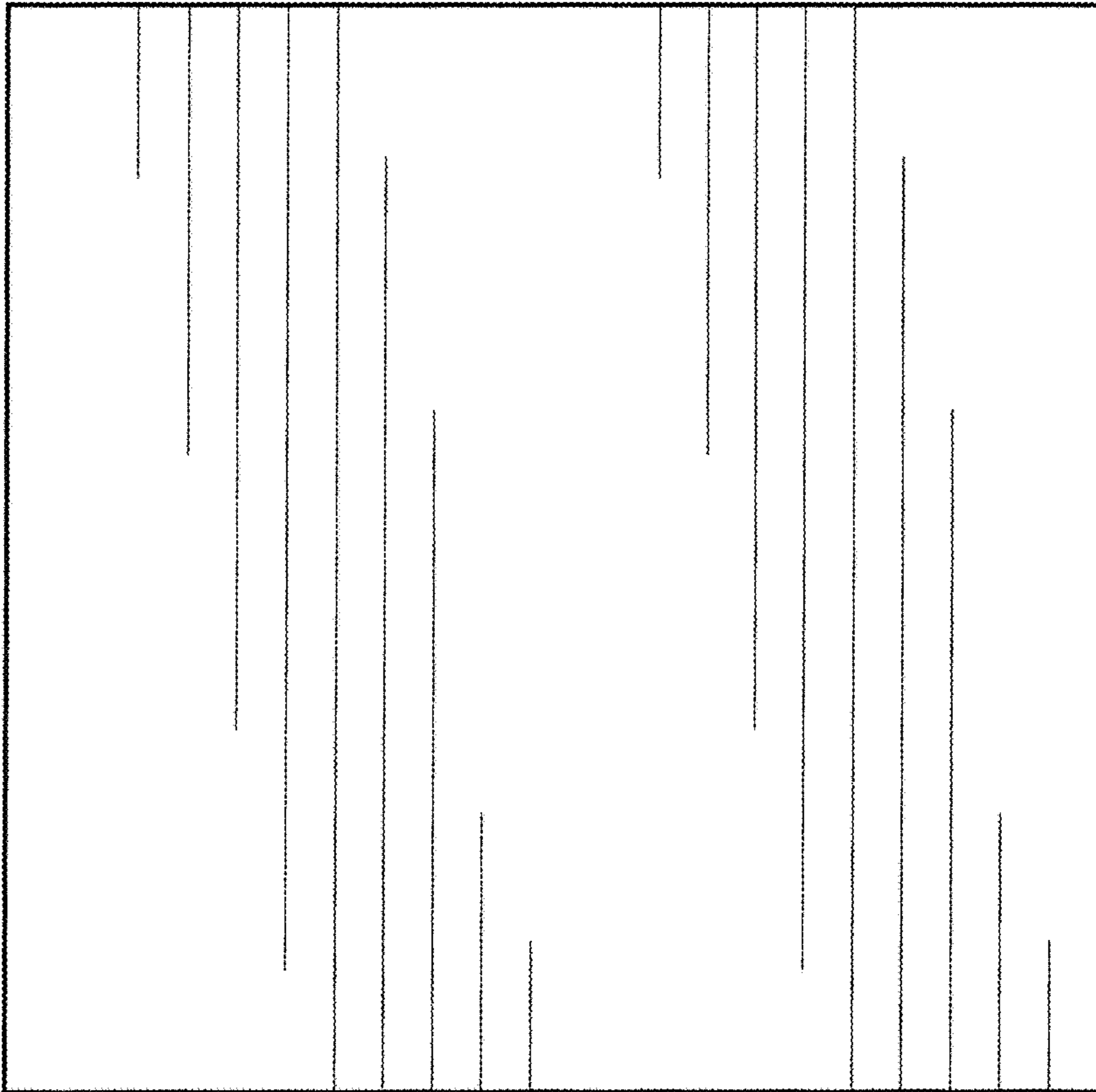

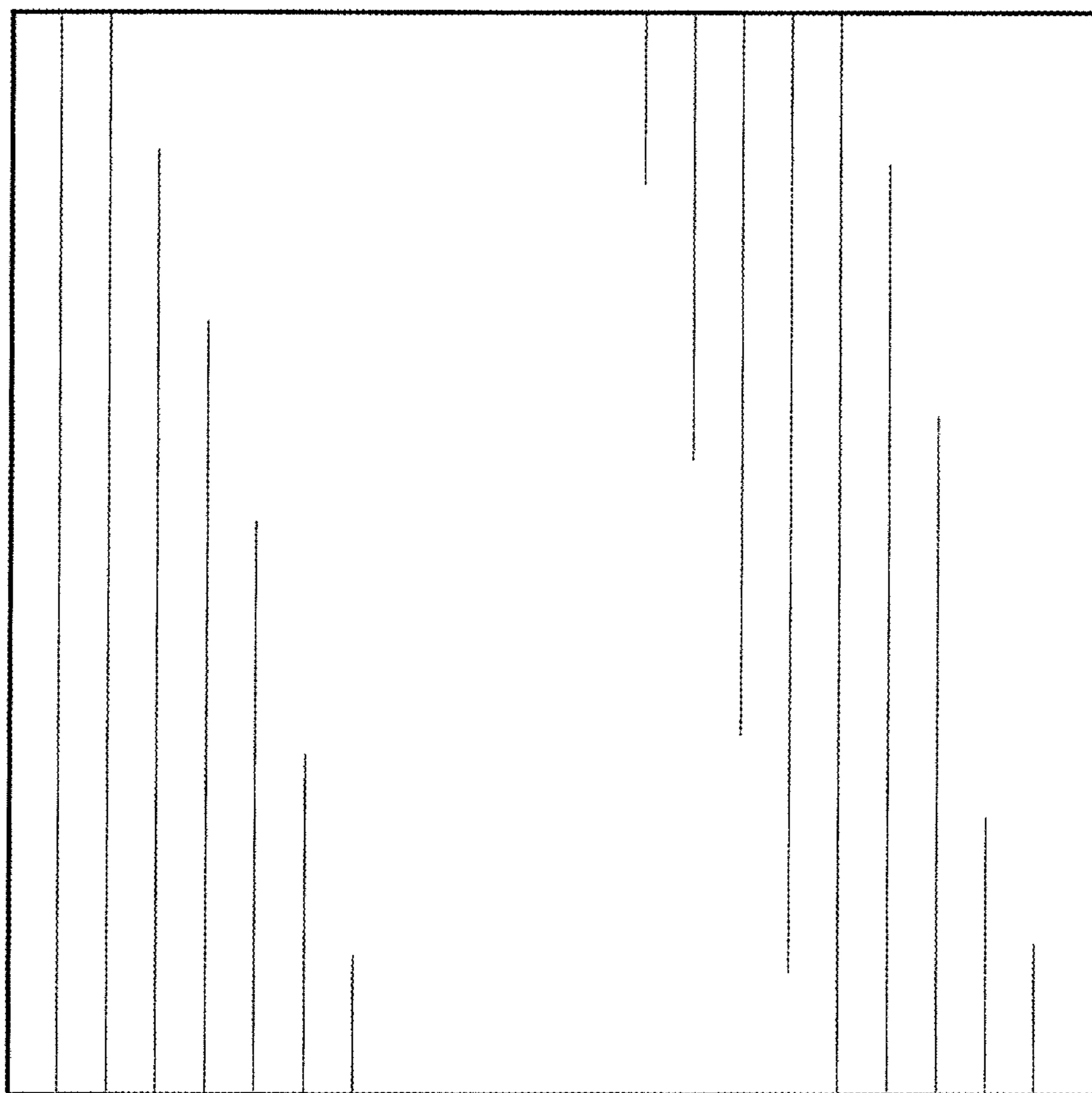
