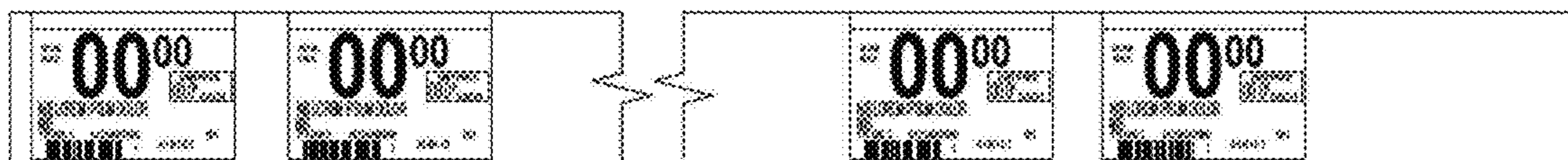
(57) **CLAIM**

We claim the ornamental design for a dual-sided product placement with information strip, as shown.

DESCRIPTION

FIG. 1 is a top view of a dual-sided product placement with information strip; and,
FIG. 2 is a bottom view of a dual-sided product placement with information strip.
The dual-sided product placement with information strip is shown with symbolic breaks in length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

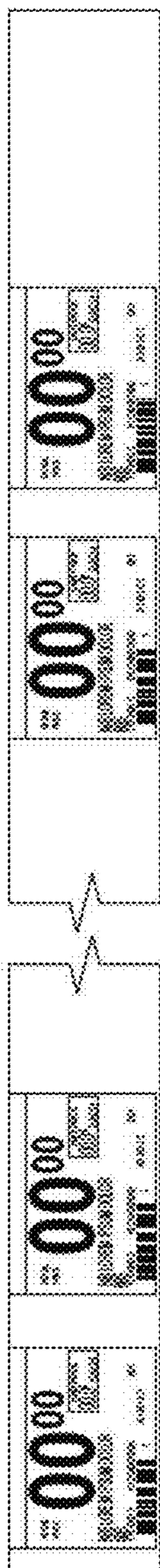

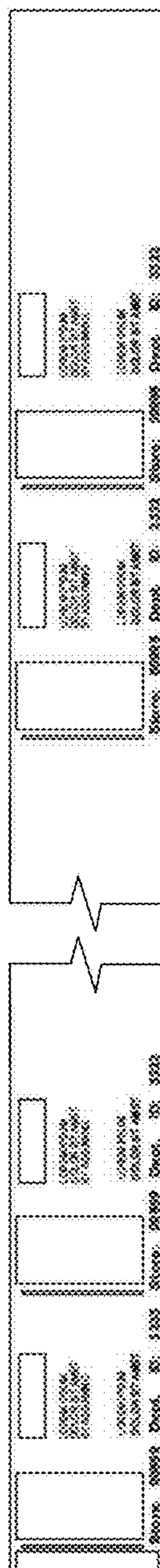
