We claim the ornamental design for a toy element, as shown and described.

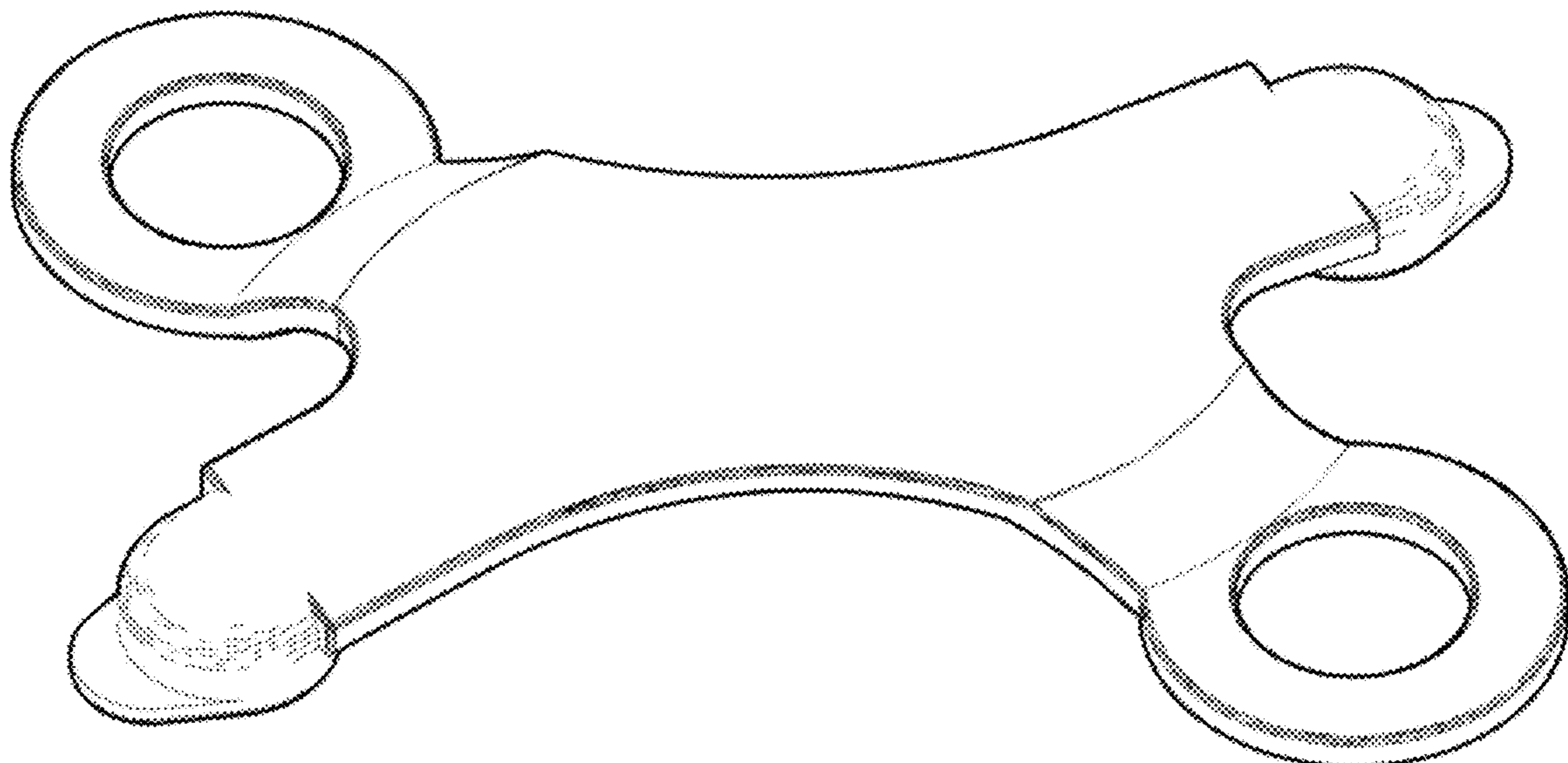

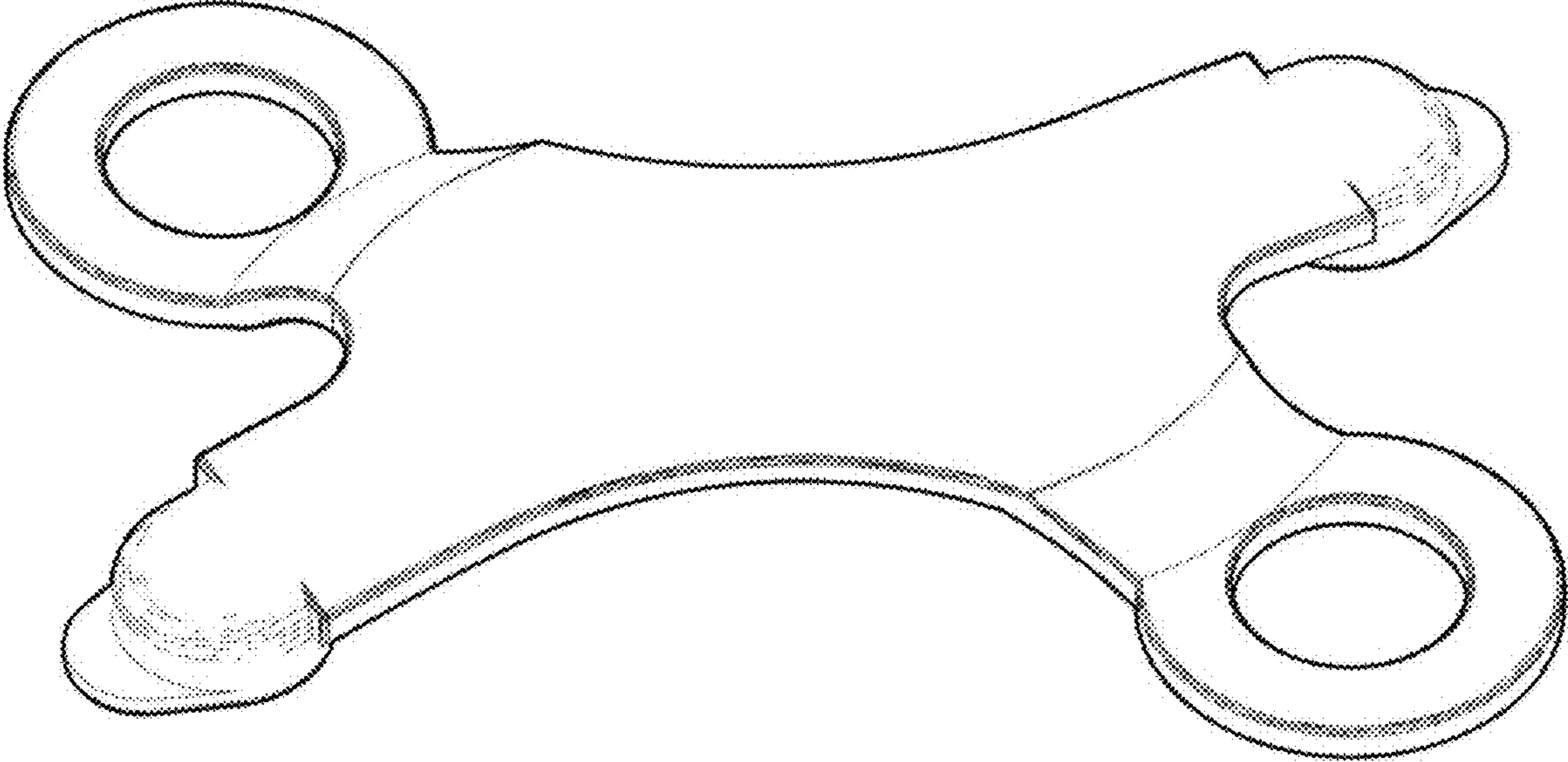
- 1. Toy element

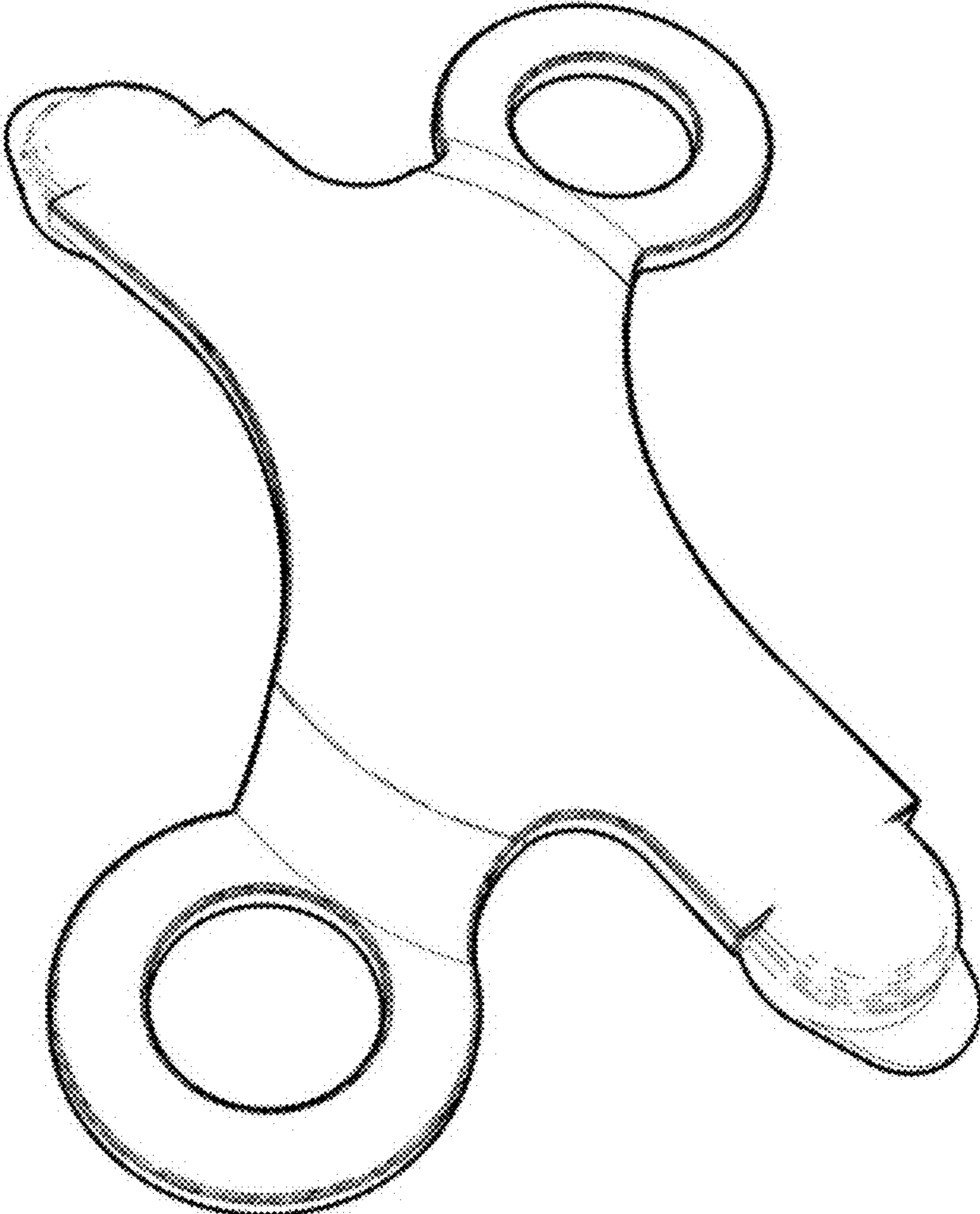

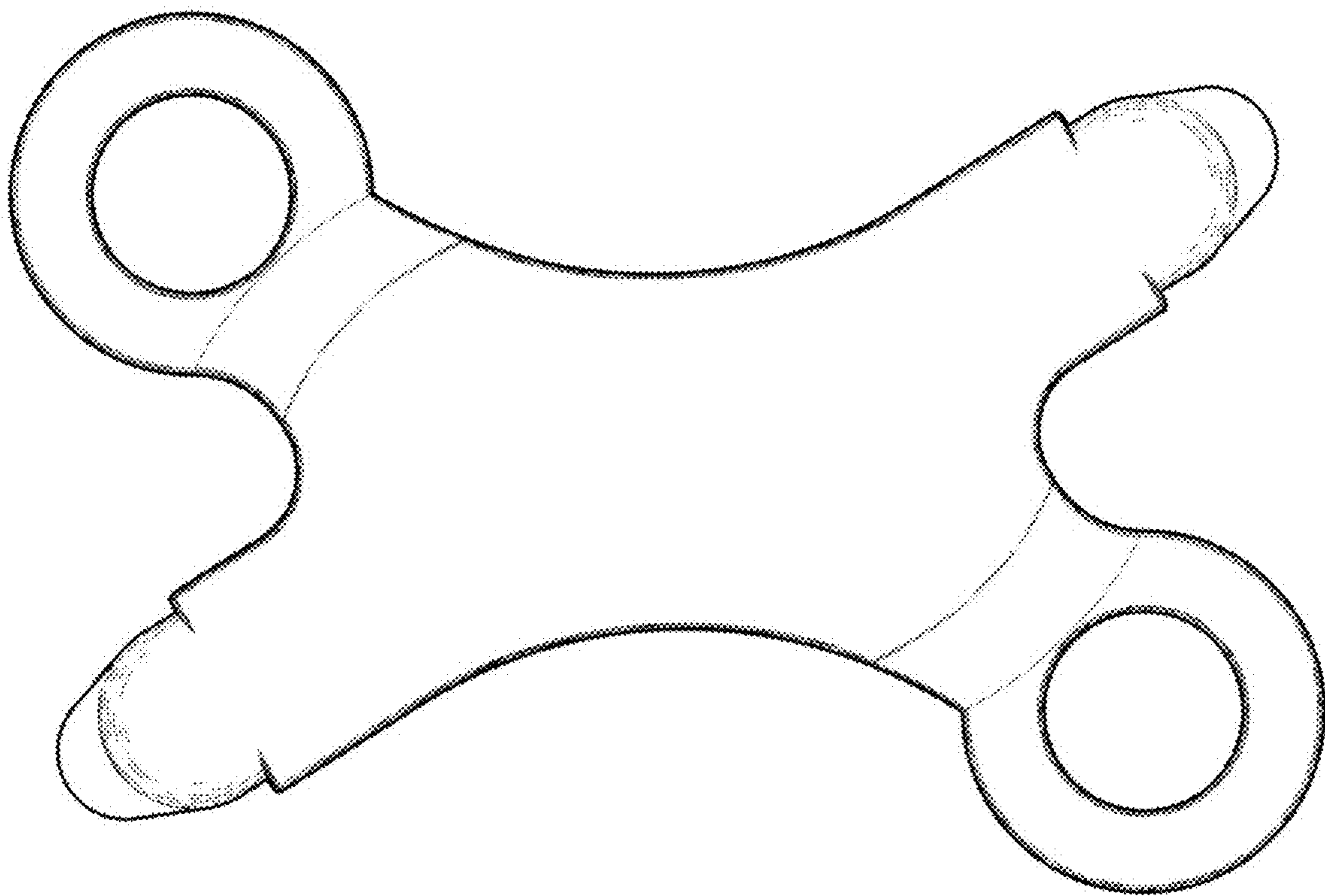
