(57) **CLAIM**

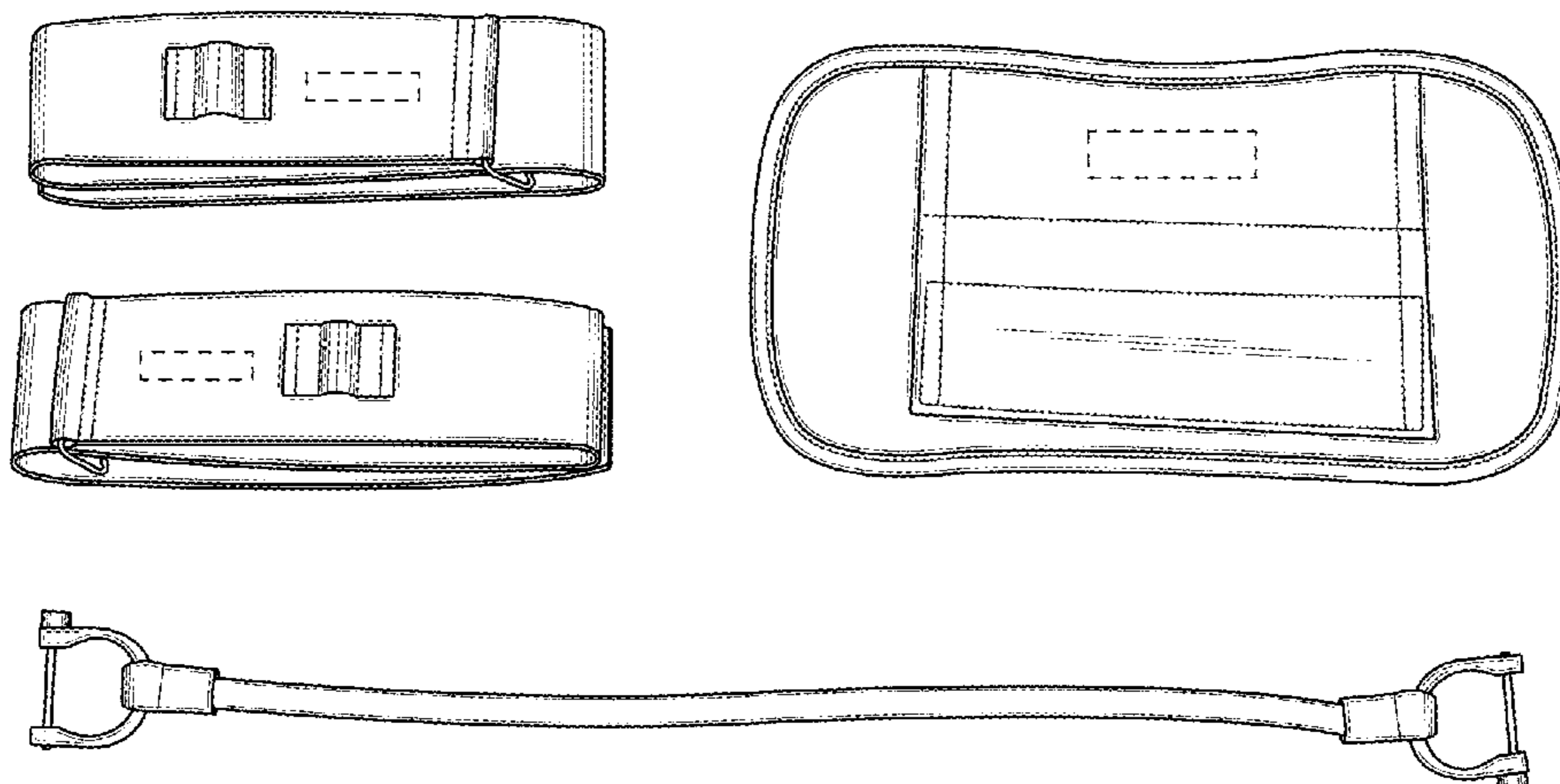
The ornamental design for a kinetic band kit, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a kinetic band kit while unassembled, showing my new design;
FIG. 2 is a front perspective view of the kinetic band kit of FIG. 1 in an assembled state thereof;
FIG. 3 is a front elevational view of FIG. 2 thereof;
FIG. 4 is a rear elevational view of FIG. 2 thereof; and,

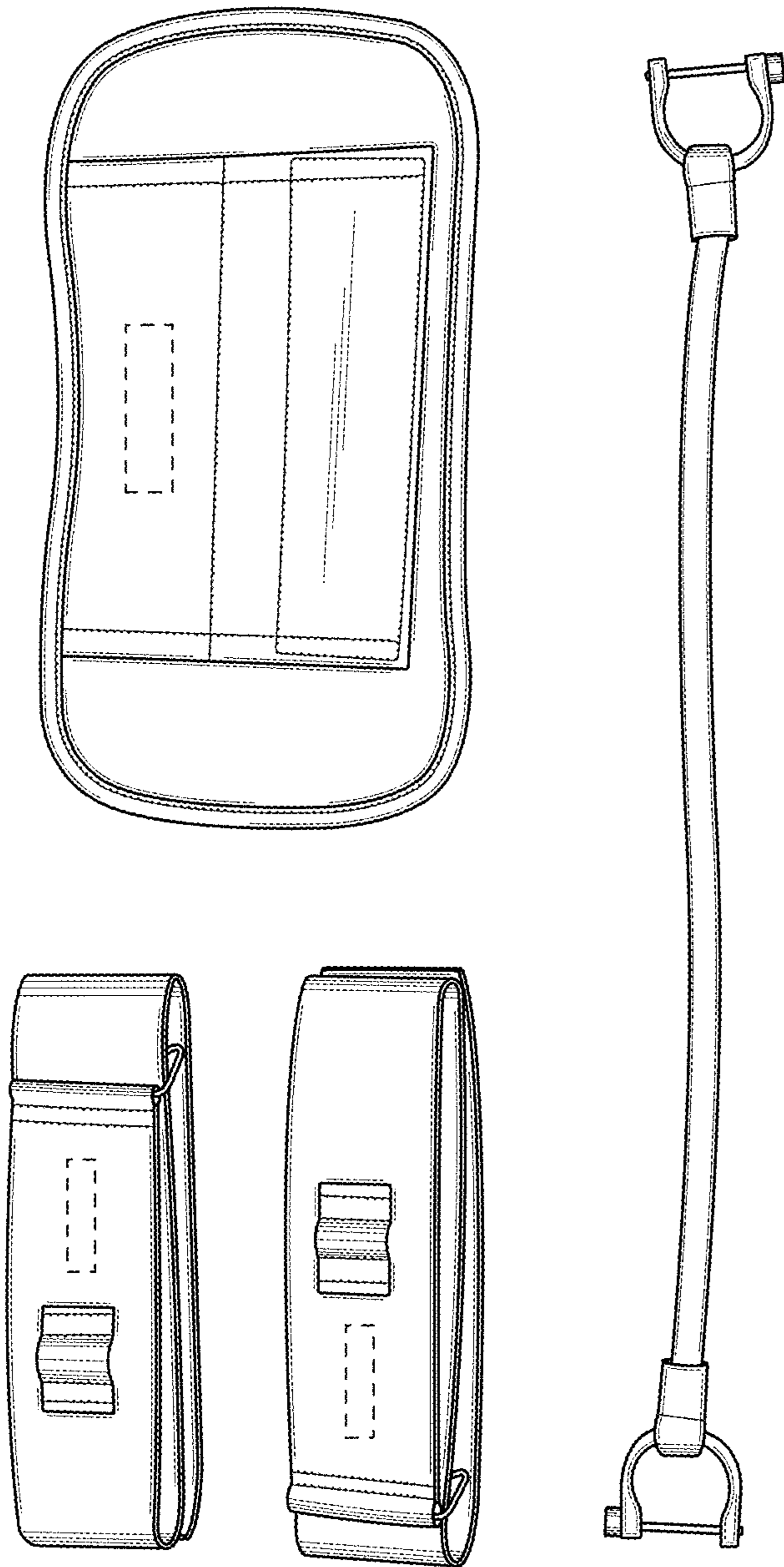

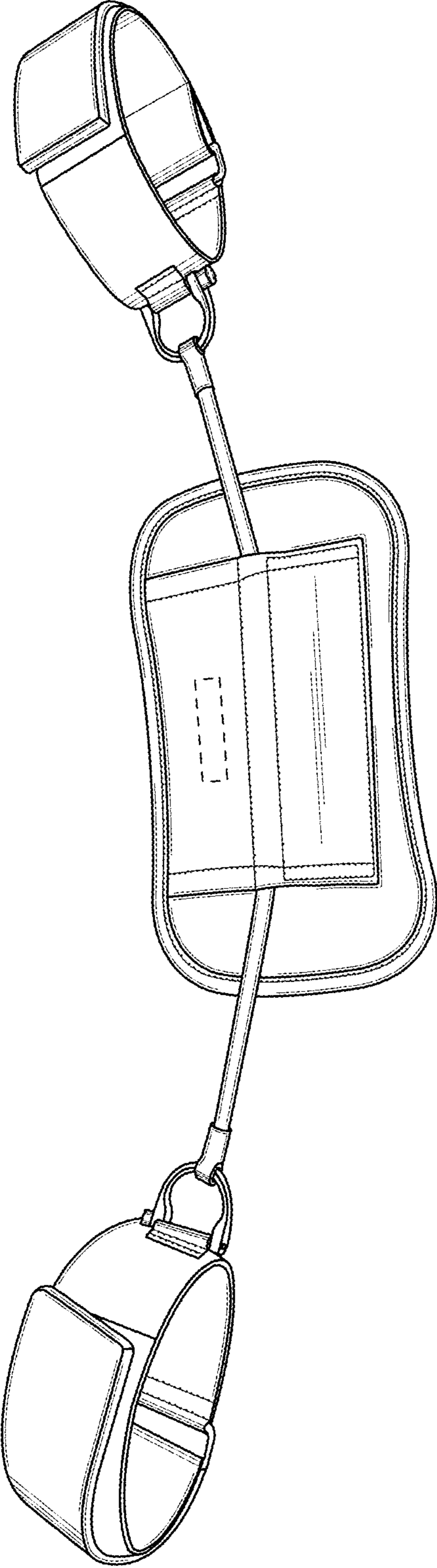

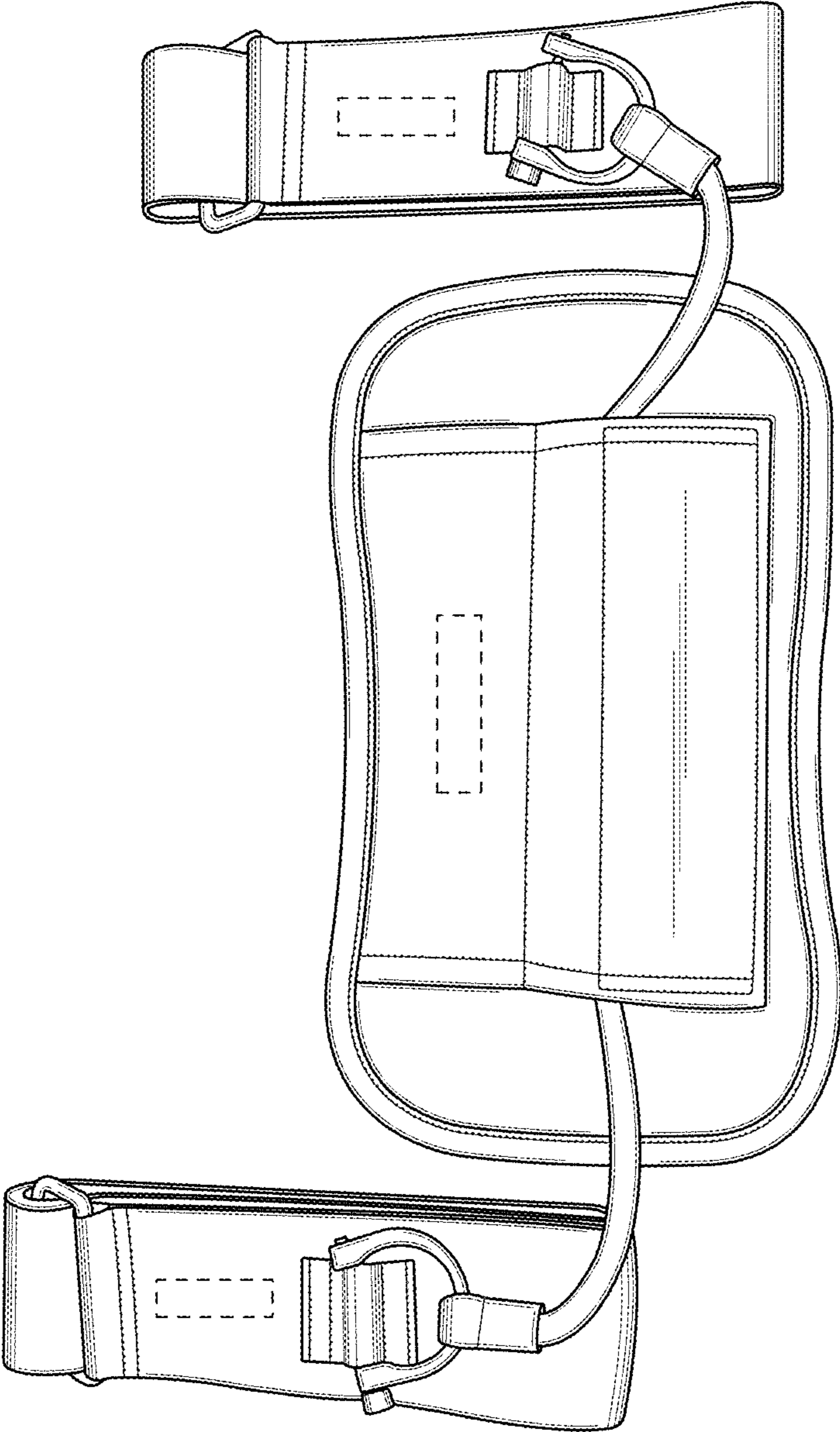

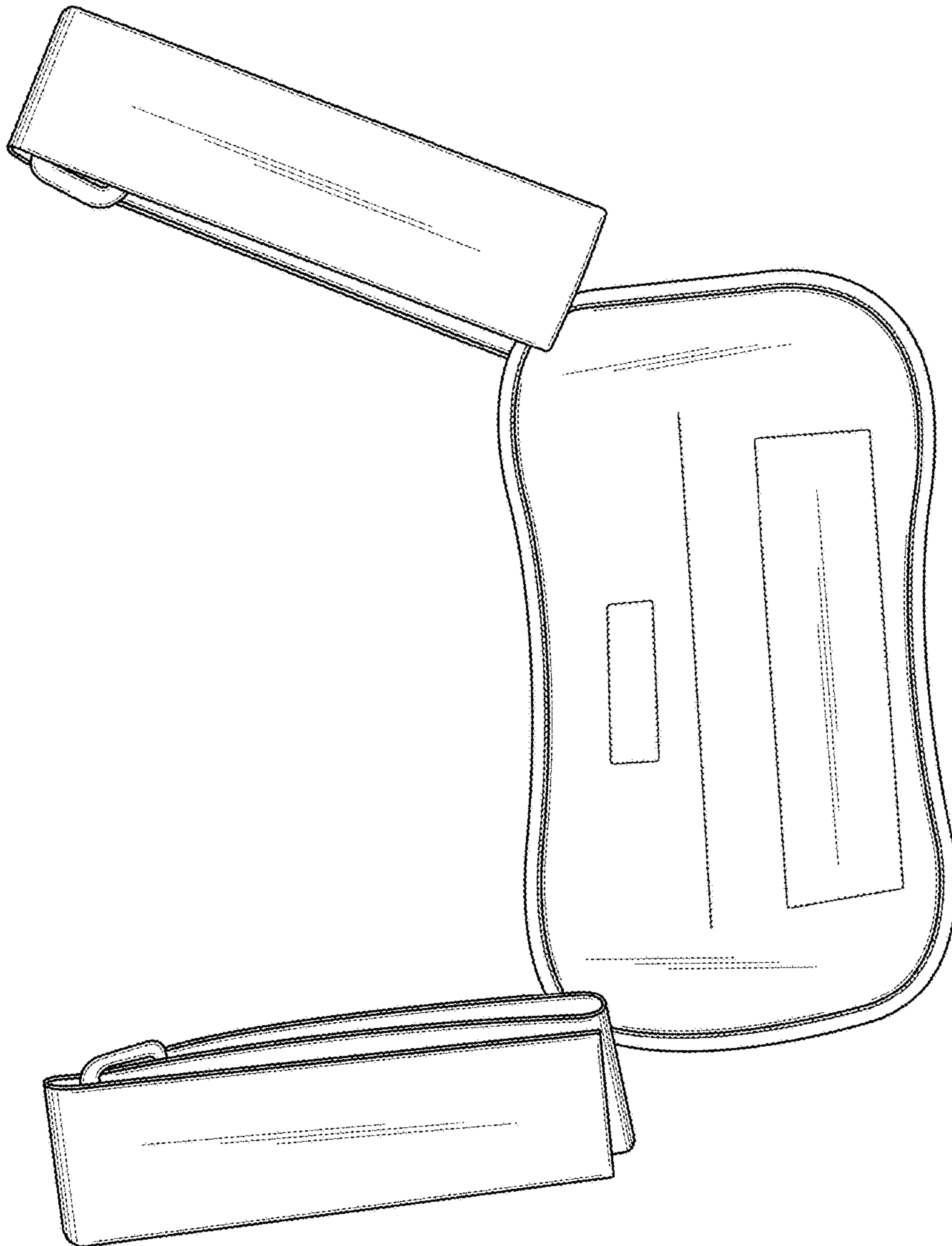

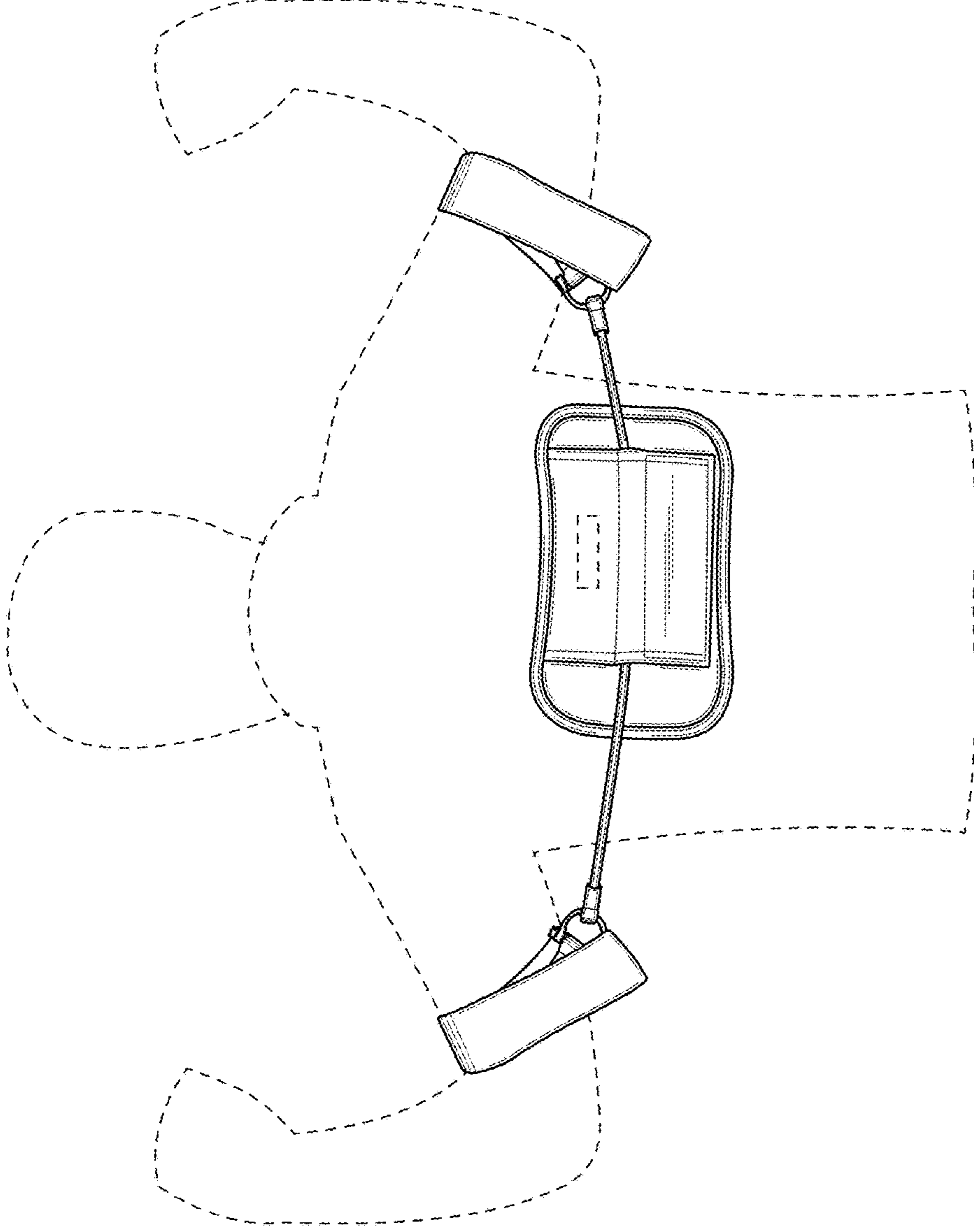
