(57) **CLAIM**

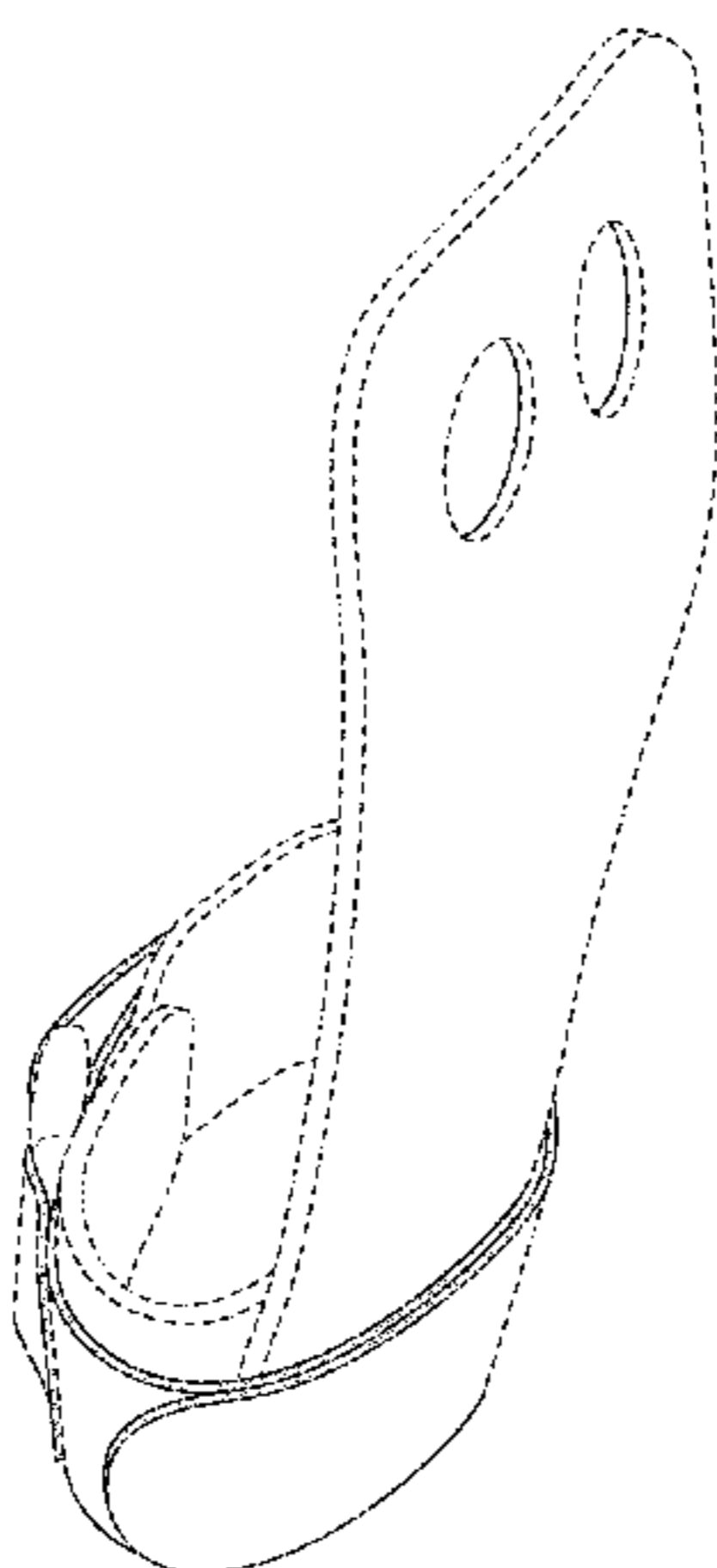
We claim the ornamental design for an athletic hand grip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an athletic hand grip; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a side elevational view thereof; FIG. 5 is another side devotional view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front elevational view similar to FIG. 2 and shows the athletic hand grip being worn on a user's hand; and, FIG. 9 is a rear elevational view similar to FIG. 3 and shows the athletic hand grip being worn on the user's hand. The stipple shading shown in FIGS. 1-9 represents a textured material.

The dash-dot-dash lines shown in FIGS. 8 and 9 illustrate the user's hand and form no part of the claim; the evenly-spaced broken lines shown in FIGS. 1-9 illustrate features of the athletic hand grip that form no part of the claimed design. Our design includes a second embodiment of an athletic hand grip that is a mirror image of the design shown in FIGS. 1-9.

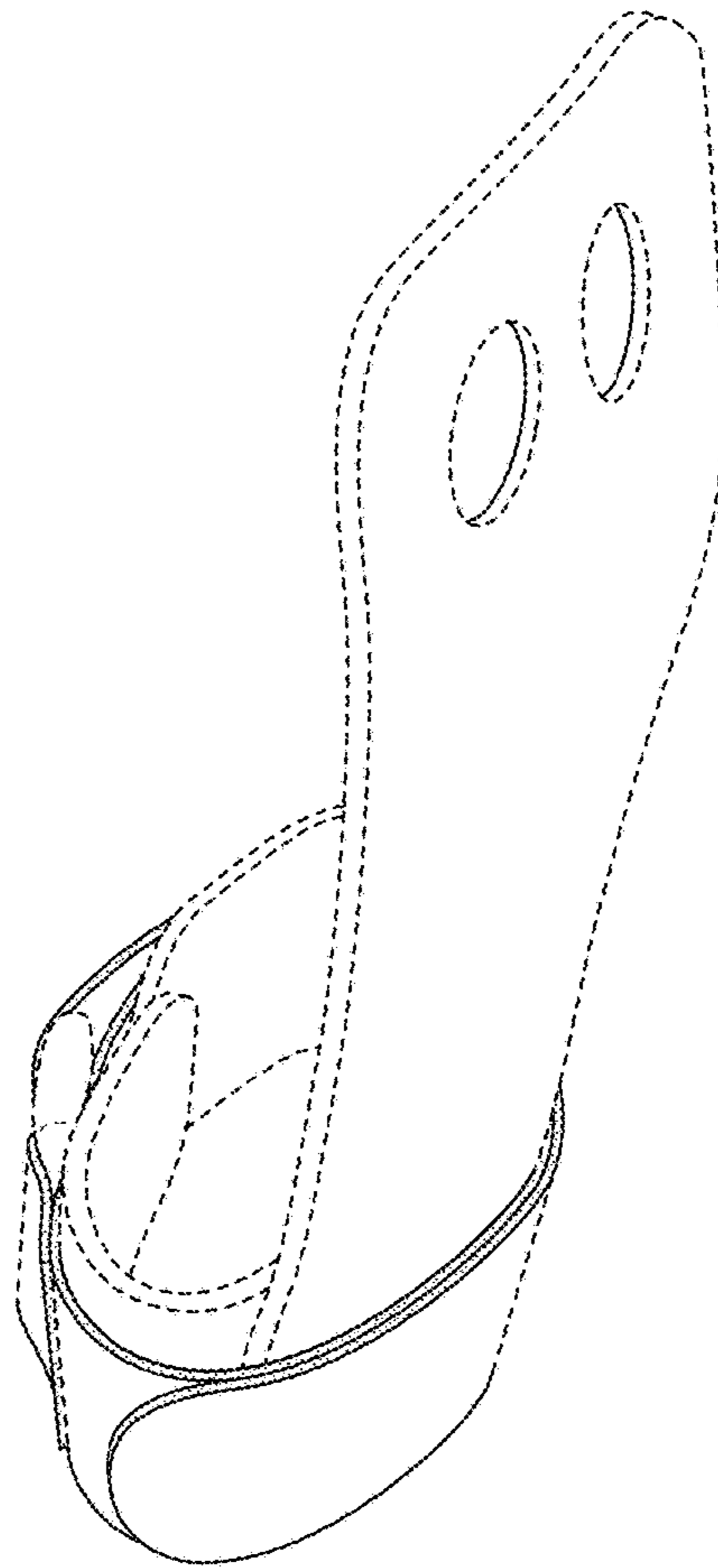

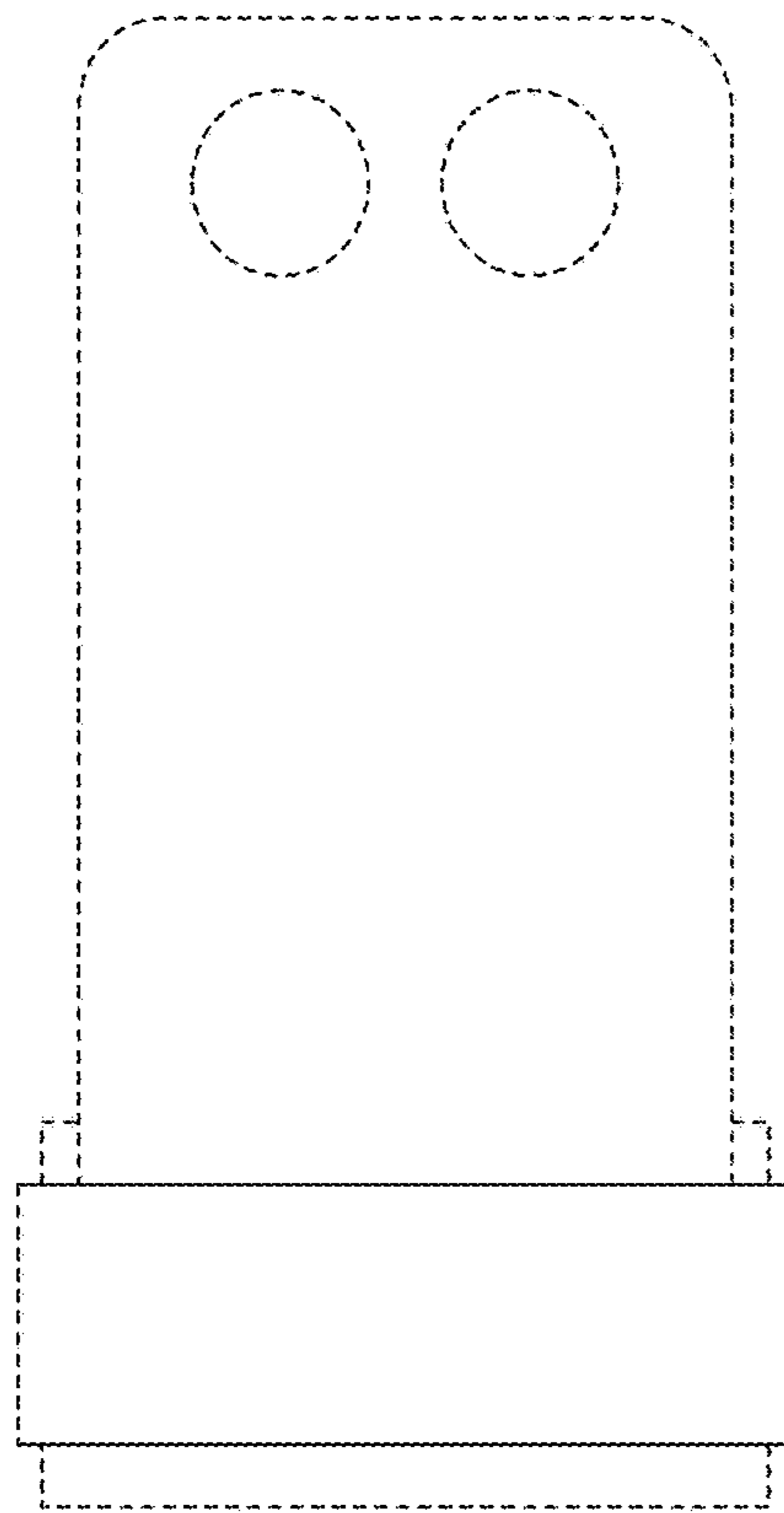

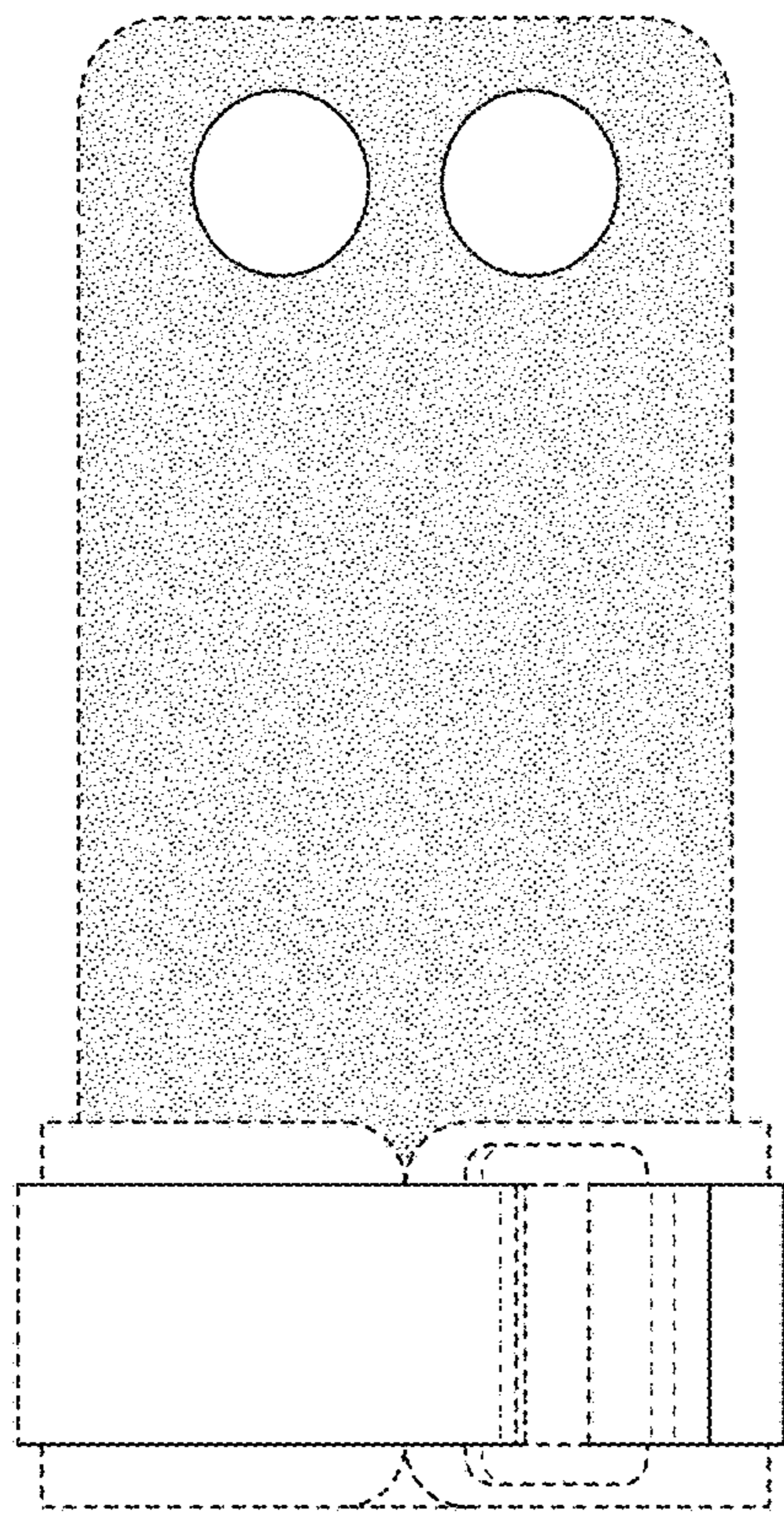

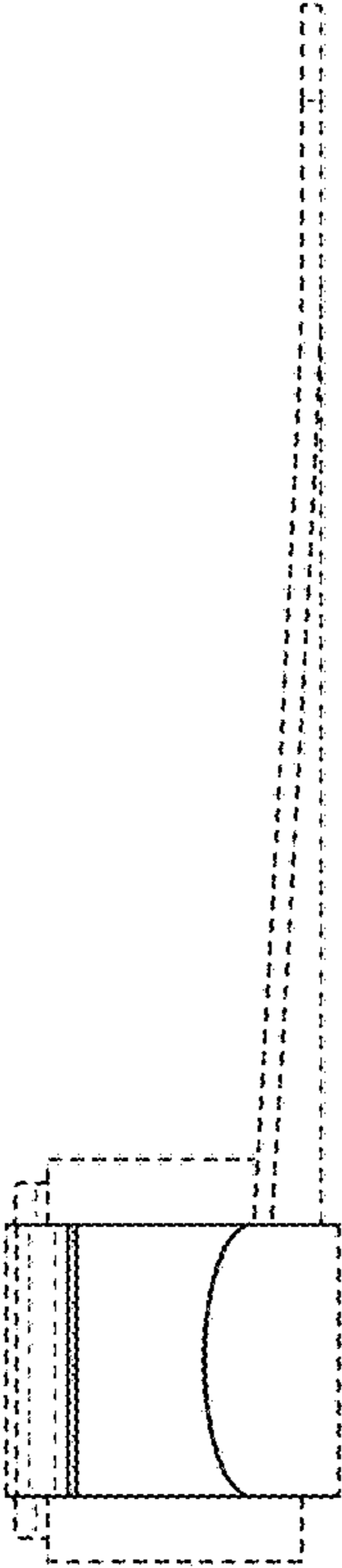

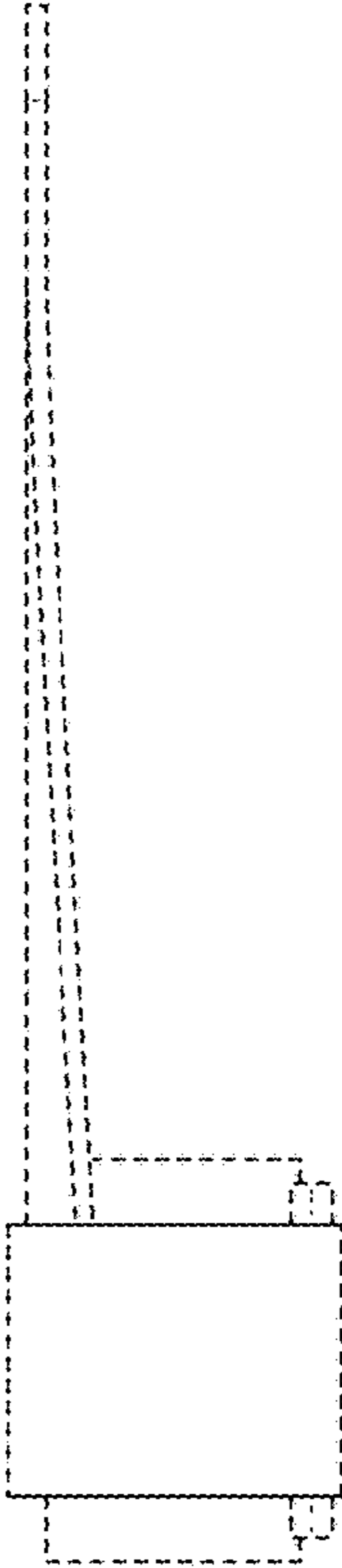

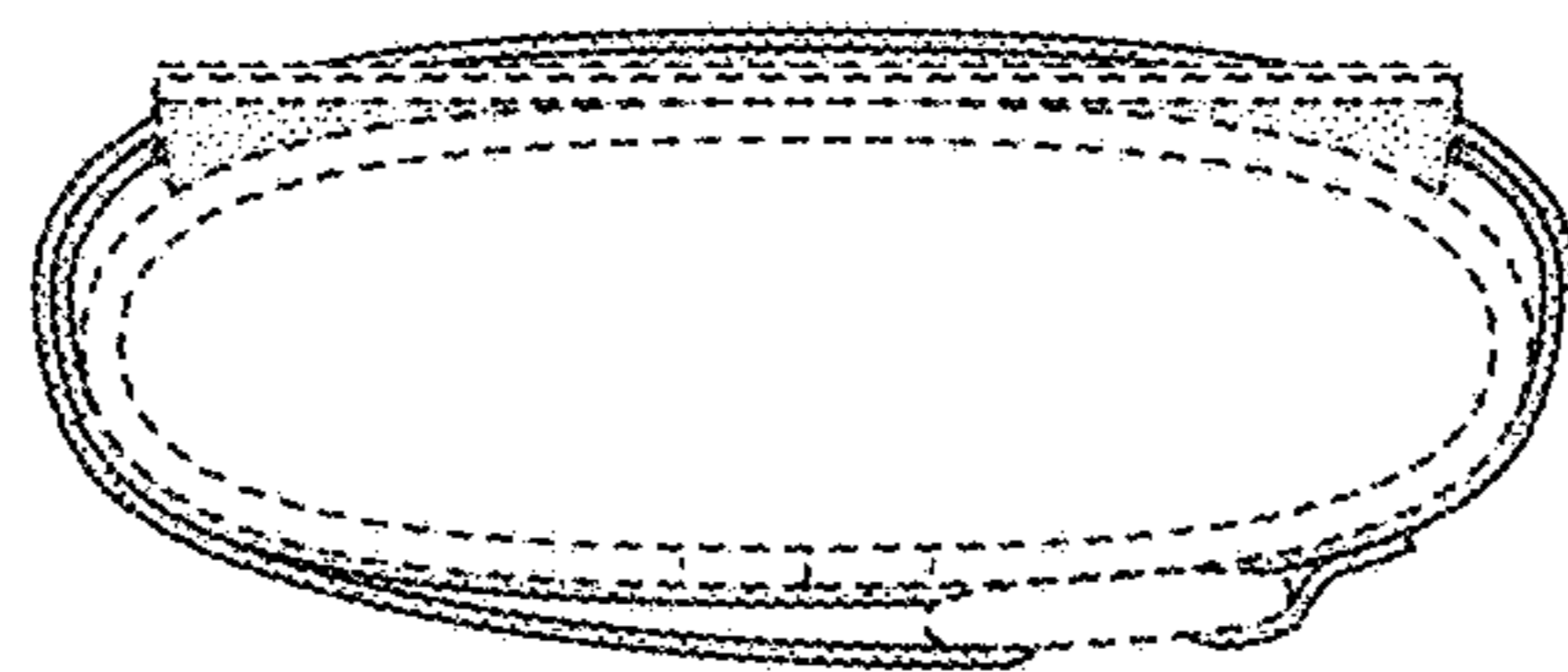

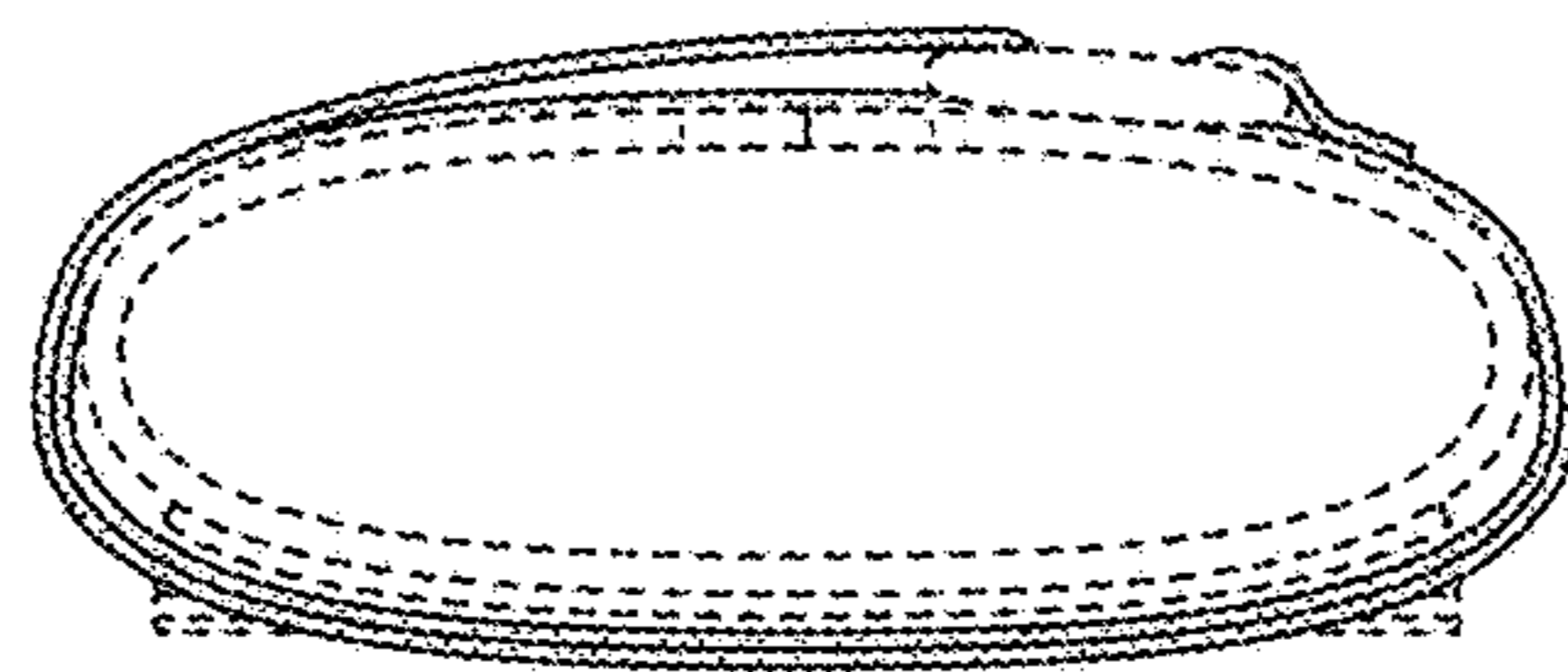

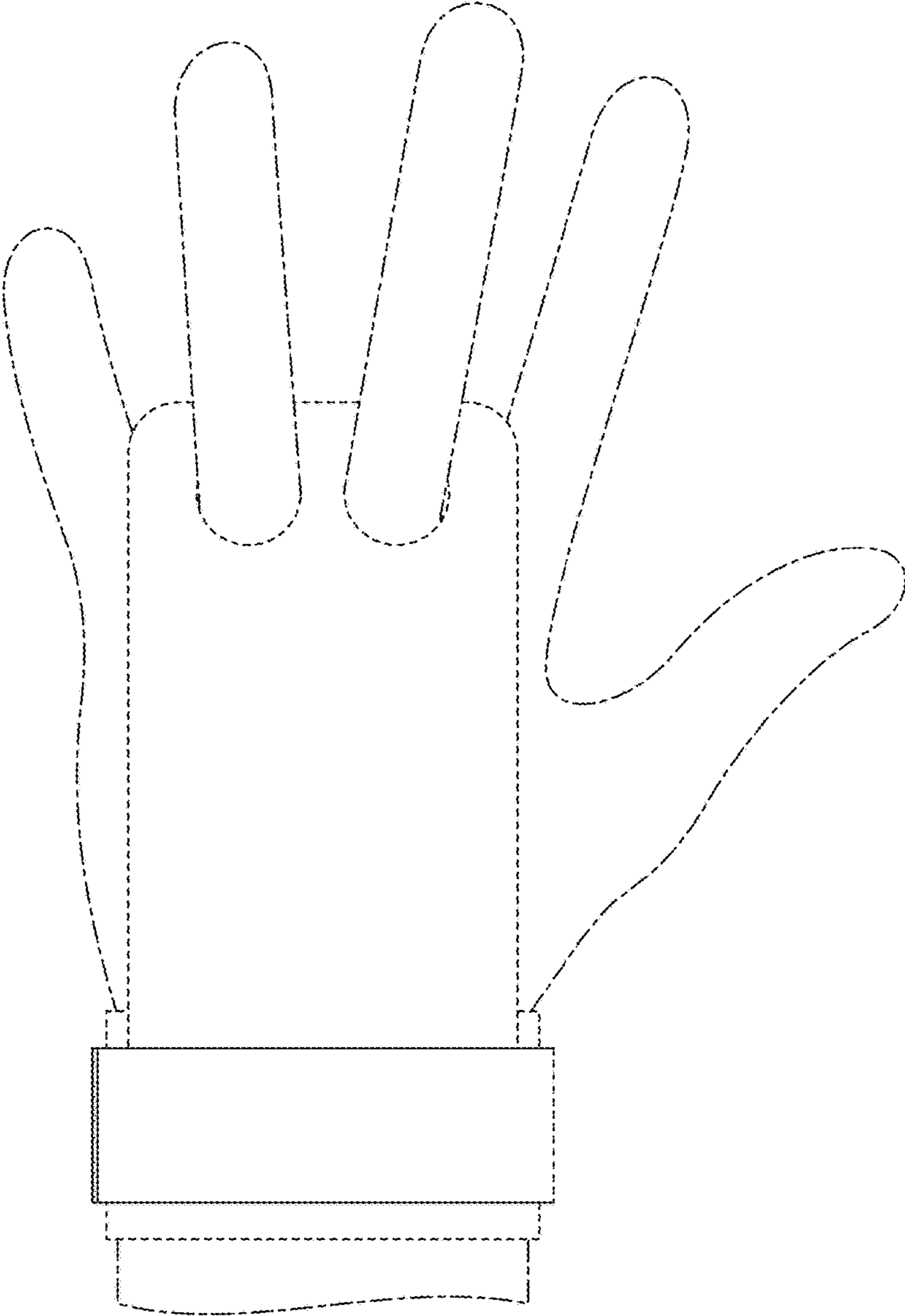

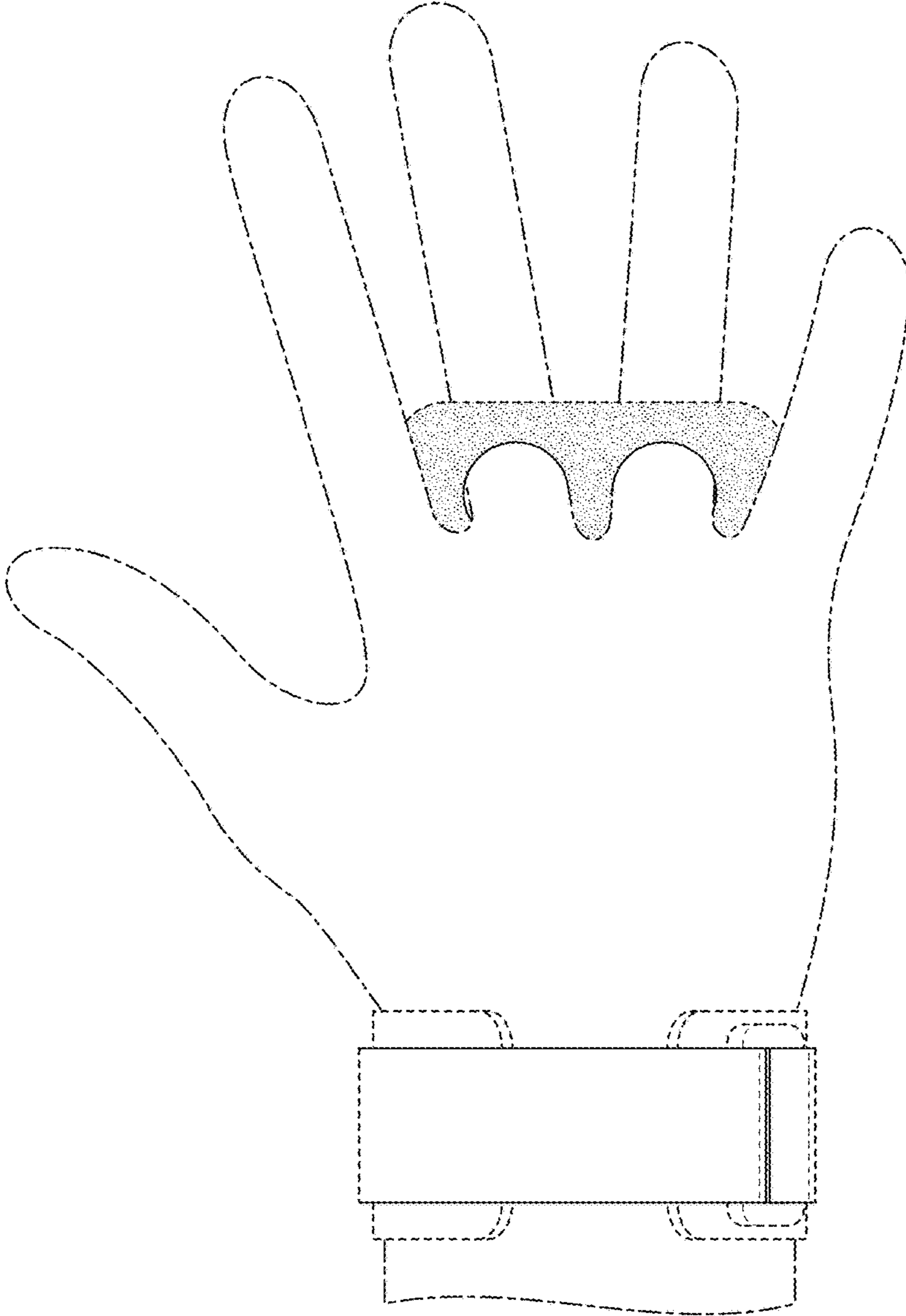
