(57) **CLAIM**

I claim the ornamental design for a sheathed battle rope, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the sheathed battle rope showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a left side elevation view thereof;

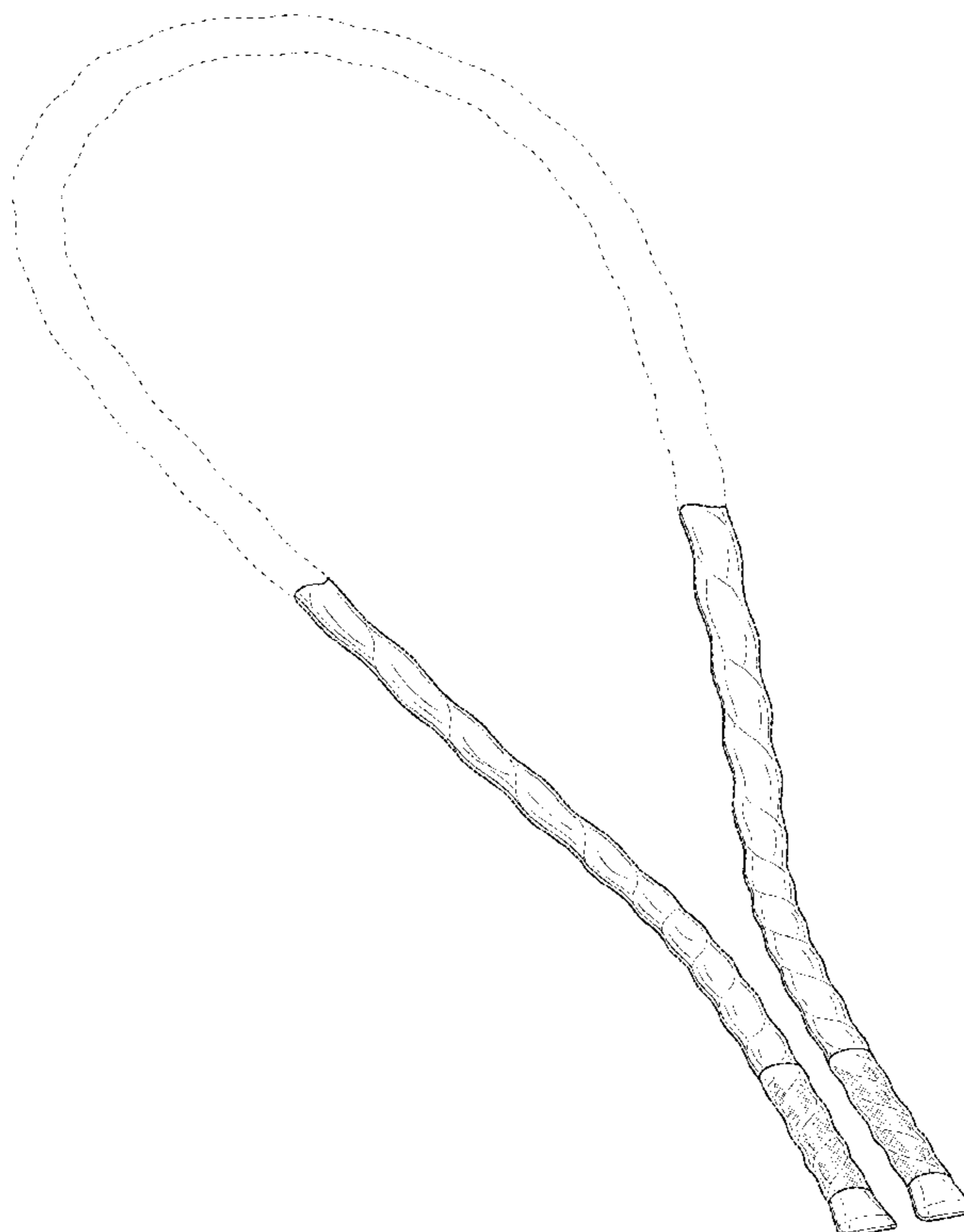
FIG. 5 is a right side elevation view thereof;

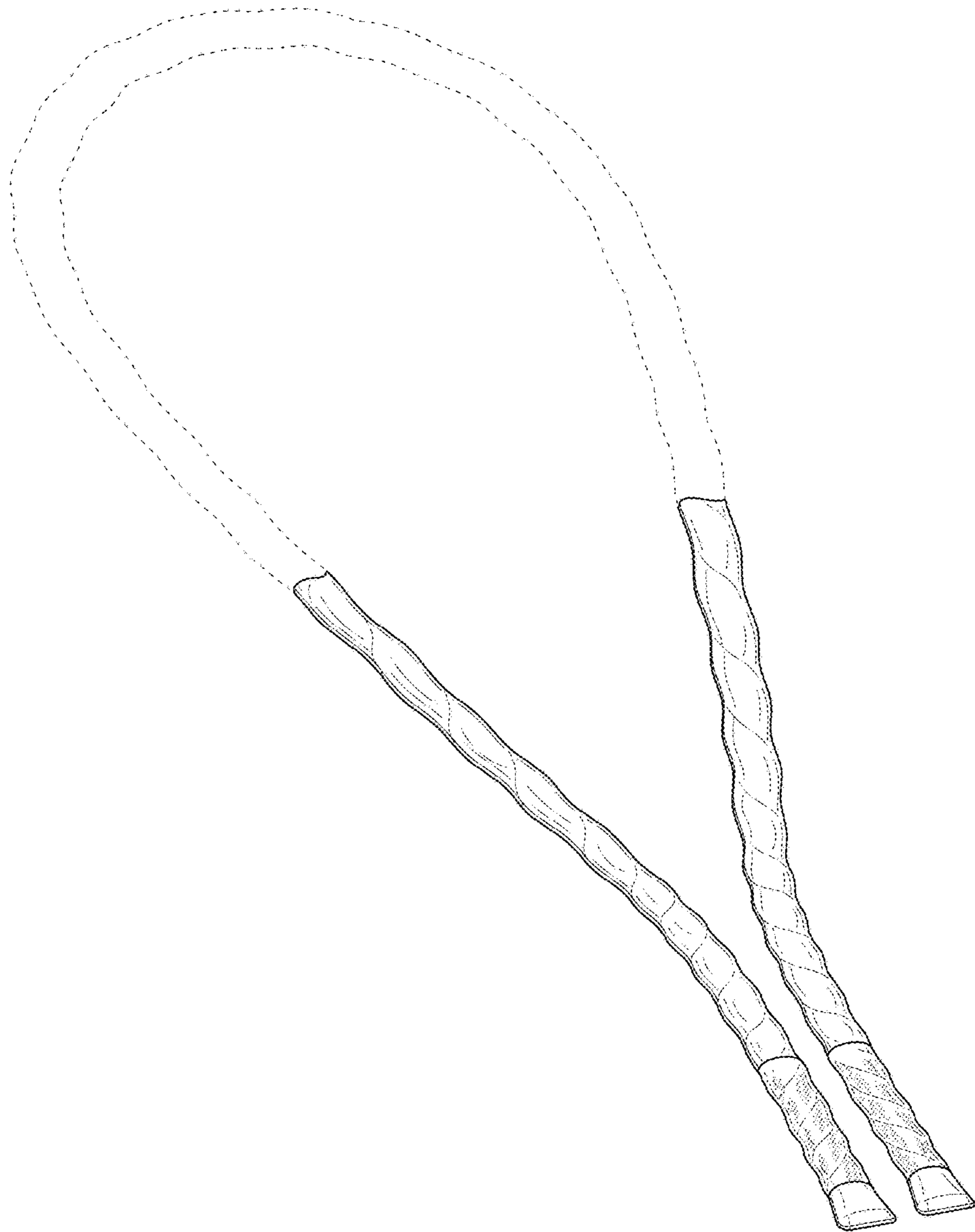

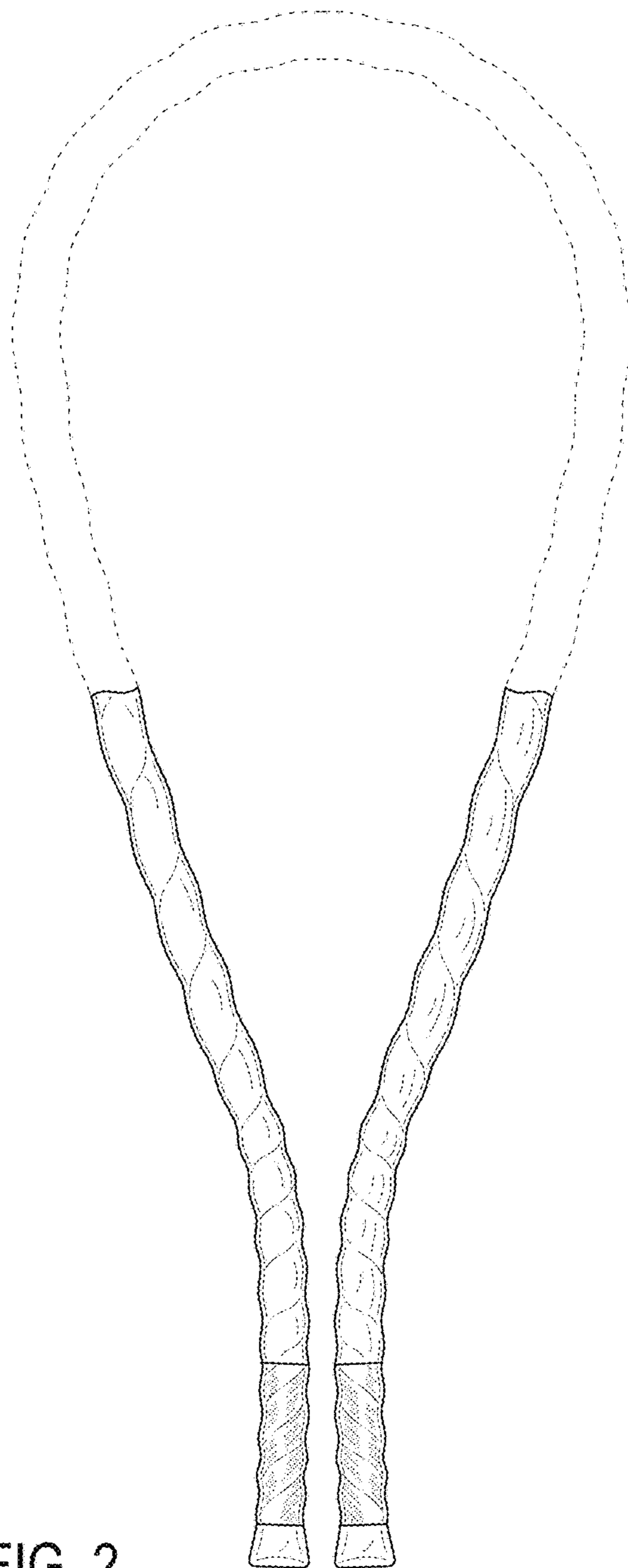

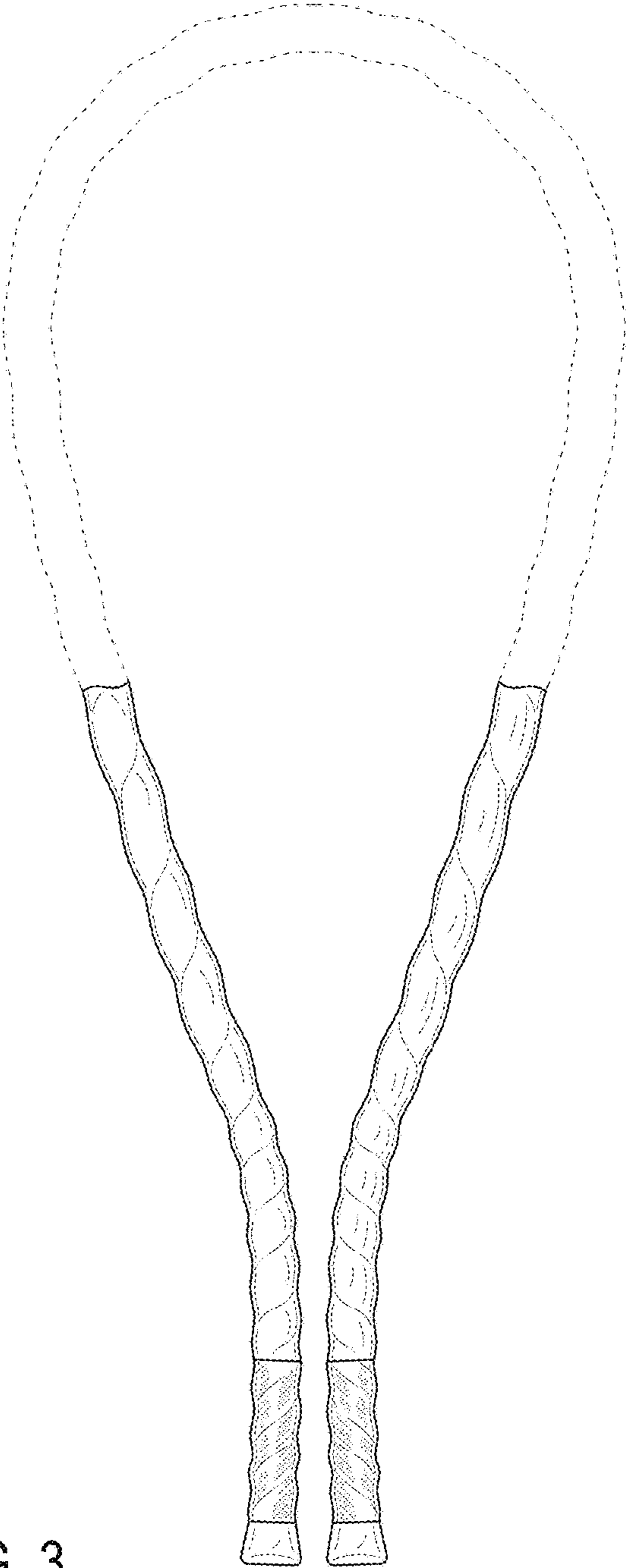

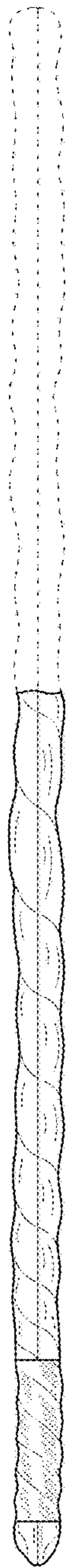

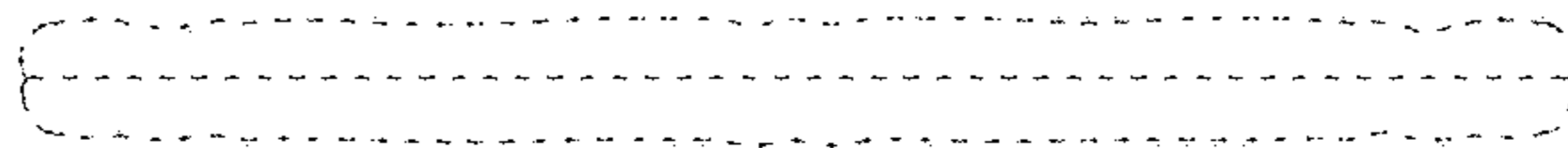
