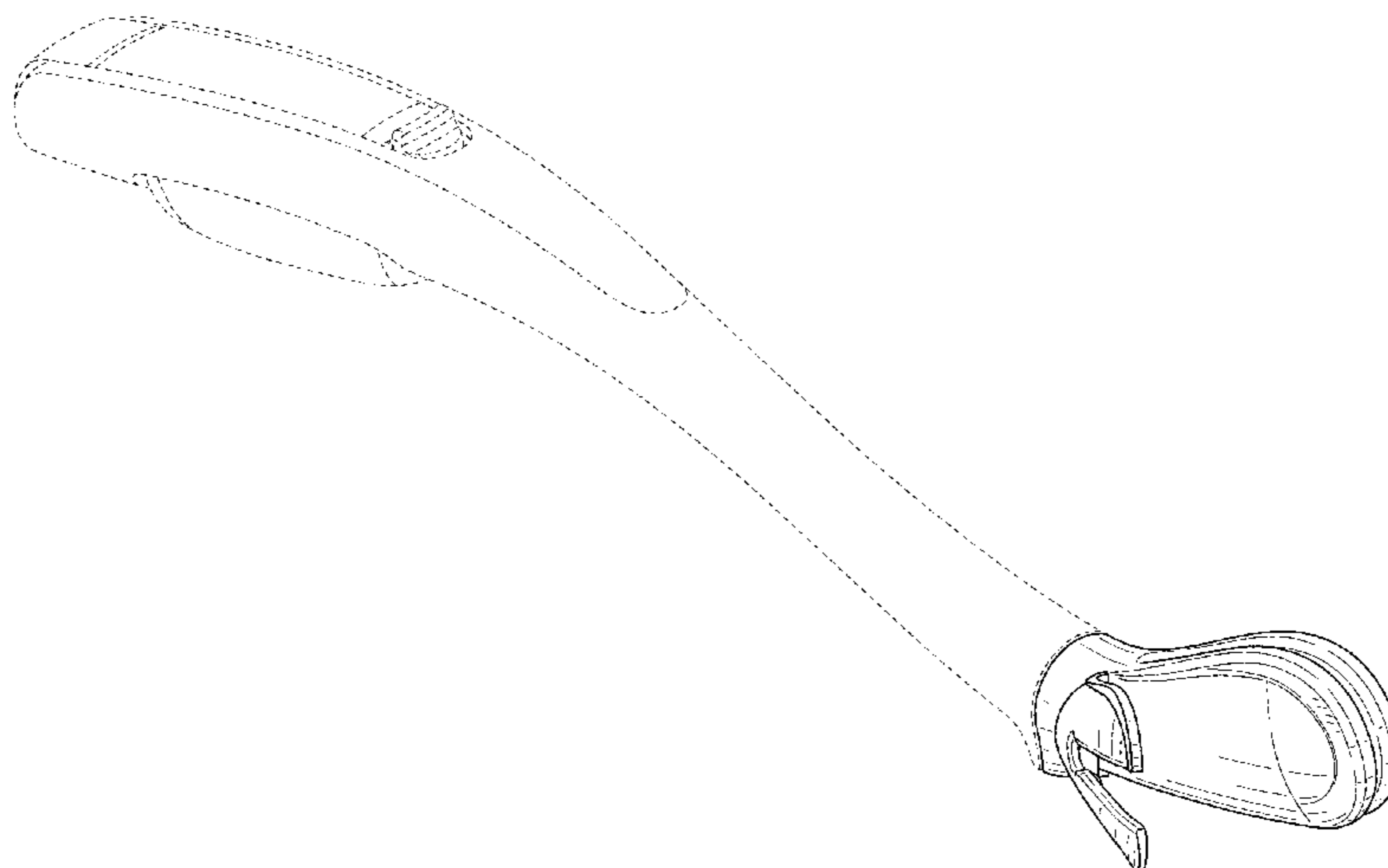
(57) **CLAIM**

We claim the ornamental design for a personal hygiene aid jaw member, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a personal hygiene aid jaw member according to one embodiment of our new design; FIG. 2 is a left side elevation view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a front side elevation view thereof; FIG. 5 is a rear side elevation view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. The broken lines shown in the figures represent portions of the personal hygiene aid jaw member that form no part of the claimed design.

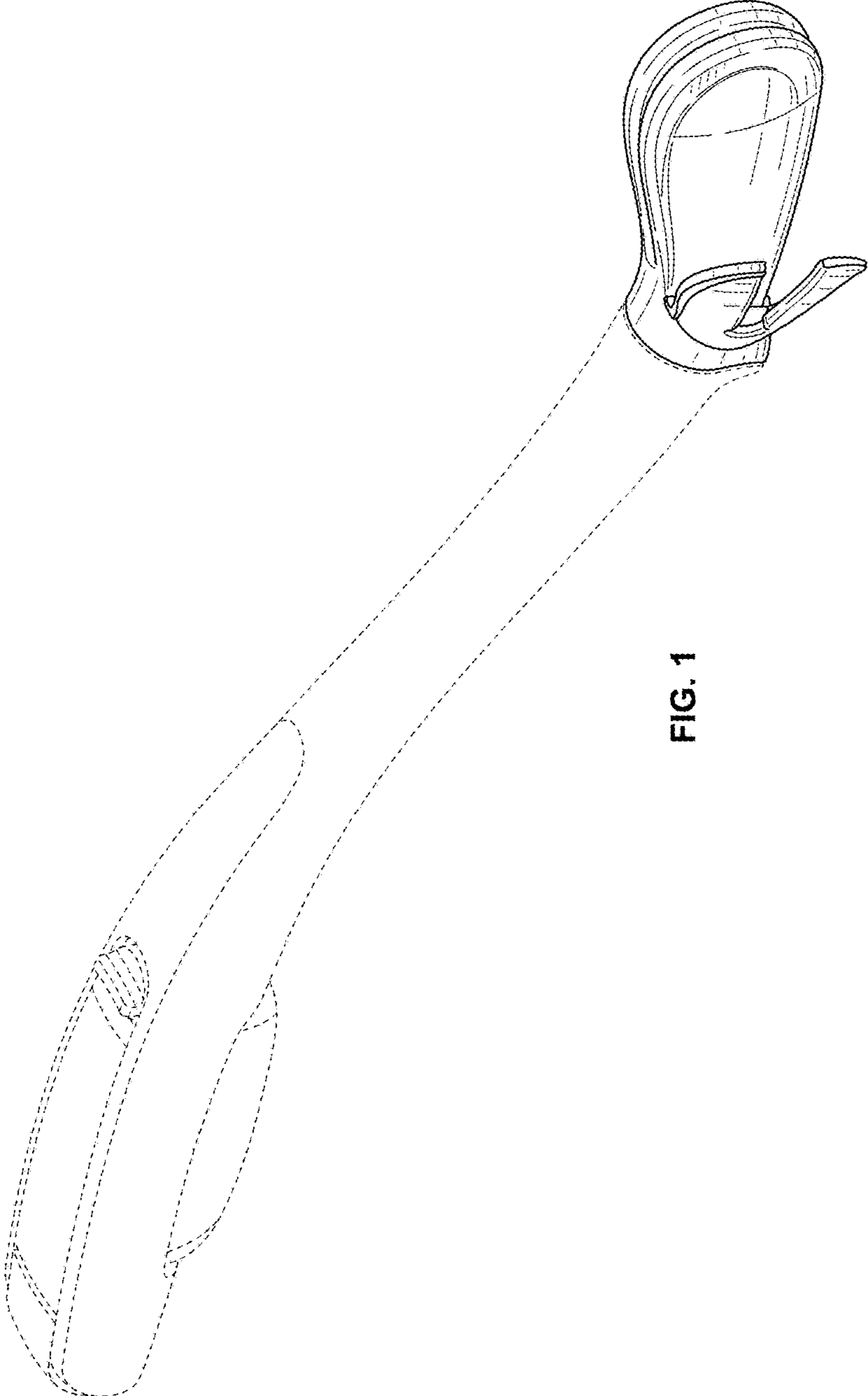

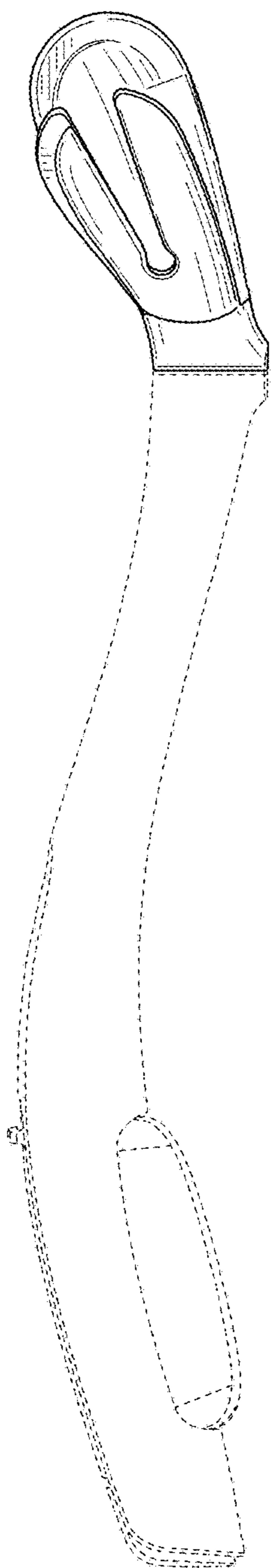

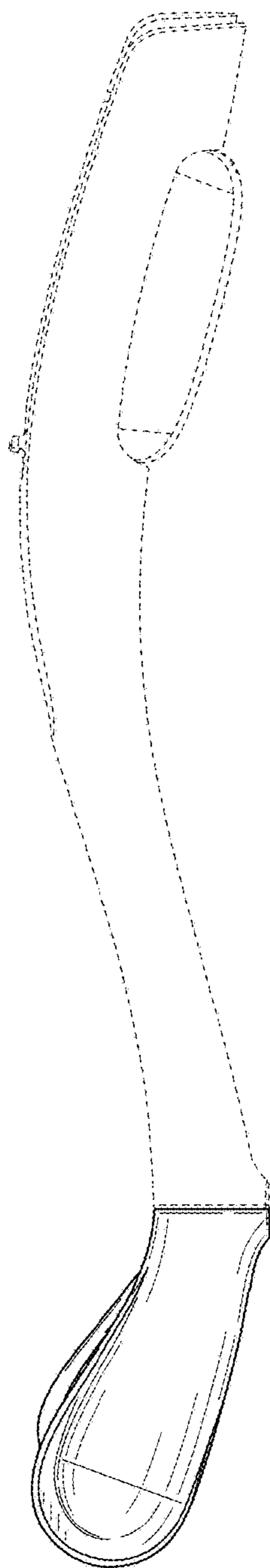

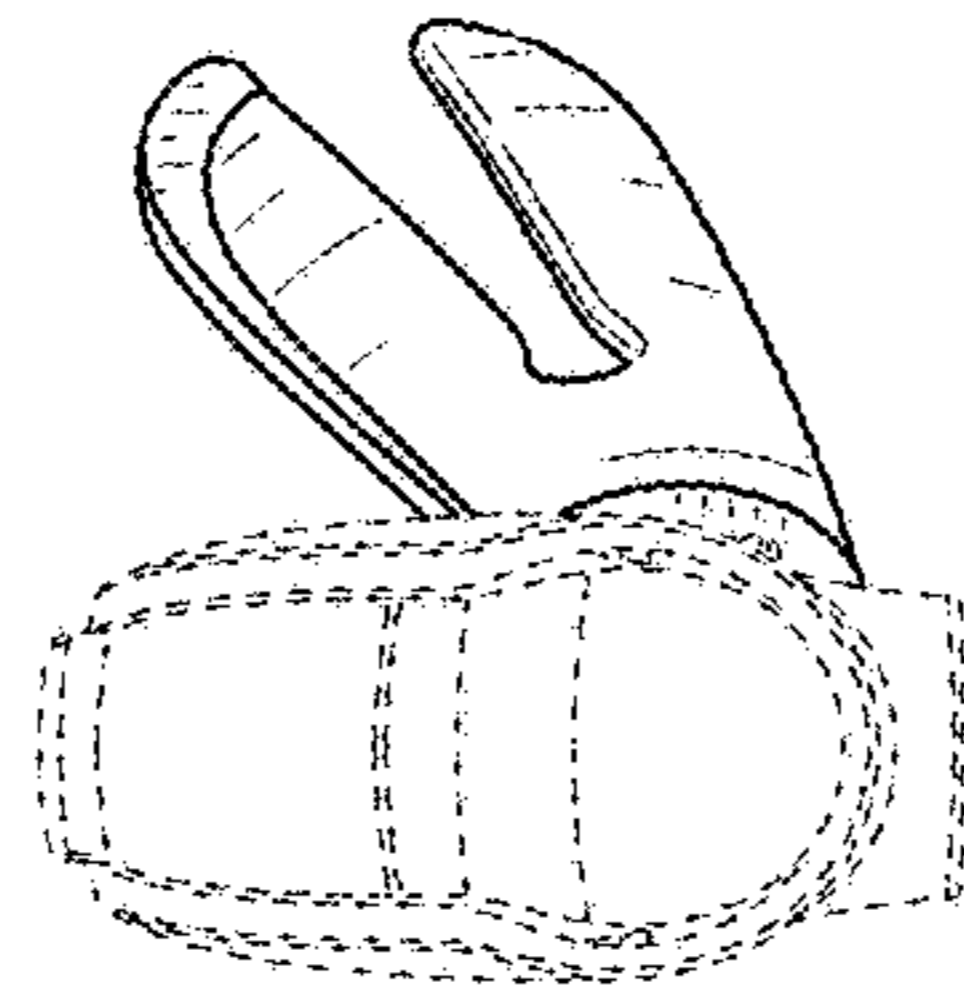

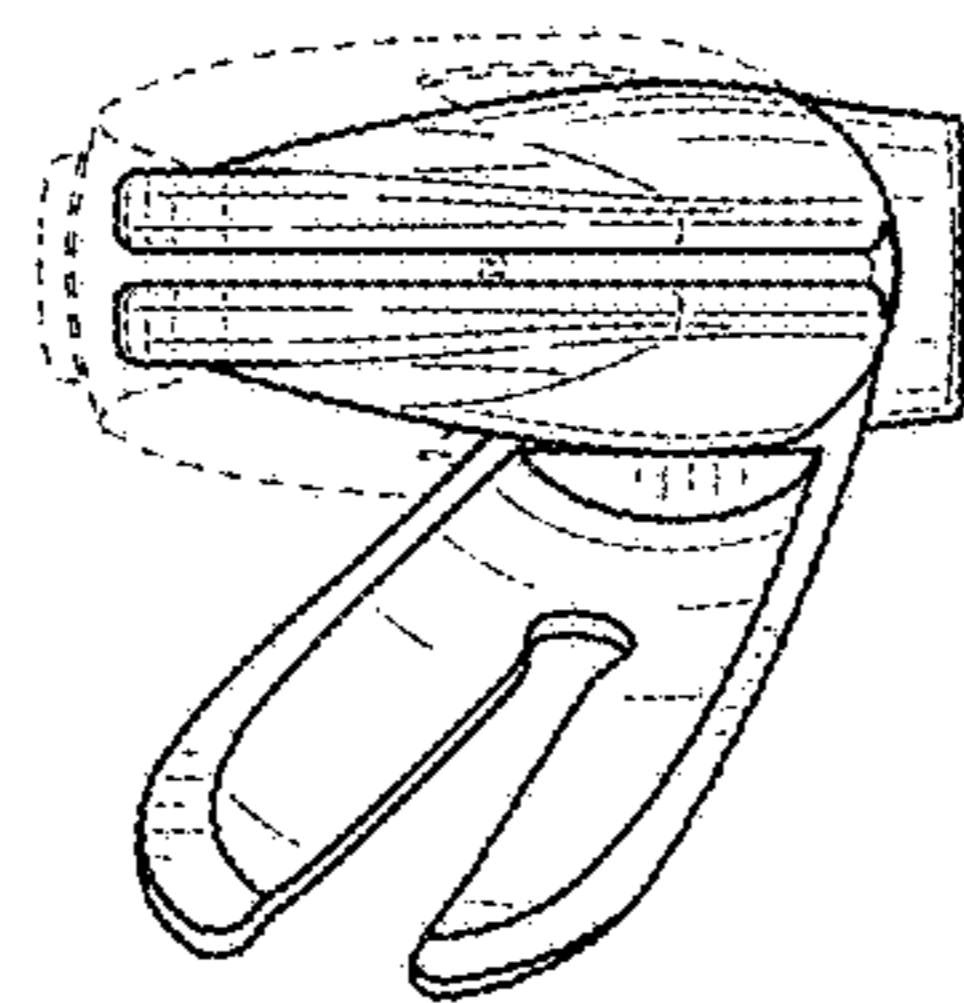

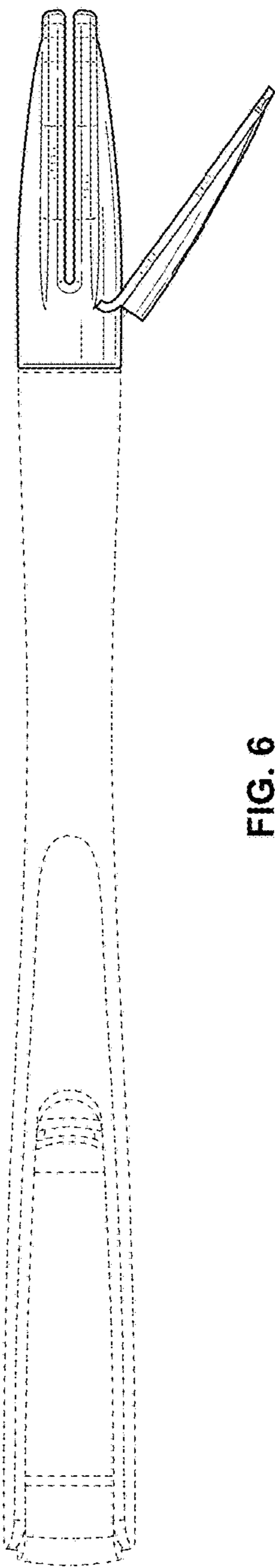

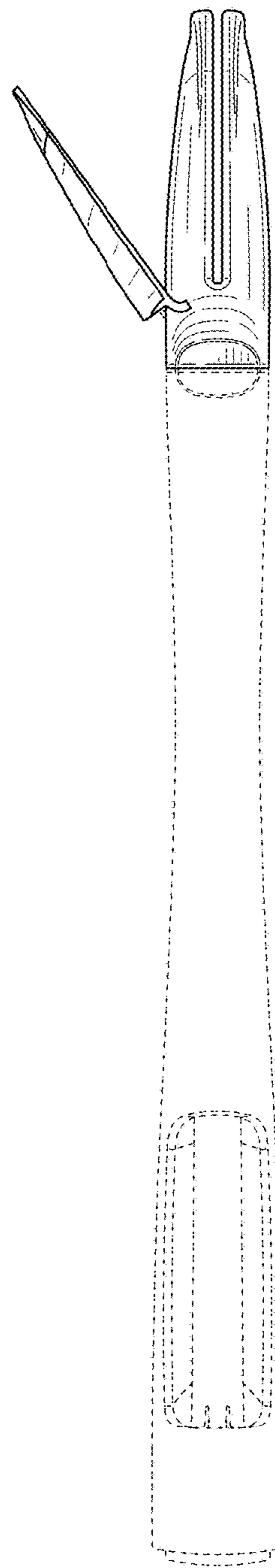
