FIG. 8 is a bottom plan view thereof.

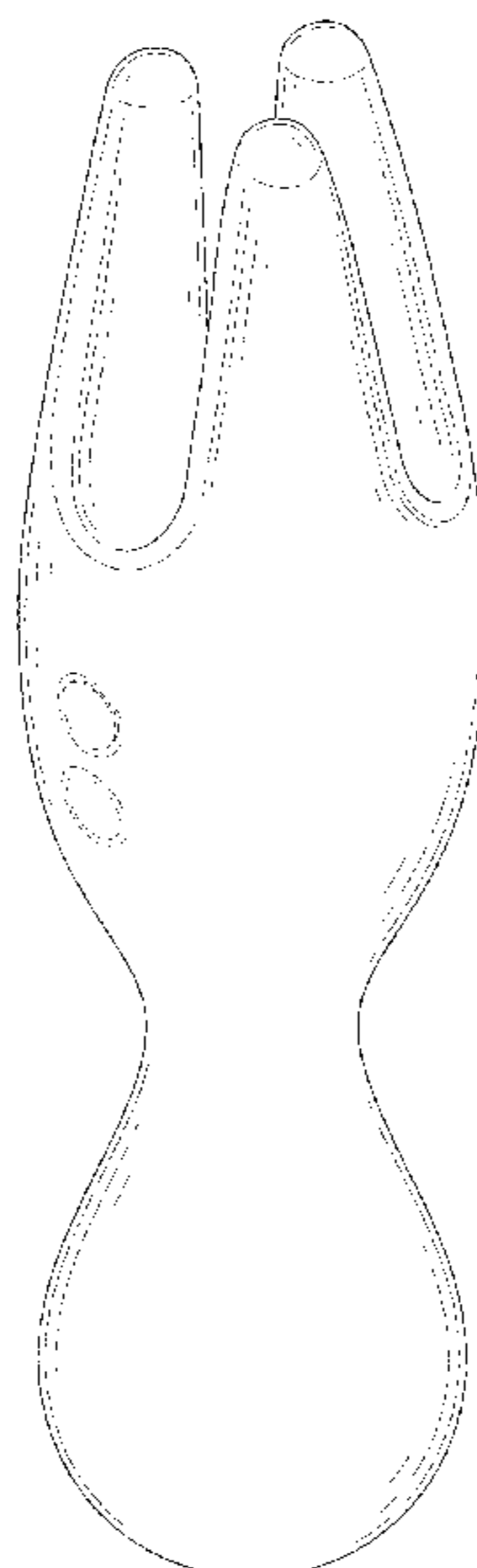
The broken lines in the drawings are for the purposes of illustrating portions of the message device, which form no part of the claimed design.

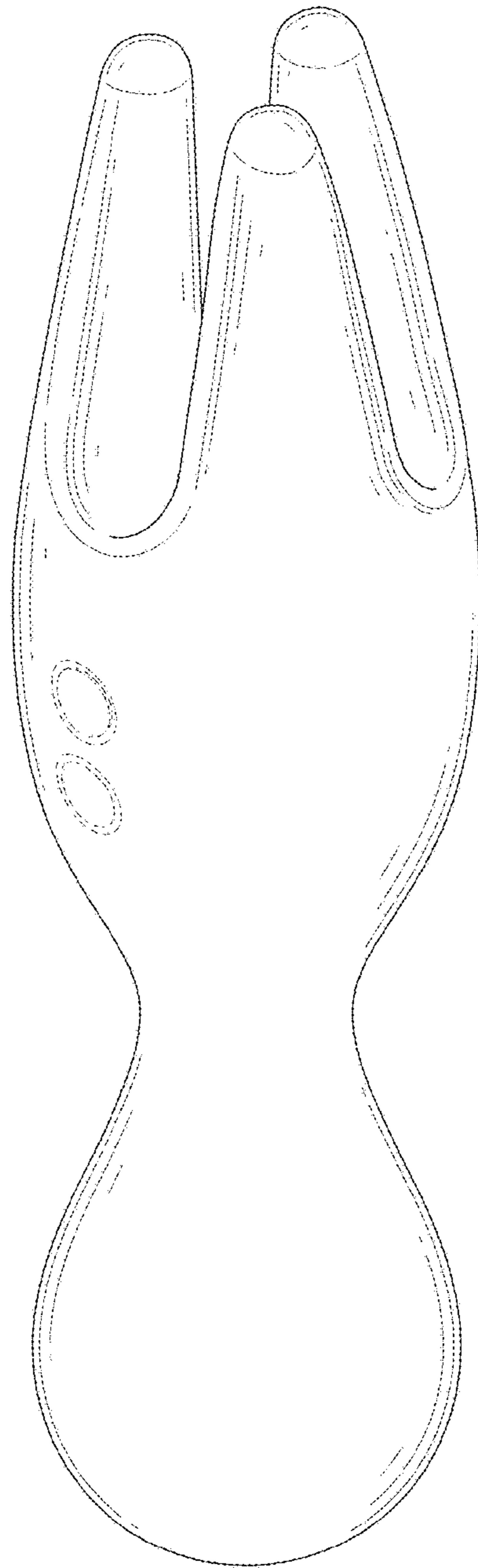

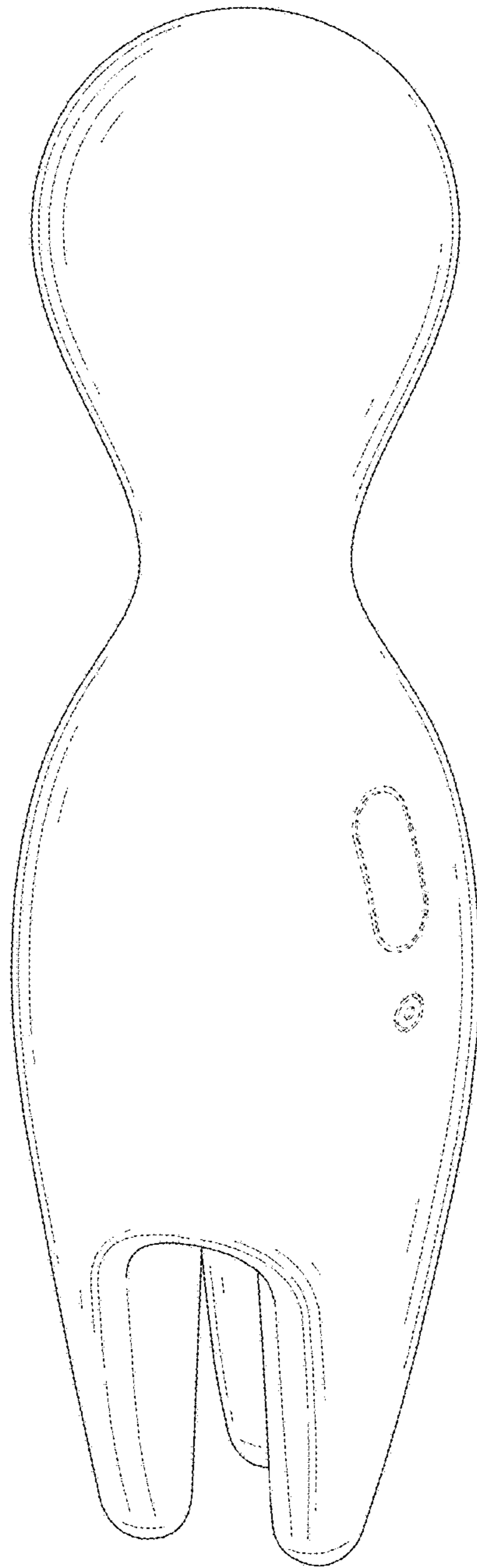

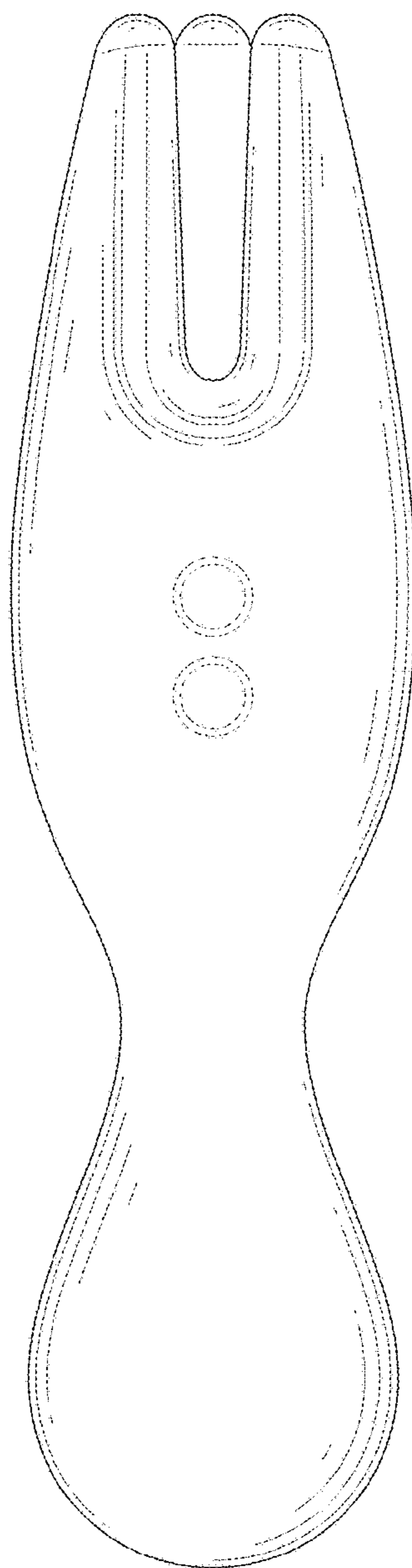

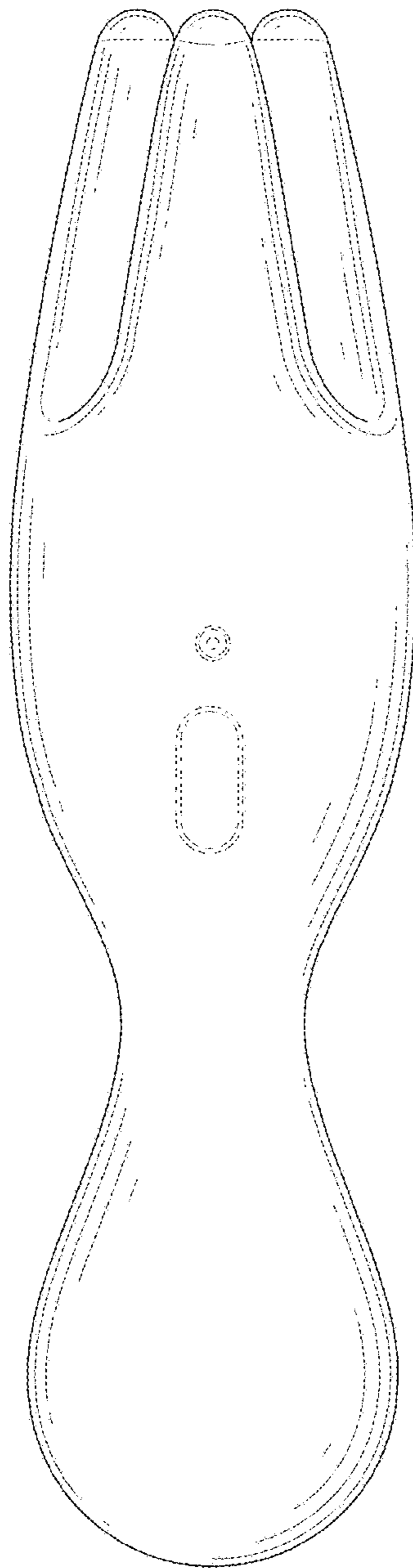

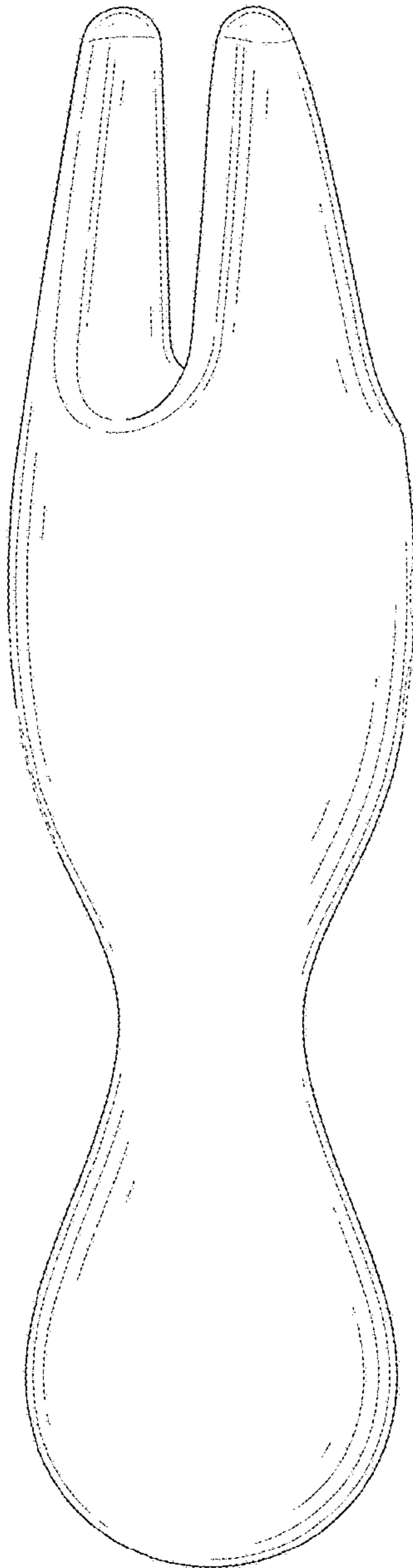

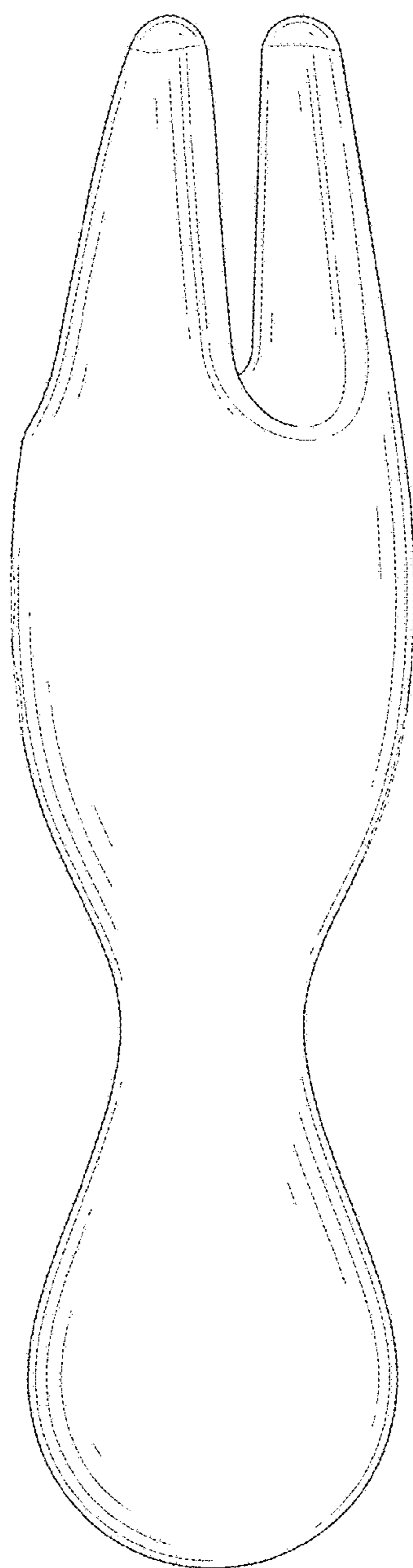

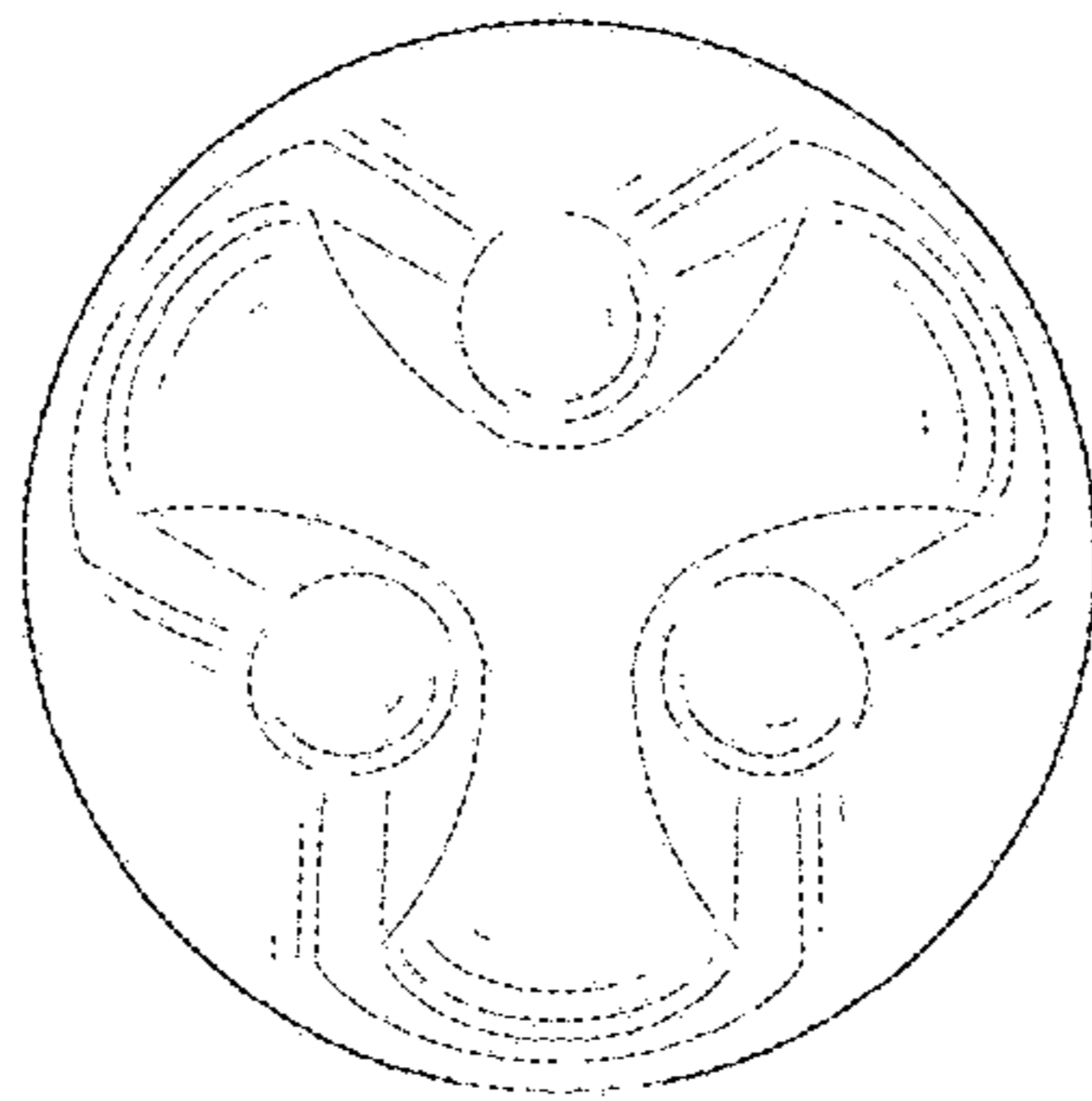

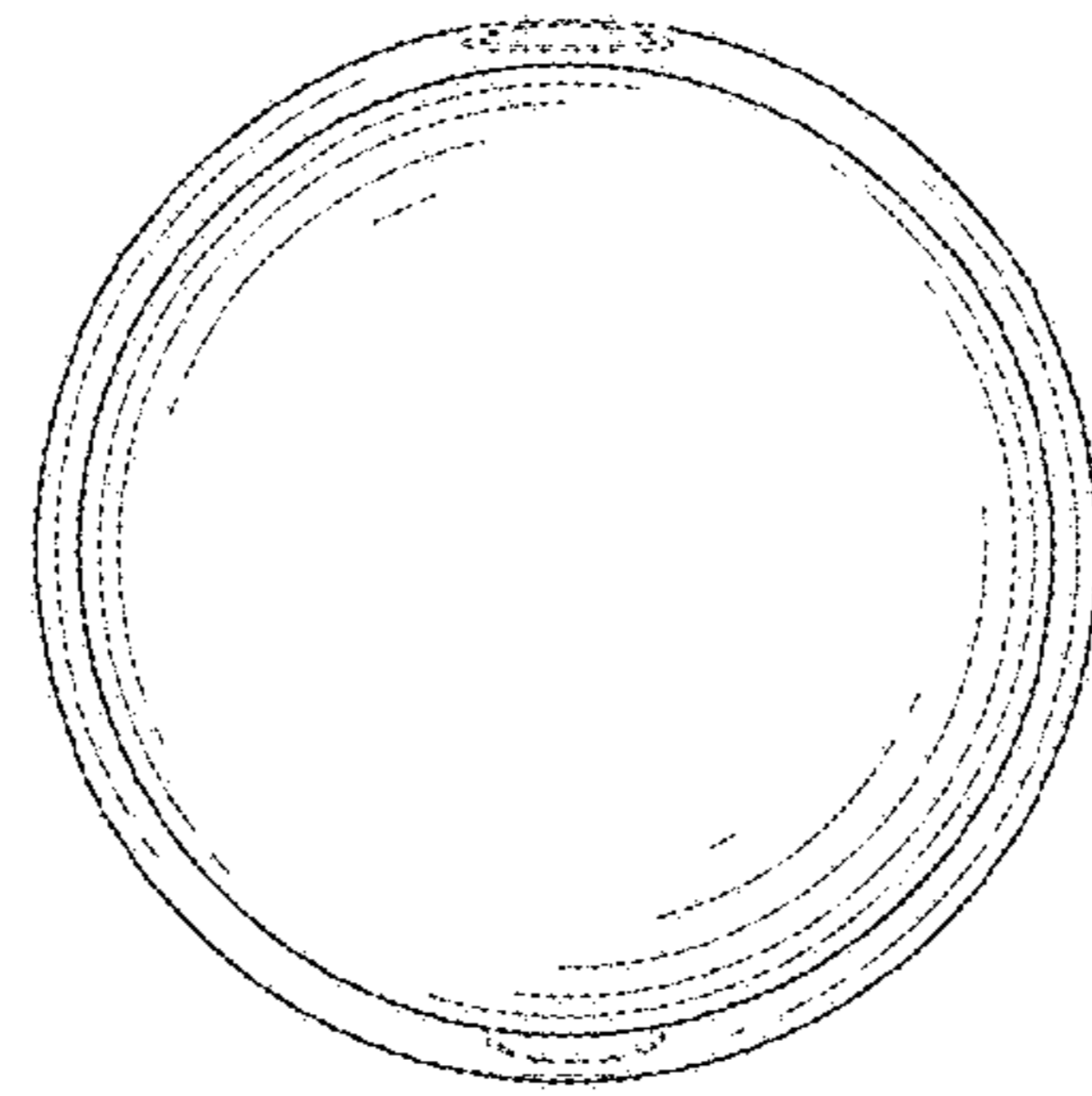
