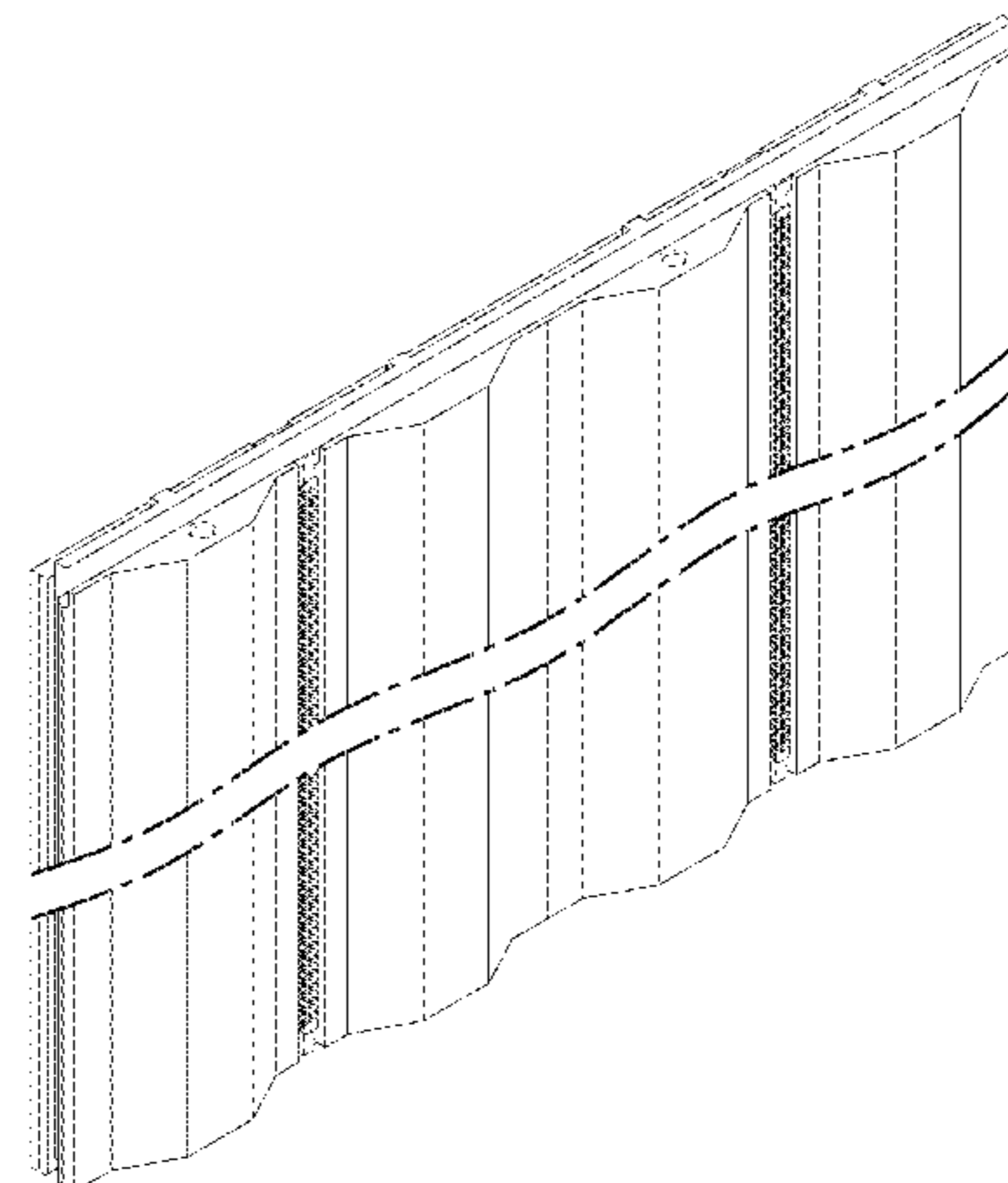
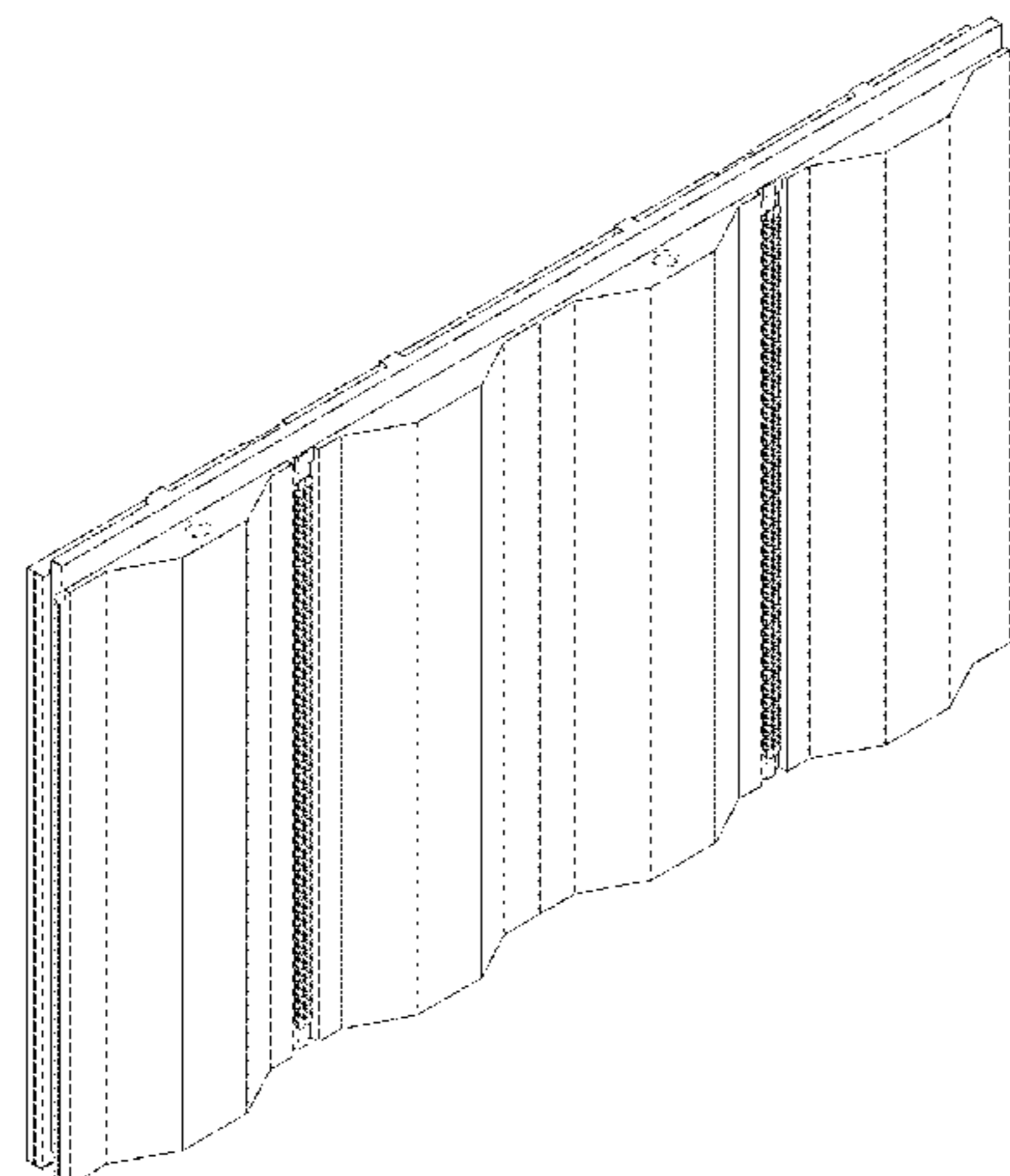
(57) **CLAIM**

The ornamental design for an insulation panel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an insulation panel showing our new design according to a first embodiment; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view being the mirror image thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a rear perspective view thereof; FIG. 9 is a front perspective view of a second embodiment of an insulation panel; FIG. 10 is a front elevational view thereof; FIG. 11 is a rear elevational view thereof; FIG. 12 is a right side elevational view thereof; FIG. 13 is a left side elevational view being the mirror image thereof; FIG. 14 is a bottom plan view thereof; FIG. 15 is a top plan view thereof; and, FIG. 16 is a rear perspective view thereof. The evenly dashed lines depict portions of the insulation panel that form no part of the claimed design. The insulation panel is shown with a symbolic break in its length in the second embodiment. The appearance of any portion of the article between the break lines forms no part of the claimed design.

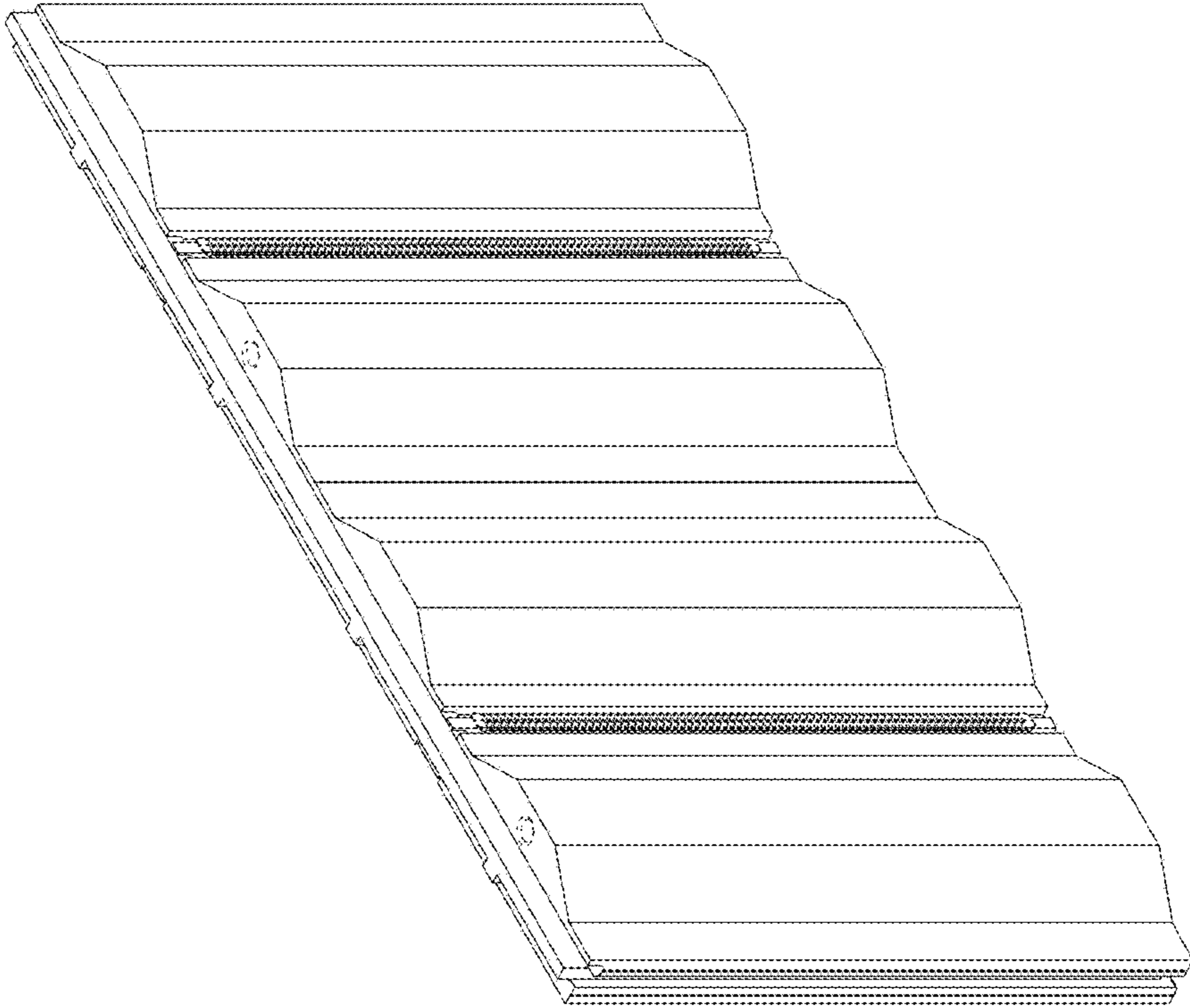

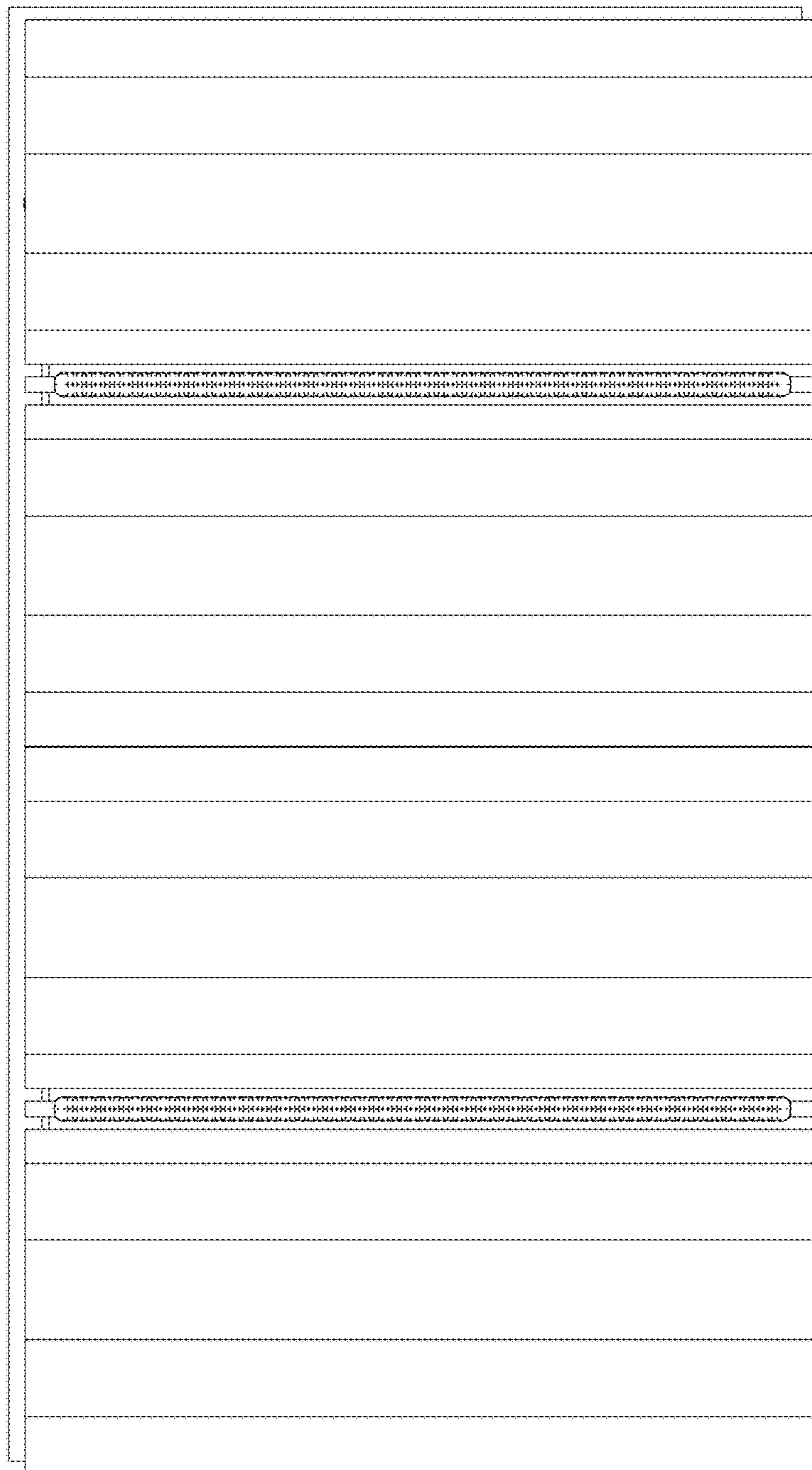

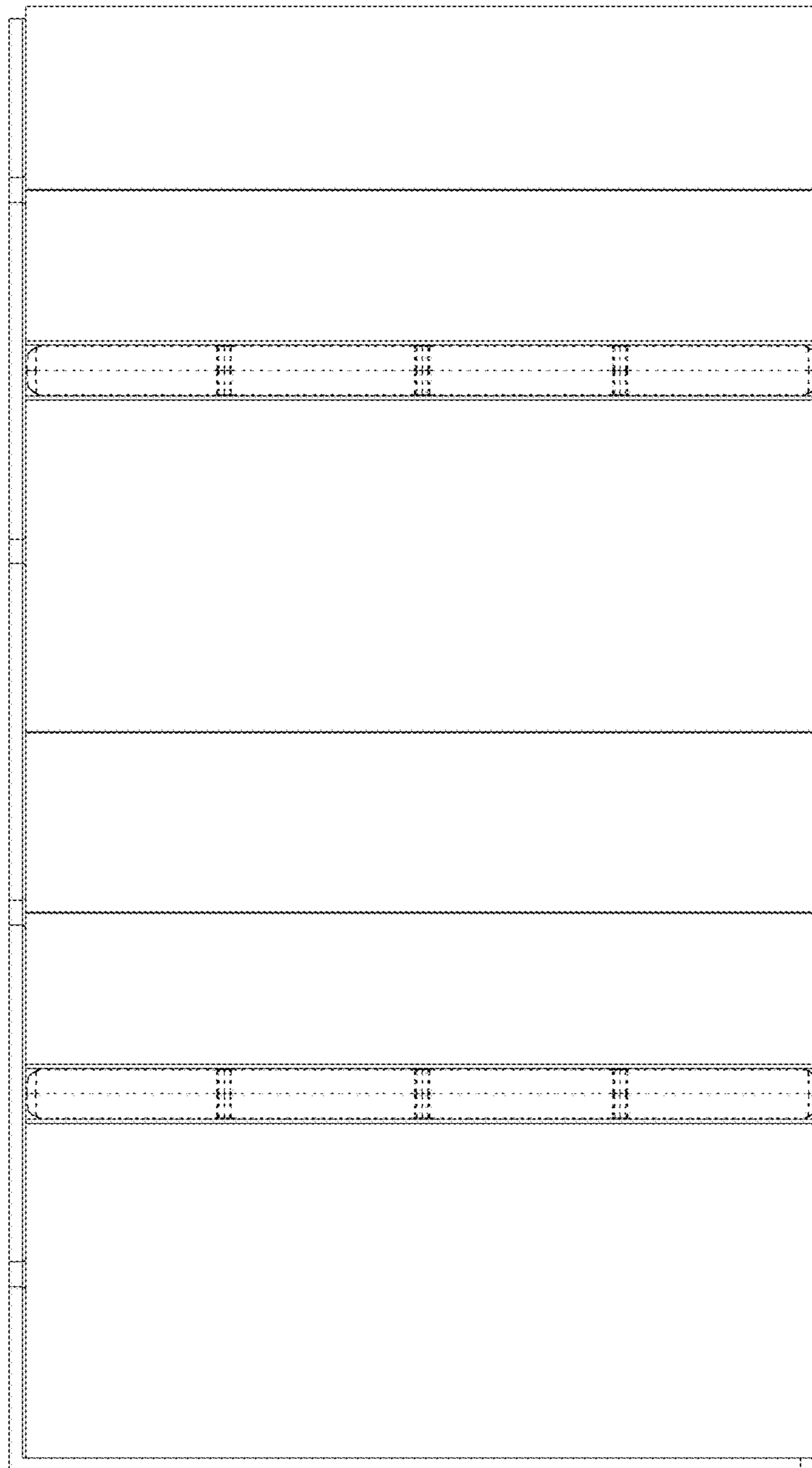

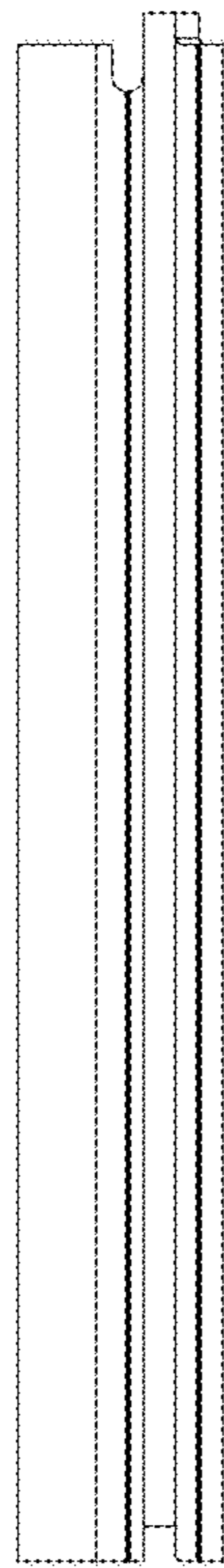

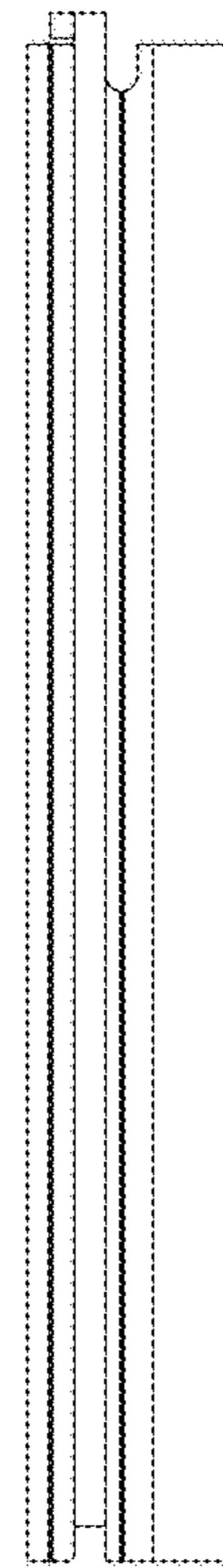

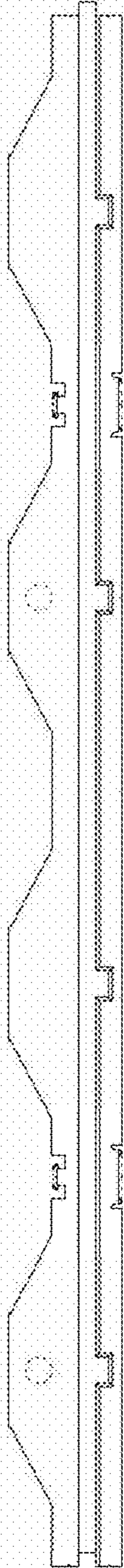
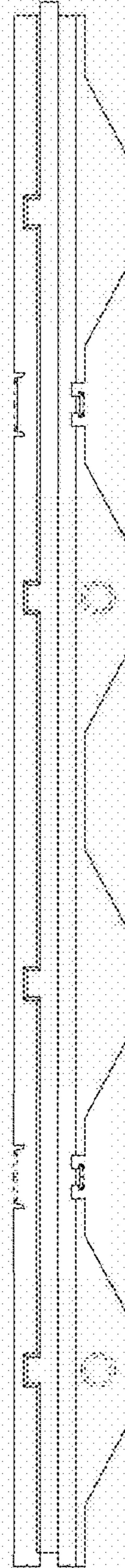

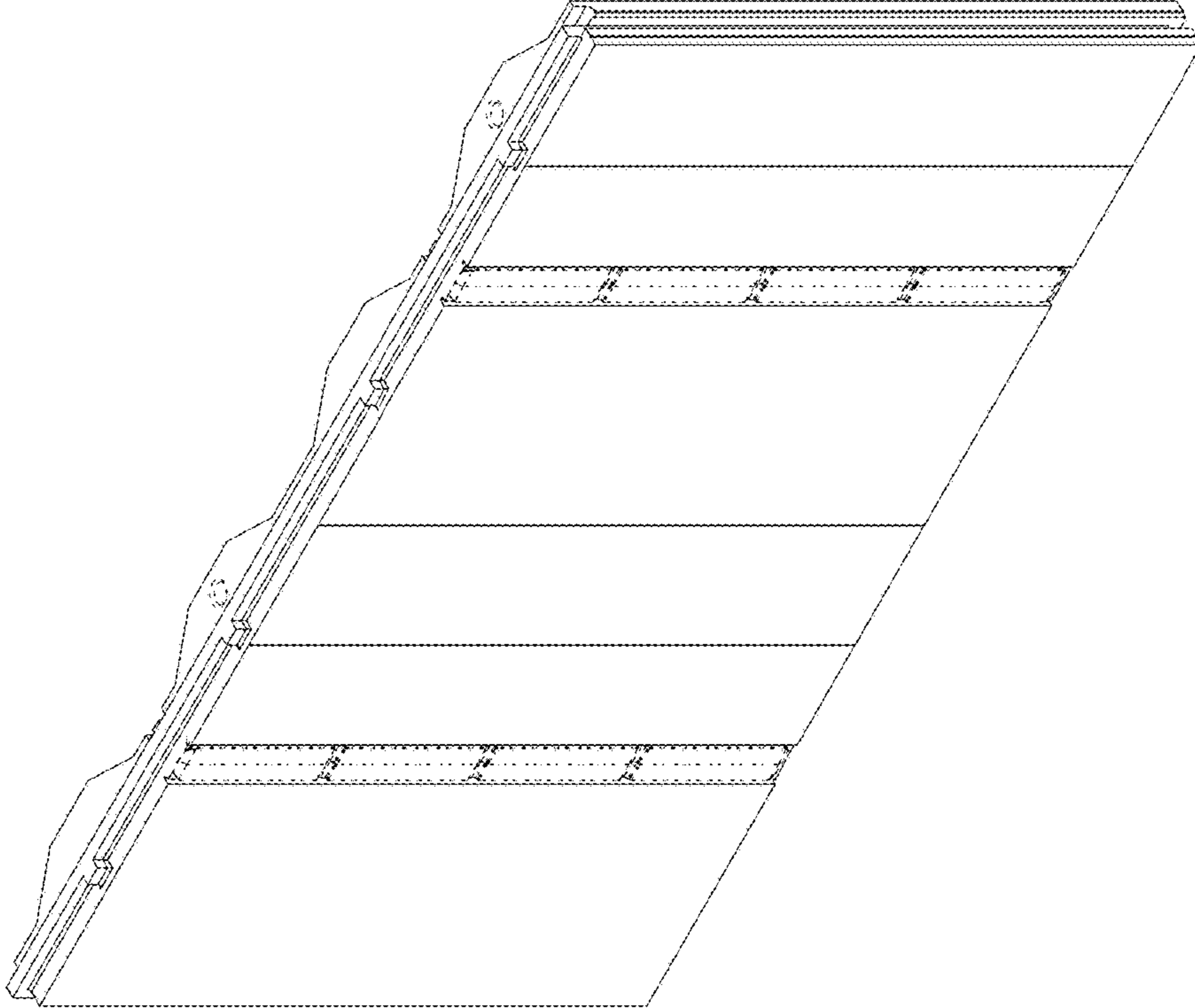

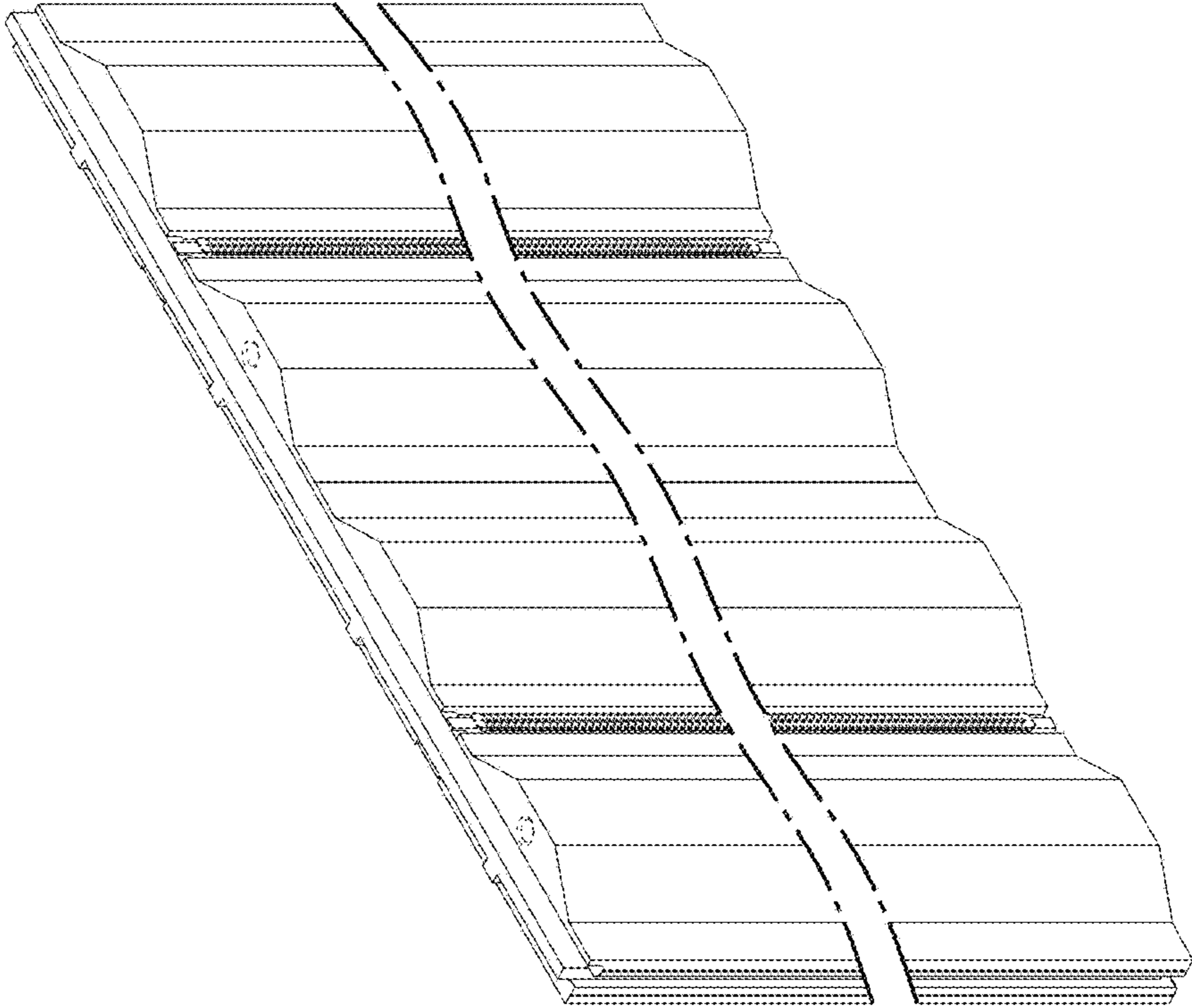

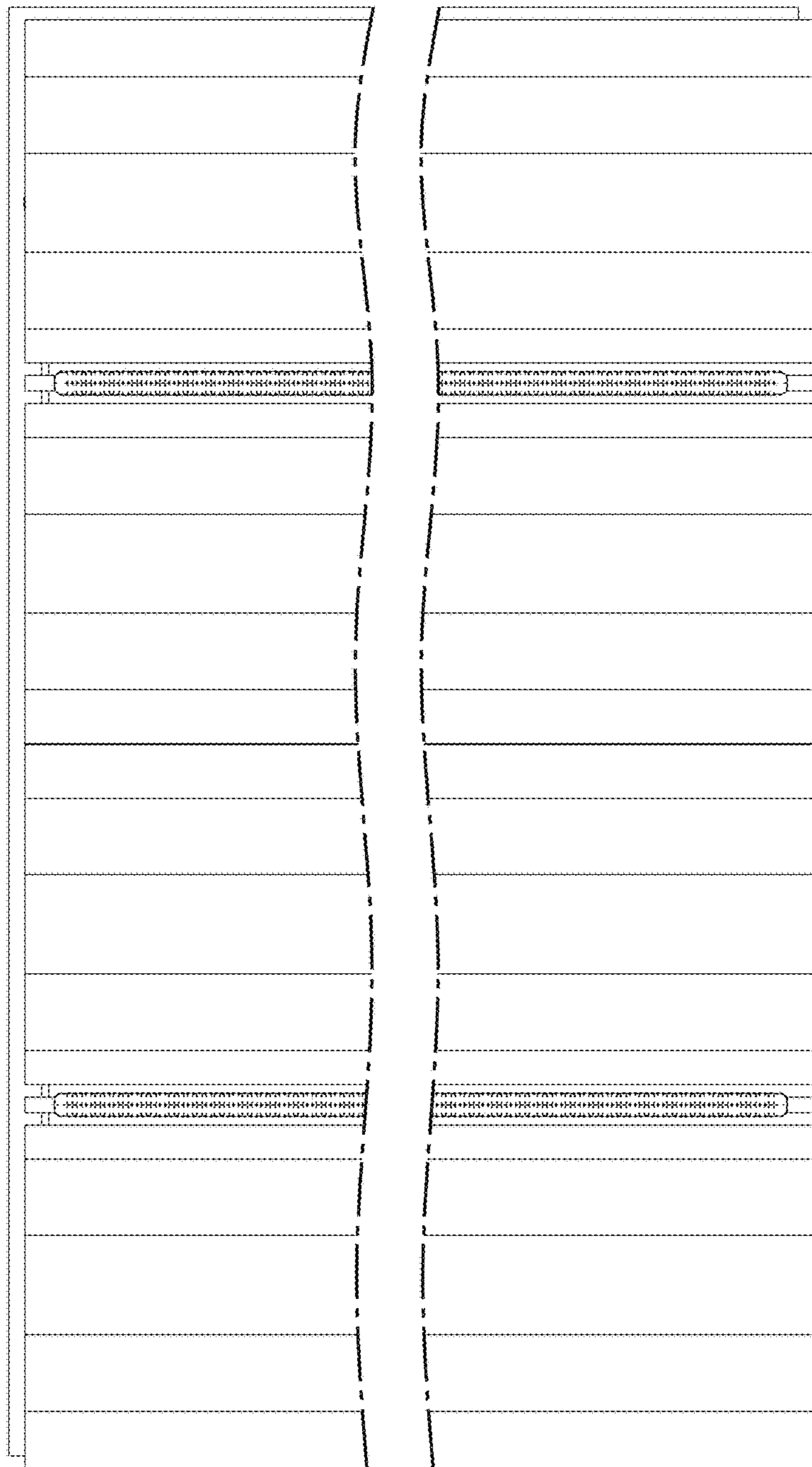

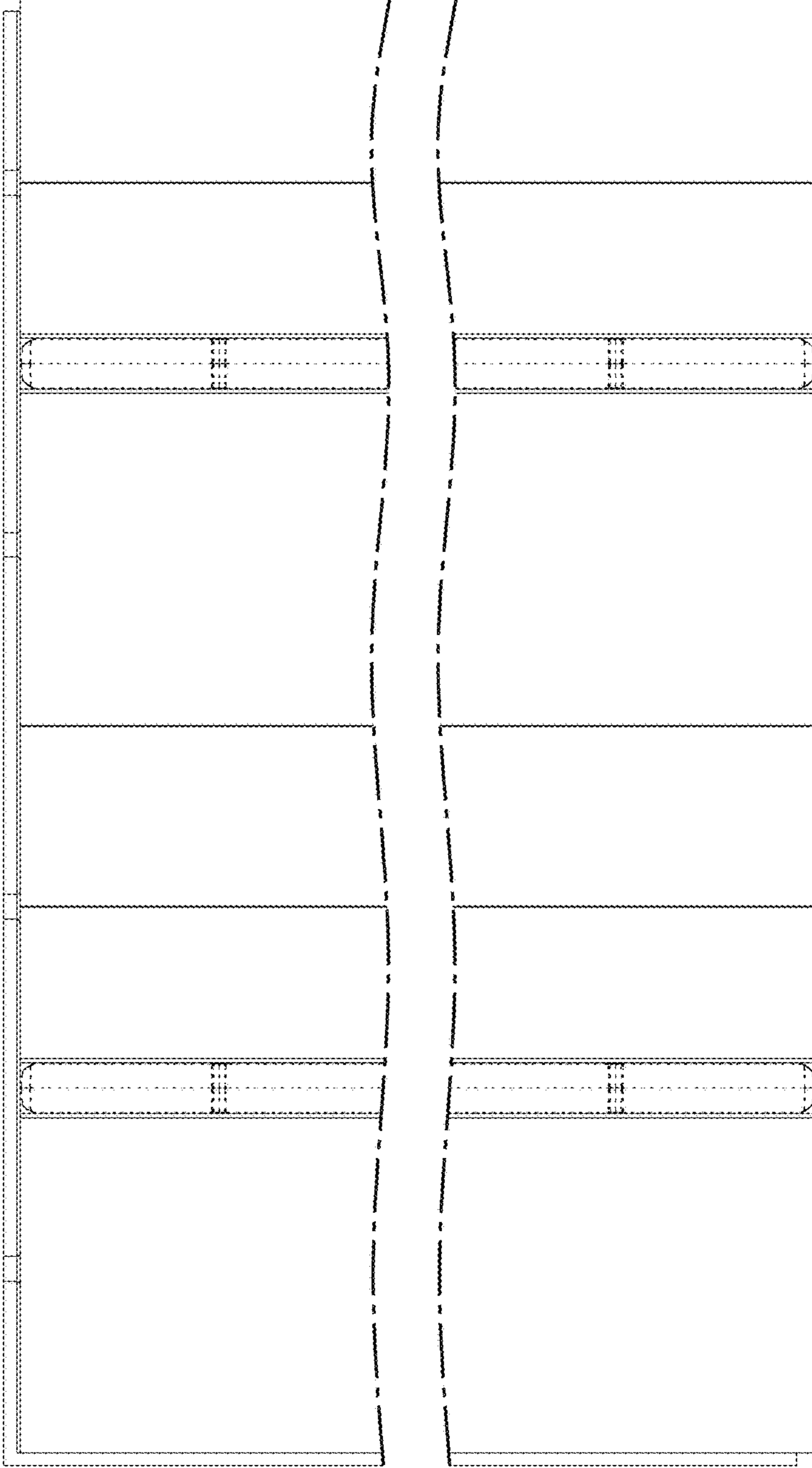

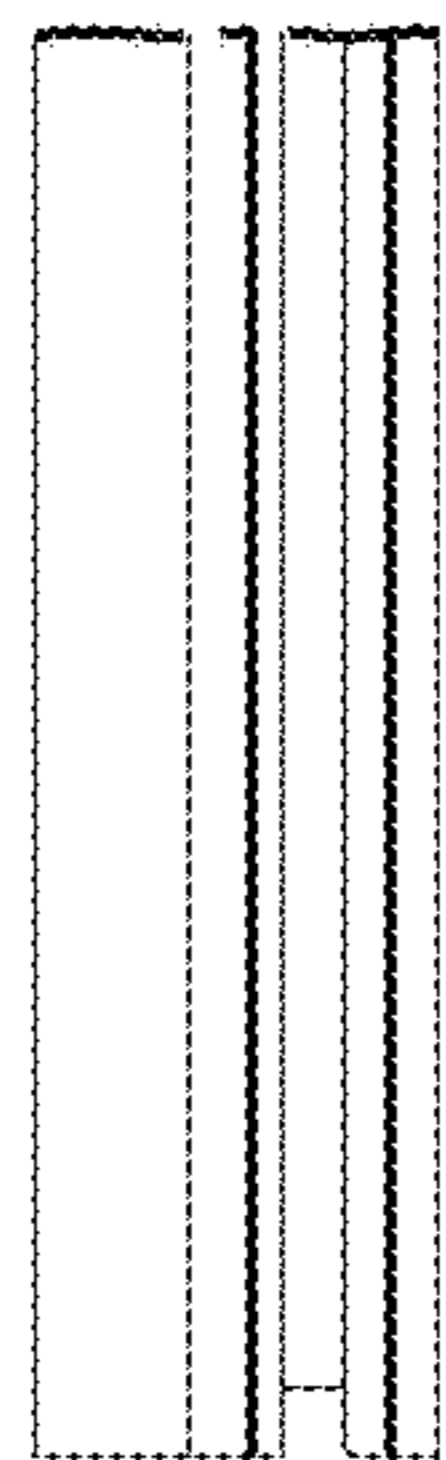
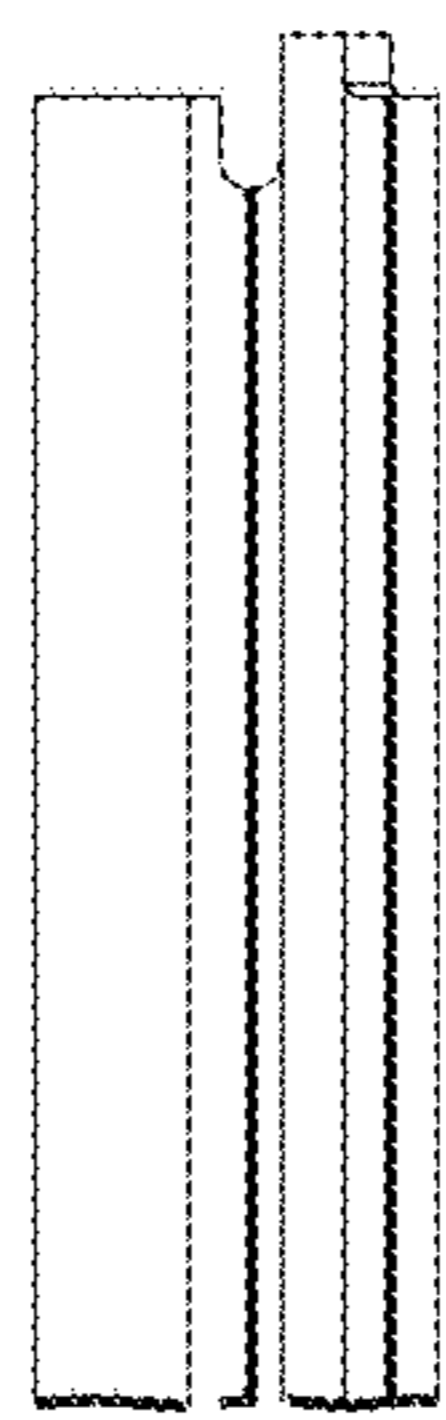

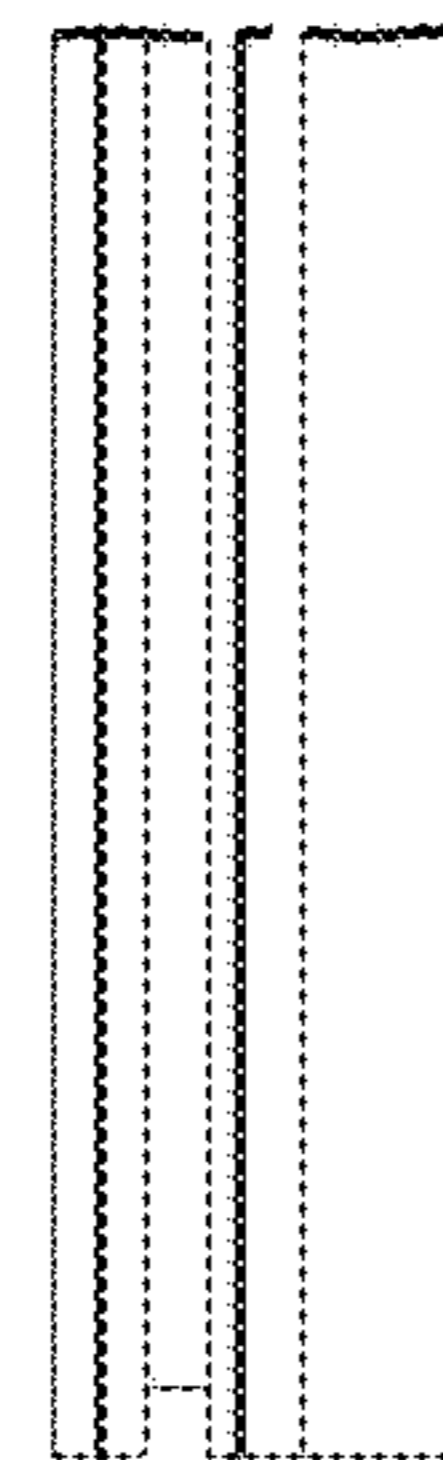
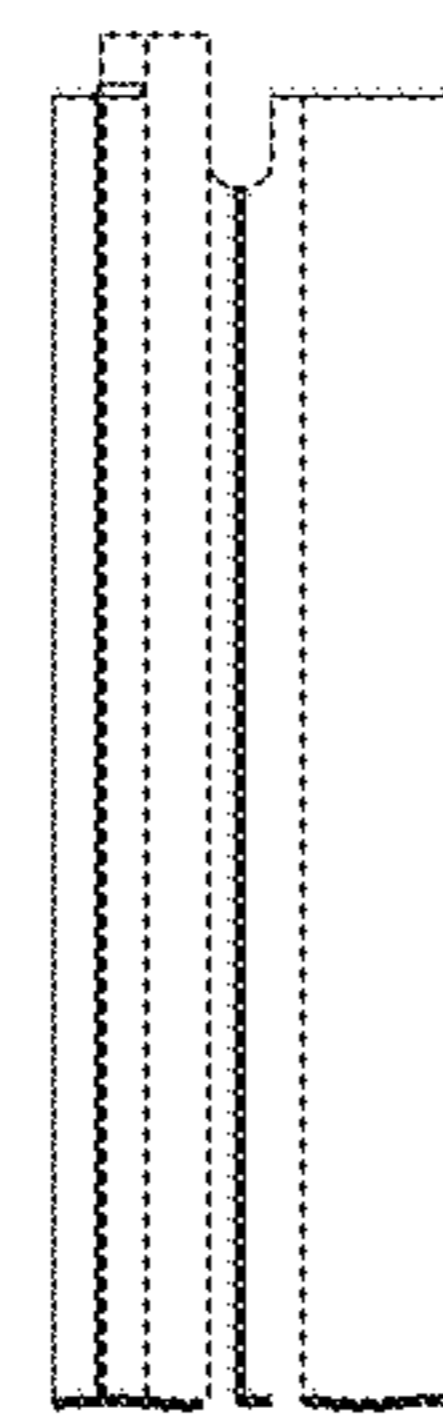

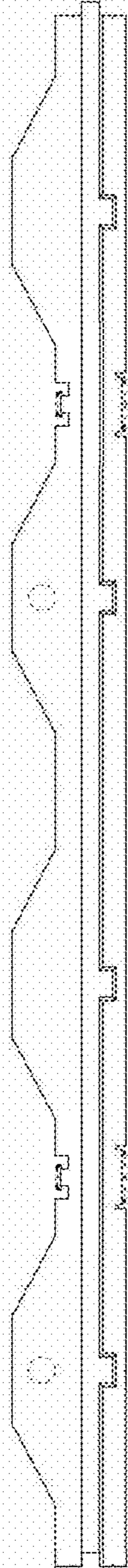
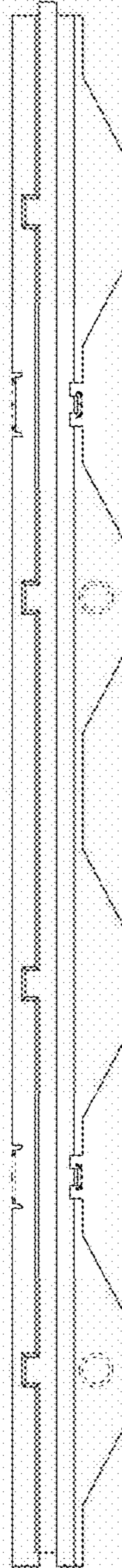

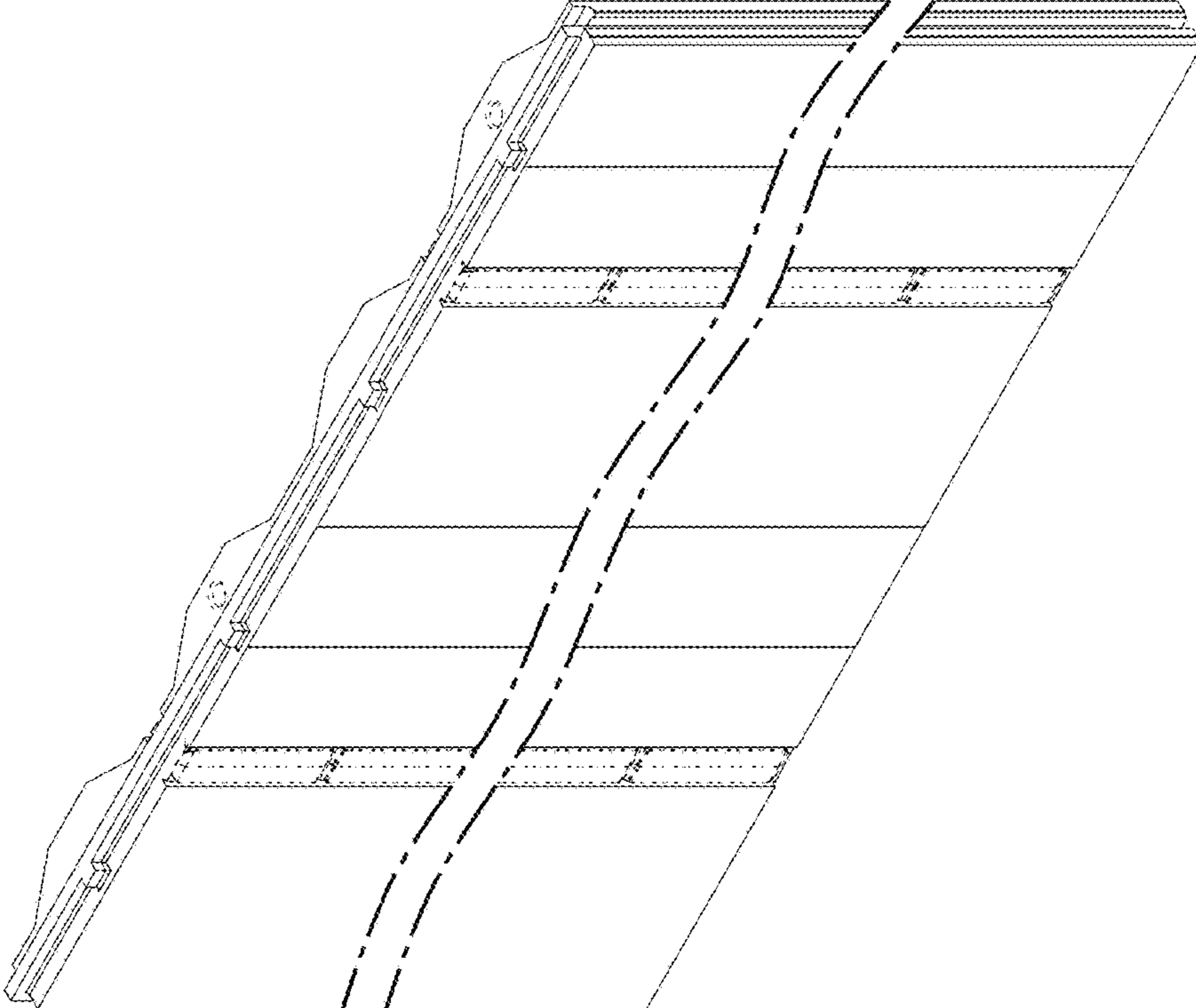
