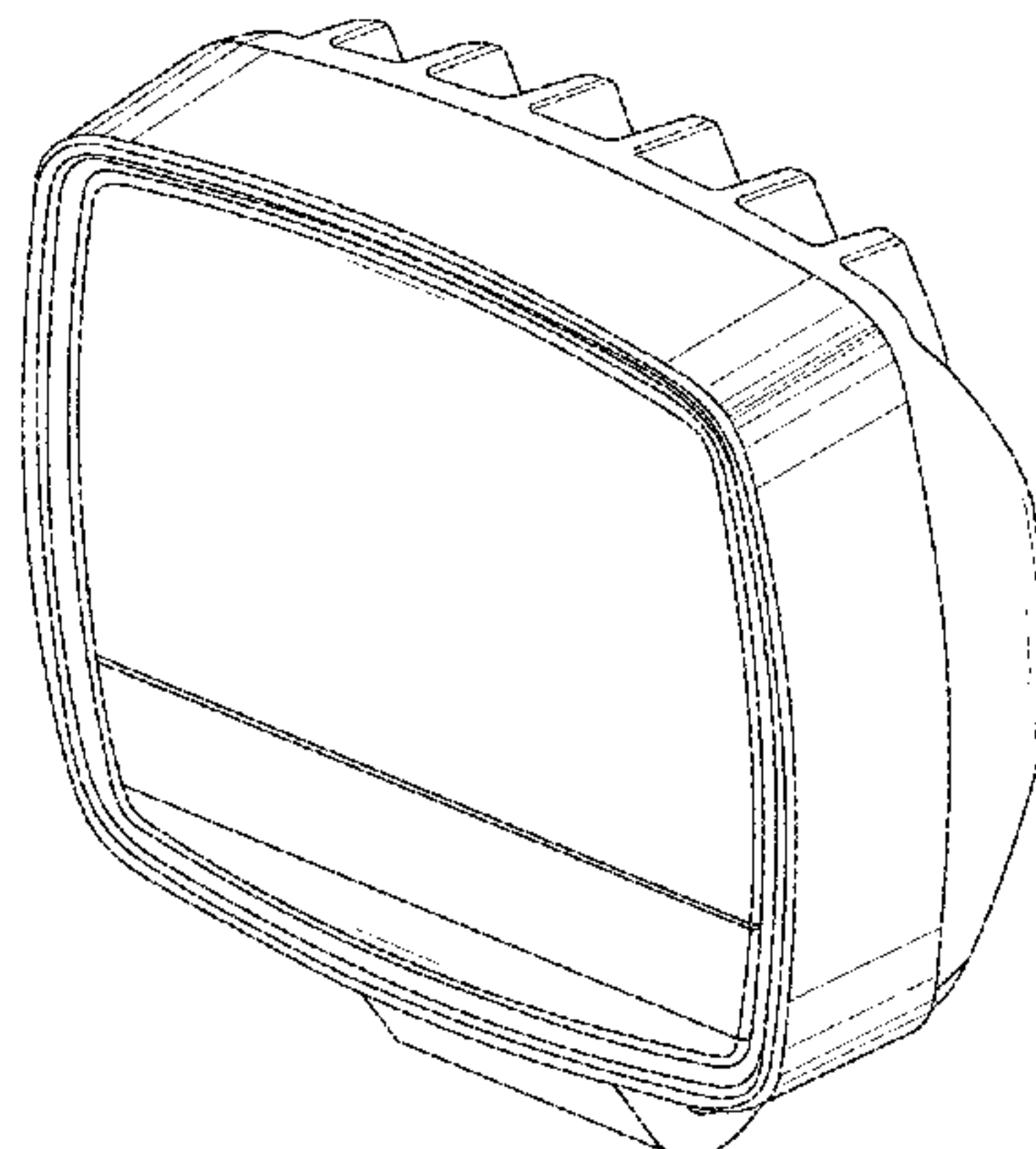
CLAIM

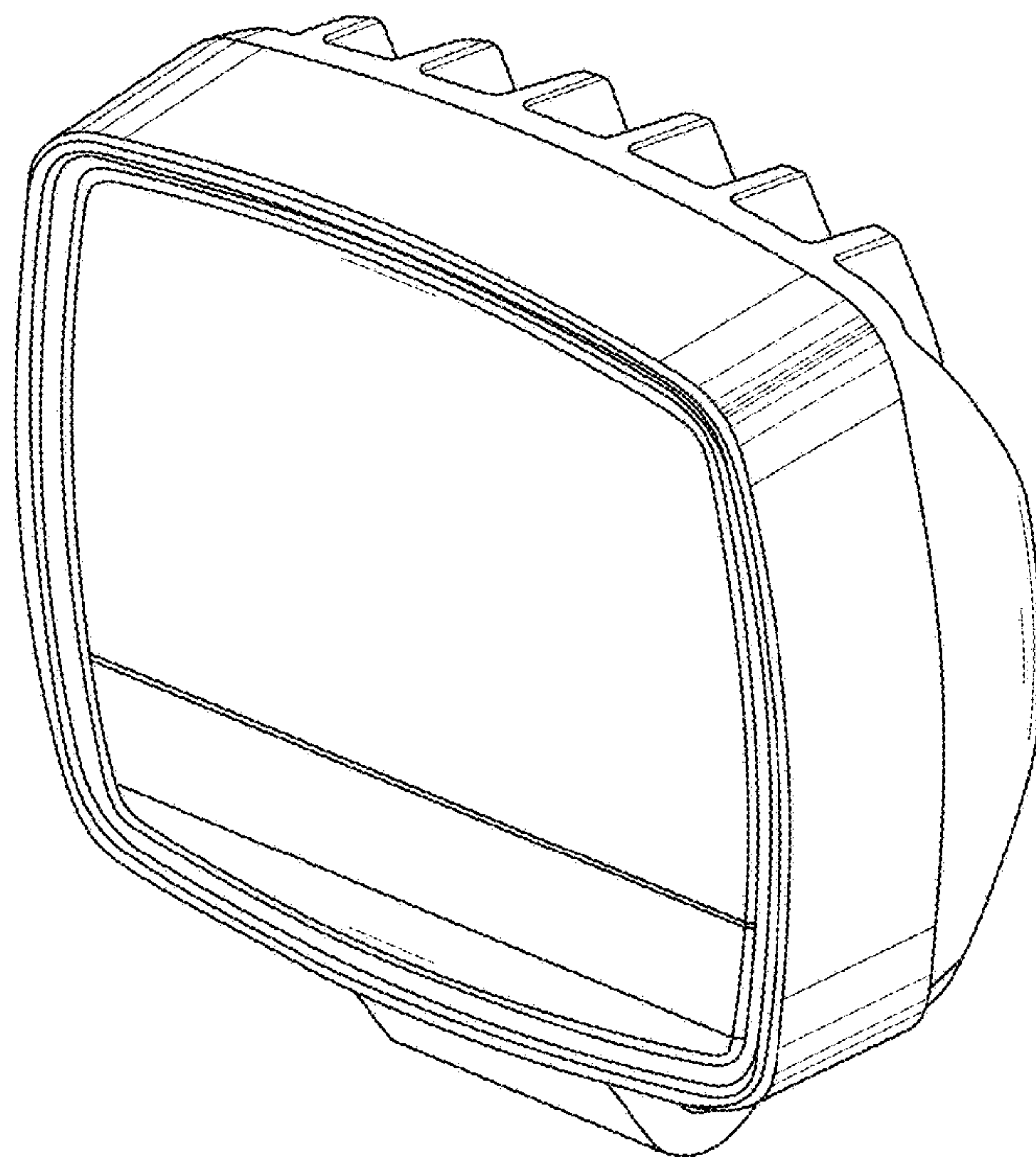

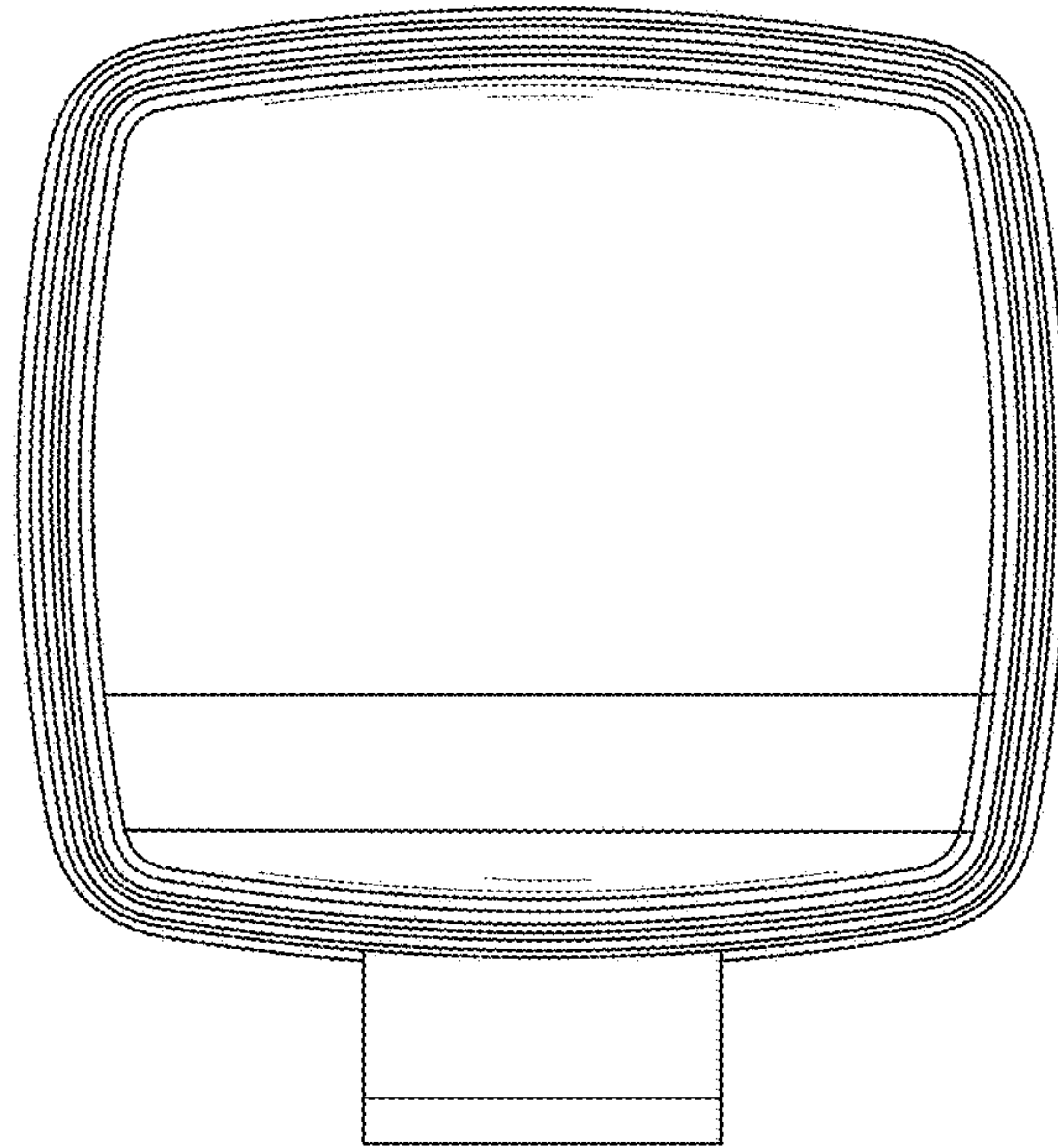

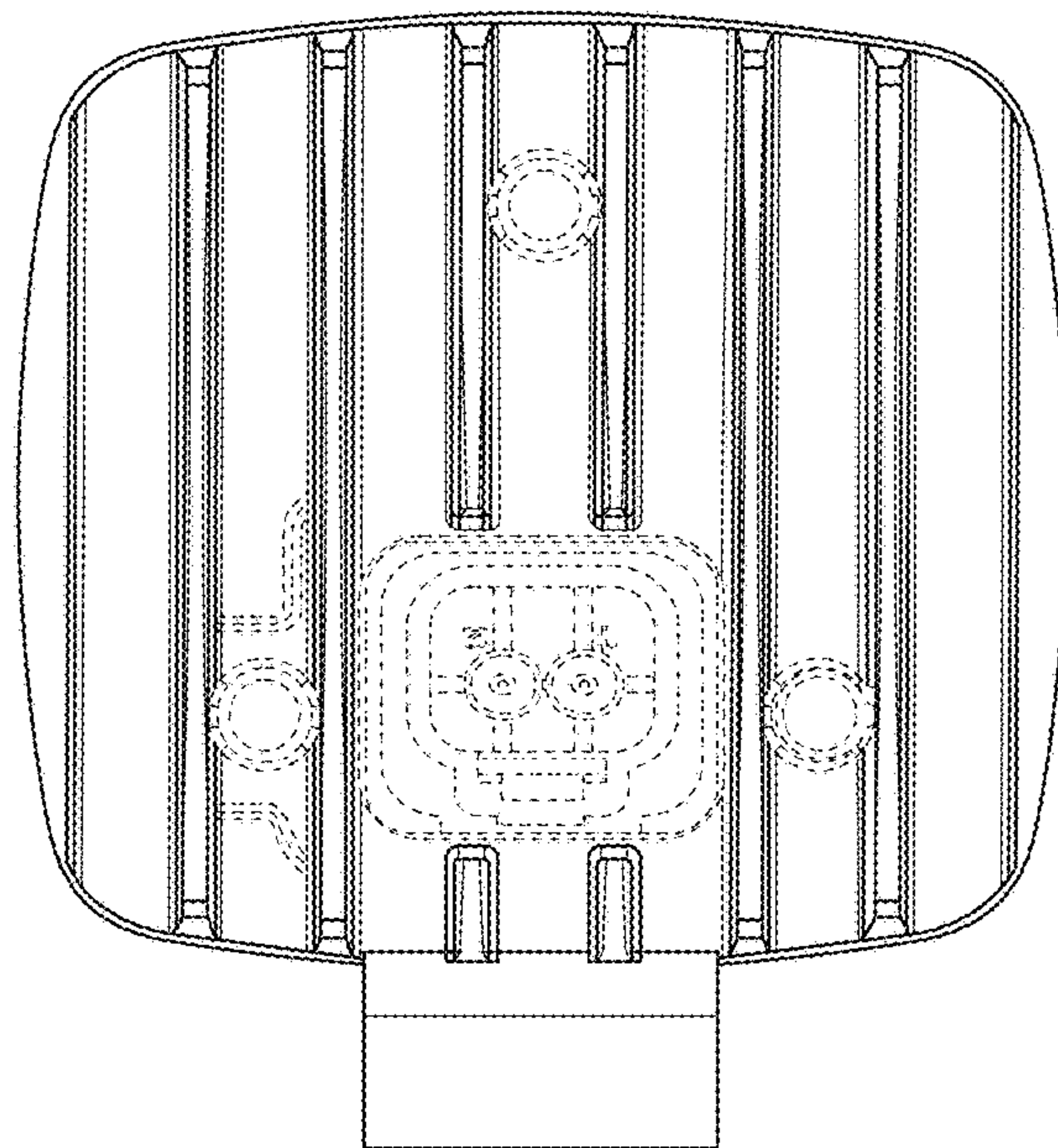

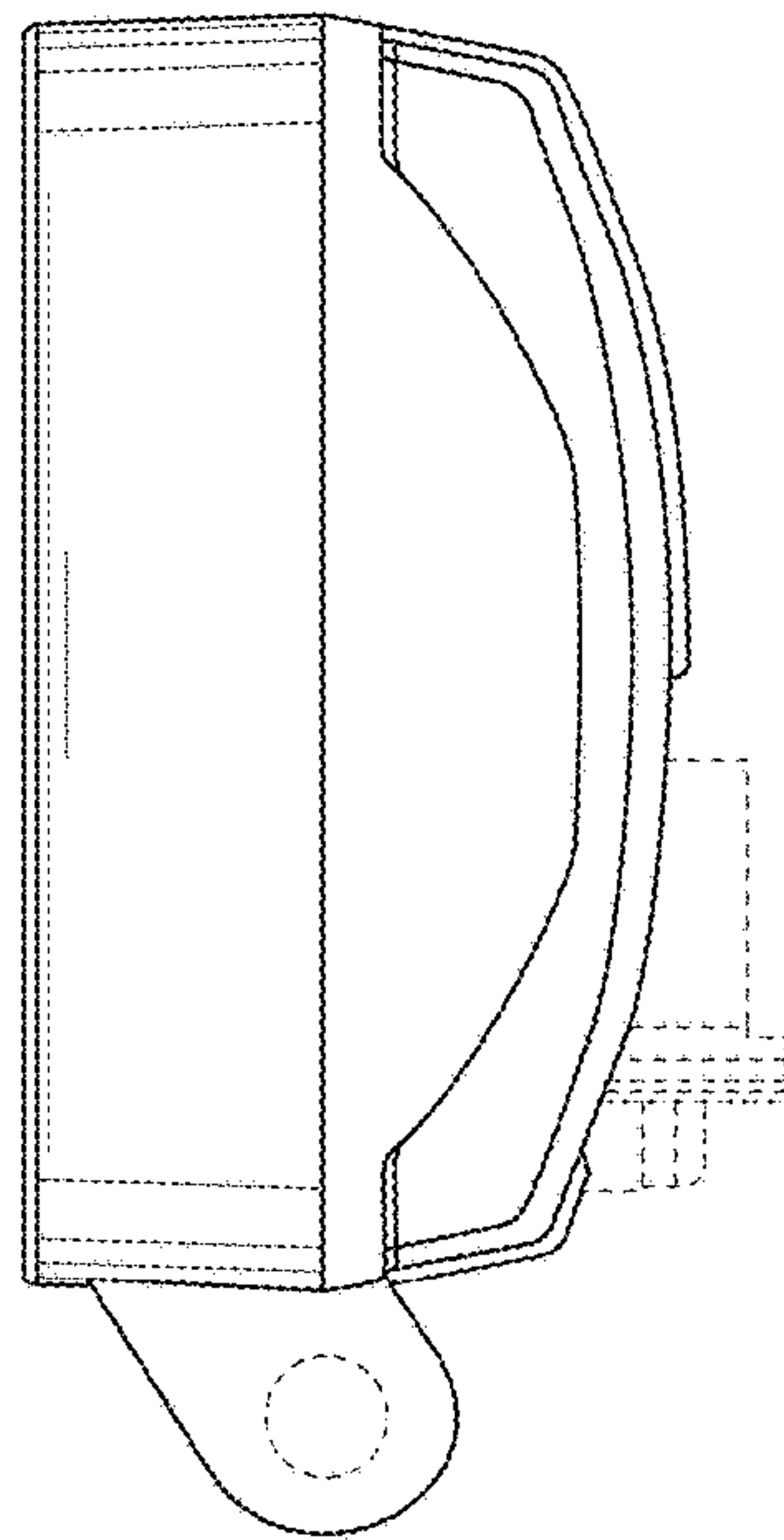

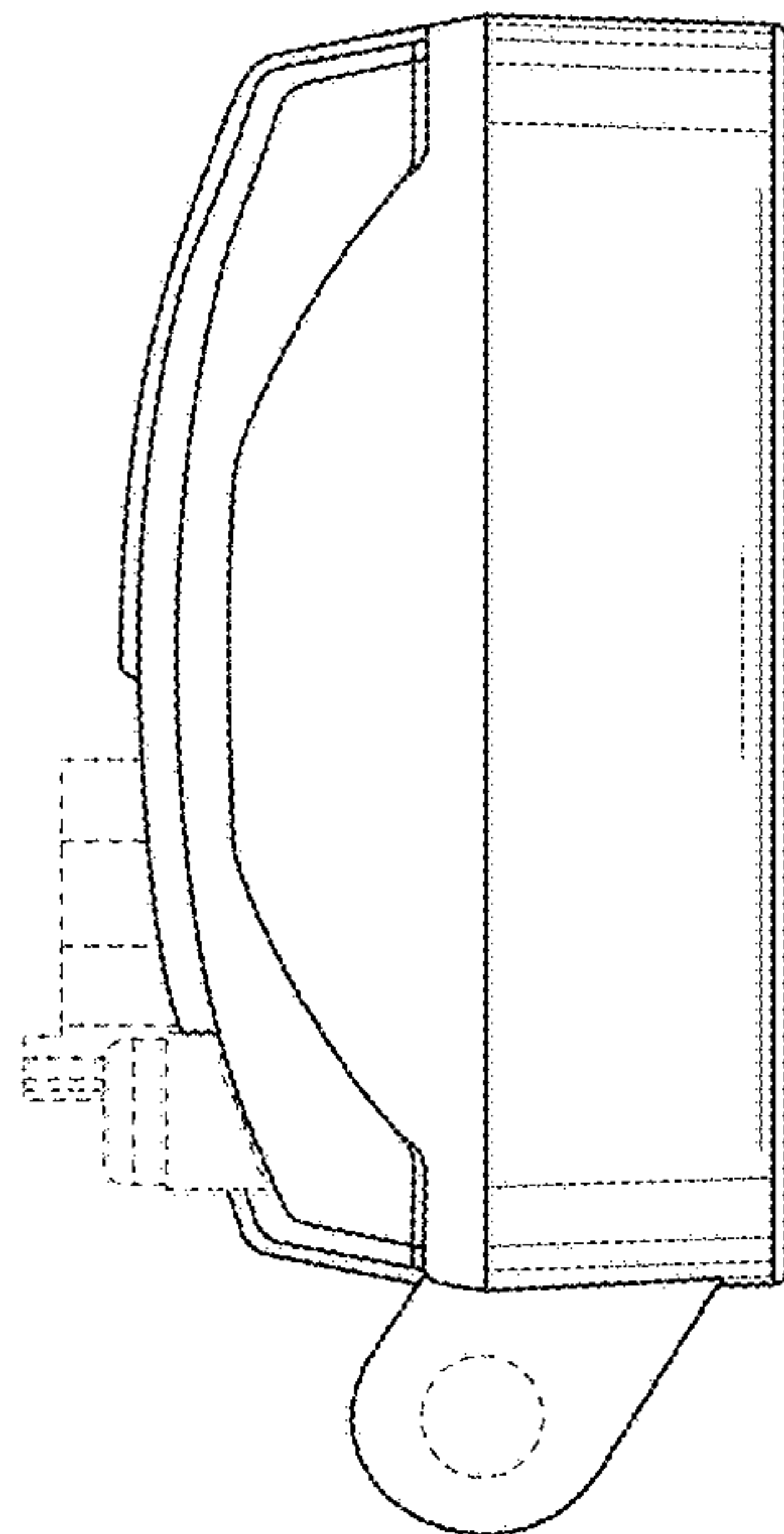

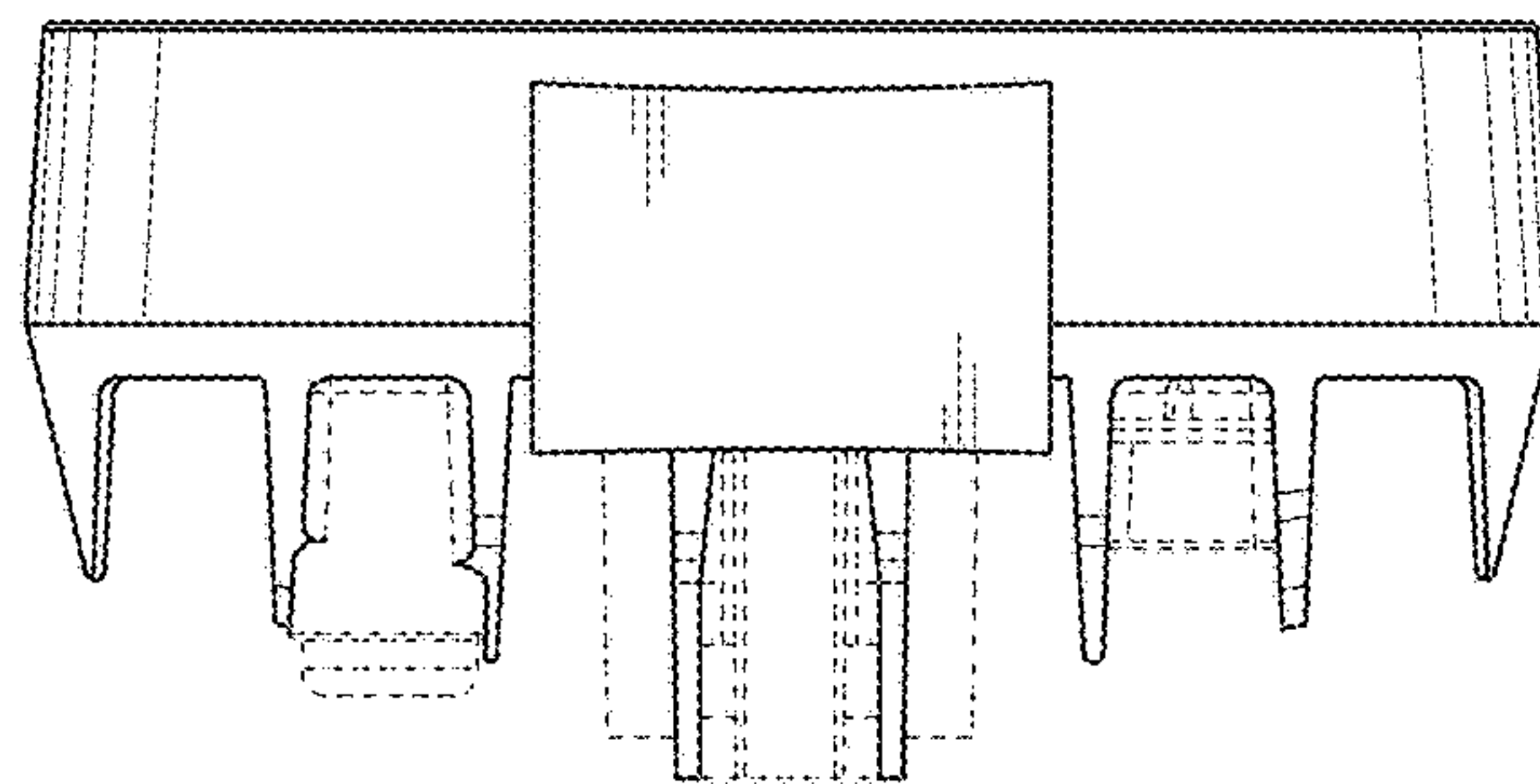

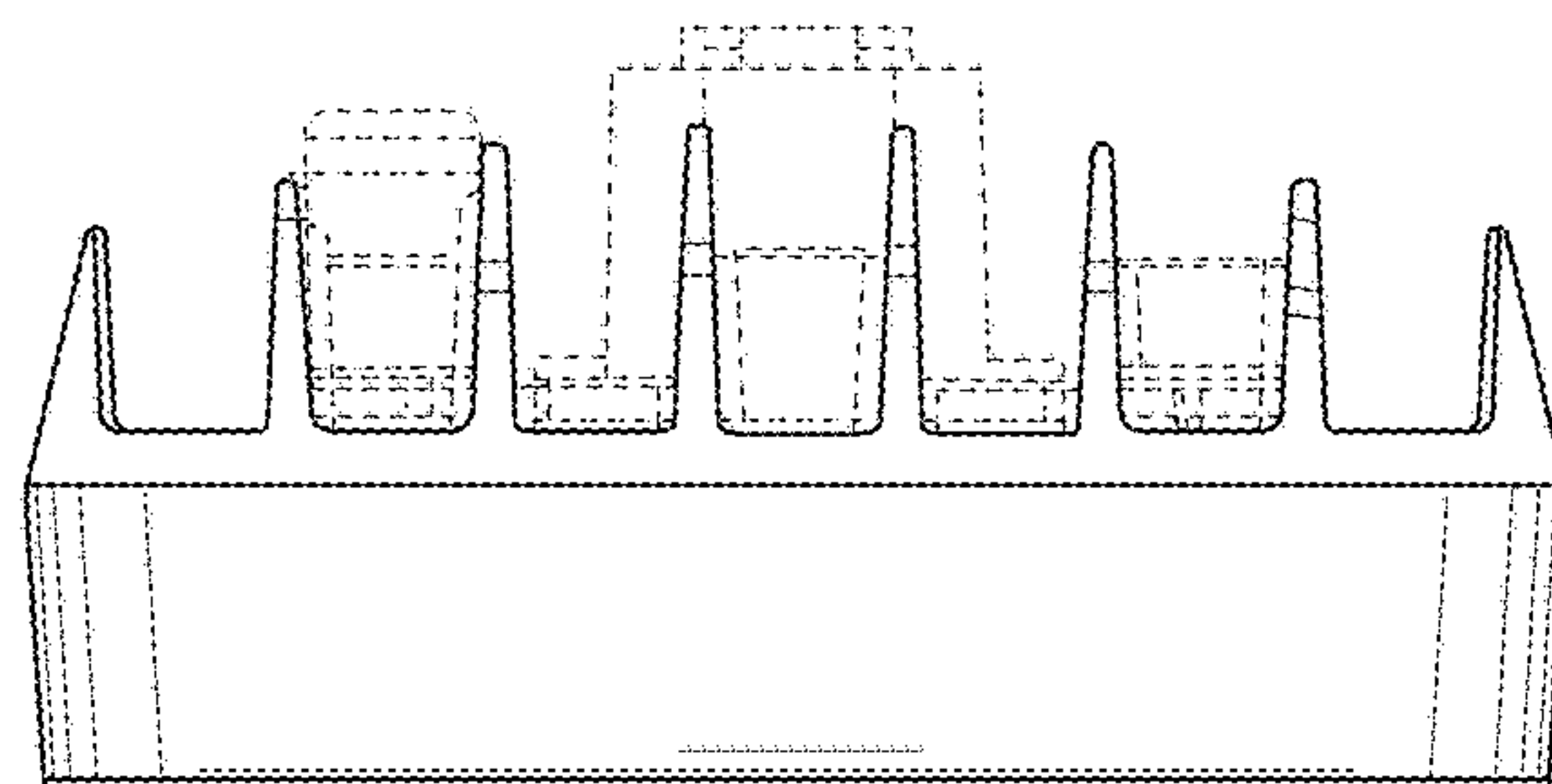
