(57) CLAIM

The ornamental design for a suspension lamp, as shown and described.

DESCRIPTION

1.1 is a perspective view of a suspension lamp, showing our new design;

1.2 is a side view thereof;

1.3 is a side view thereof, from a side opposite that of 1.2;

1.4 is a side view thereof, from a different side than 1.2 and 1.3;

1.5 is a side view thereof, from a side opposite that of 1.4;

1.6 is a top view thereof; and

1.7 is a bottom view thereof.

The broken lines are shown for the purpose of illustrating portions of the suspension lamp that forms no part of the claimed design.

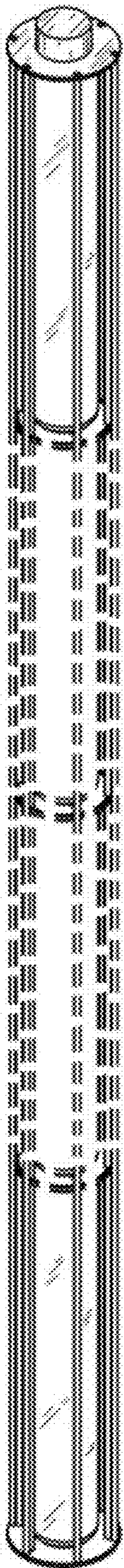

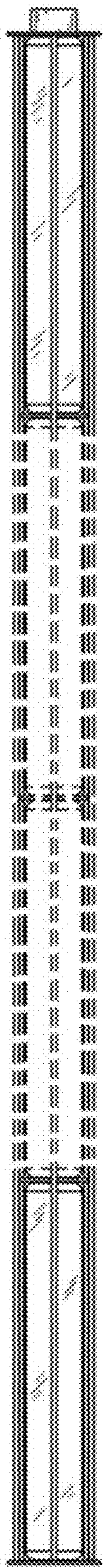

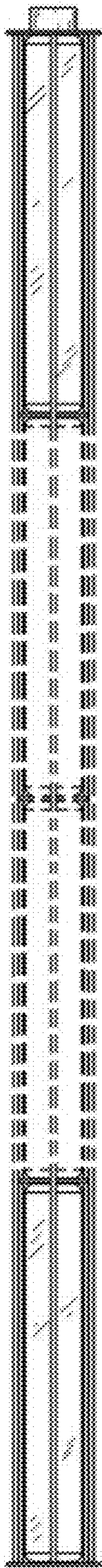

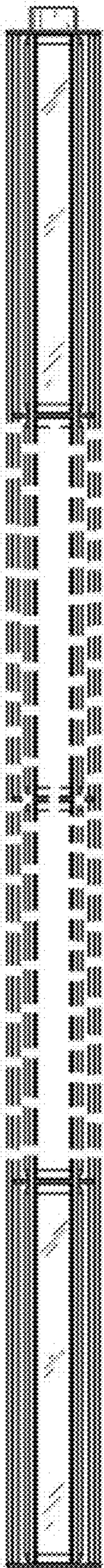

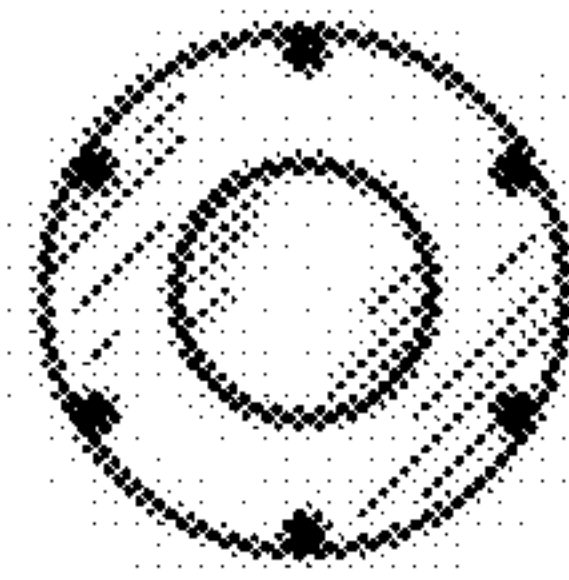
