**DESCRIPTION**

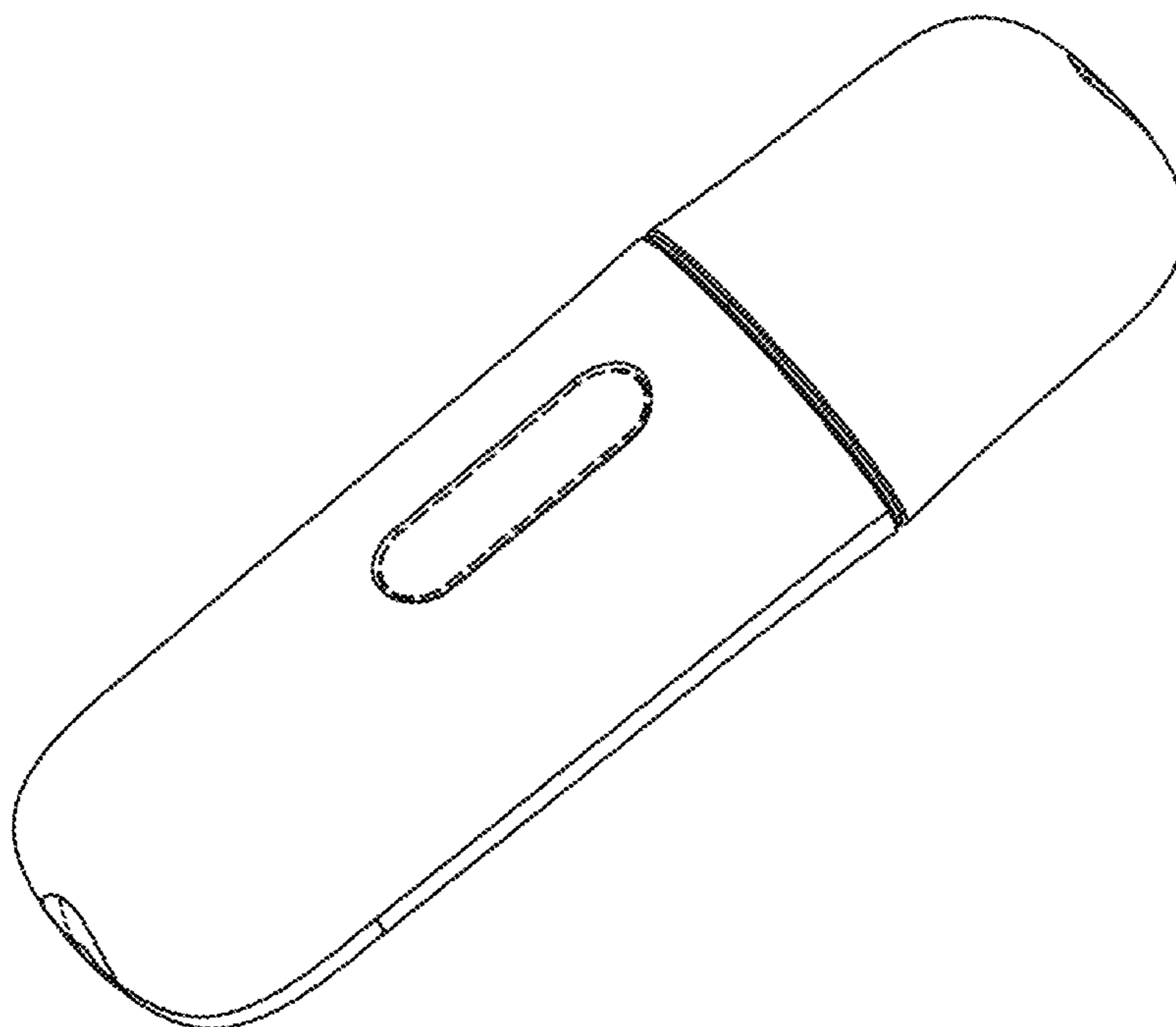
FIG. 1 is a right side, top perspective view of a dispenser for E-liquid embodying our new design;

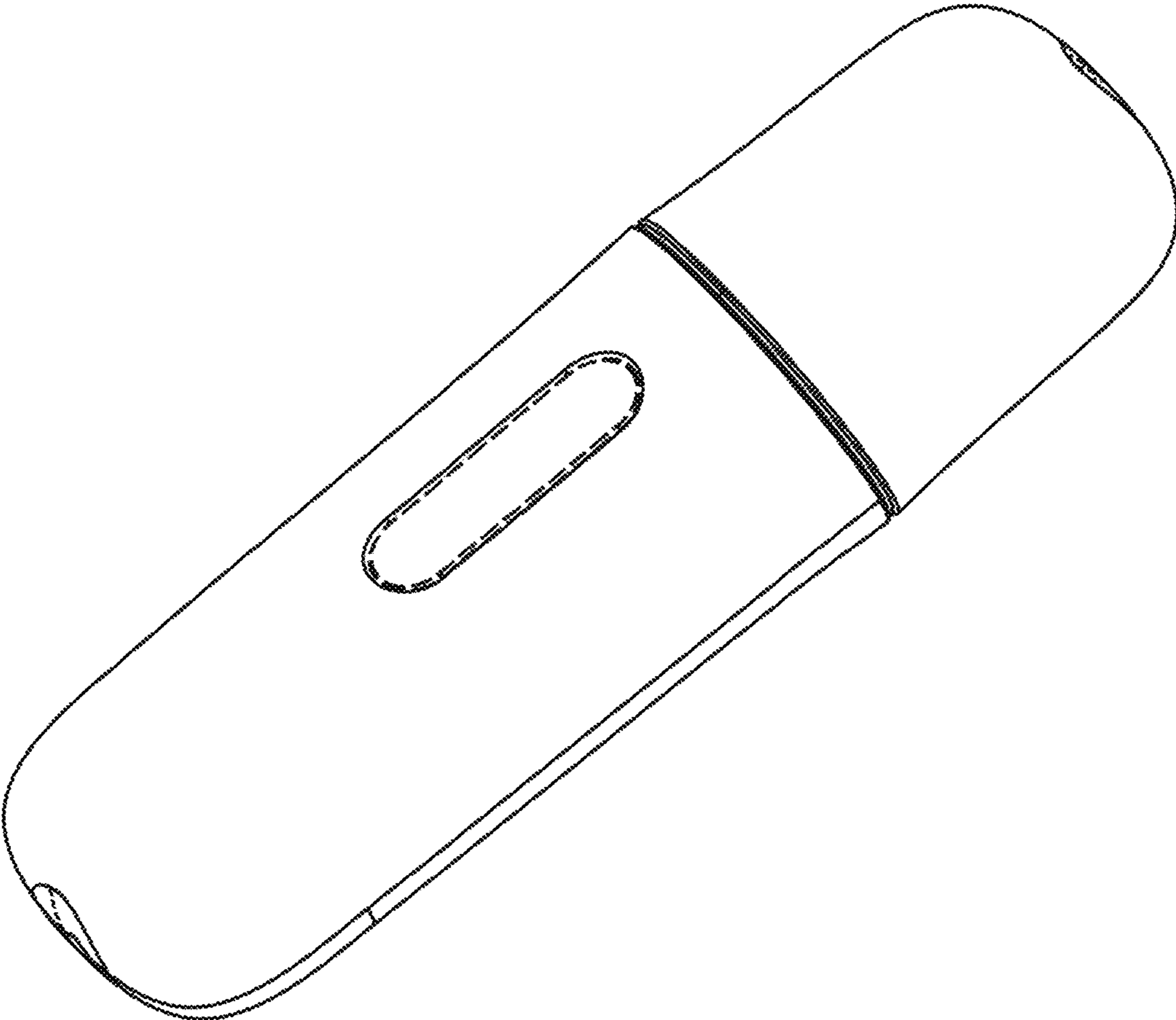

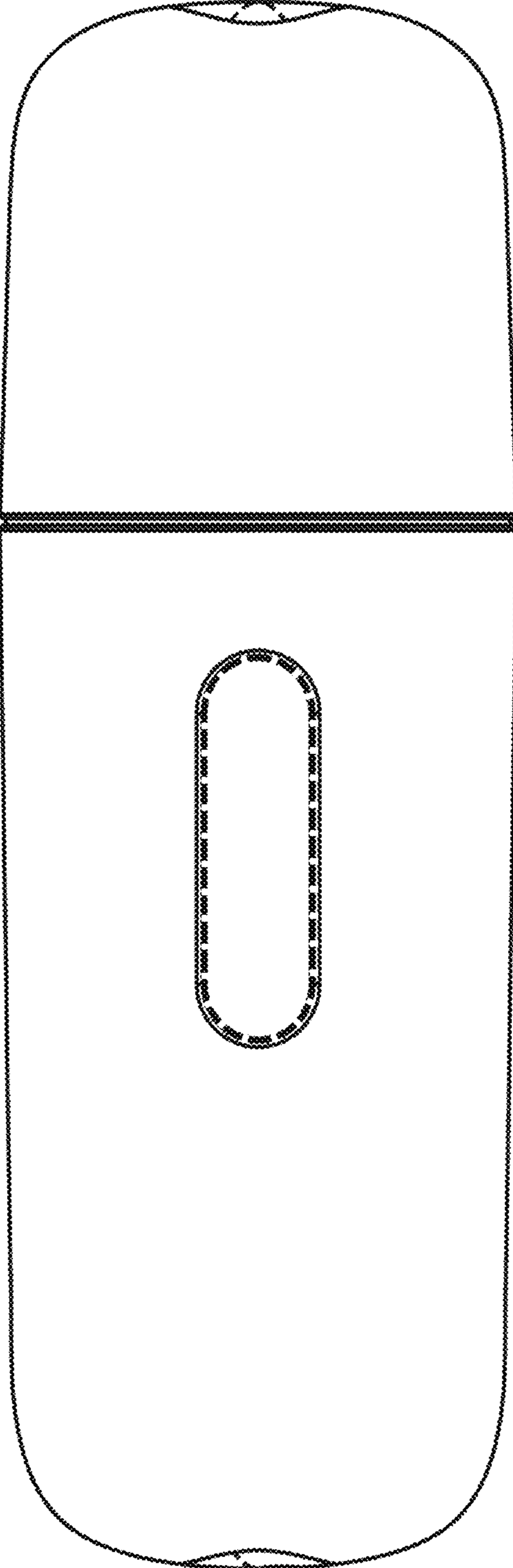
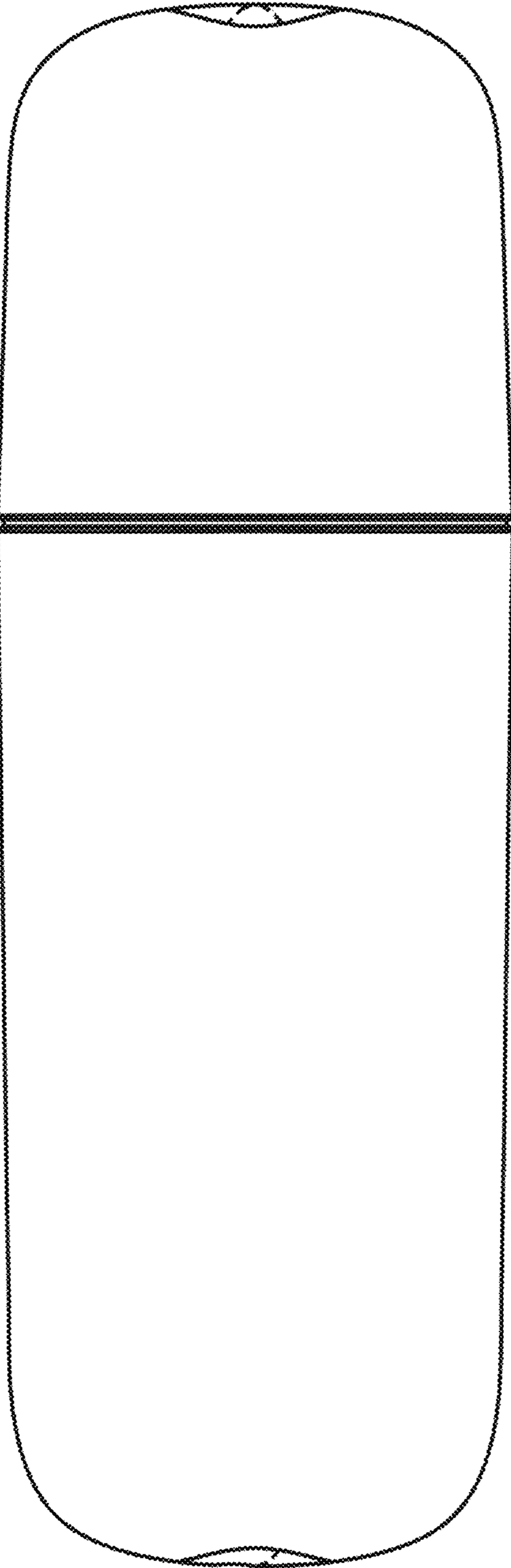
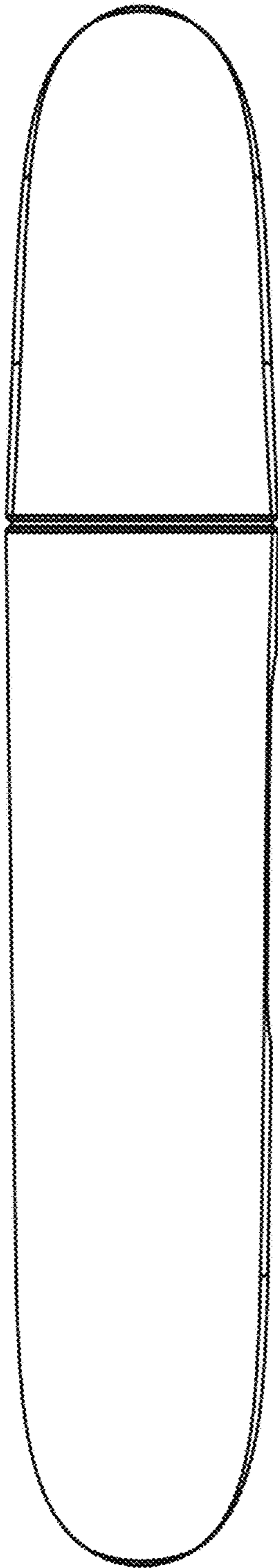


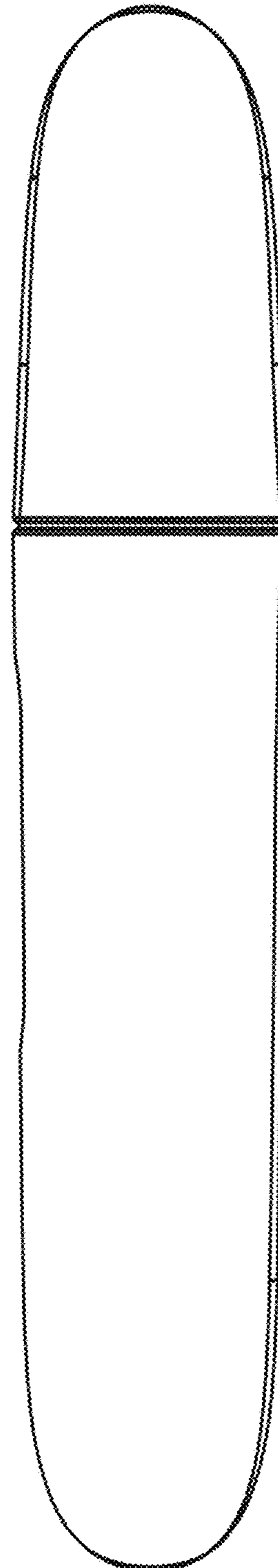

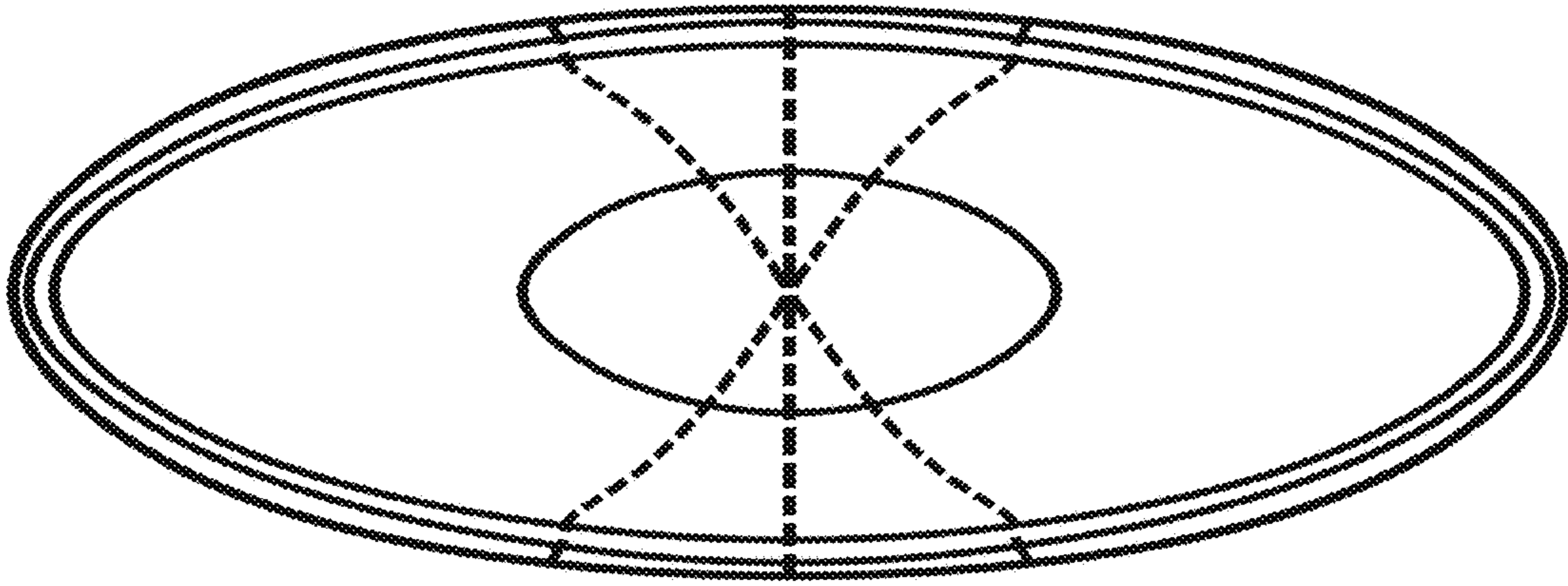

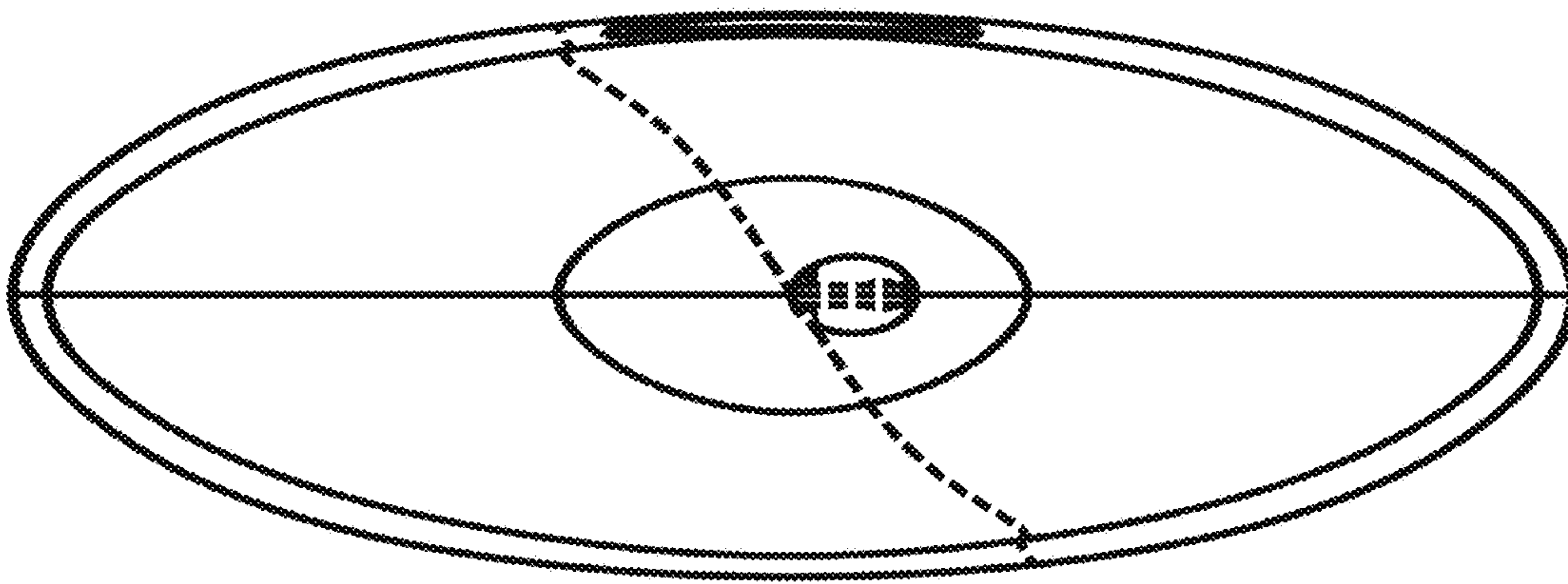
