DESCRIPTION

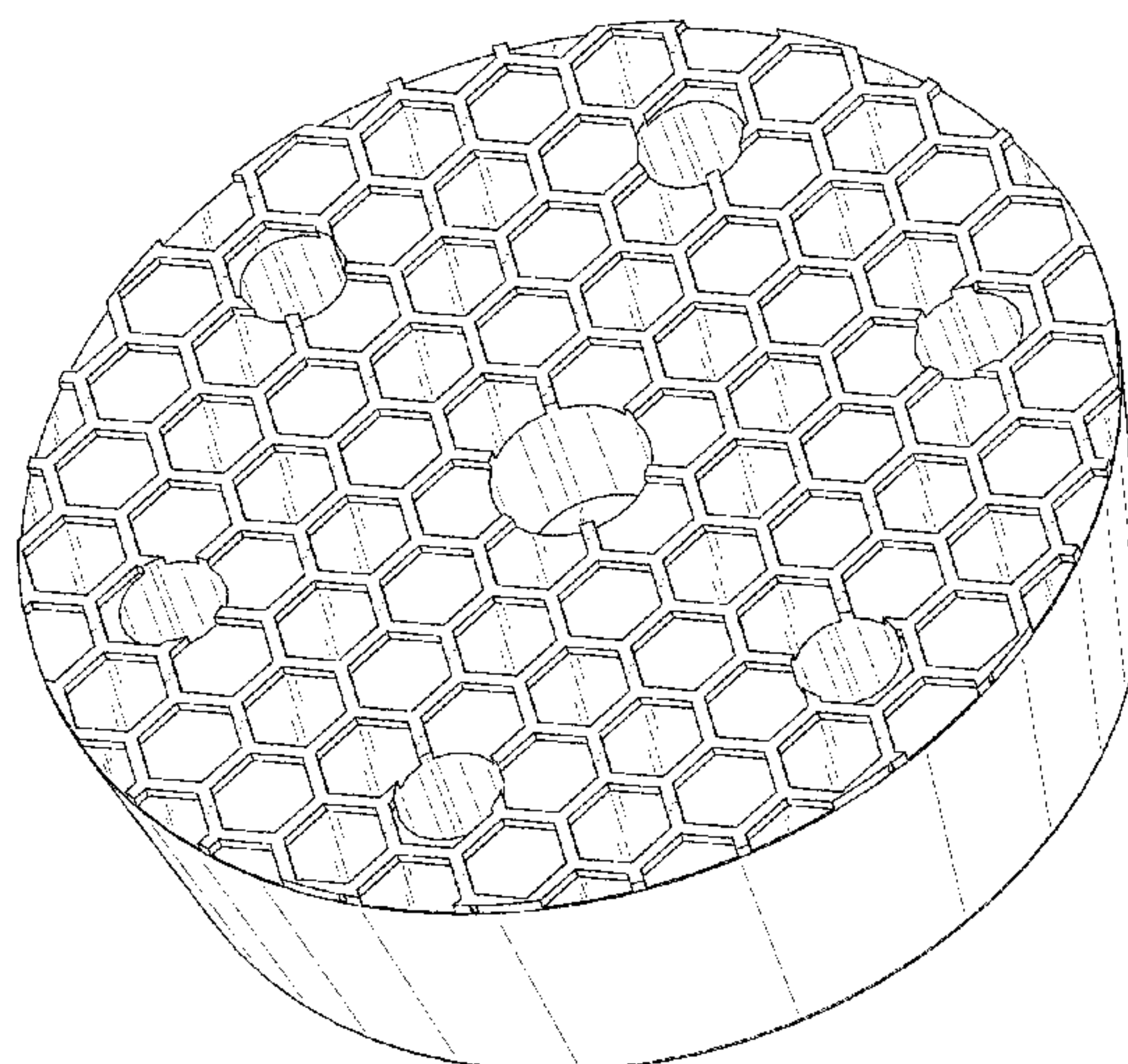
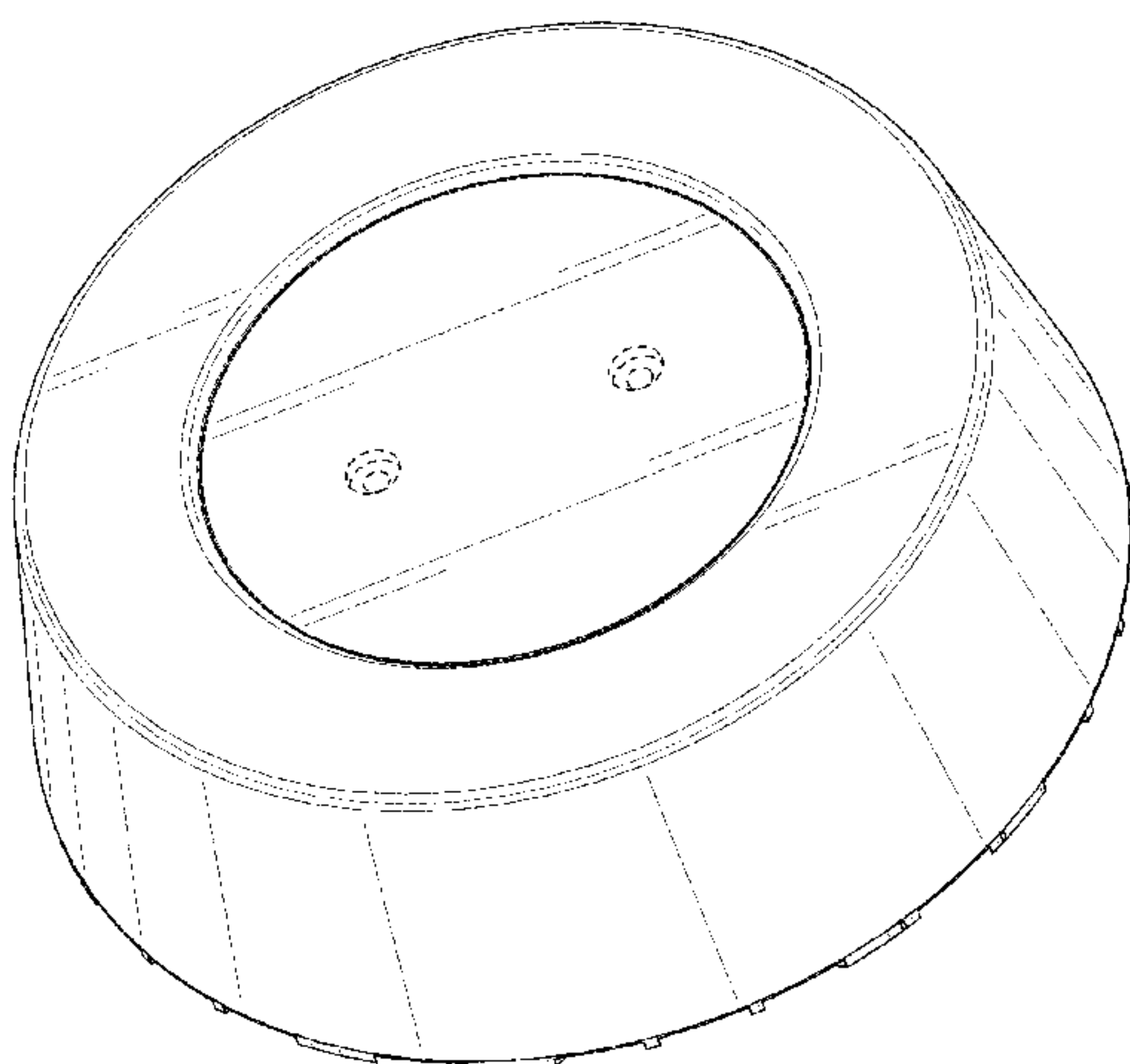
FIG. 1 is a perspective view showing a face of a vibration dampening support;

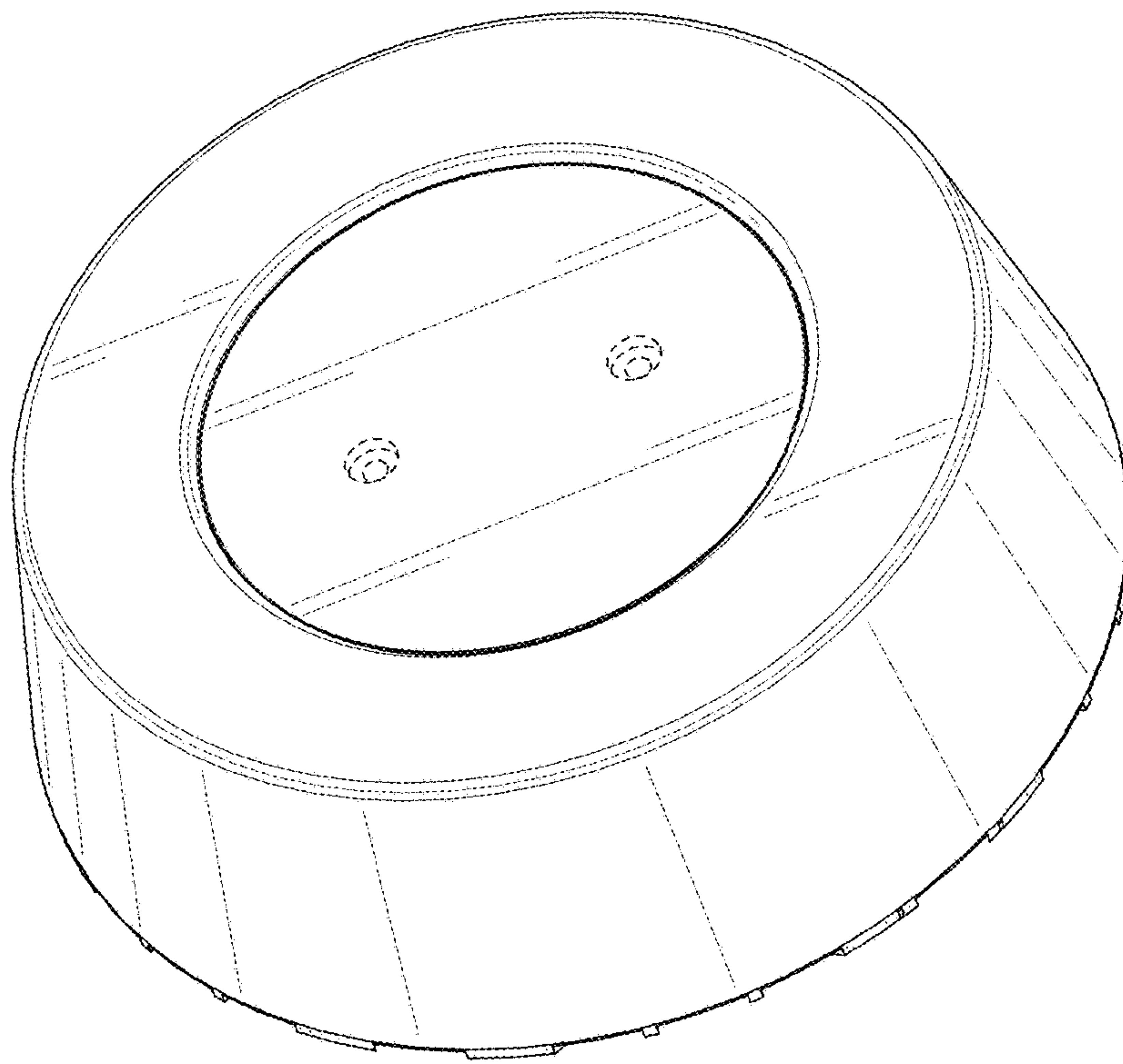

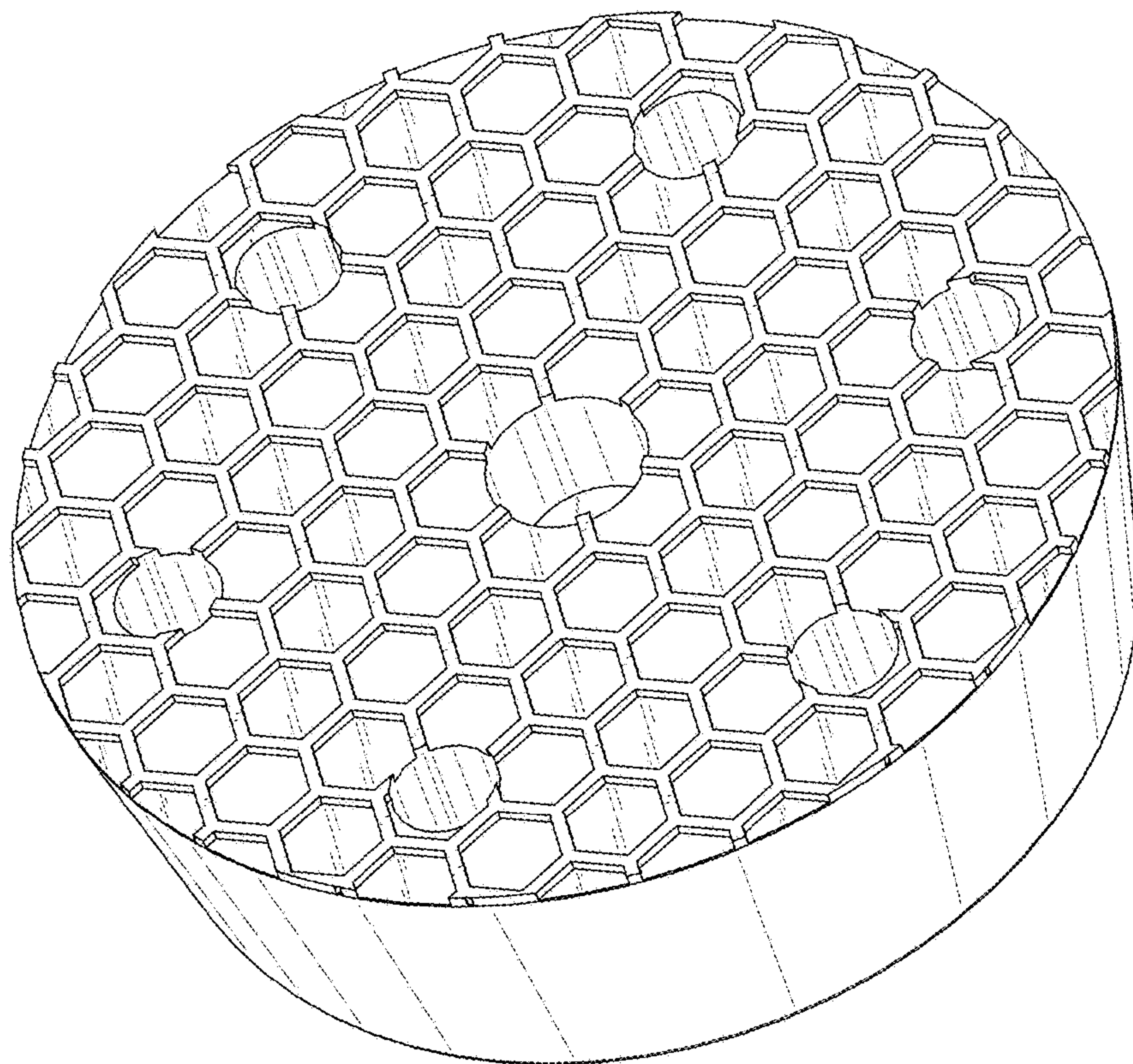

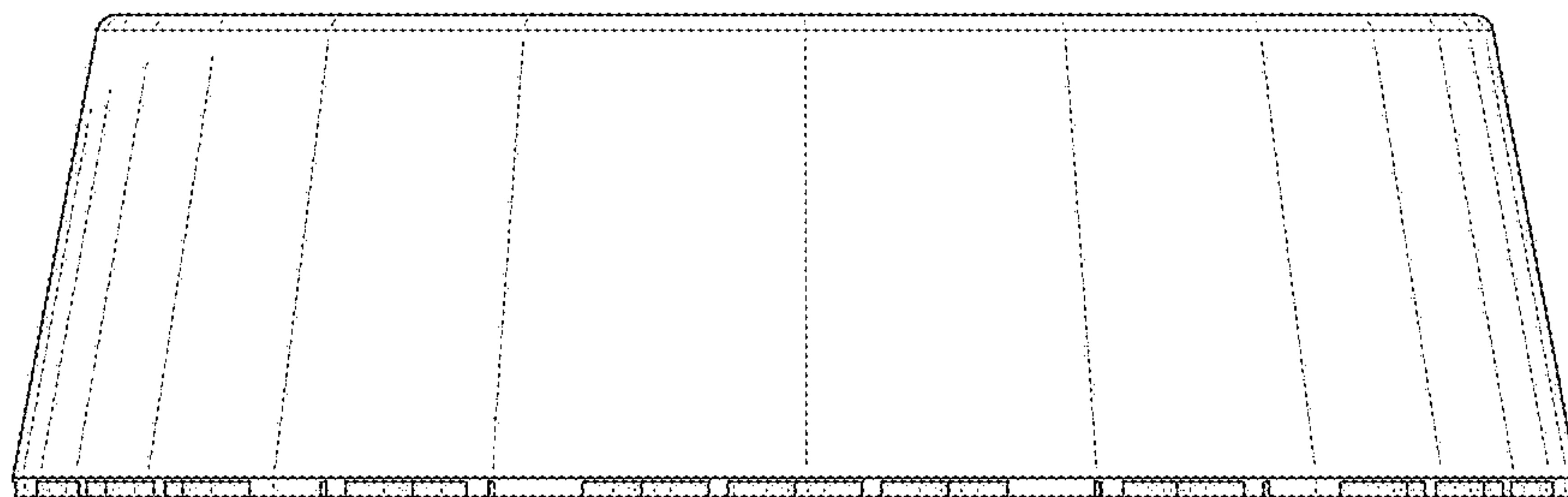

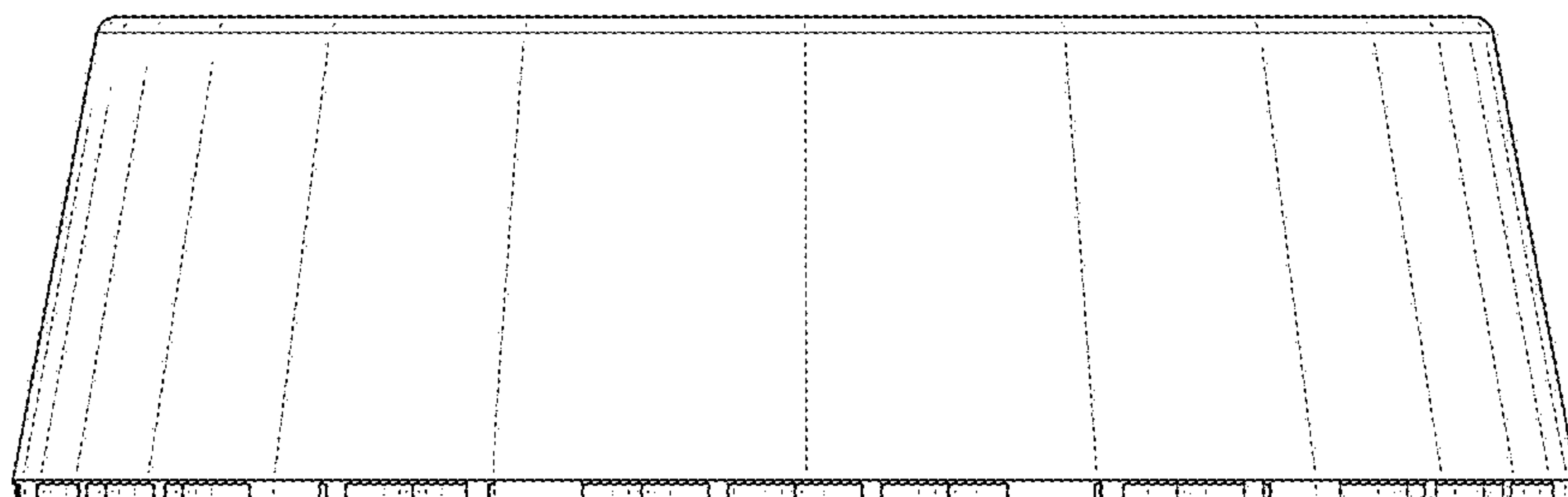

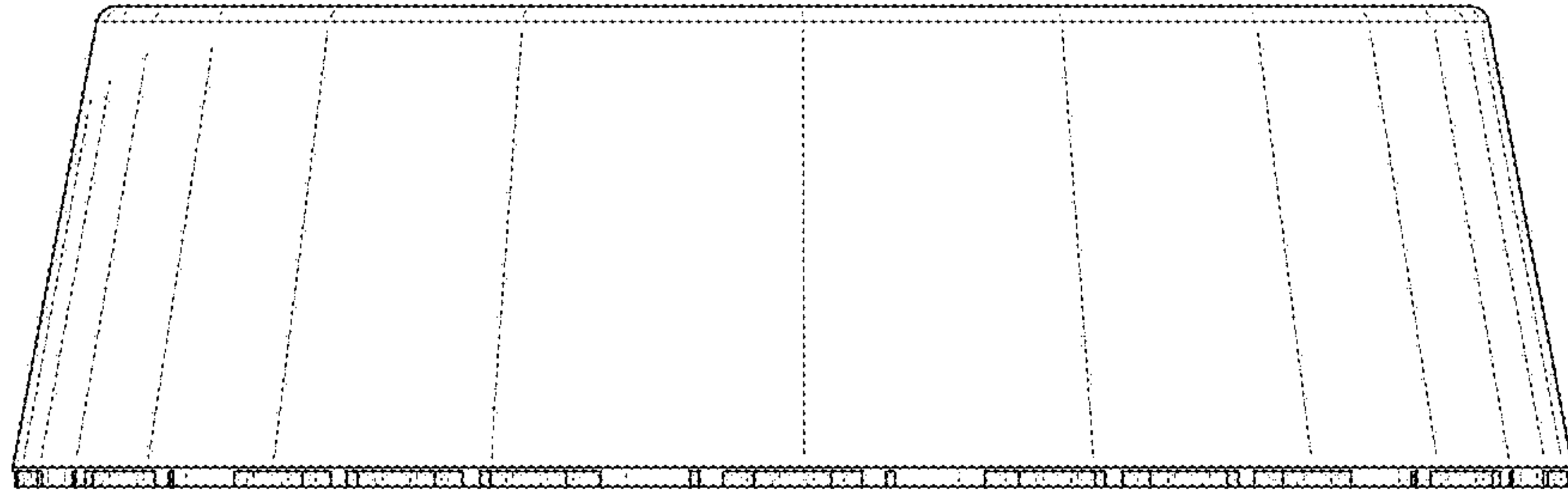

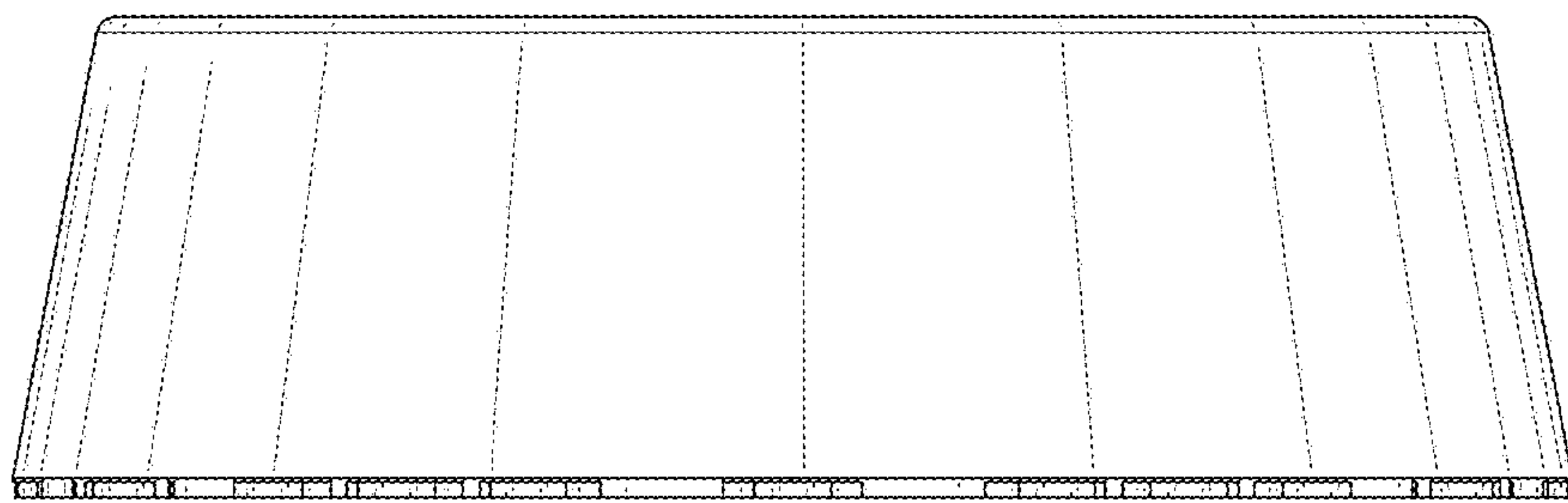

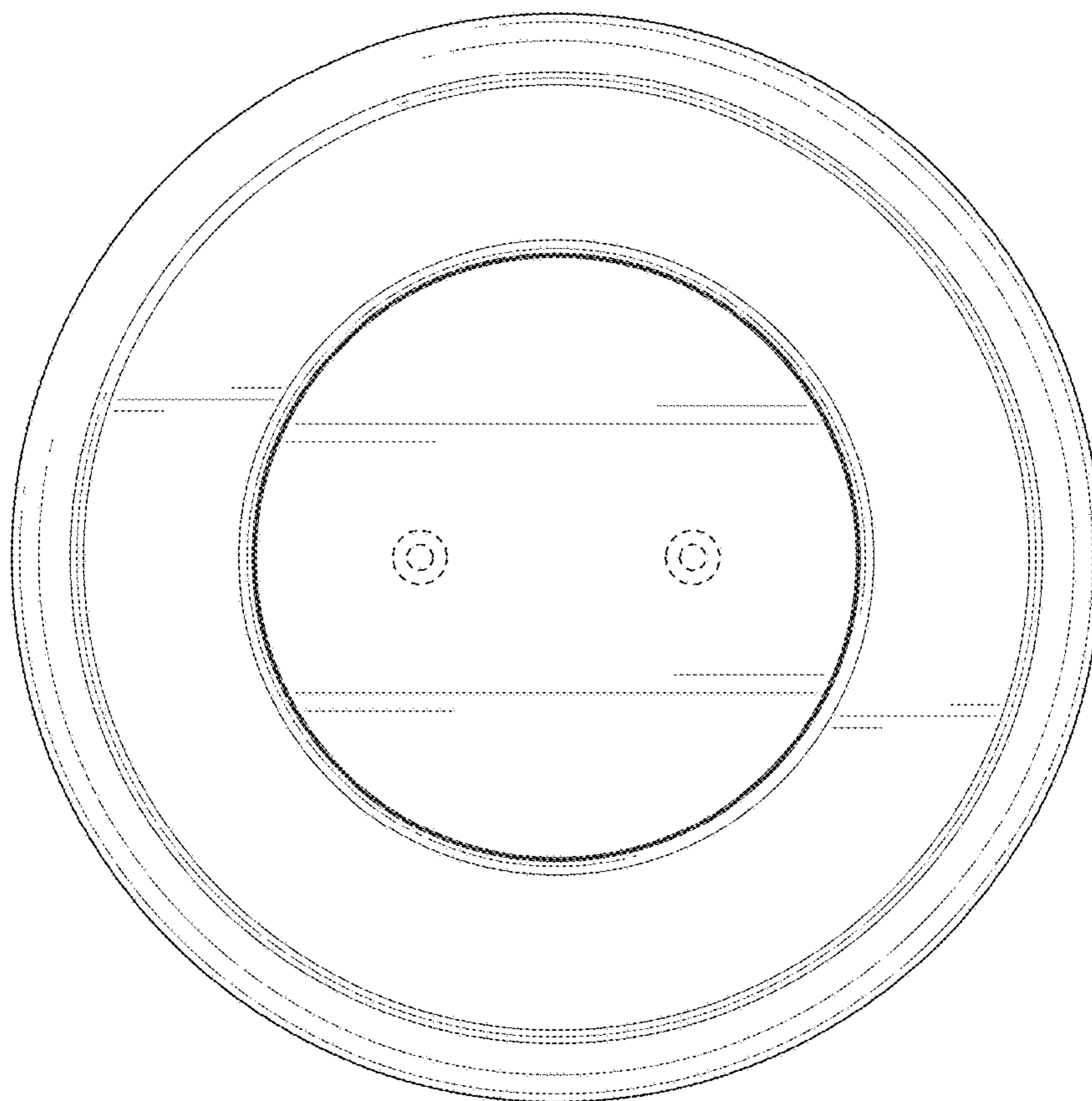

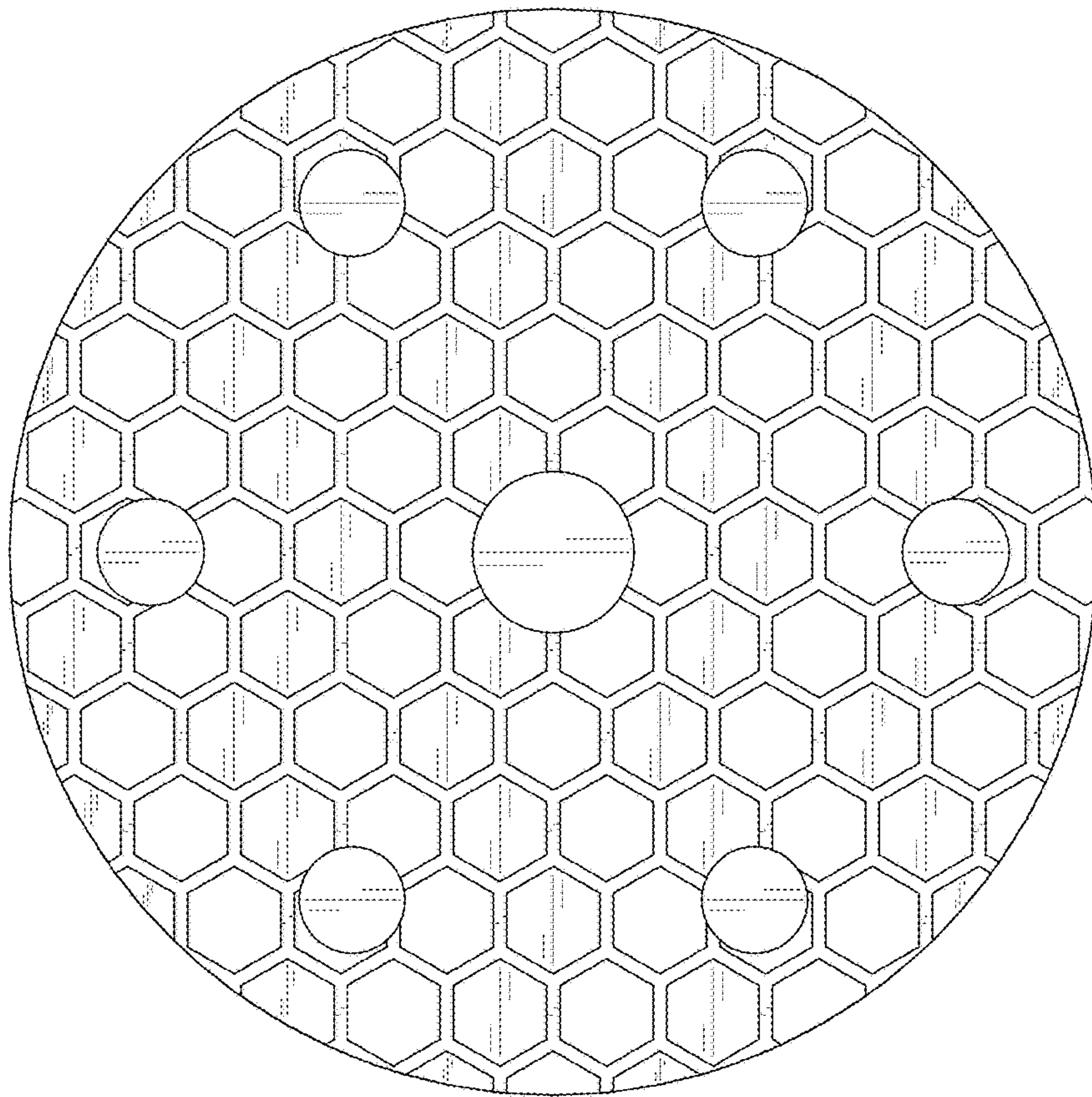
