FIG. 10 is a back elevation view thereof;

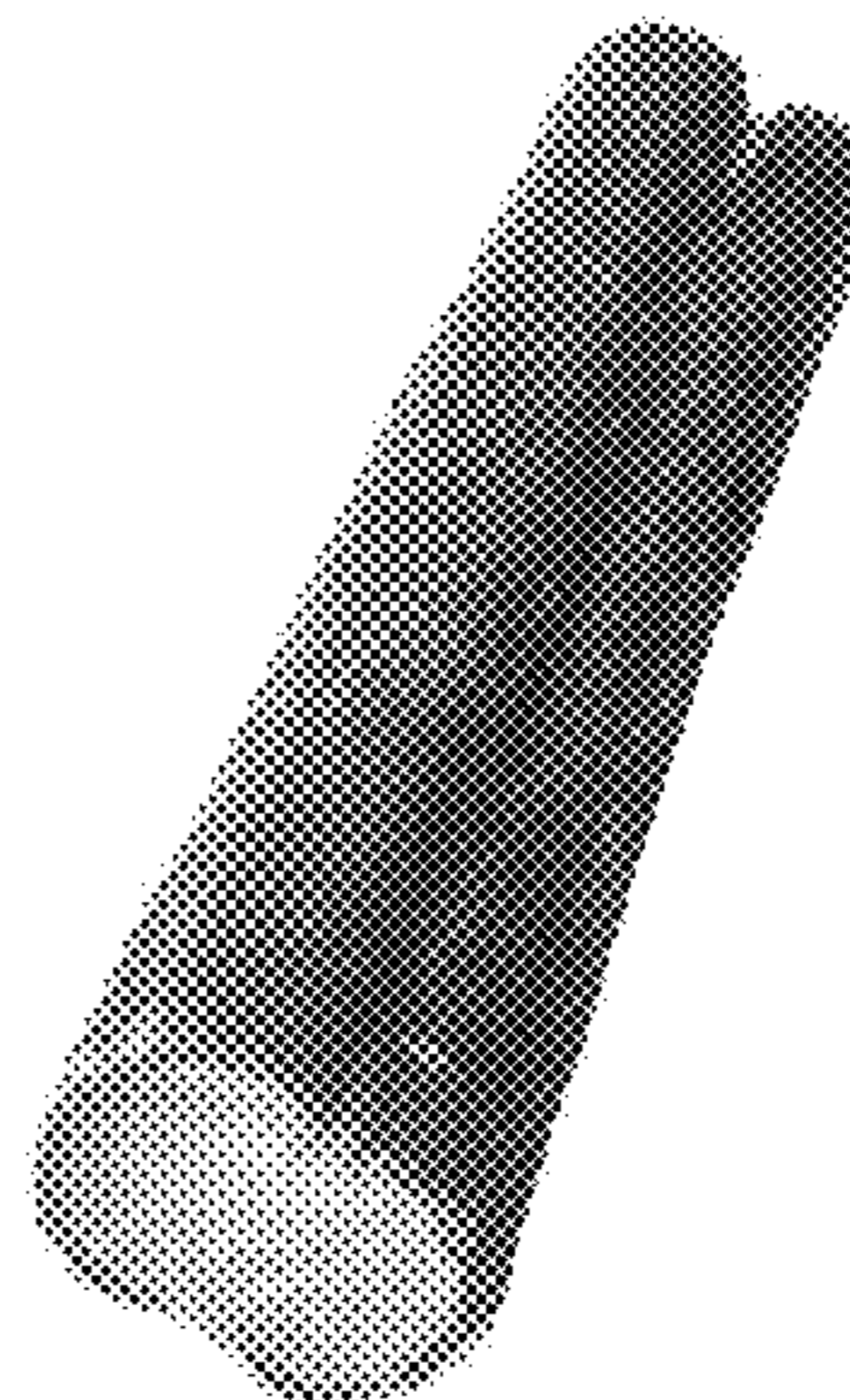
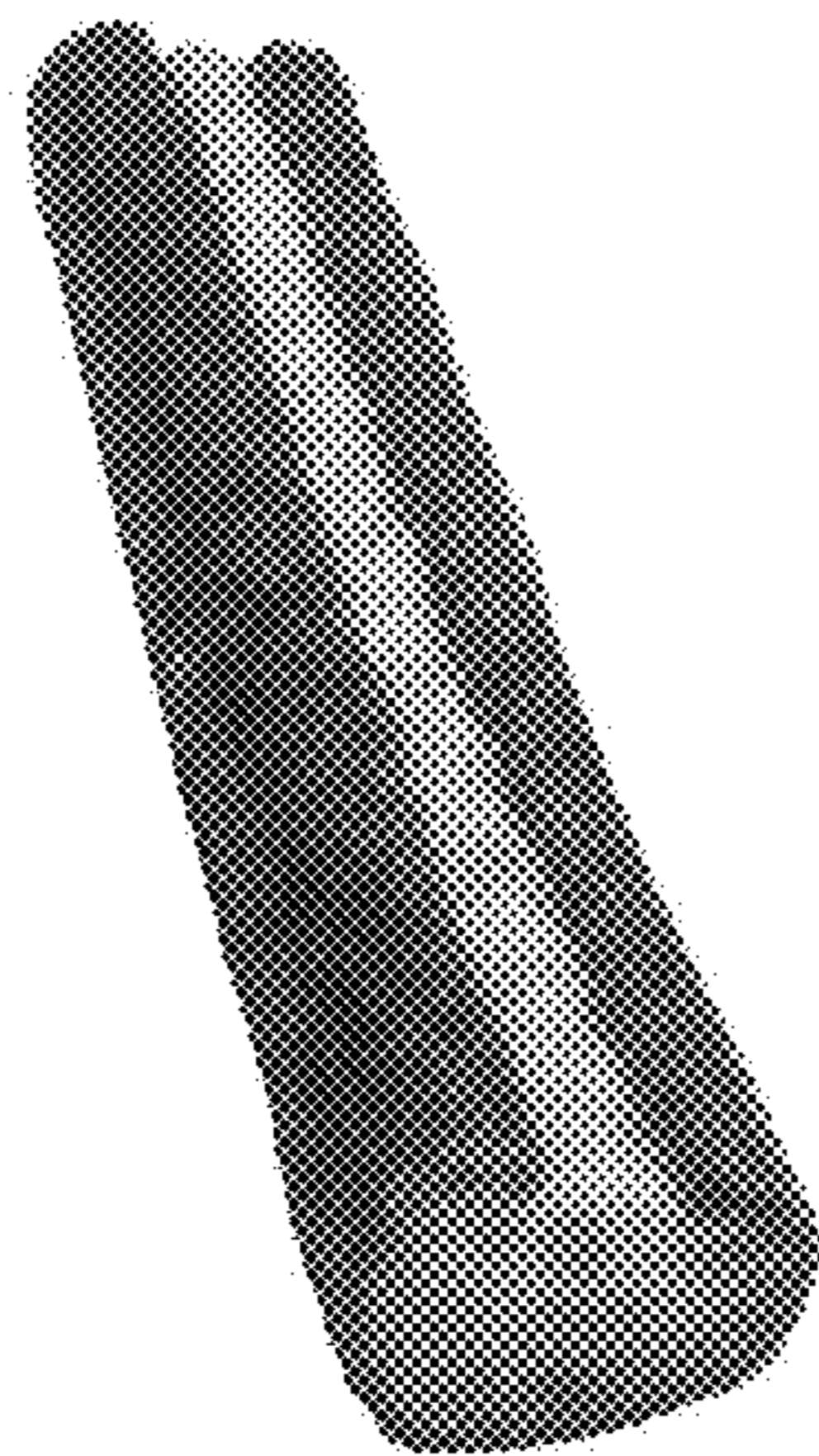
FIG. 11 is a left elevation view thereof;

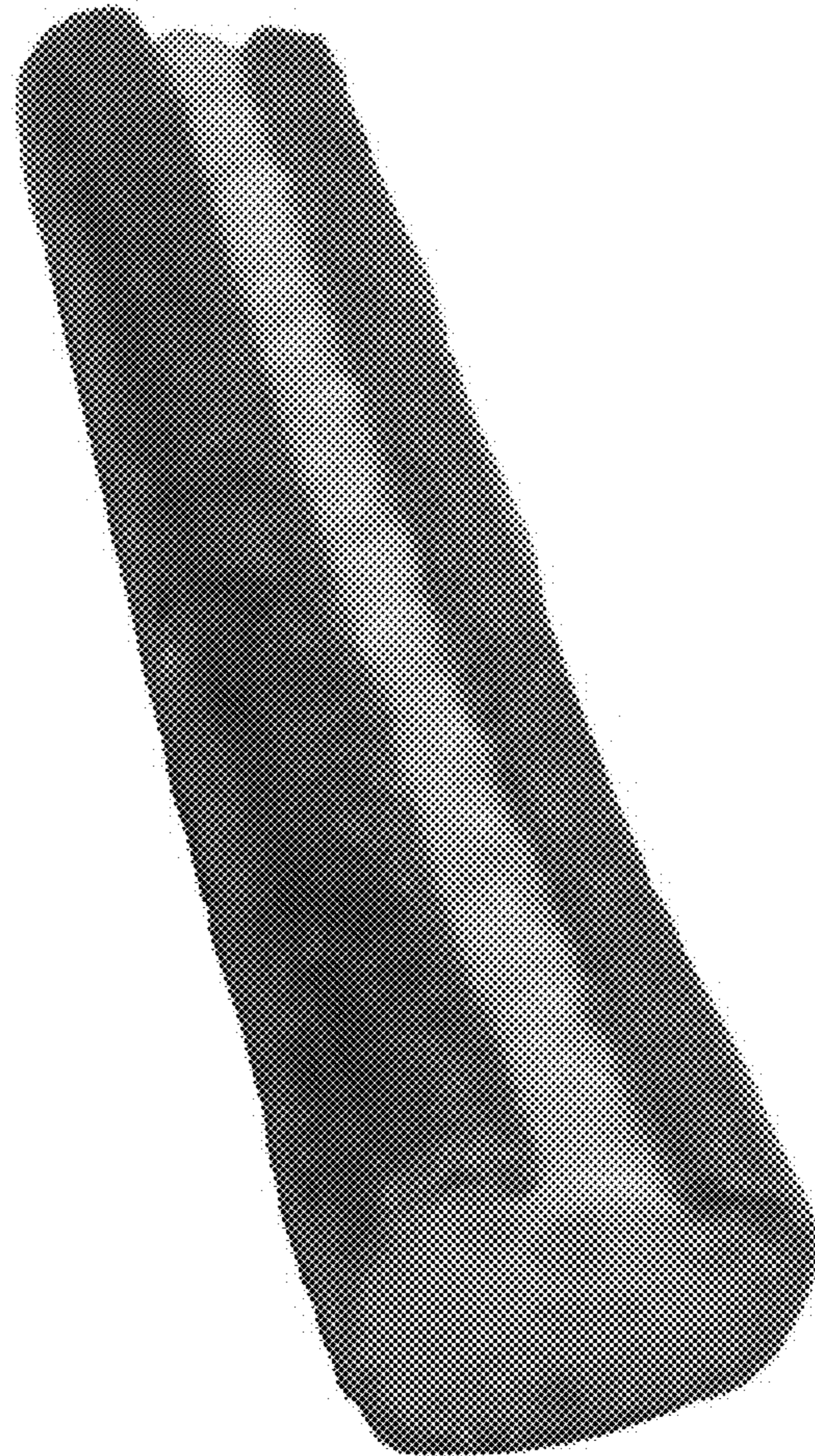

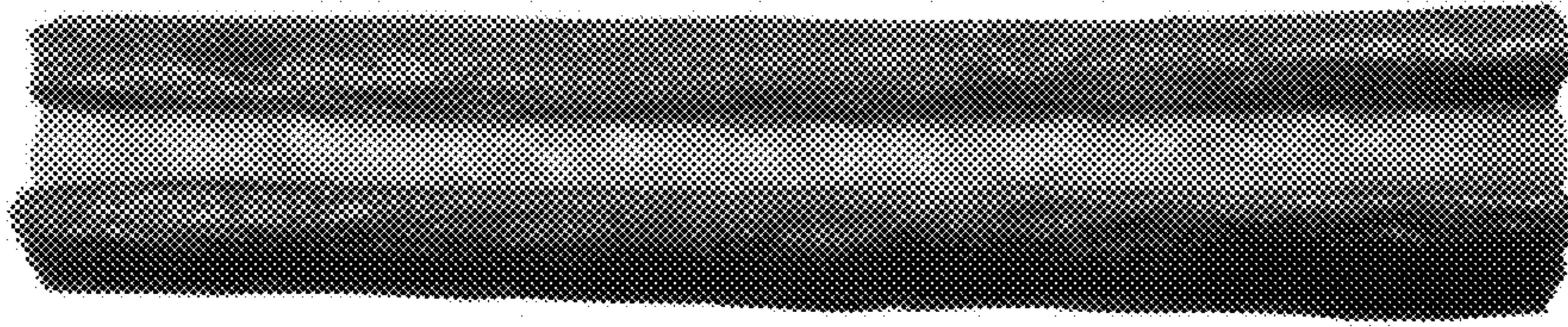

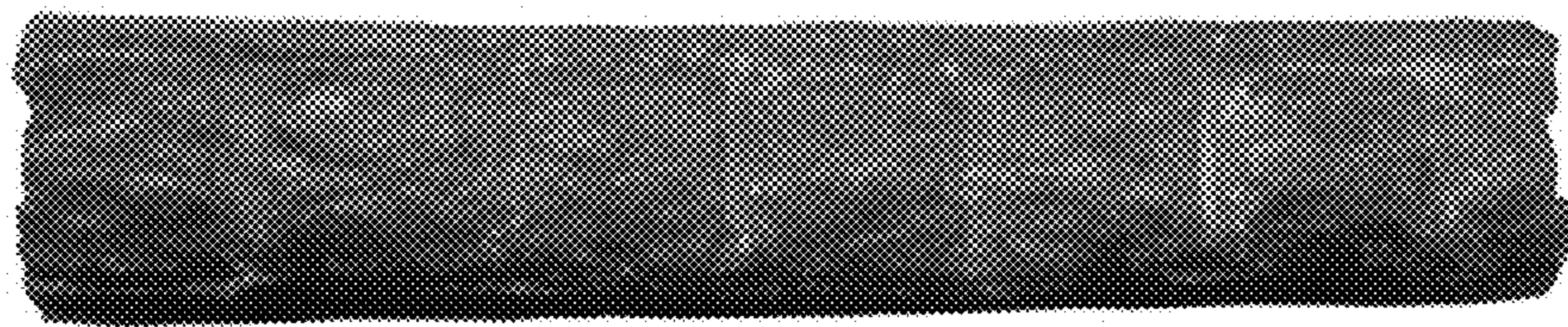

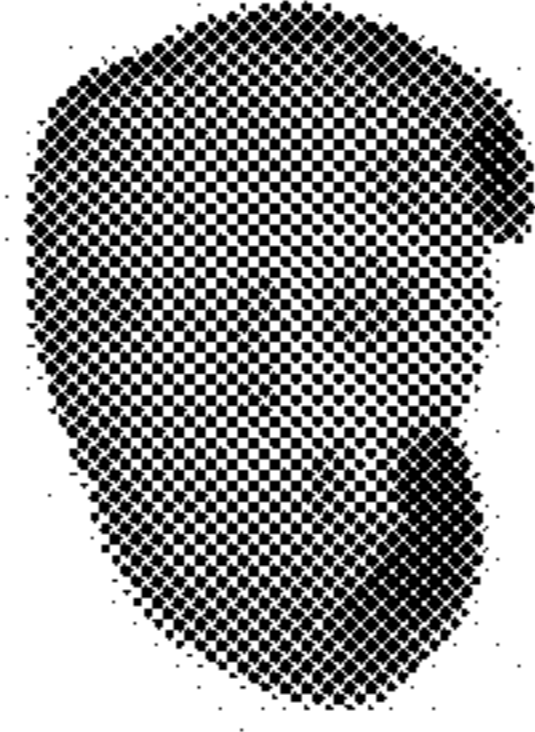

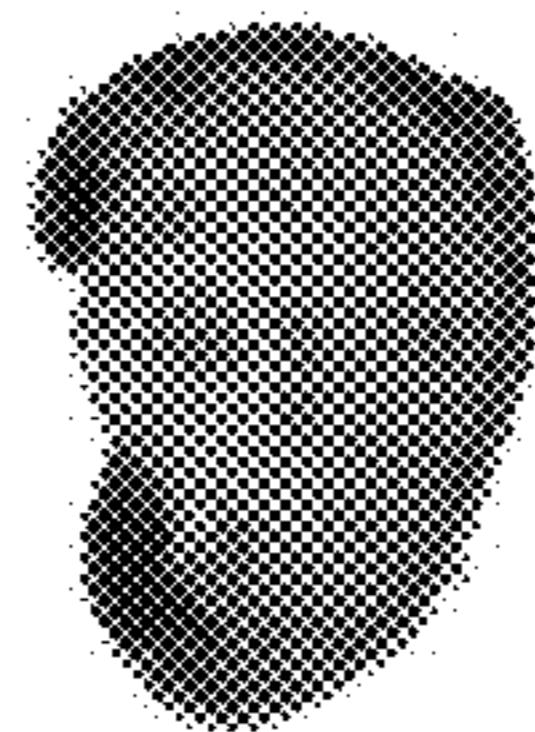

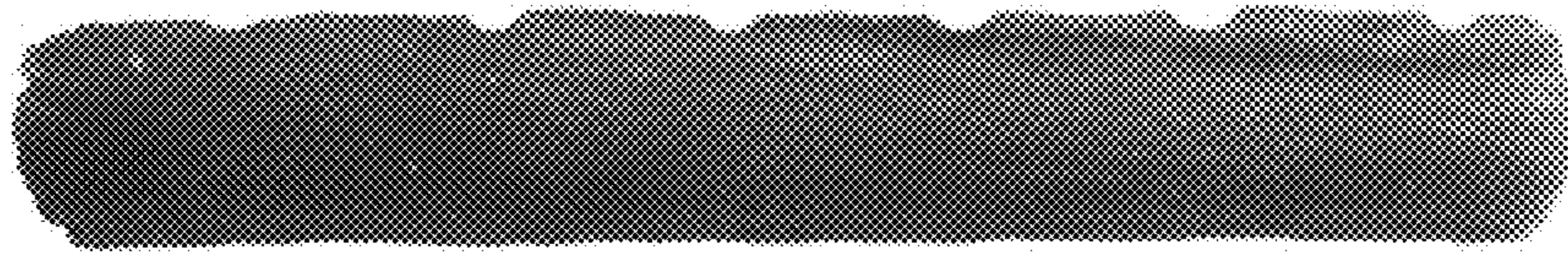

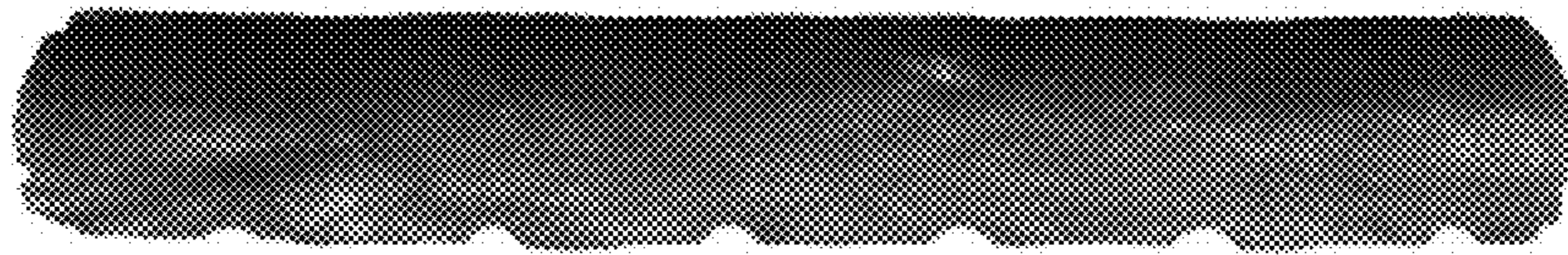

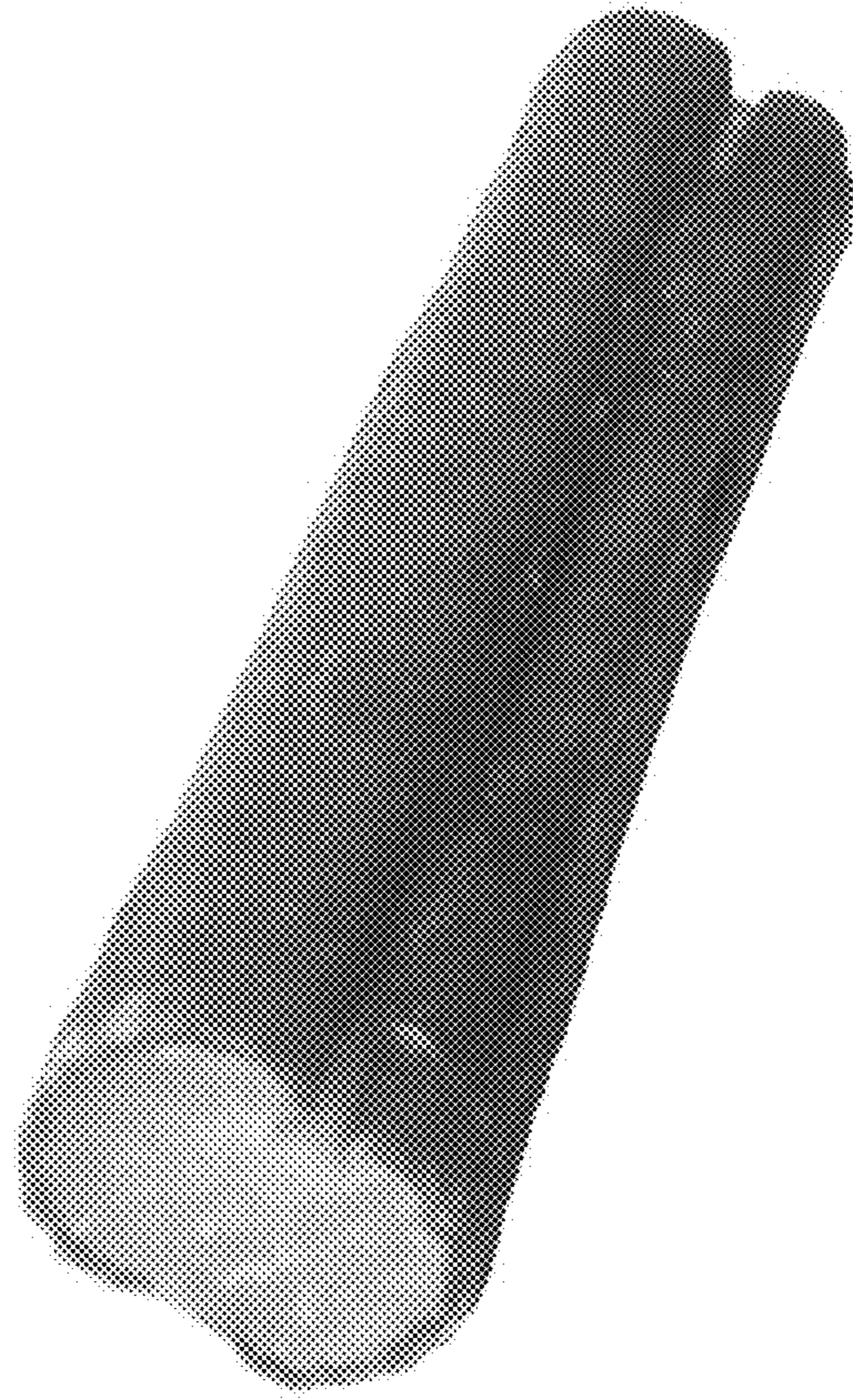

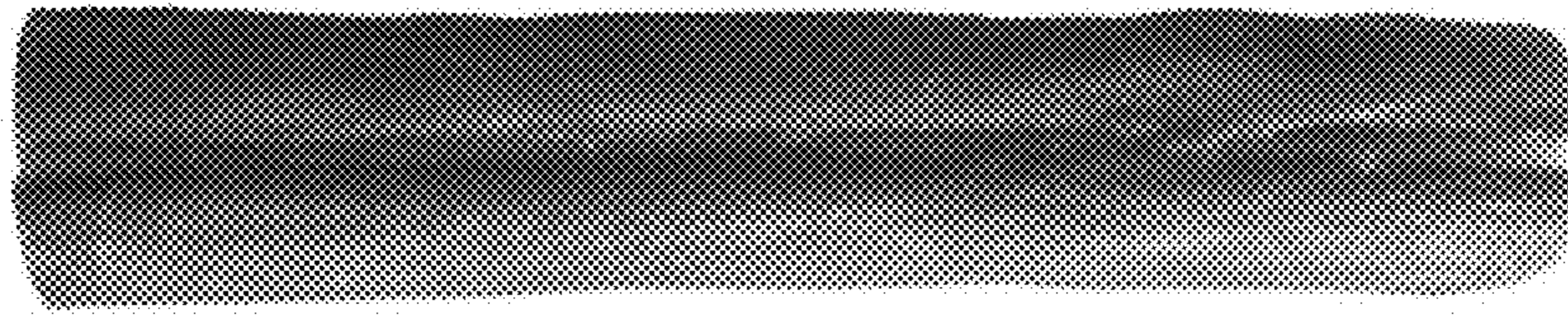

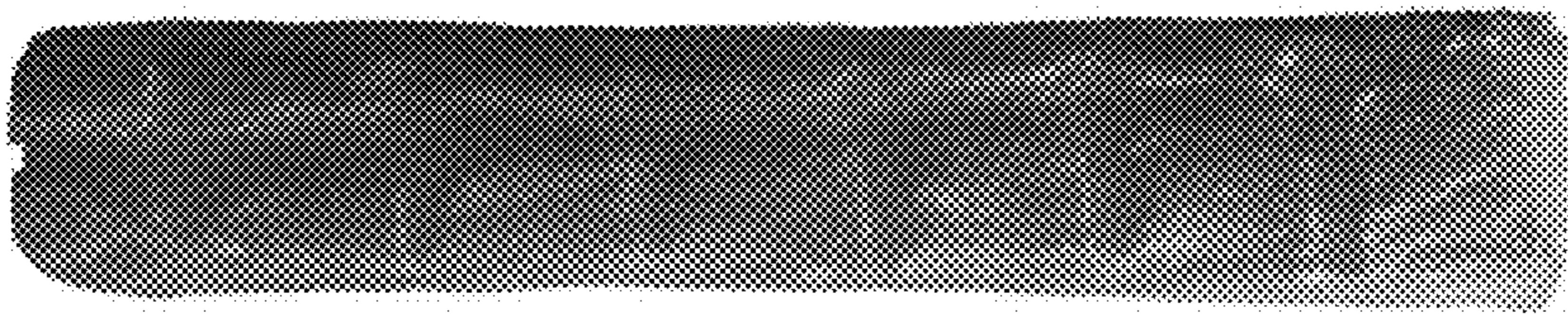

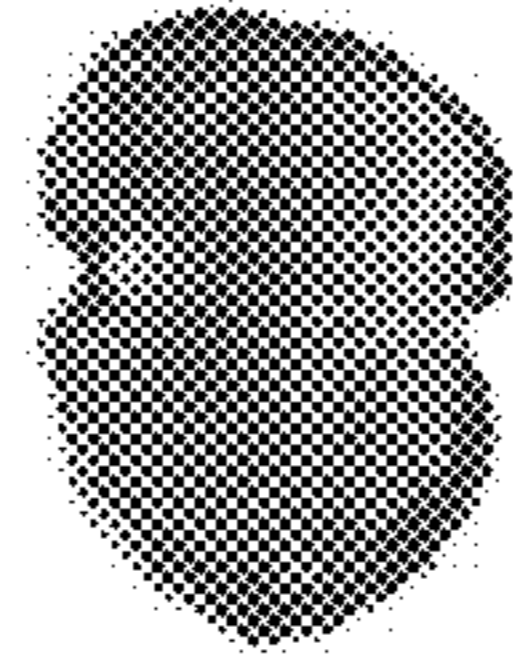

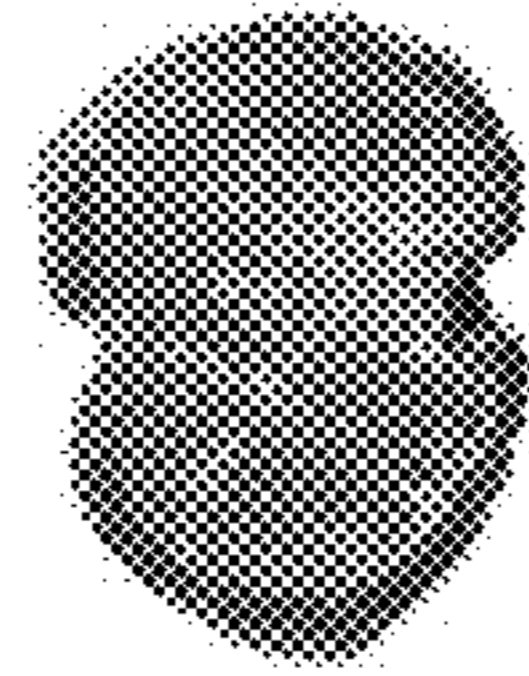

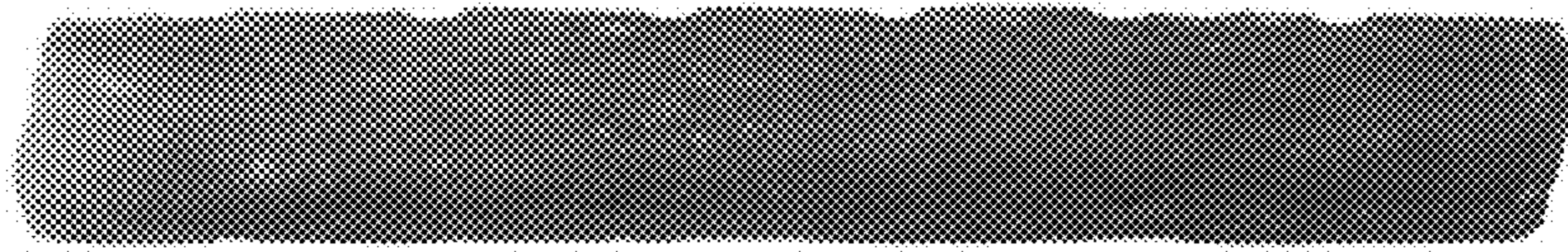

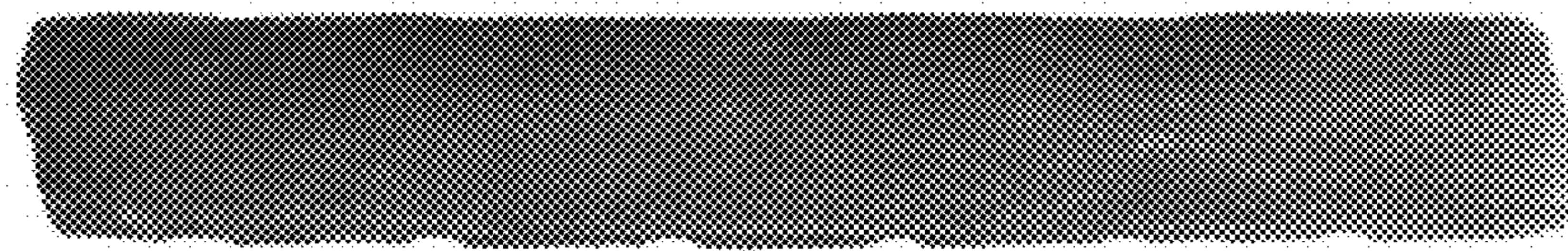
