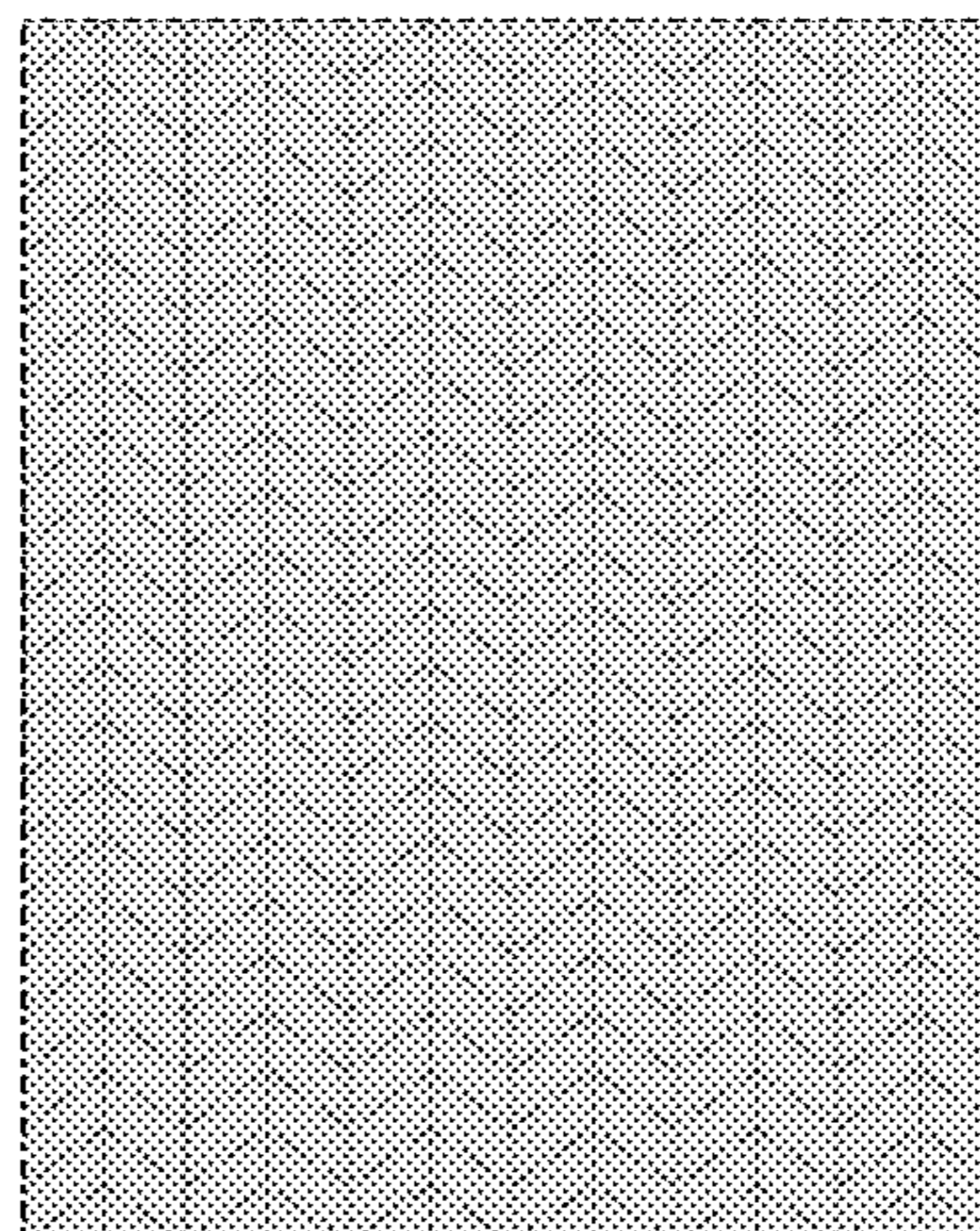
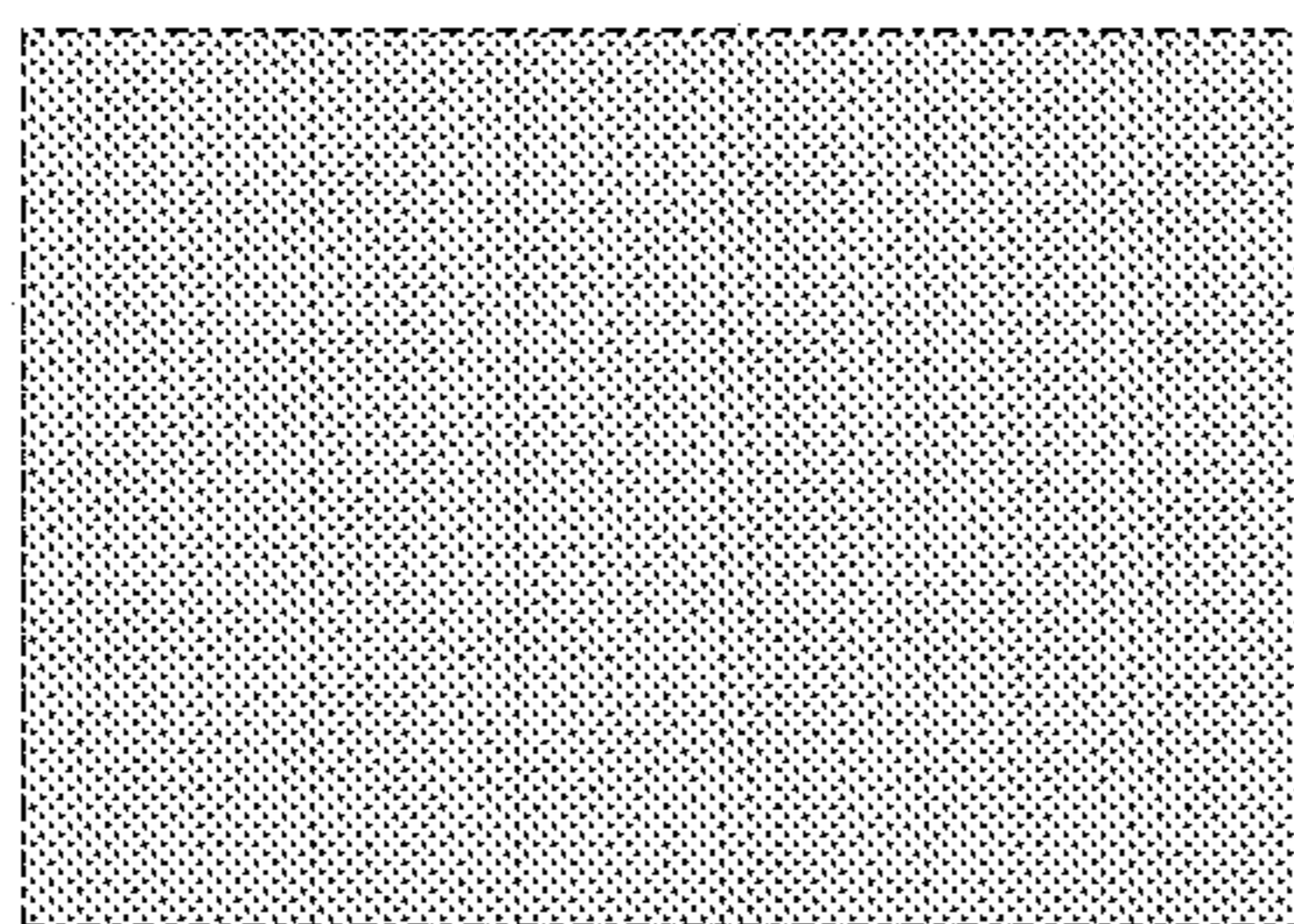
The ornamental design for a textile, as shown and described.

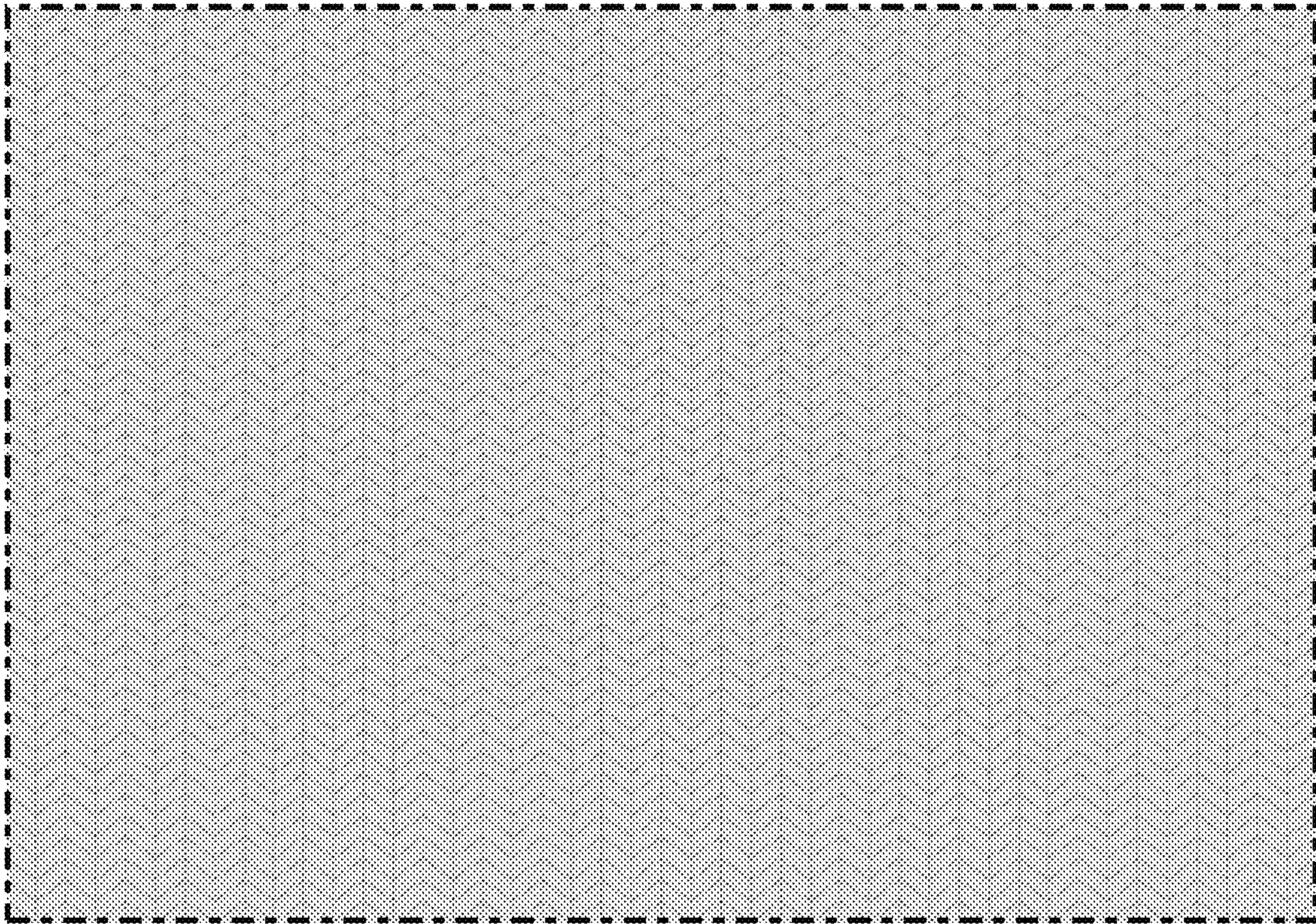

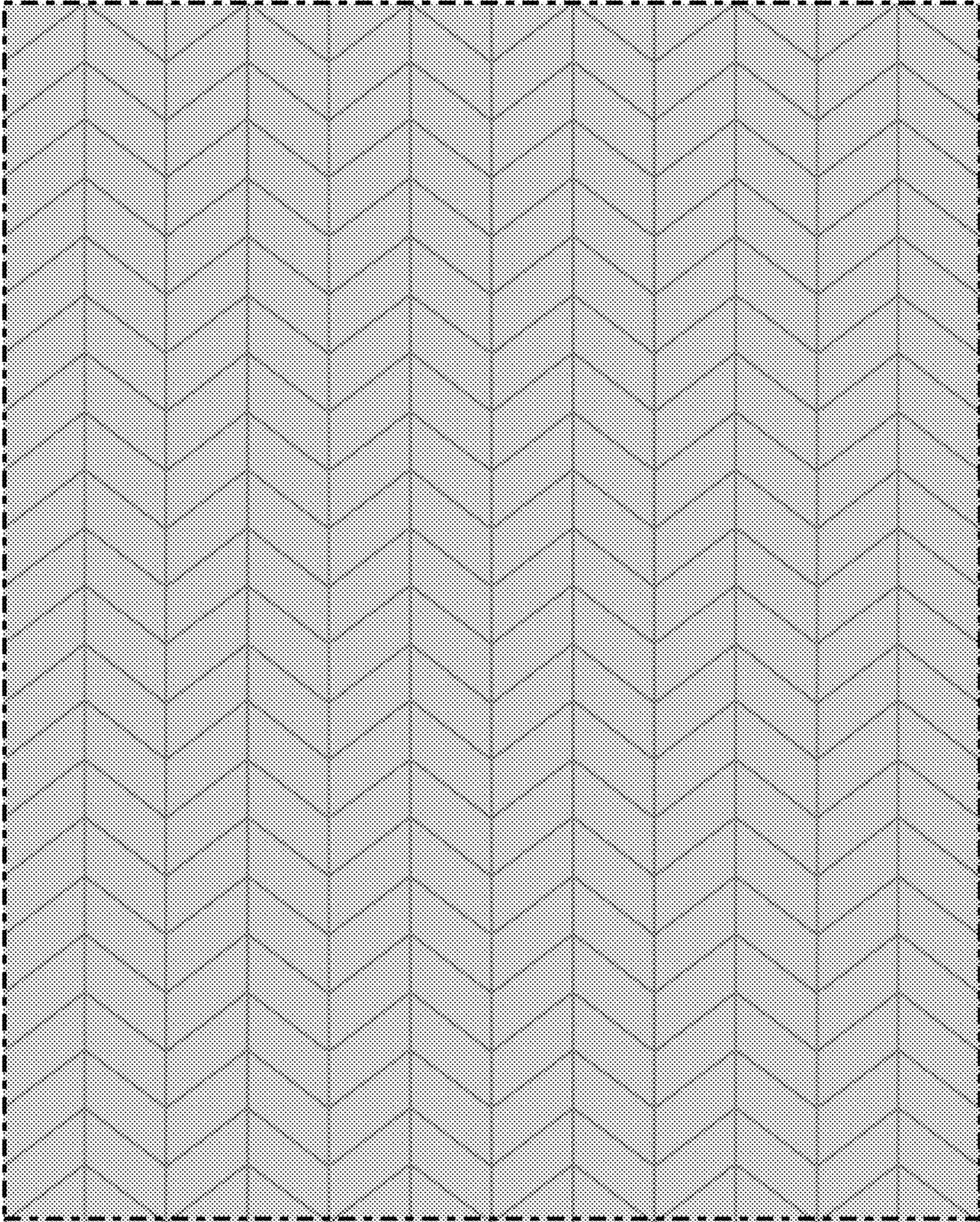
