(57) **CLAIM**

The ornamental design for a hinge having multiple degrees of freedom, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the hinge having multiple degrees of freedom;

FIG. 2 is a back view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a side view thereof;

FIG. 6 is the opposite side view thereof;

FIG. 7 is a perspective view thereof;

FIG. 8 is an enlarged perspective view thereof taken from the portion within the broken line rectangle in FIG. 7;

FIG. 9 is an enlarged view of FIG. 5;

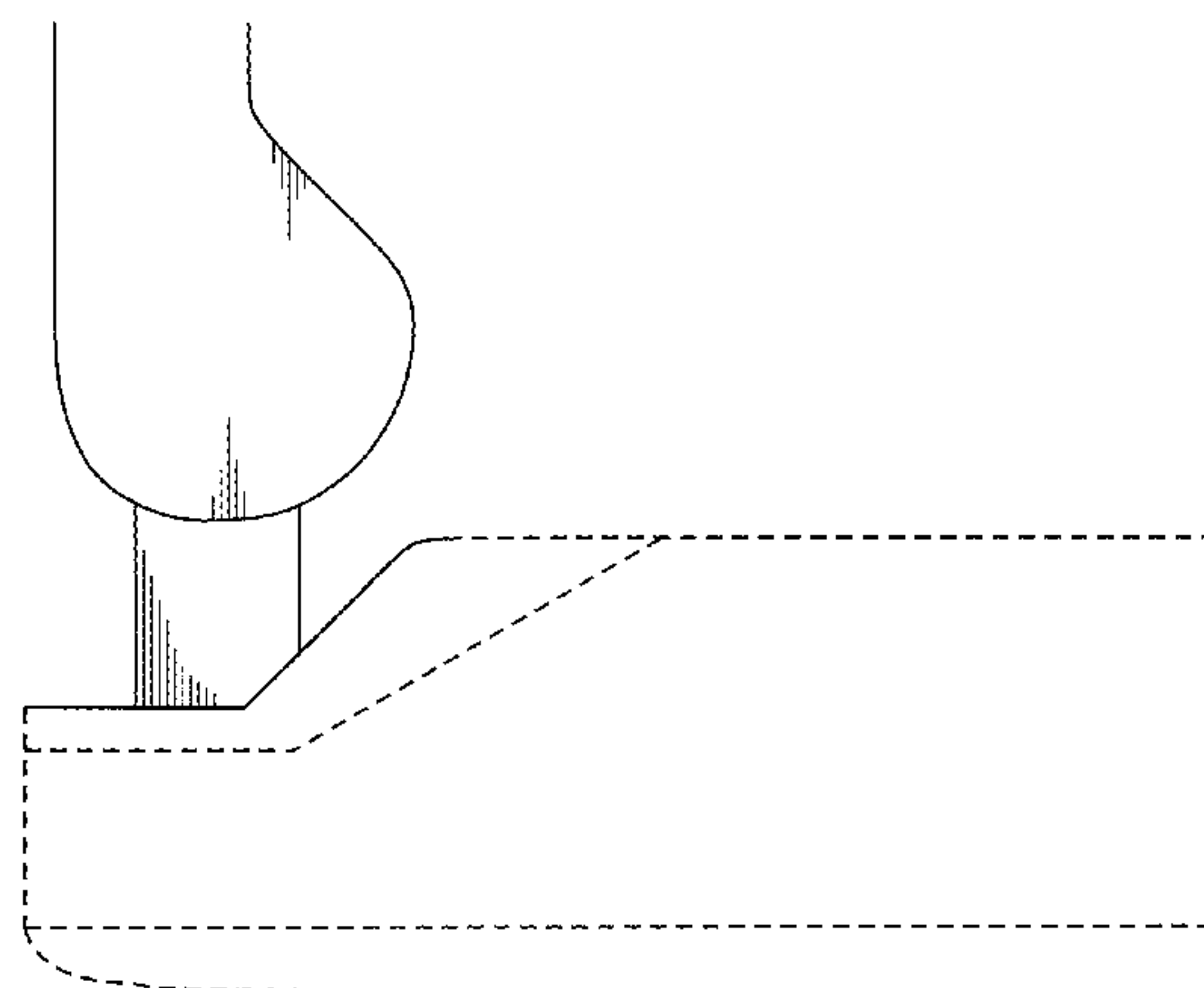
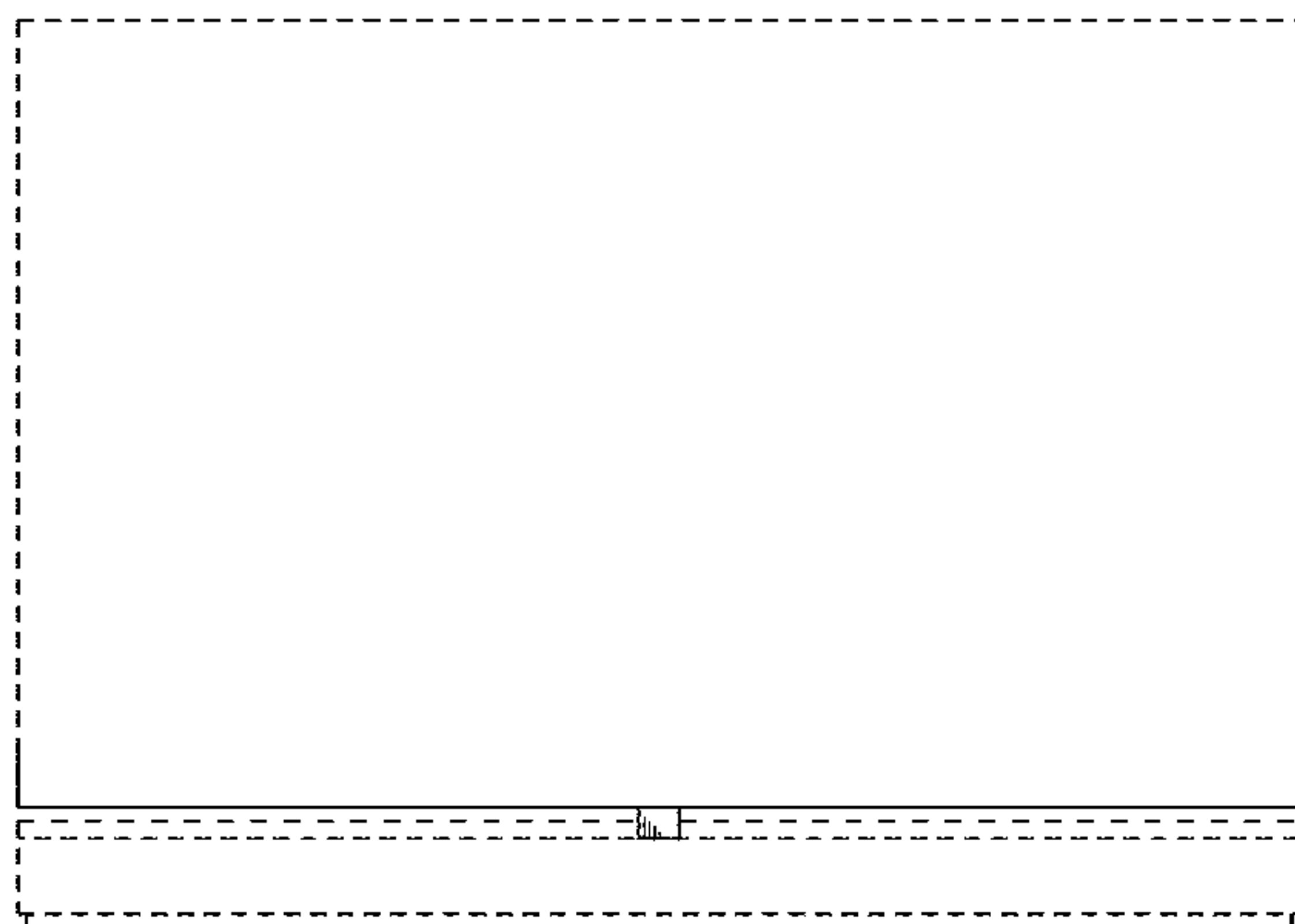
FIG. 10 is a front view of the hinge having multiple degrees of freedom from FIG. 1 in an alternate configuration;

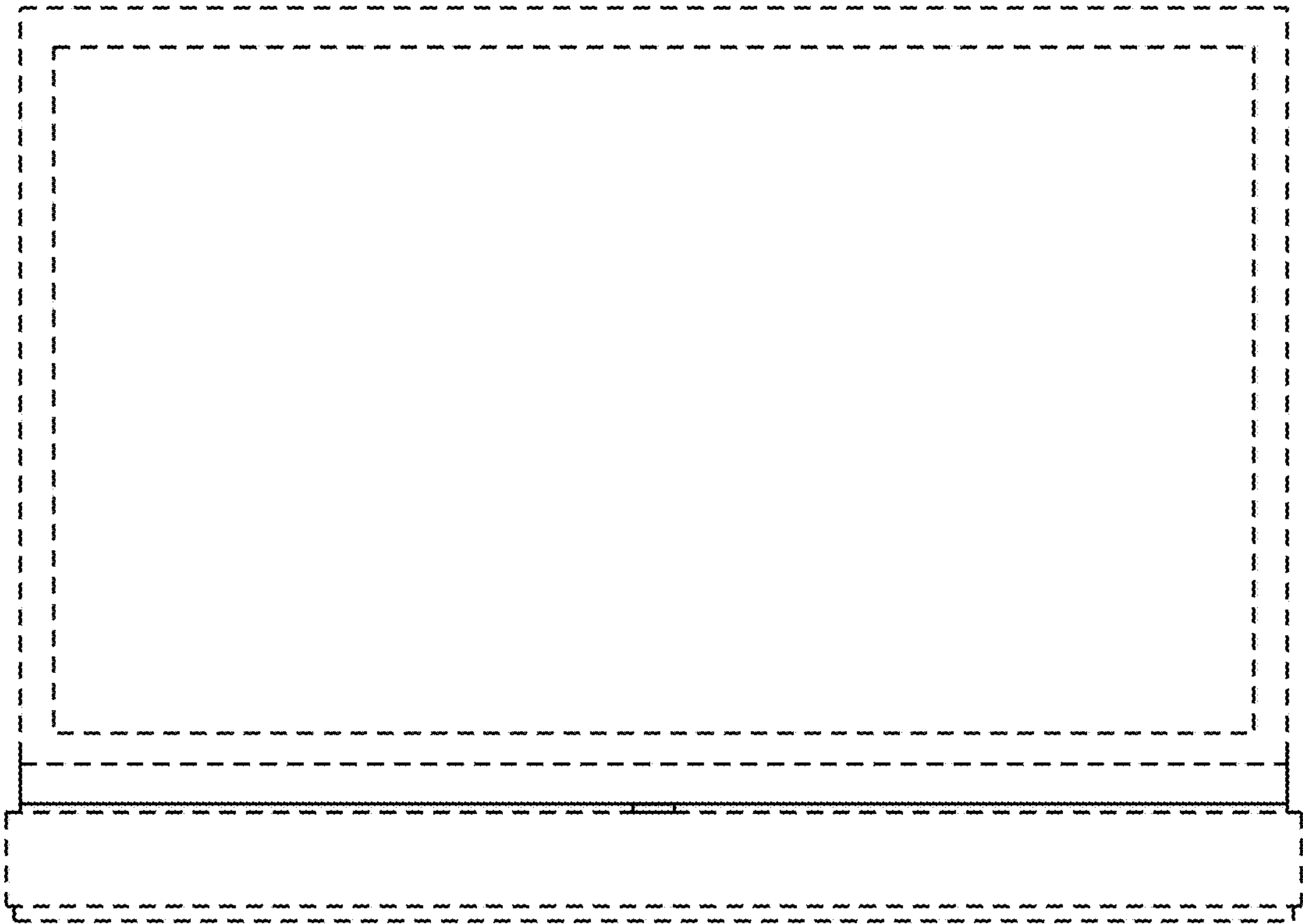

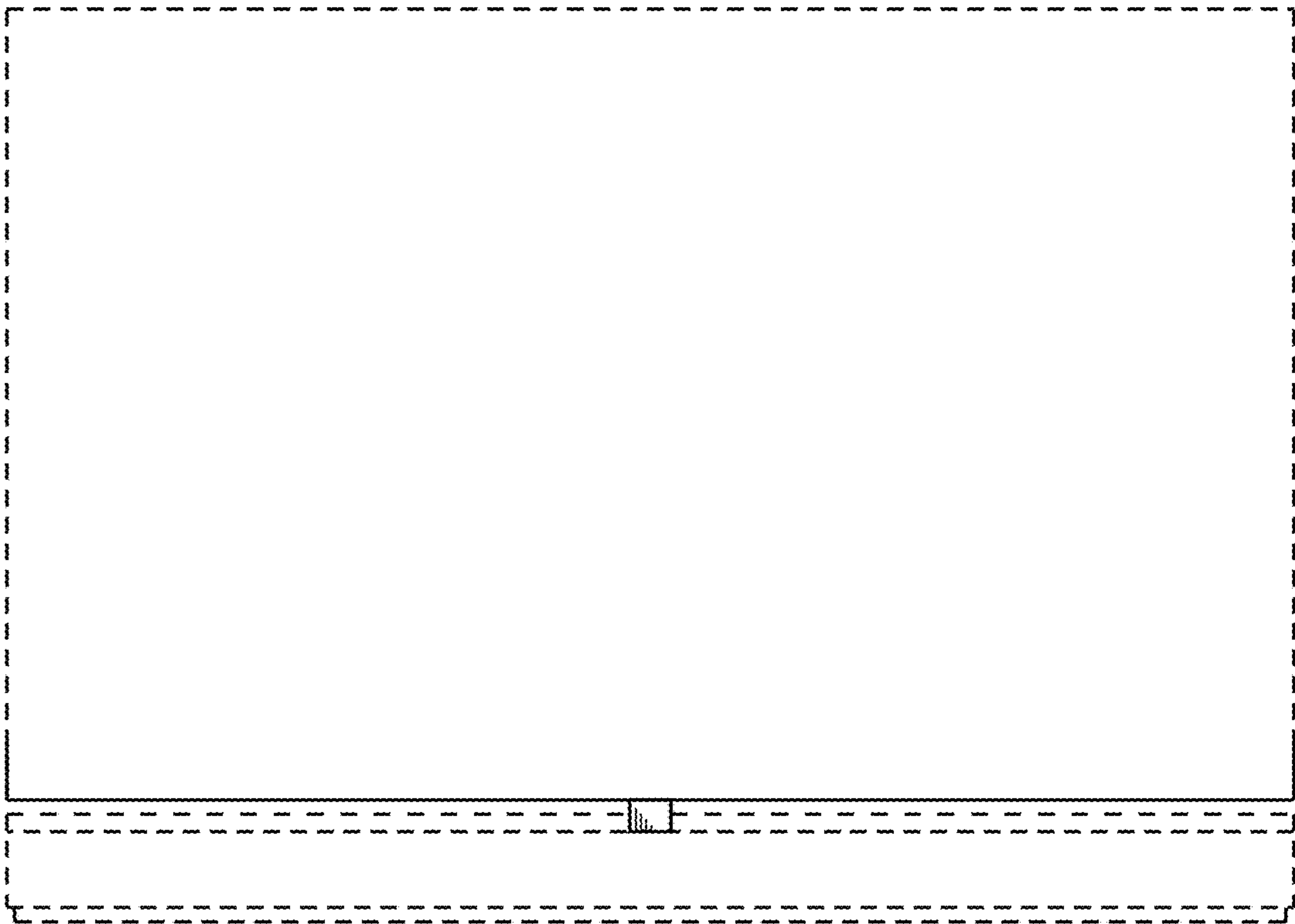

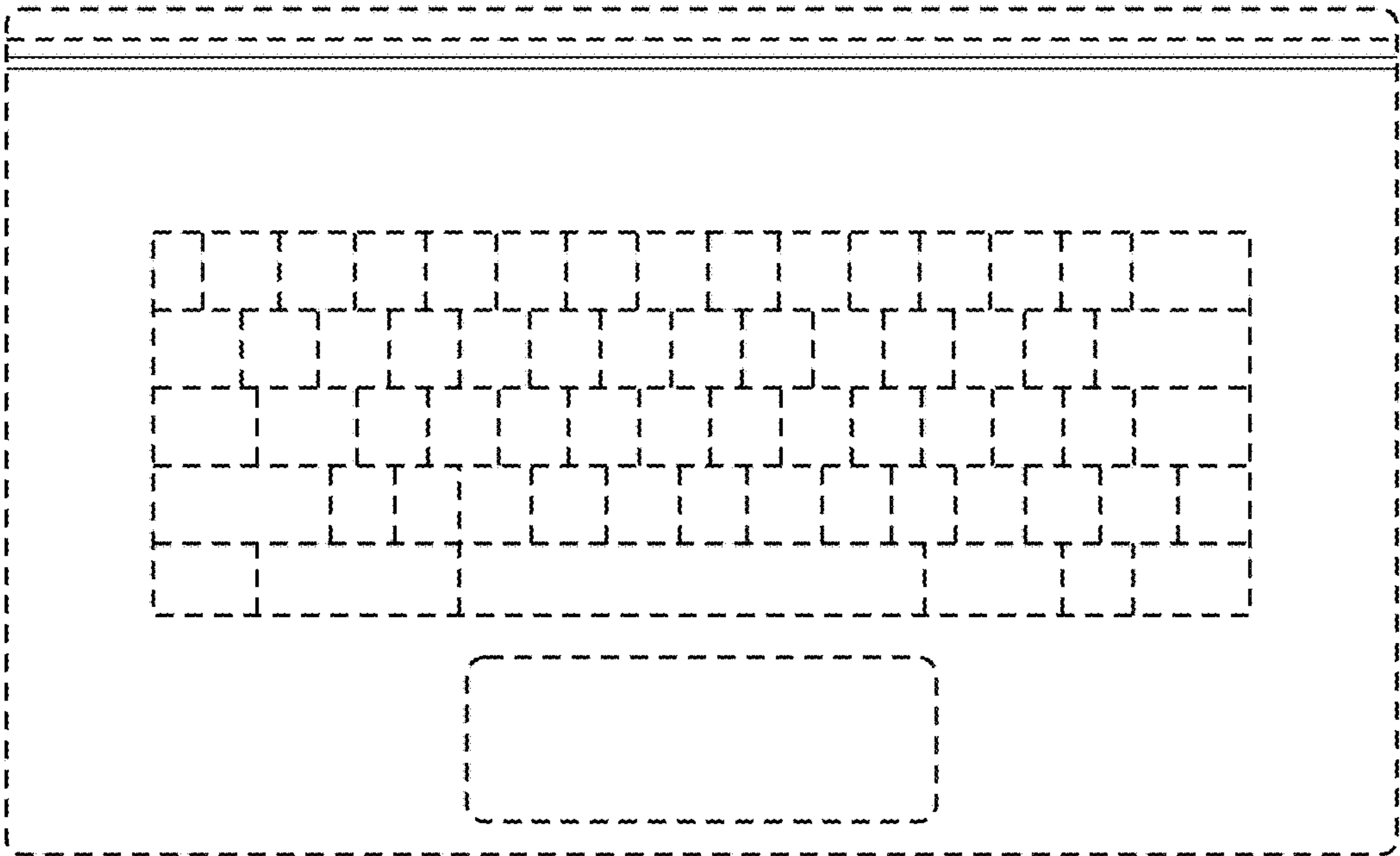

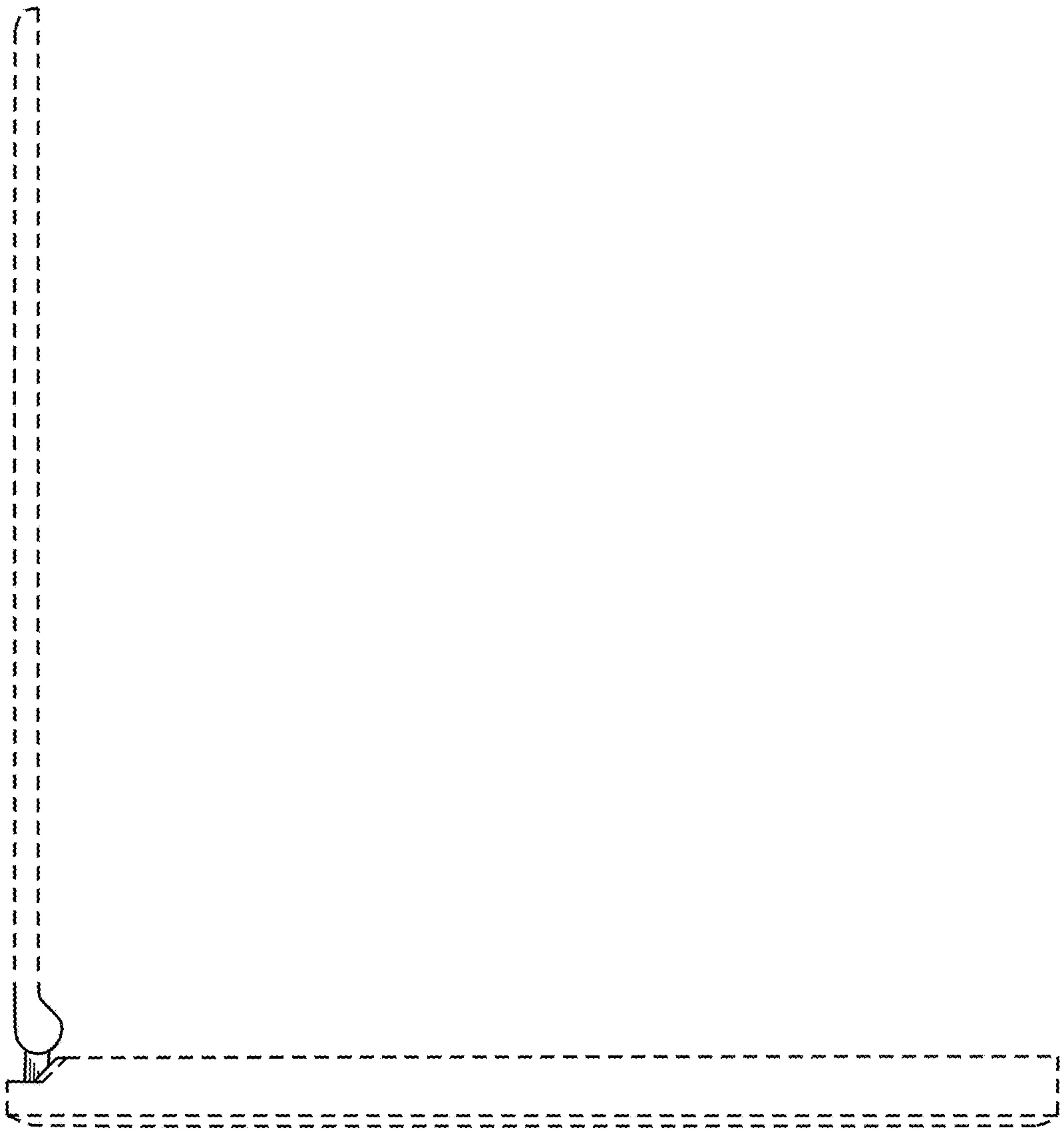

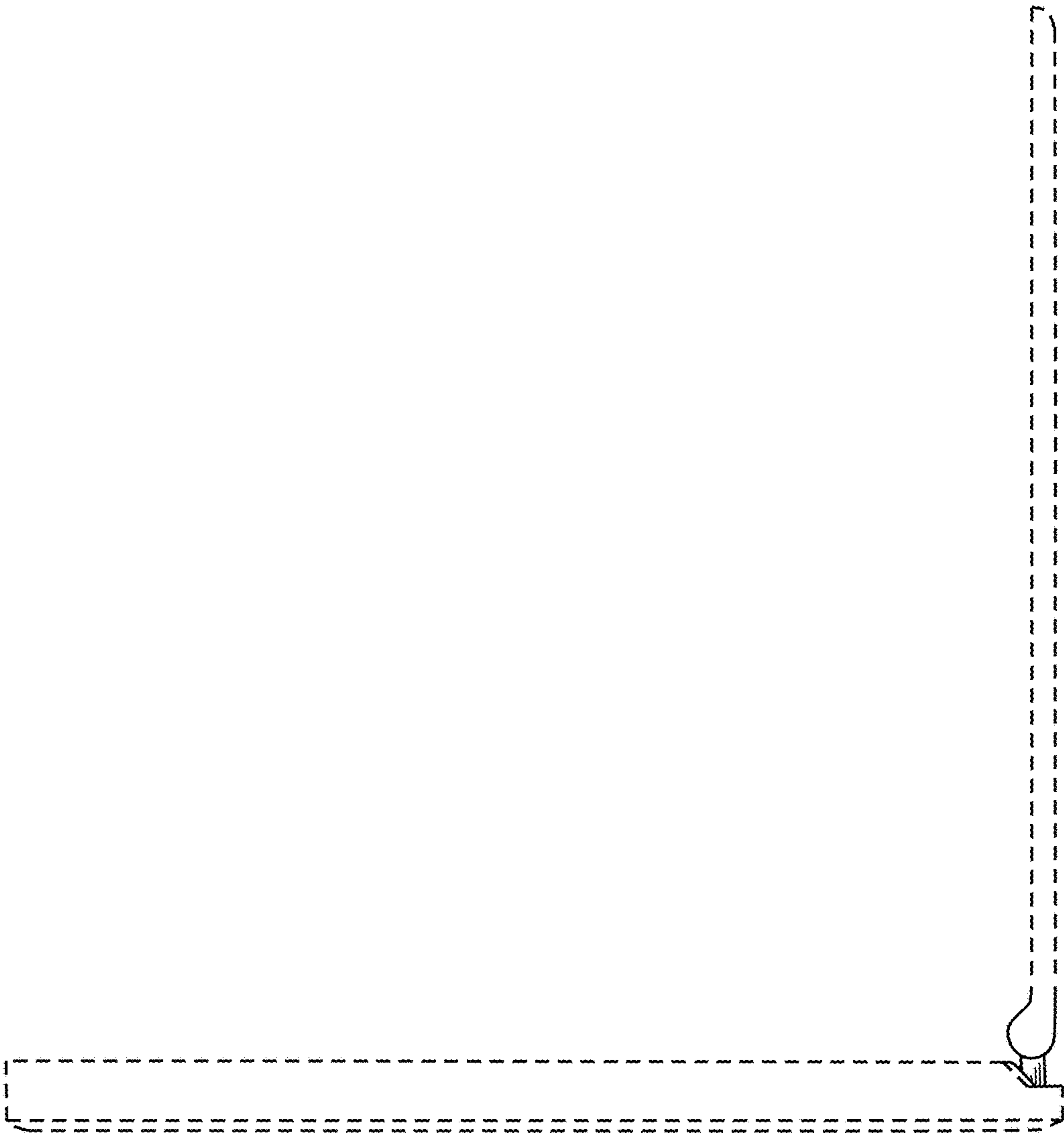

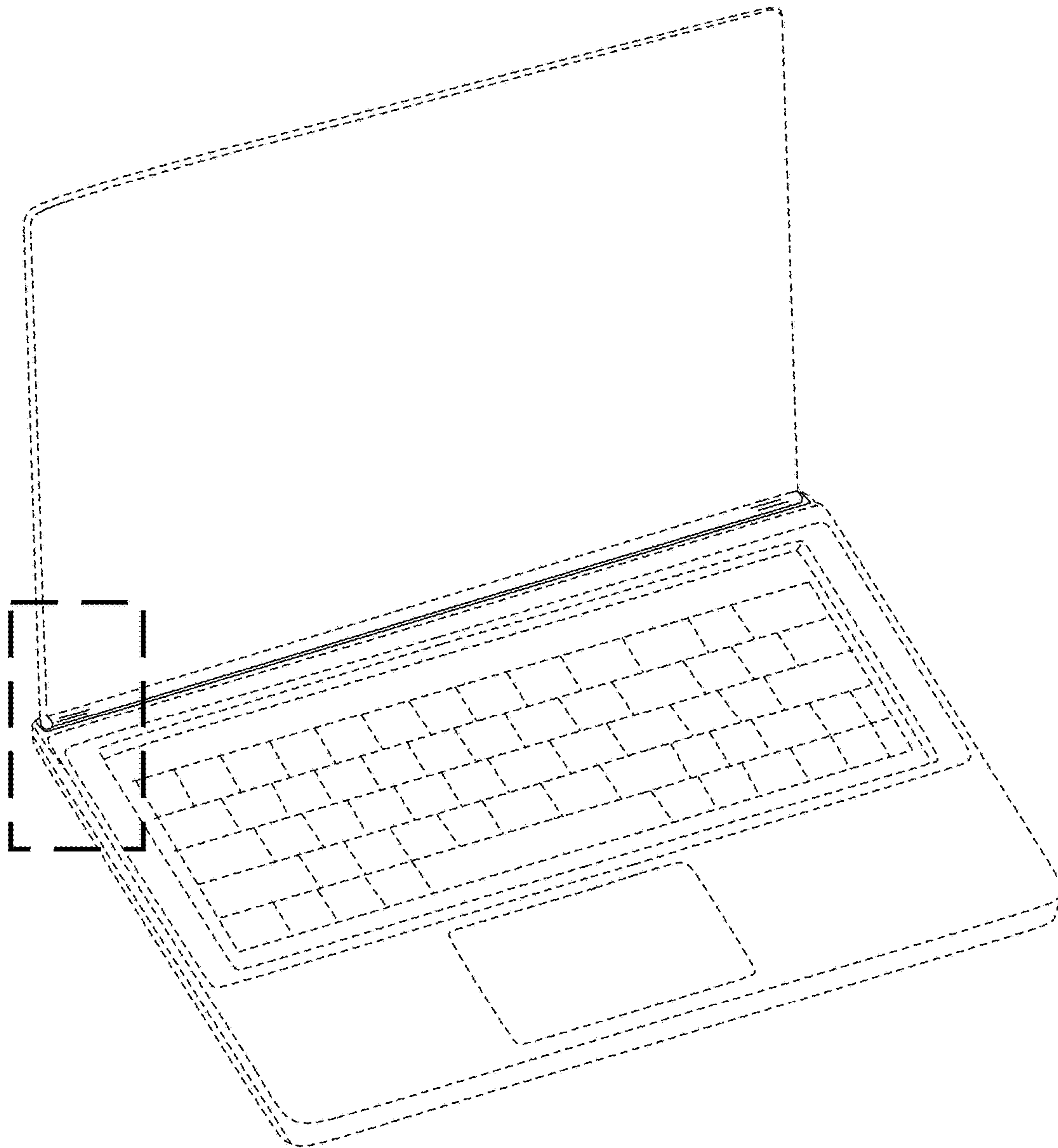

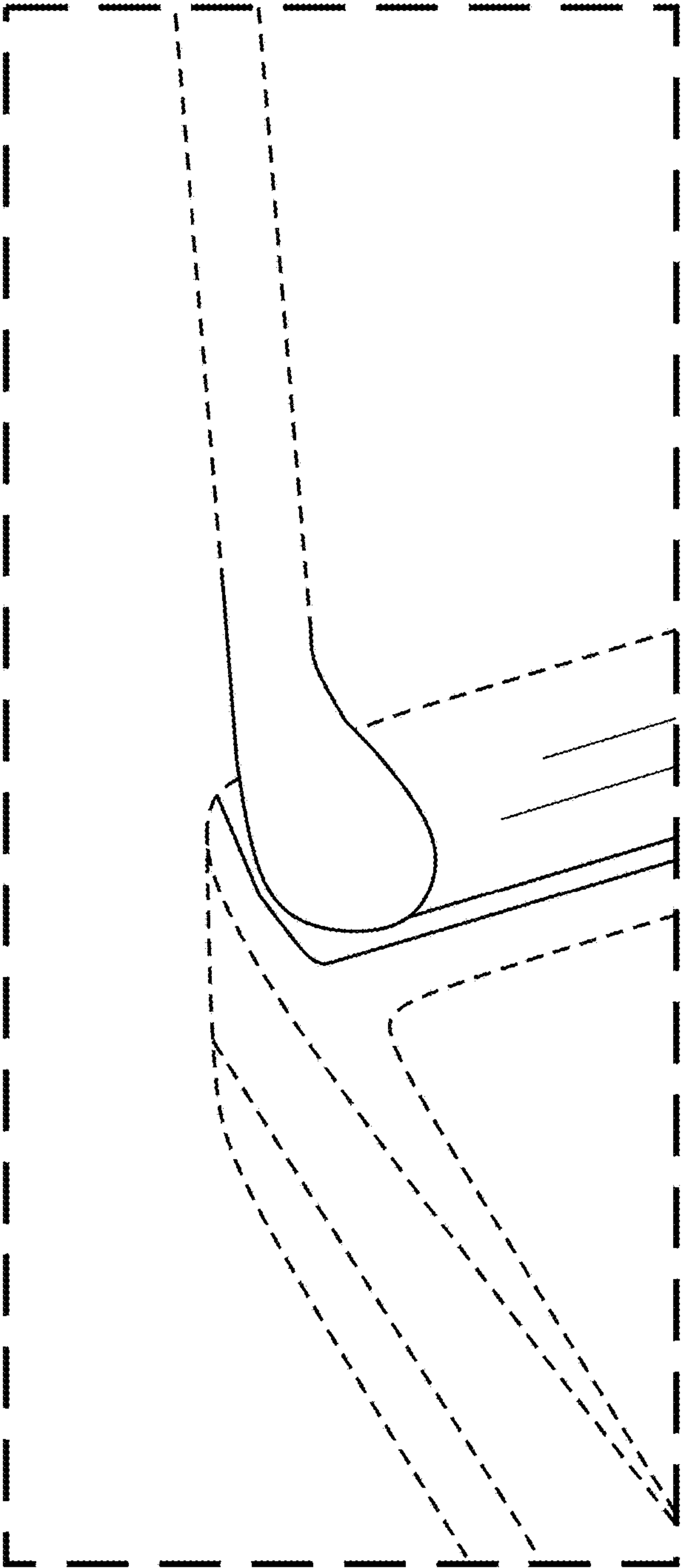

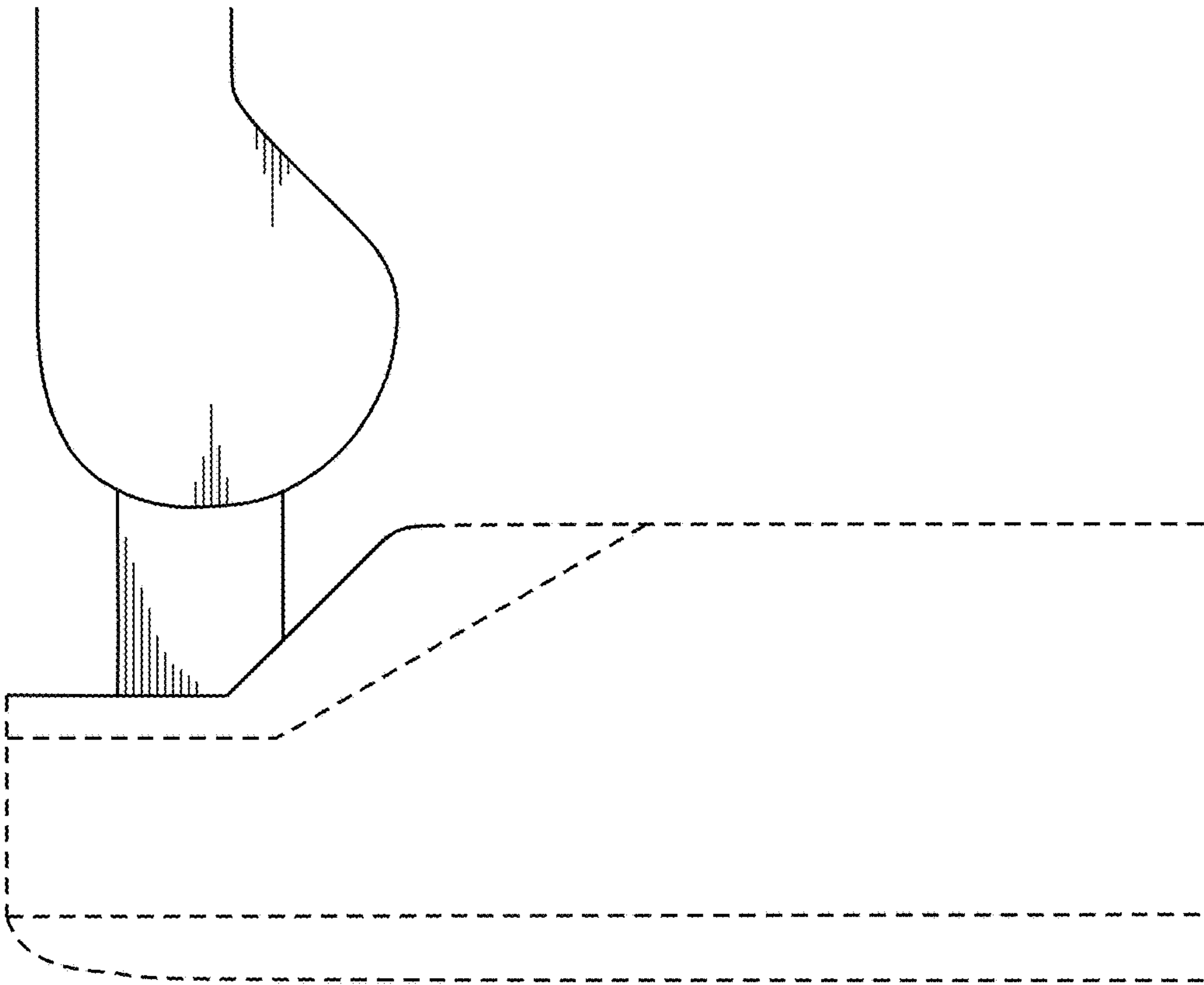

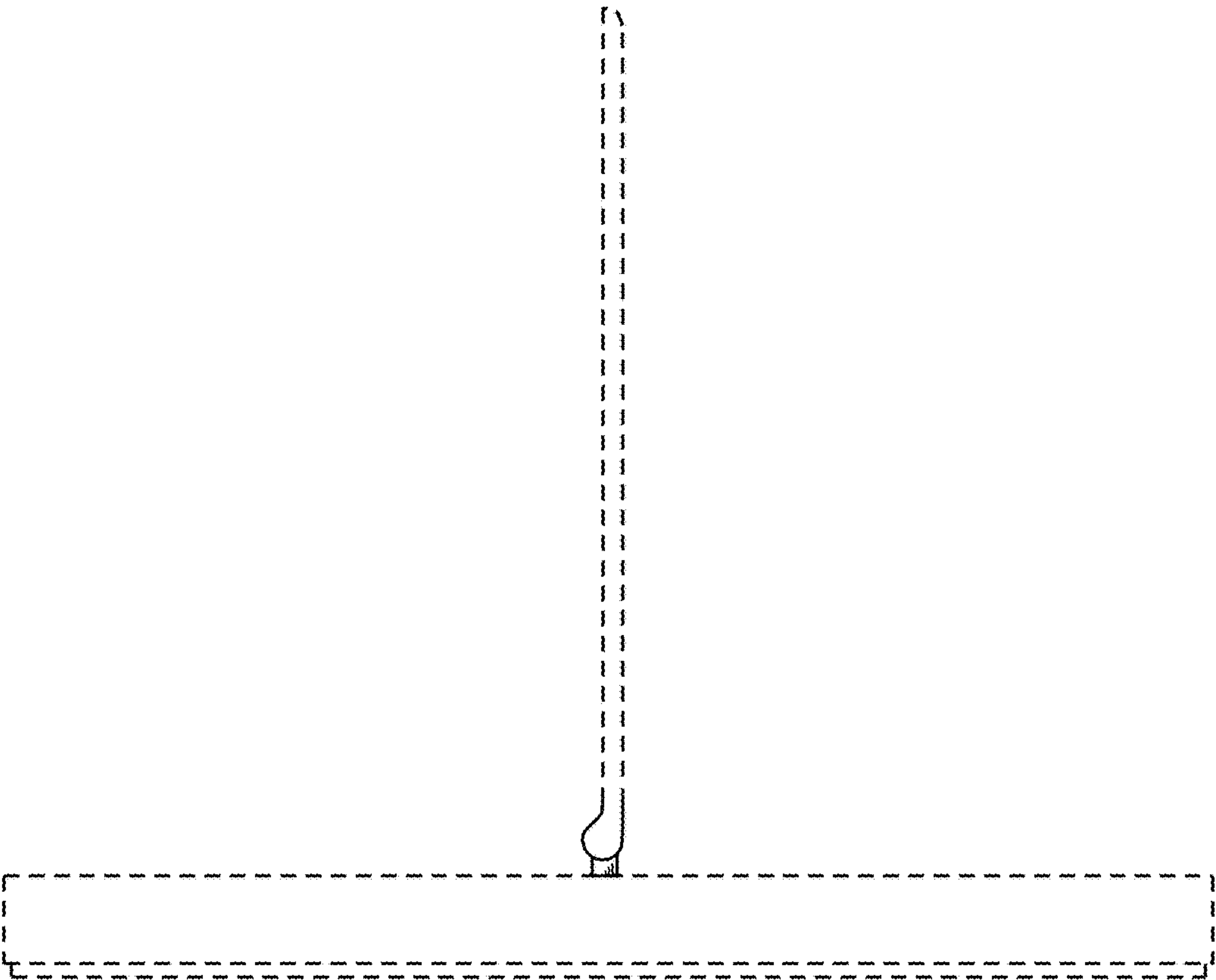

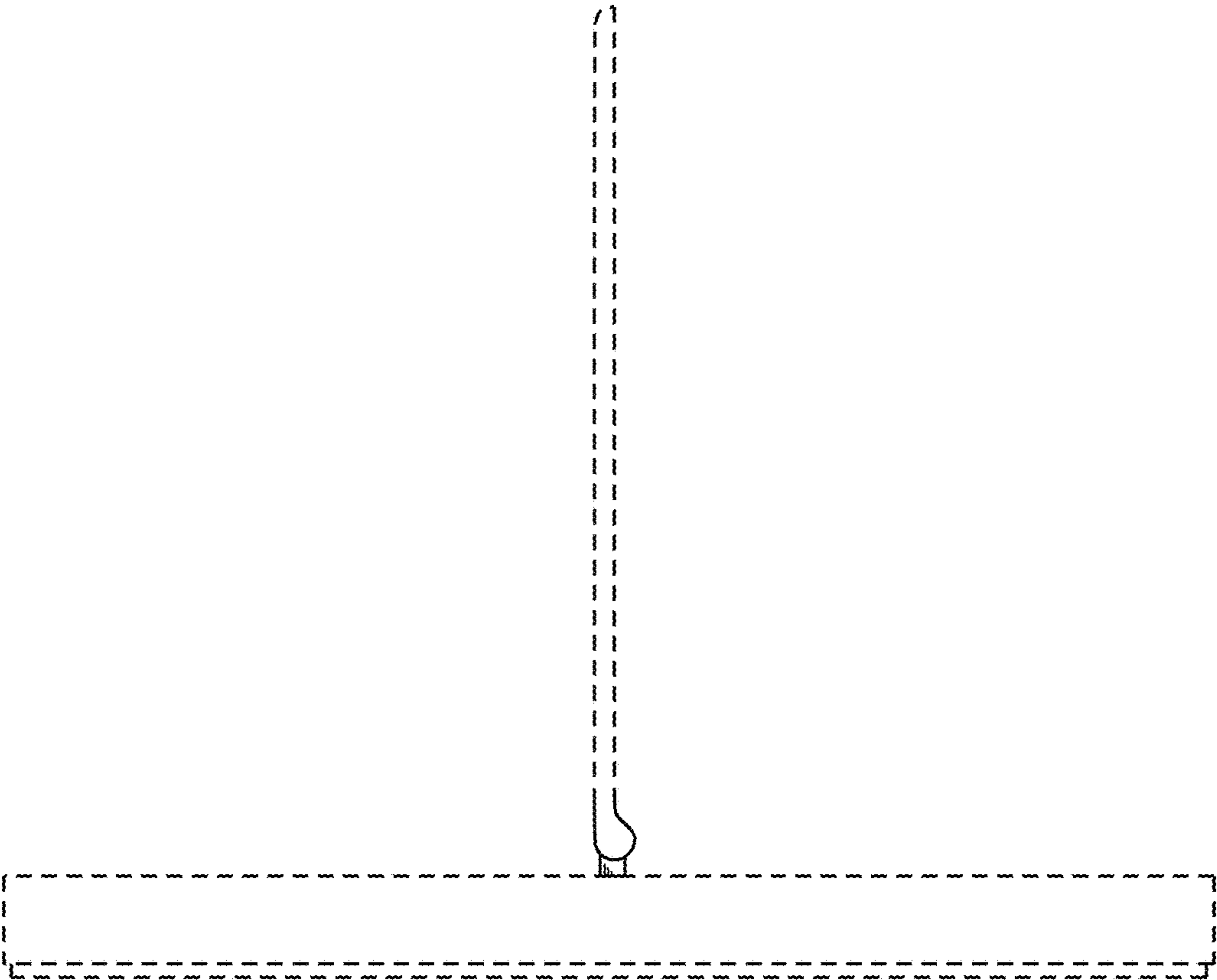
