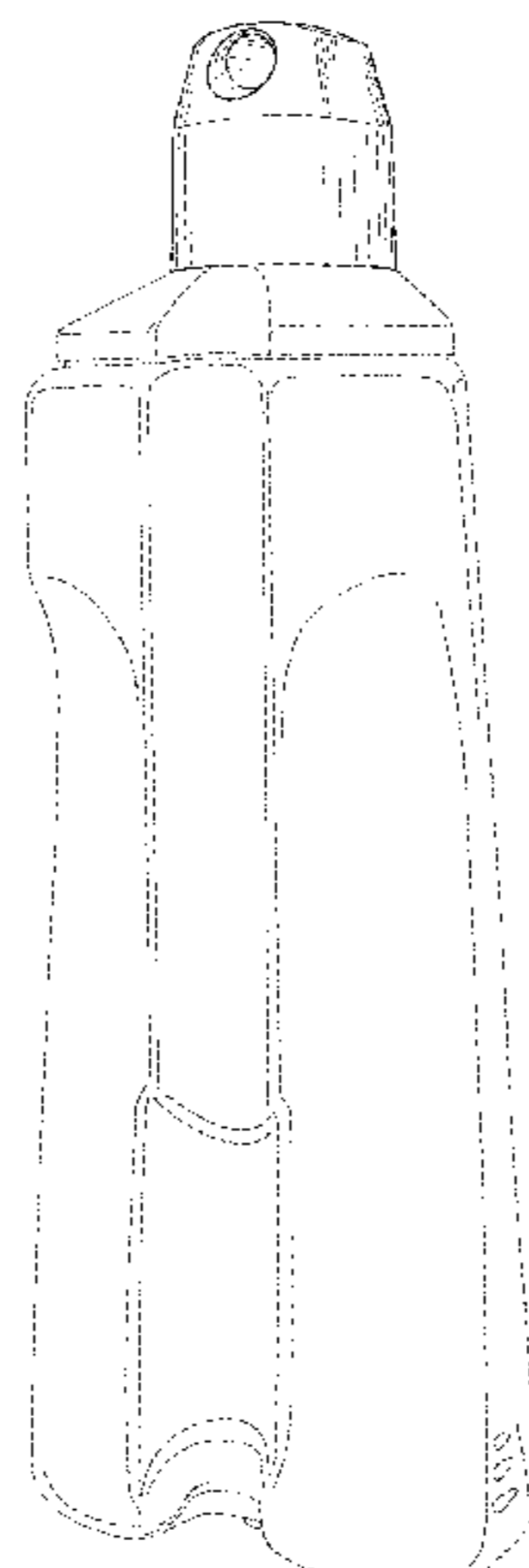
(57) **CLAIM**

The ornamental design for a liquid container bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear isometric view of a liquid container bottle showing our new design;  
FIG. 2 is a top isometric view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a front elevation view thereof;  
FIG. 5 is a right side elevation view thereof of which the left side elevation view is a mirror image;

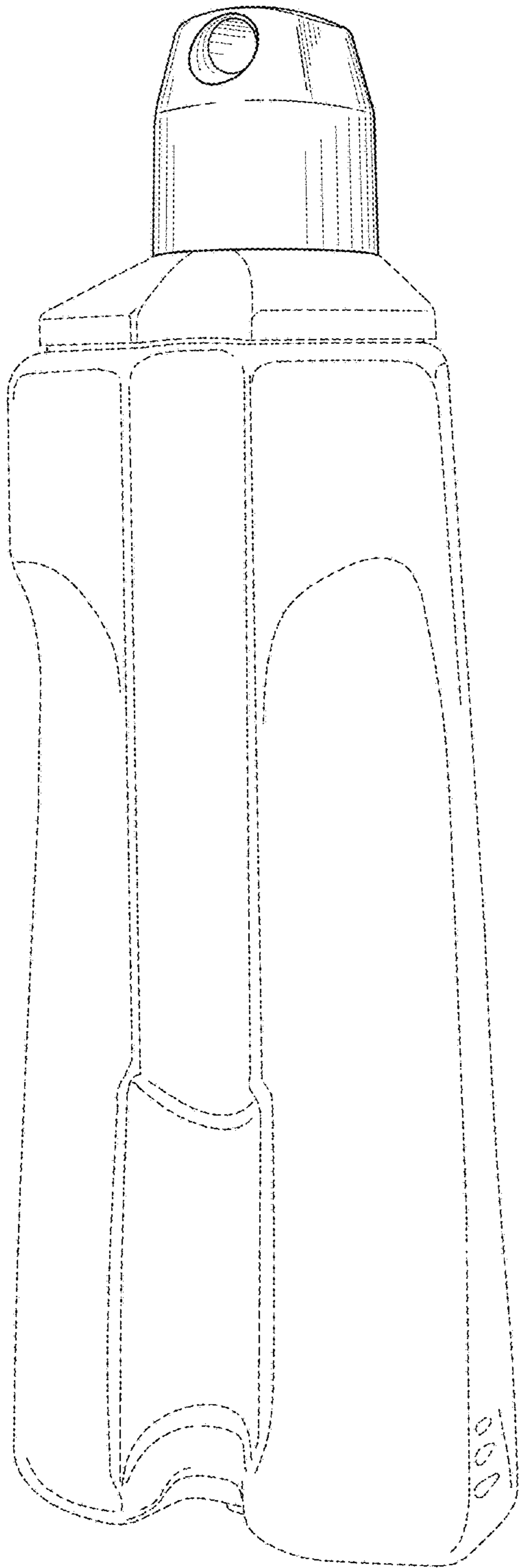

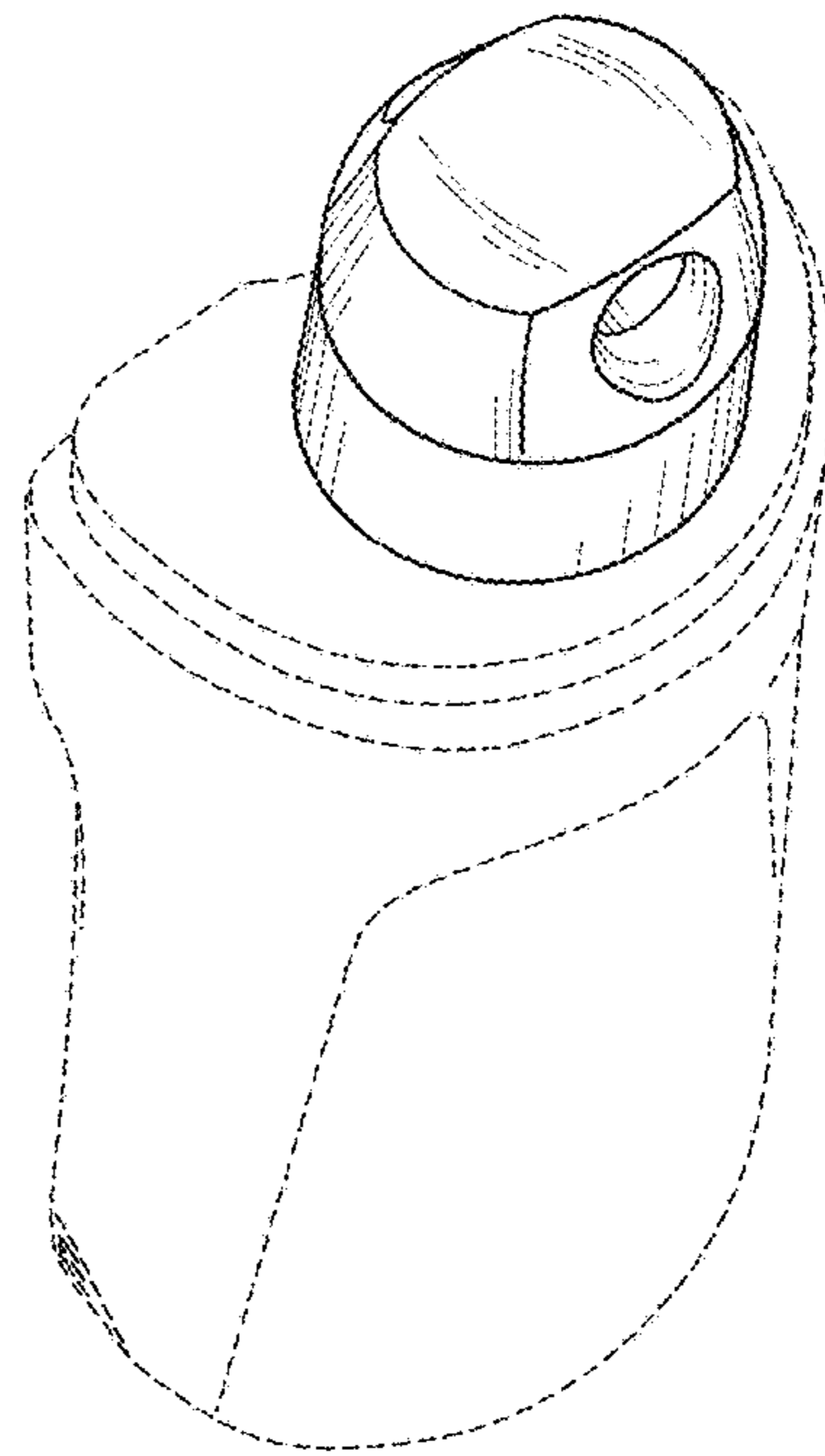

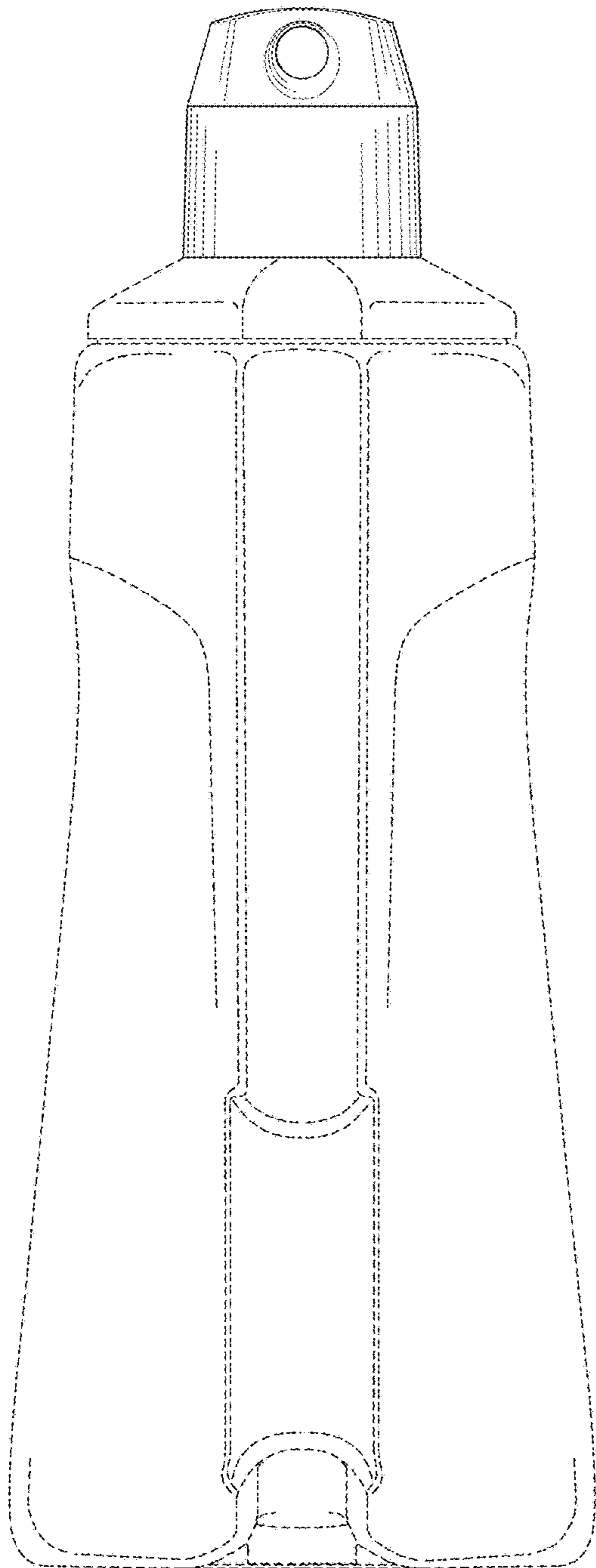

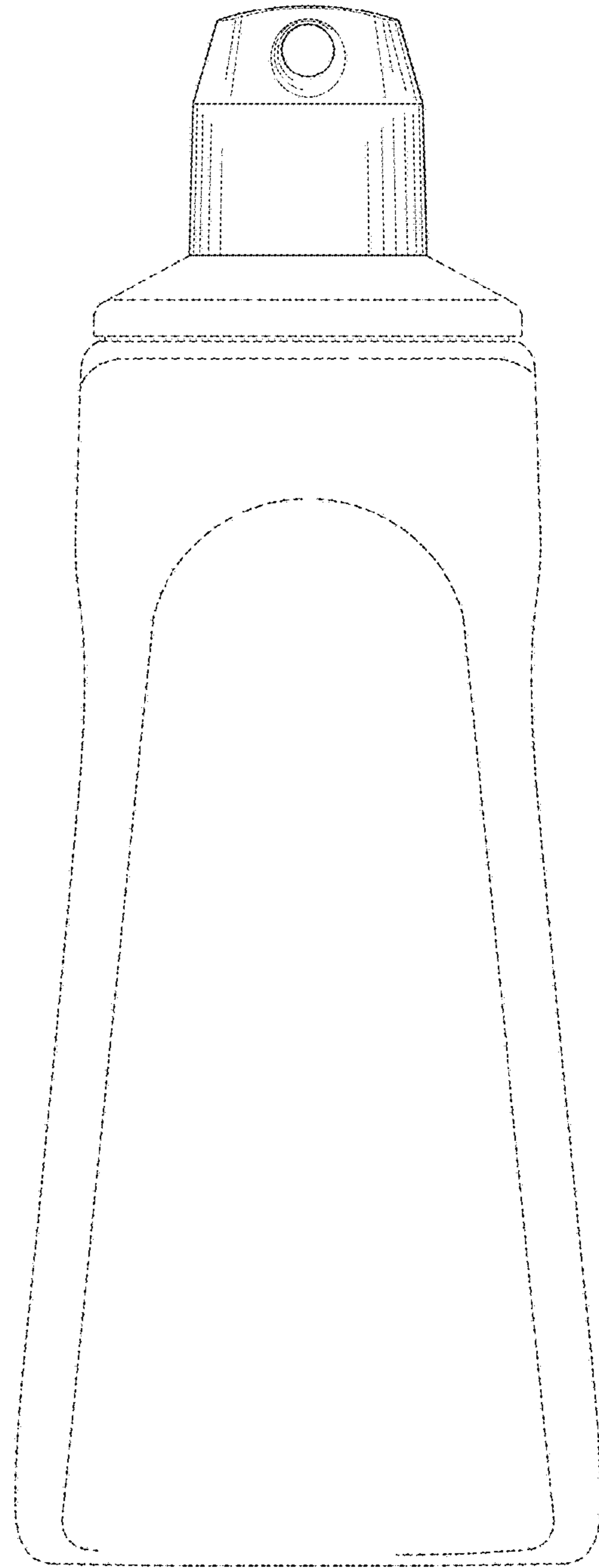

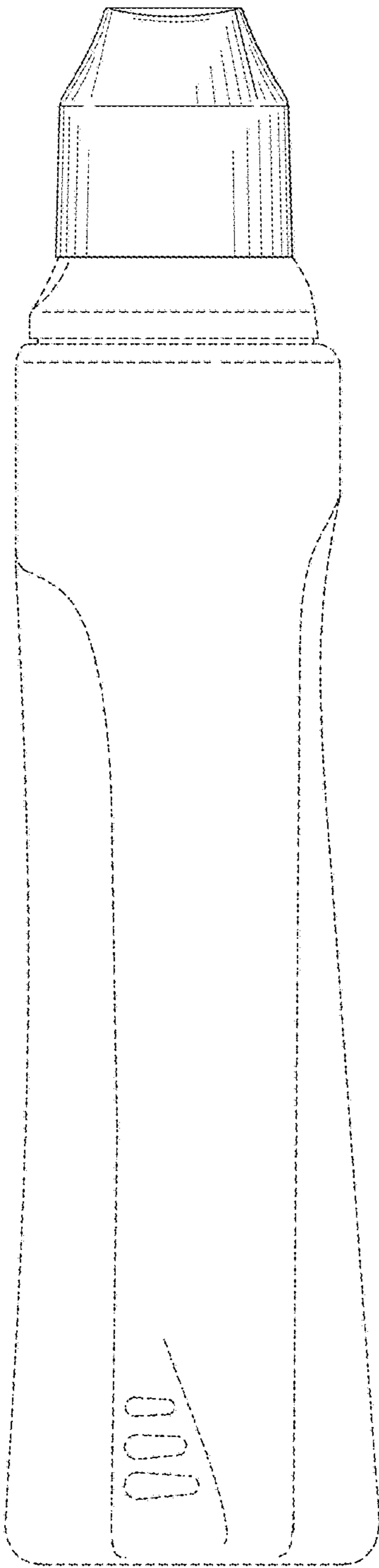

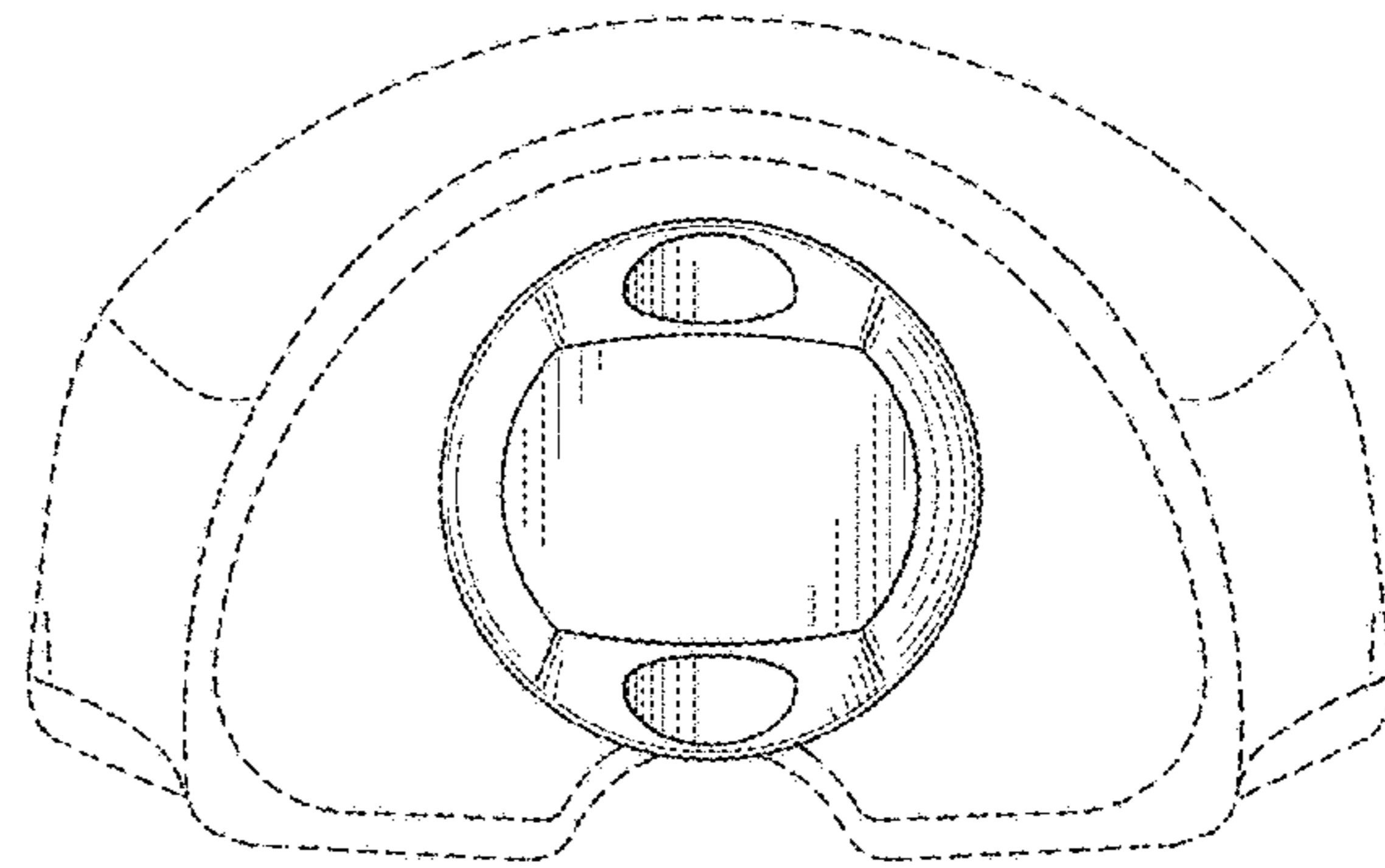

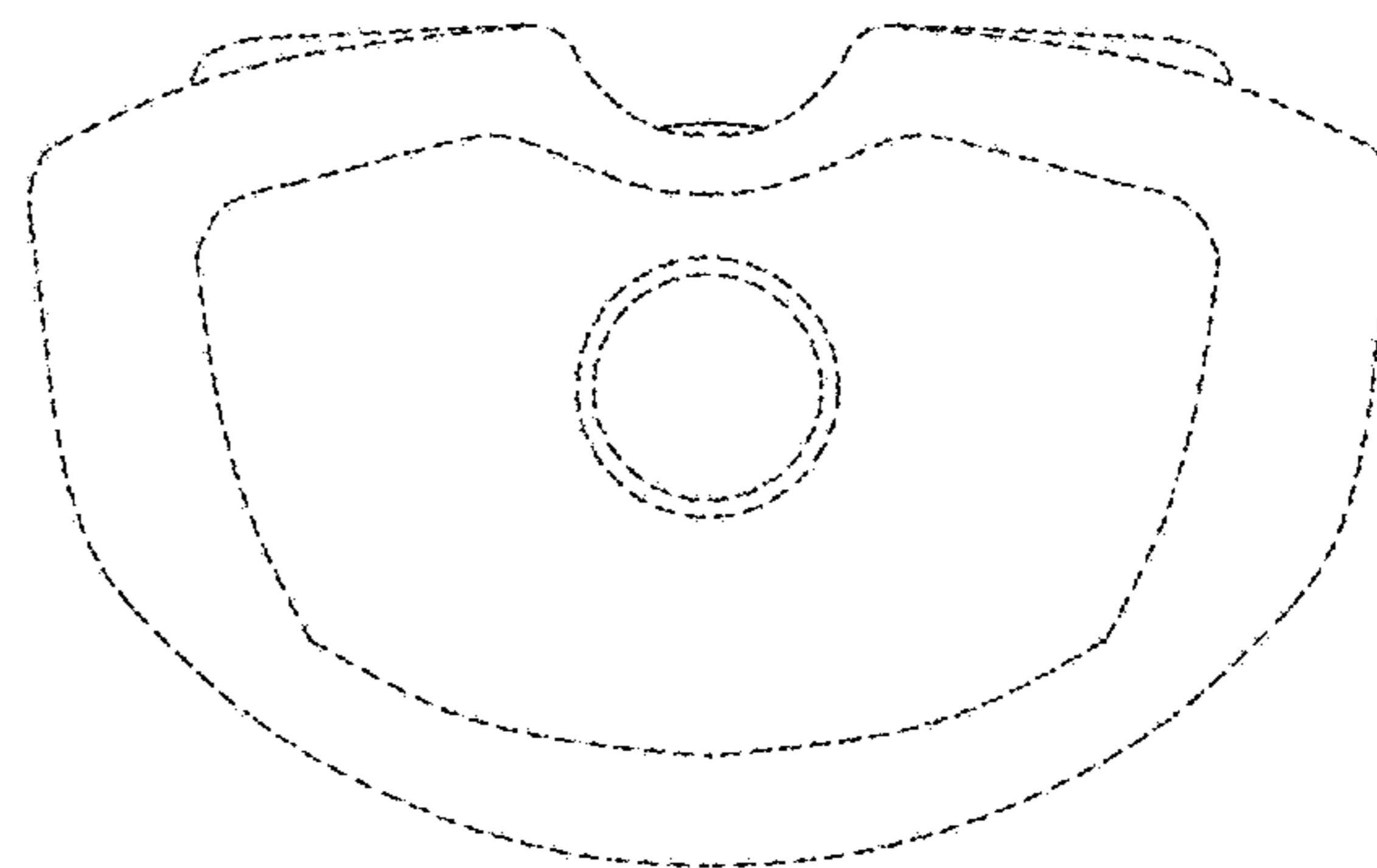
