We claim the ornamental design for a dimple bottle, as shown and described.

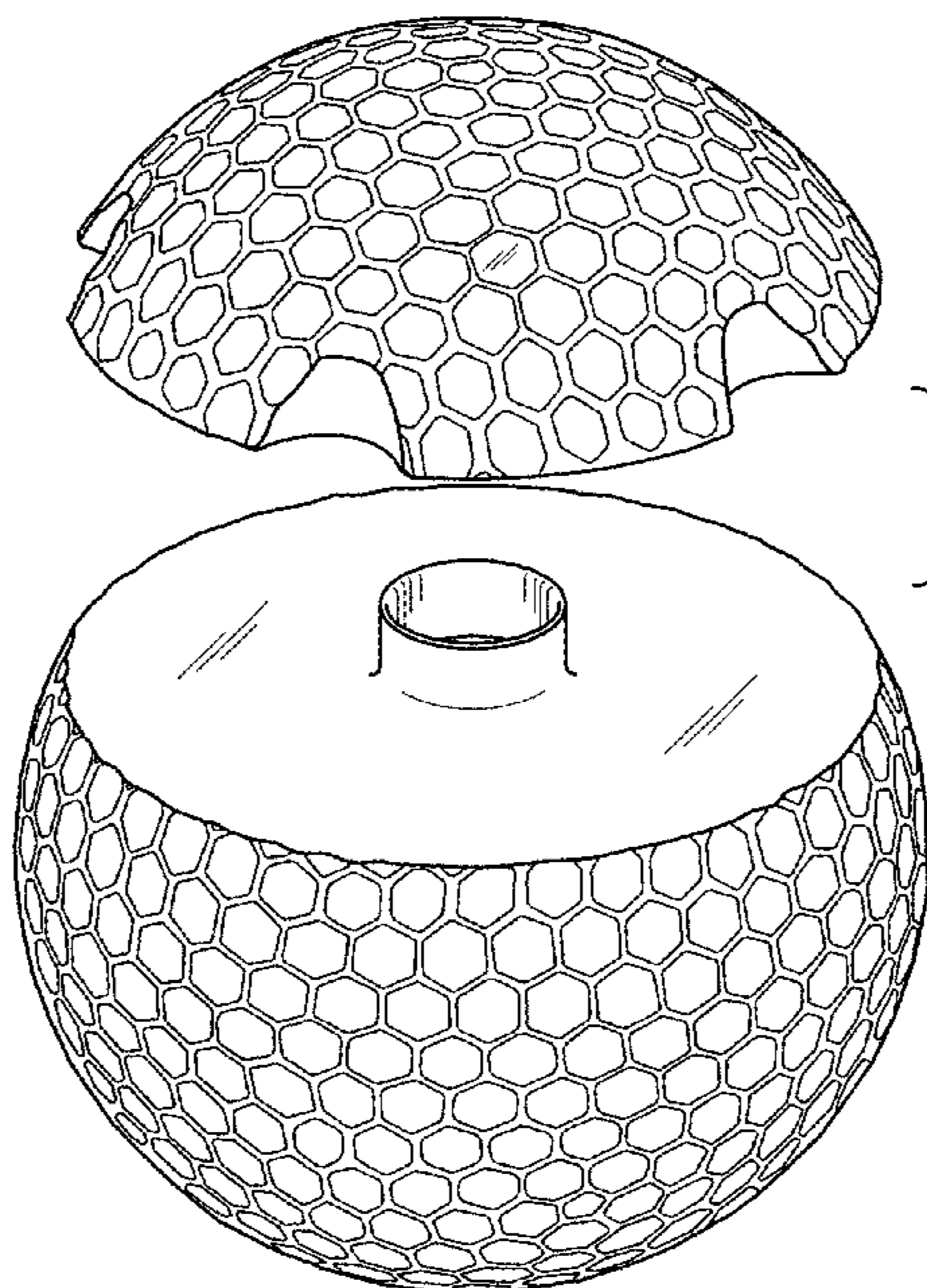
DESCRIPTION

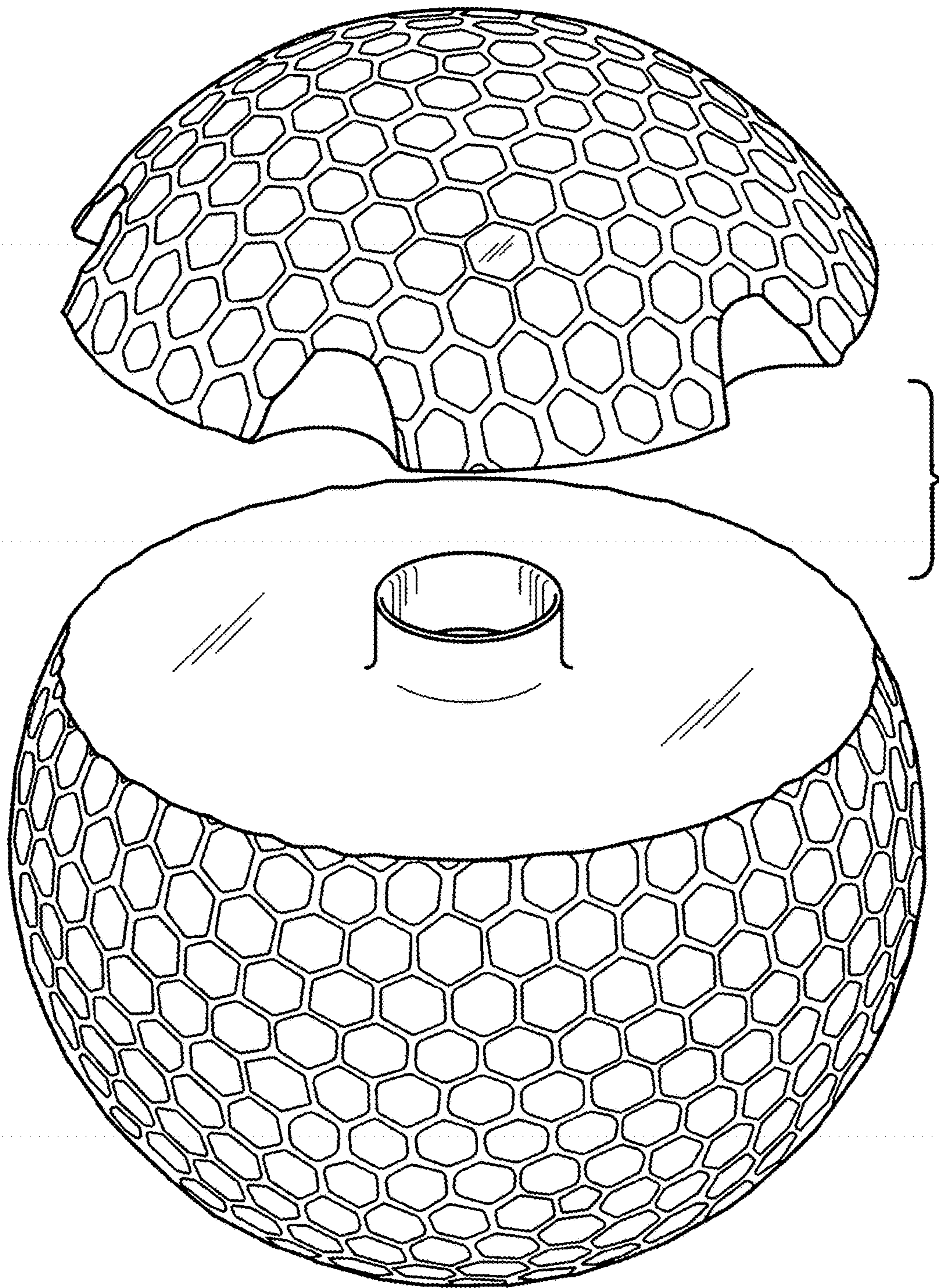

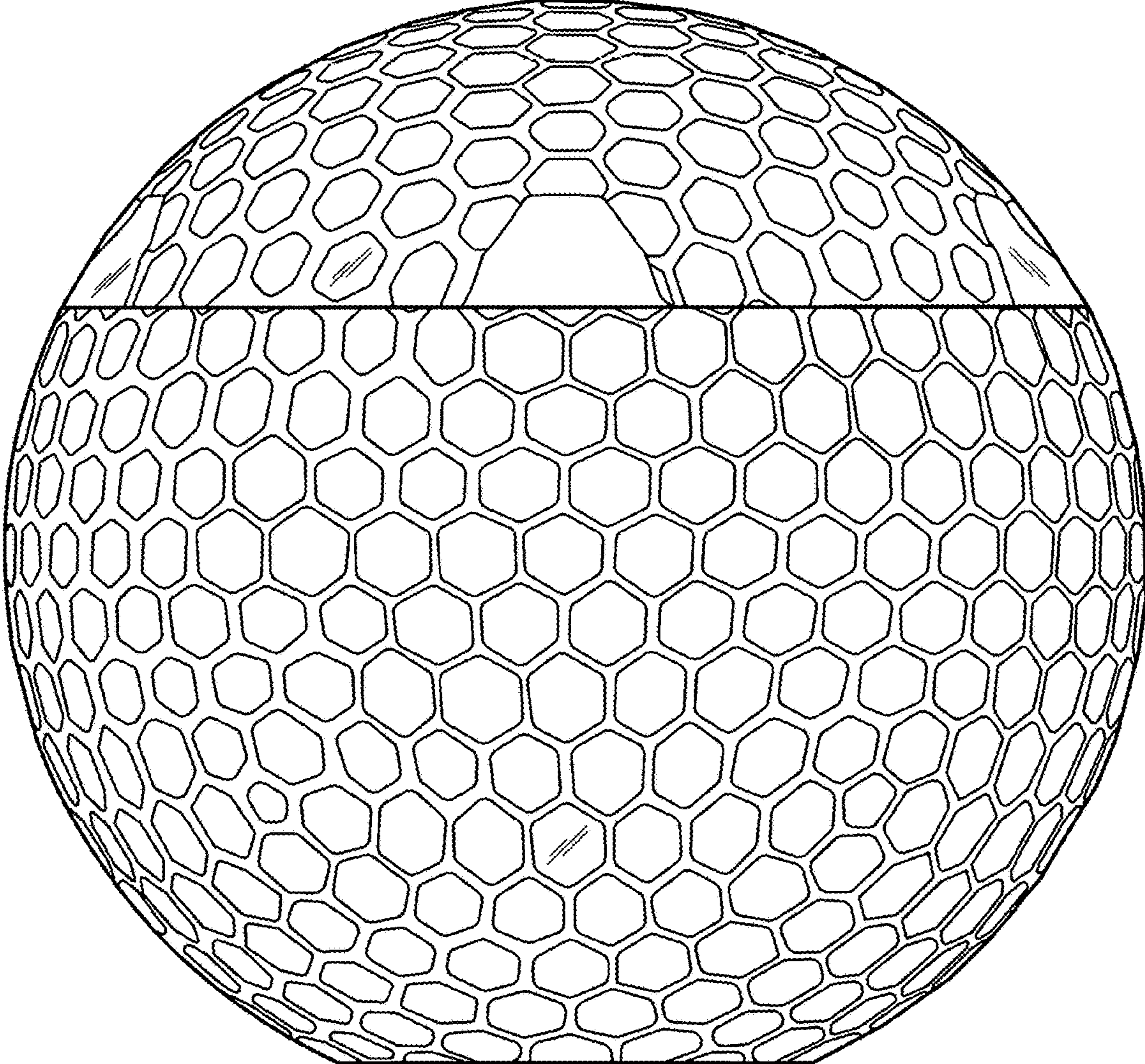

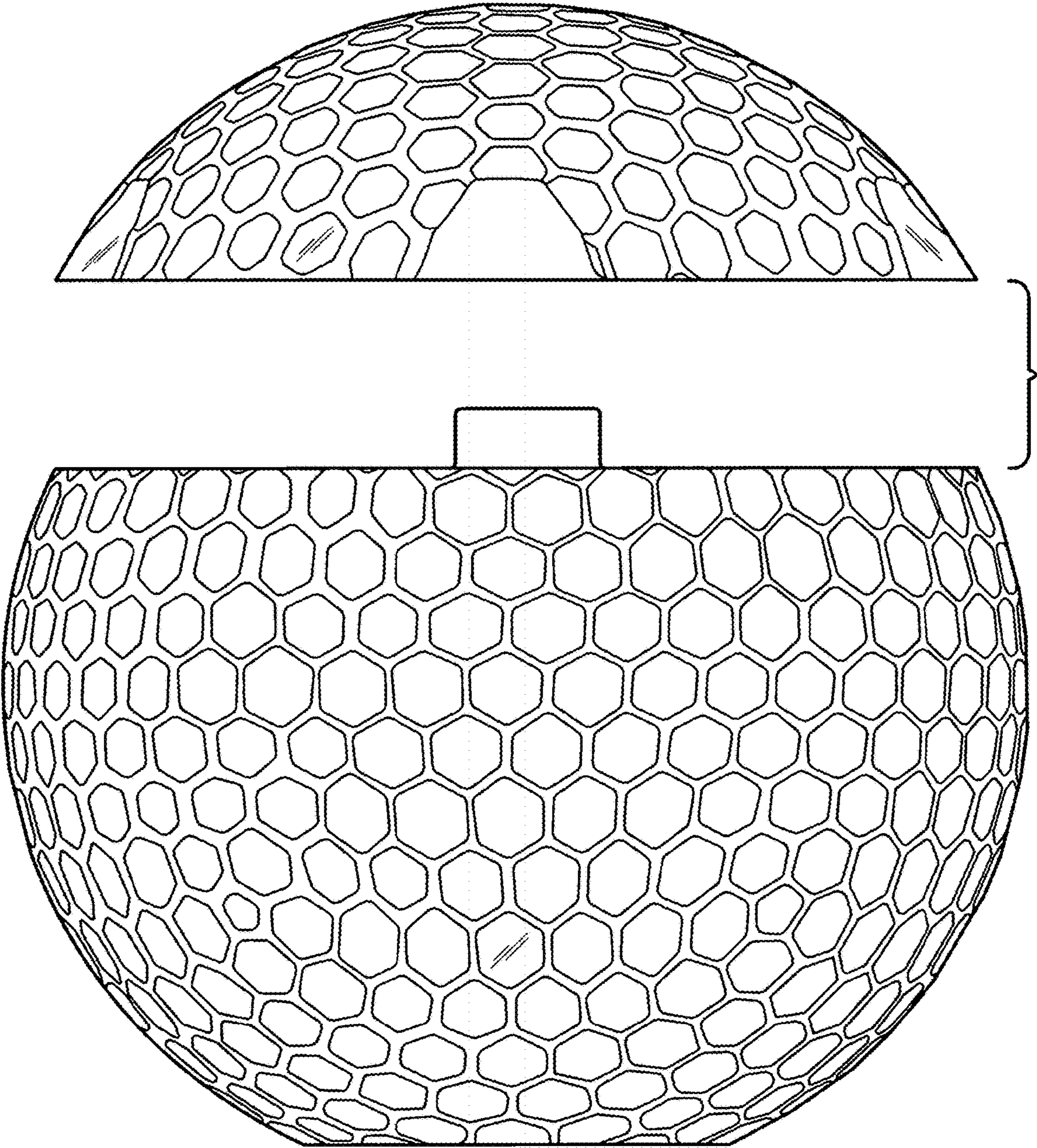
