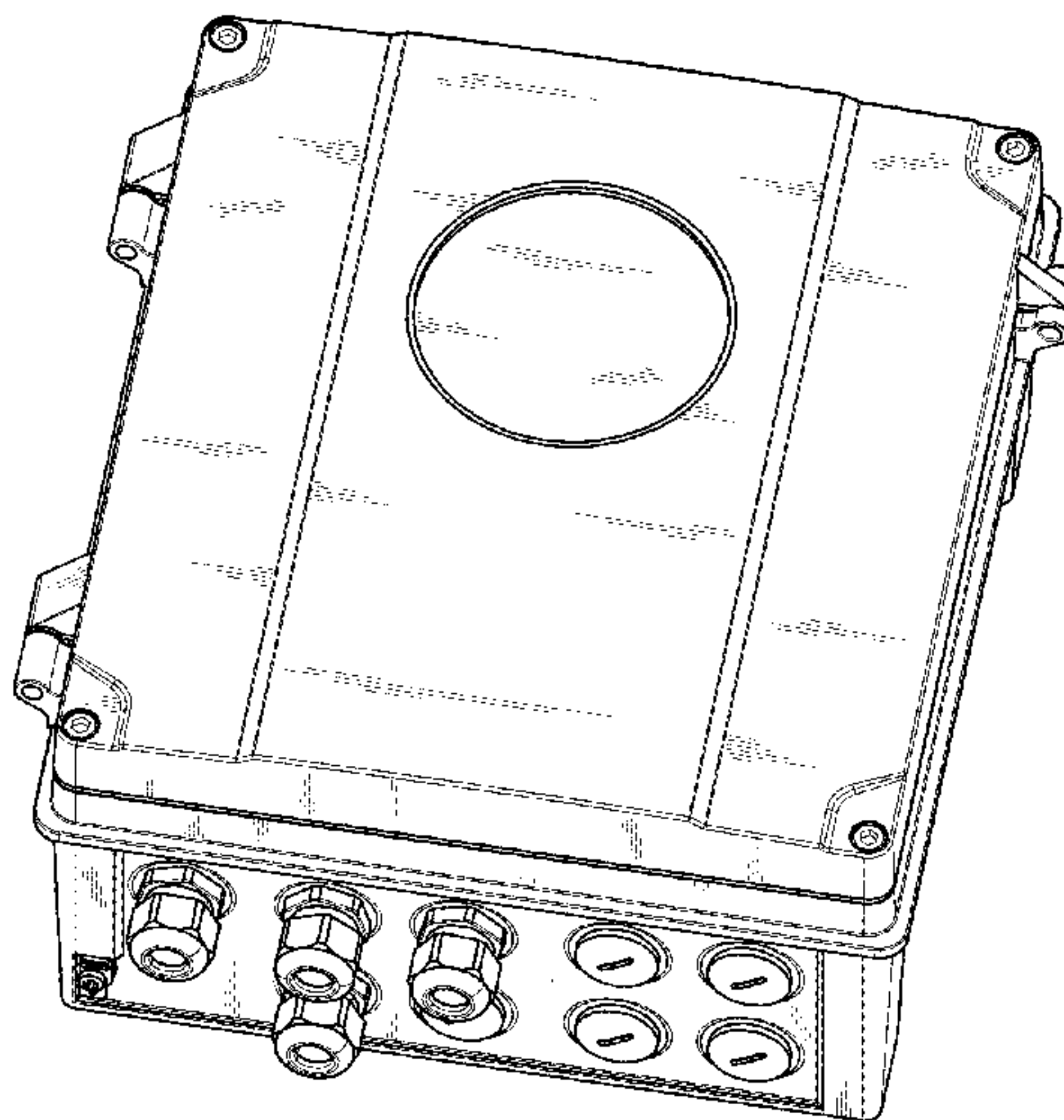
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of an enclosure showing our new design;  
FIG. 2 is a back elevational view thereof;

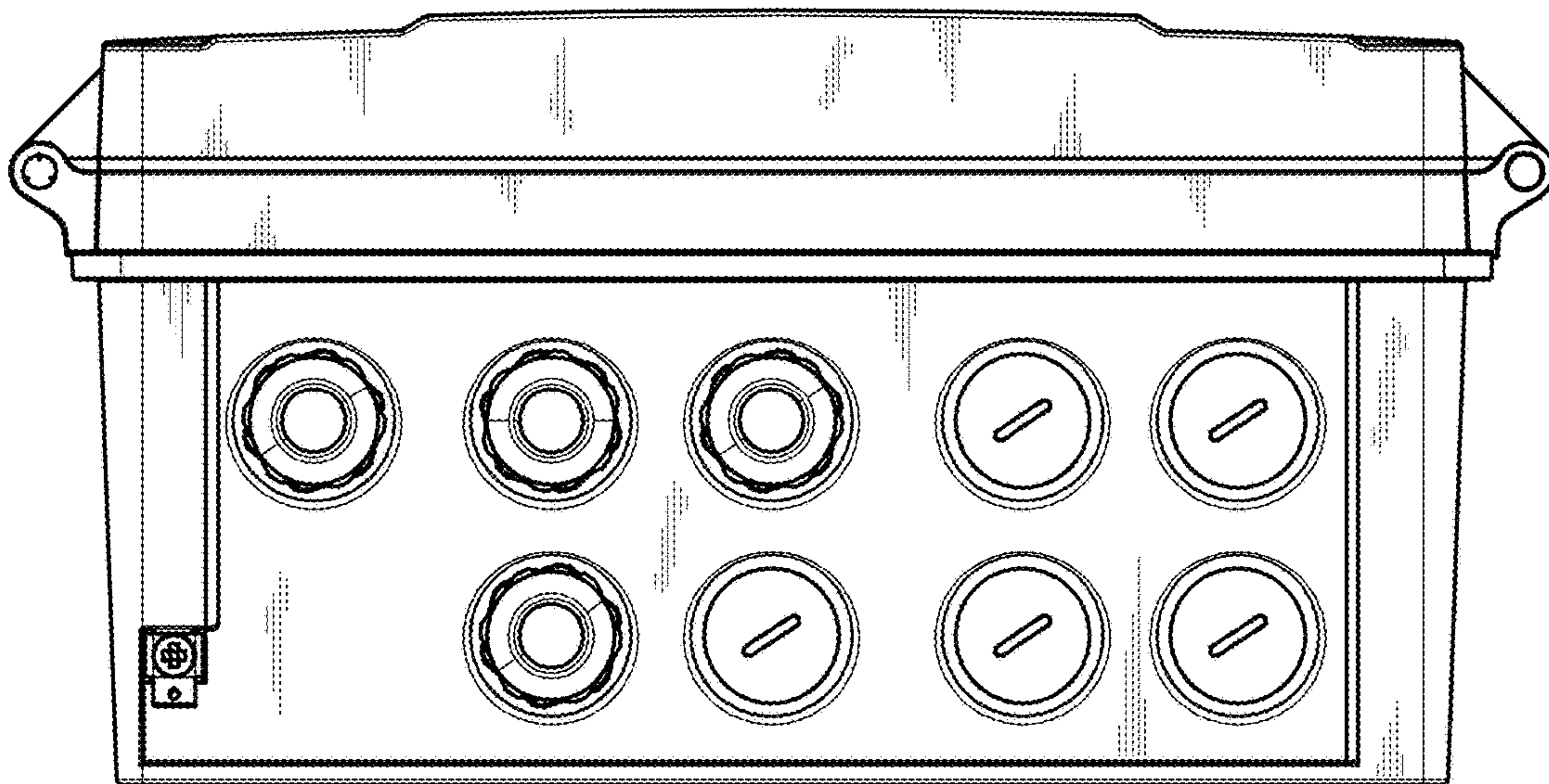

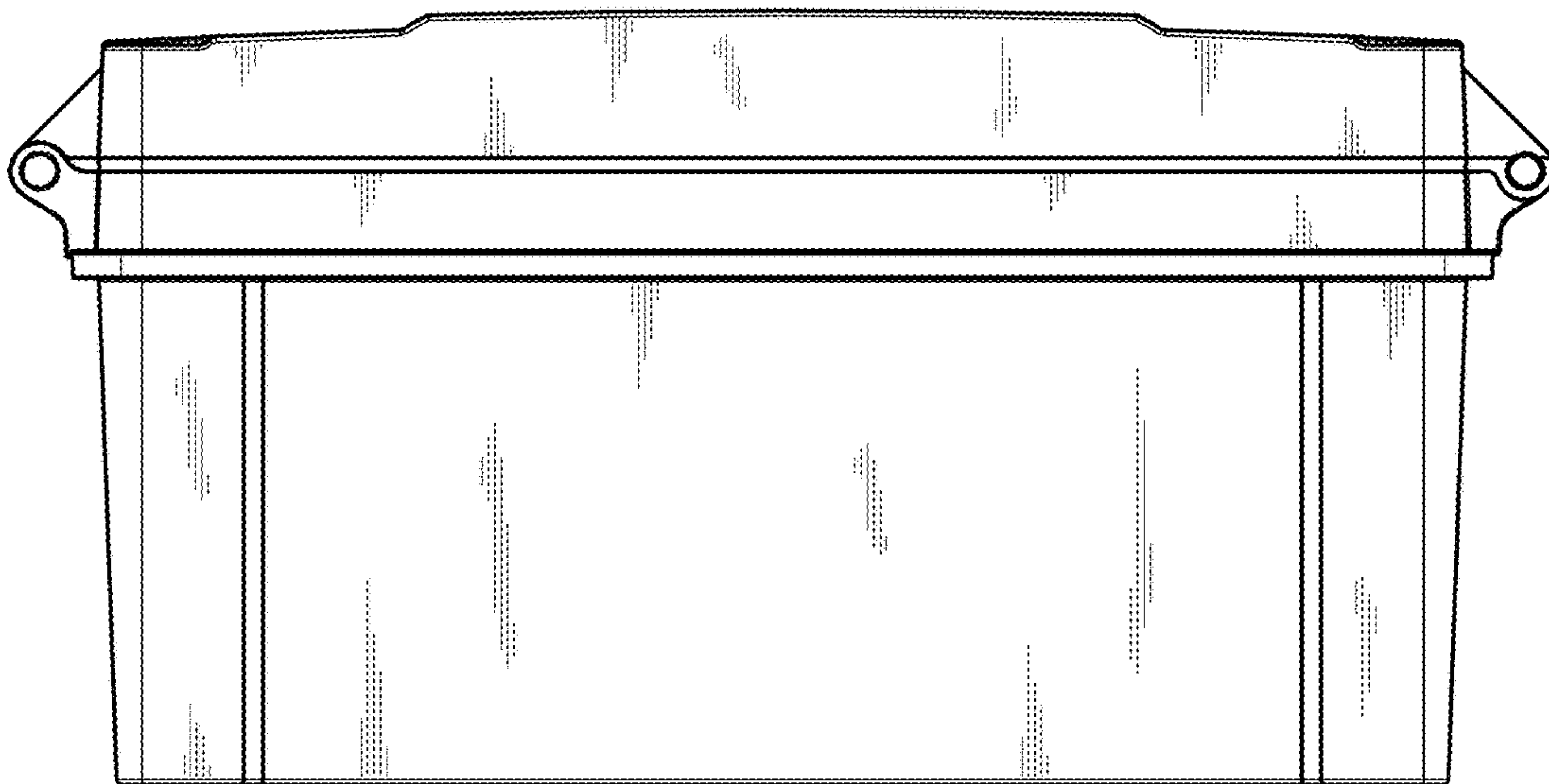

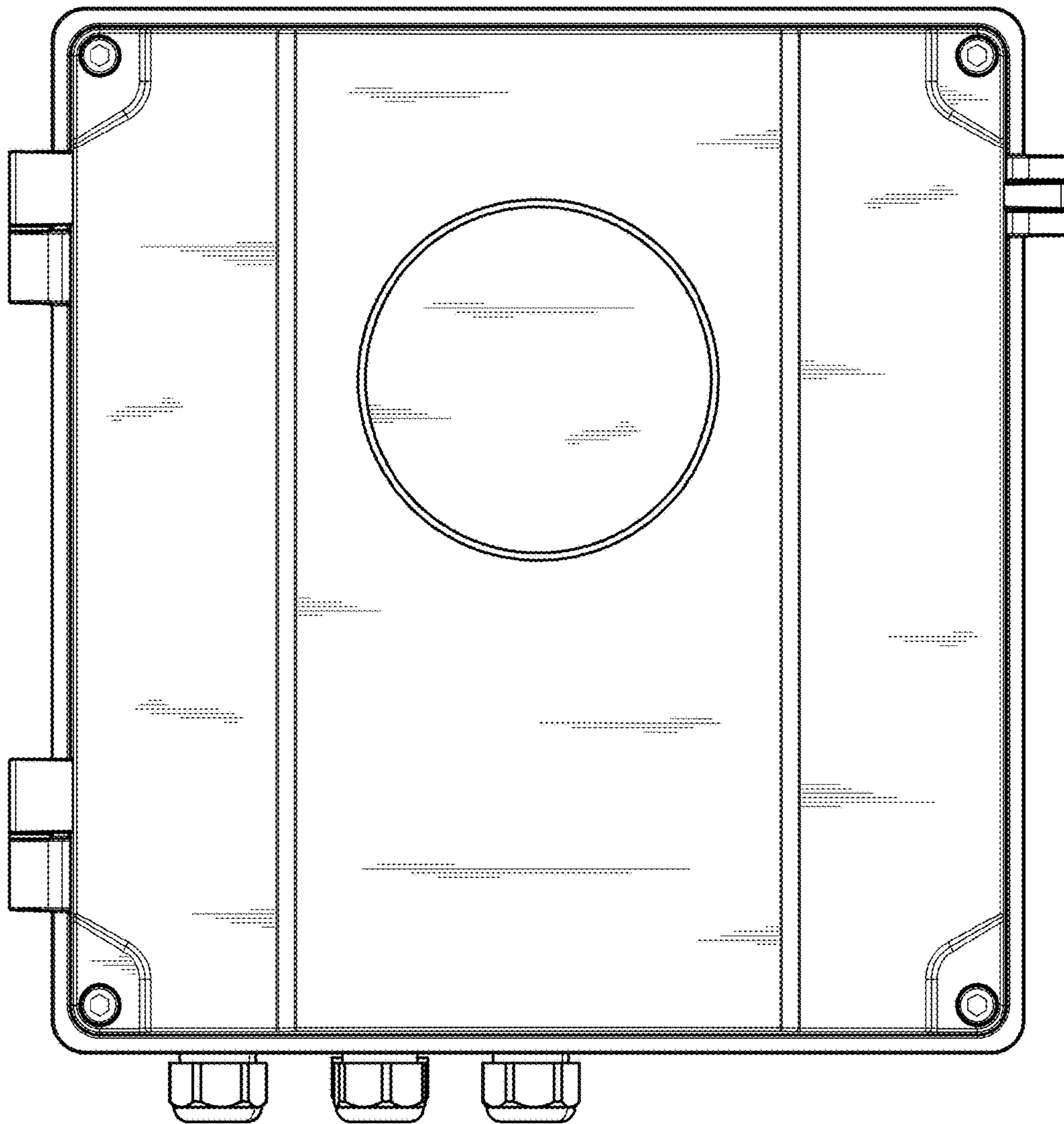

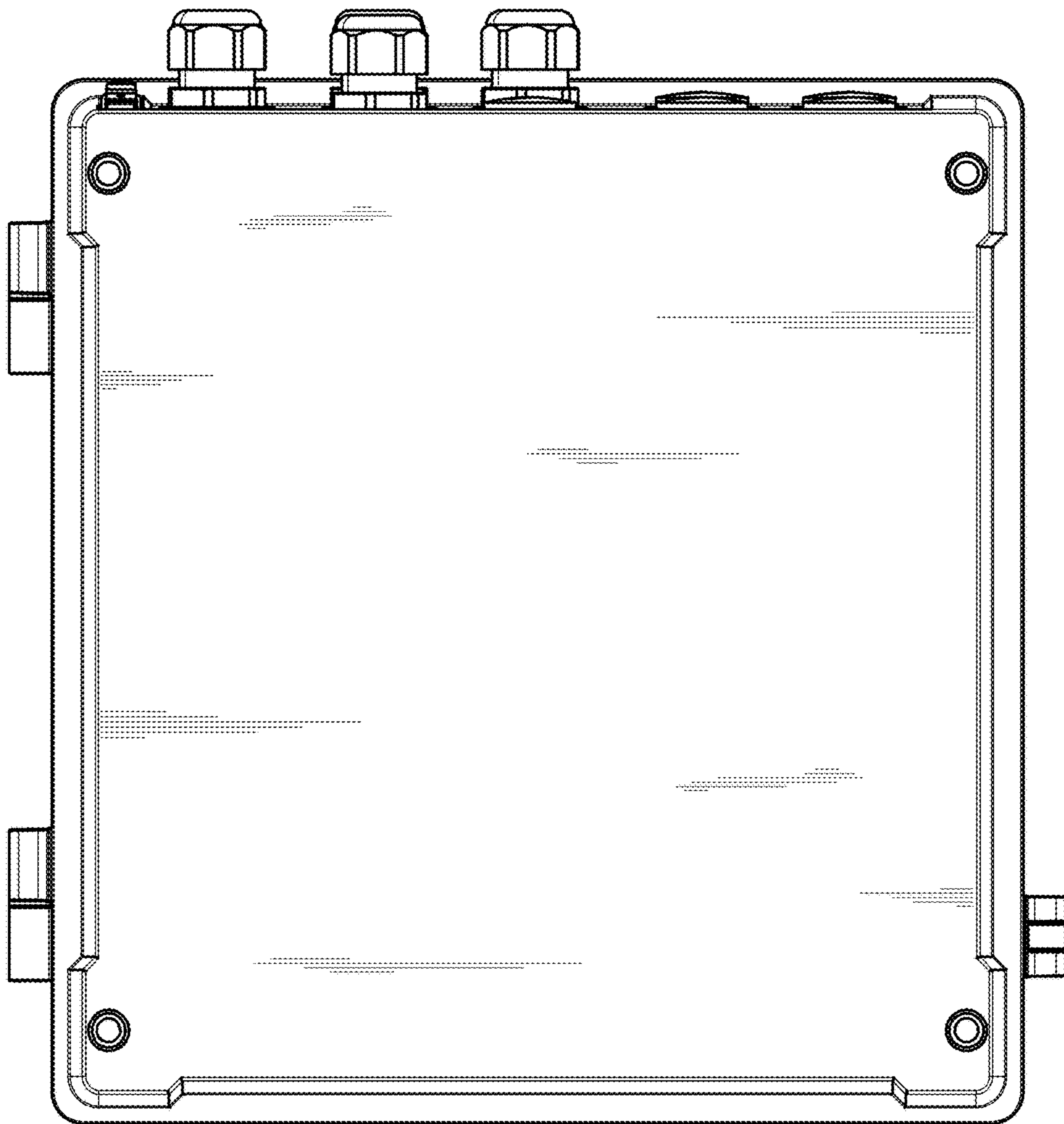

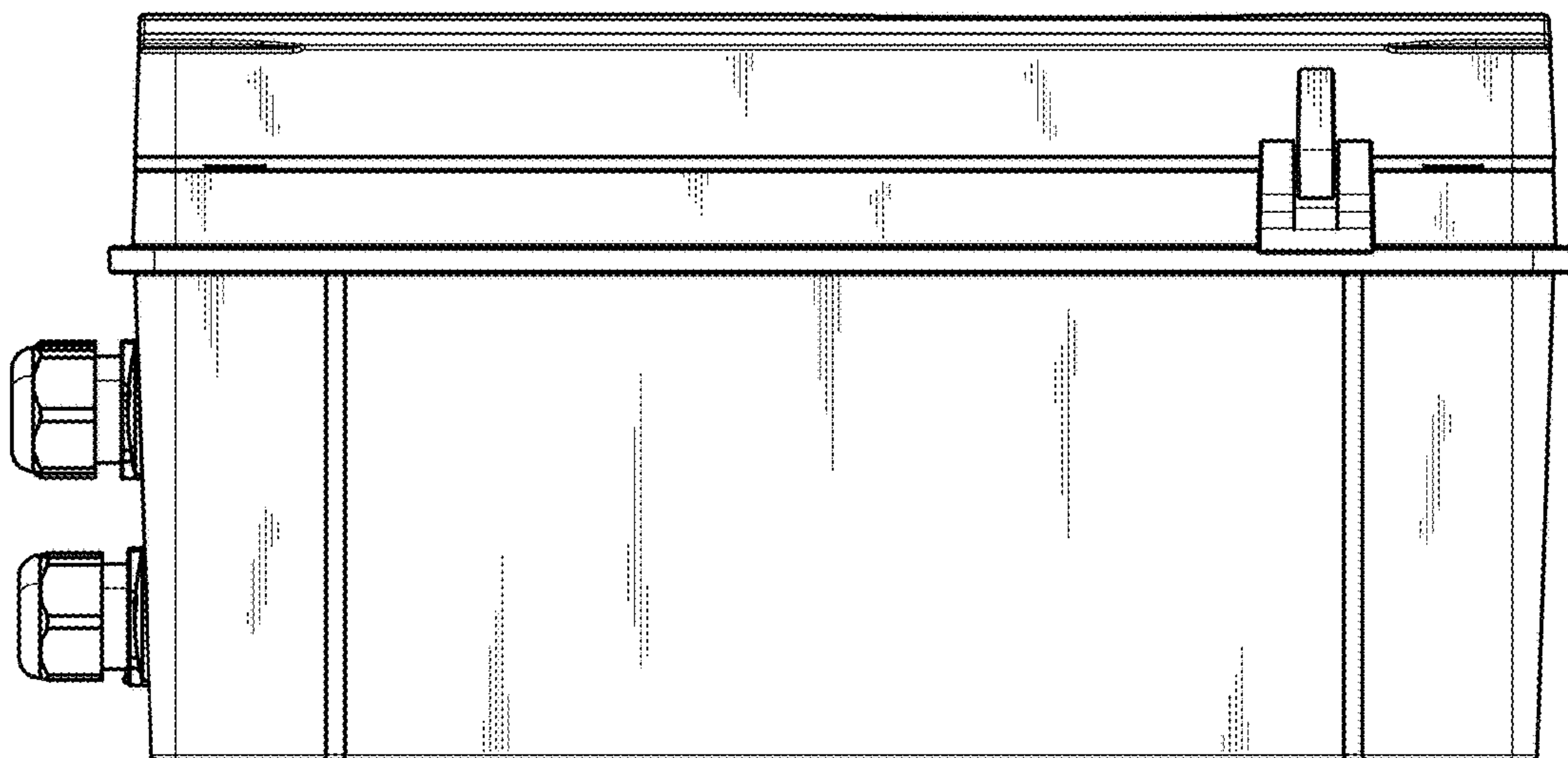

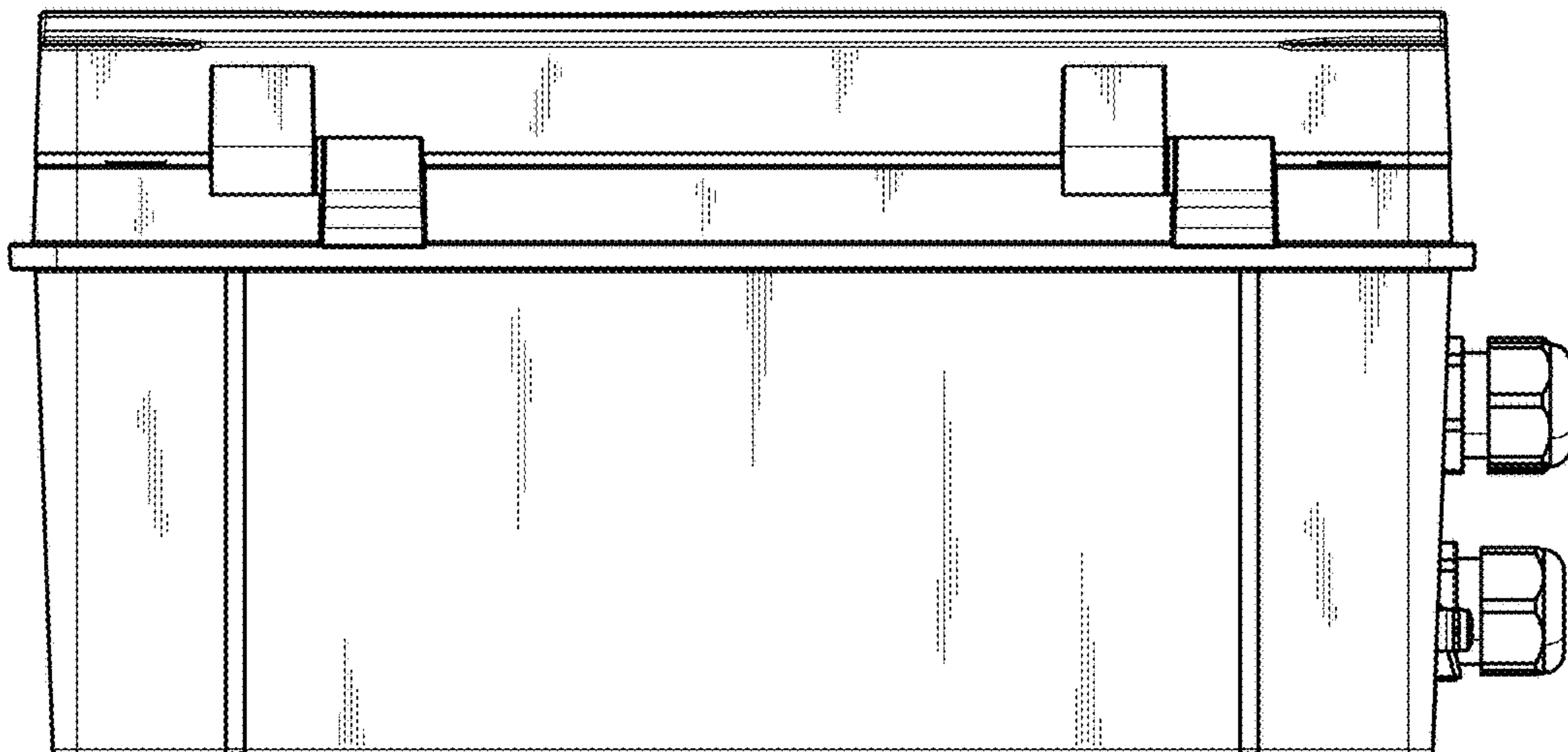
