DESCRIPTION

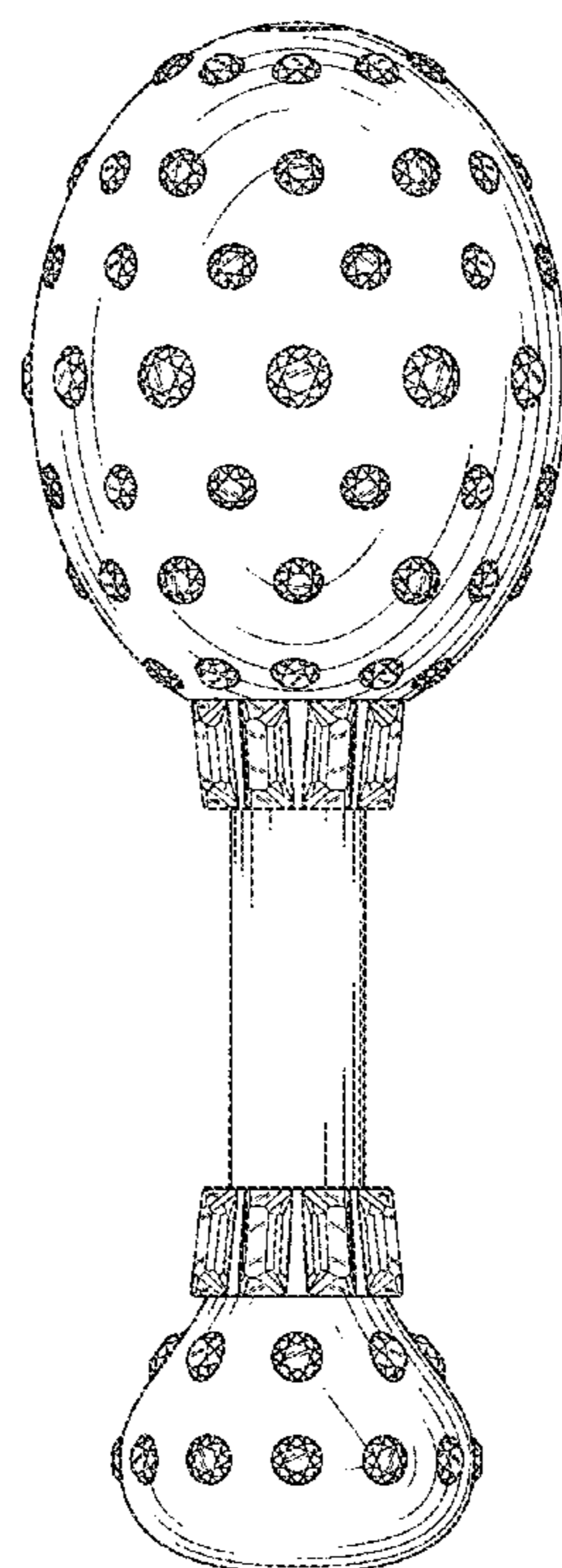
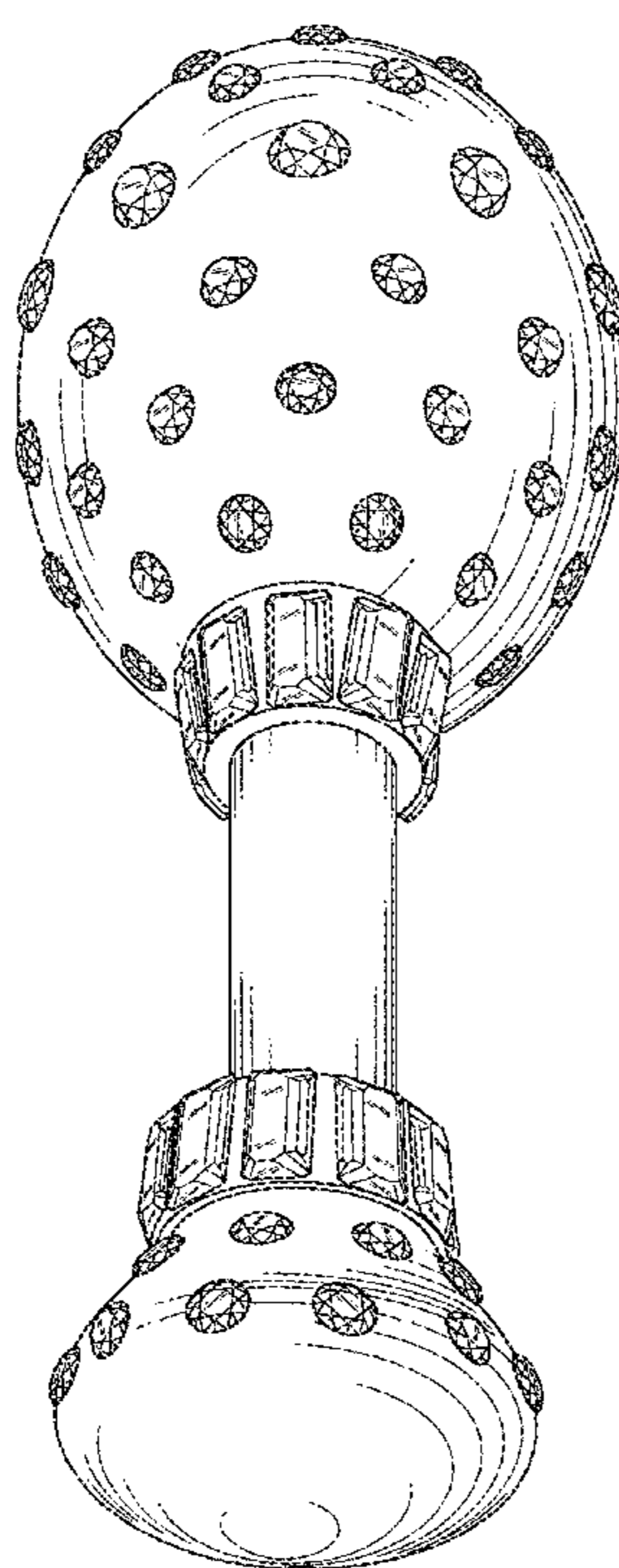
FIG. 1 is a bottom perspective view of an ornament showing my new design;

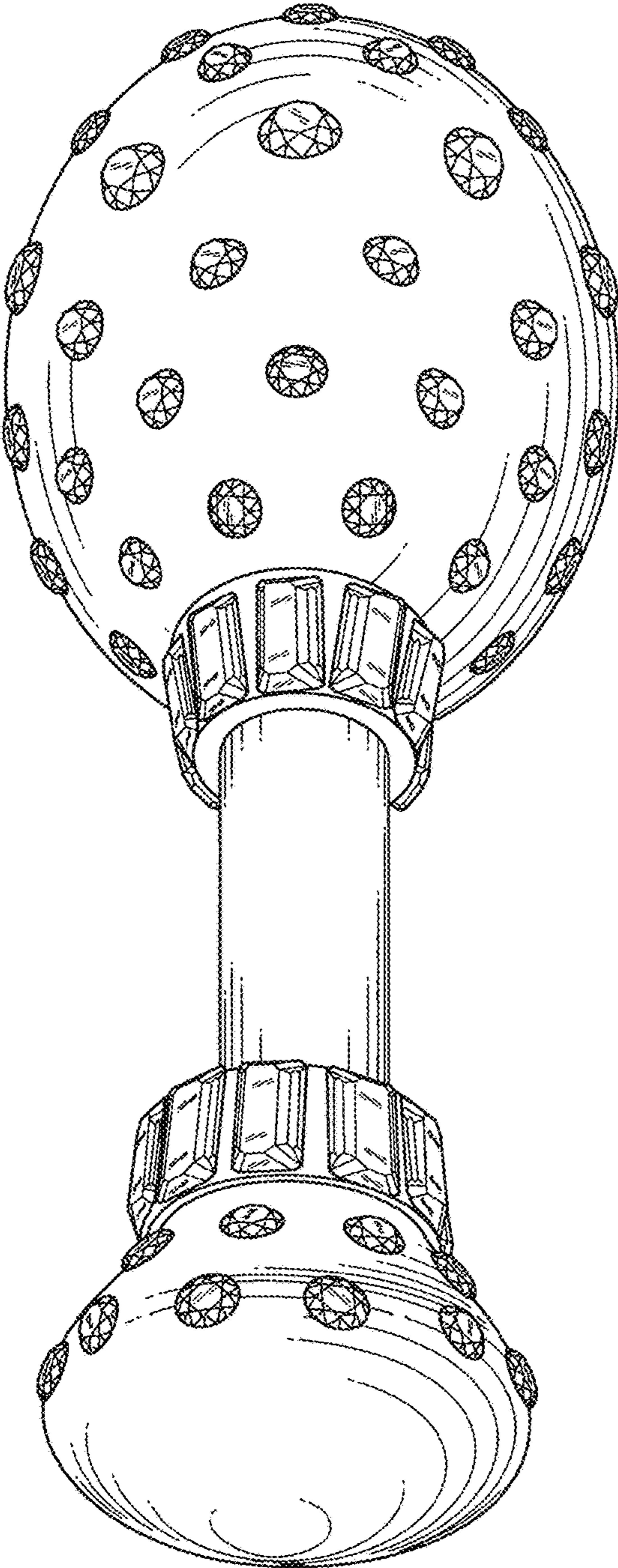

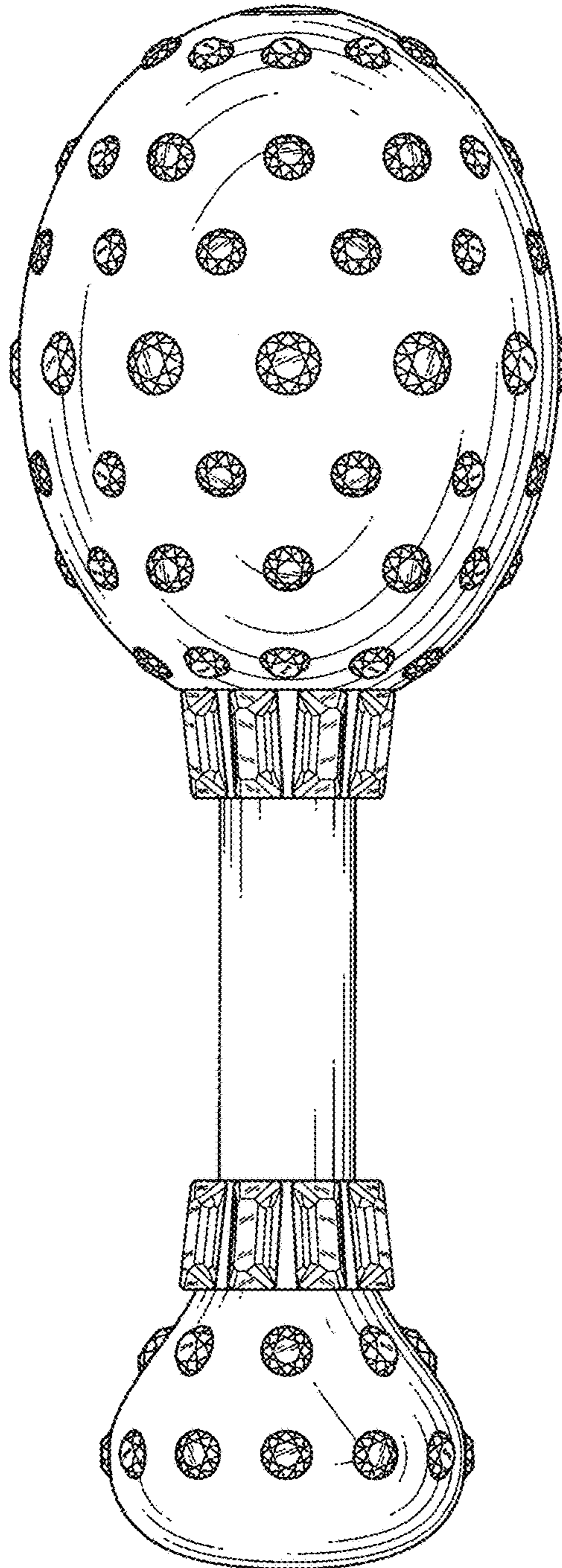

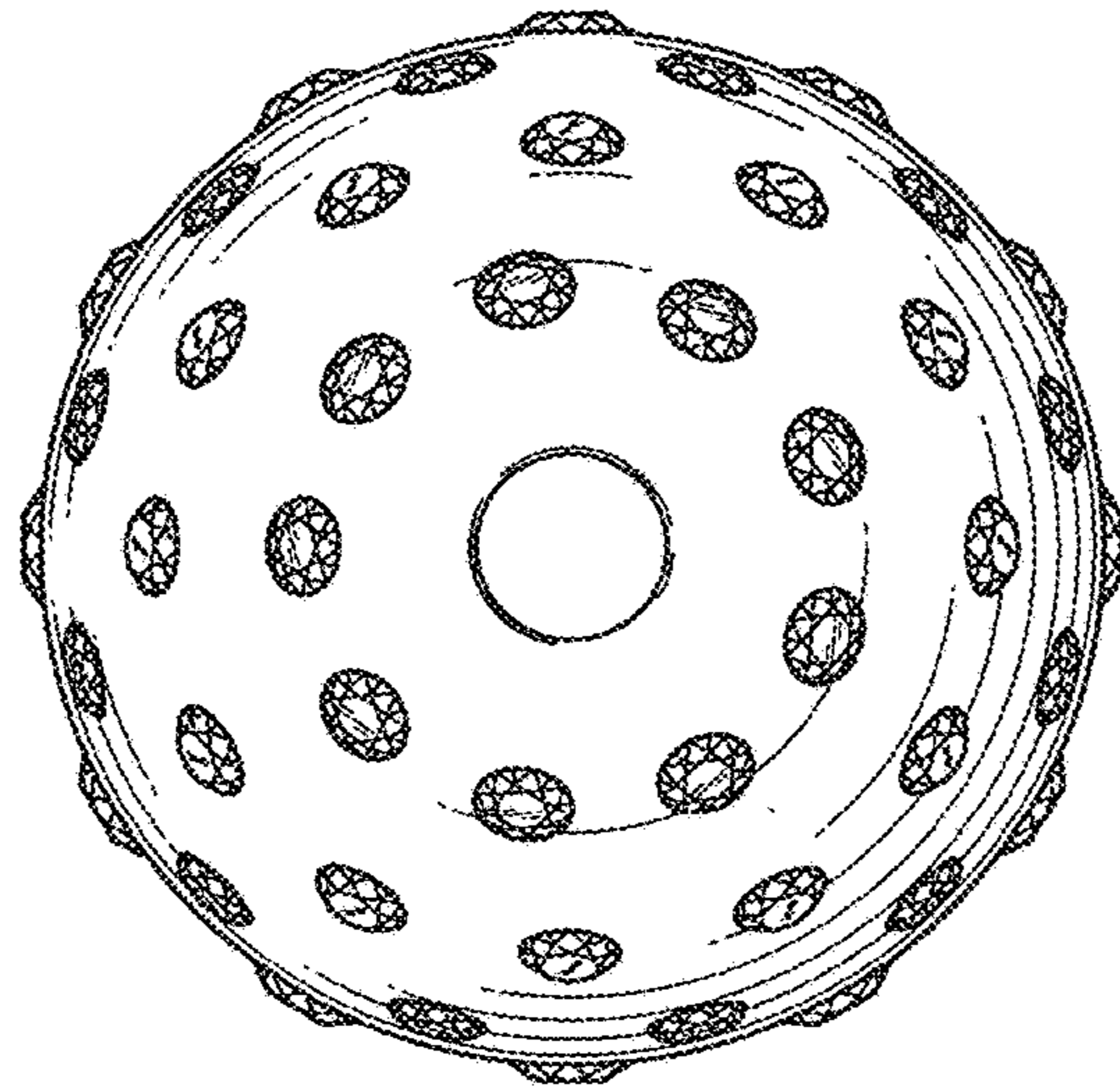

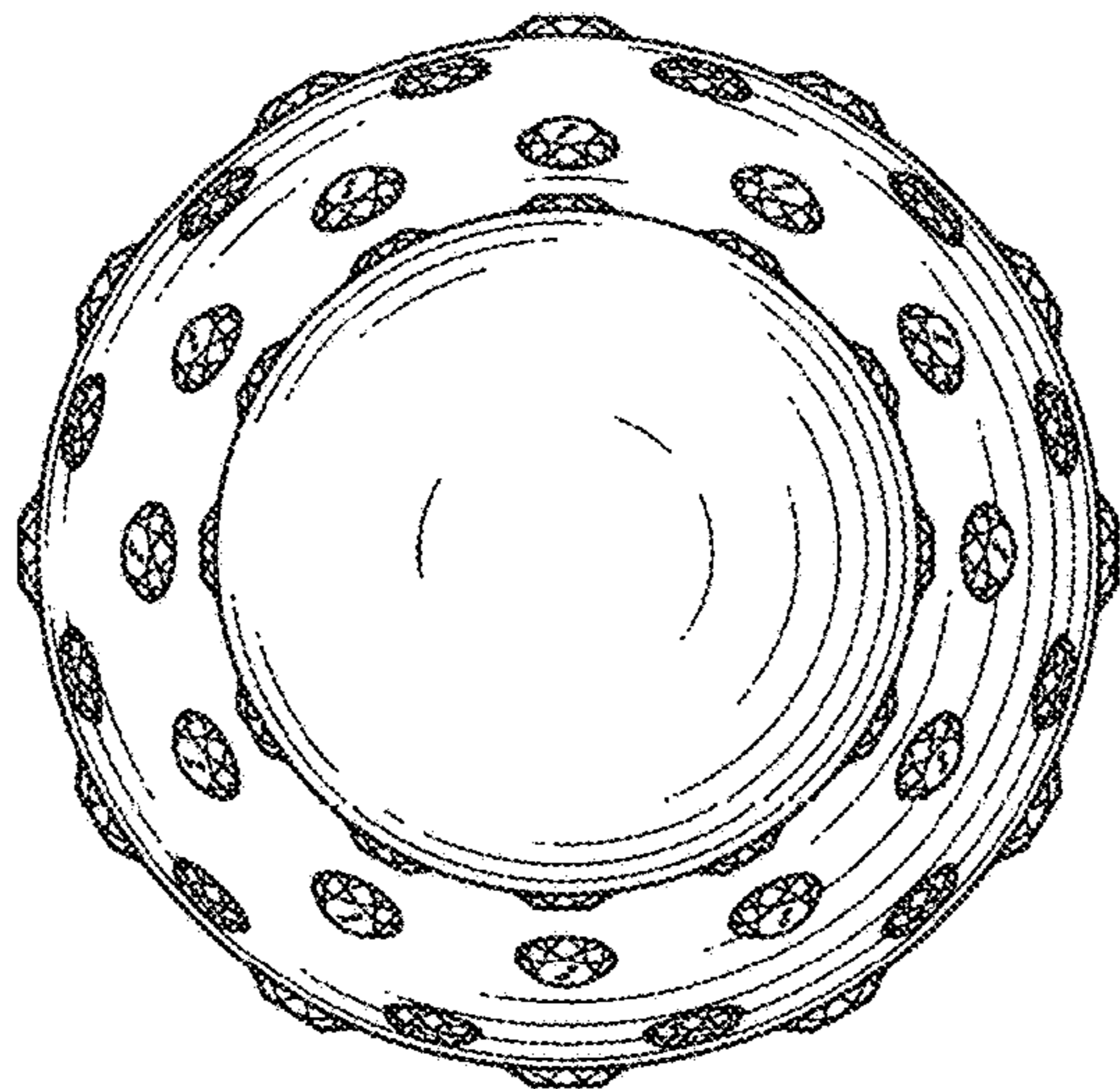
