DESCRIPTION

FIG. 1 is a front isometric view of a flower box in accordance with the new design;

FIG. 2 is a top view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a right side elevation view thereof;

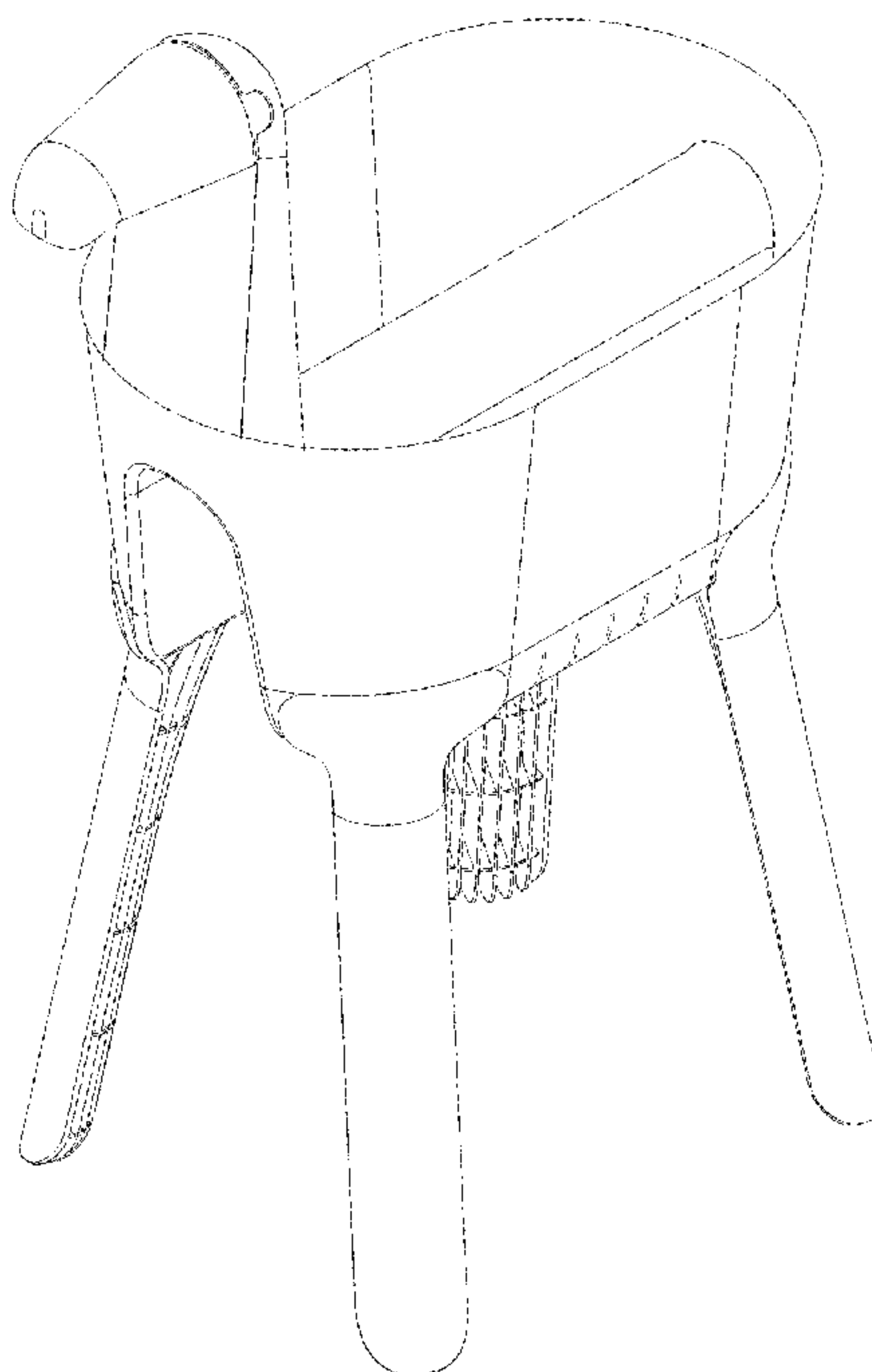
FIG. 5 is a left side elevation view thereof;

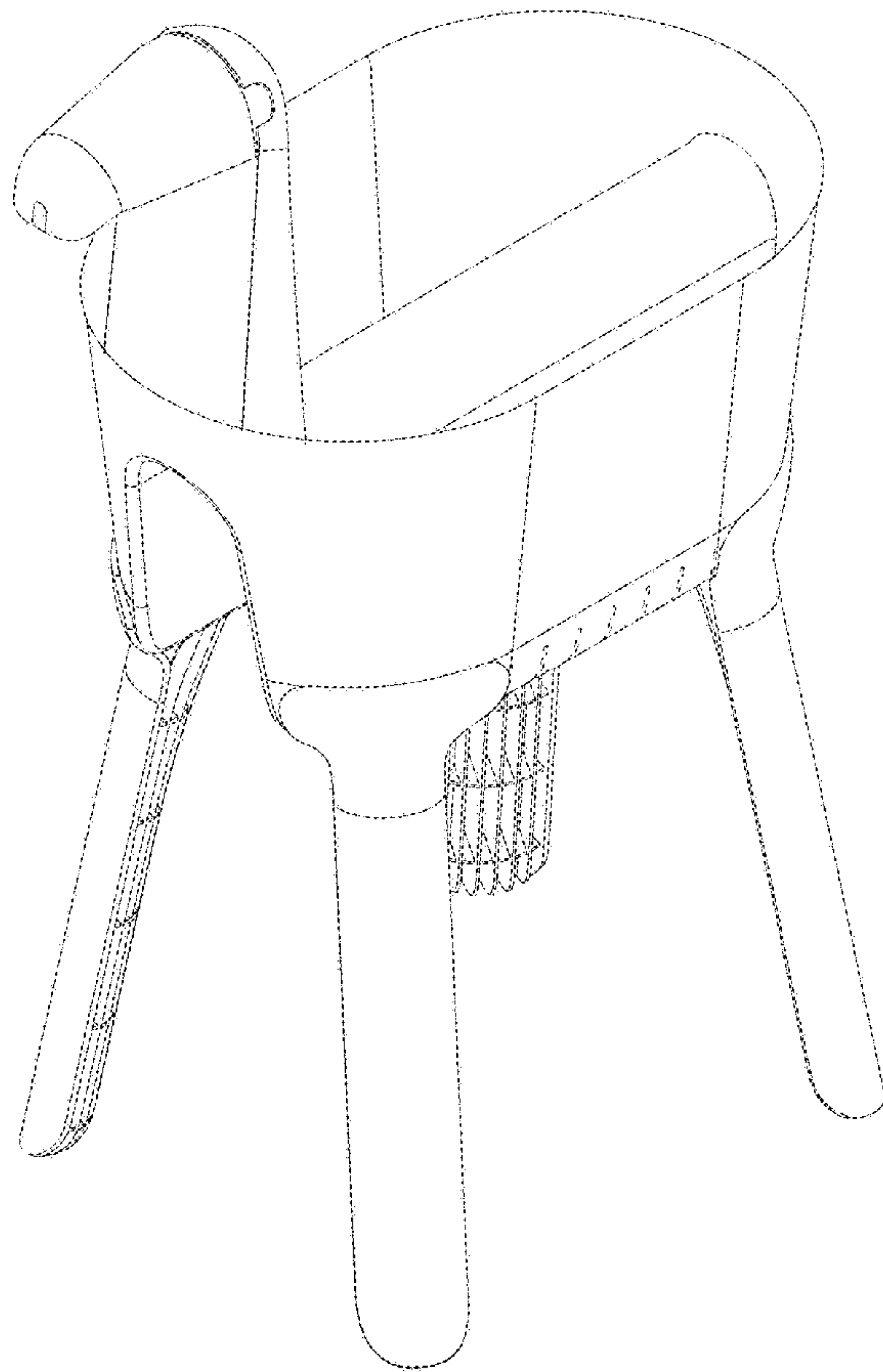

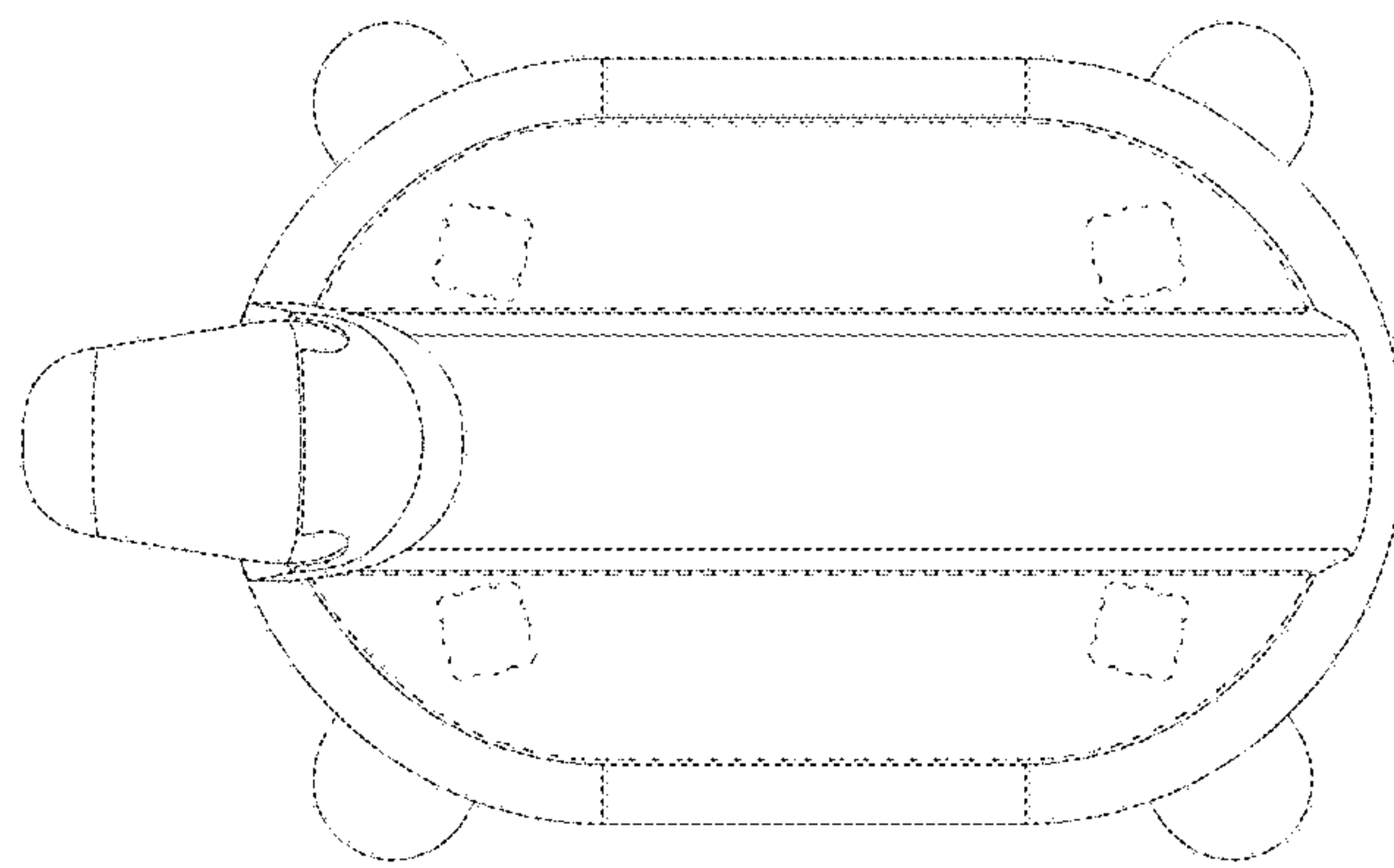

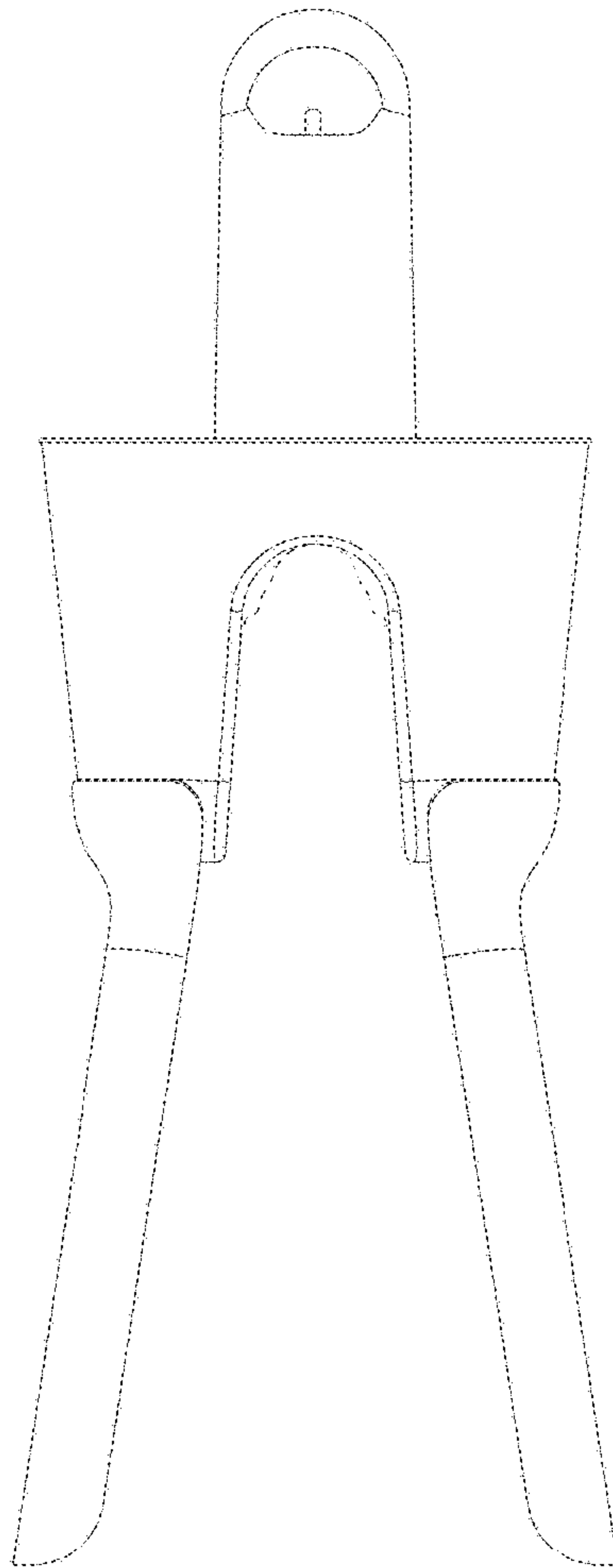

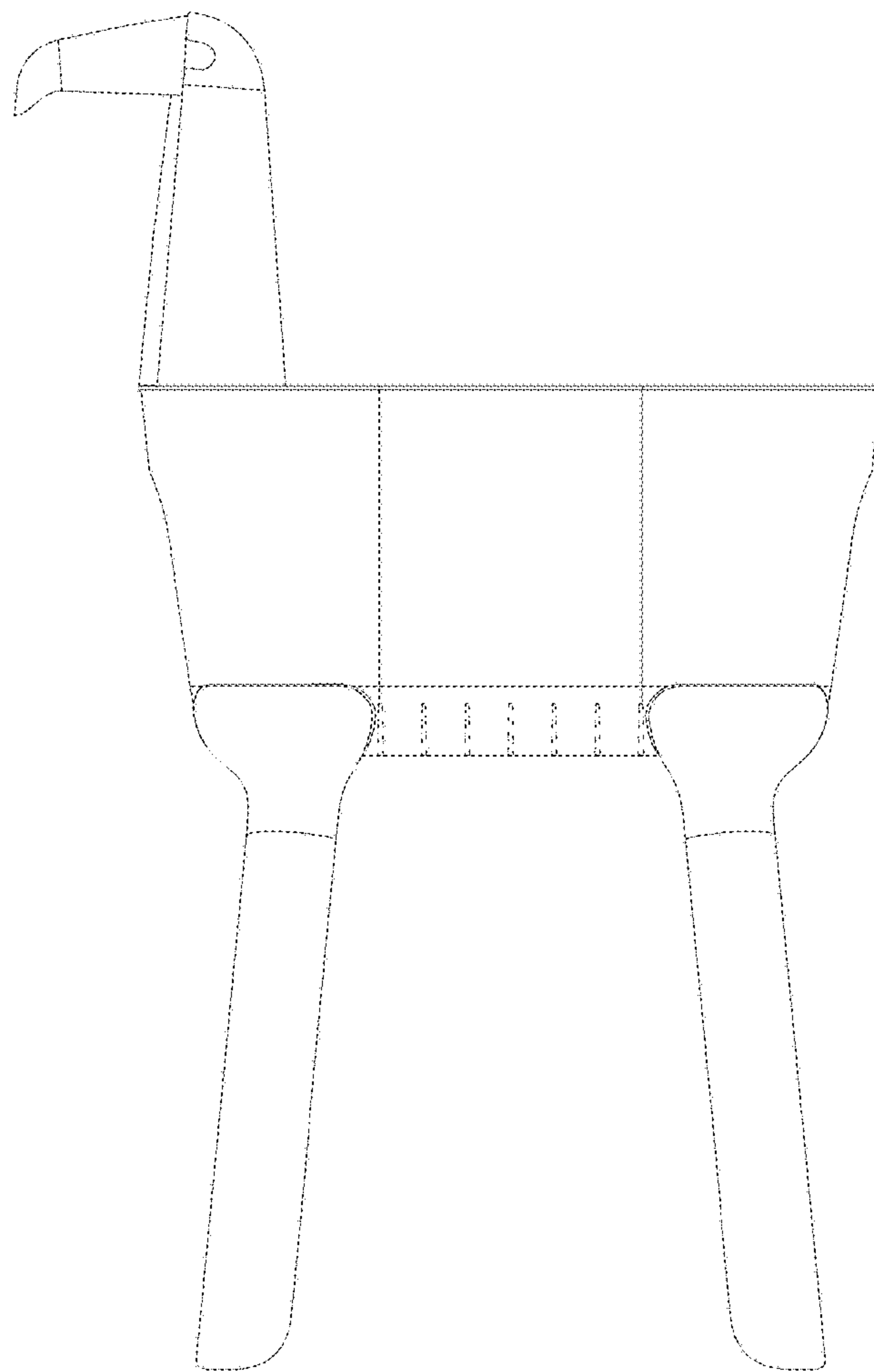

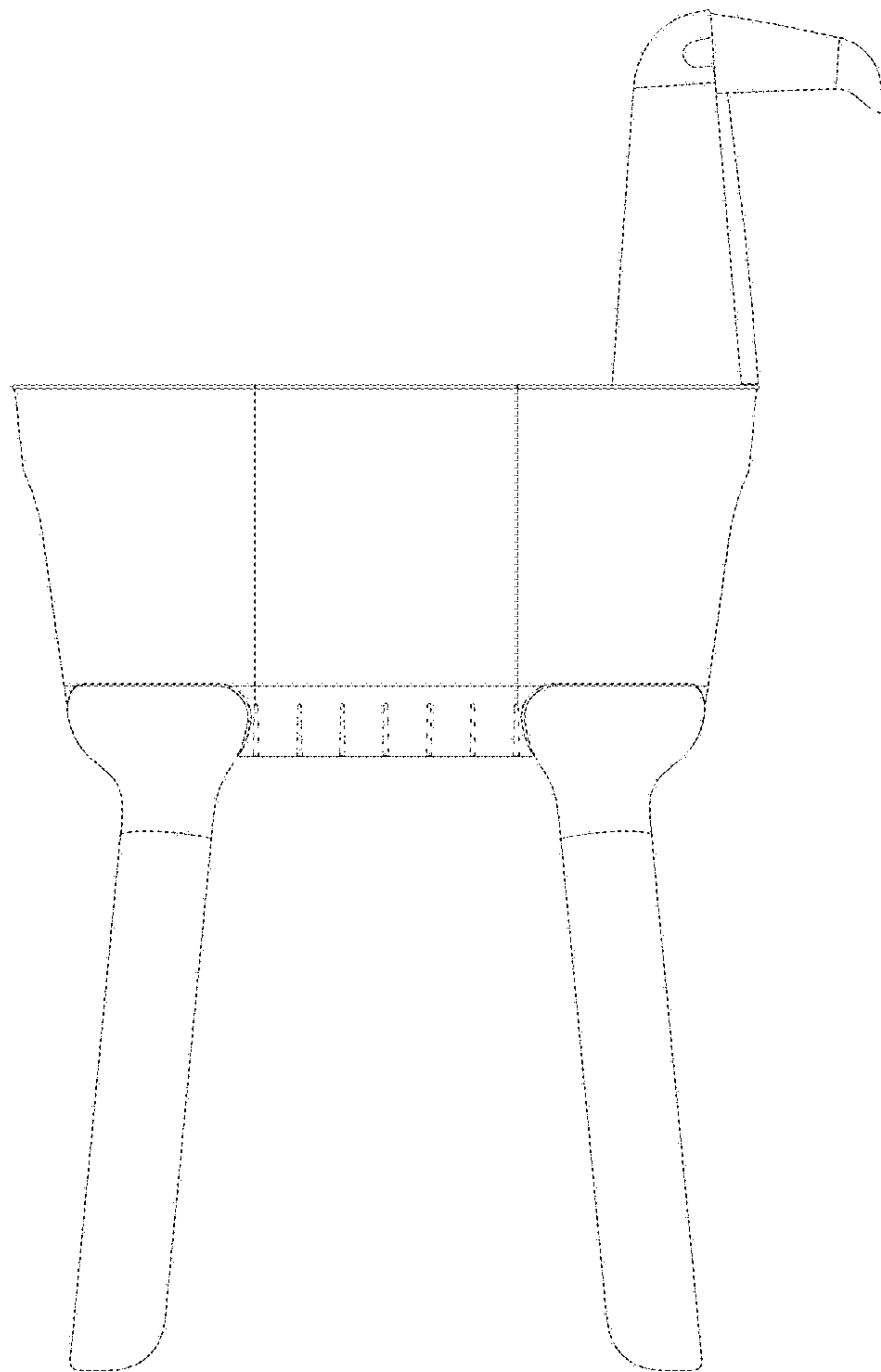

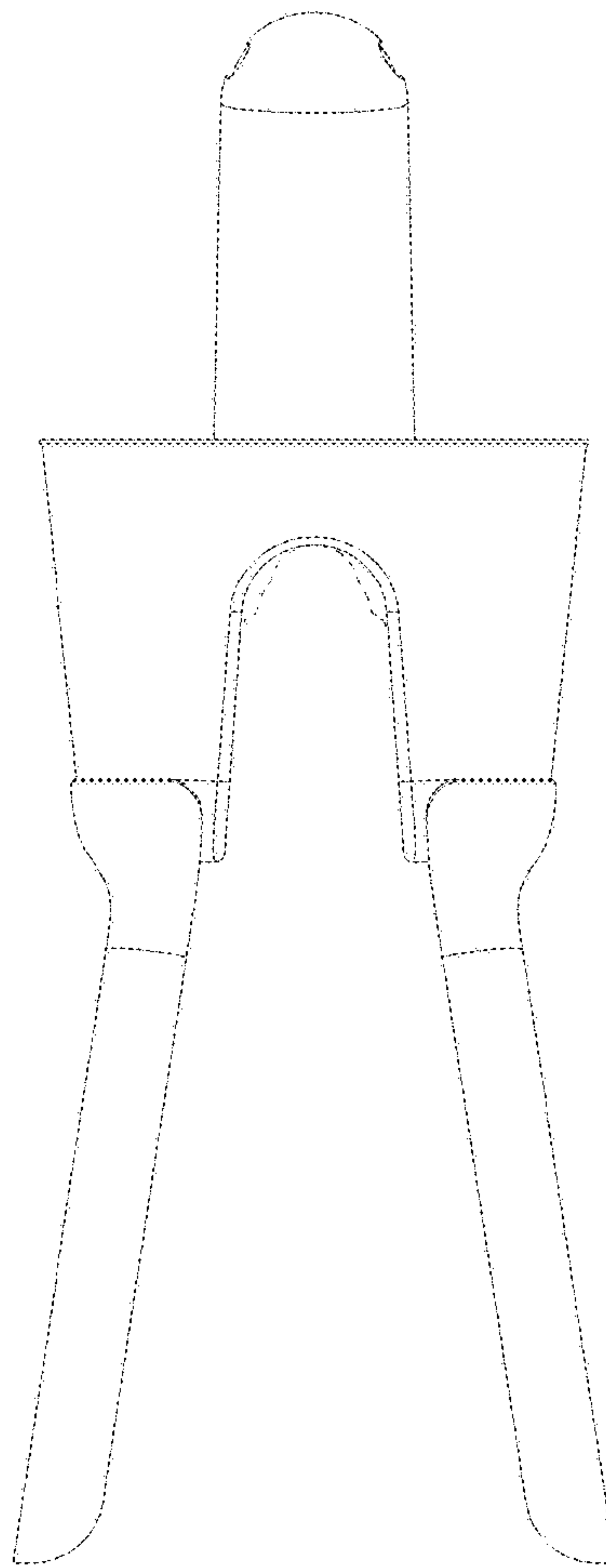

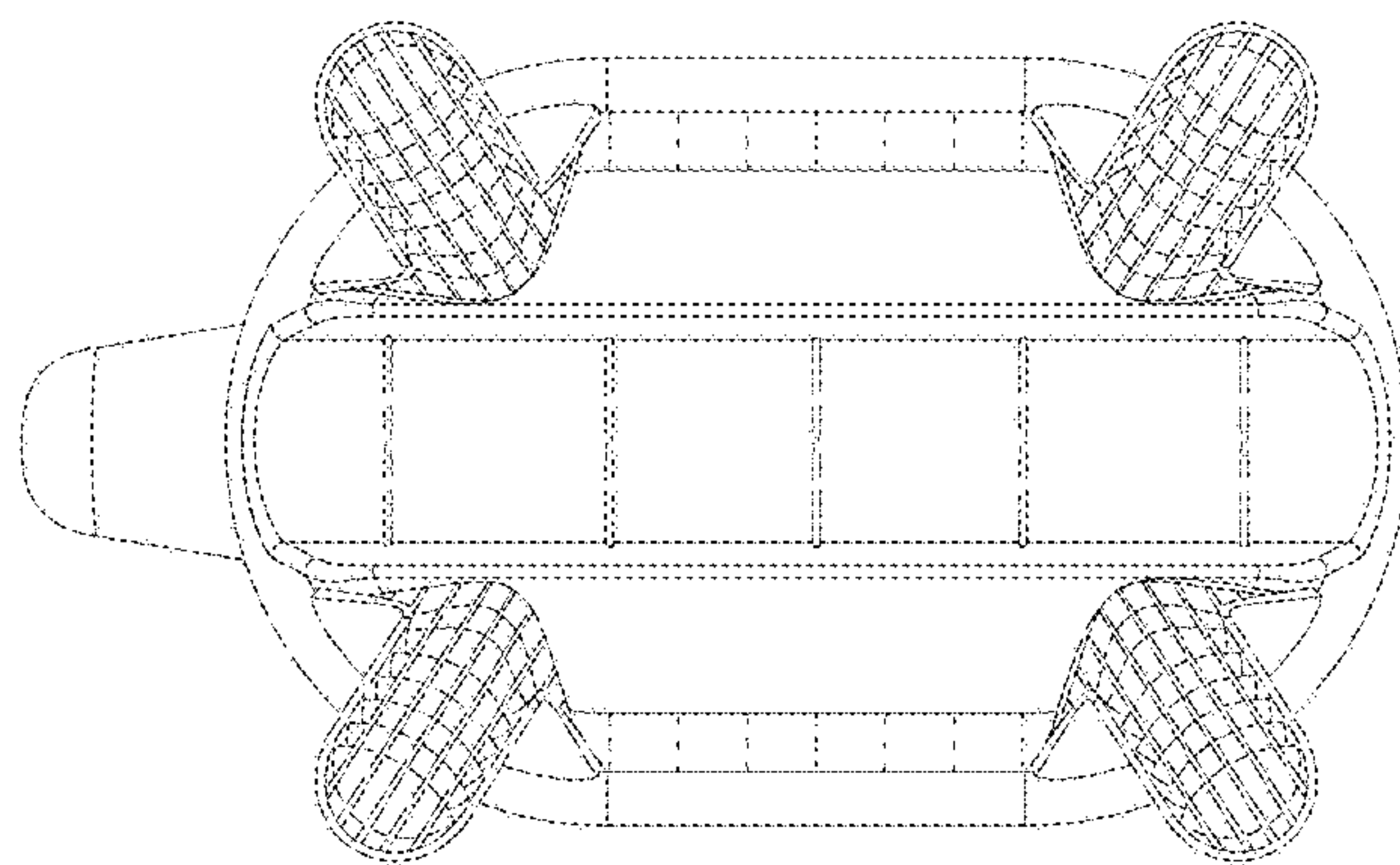
