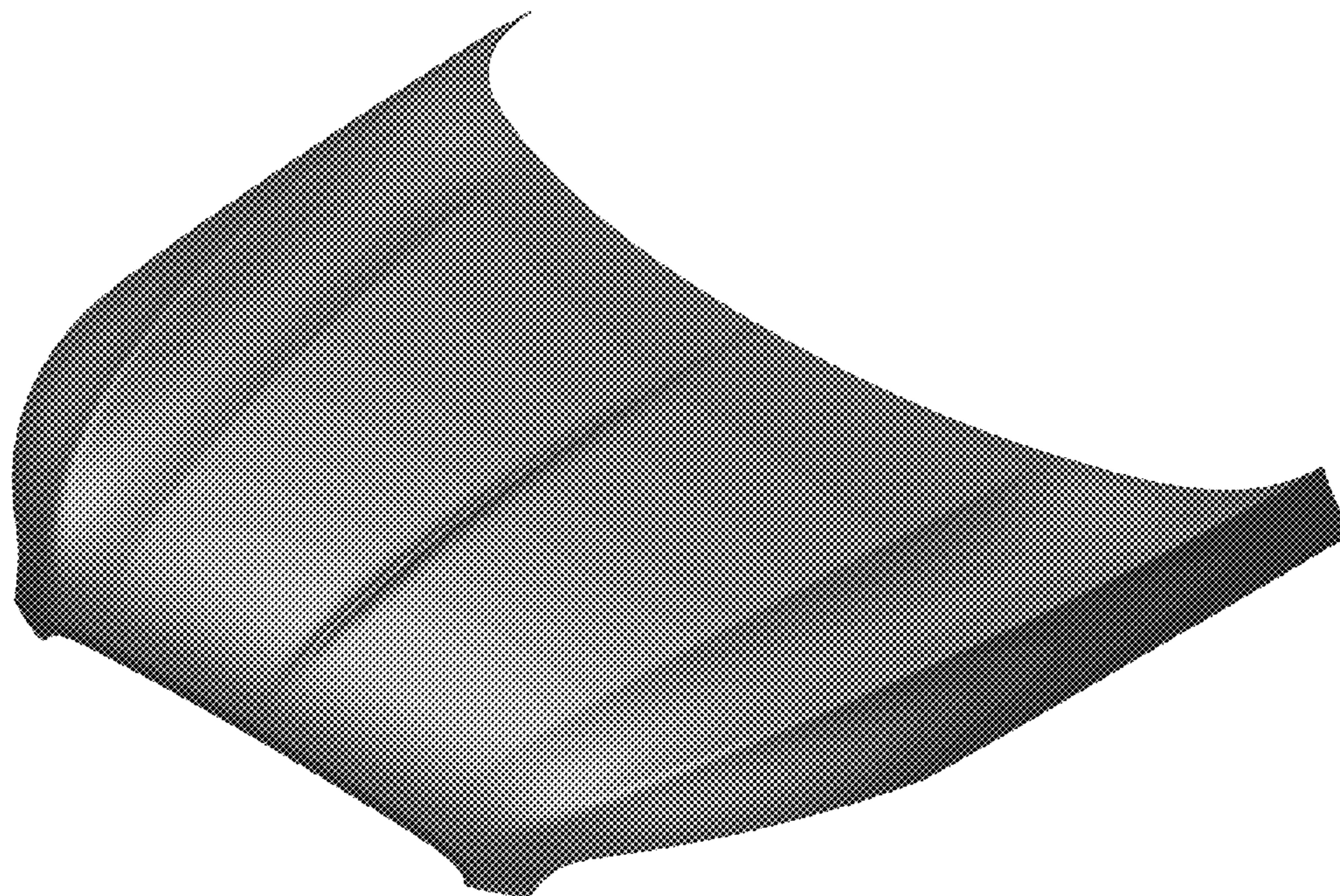

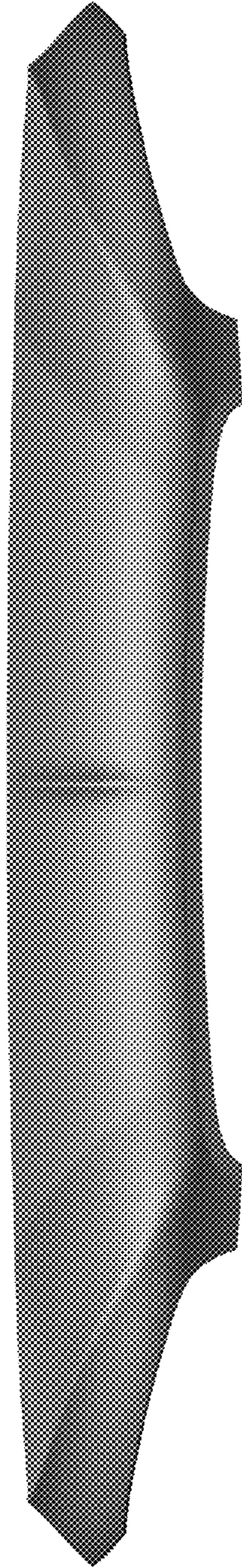
The ornamental design for a vehicle hood, as shown and described.

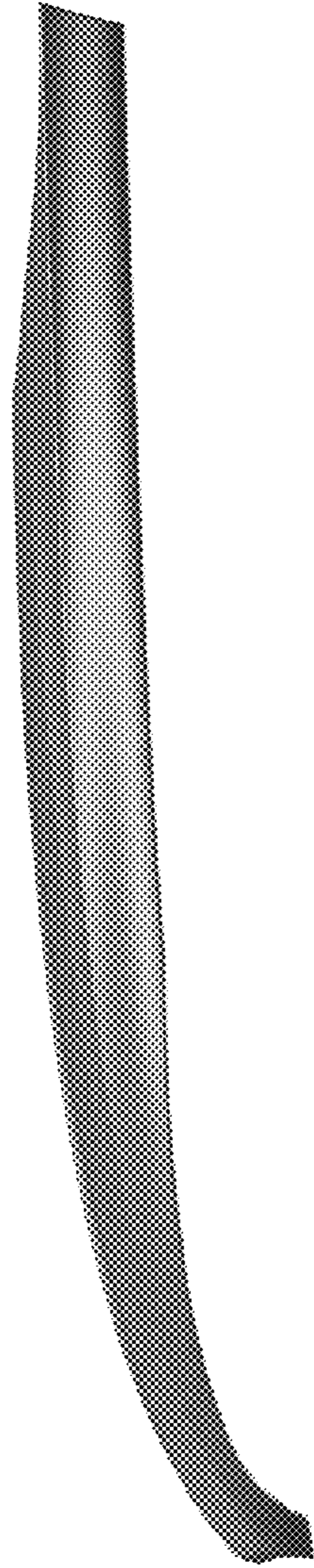

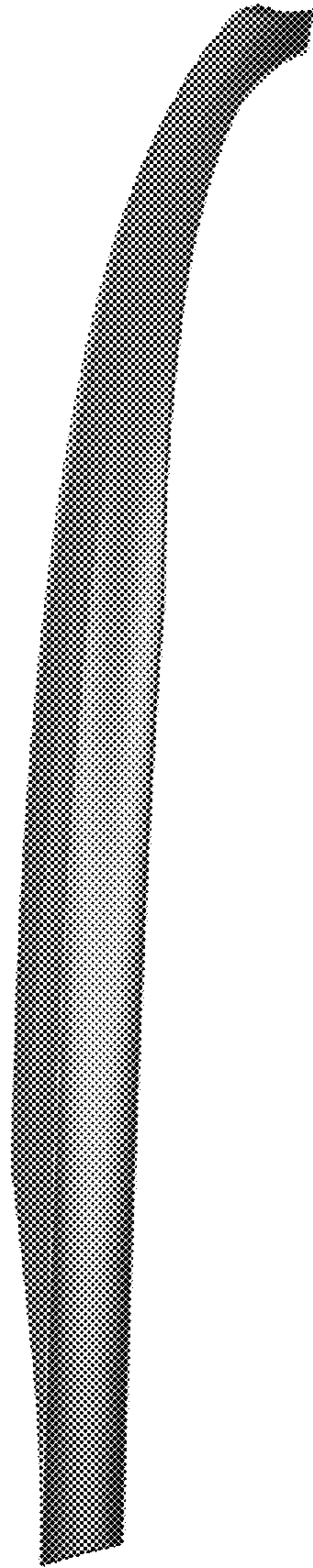

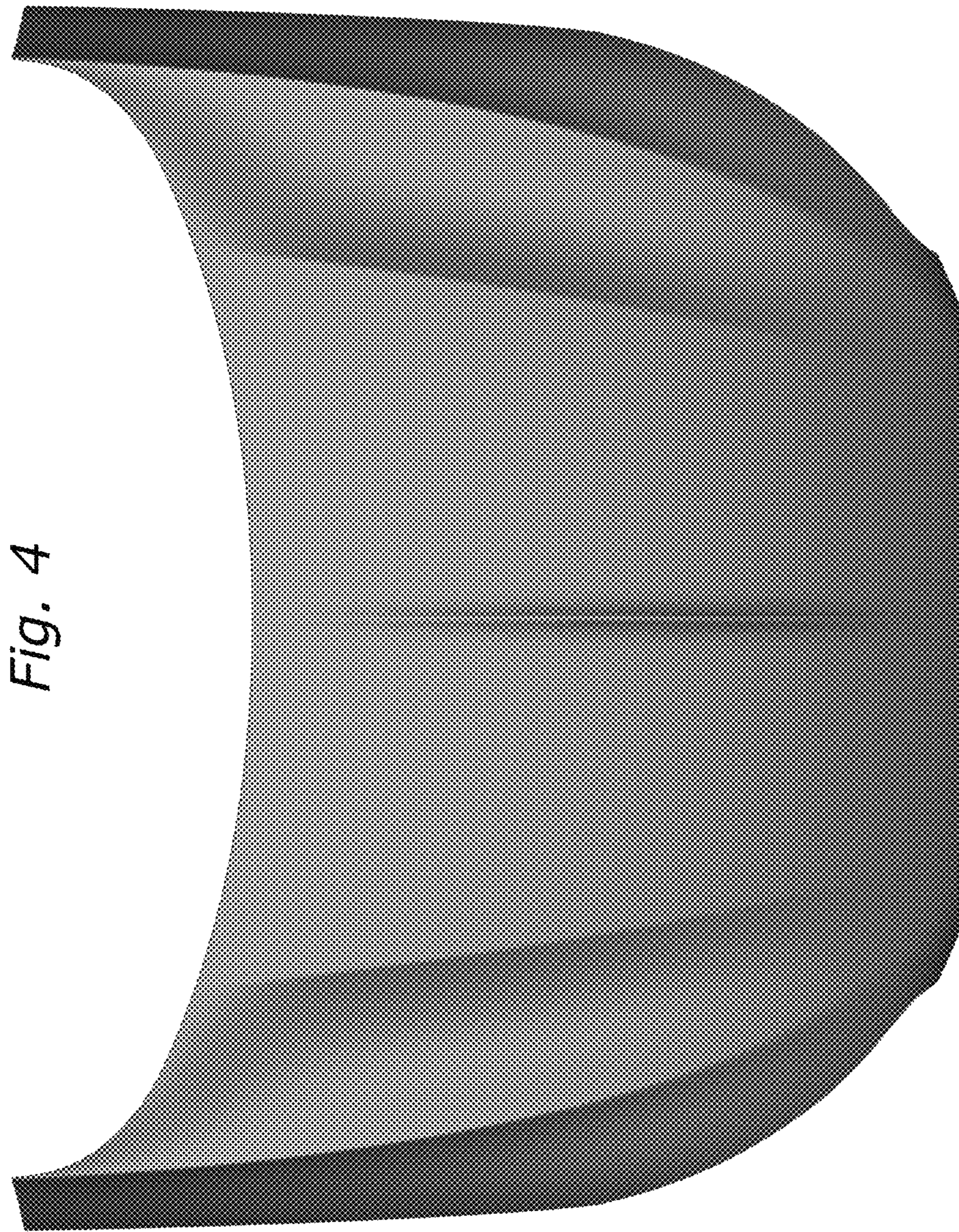

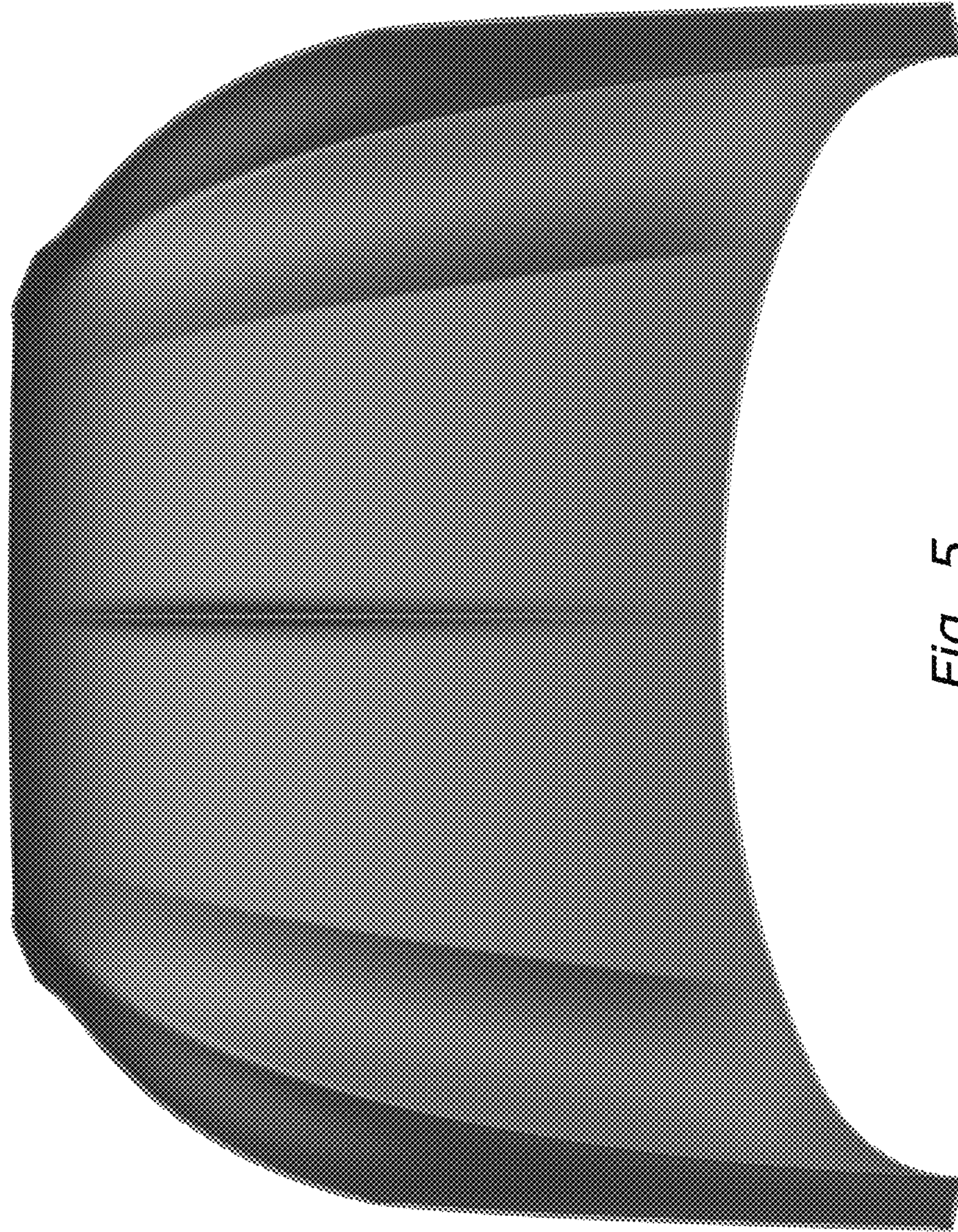

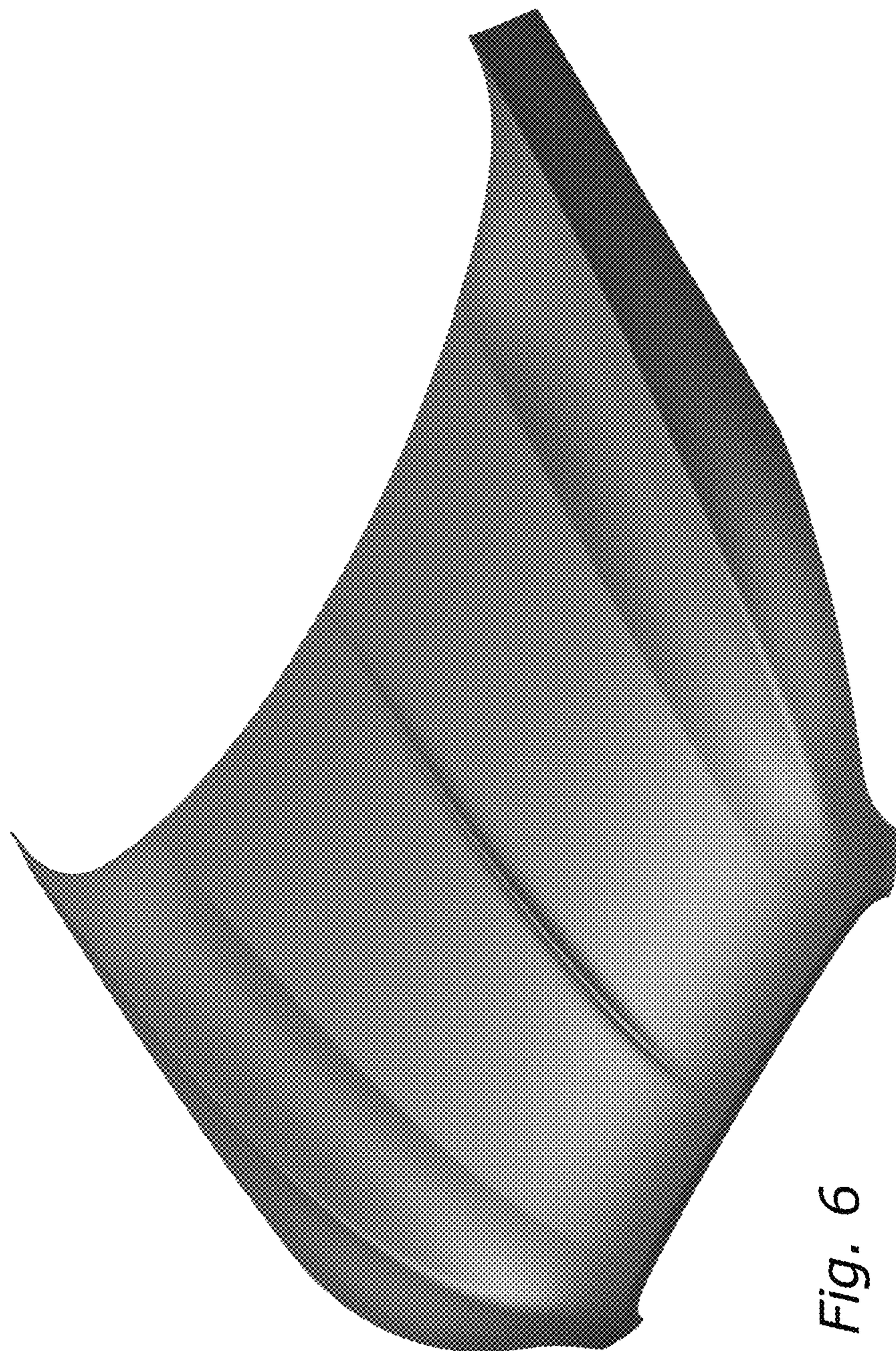

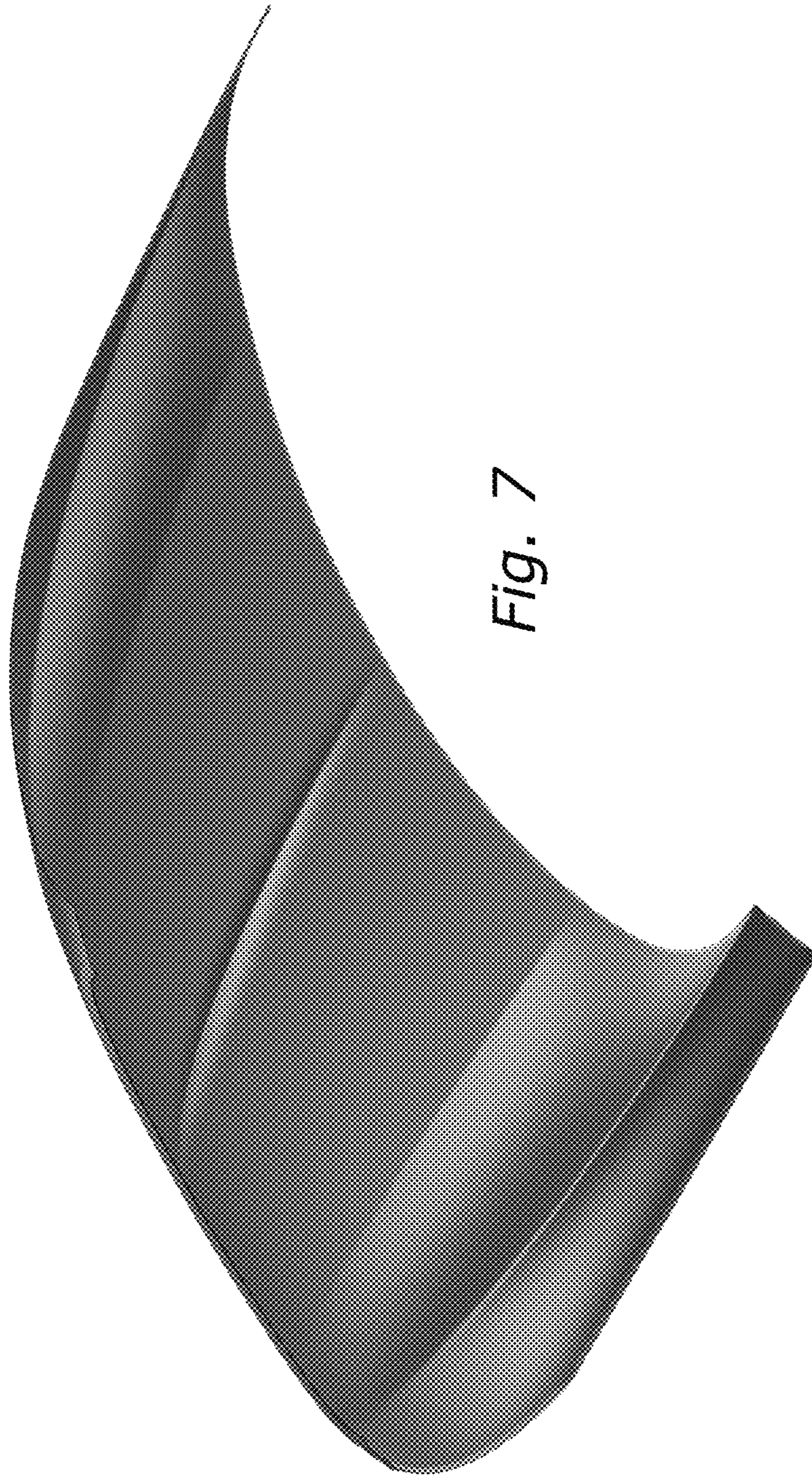
