(57) **CLAIM**

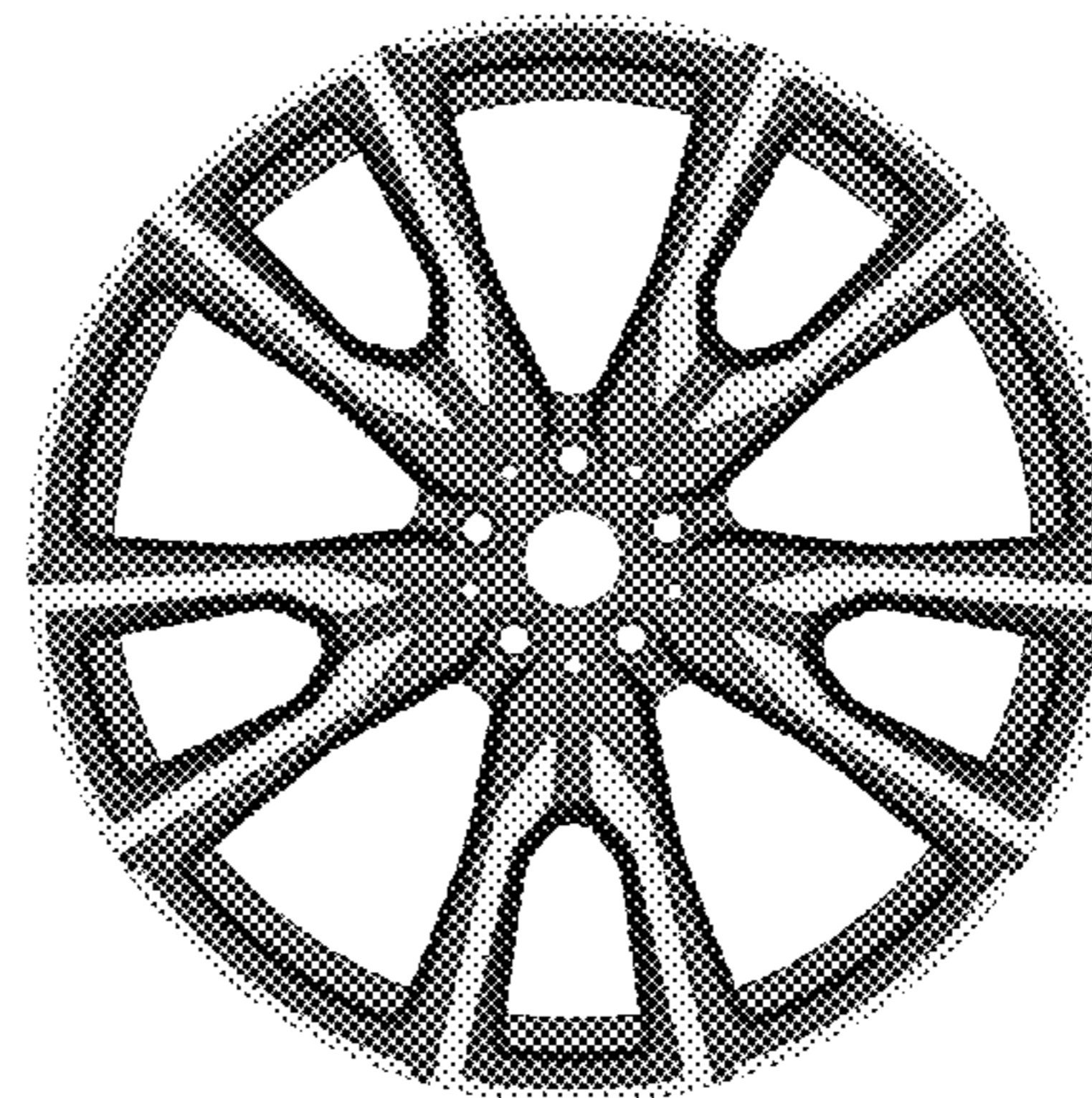
The ornamental design for a vehicle wheel, toy vehicle wheel, and/or replicas thereof, as shown and described.

DESCRIPTION

This application contains subject matter related to the following co-pending U.S. design patent application: Application Ser. No. 29/594,300, filed Feb. 17, 2017 and entitled "Vehicle Wheel."

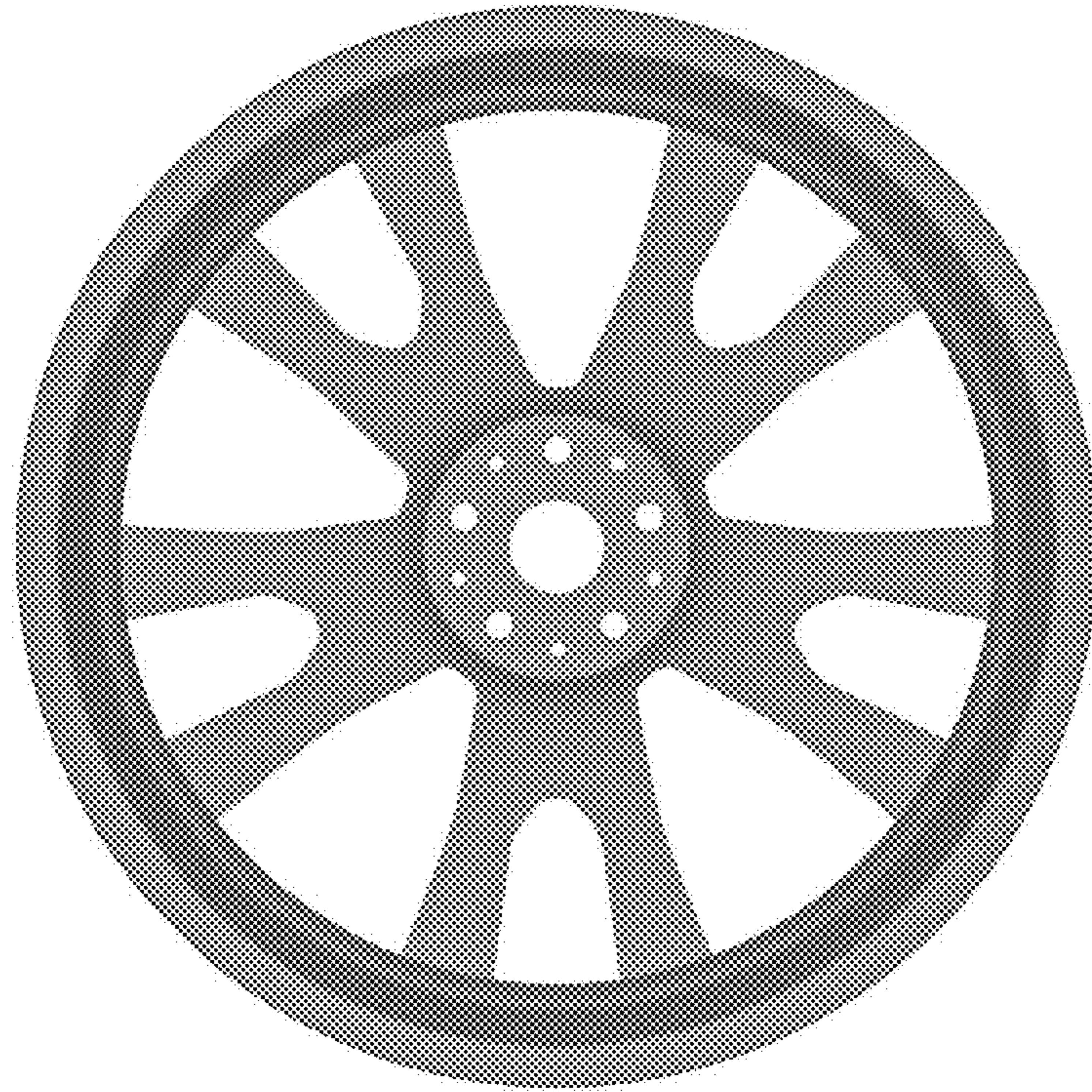
