(57) **CLAIM**

The ornamental design for a vehicle wheel, toy vehicle wheel, and/or replicas thereof, as shown and described.

**DESCRIPTION**

This application contains subject matter related to the following co-pending U.S. design patent application: Application Ser. No. 29/617,244, filed Sep. 13, 2017 and entitled “Vehicle Wheel, Toy Vehicle Wheel, and/or Other Replicas.”

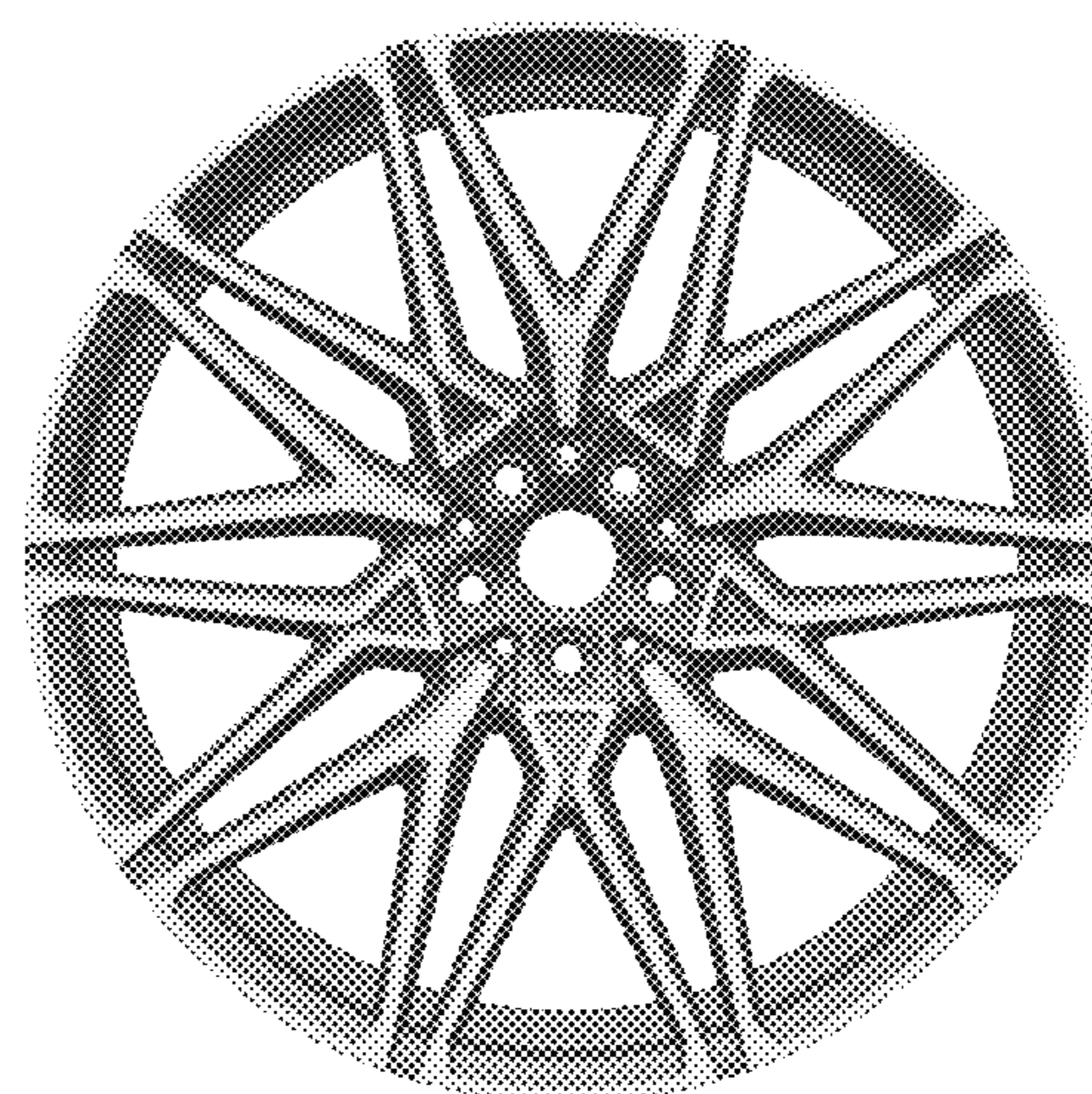

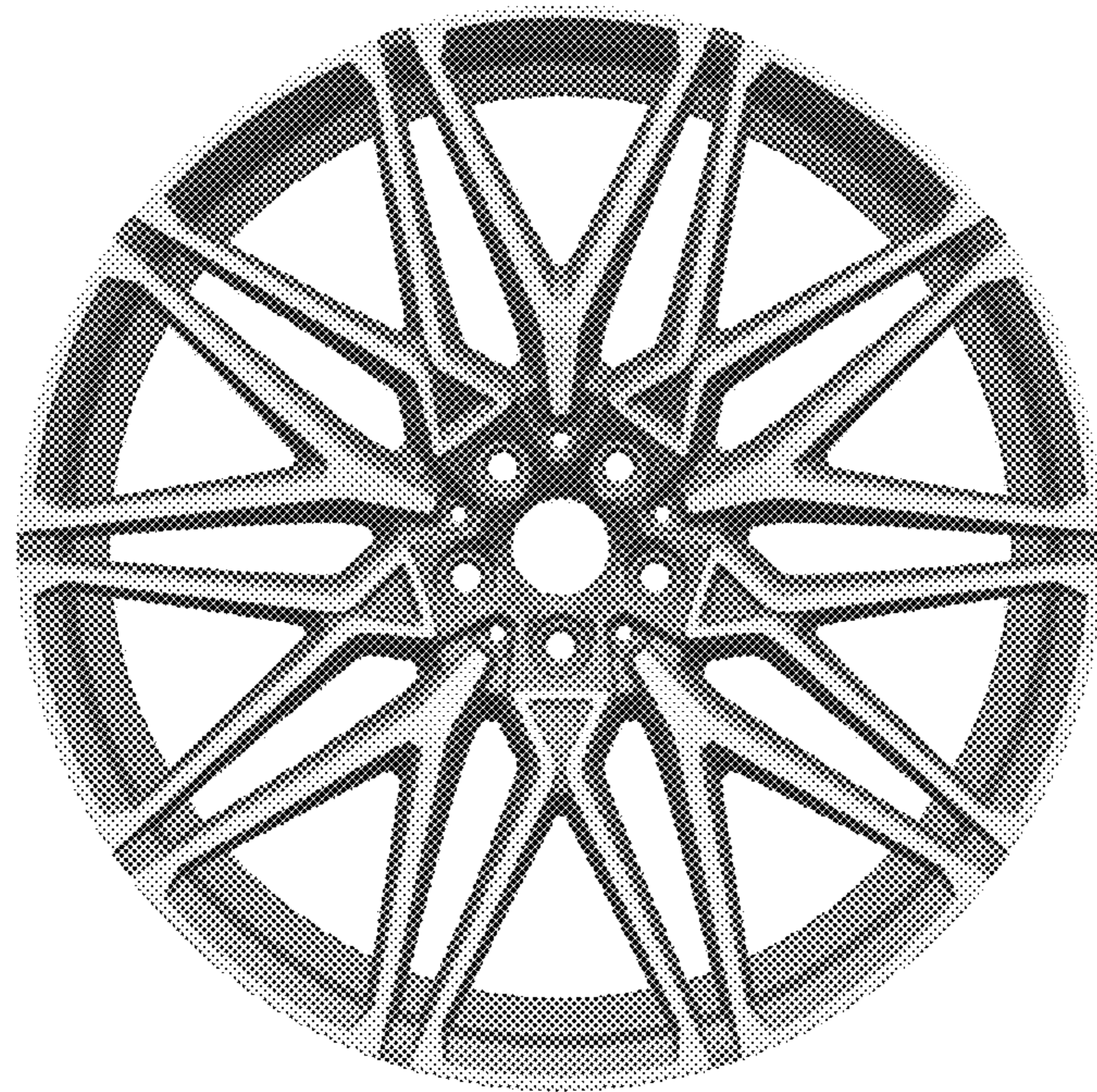

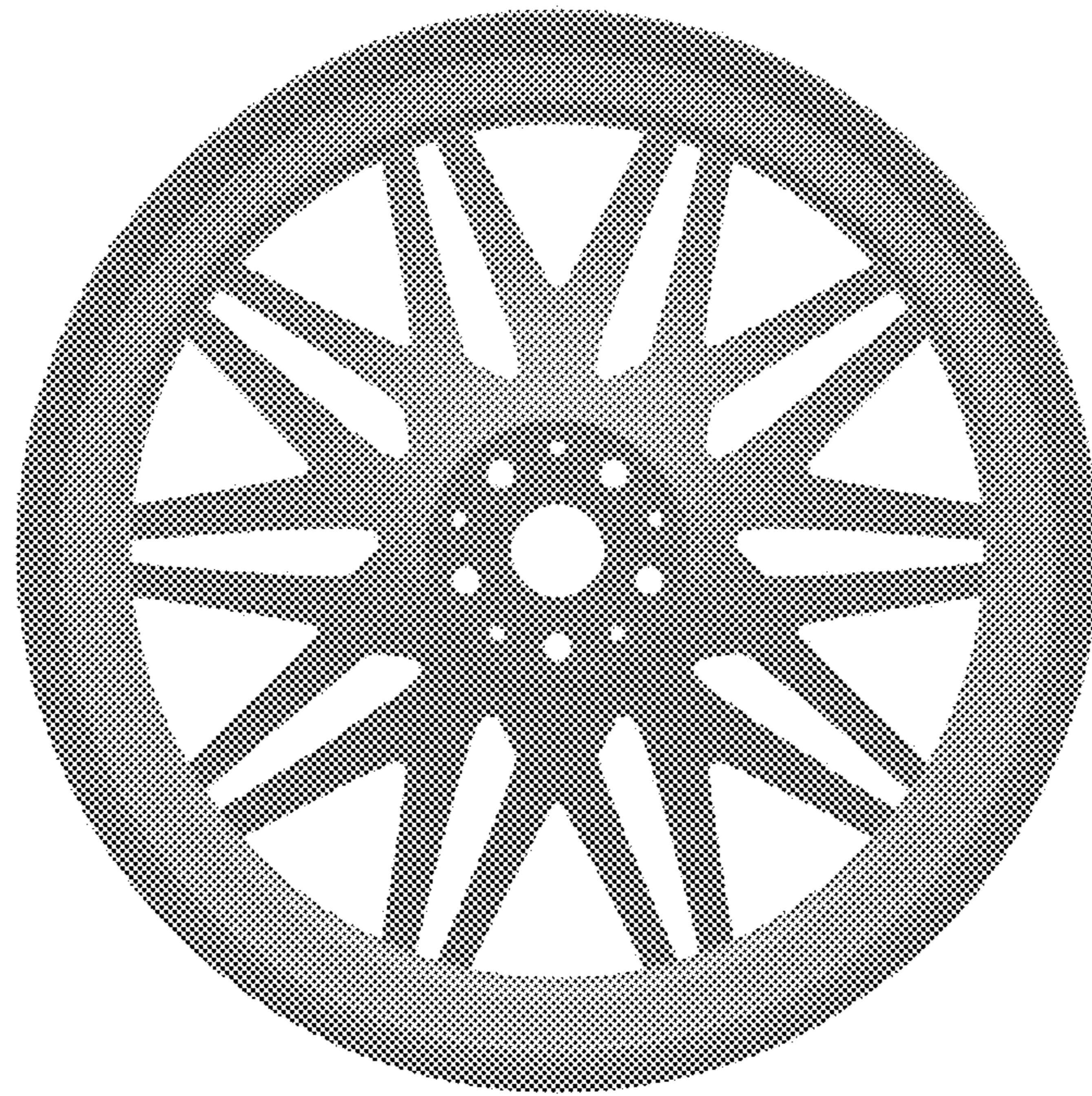

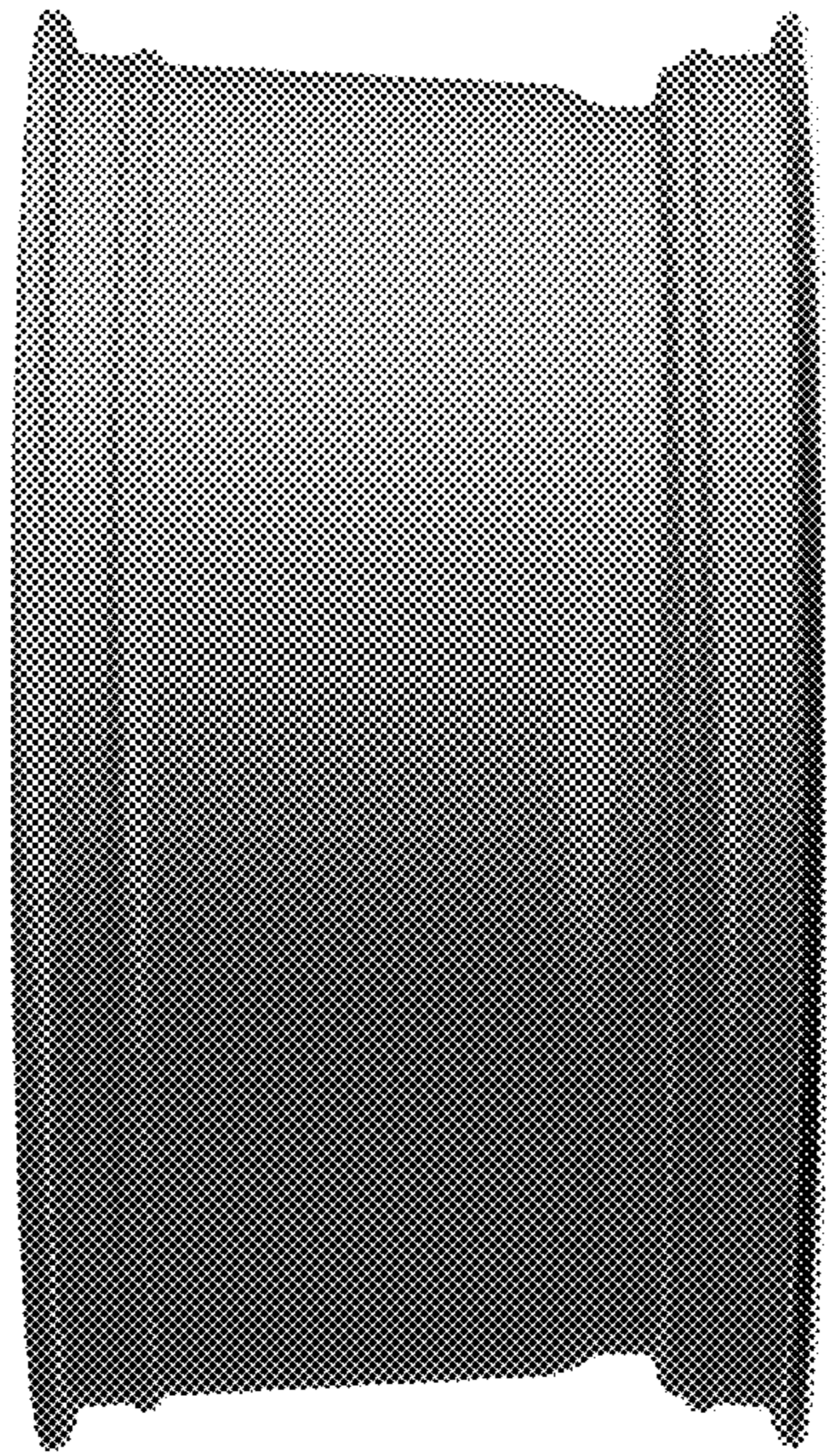
