DESCRIPTION

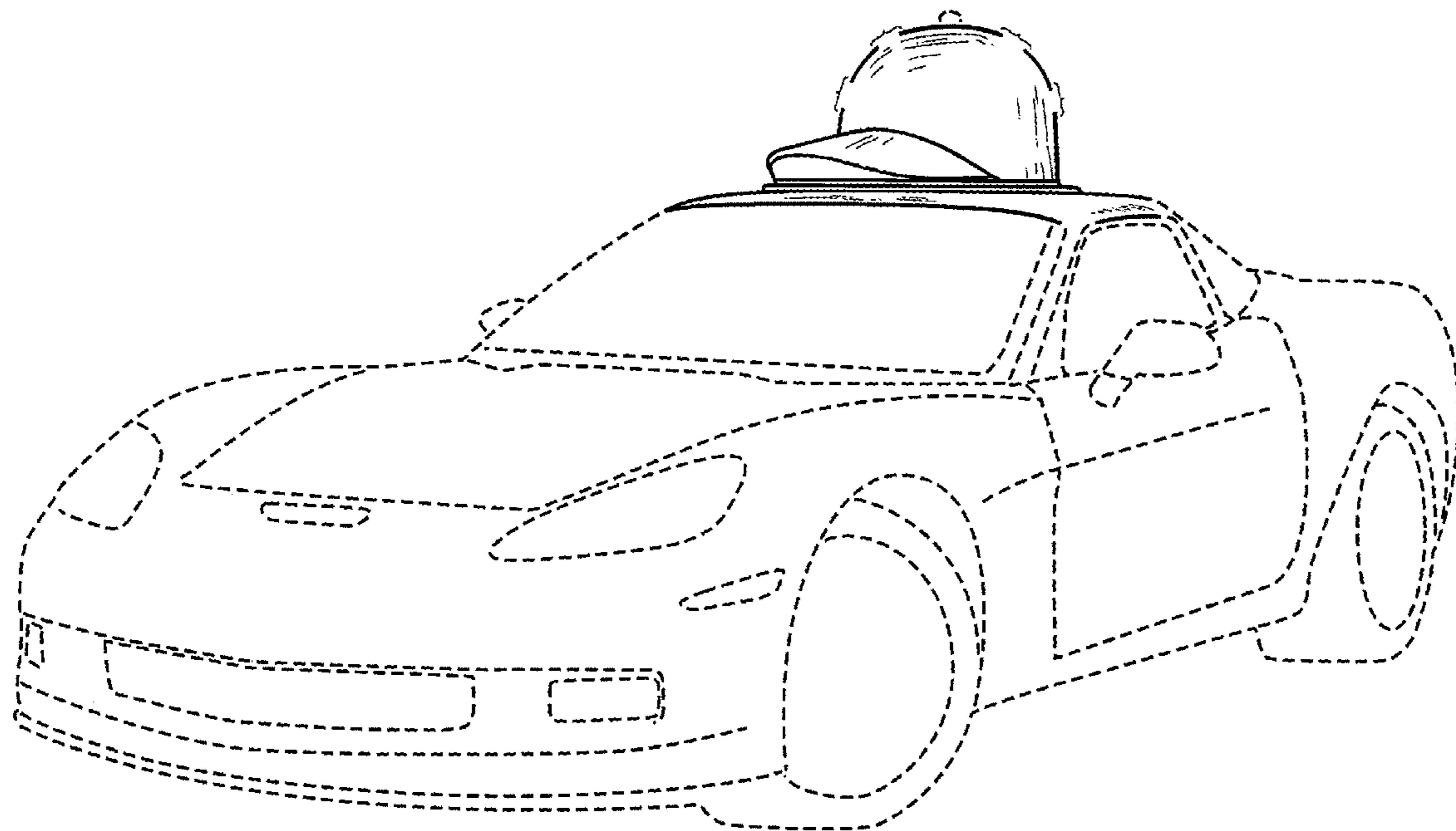
FIG. 1 is a distant front left side perspective view of the vehicle topper.

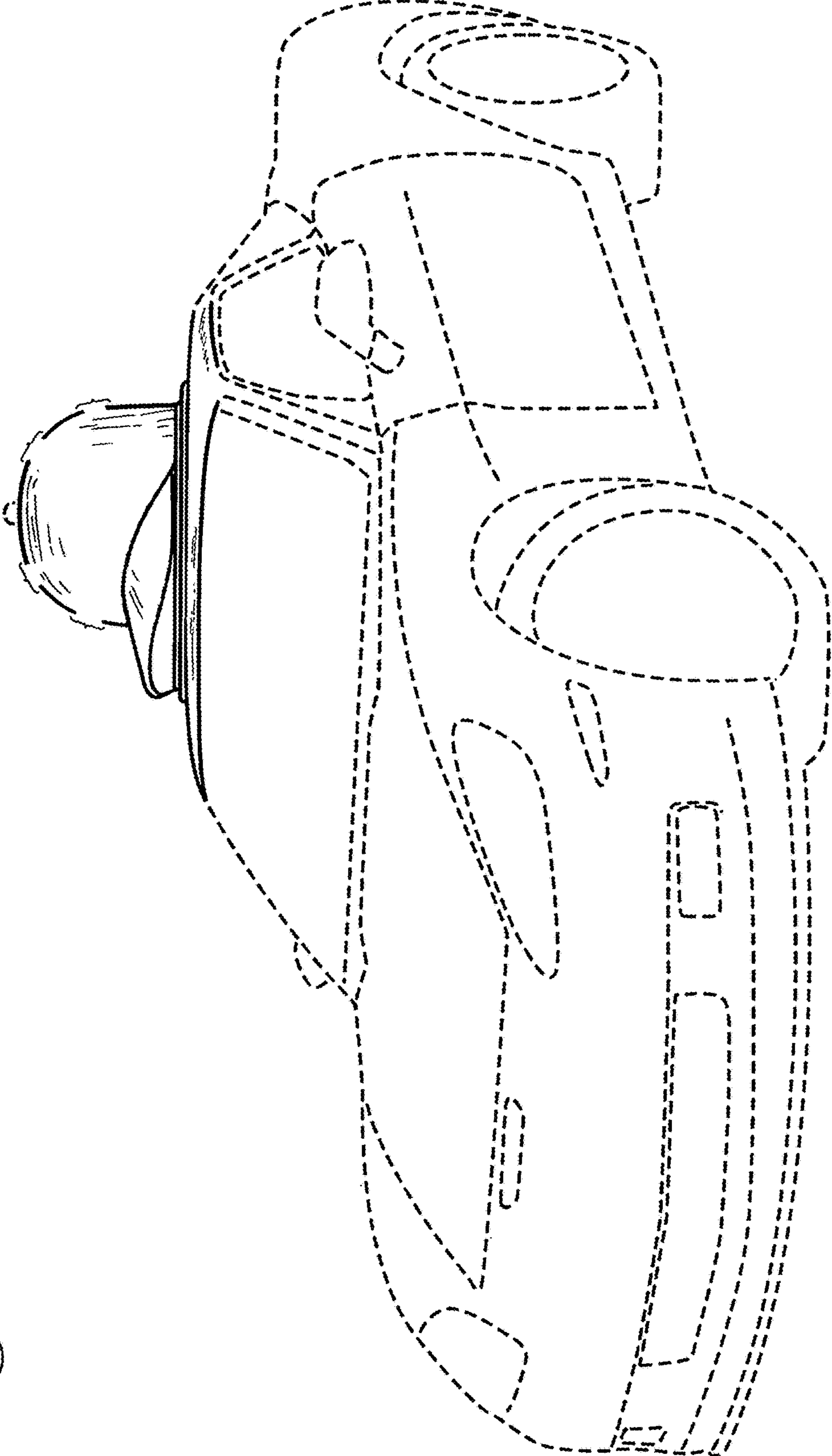
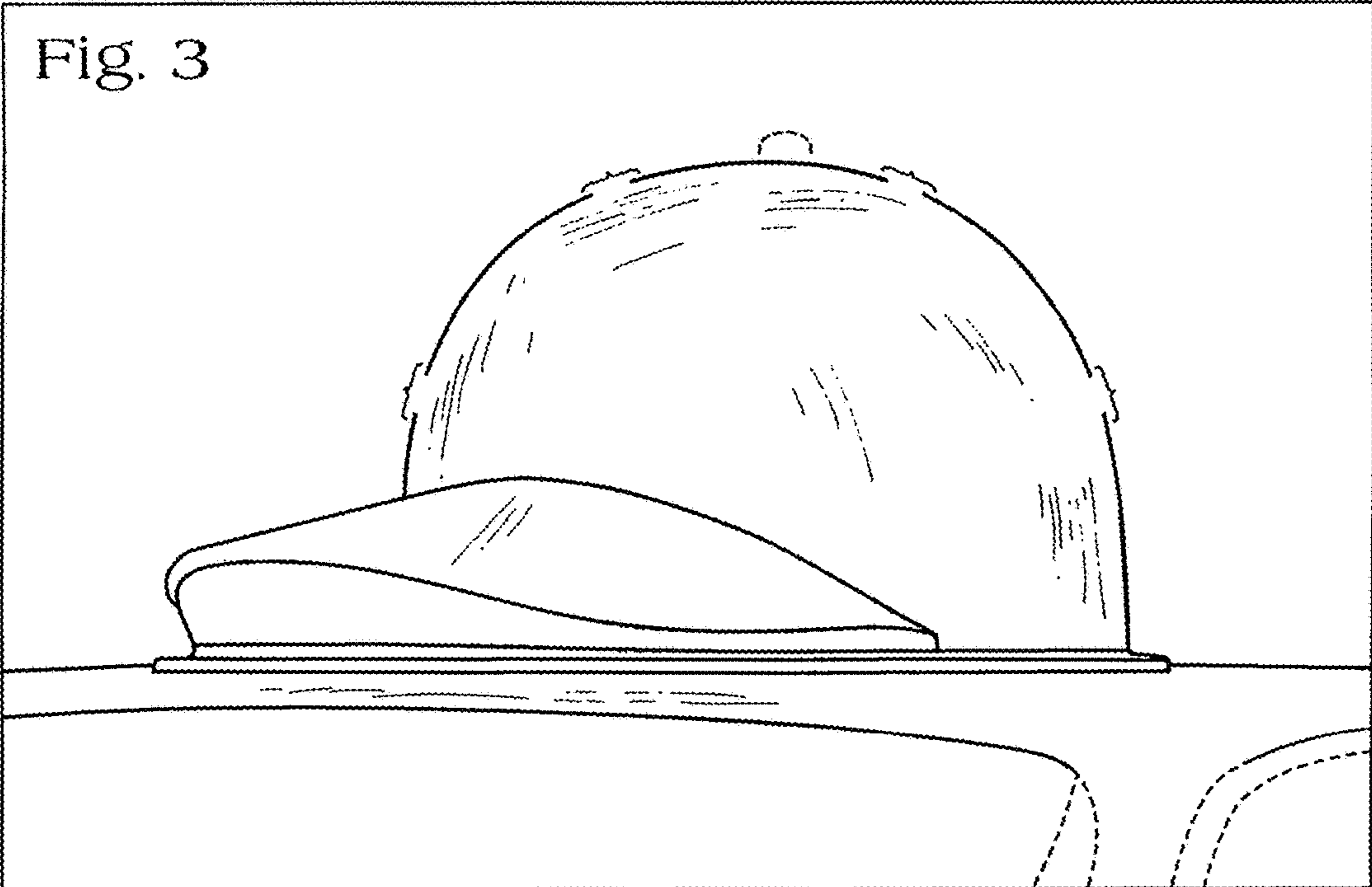
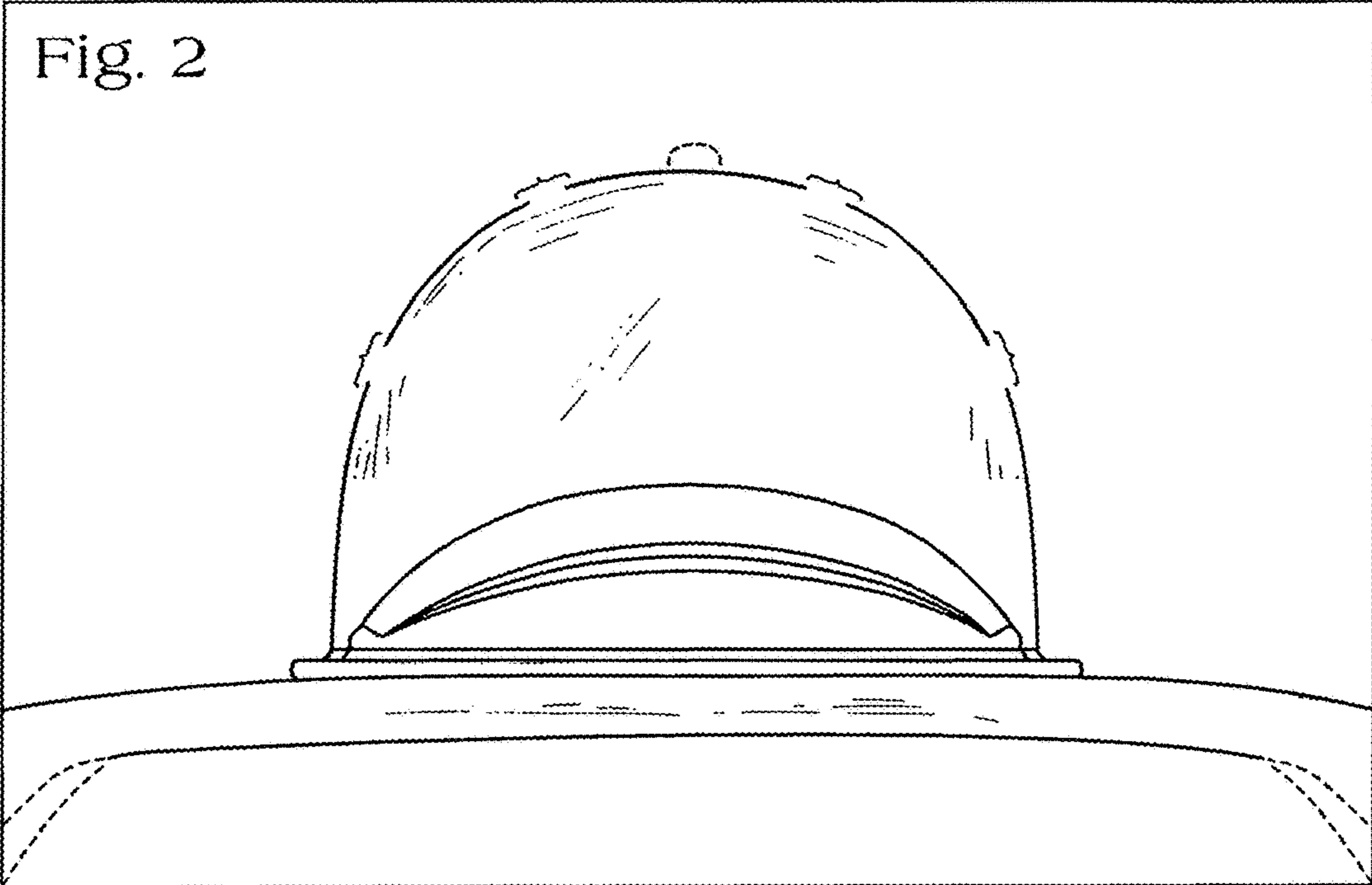
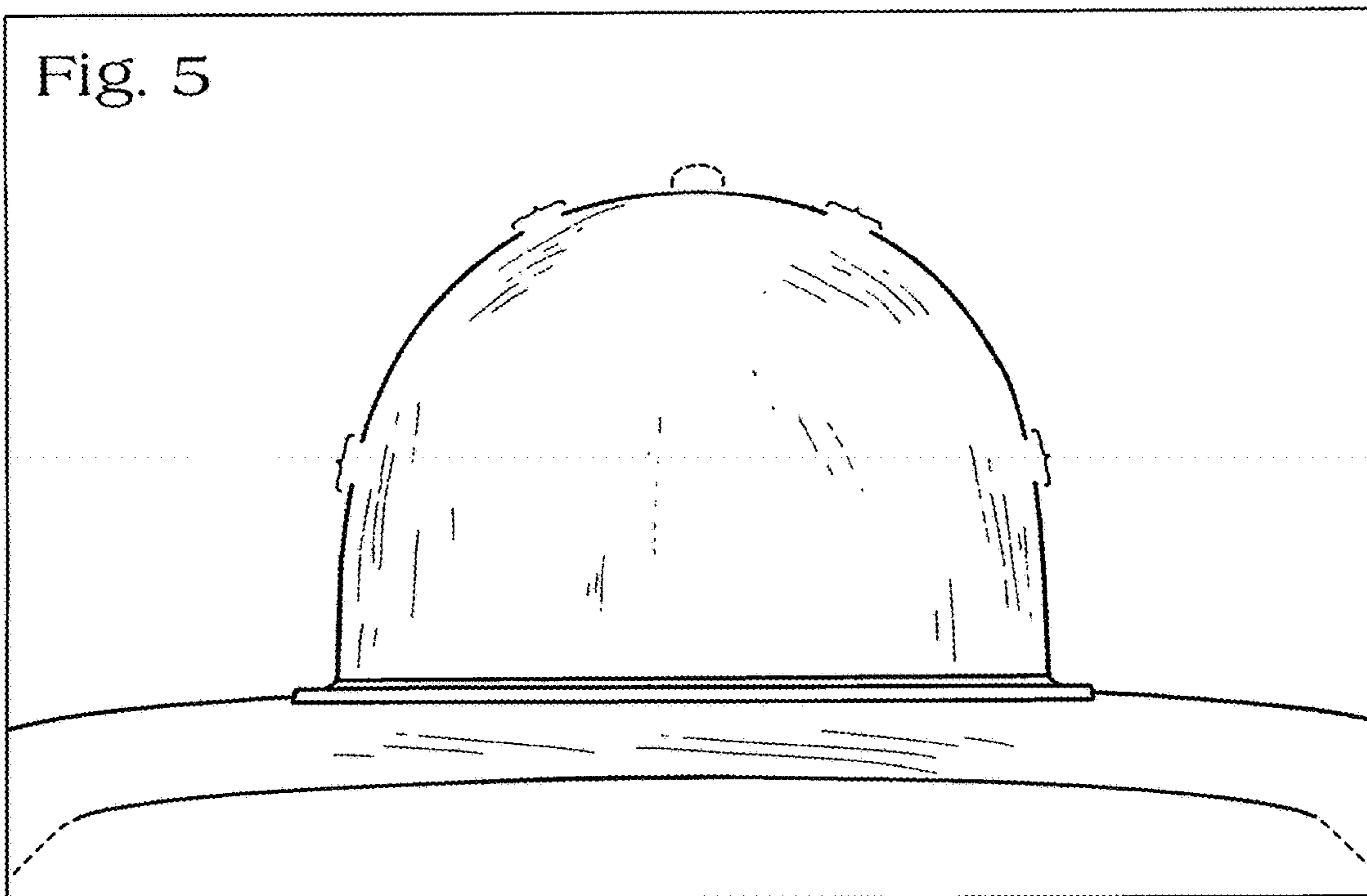
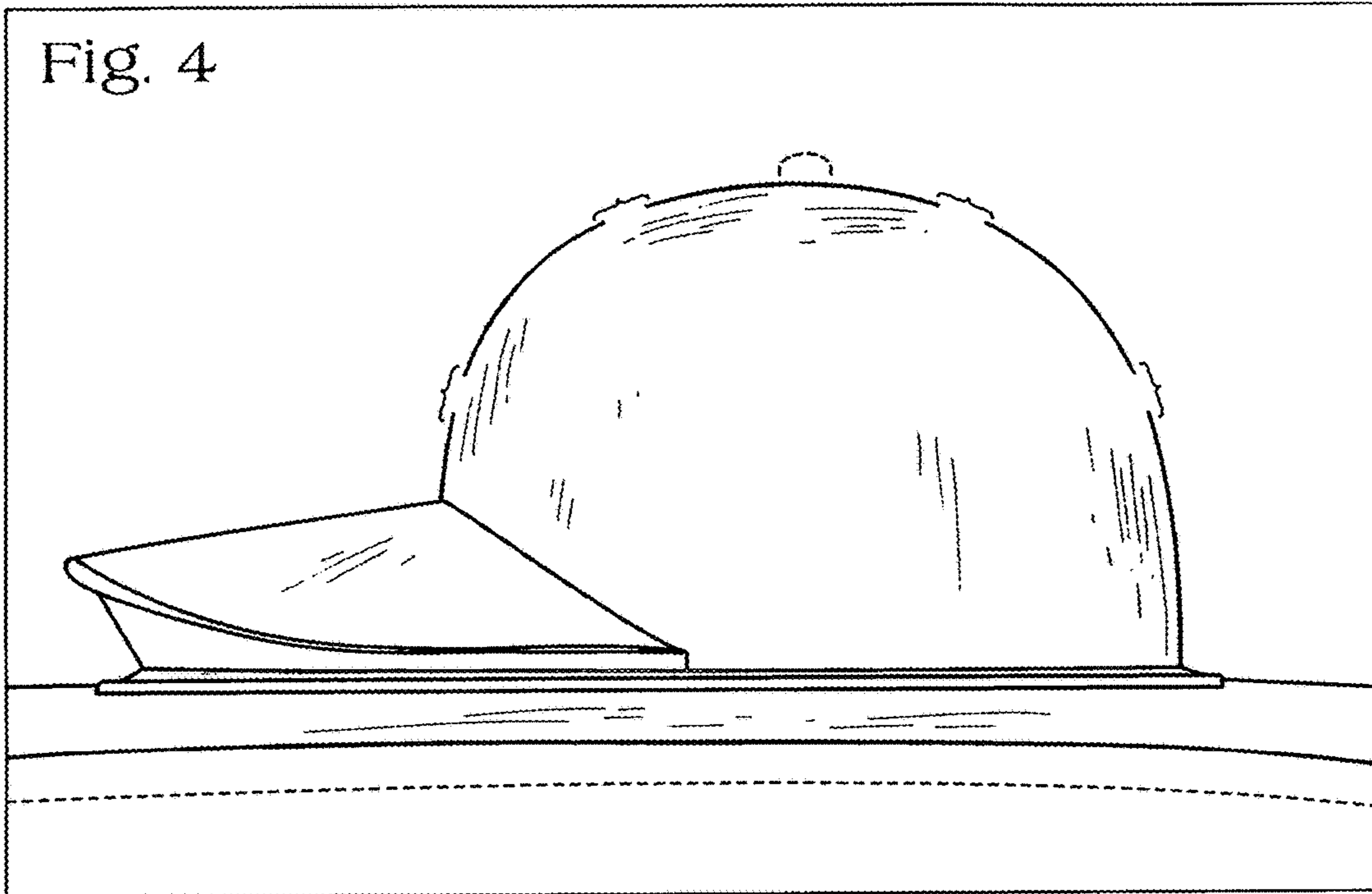
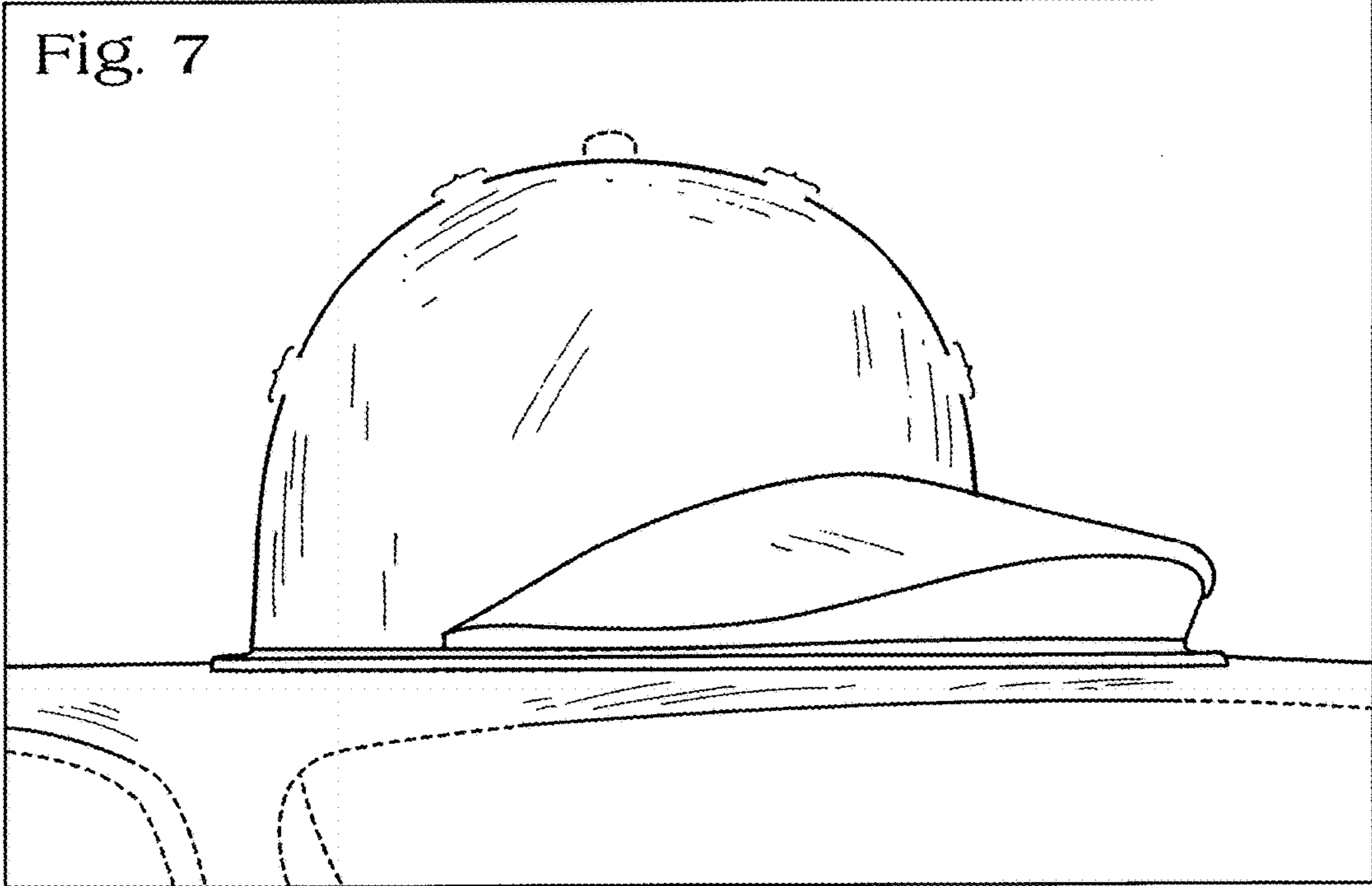
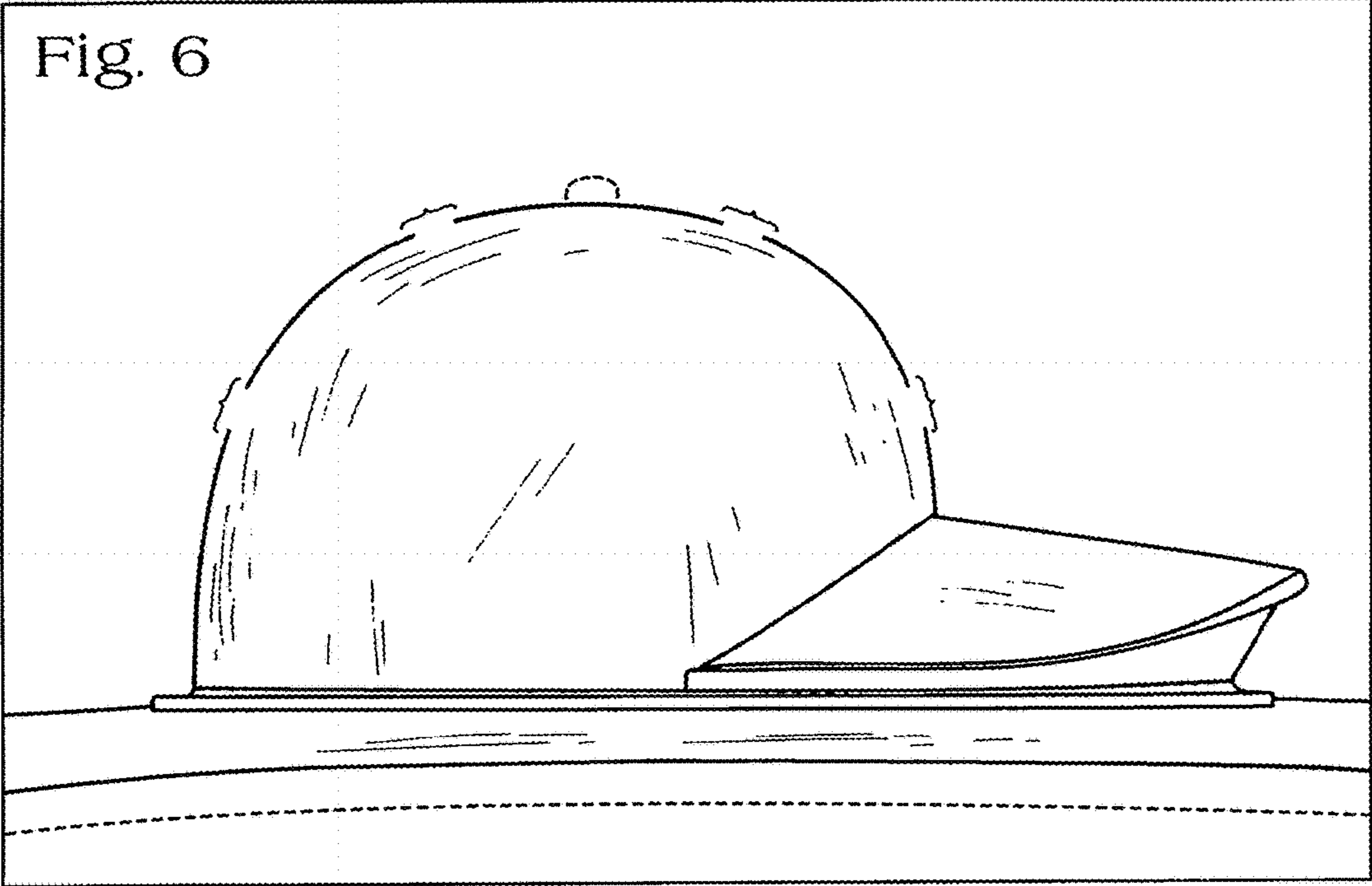
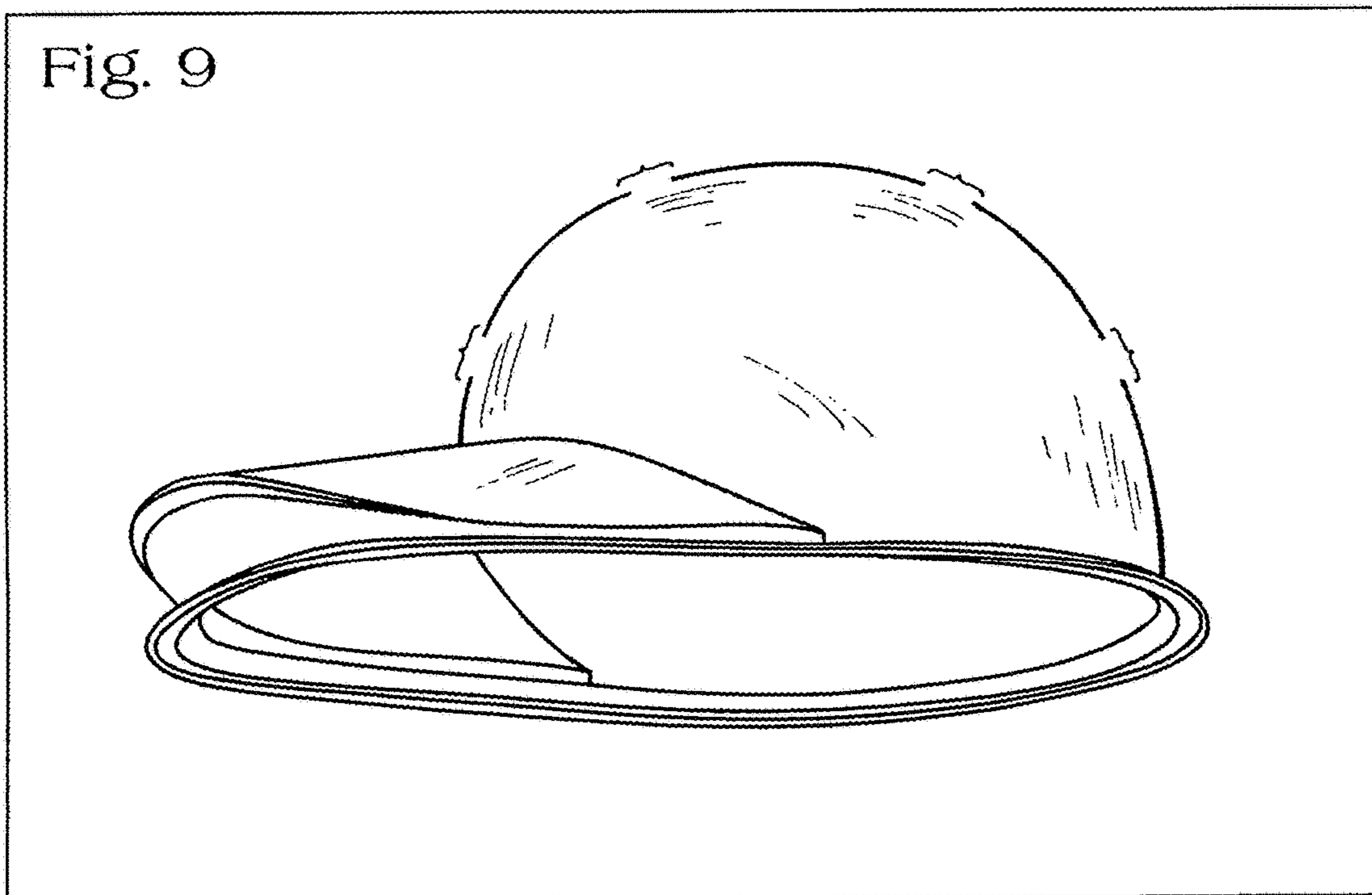
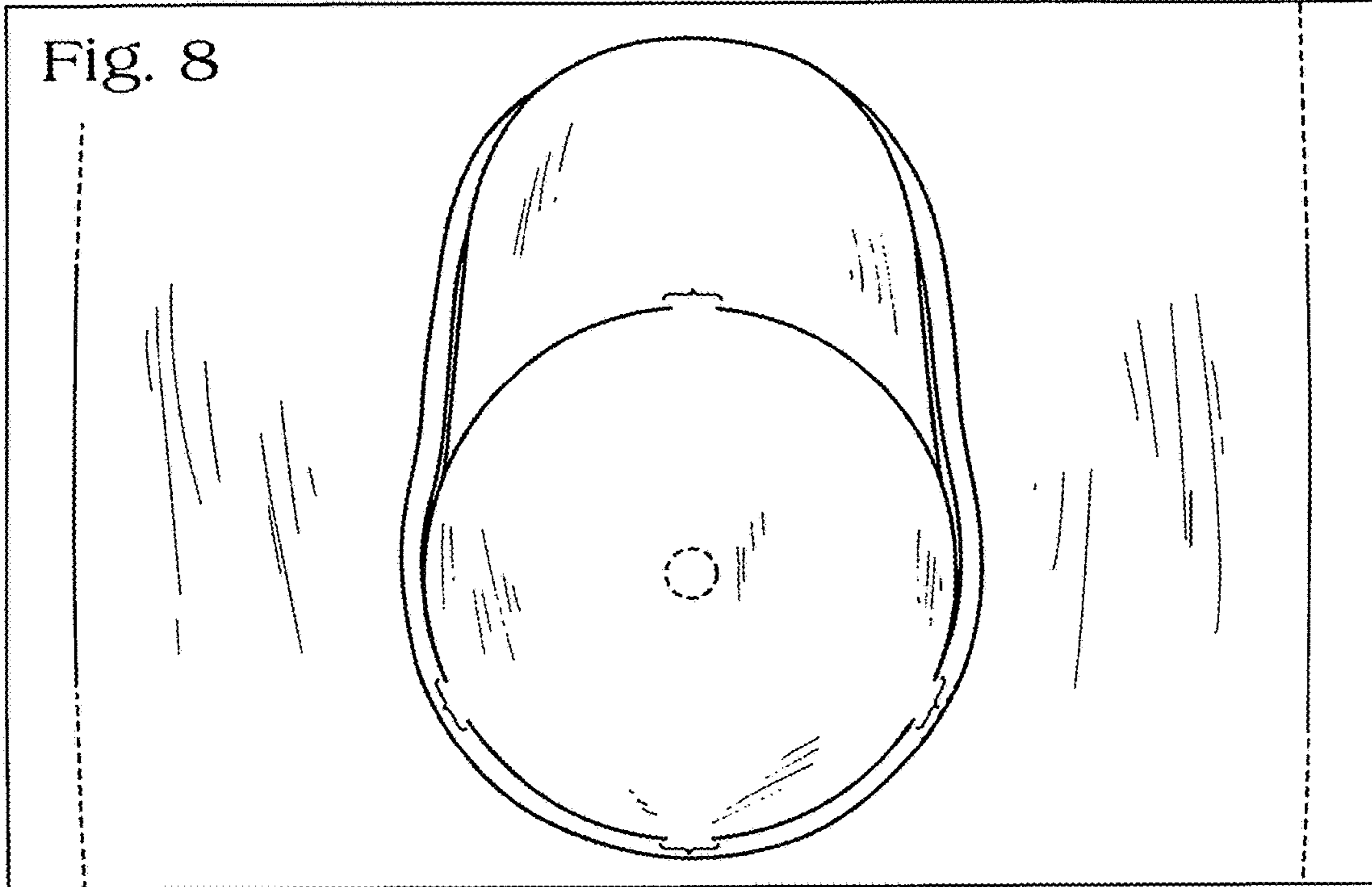

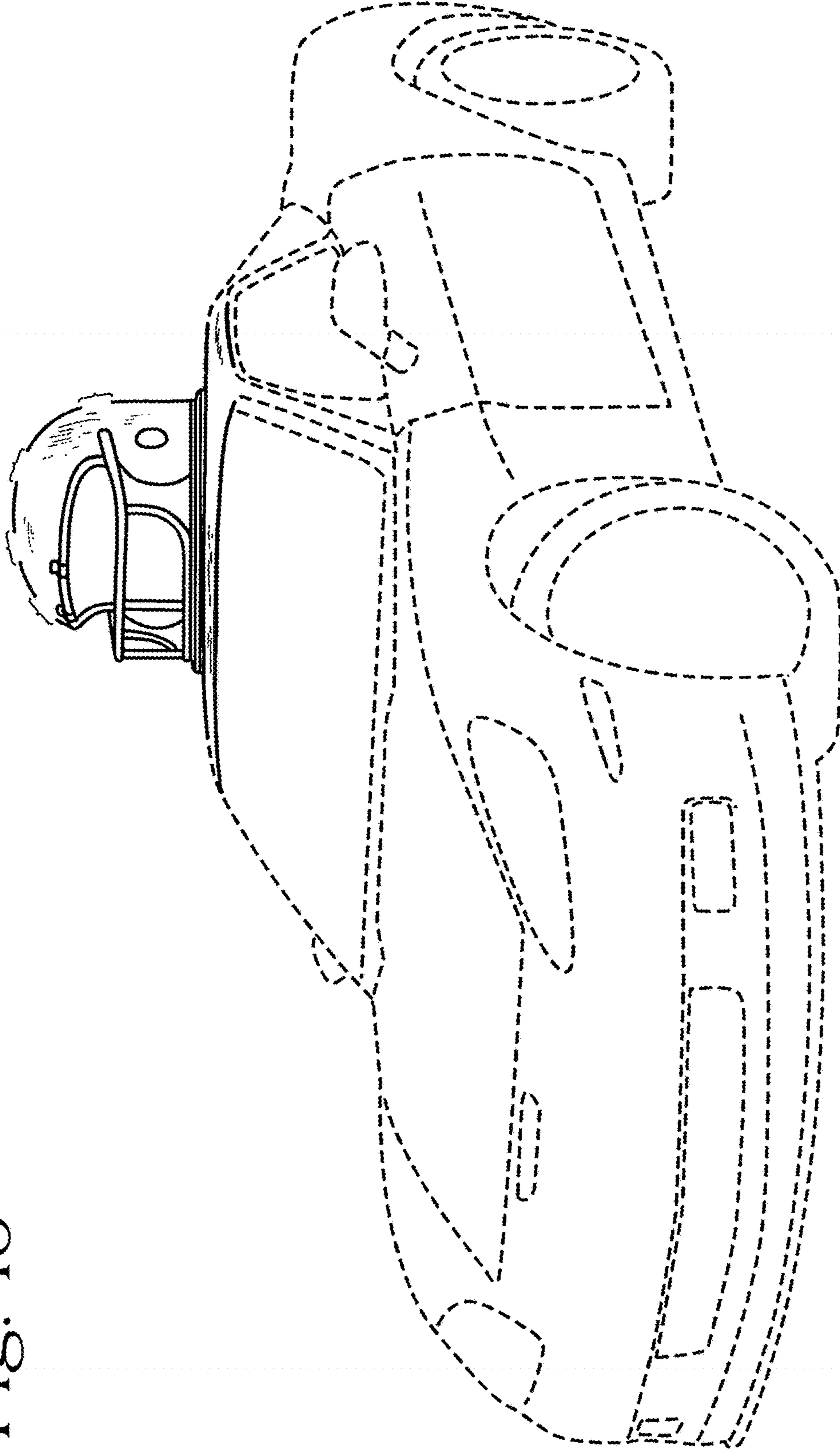
