The ornamental design for tire tread, as shown and described.

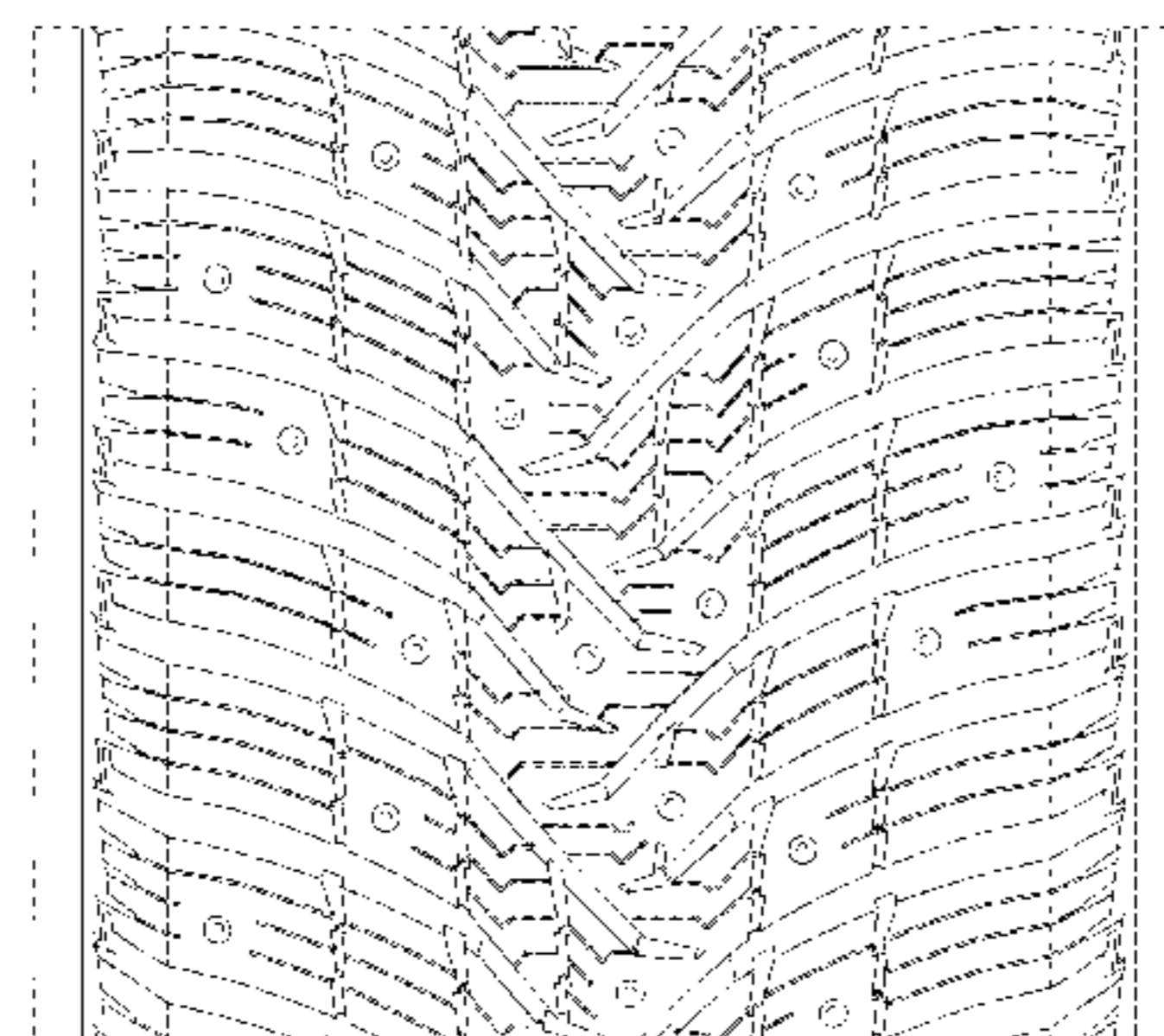
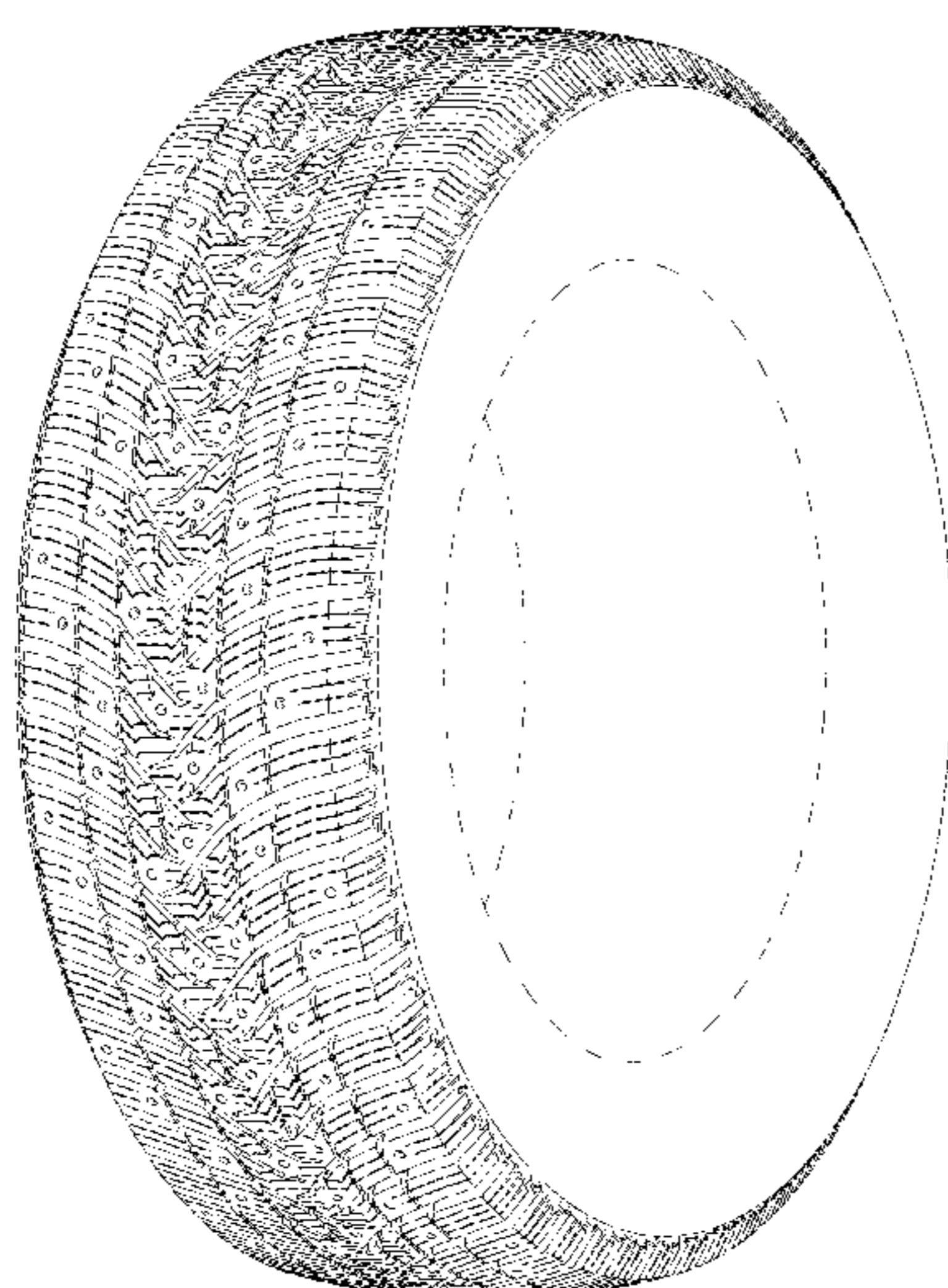
**DESCRIPTION**

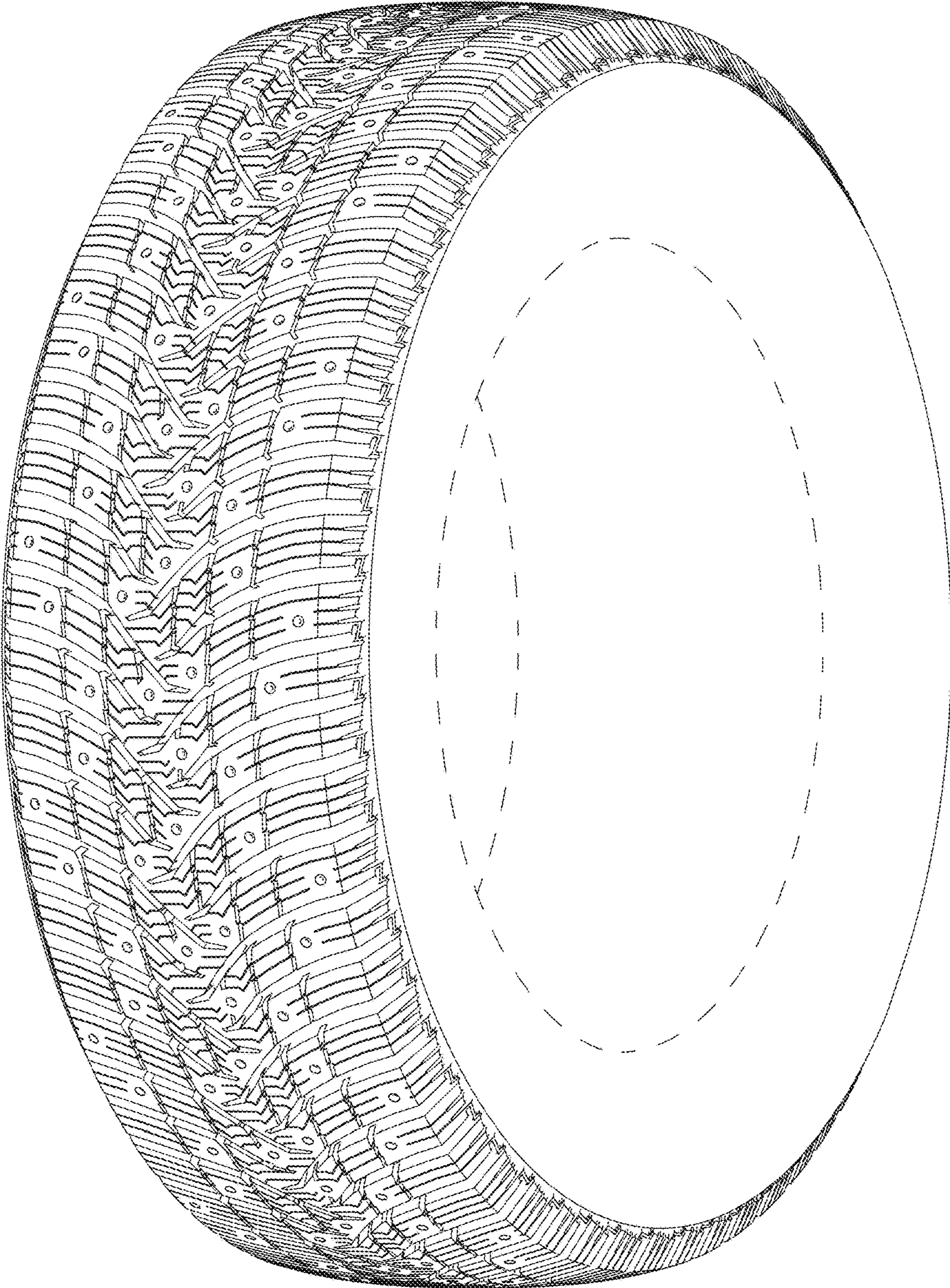

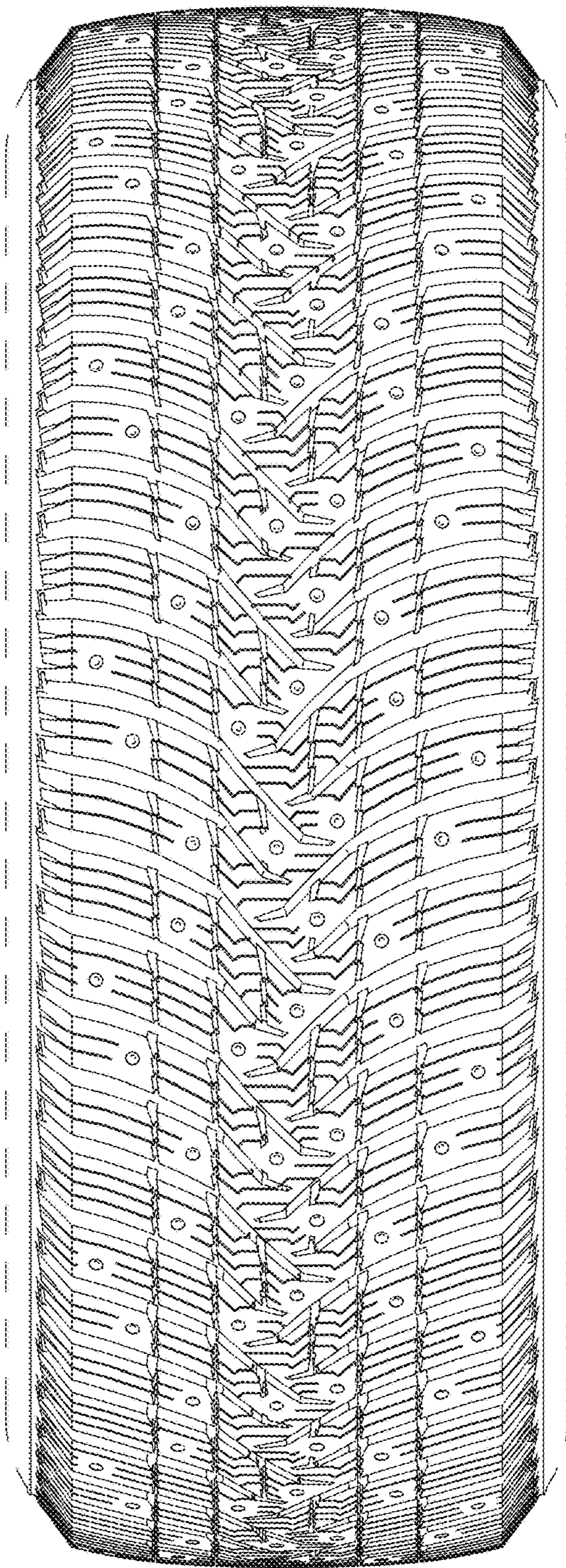

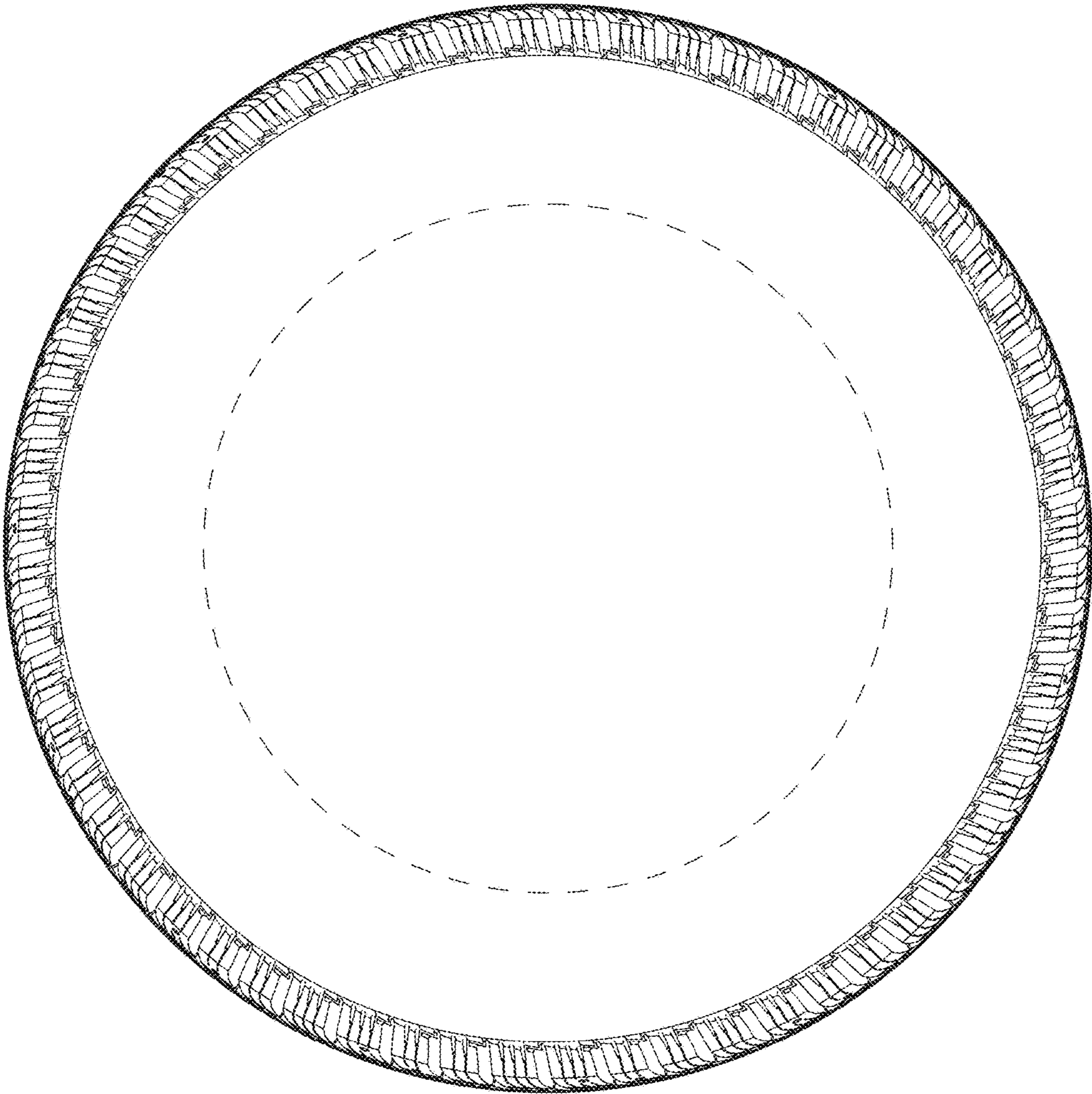

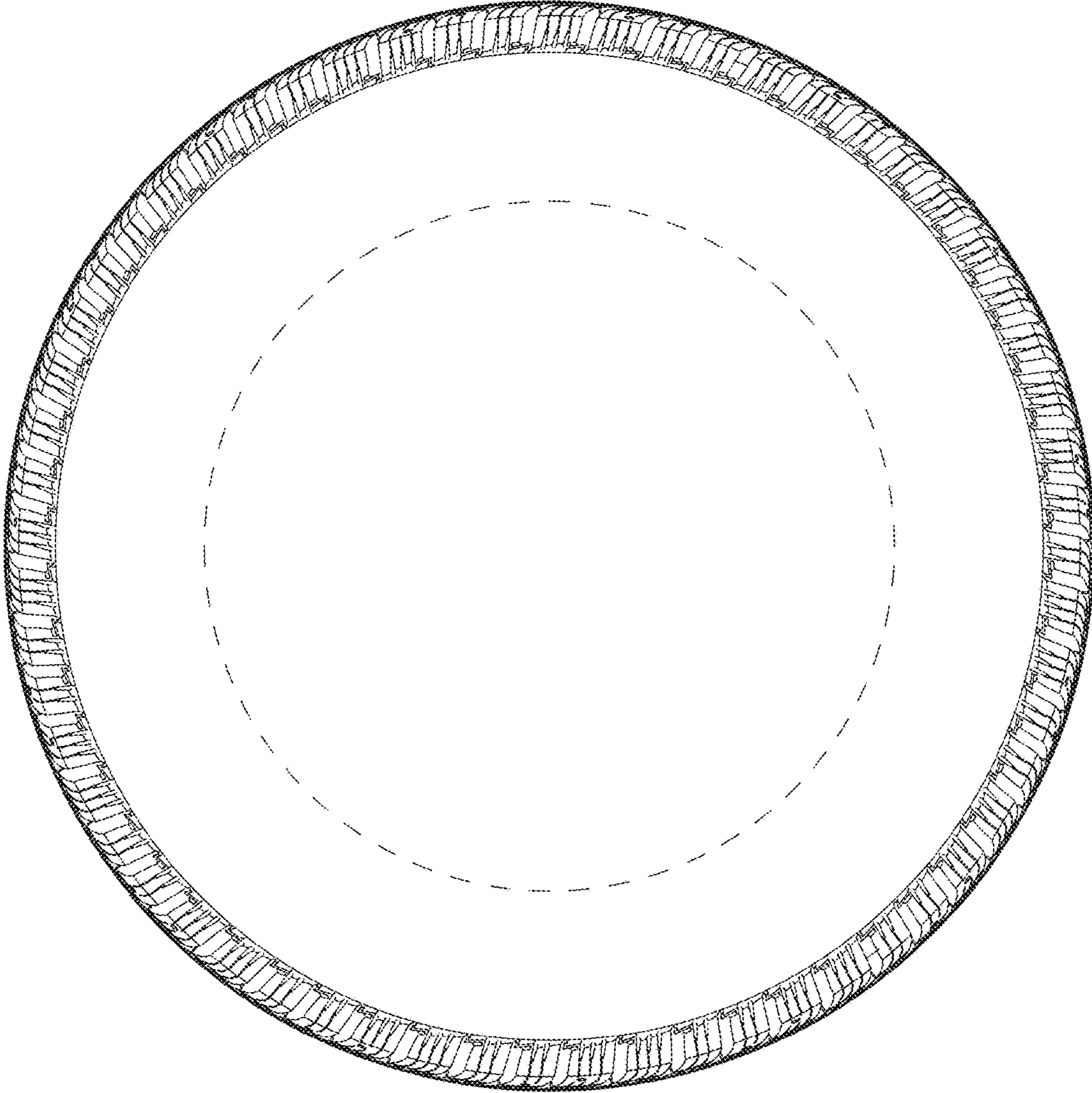

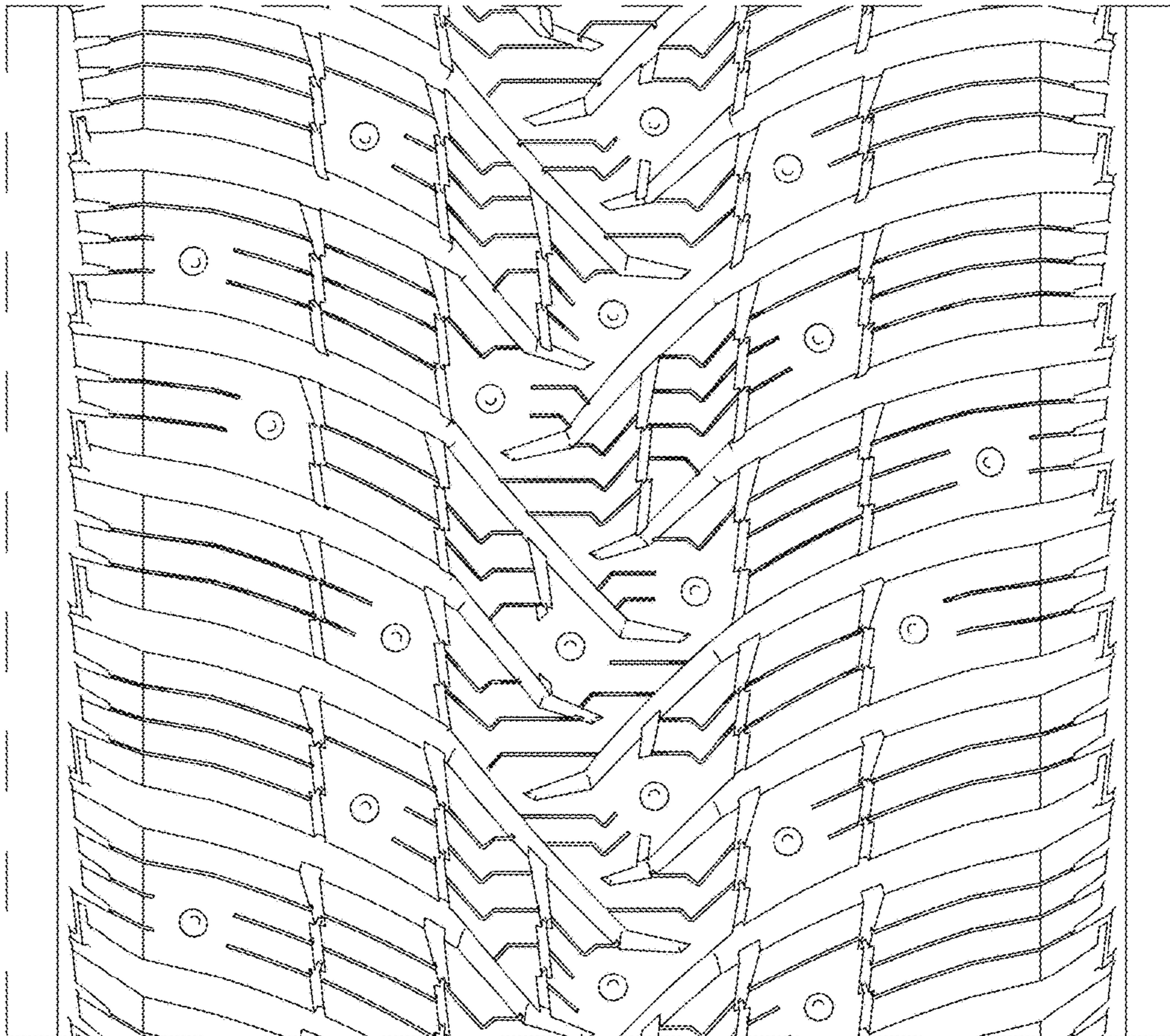
