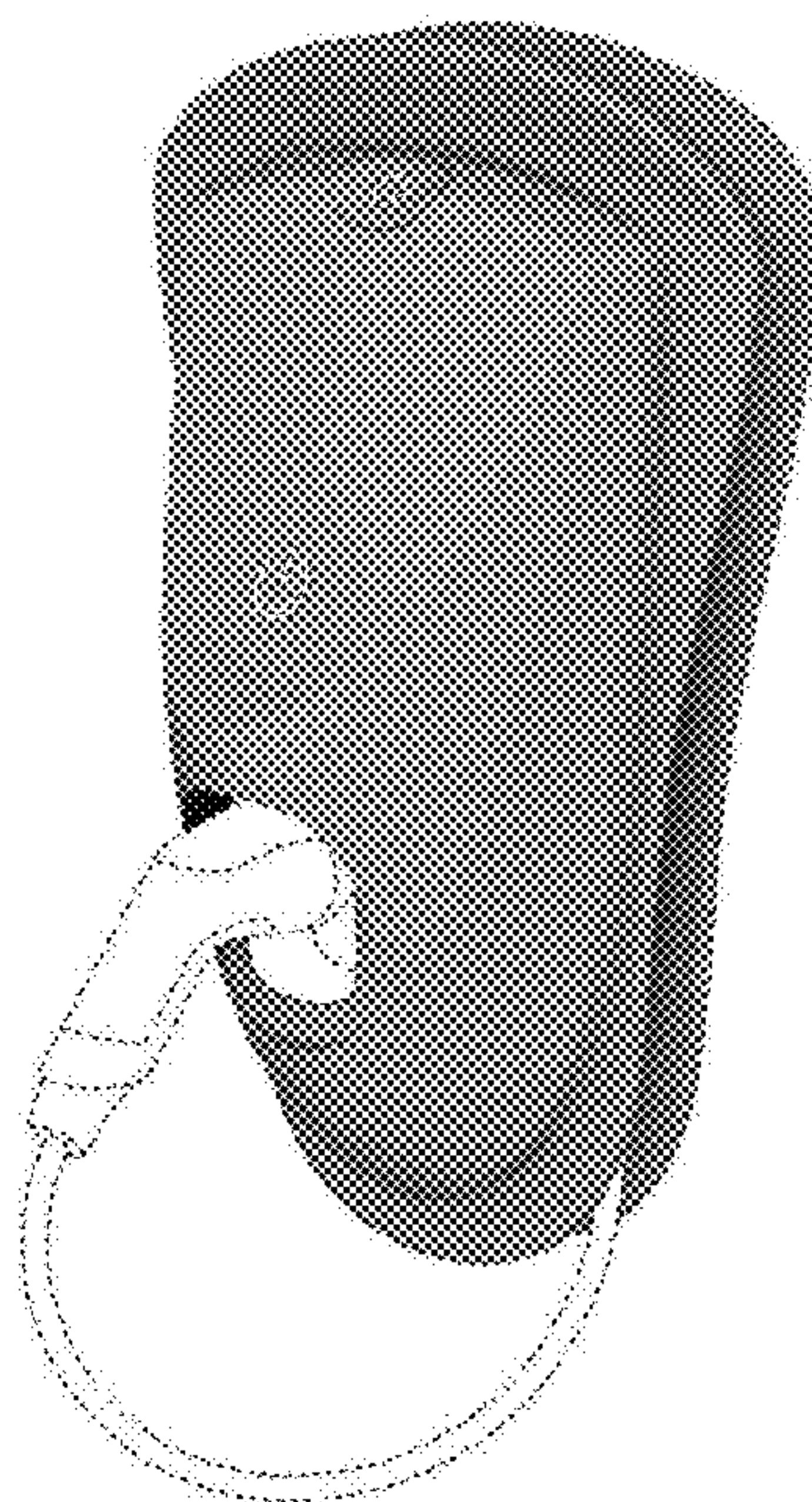
(57) **CLAIM**

The ornamental design for a holder for vehicle charging cable with connector, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a holder for vehicle charging cable with connector showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a left side elevation view thereof; FIG. 8 is a right side elevation view thereof; and, FIG. 9 is a front perspective view thereof when in use. In FIG. 9, the broken line showing of the automobile is provided for the purpose of illustrating environmental structure and forms no part of the claimed design. All other broken lines in the drawings illustrate portions of the holder for vehicle charging cable with connector that form no part of the claimed design.

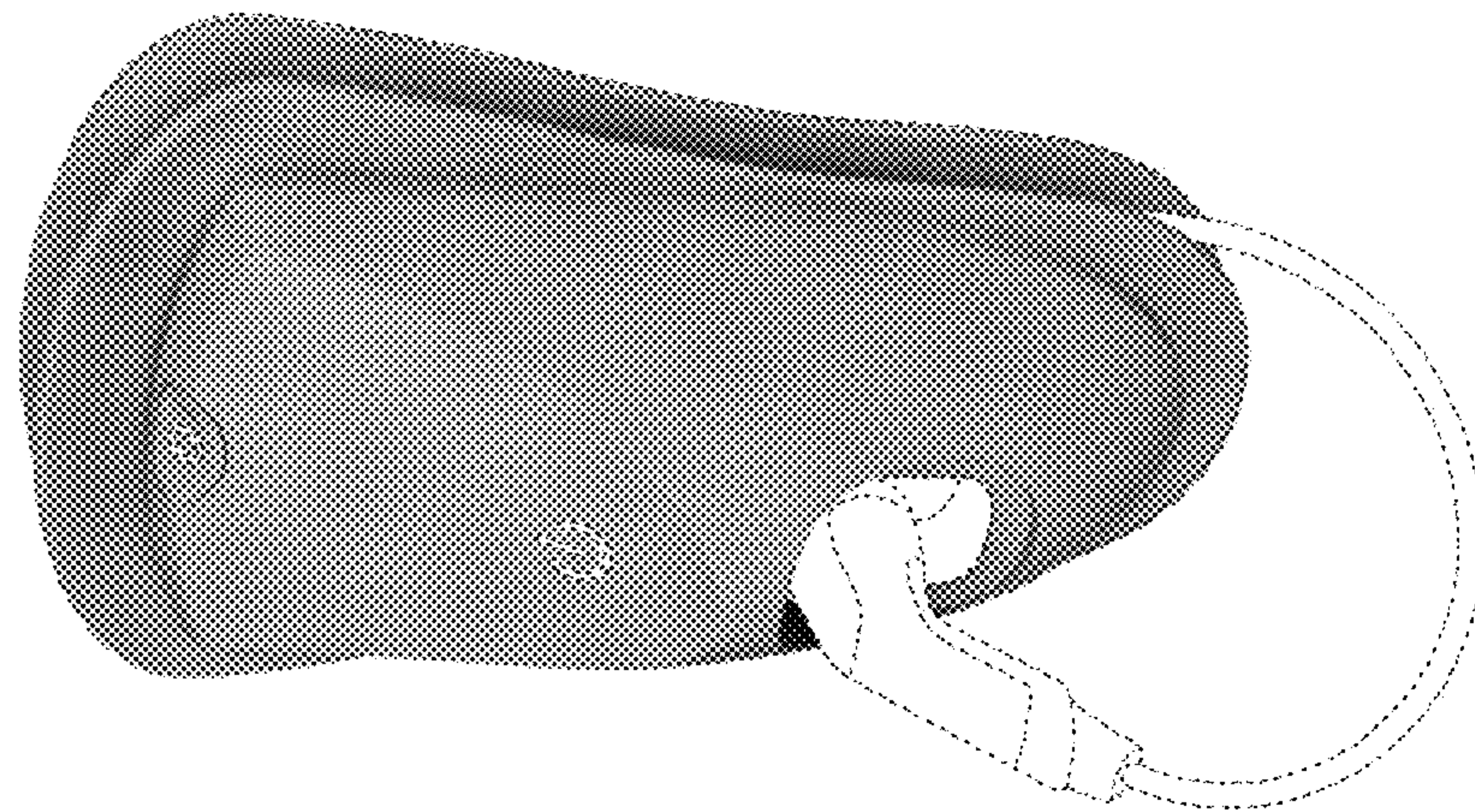

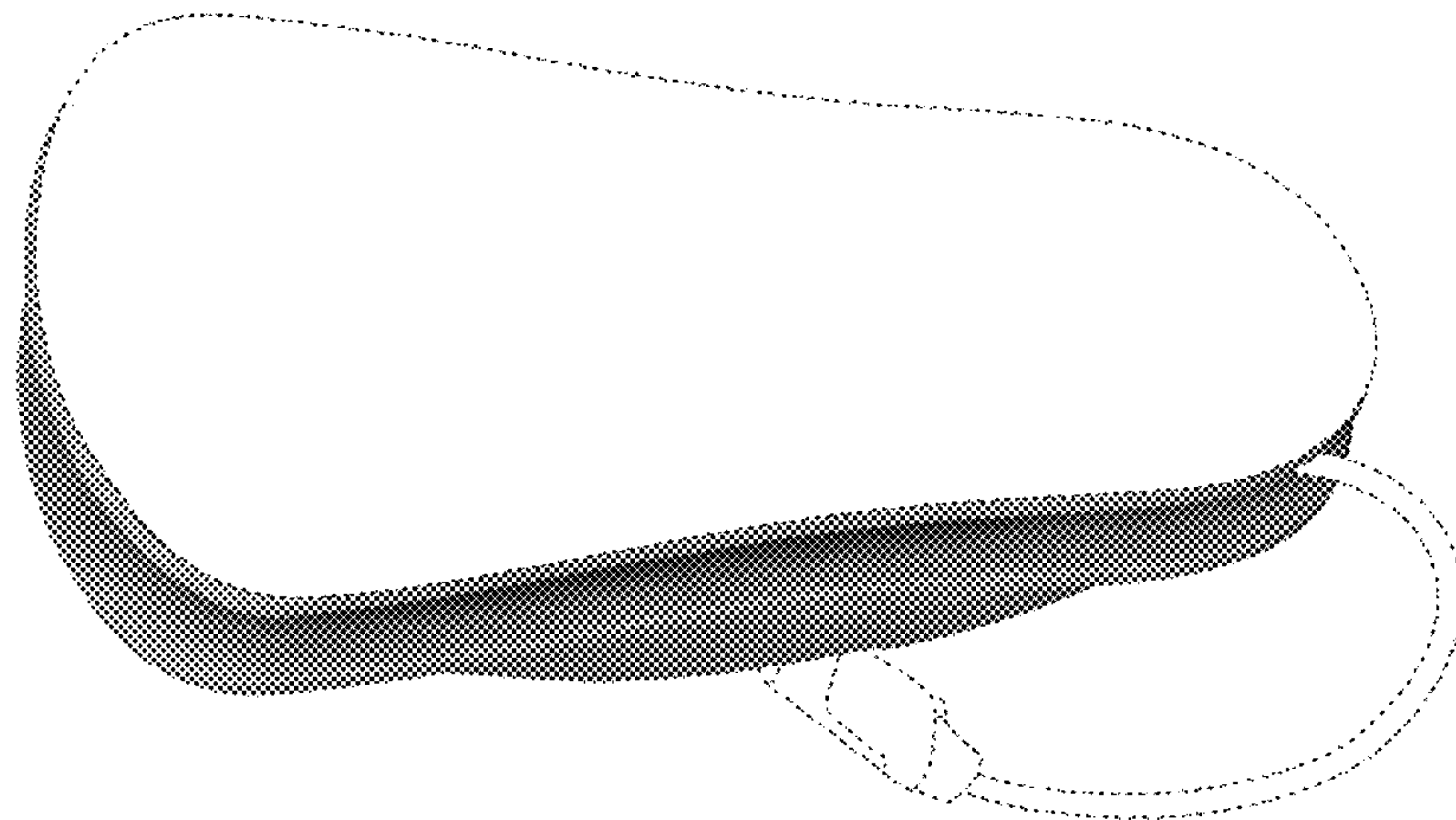

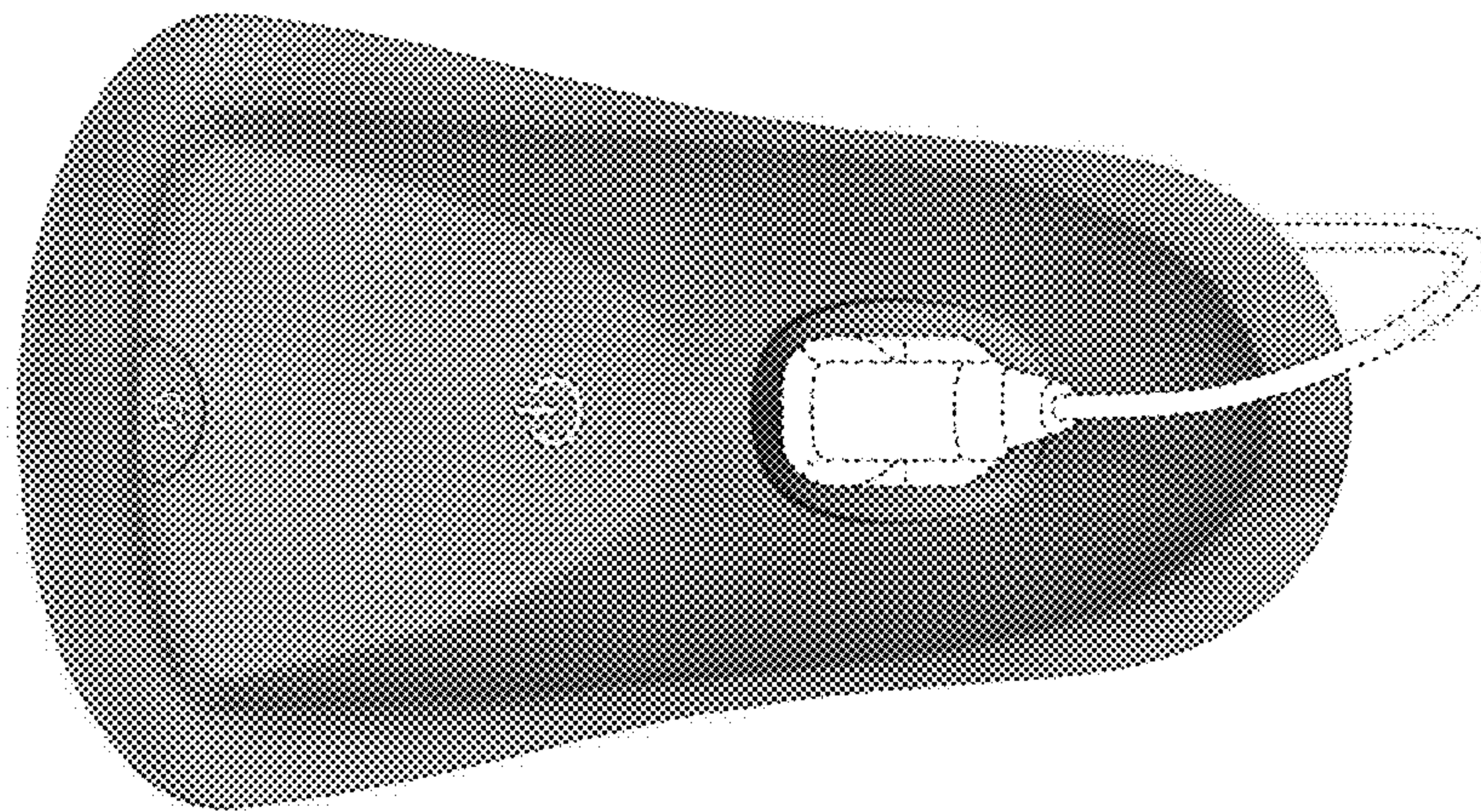

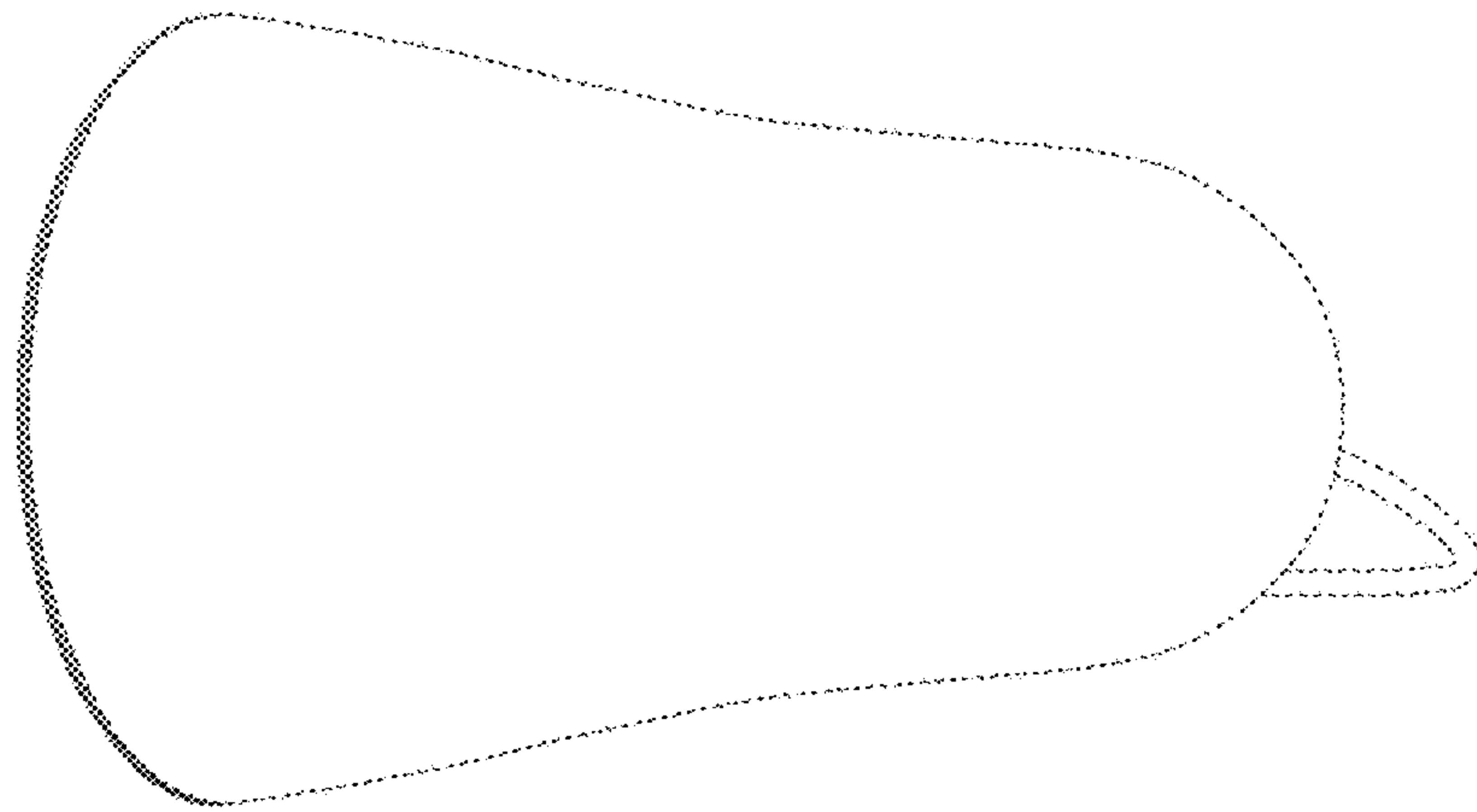

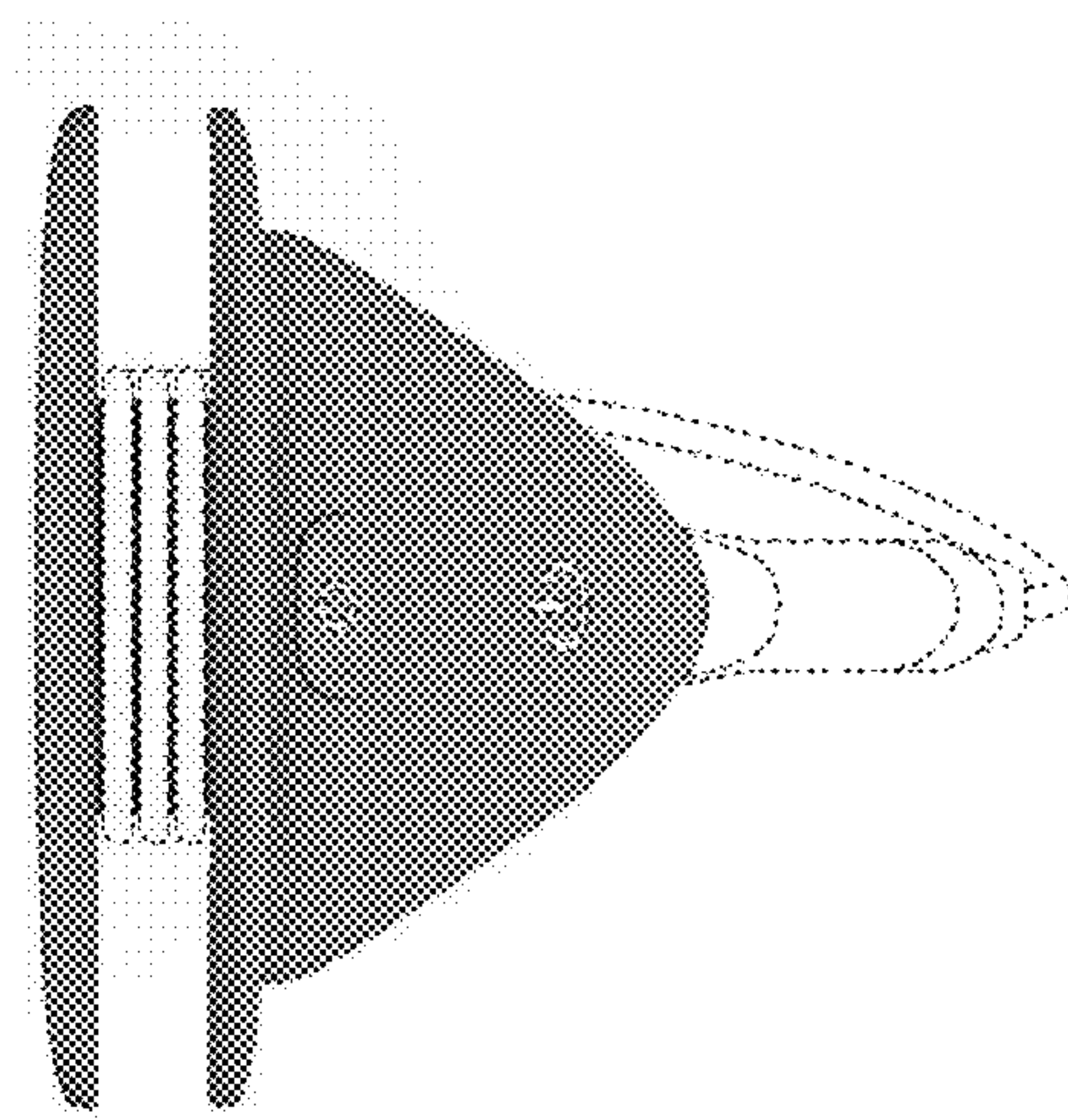

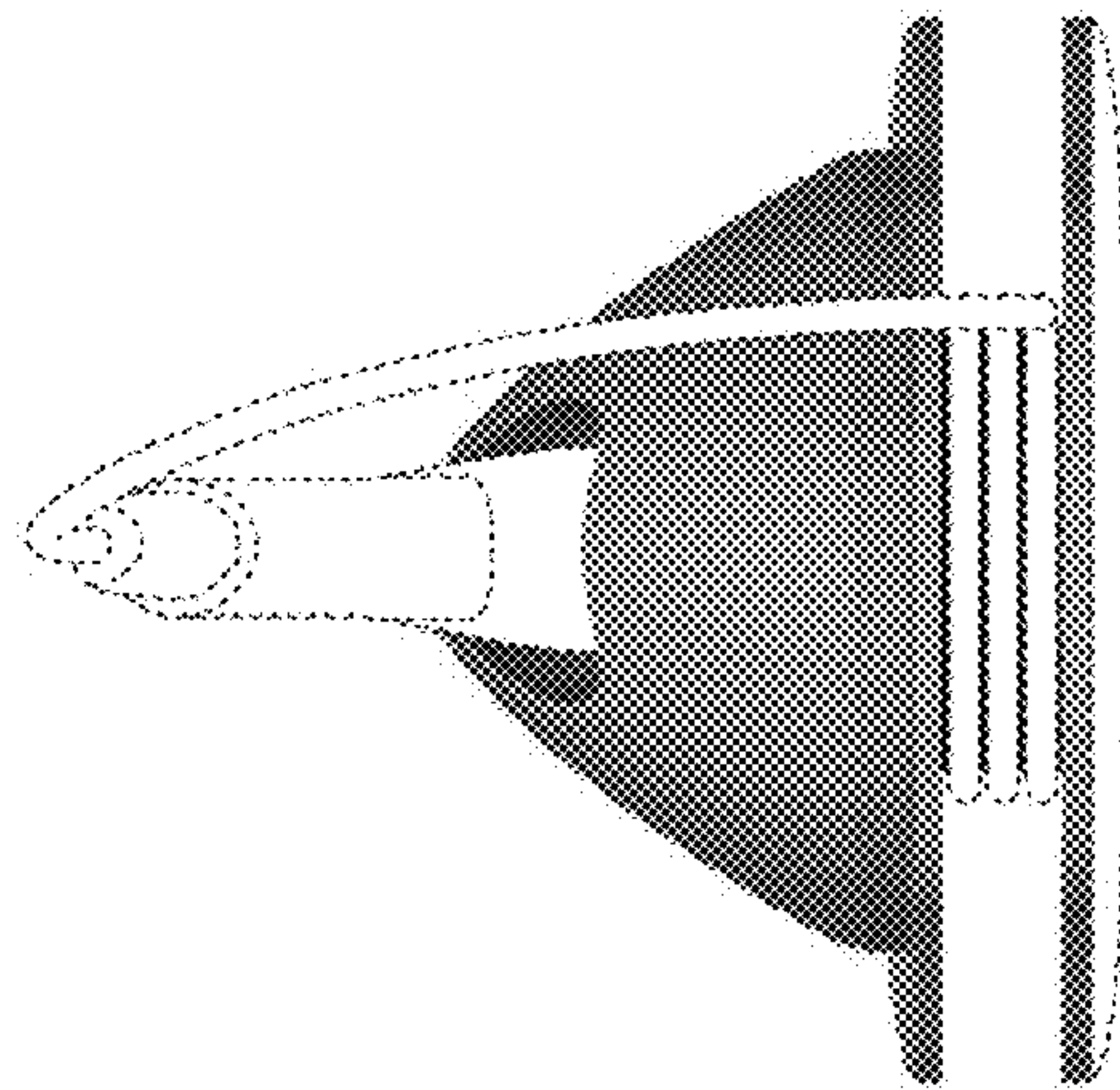

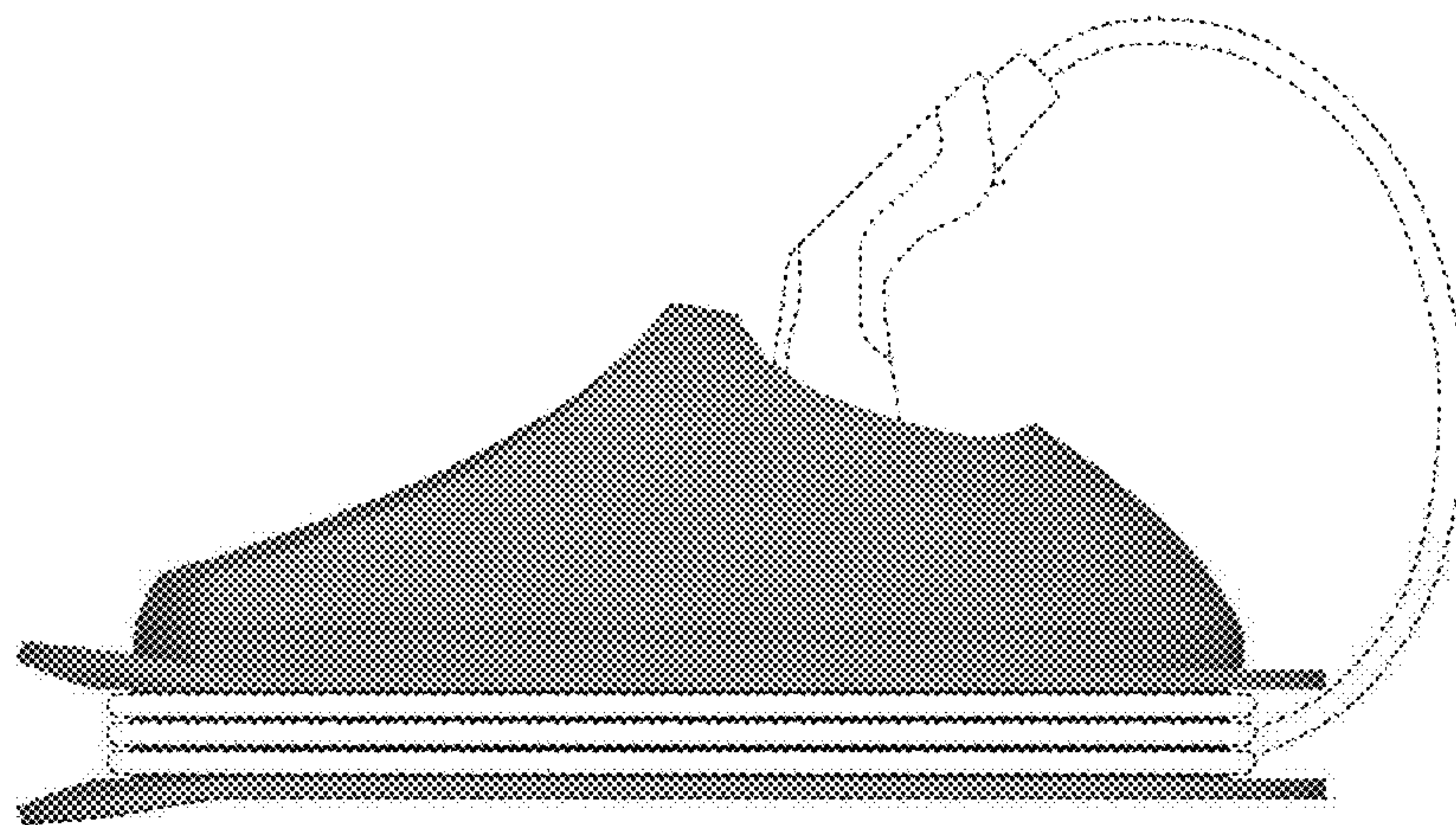

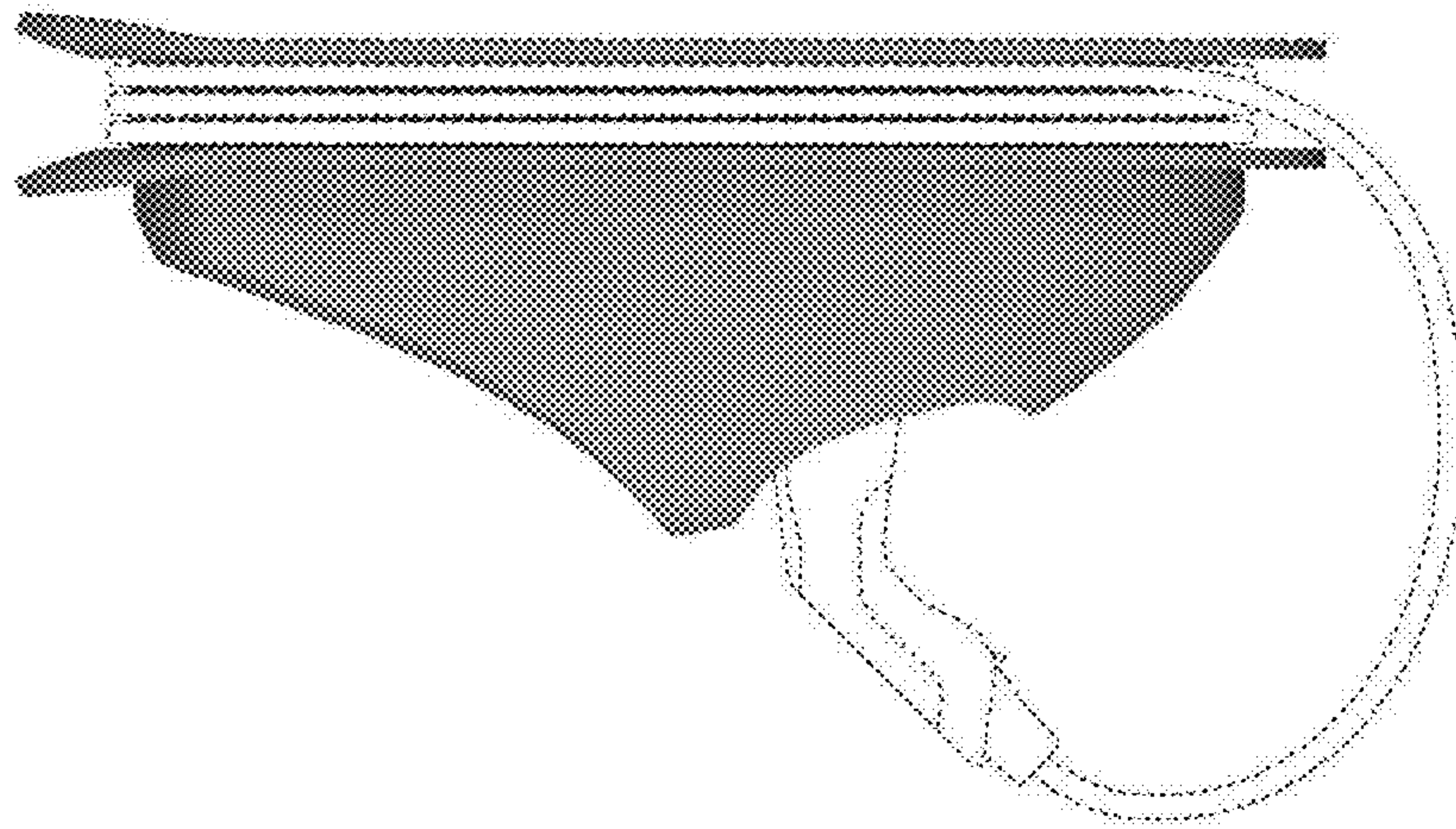

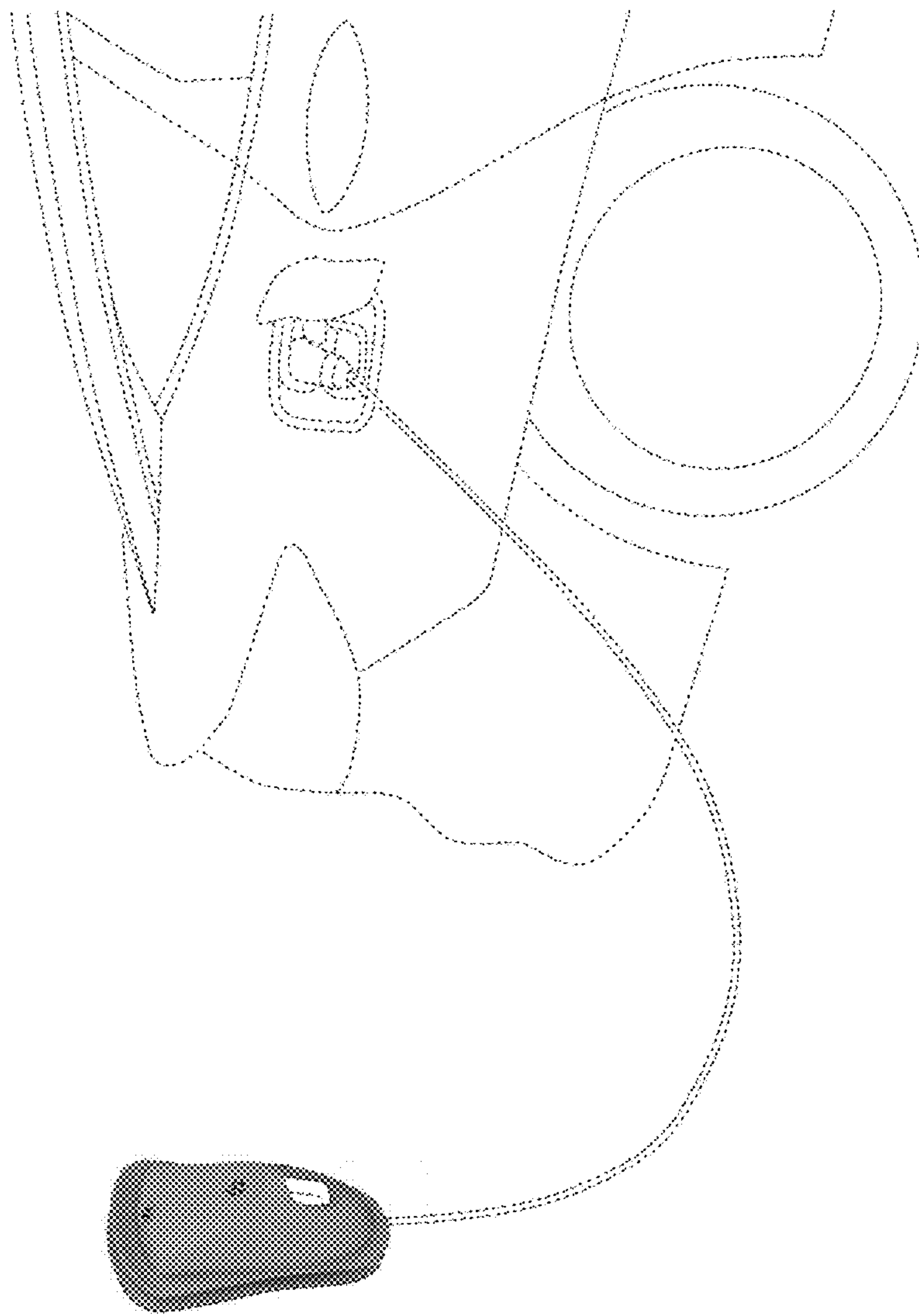
