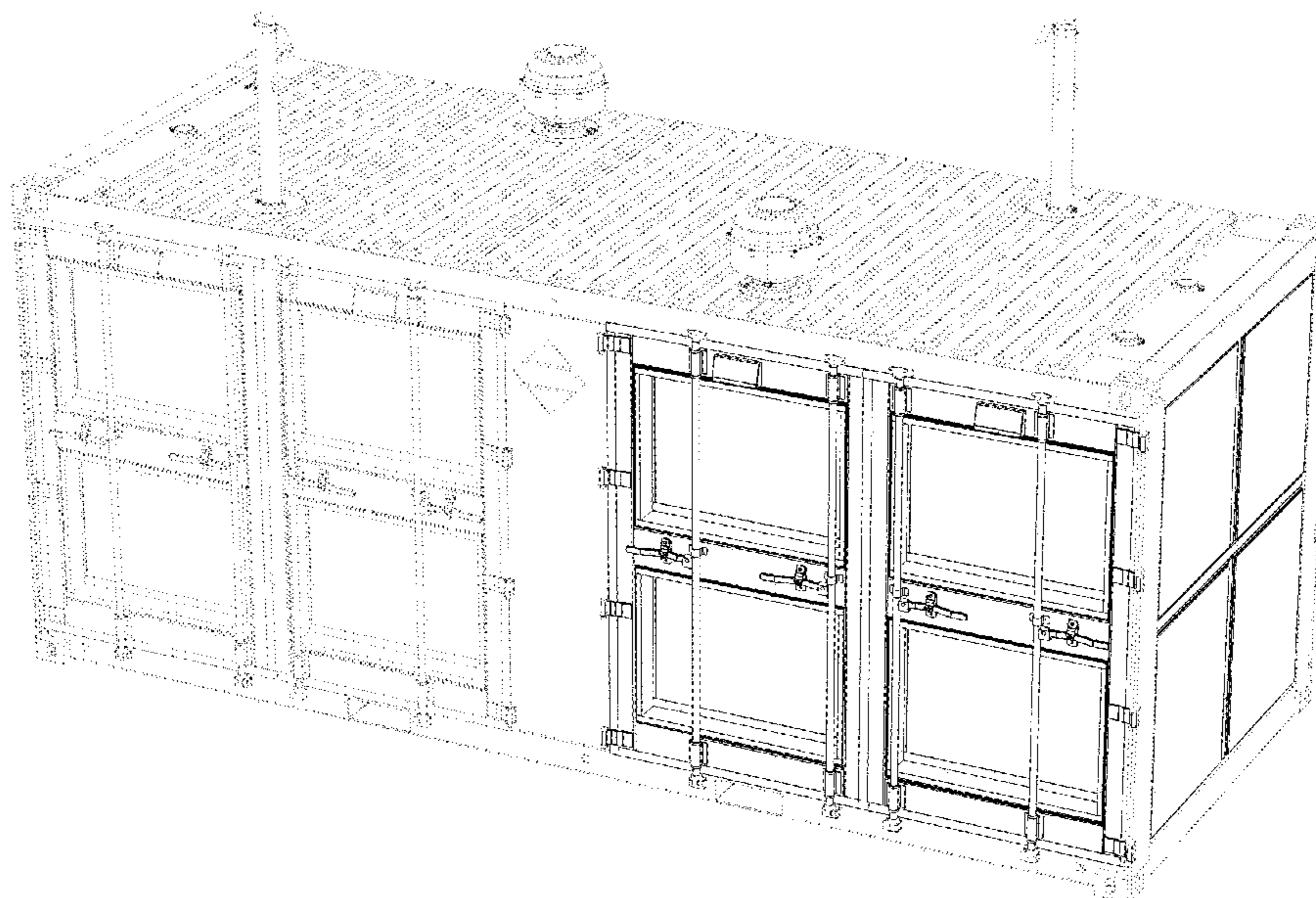
(57) **CLAIM**

What is claimed is the ornamental design for a modular power supply container with doors, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a modular power supply container with doors showing our new design; FIG. 2 is a view of a first side thereof; FIG. 3 is a view of a second side thereof, the second side being opposite the first side; FIG. 4 is a view of a first end thereof; FIG. 5 is a view of the second end thereof, the second end being opposite the first end; and, FIG. 6 is a top view thereof. The broken lines represent the portions of the modular power supply container with doors that form no part of the claimed design.

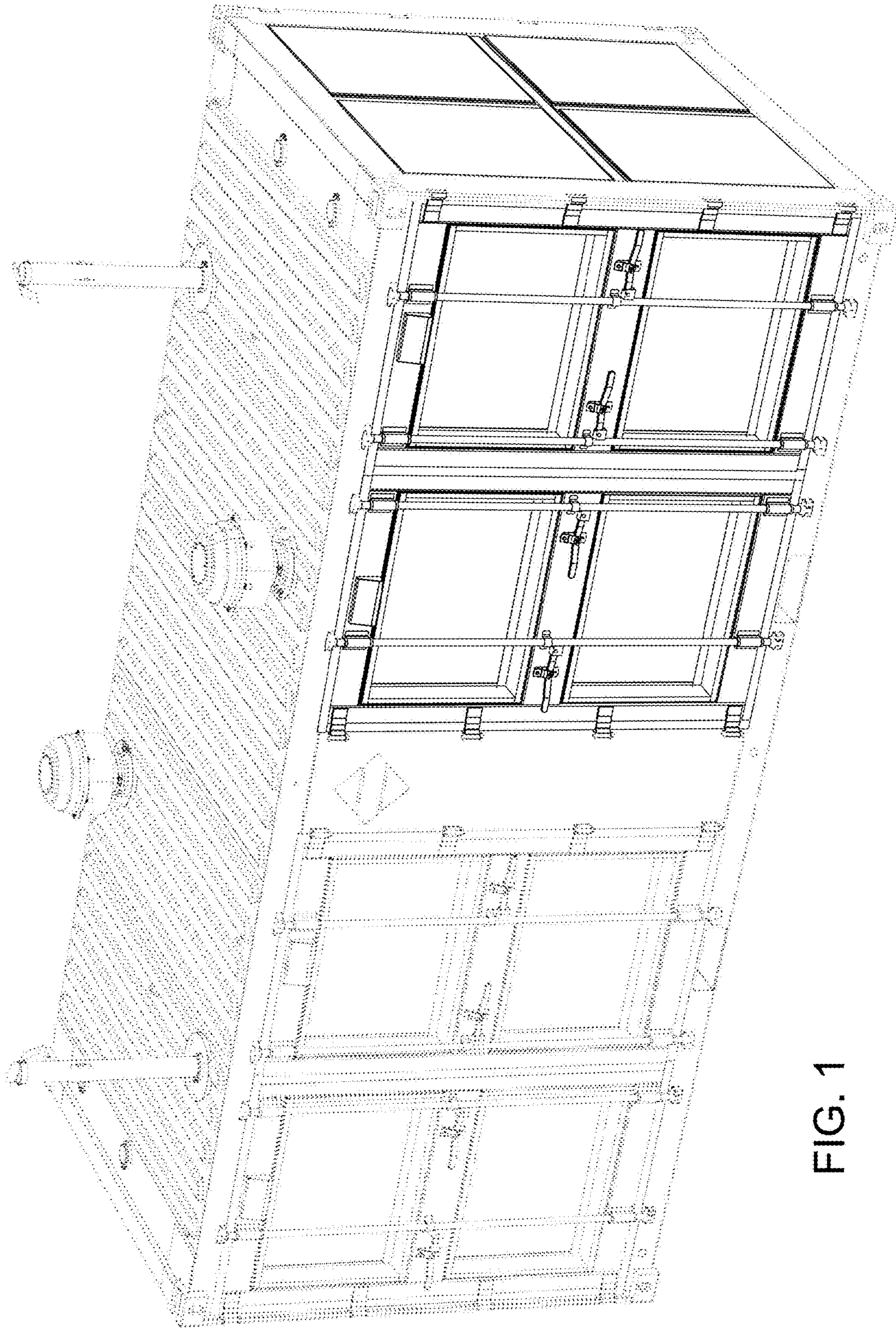

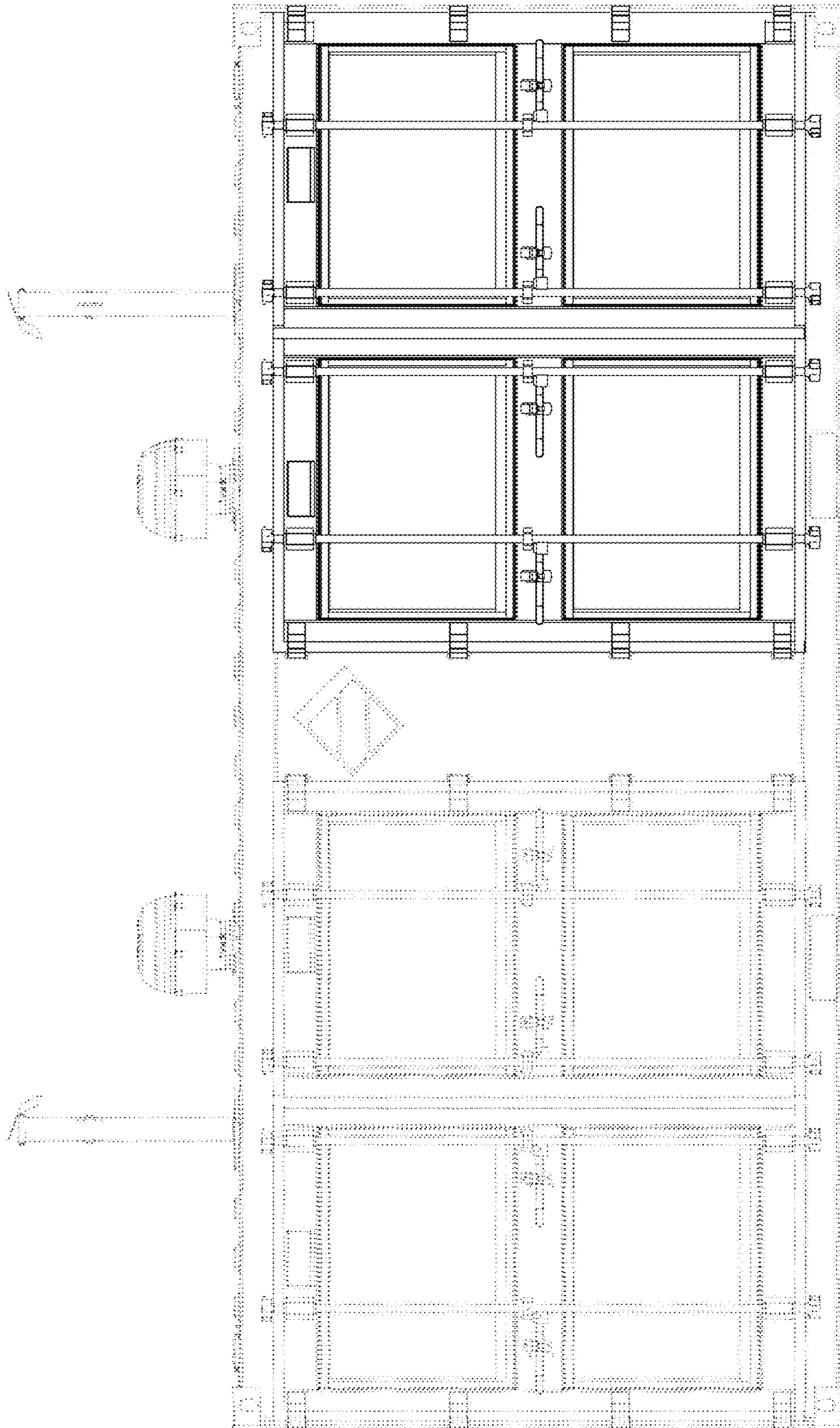

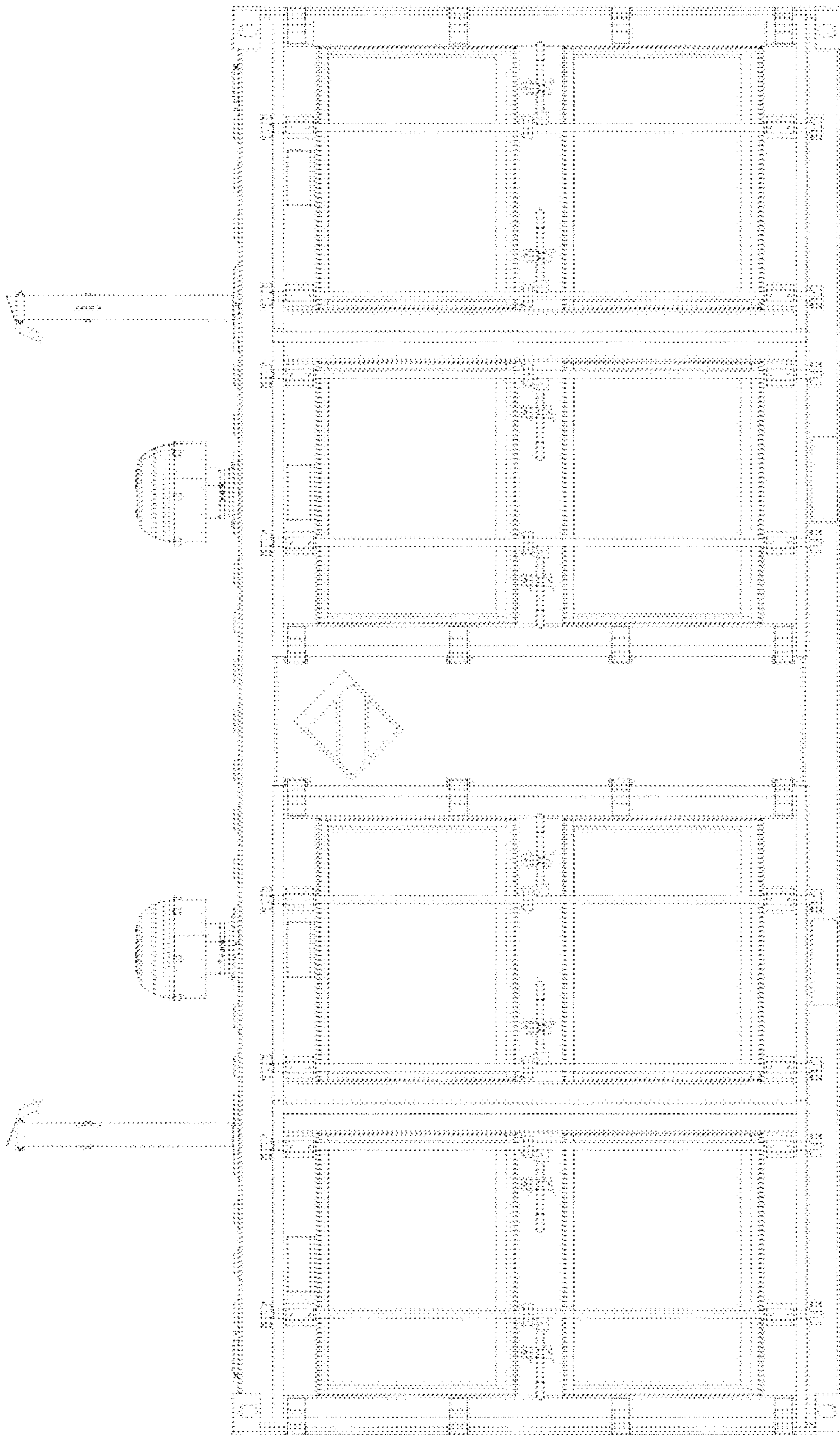

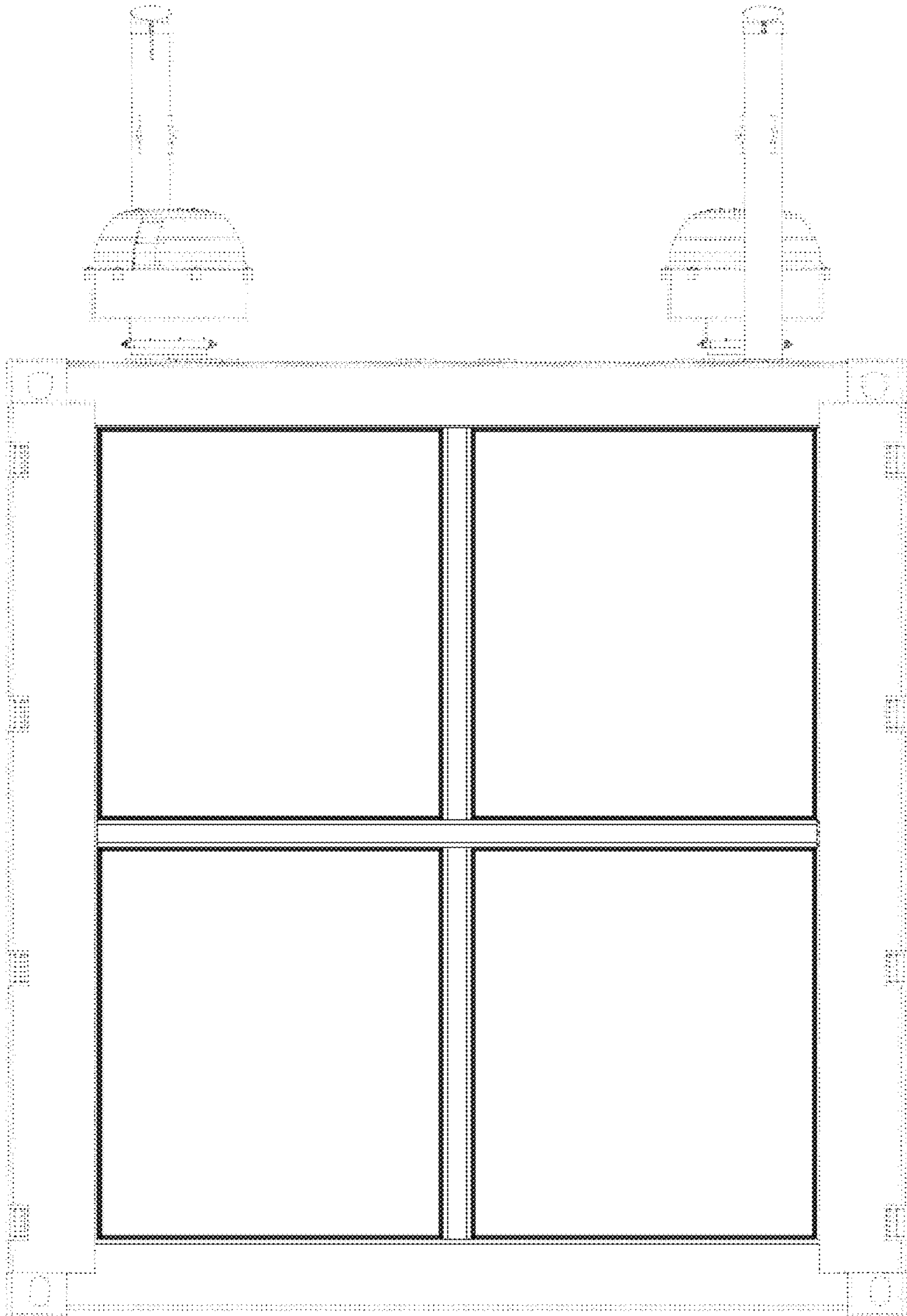

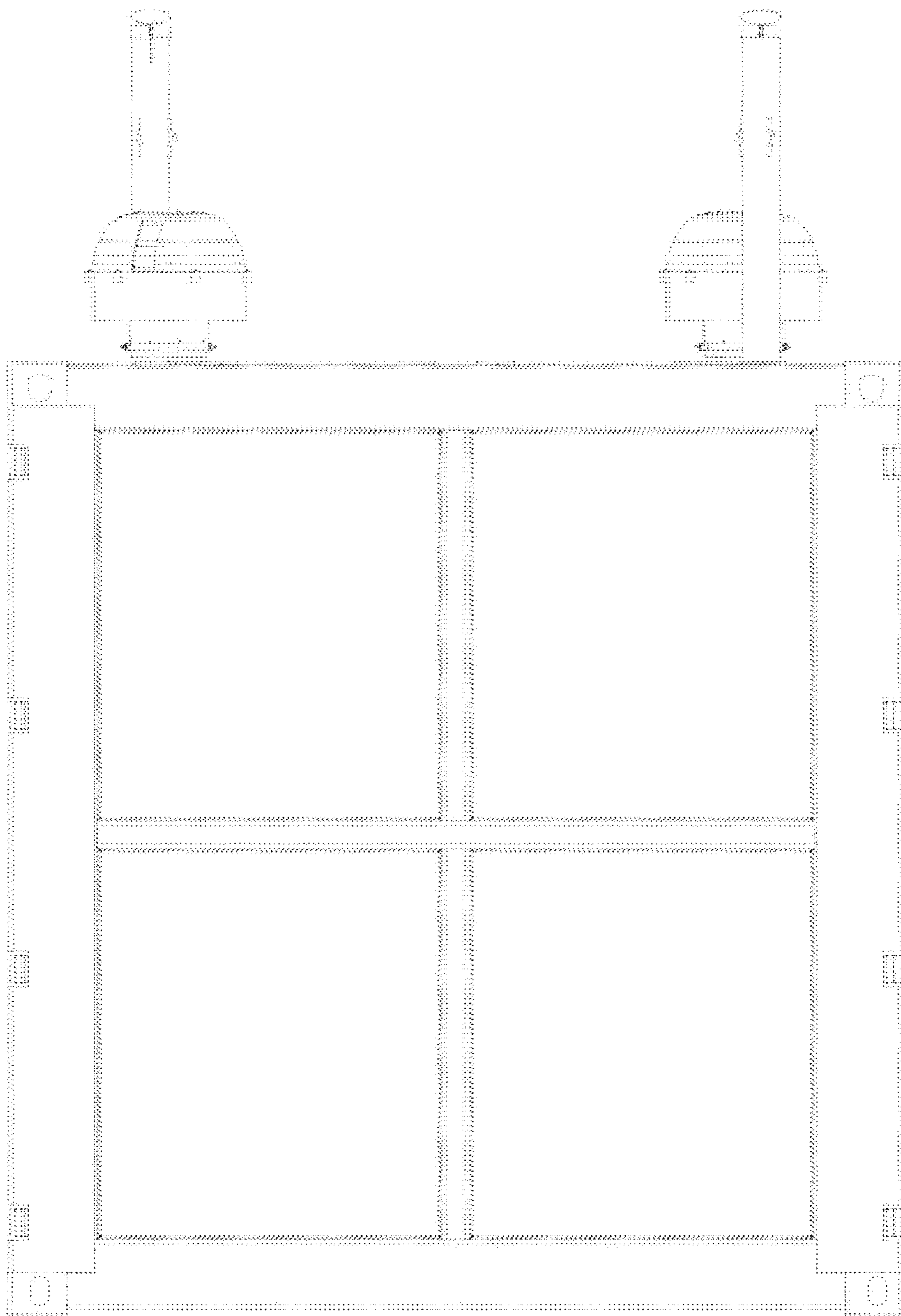

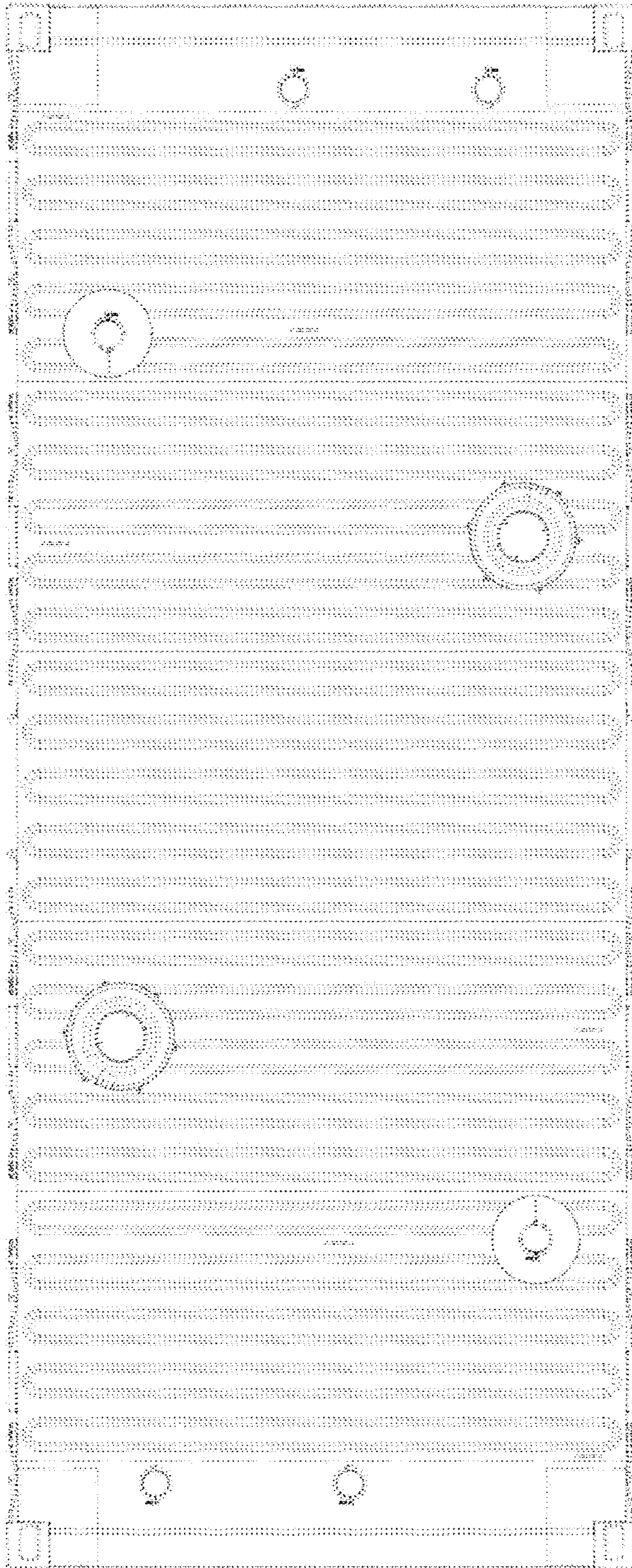
