FIG. 4 is a left view of the speaker shown in FIG. 1.

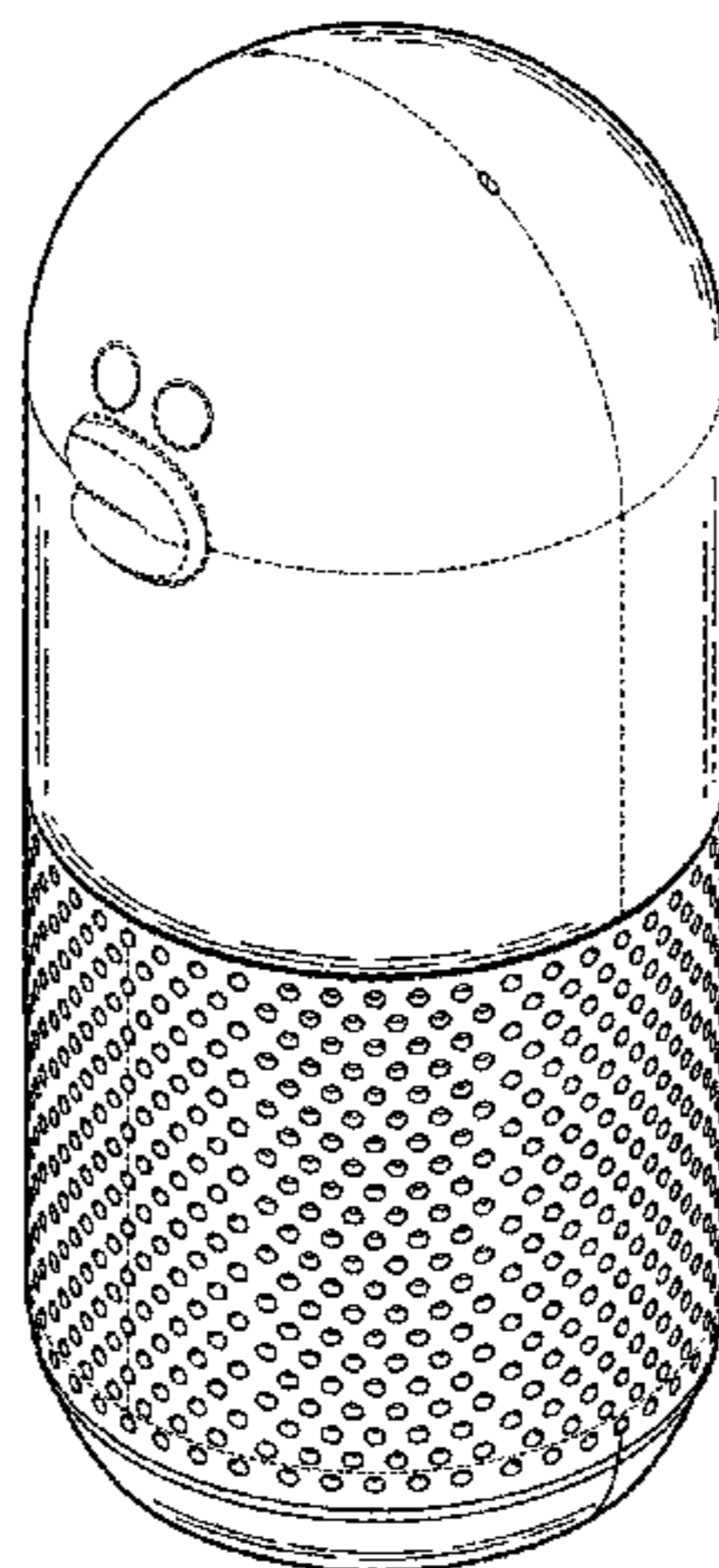
FIG. 5 is a right view of the speaker shown in FIG. 1.

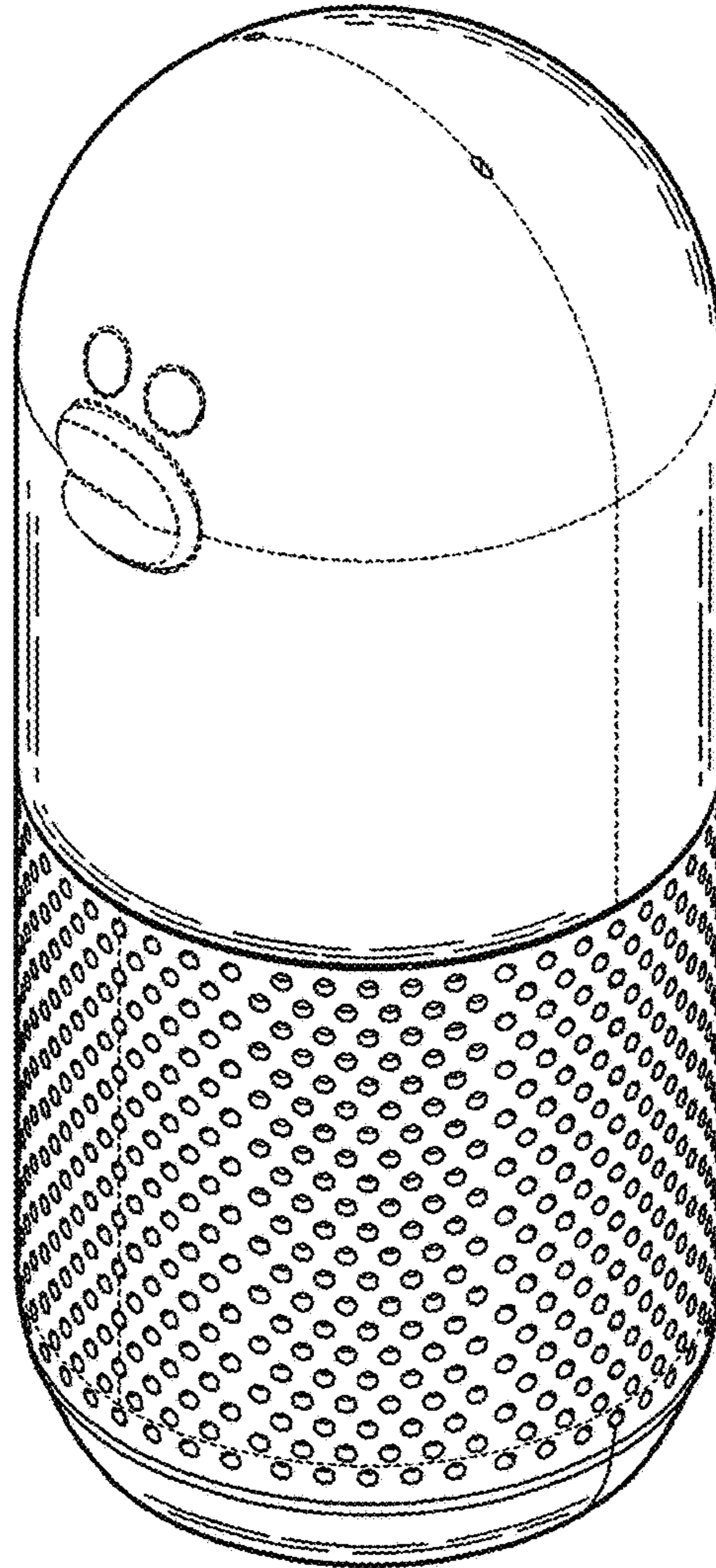

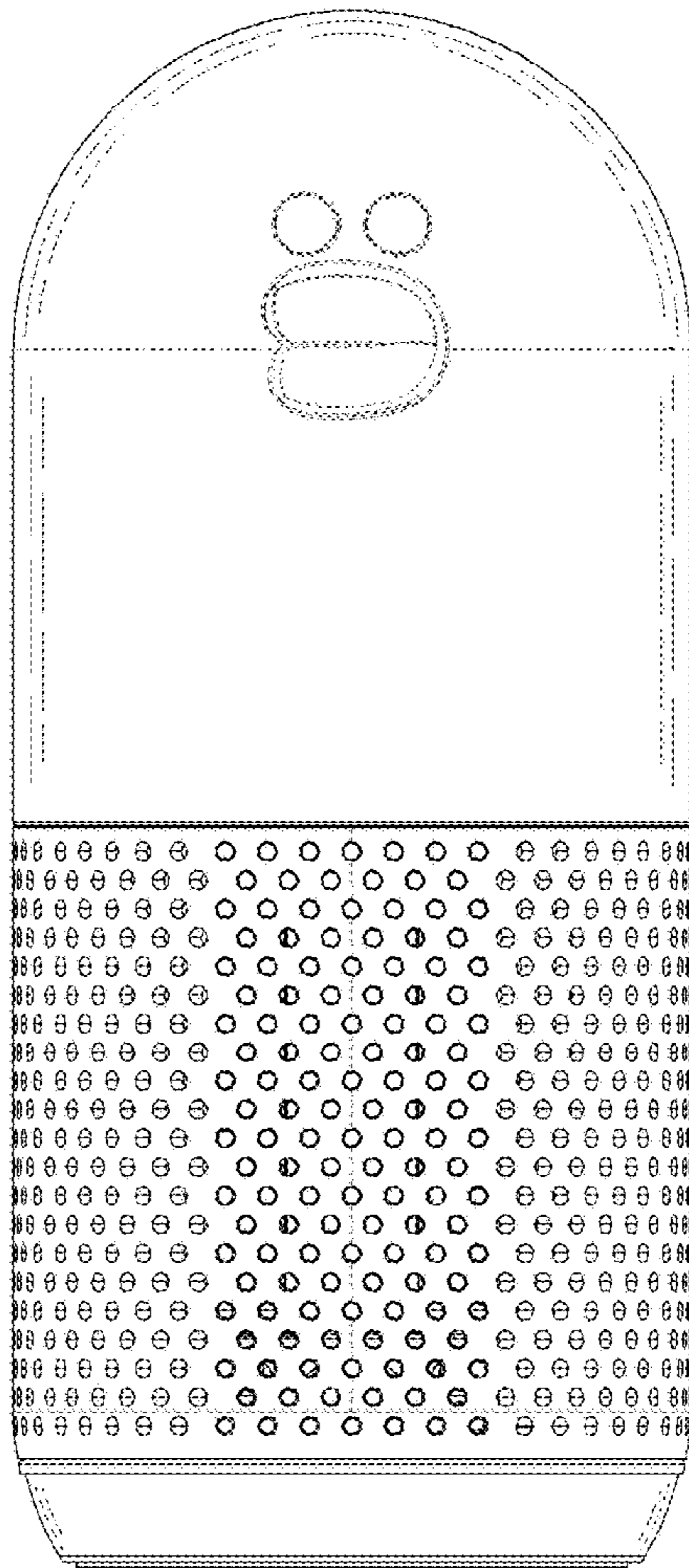

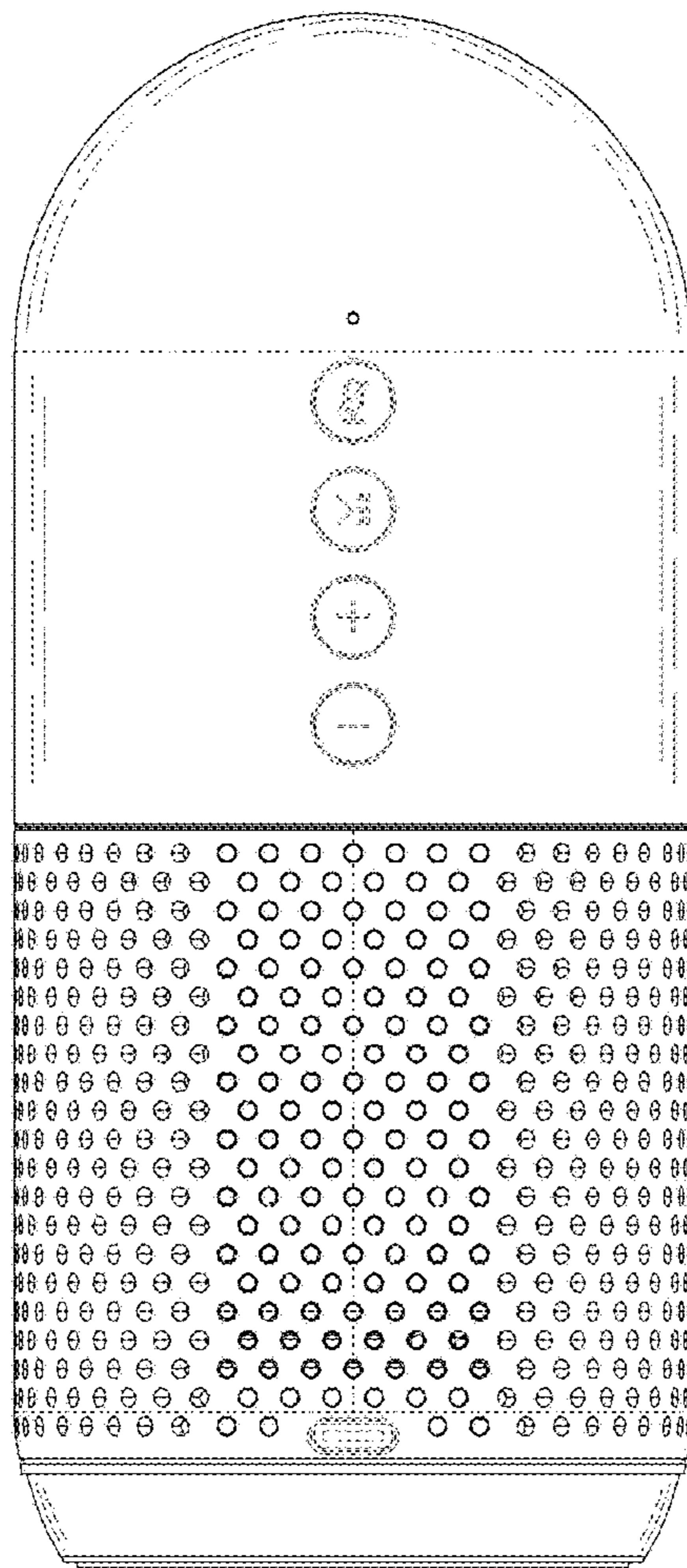

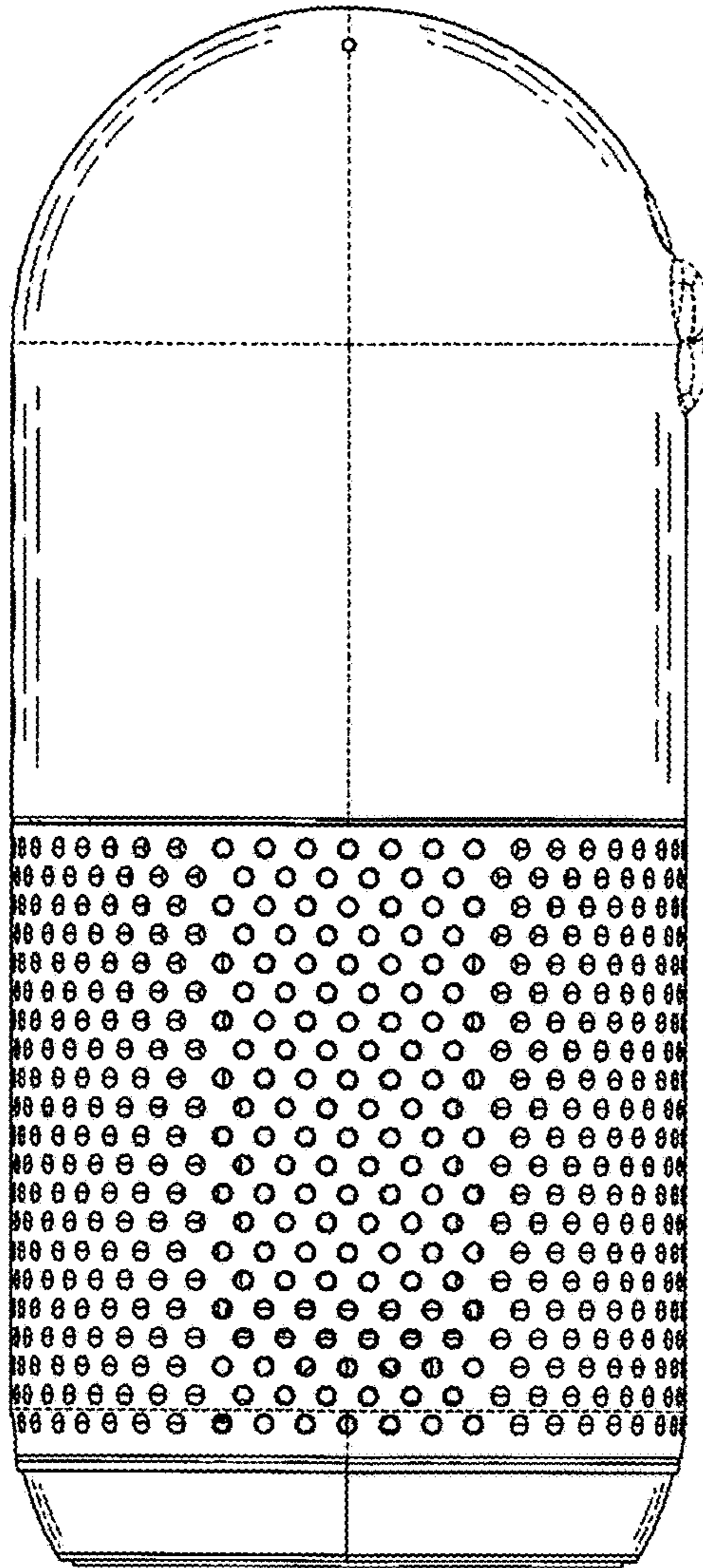

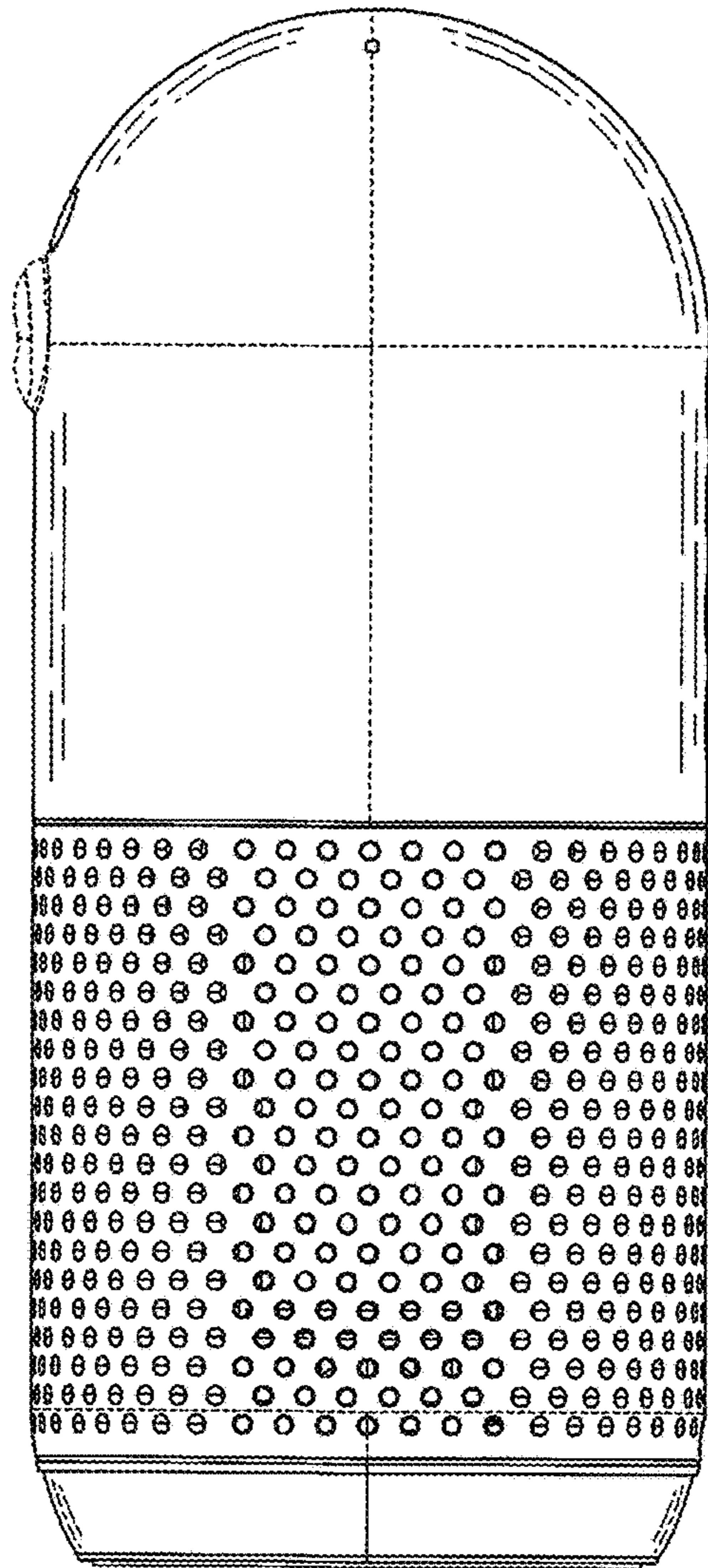

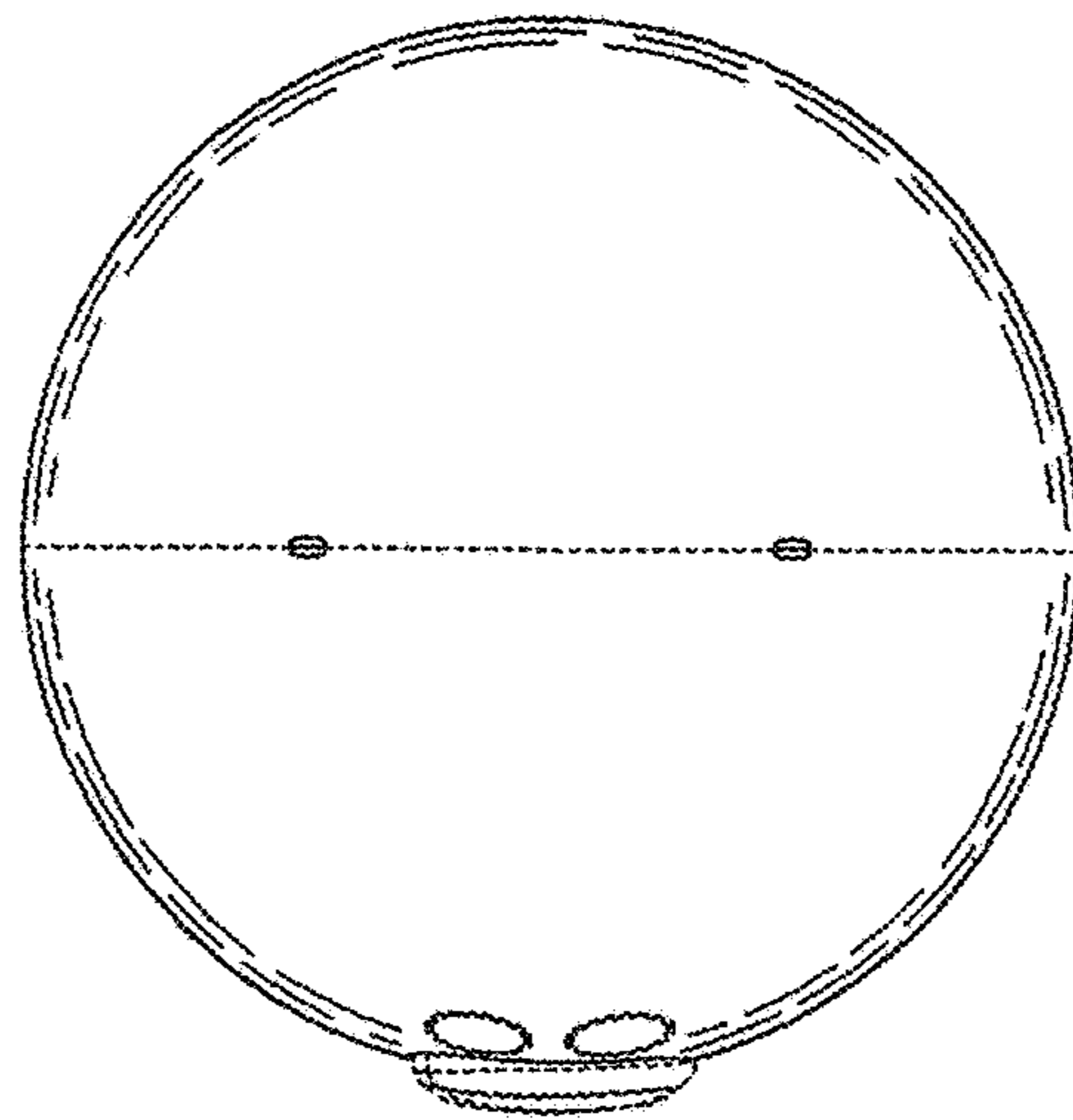
