(57) **CLAIM**

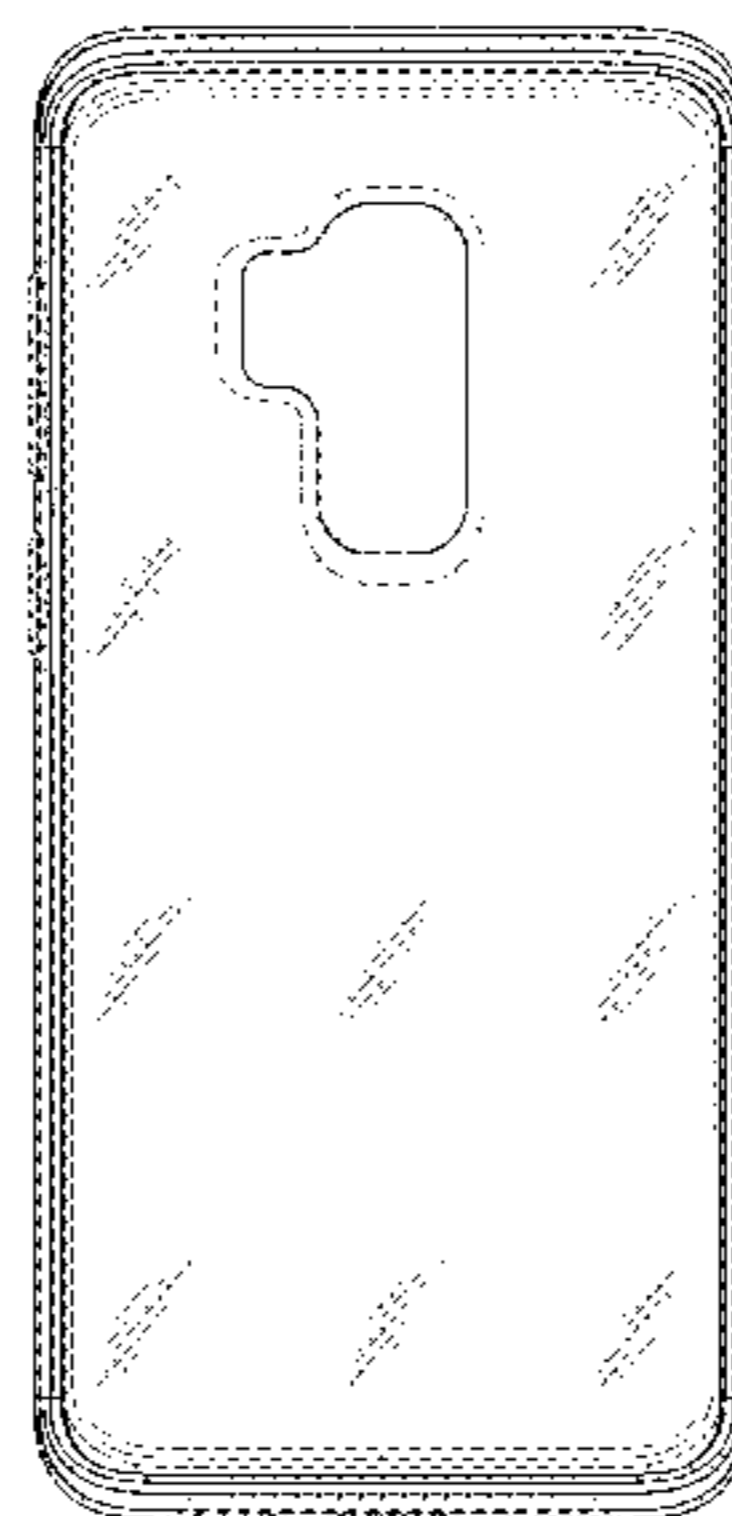
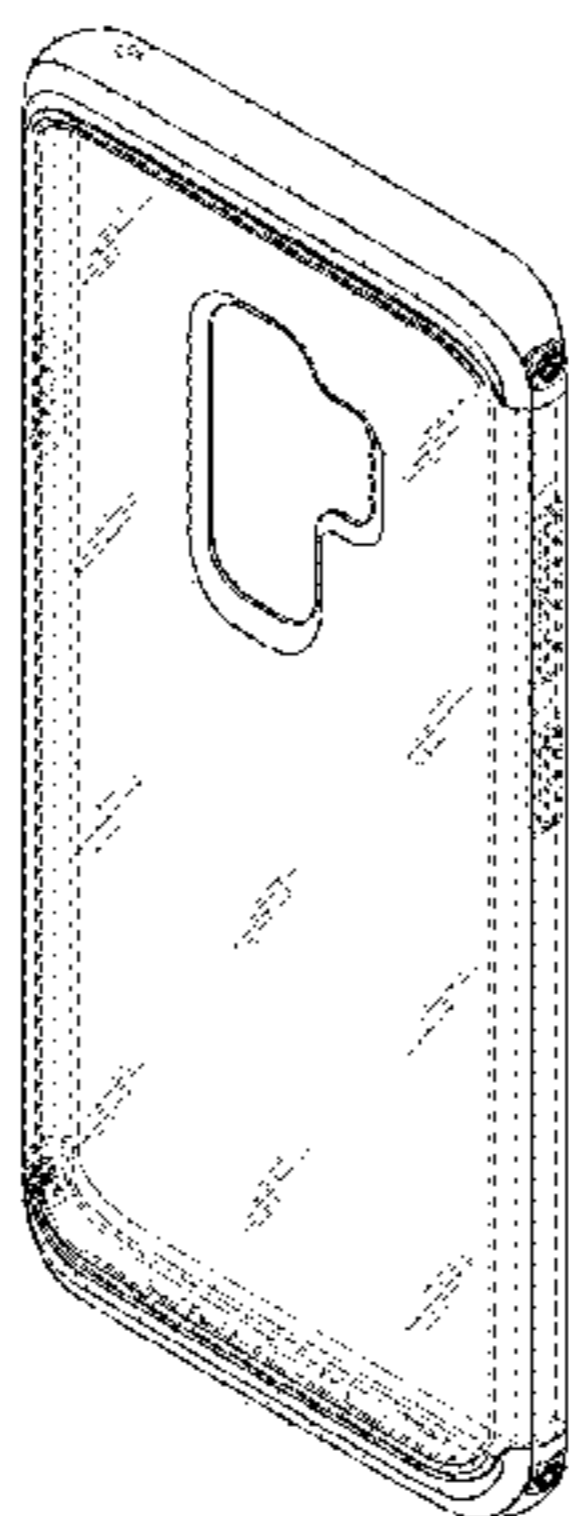
The ornamental design for a case for electronic communications device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a case for electronic communications device showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a front perspective view showing the upper cover component of the case in isolation; FIG. 10 is a rear perspective view showing the upper cover component of the case in isolation; FIG. 11 is a front perspective view showing the middle cover component of the case in isolation; FIG. 12 is a rear perspective view showing the middle cover component of the case in isolation; FIG. 13 is a front perspective view showing the bottom cover component of the case in isolation; FIG. 14 is a rear perspective view showing the bottom cover component of the case in isolation; FIG. 15 is an exploded front perspective view showing the components of the case separated; FIG. 16 is an exploded rear perspective view showing the components of the case separated; and, FIG. 17 is an enlarged detail view of the encircled region from FIG. 1.

For clarity of disclosure, the components of the case are shown in isolation in FIGS. 9-14 and separated in FIGS. 15-16. Although the case for electronic communications device, in which the claimed design is embodied, consists of an upper cover component, a middle cover component, and a bottom cover component, the claim is directed to the overall ornamental appearance of the case for electronic communications device in its entirety and does not extend to the ornamental appearance of each of the individual components.

The dot-dash broken line circle in FIGS. 1 and 17 delineates a portion of the case for electronic communications device that is part of the claimed design and that is shown on an enlarged scale in FIG. 17. The dashed broken lines throughout the drawing figures depict portions of the case for electronic communications device that form no part of the claimed design. The broken lines and regions bounded by dashed broken lines form no part of the claimed design.

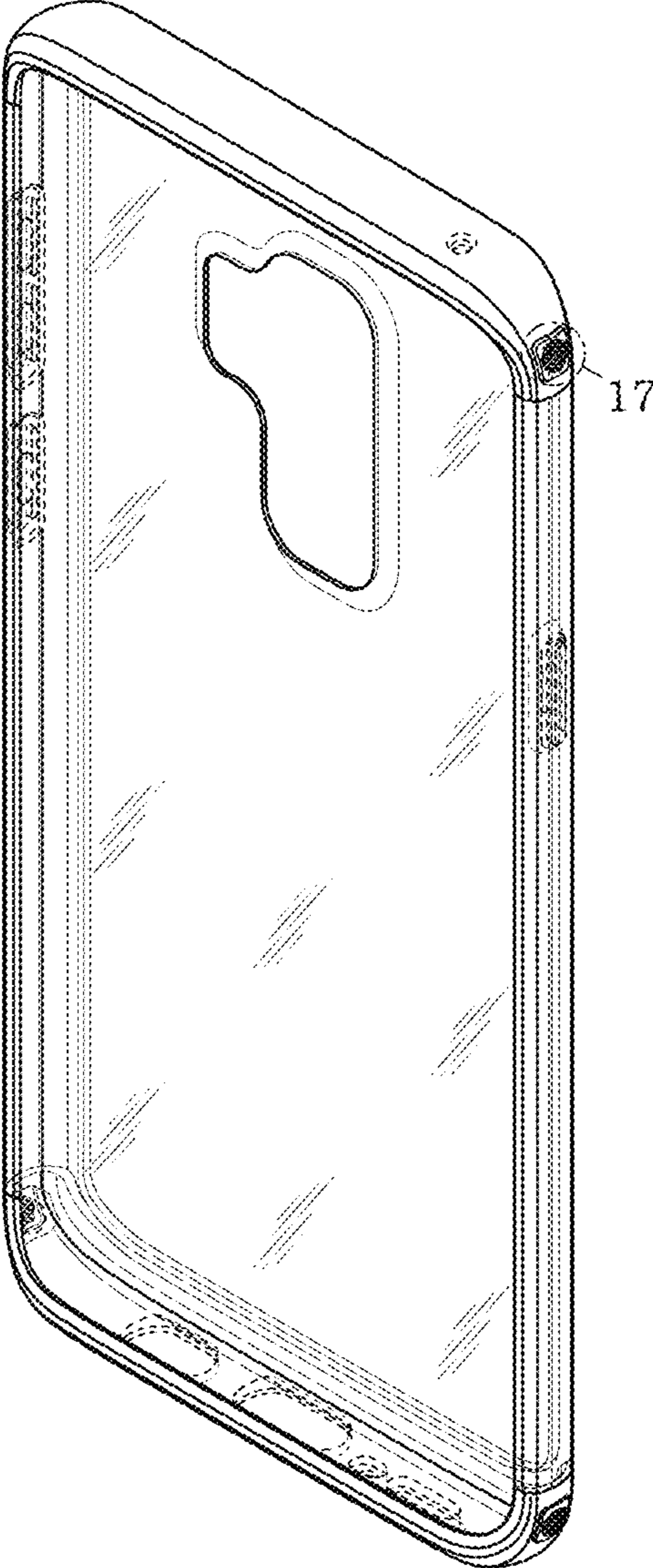

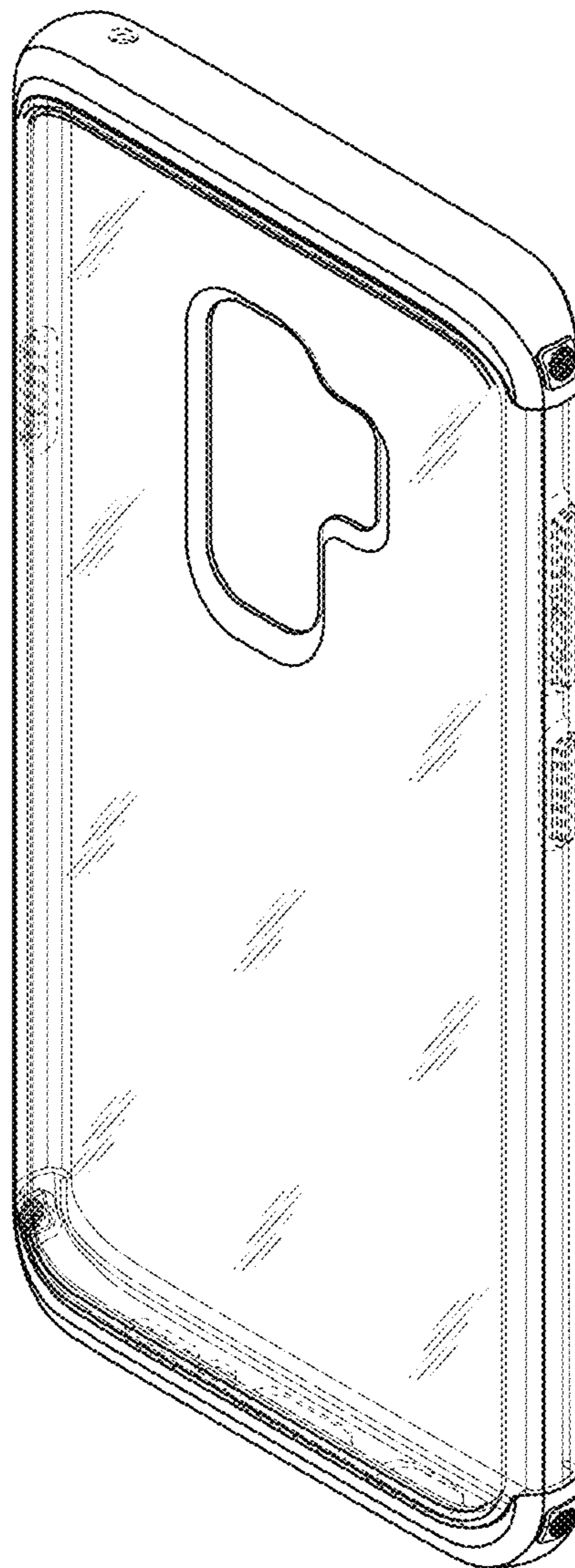

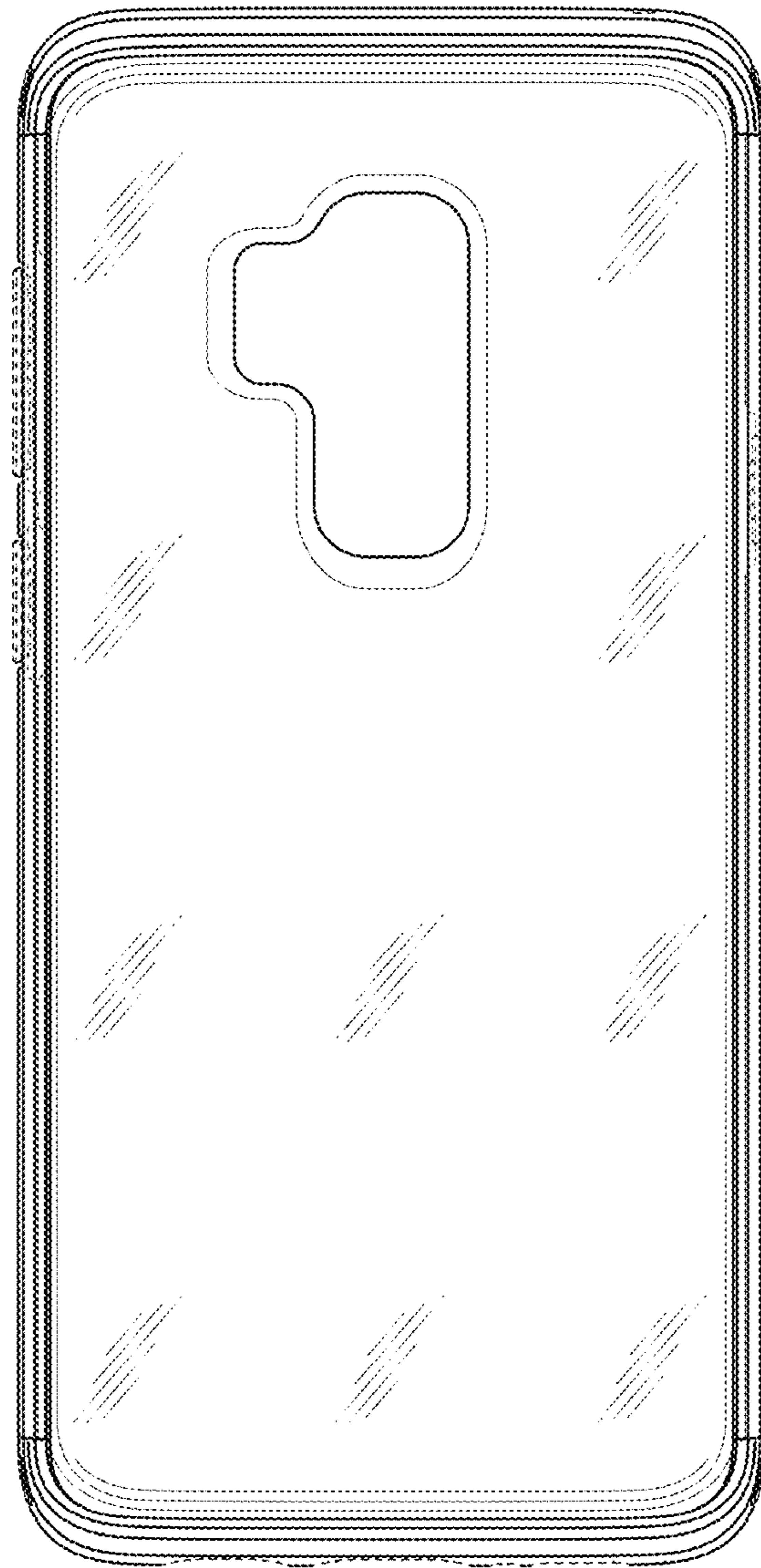

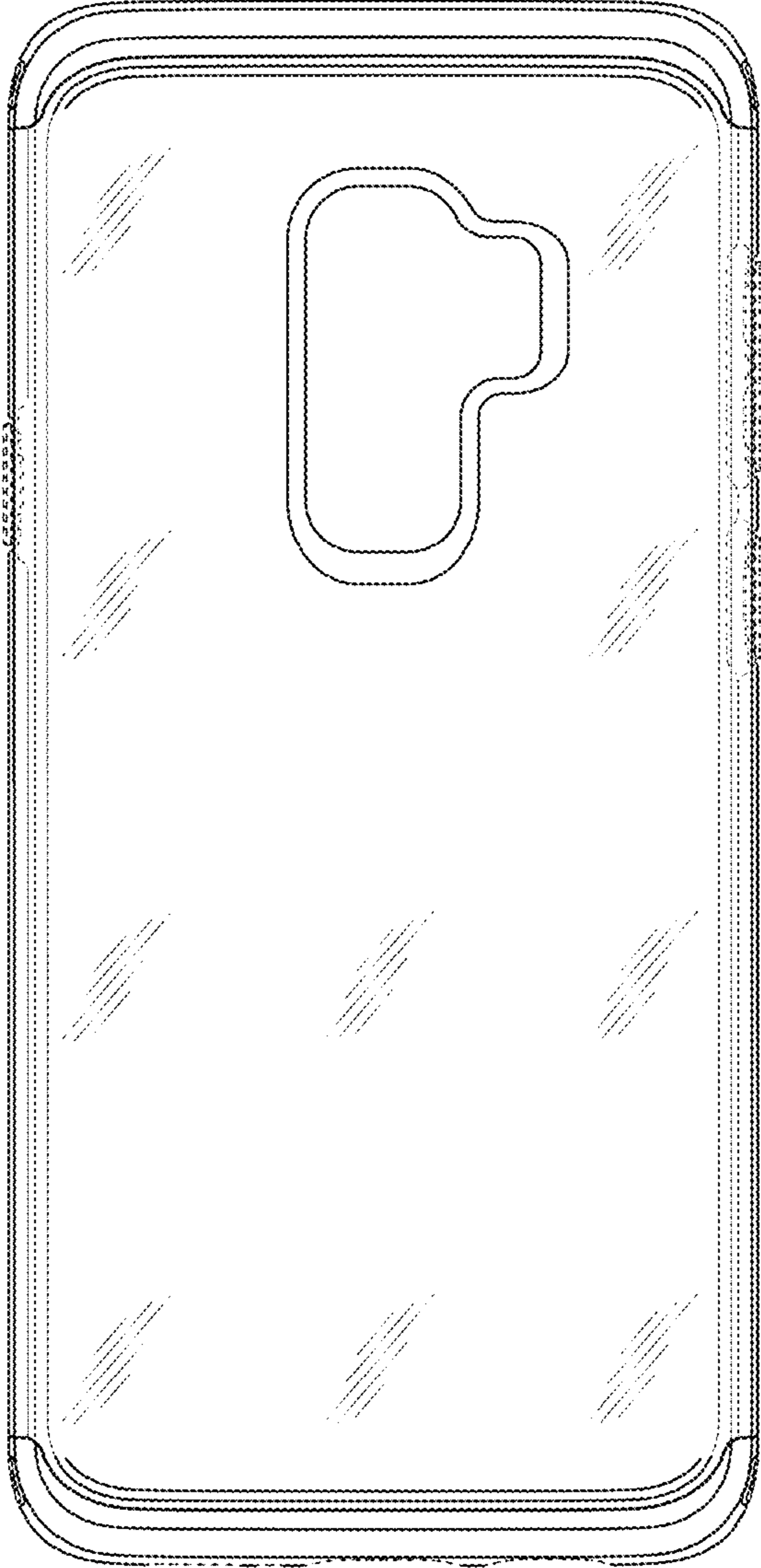

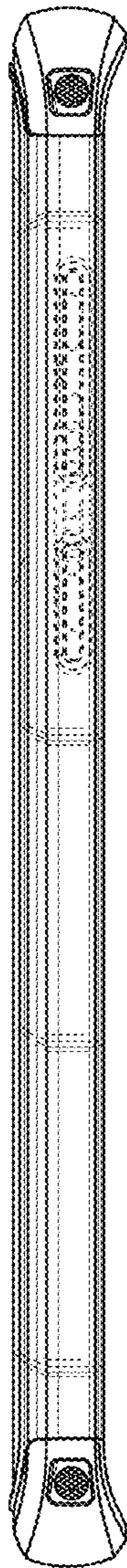

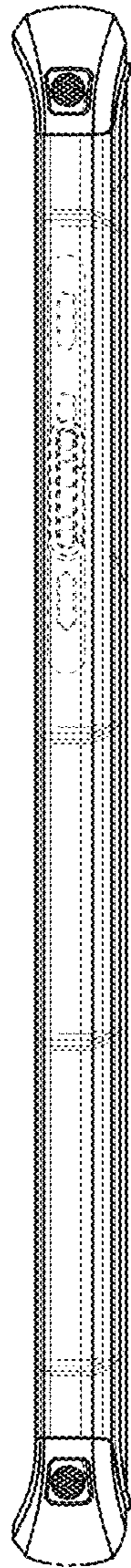

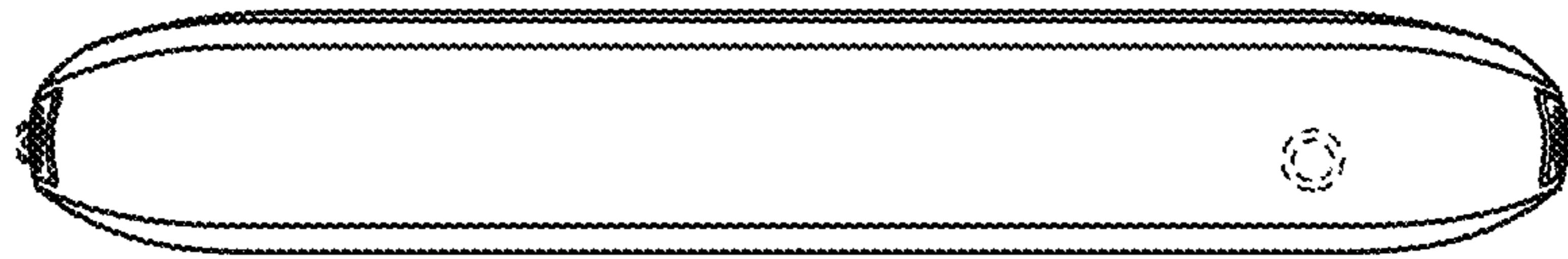

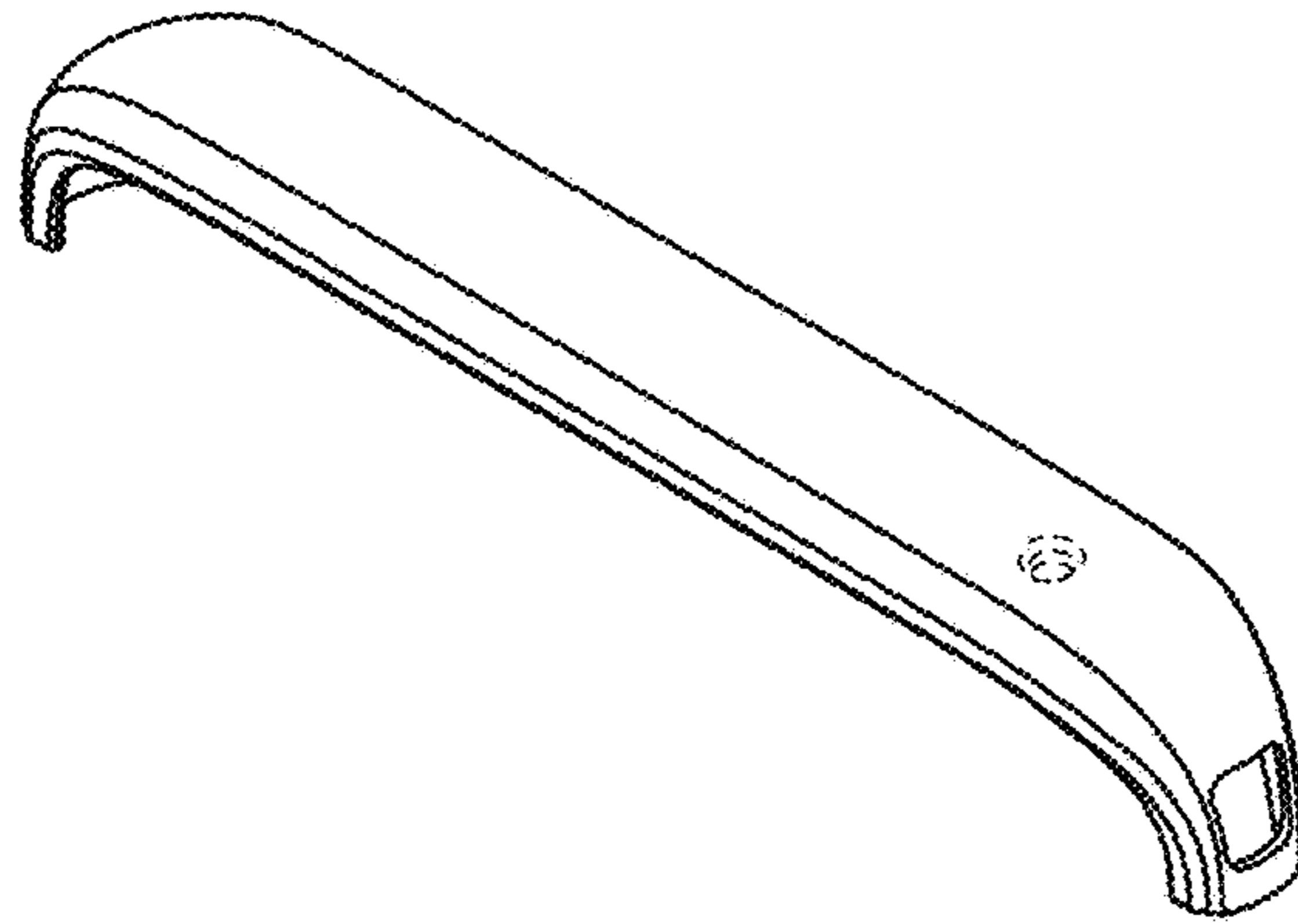

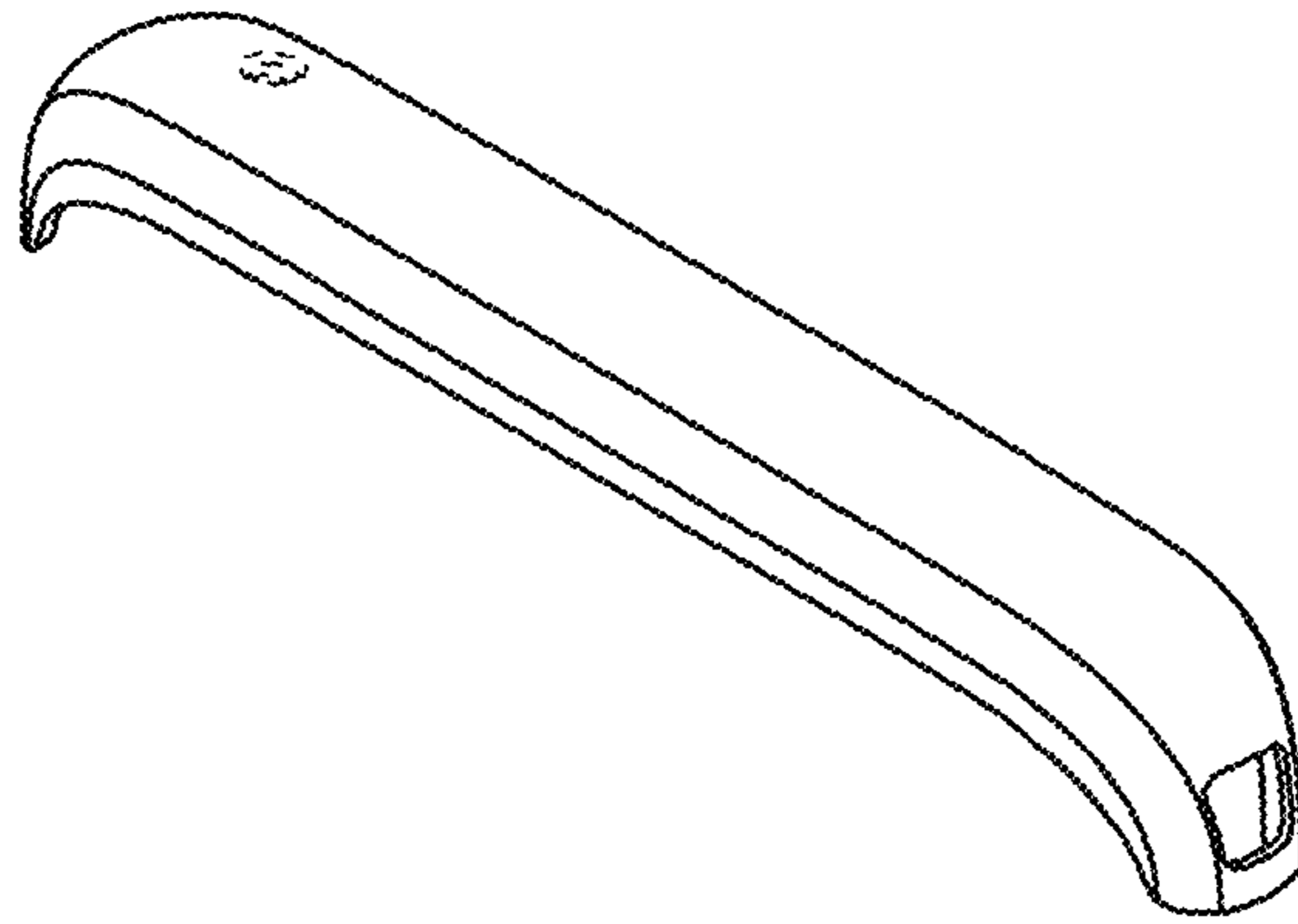

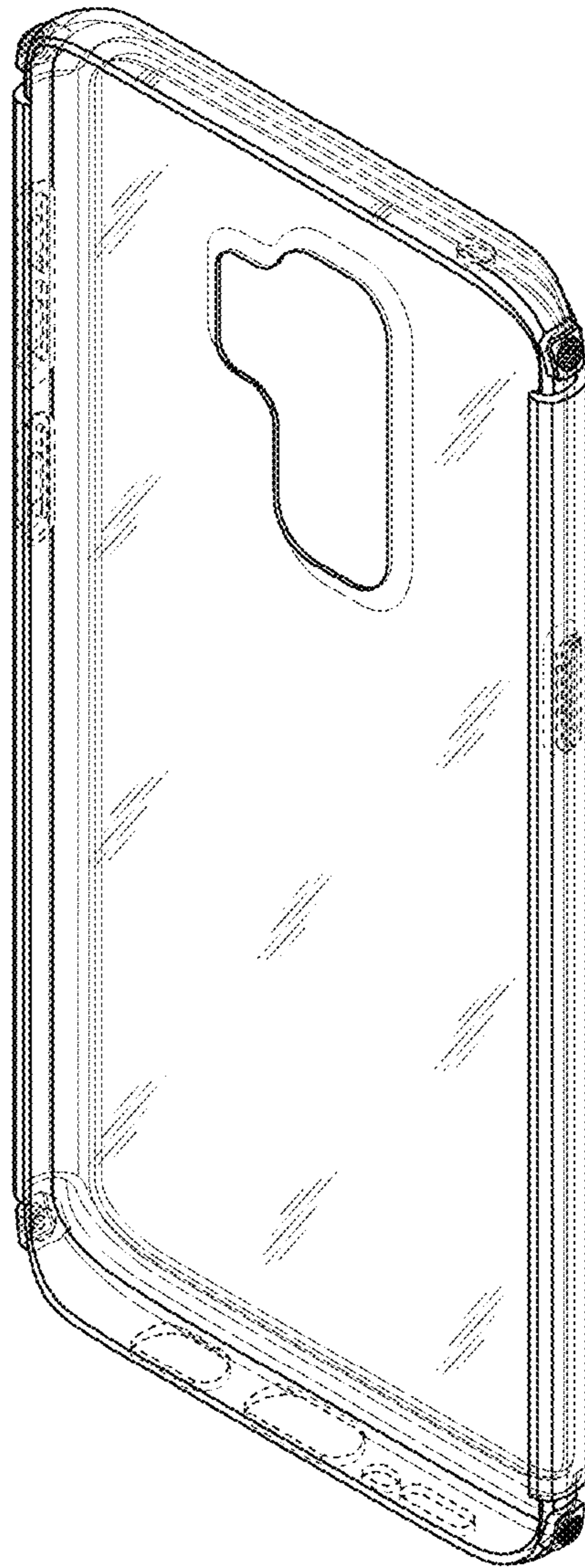

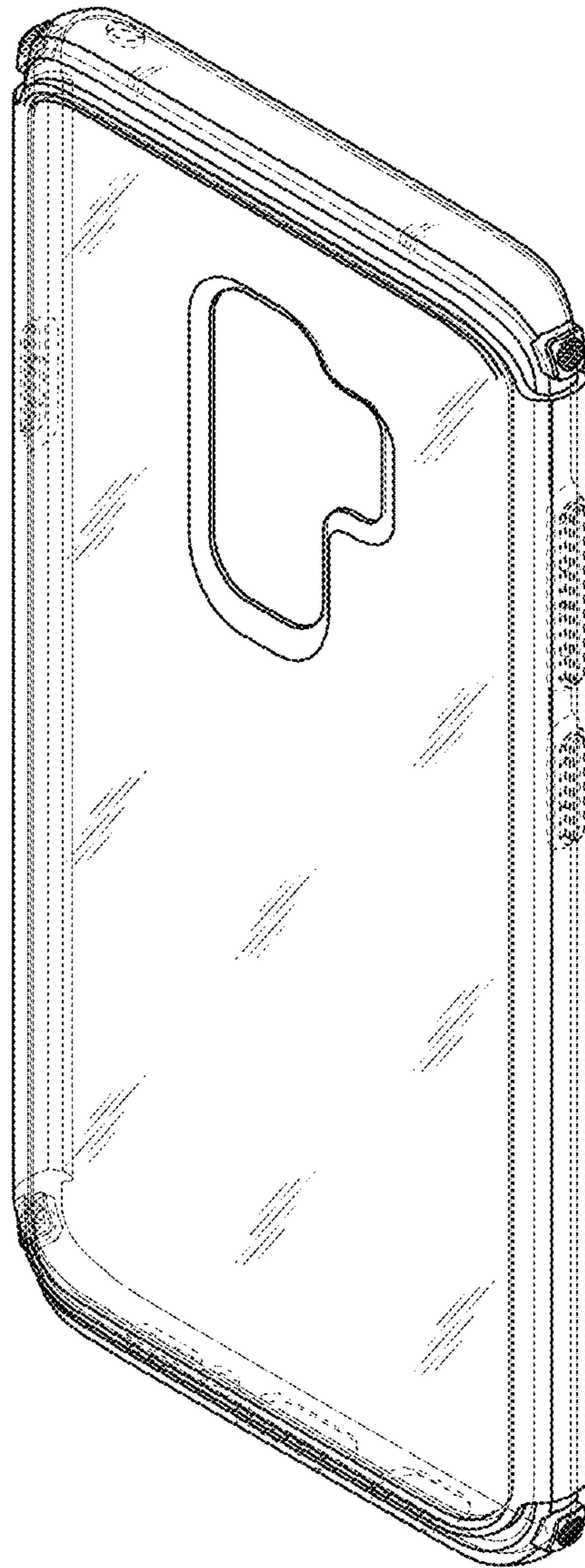

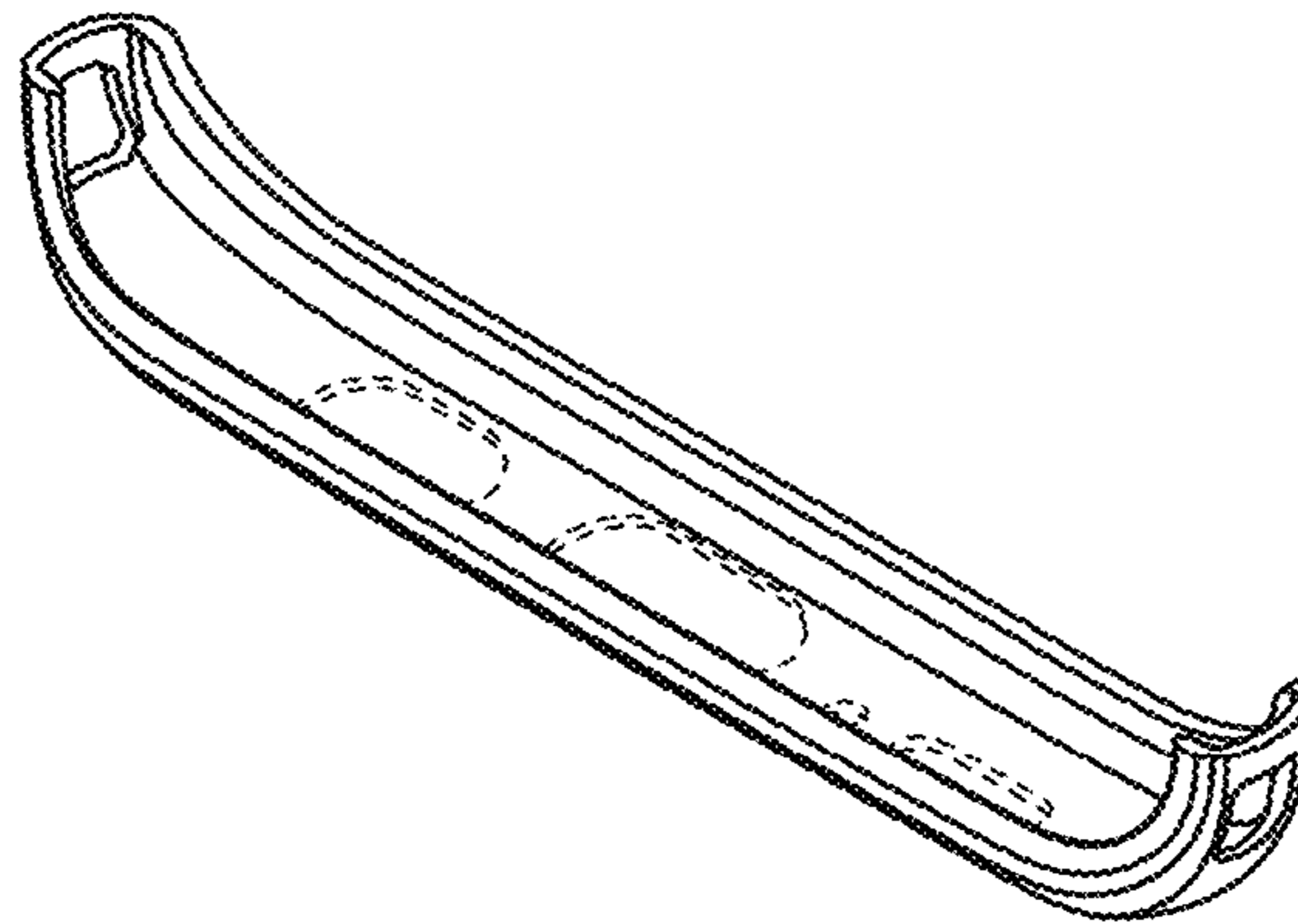

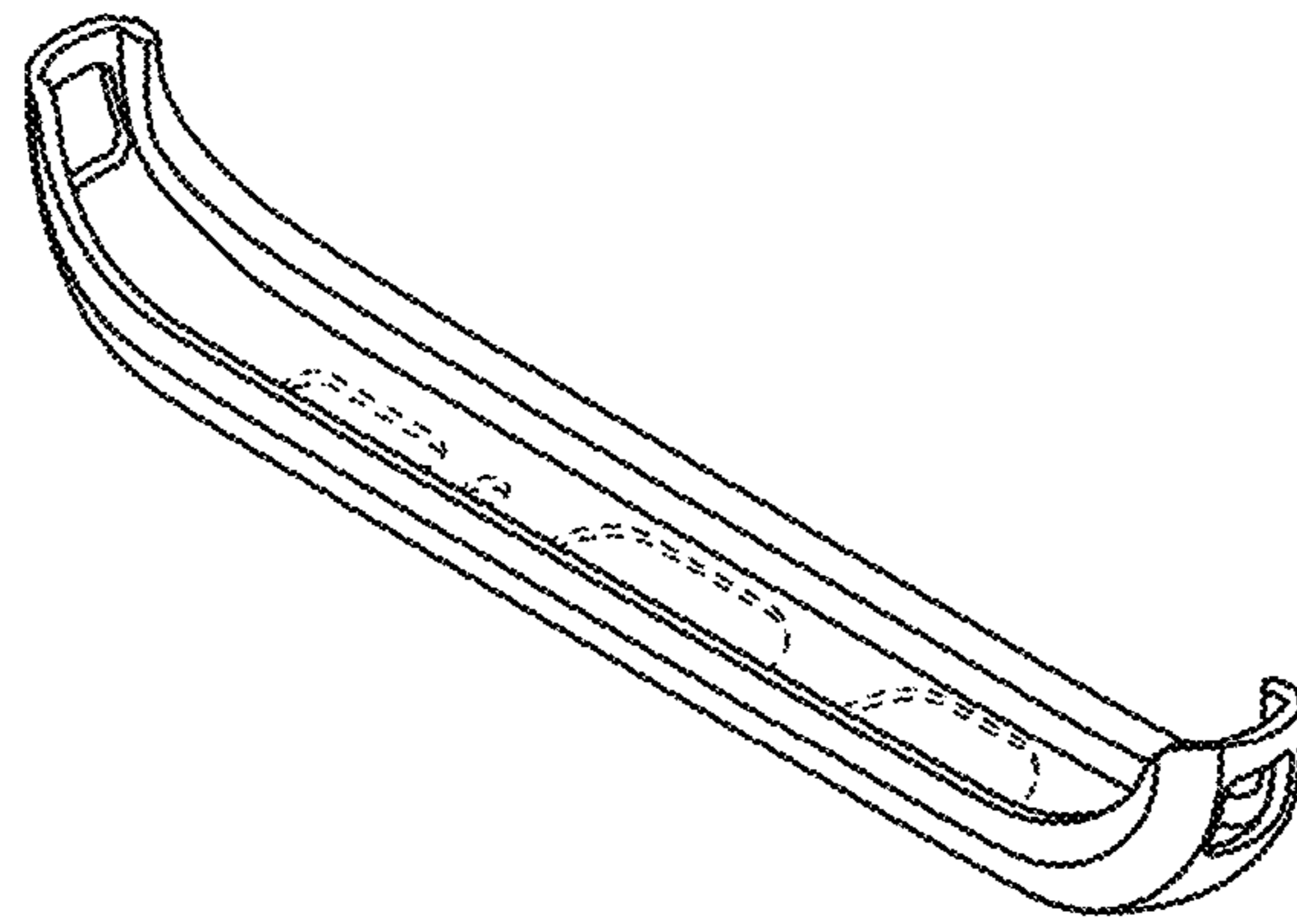

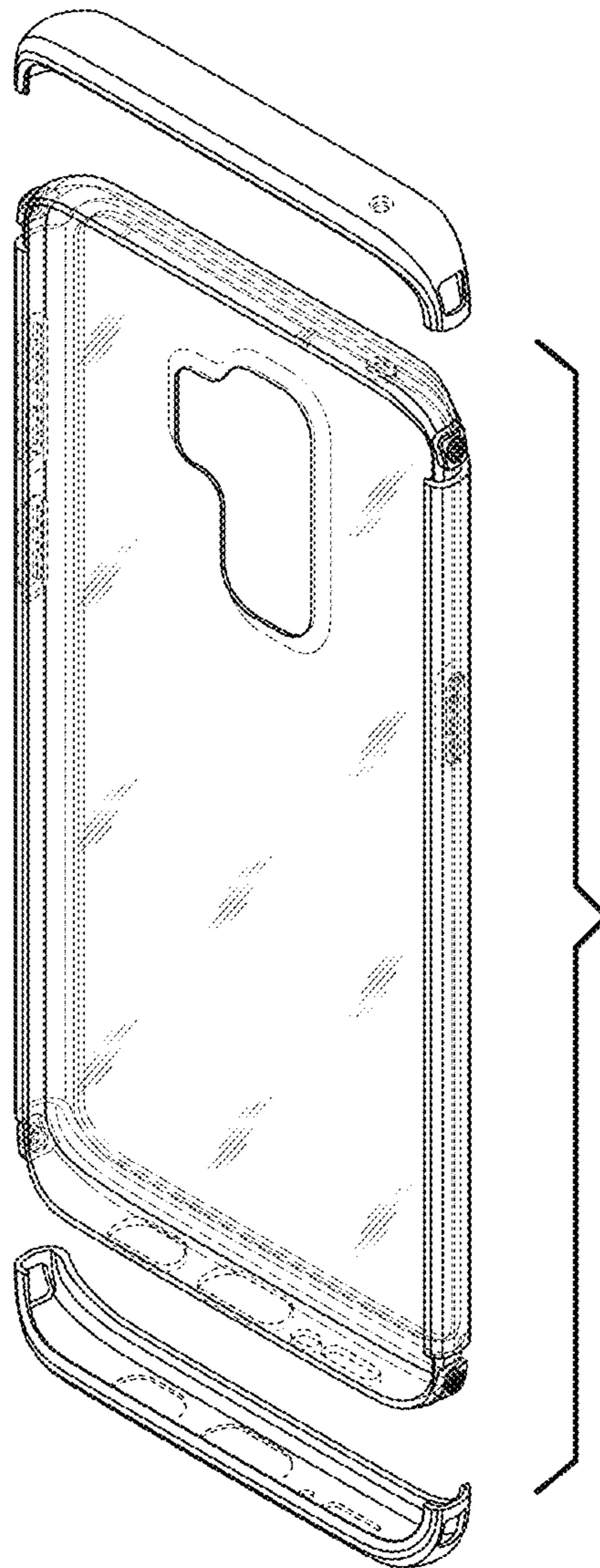

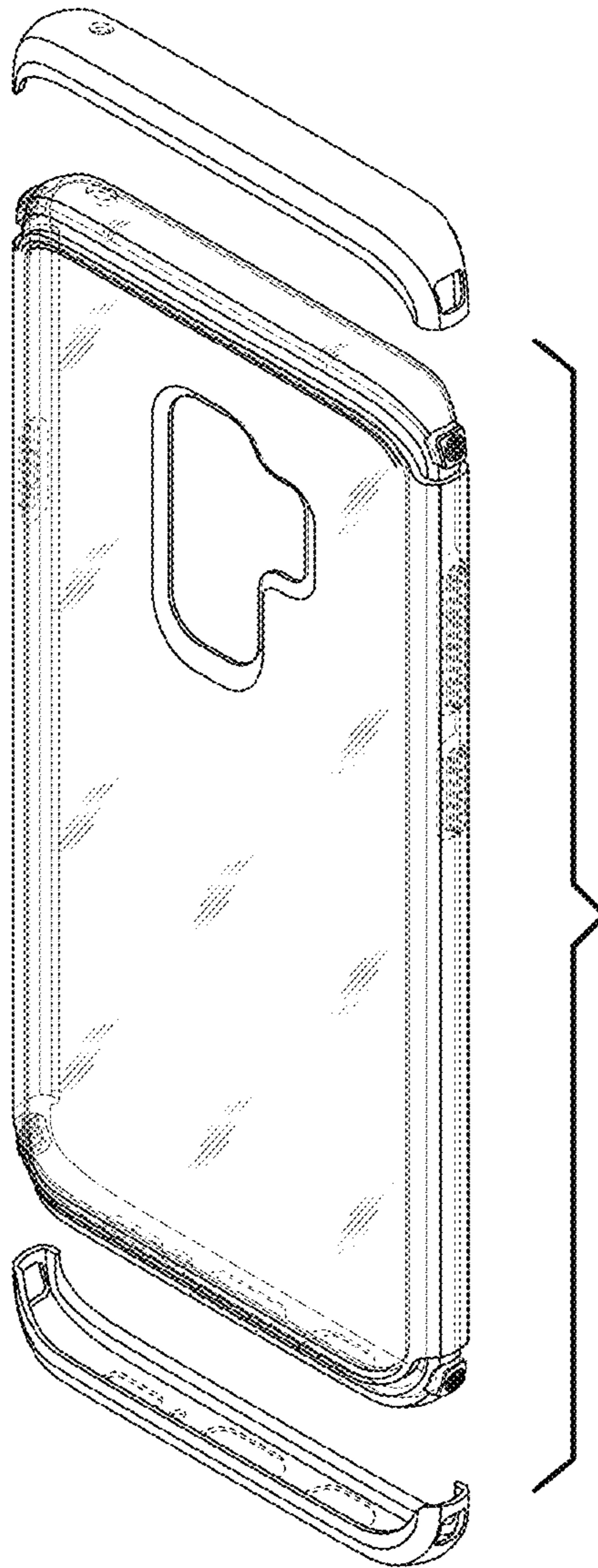
