(57) **CLAIM**

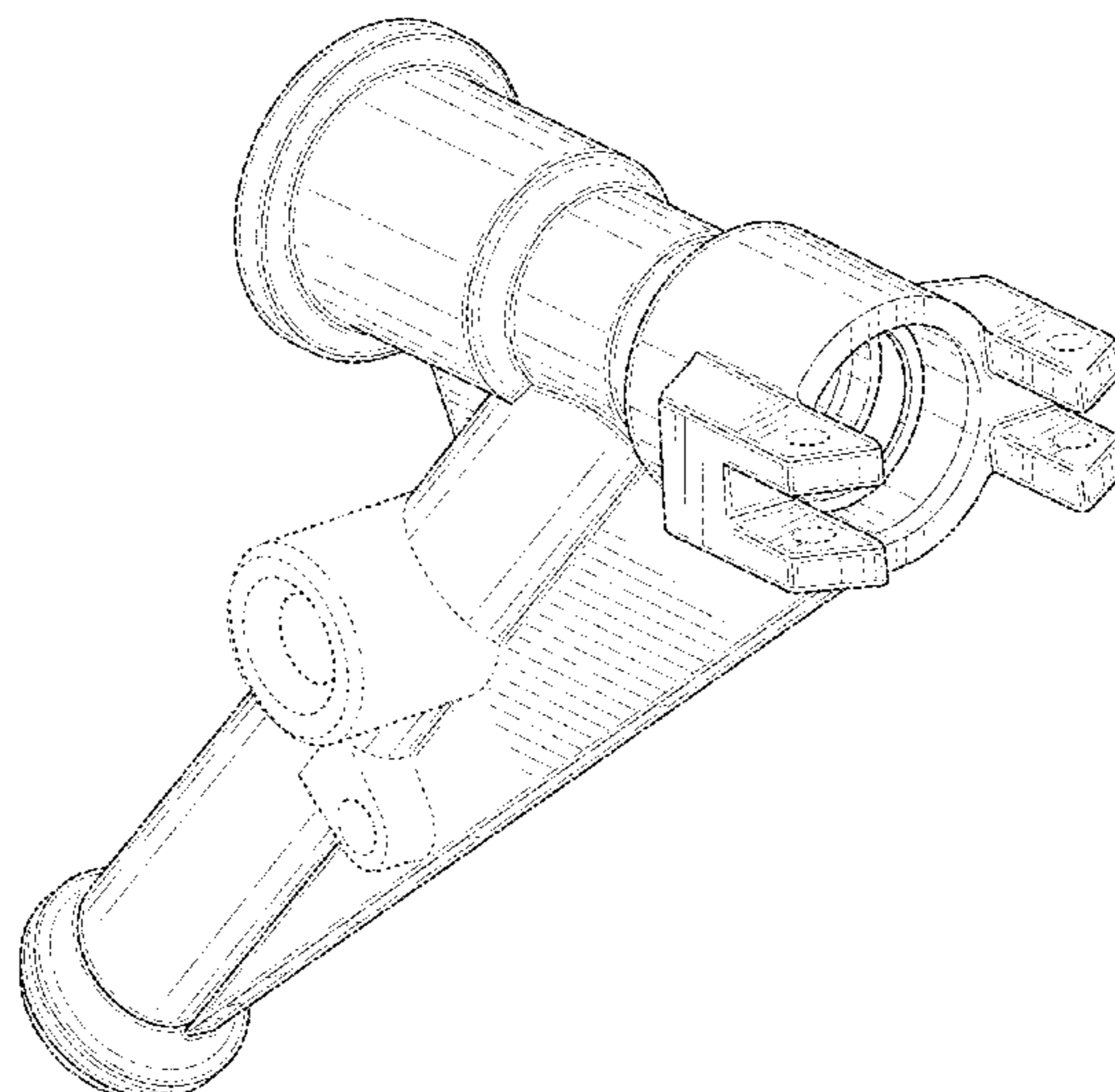
The ornamental design for a fluid body of a dispense valve,

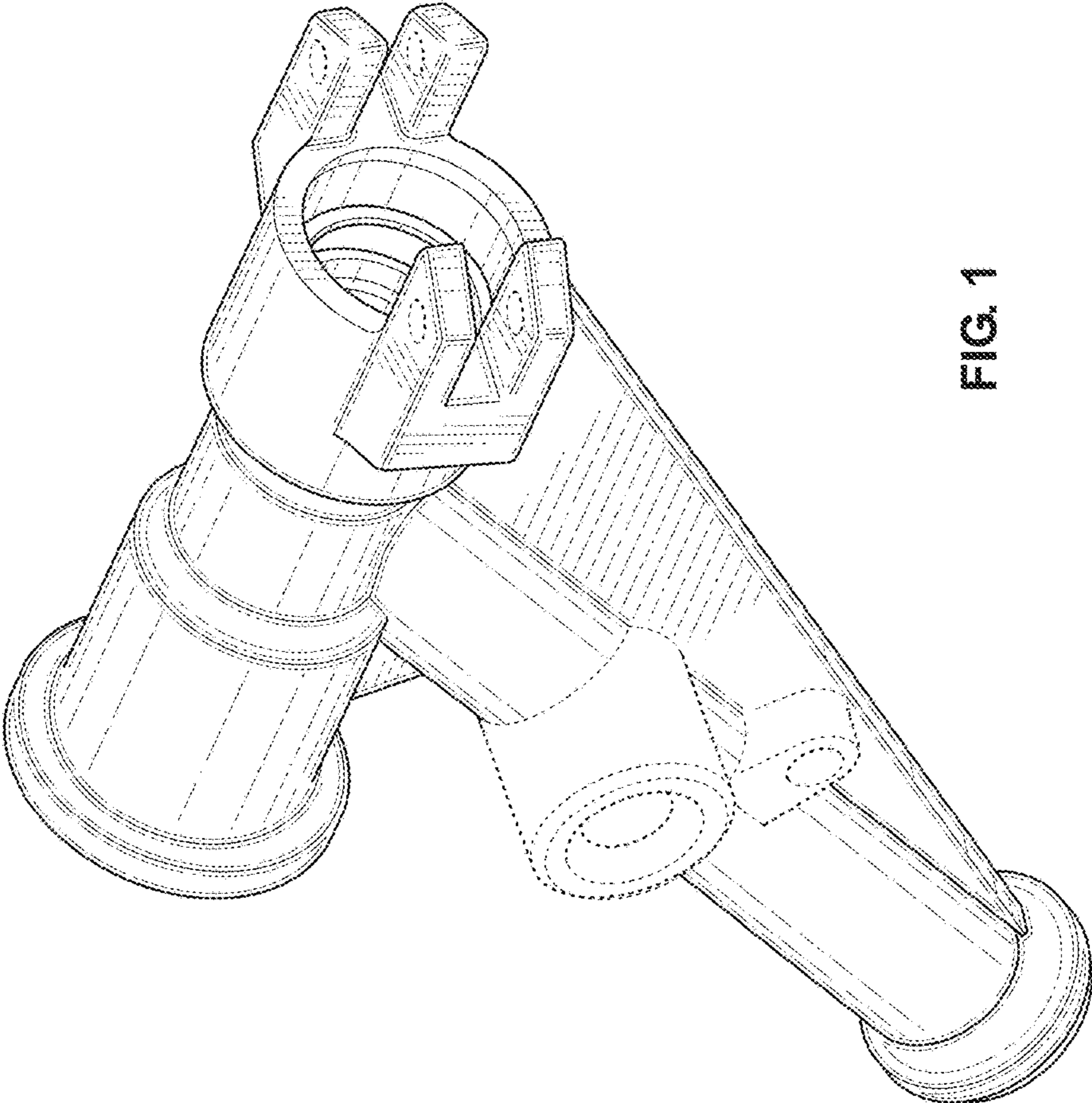

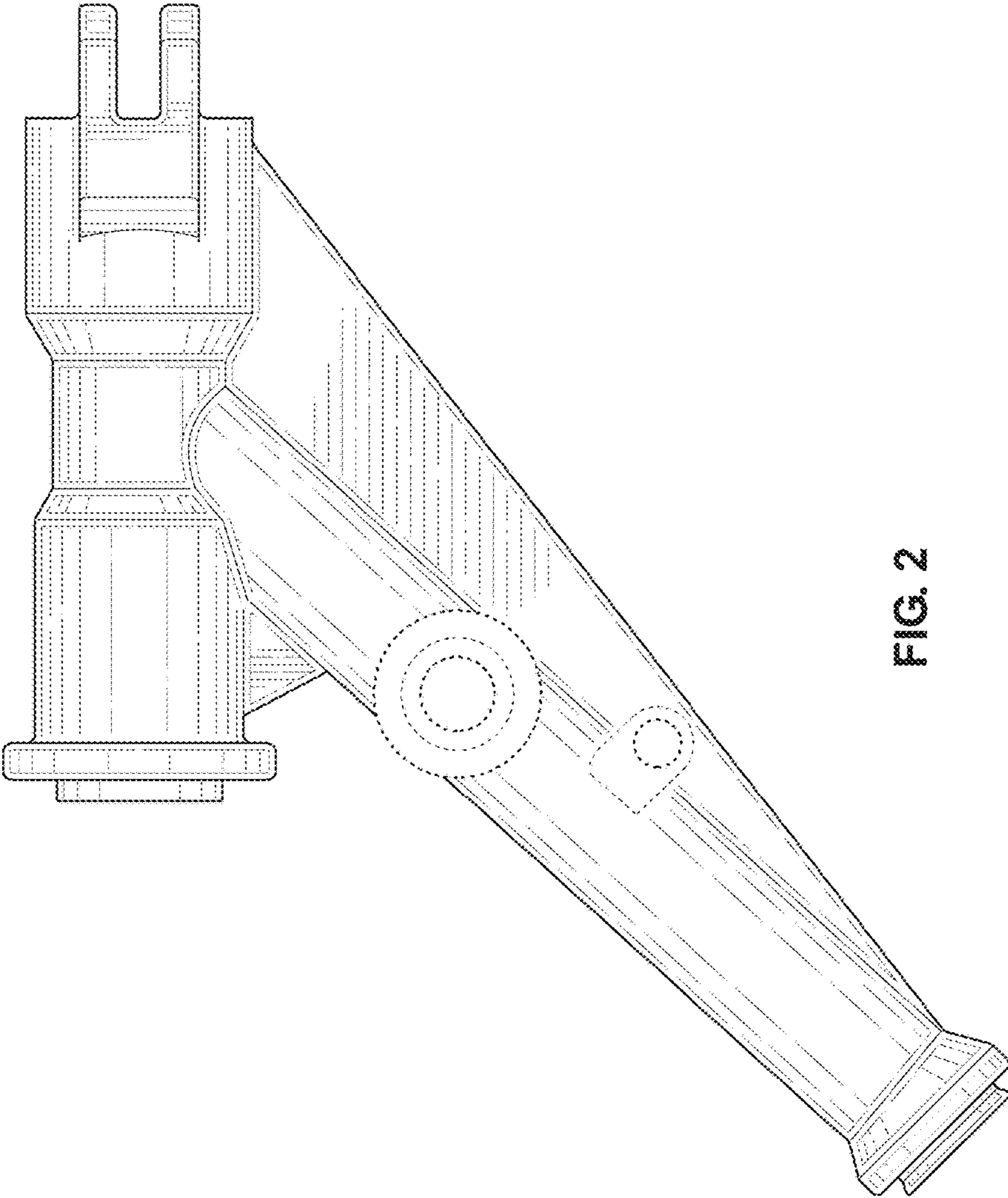

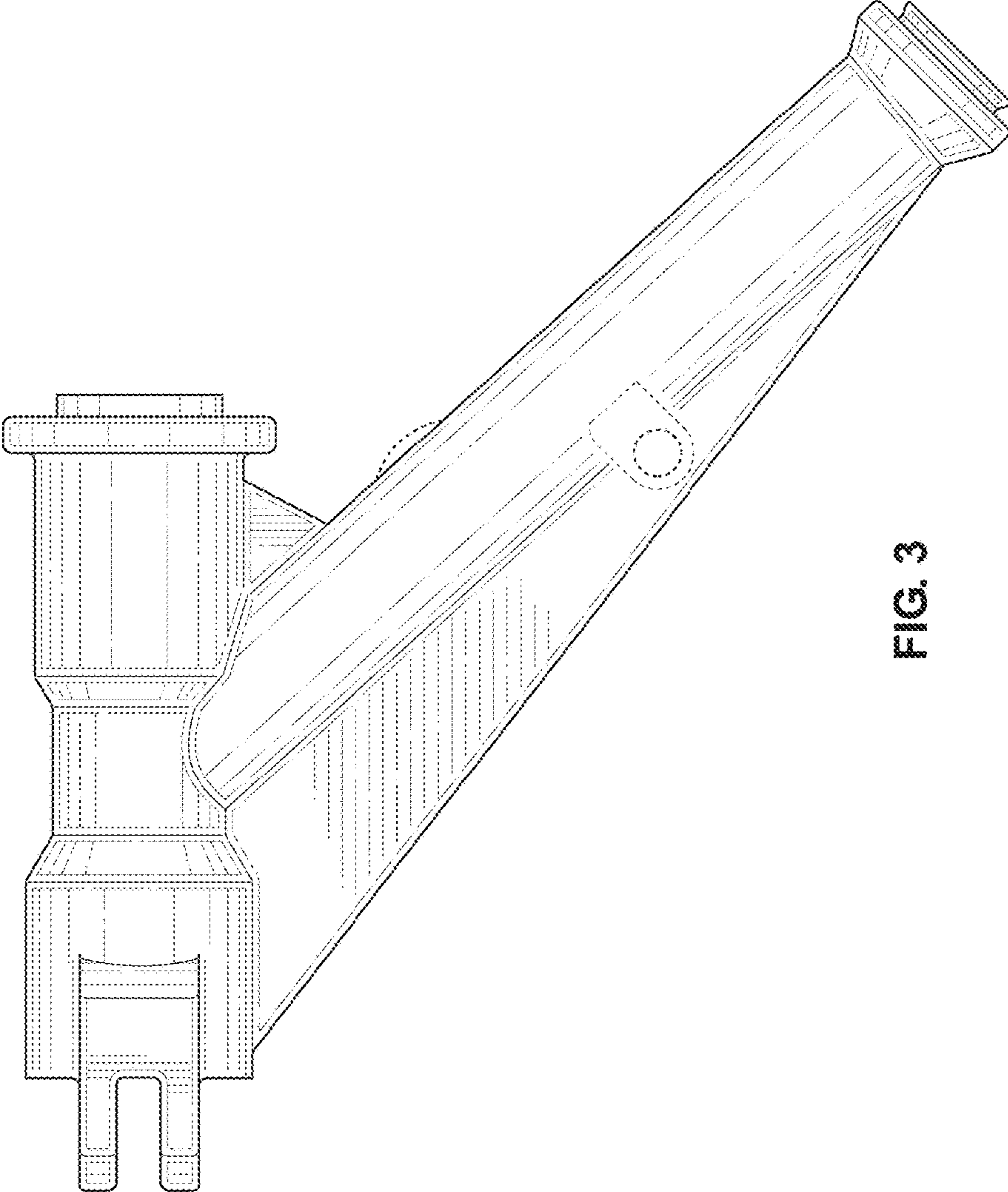

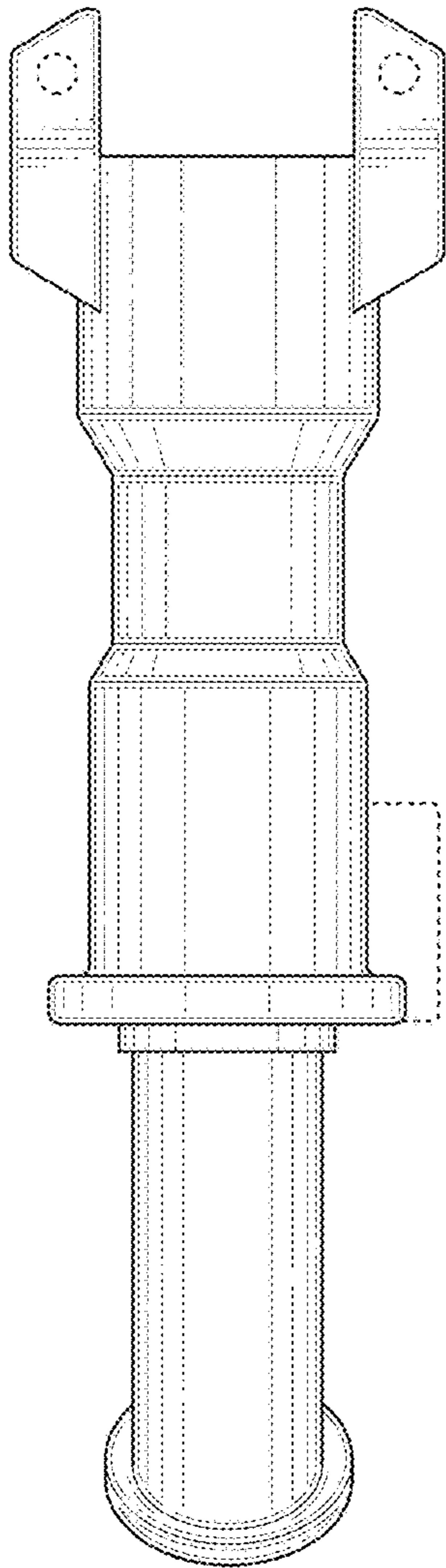

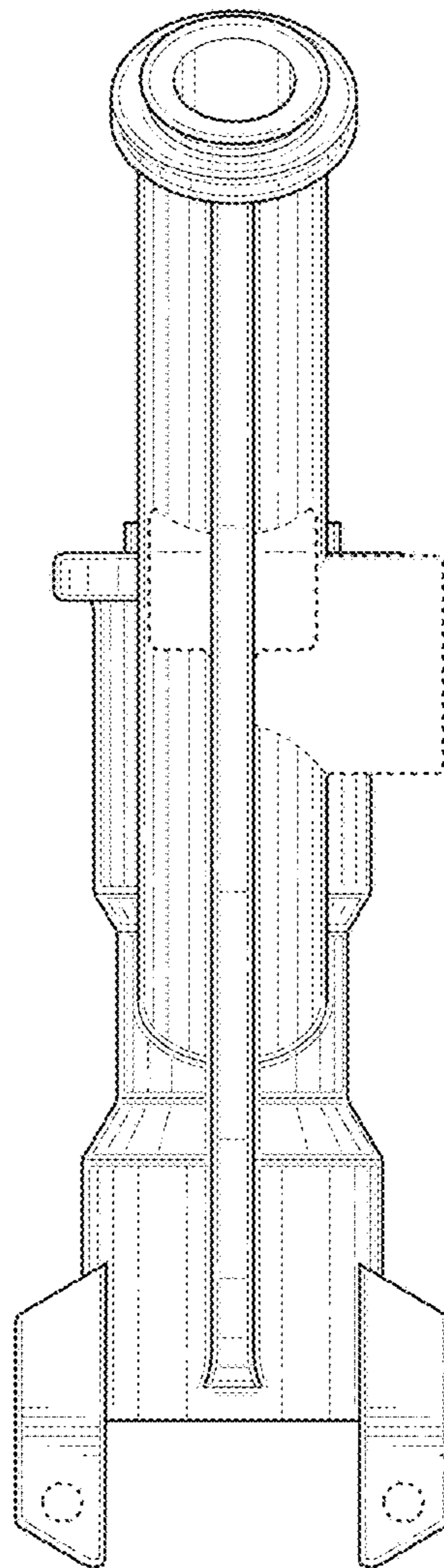

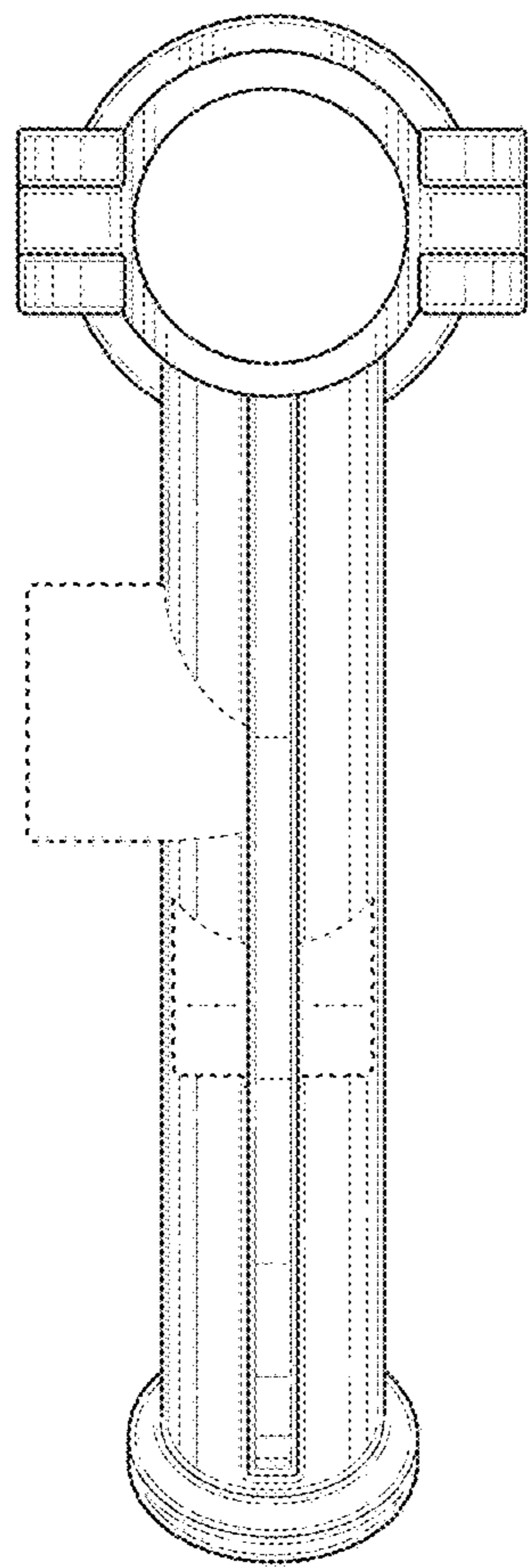

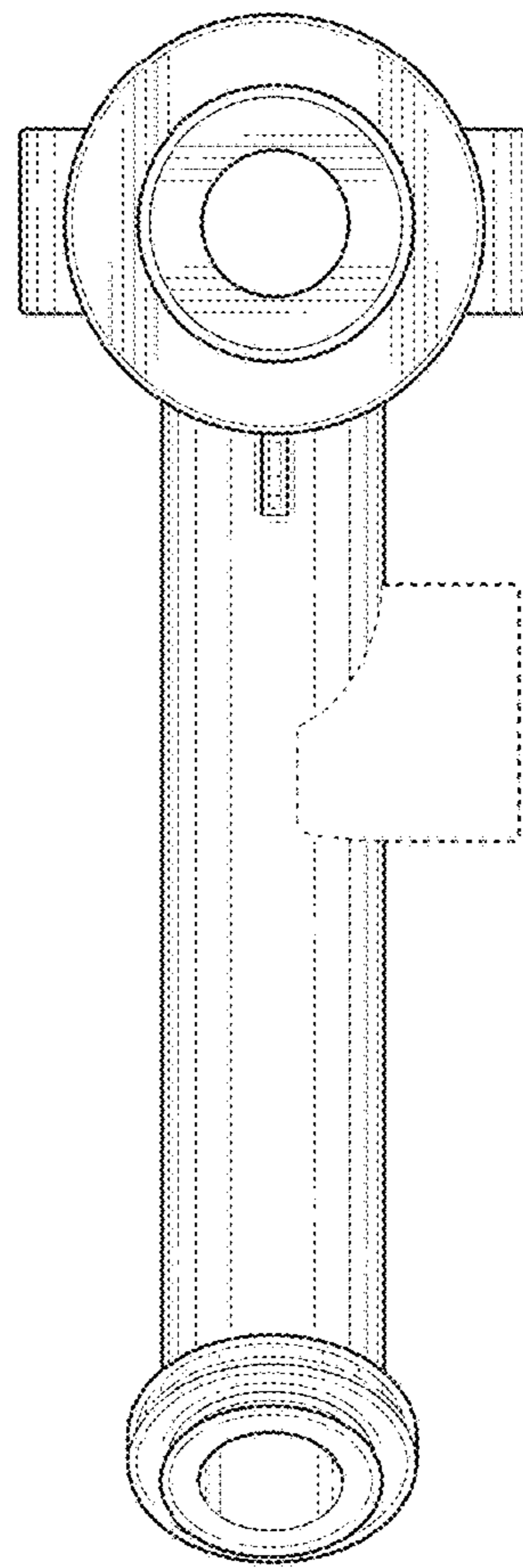
