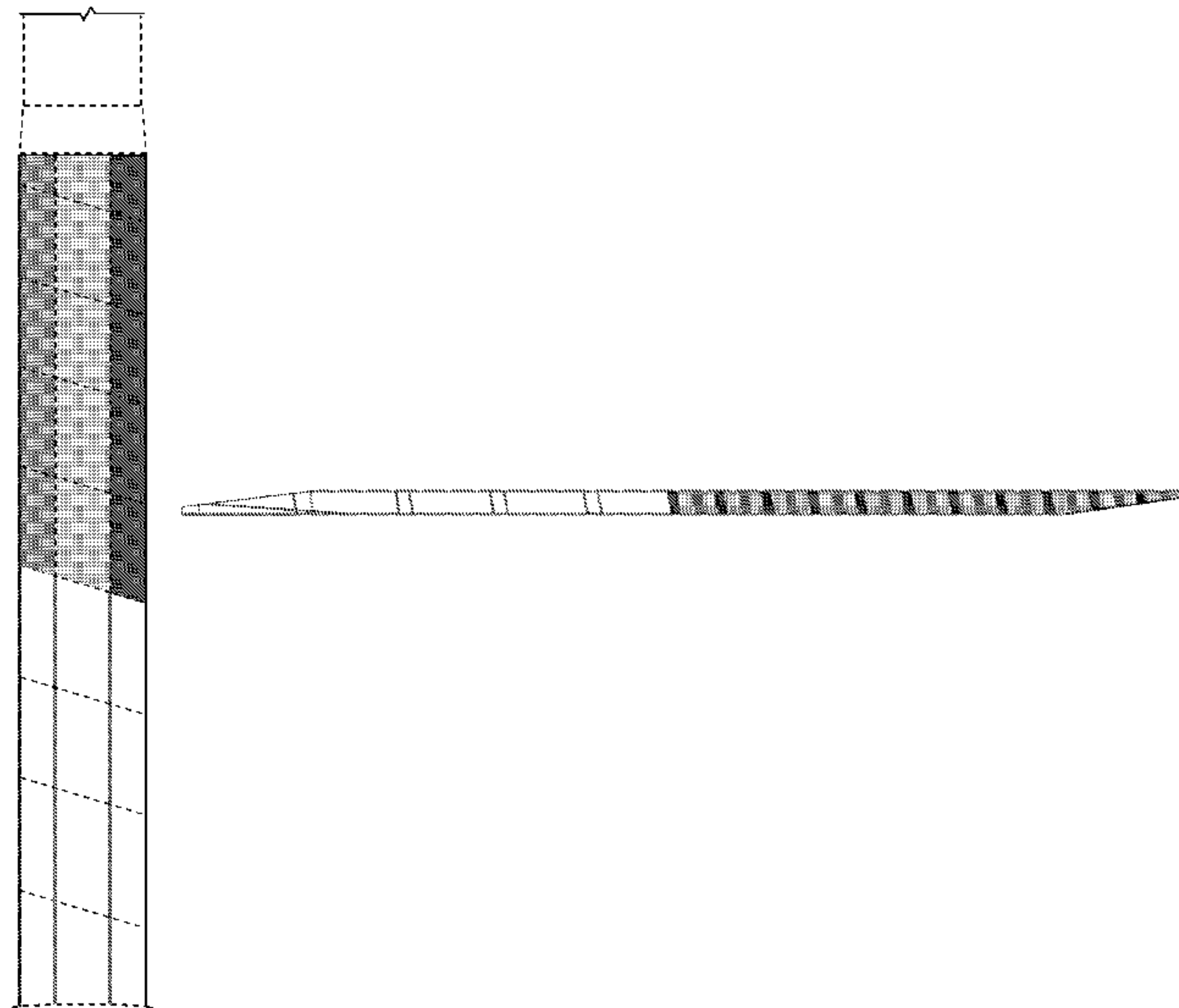
(57) **CLAIM**

The ornamental design for a color coded grip guide, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the color coded grip guide shown on an unclaimed equipment handle; FIG. 2 is a right side elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is the left side elevational view thereof shown with an unclaimed hand; and, FIG. 6 is a plan view of the unwrapped color grip guide. The broken line showing is included for the purpose of illustrating and forms no part of the claimed design. The claimed design has no substantial thickness and therefore is not claimed or shown. The three different shades of grey indicate a contrasting appearance.

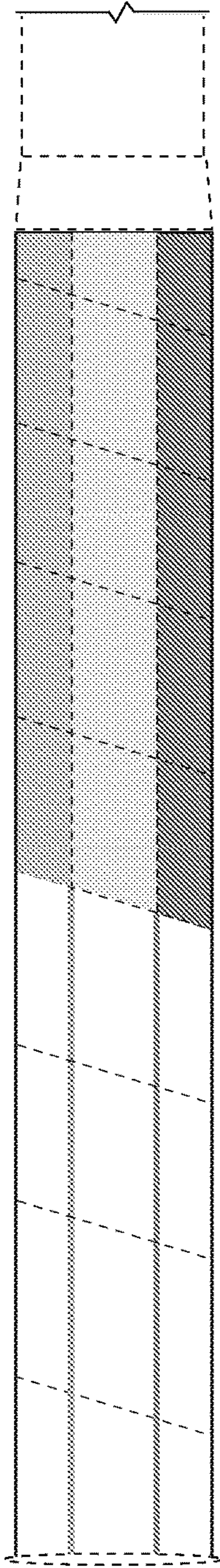

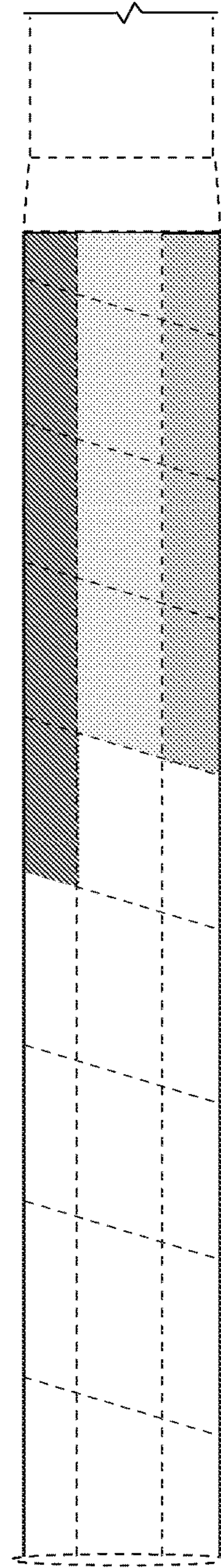

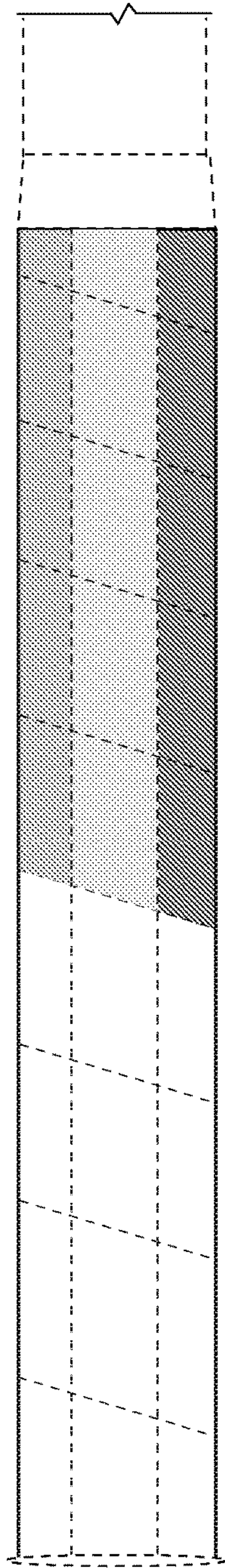

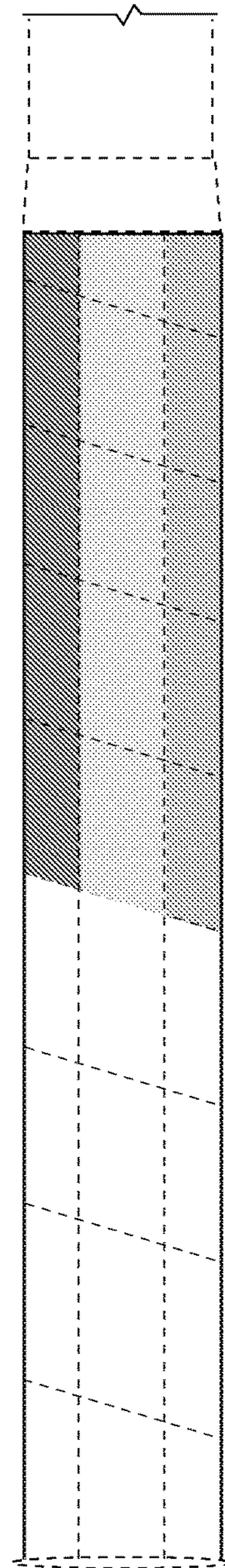

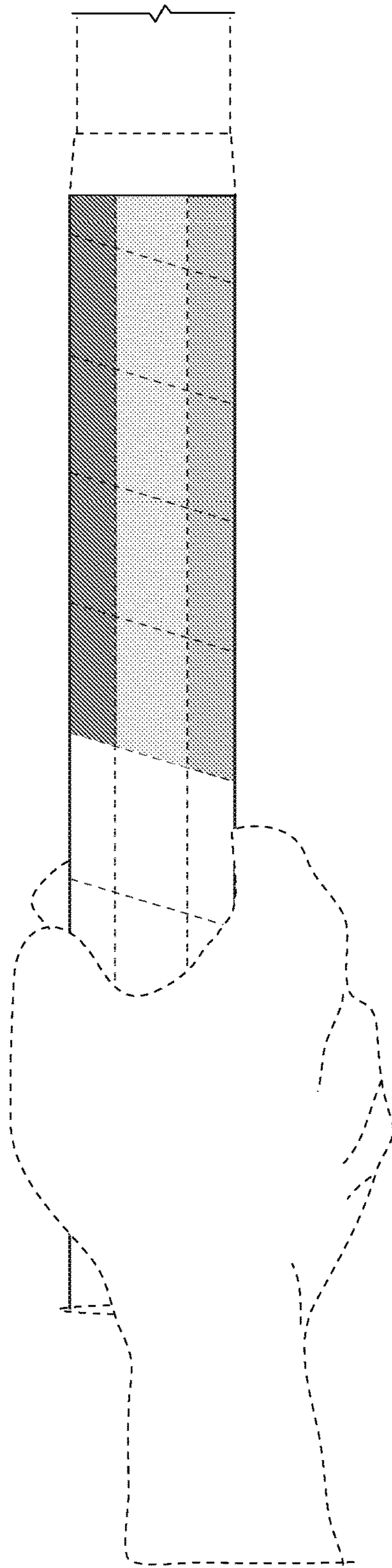
