(57) **CLAIM**

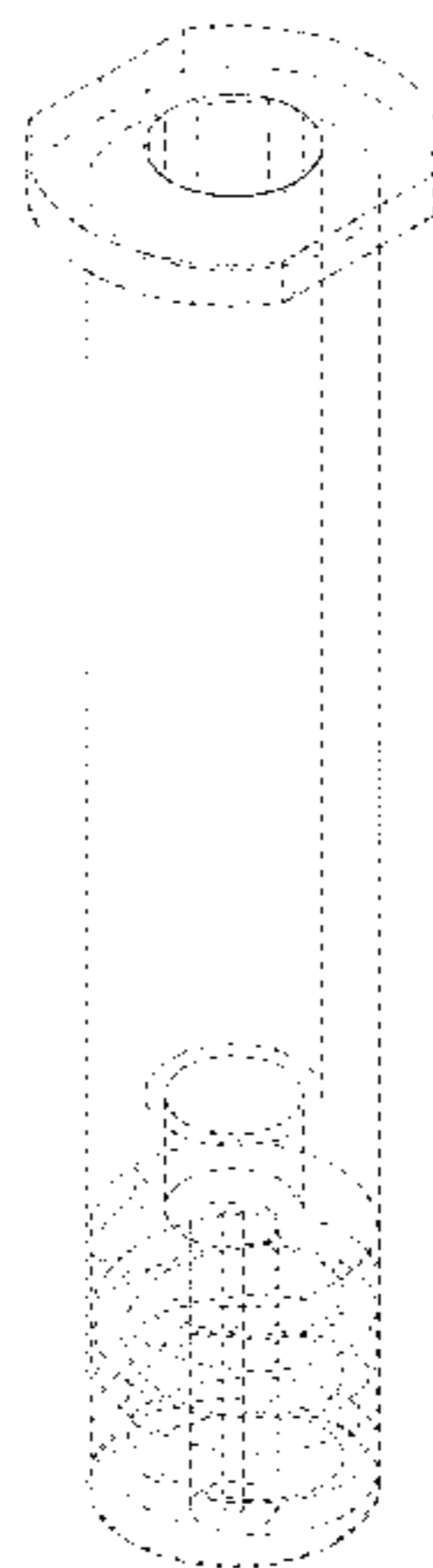
We claim the ornamental design for an injector body, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an injector body, showing our new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof; and,
 FIG. 8 is a cross-sectional view taken along line 8-8 in FIG. 6.

The broken lines shown in the drawings show portions of the injector body which form no part of design.

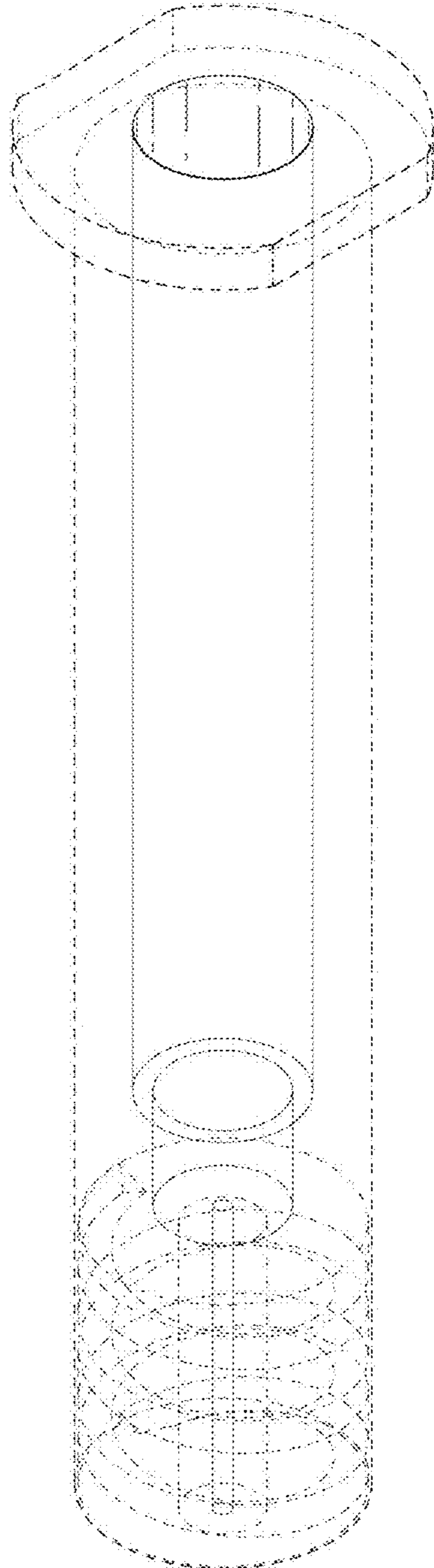

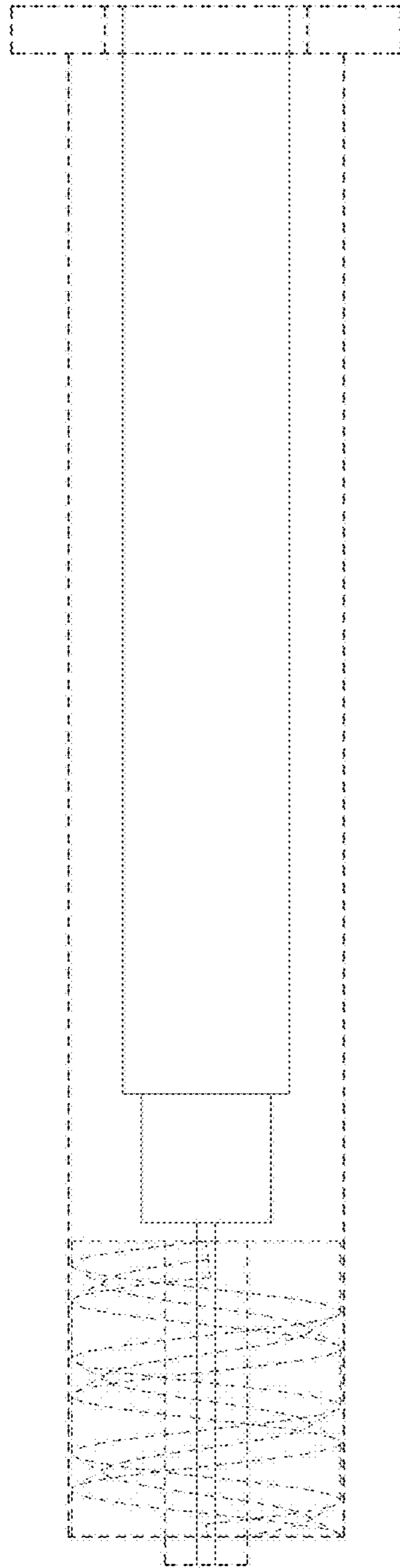

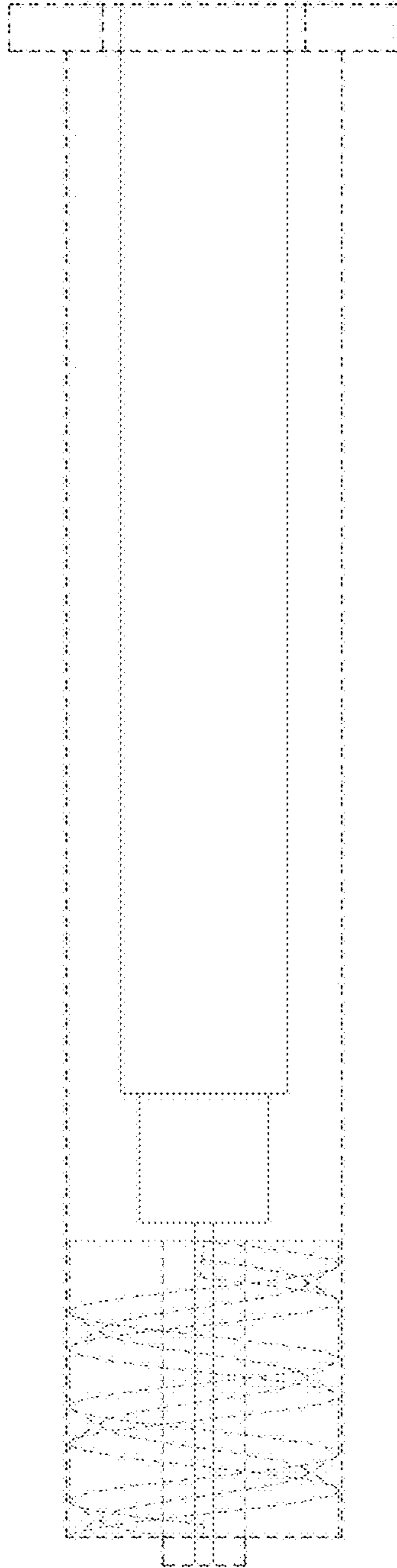

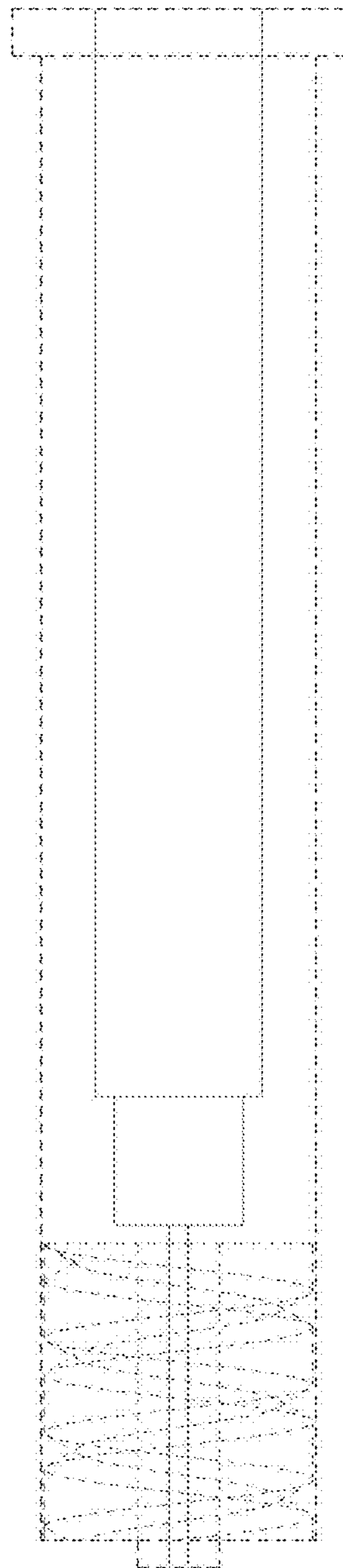

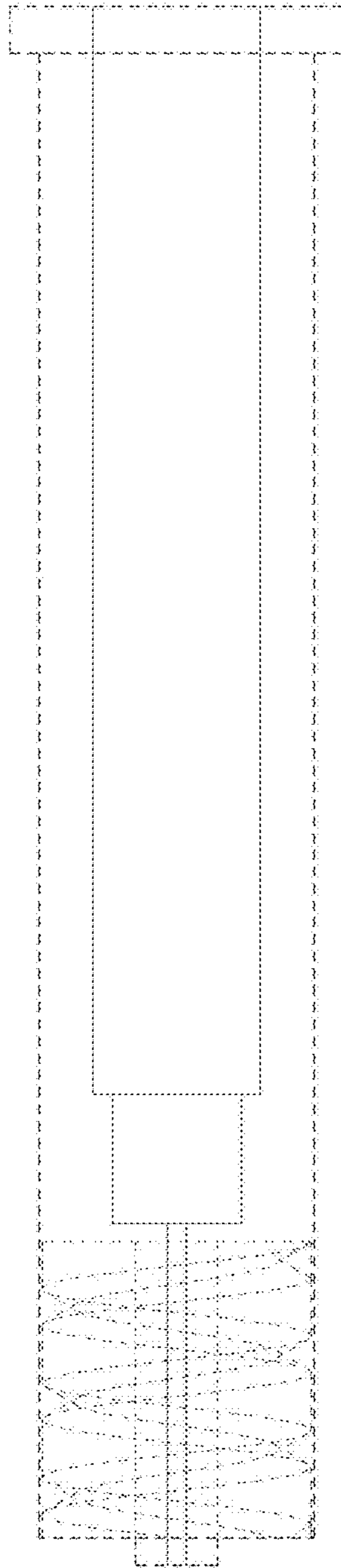

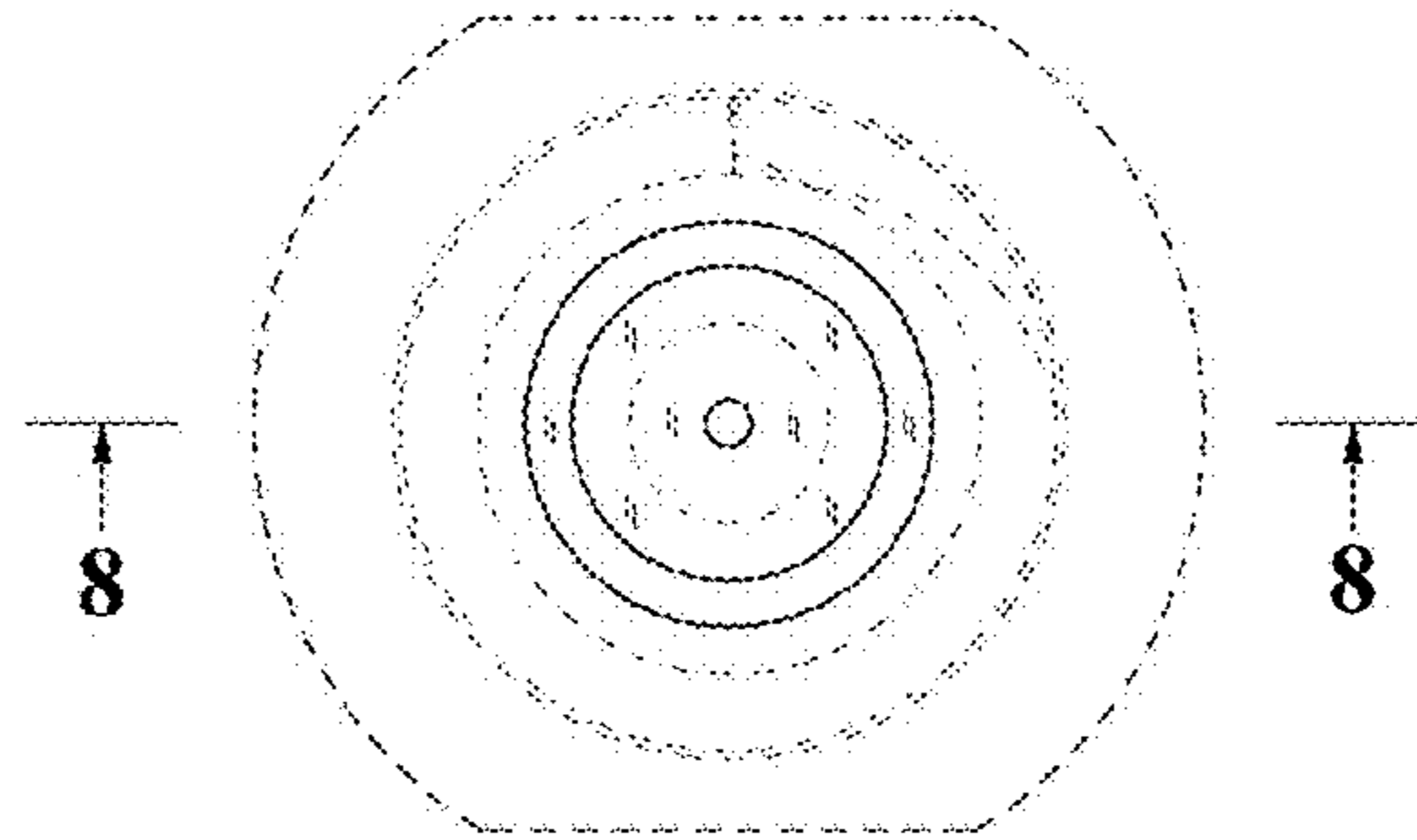

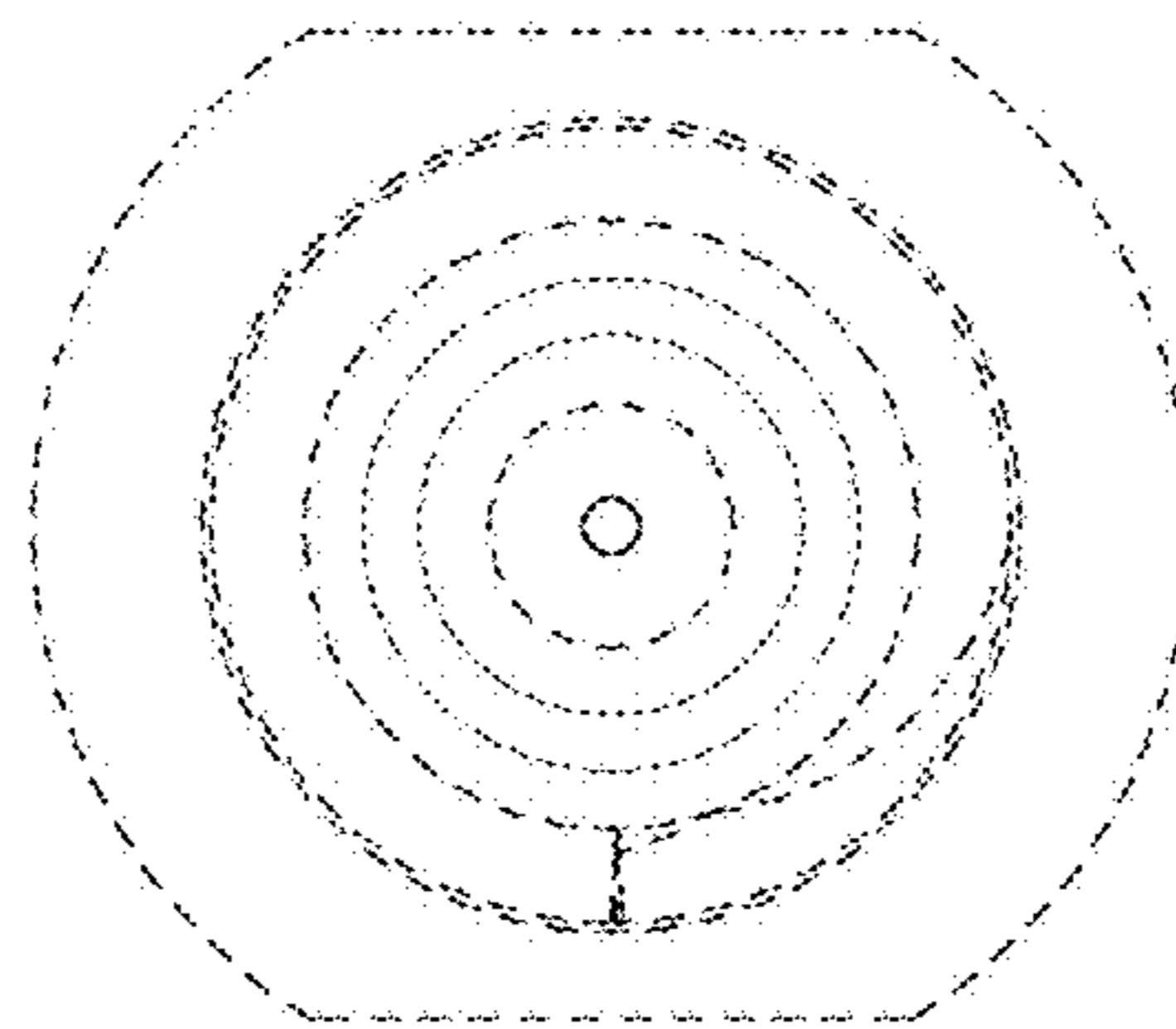

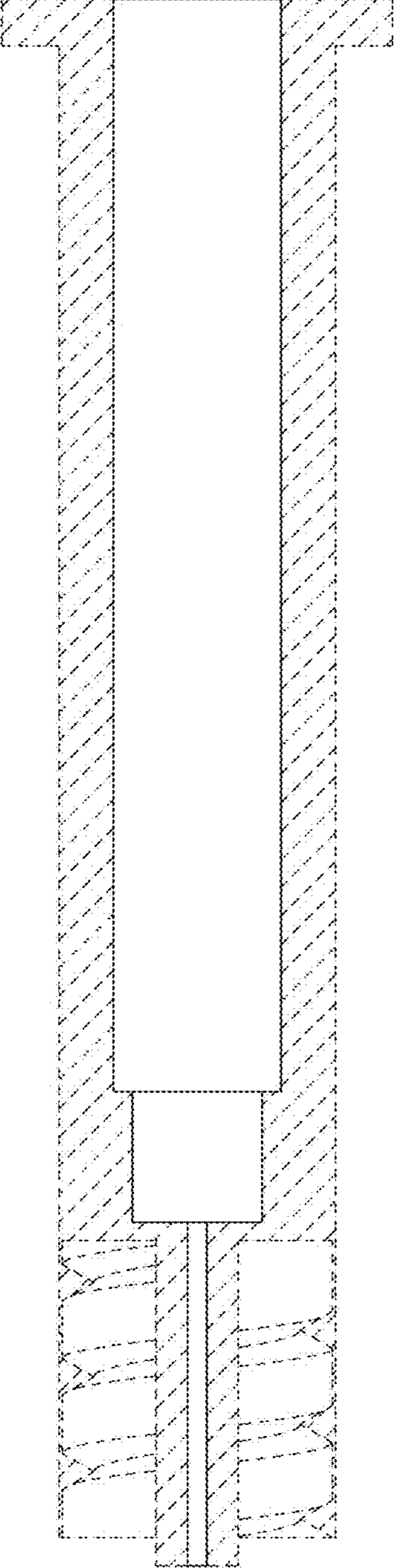
